FIG. 4 is an elevational view showing a front of the pitcher.

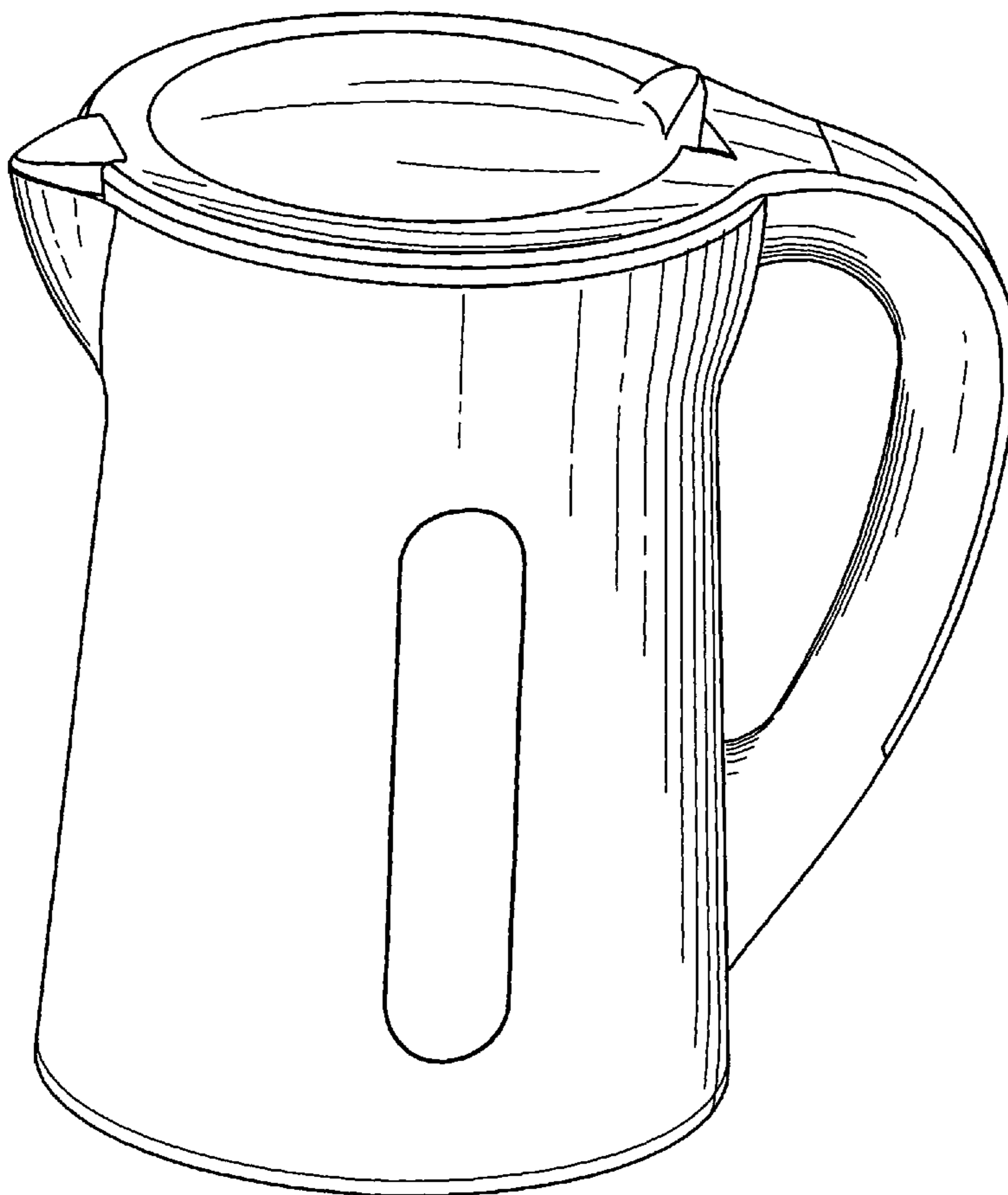
FIG. 5 is an elevational view showing a back of the pitcher.

FIG. 7 is a plan view showing a bottom of the pitcher.

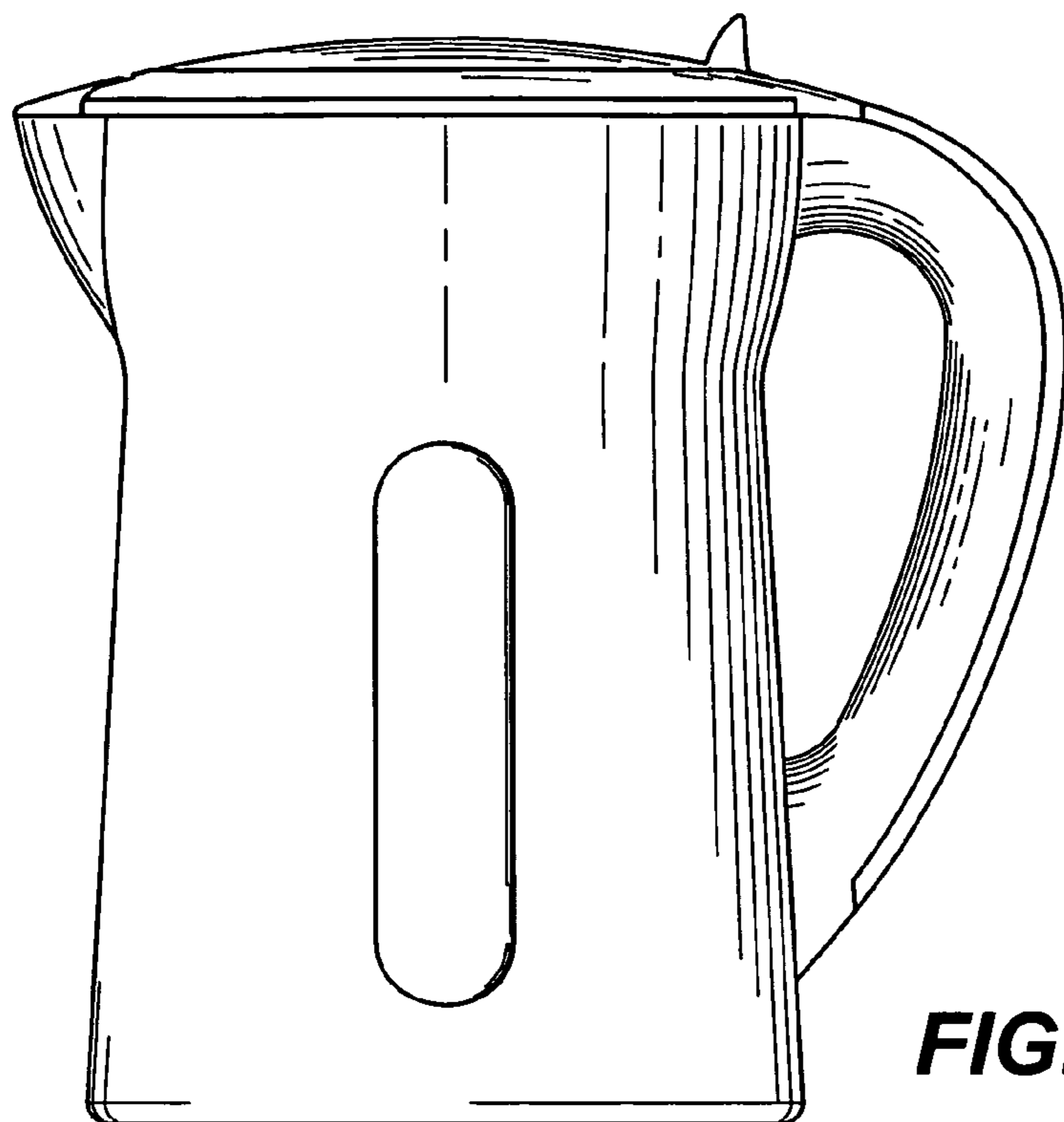

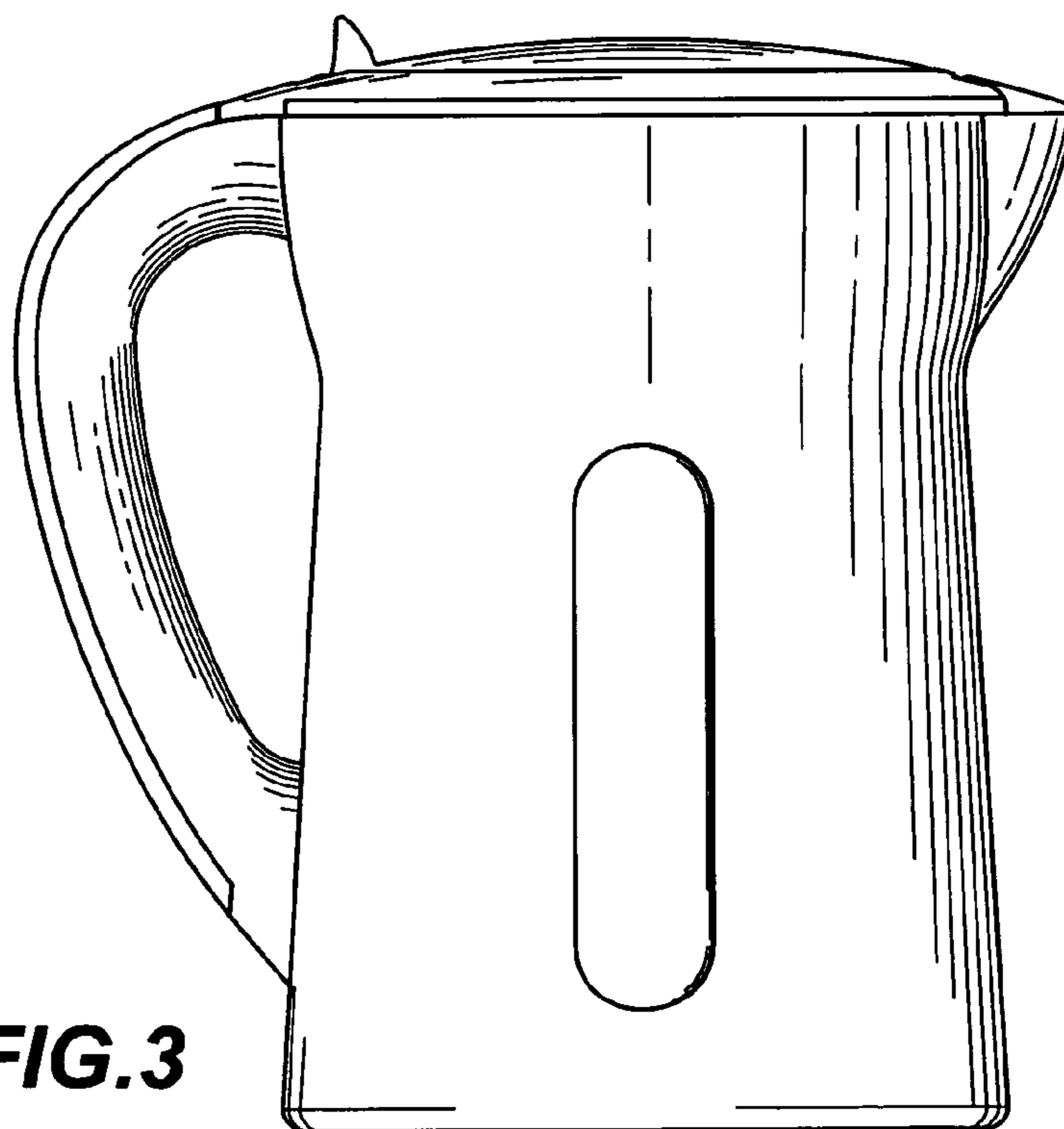




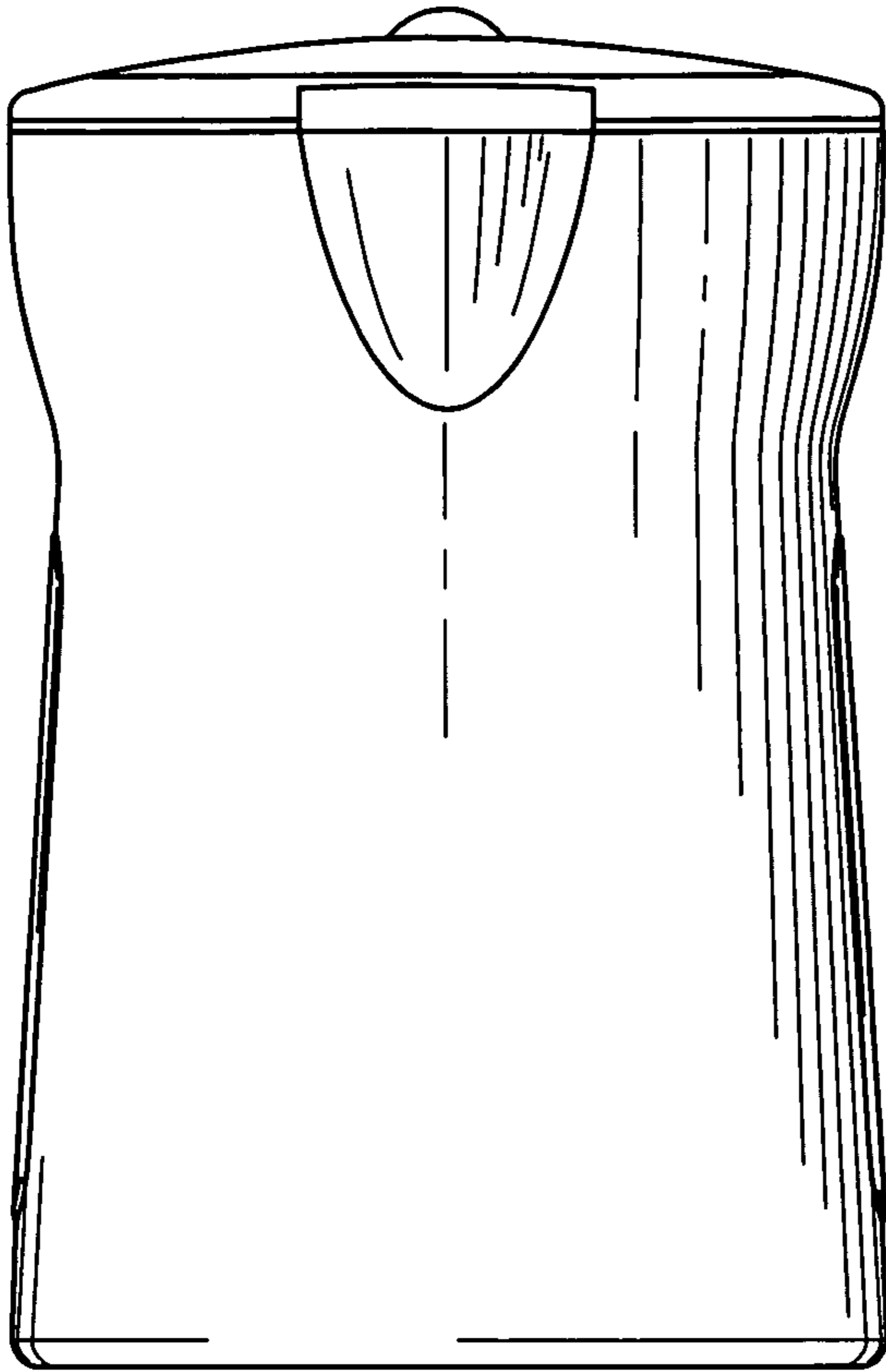

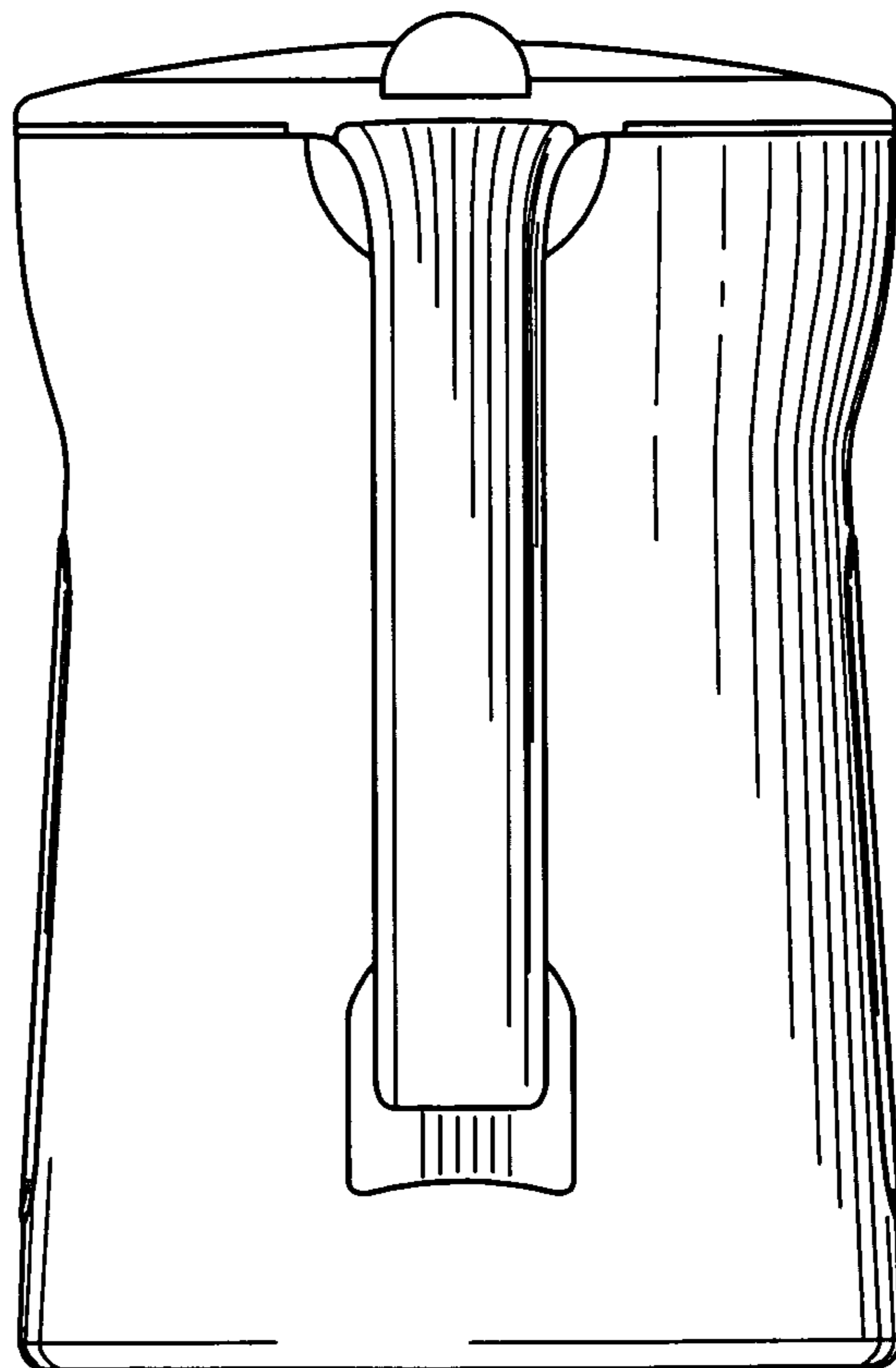

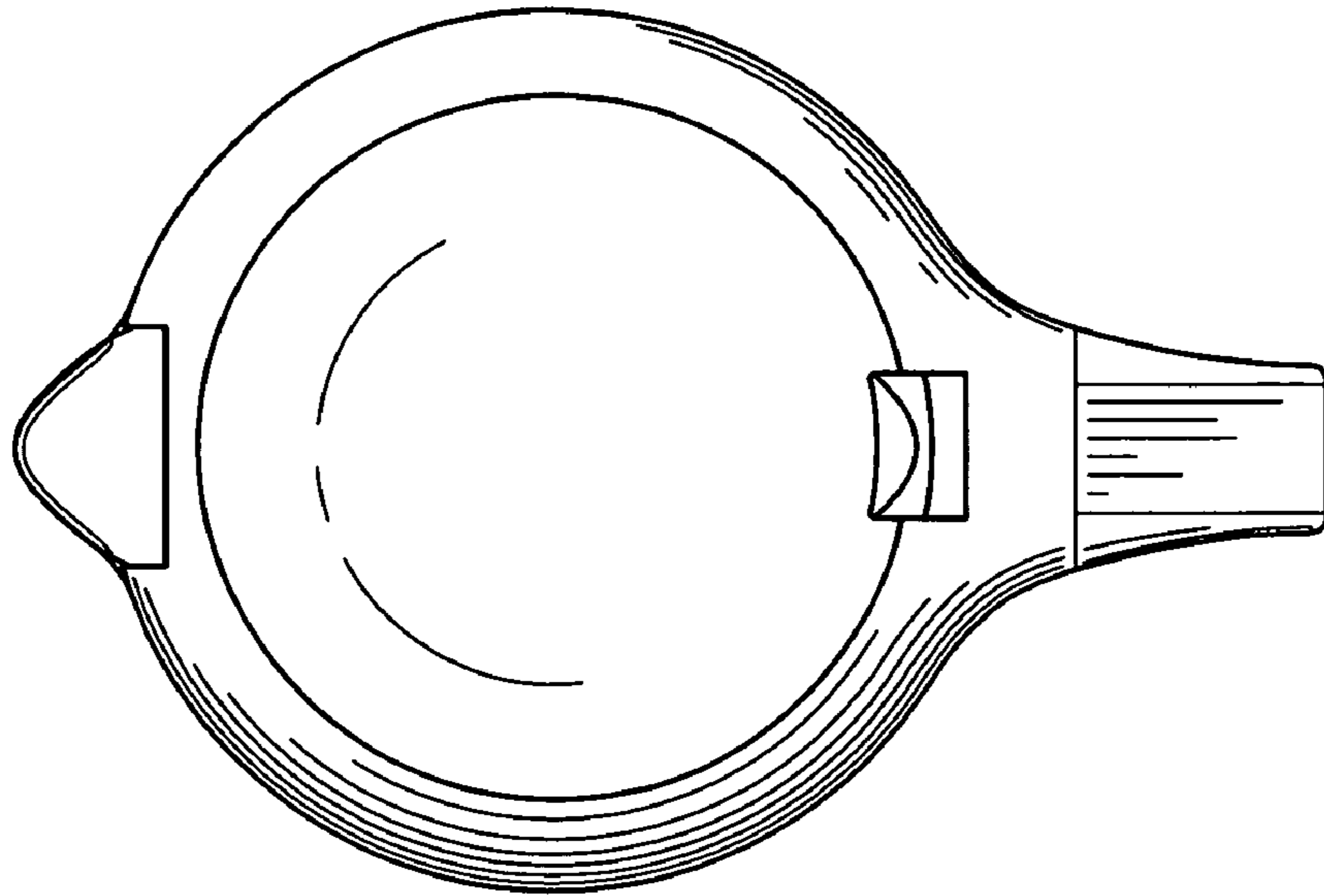

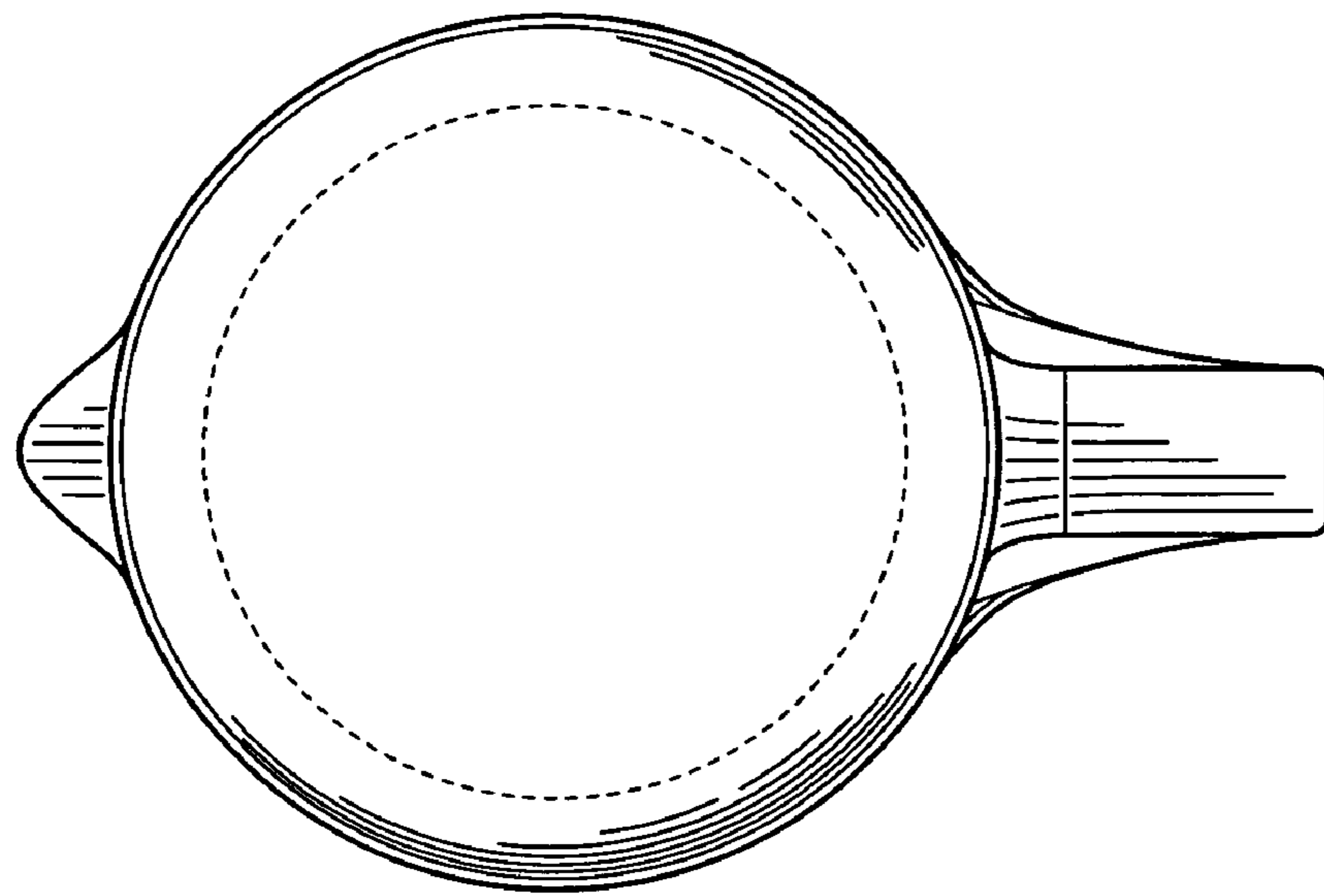
