(57) **CLAIM**

We claim the ornamental design for a hammock strap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hammock strap; FIG. 2 is an enlarged view of an intermediate portion of the hammock strap indicated at dashed box 2 in FIG. 1; FIG. 3 is an enlarged view of an end of the hammock strap indicated at dashed box 3 in FIG. 1; FIG. 4 is a front view of the hammock strap; FIG. 5 is an enlarged view of an intermediate portion of the hammock strap indicated at dashed box 5 in FIG. 4; FIG. 6 is a back view of the hammock strap; and, FIG. 7 is an enlarged side view of the hammock strap shown in a folded position and with dashed lines for ease of illustration and indicating continuous formation of the strap from one end to the other.

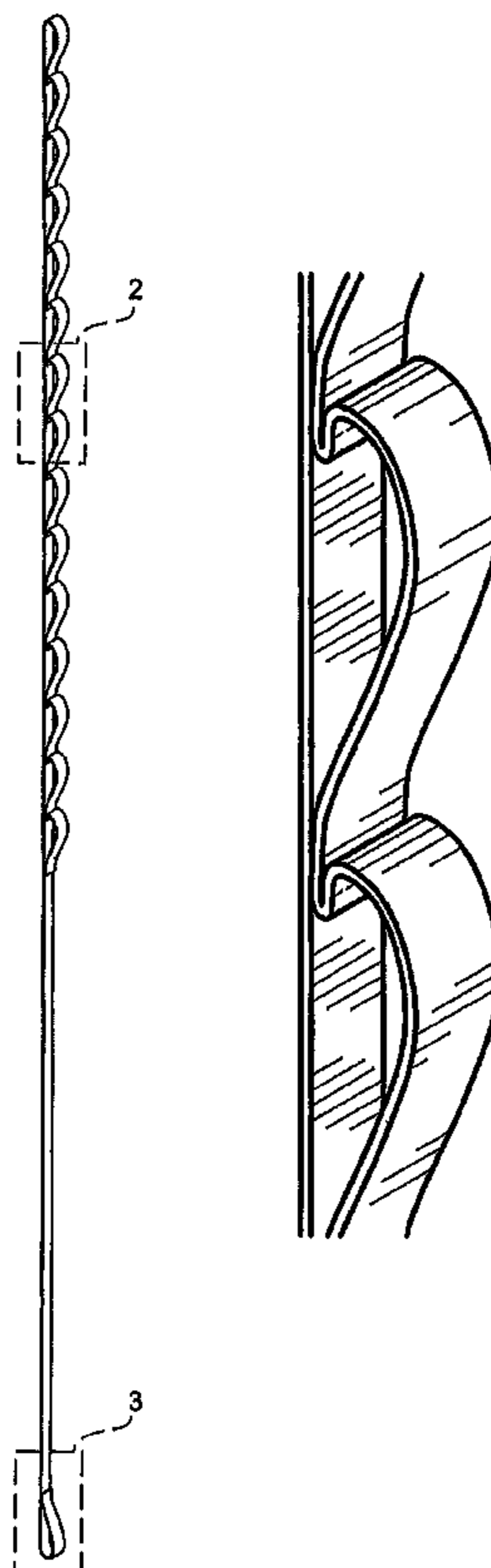

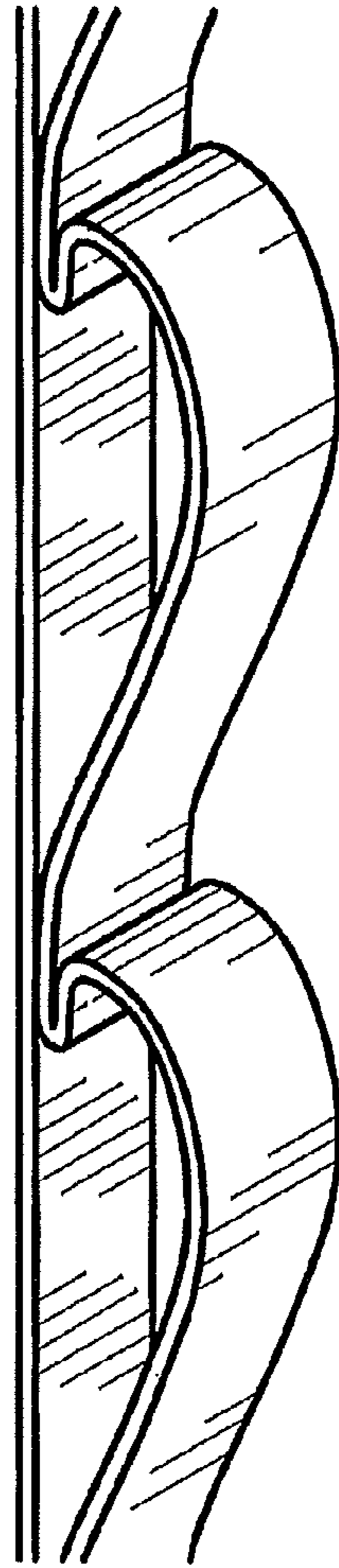
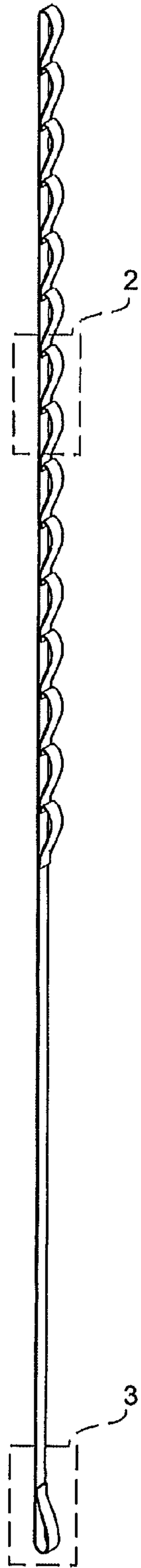

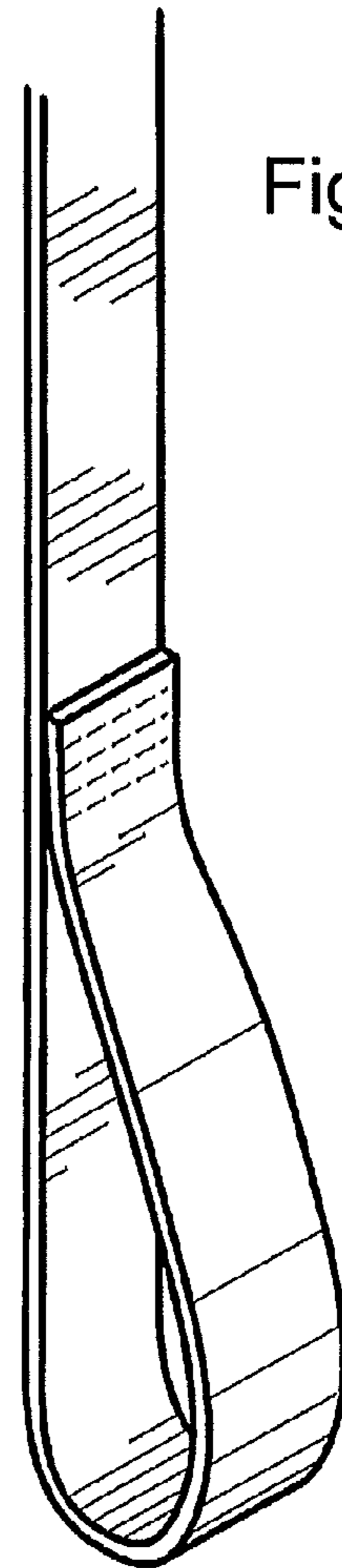

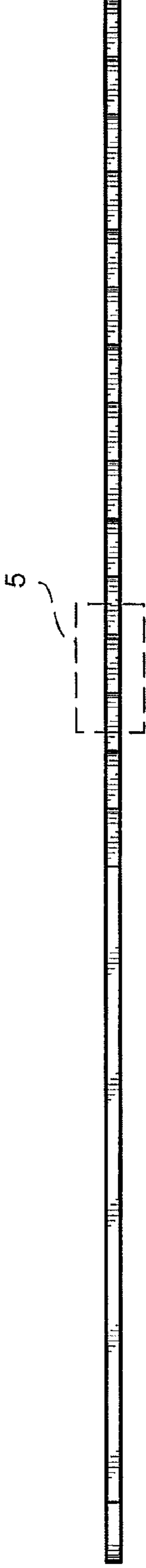

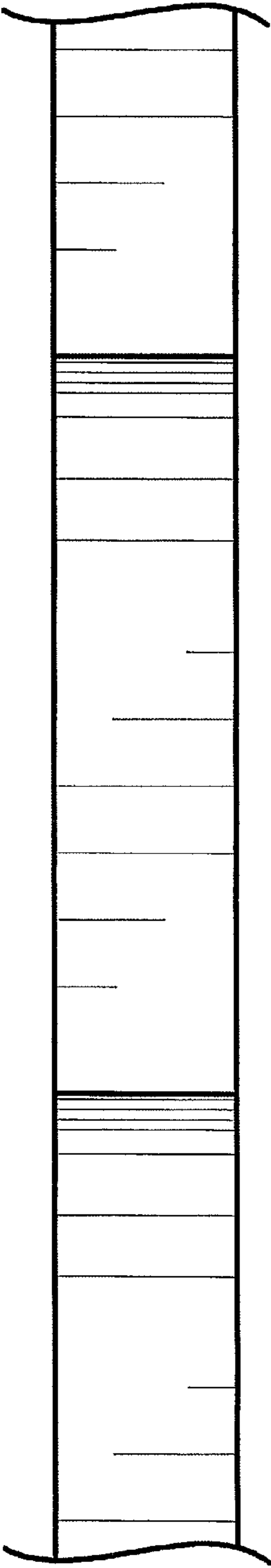

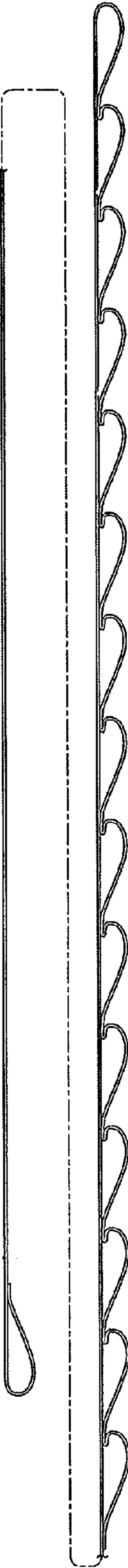
