FIG. 1 is a perspective view of a wire harness, showing my new design;

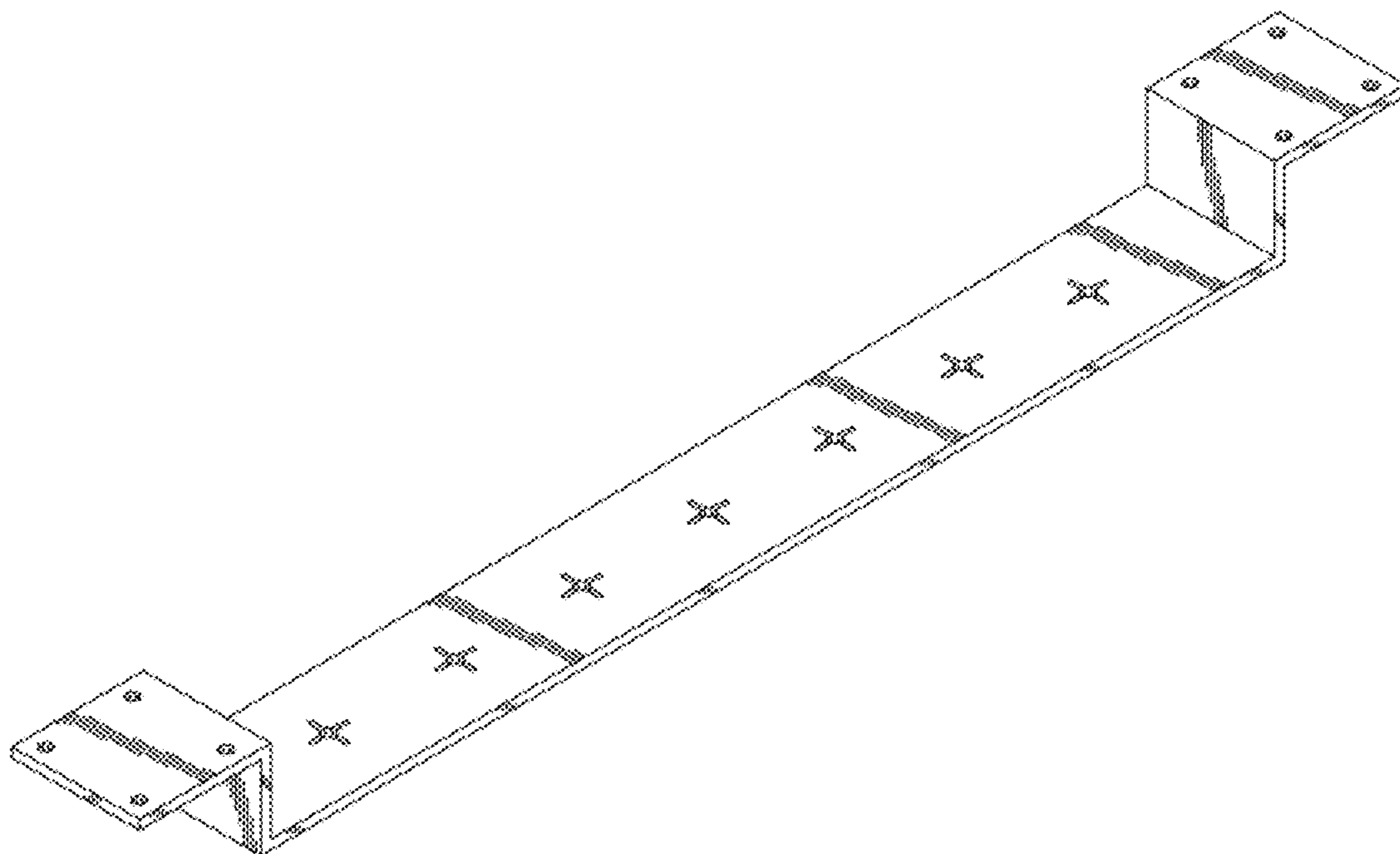
FIG. 2 is a front view thereof with a rear view being a mirror image;

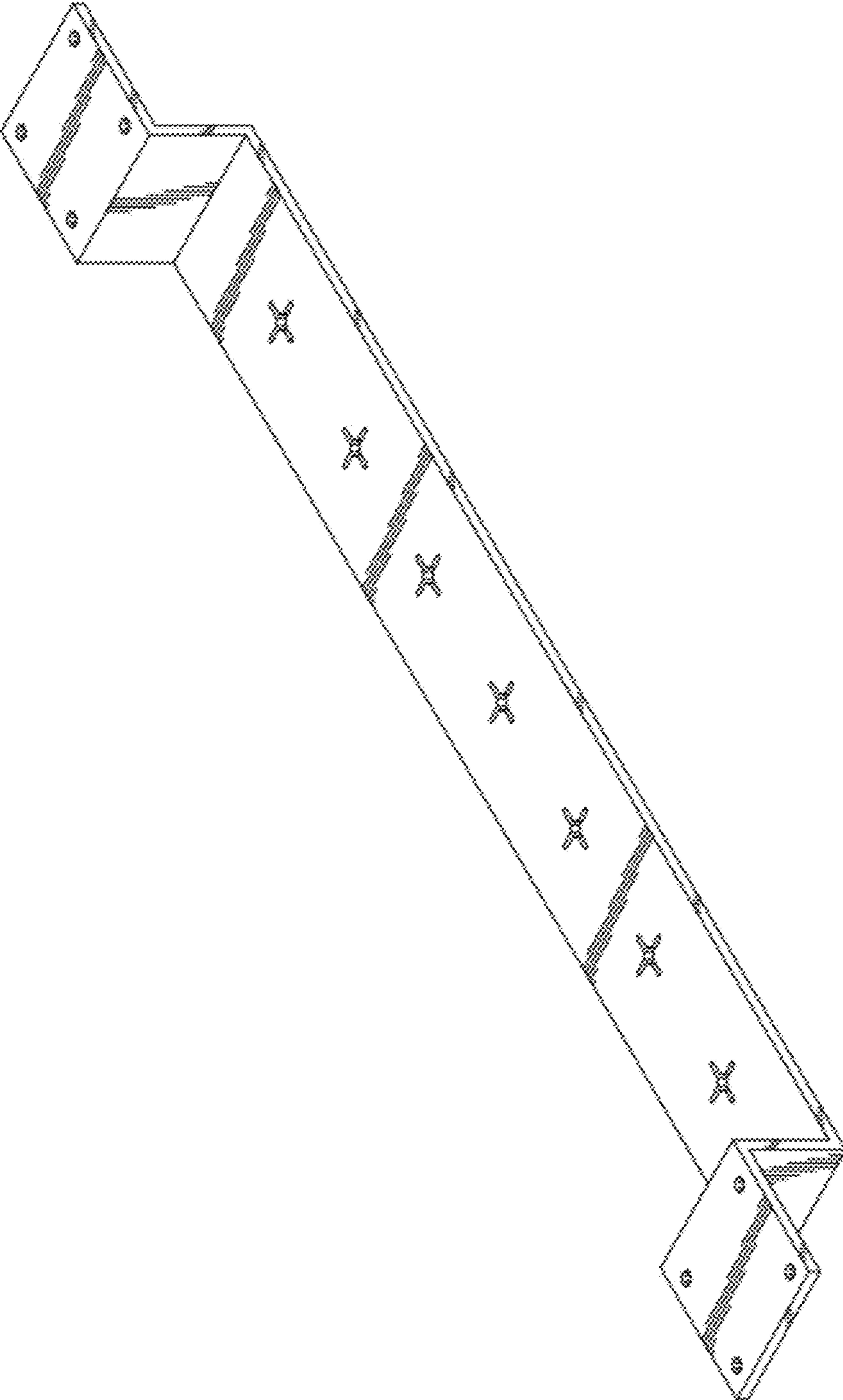

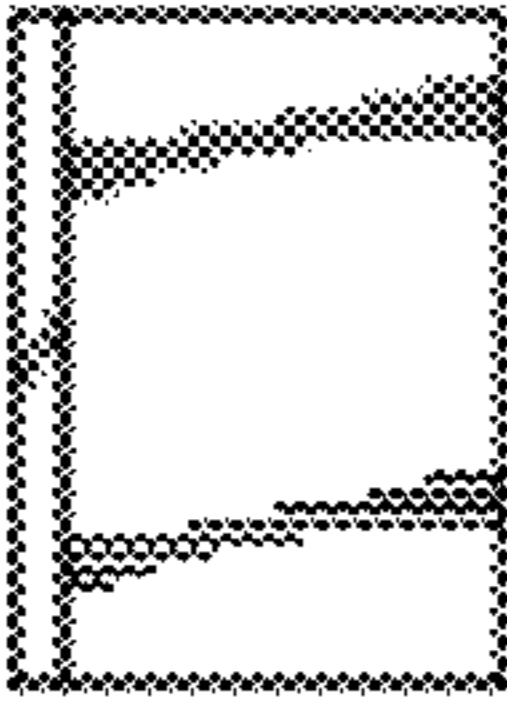

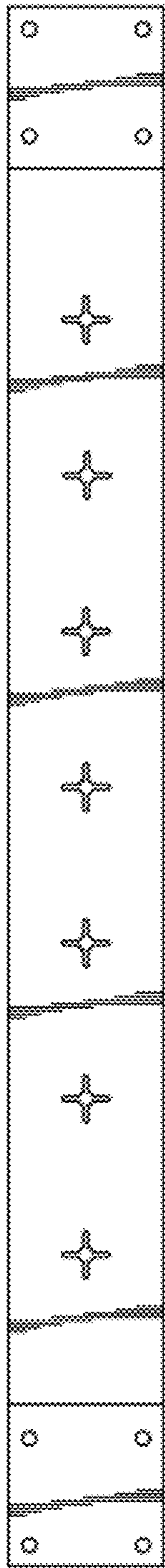

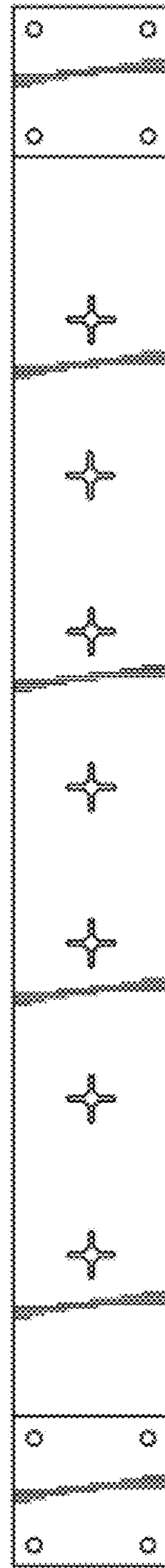
