The ornamental design for a push button, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a push button in accordance with the new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side elevation view thereof, a right side elevation view being mirror image thereof;

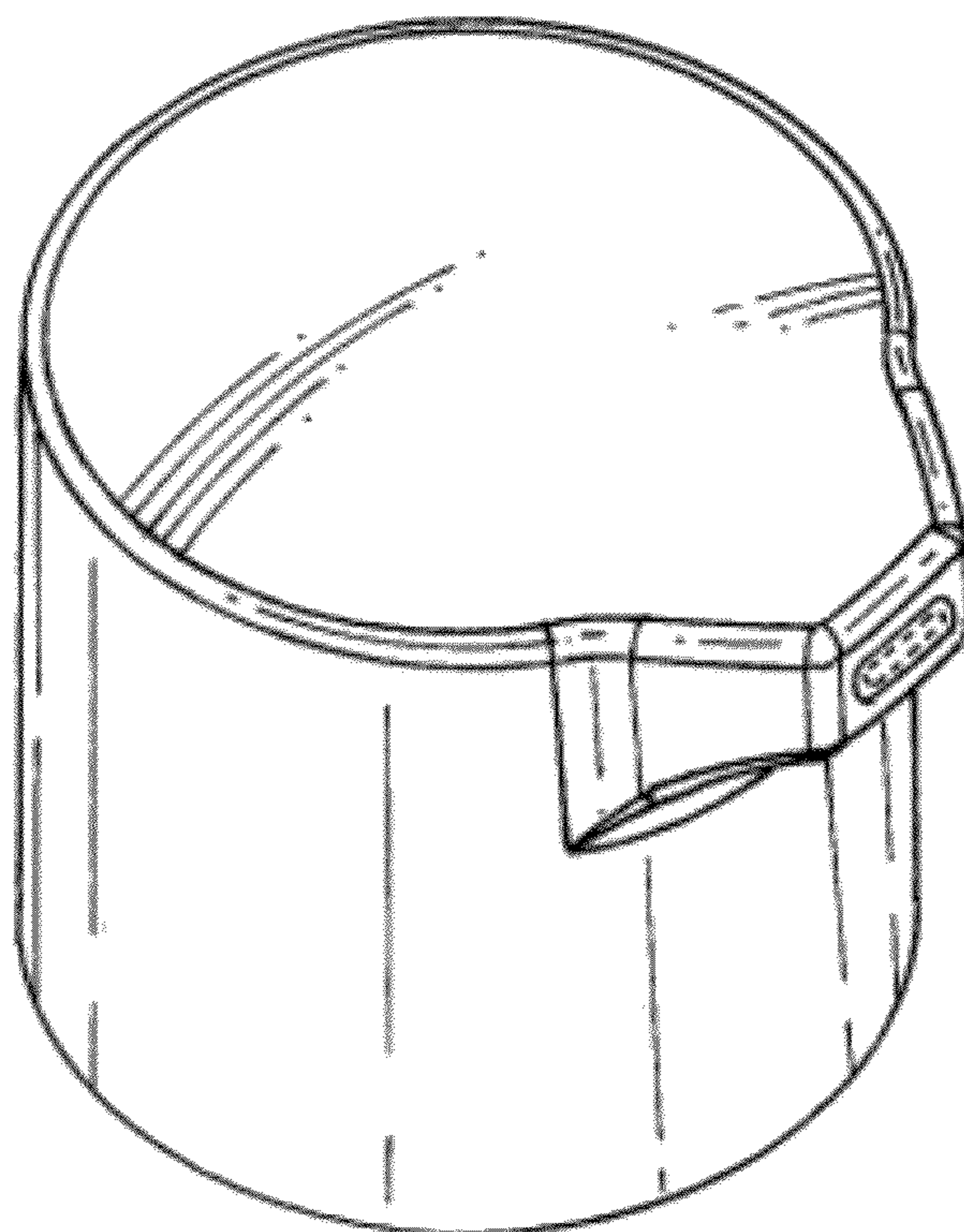
FIG. 4 is a rear elevation view thereof;

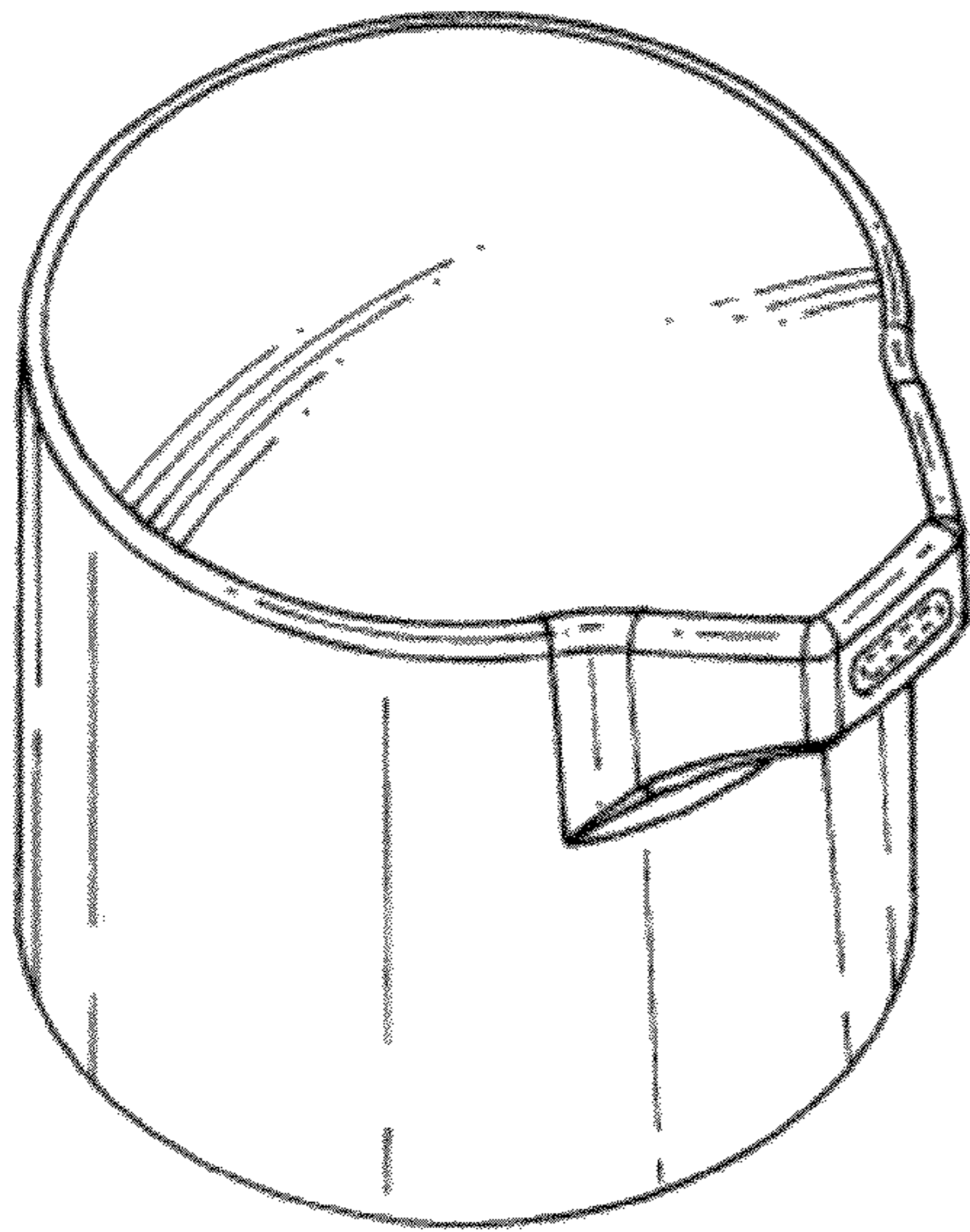

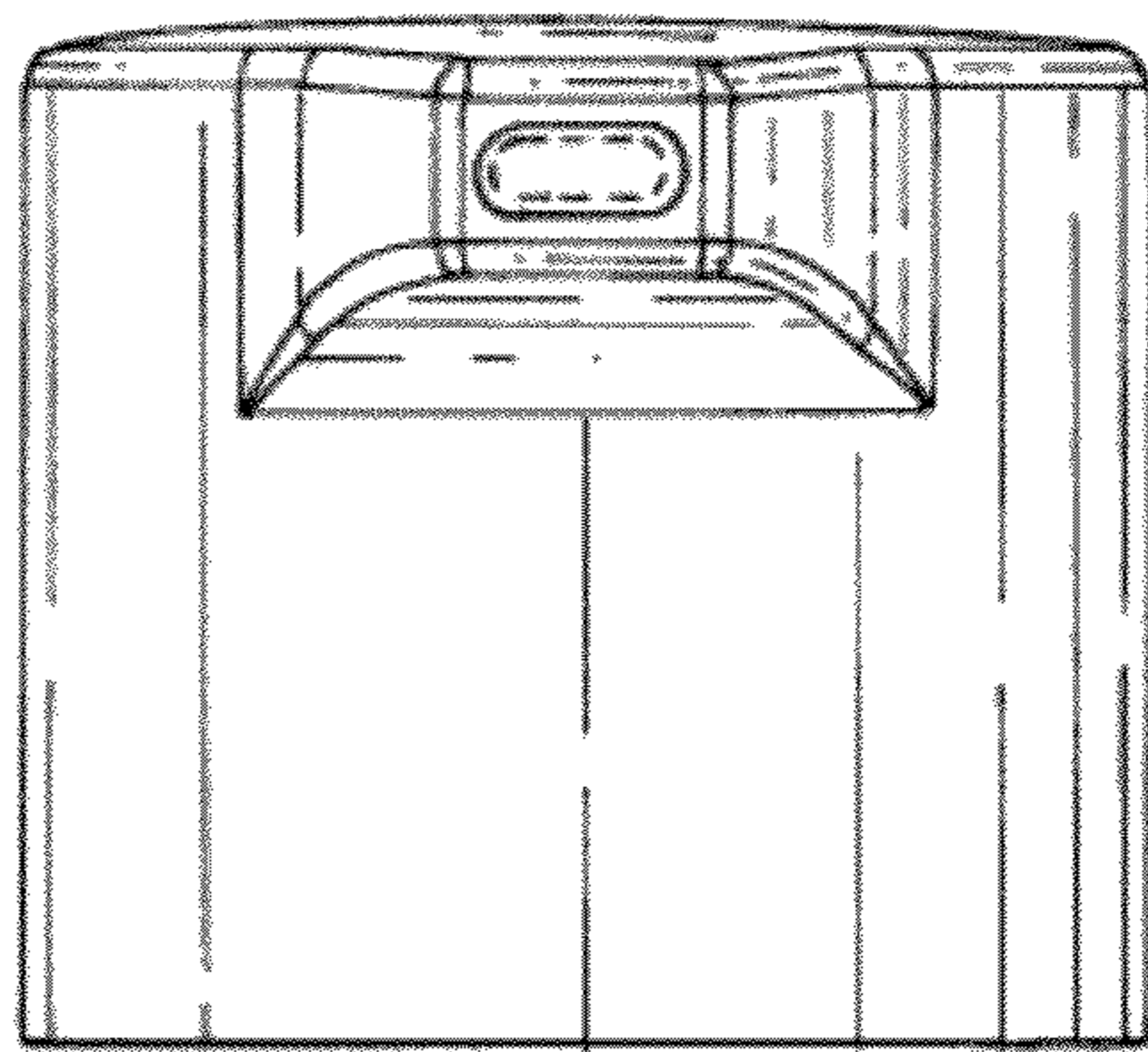

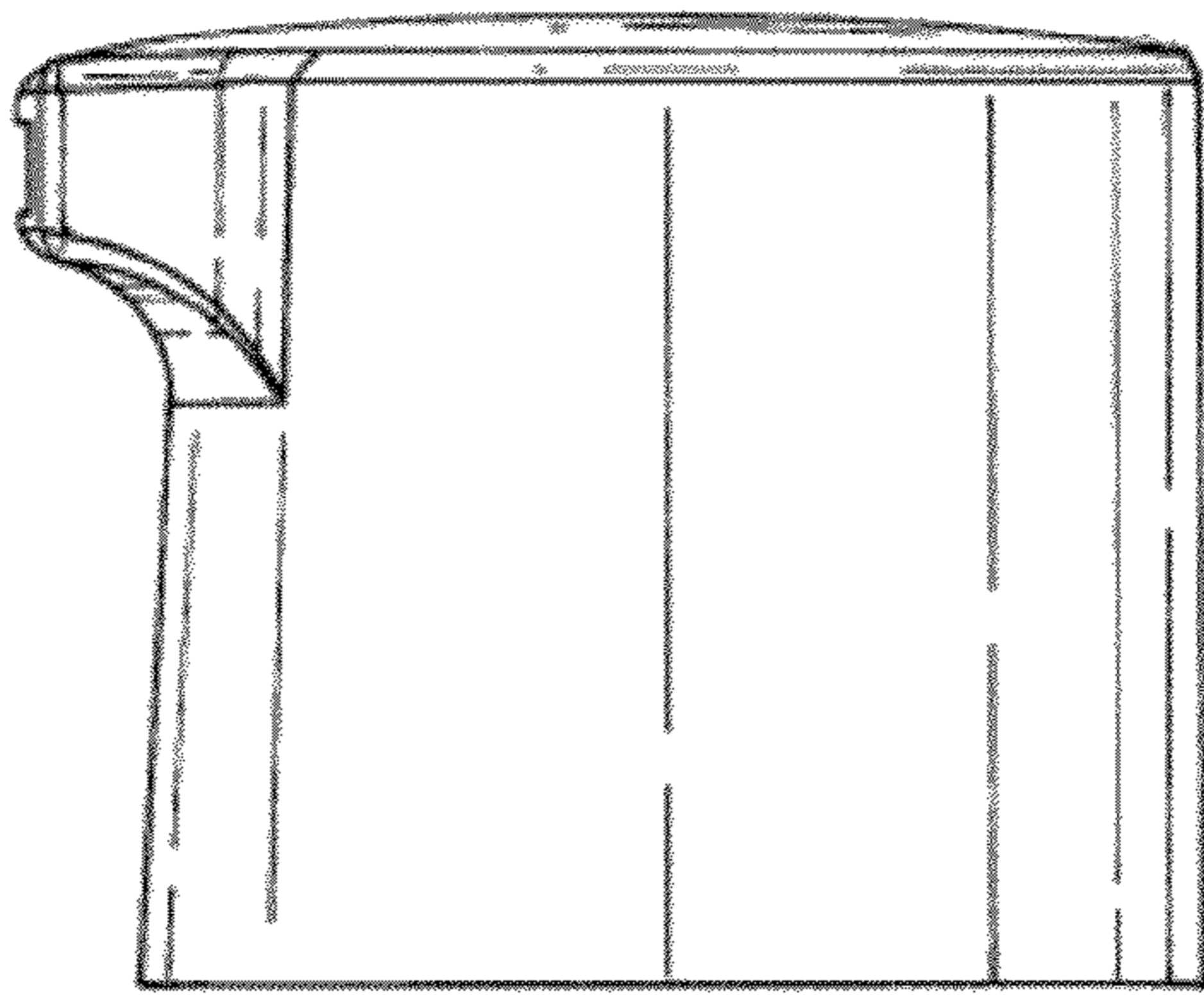

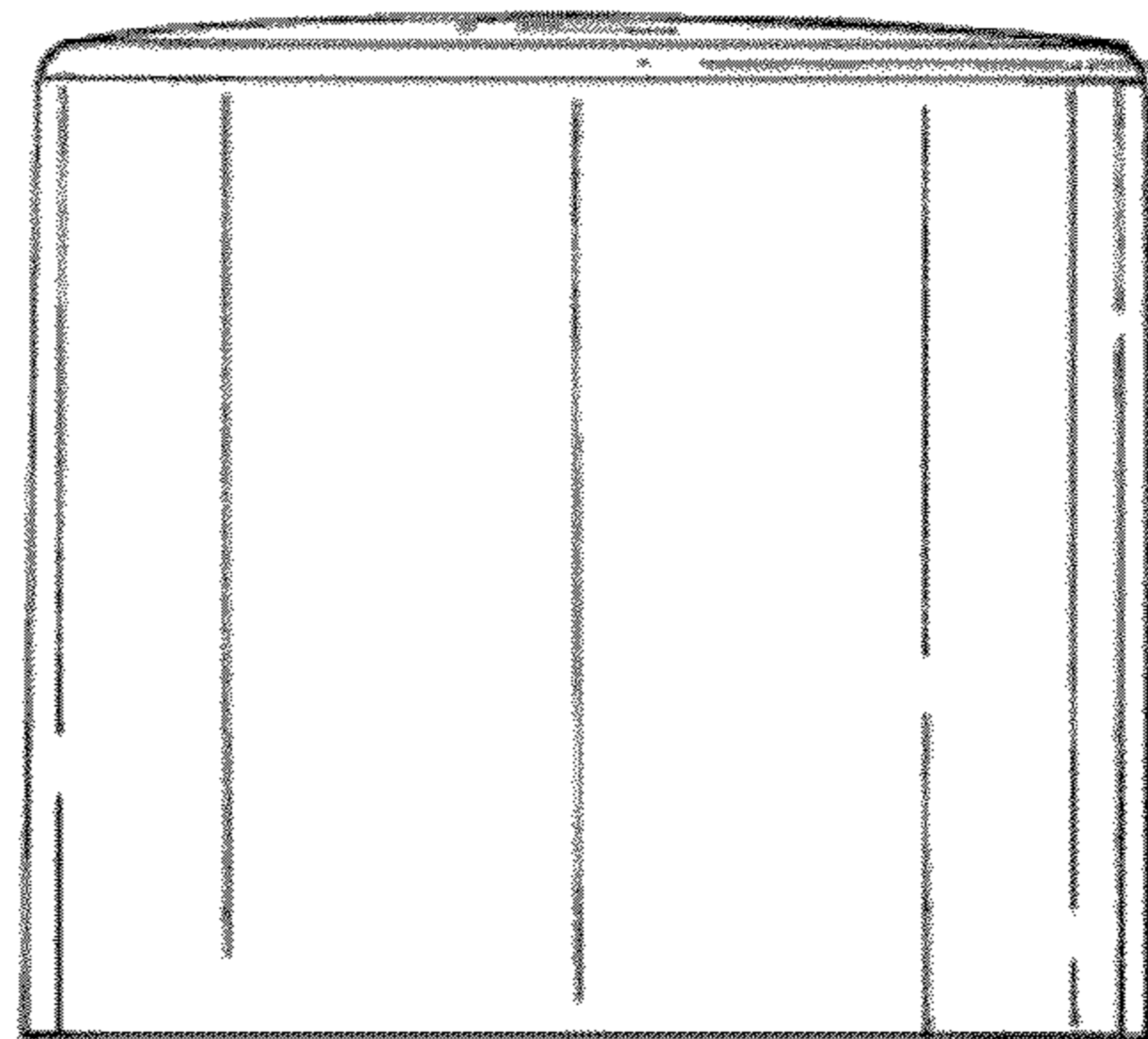

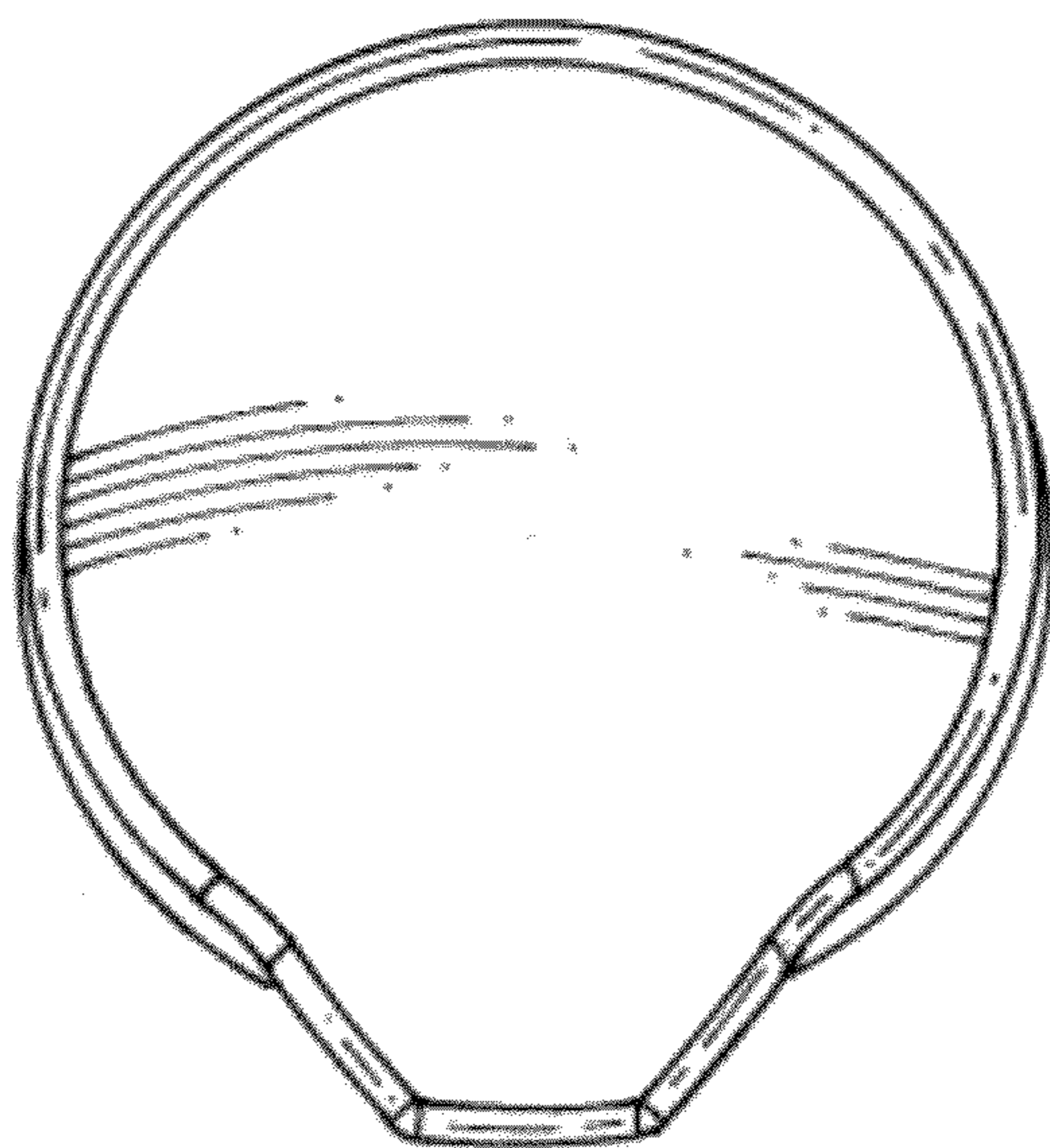

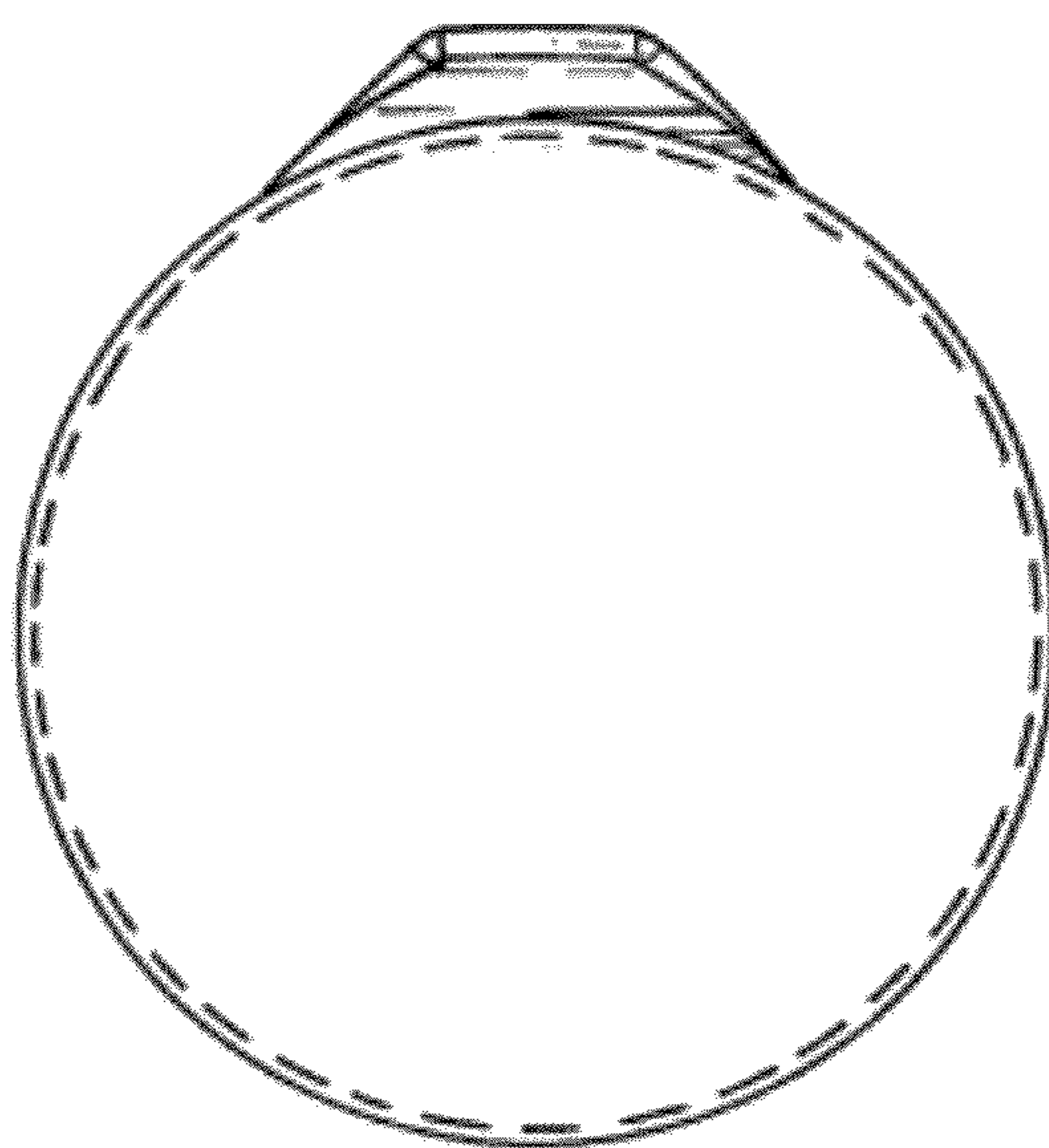
