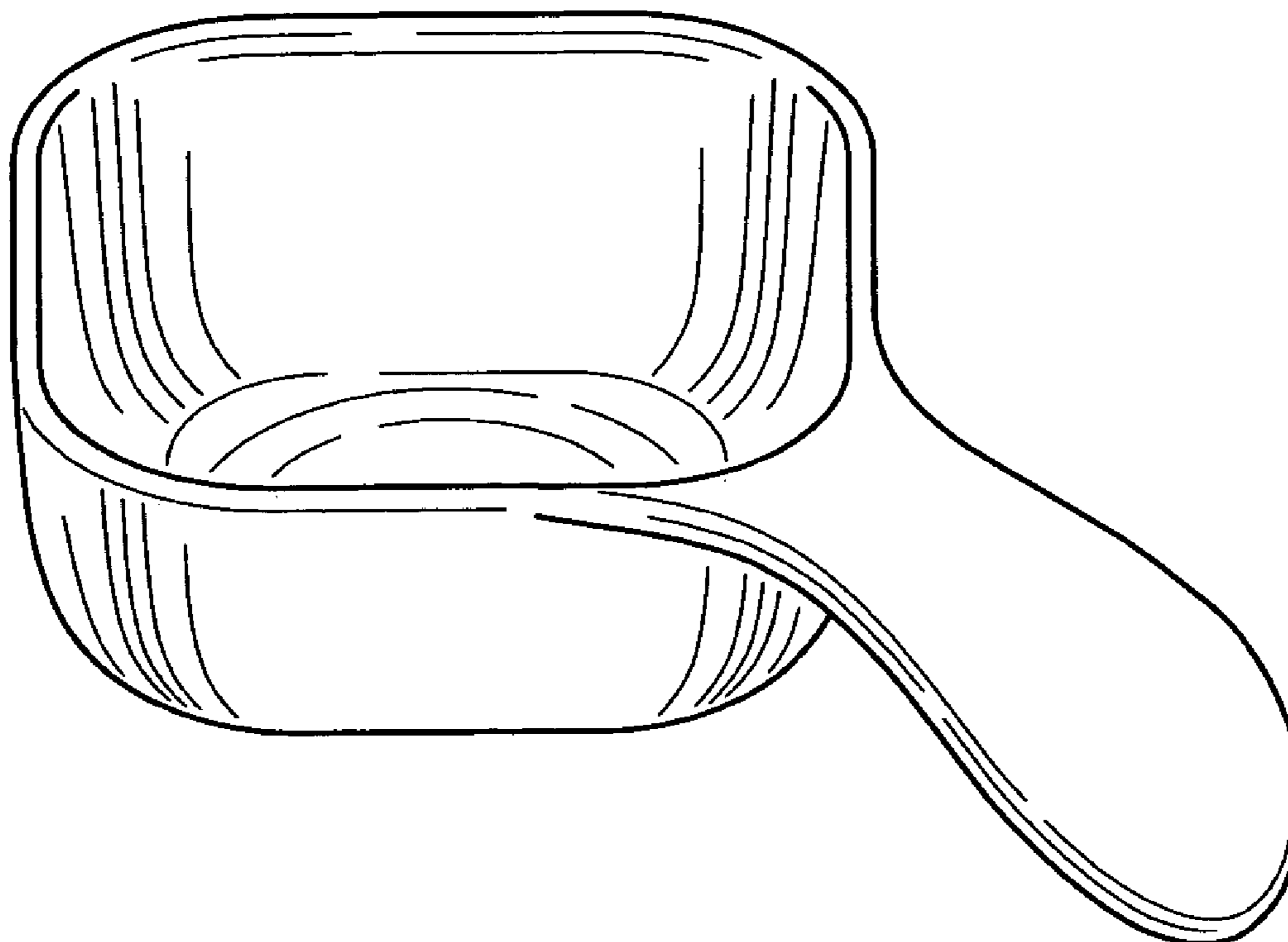

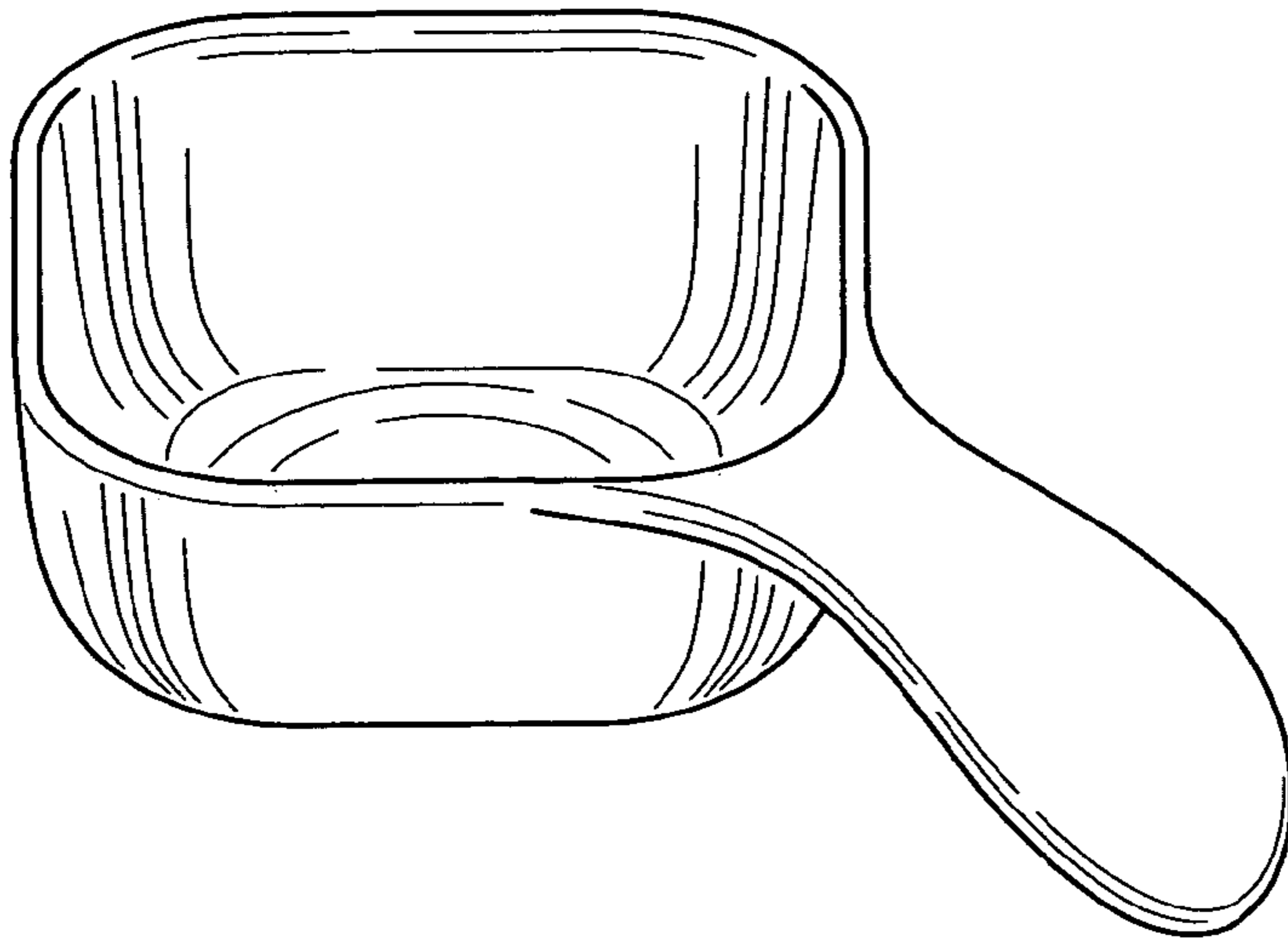
The ornamental design for measuring cup, as shown and described.

**DESCRIPTION**

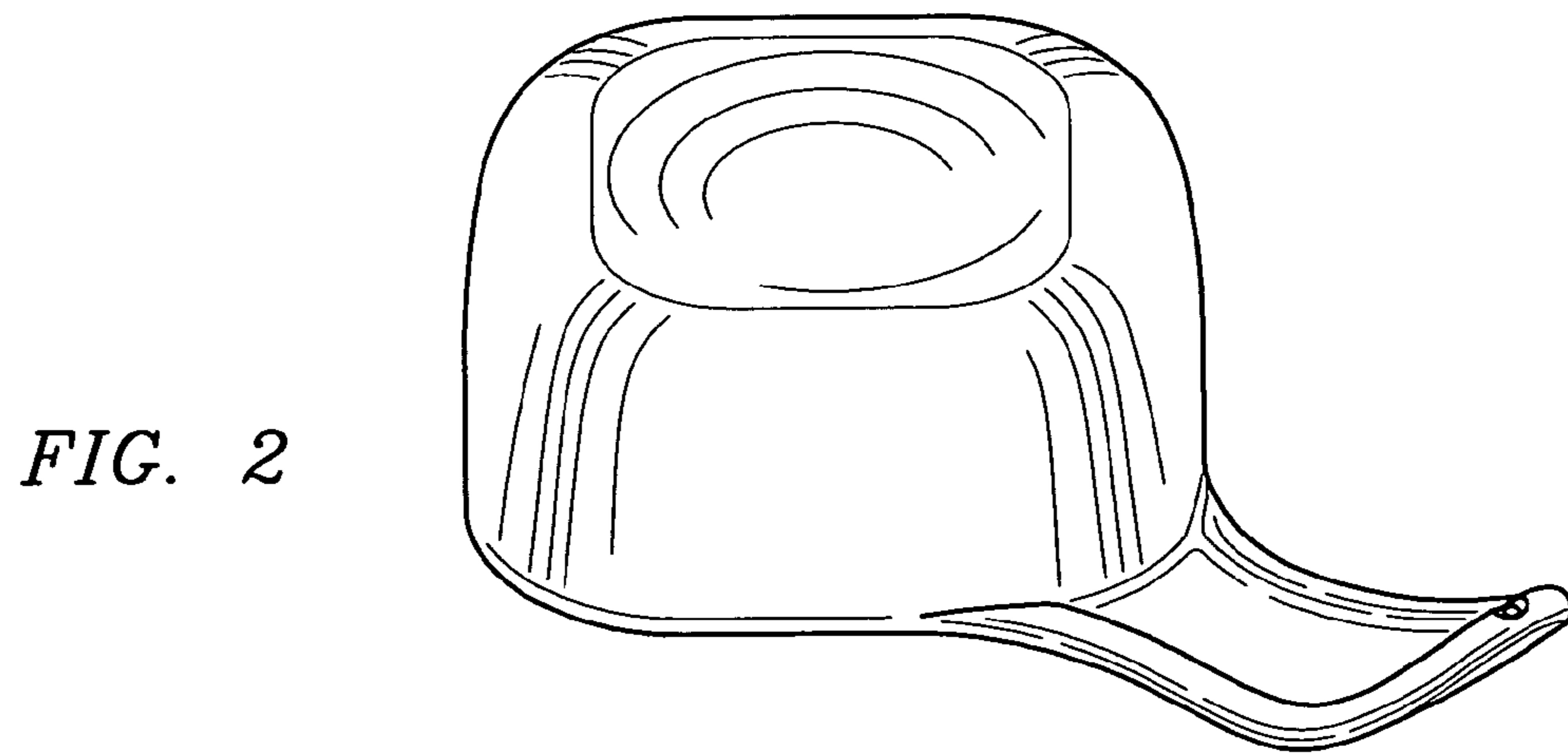
FIG. 1 is a top, side and front perspective view of measuring cup showing my new design;

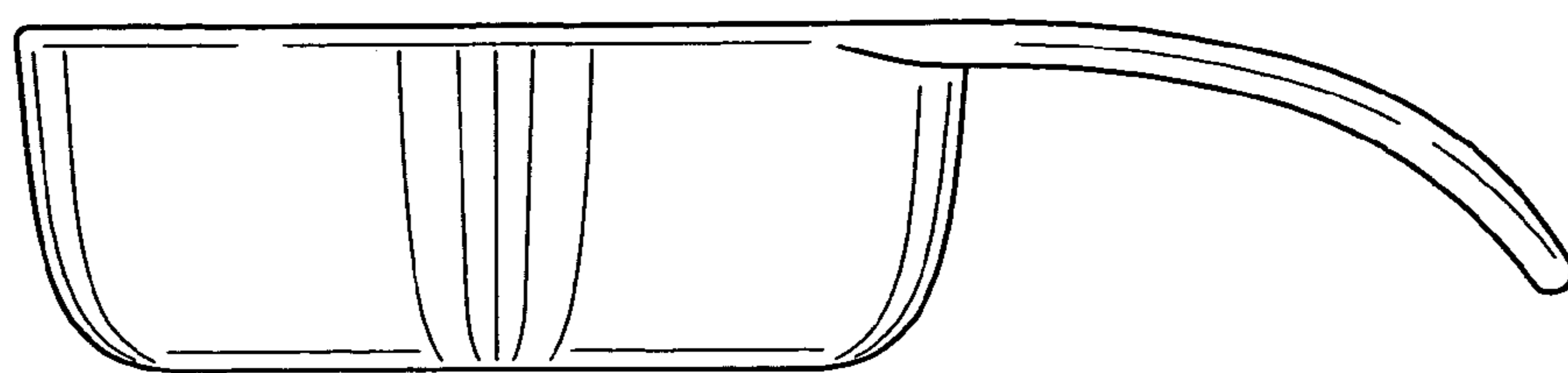

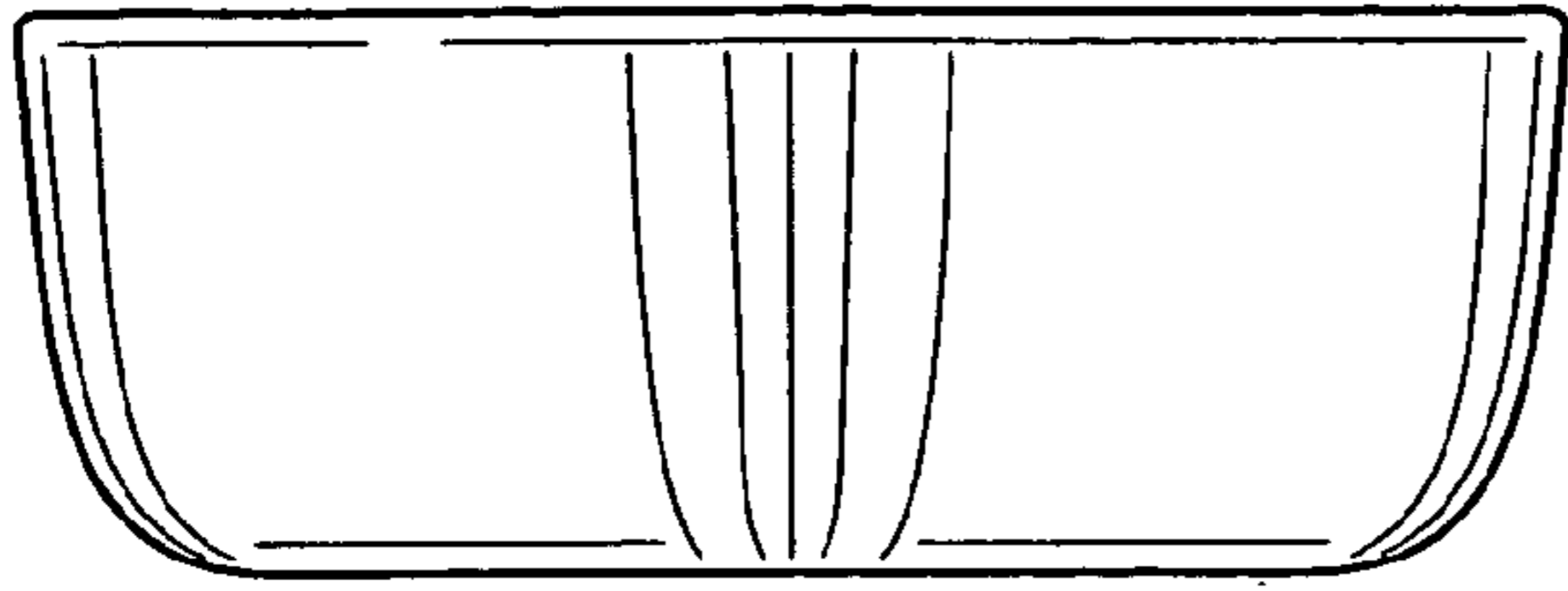

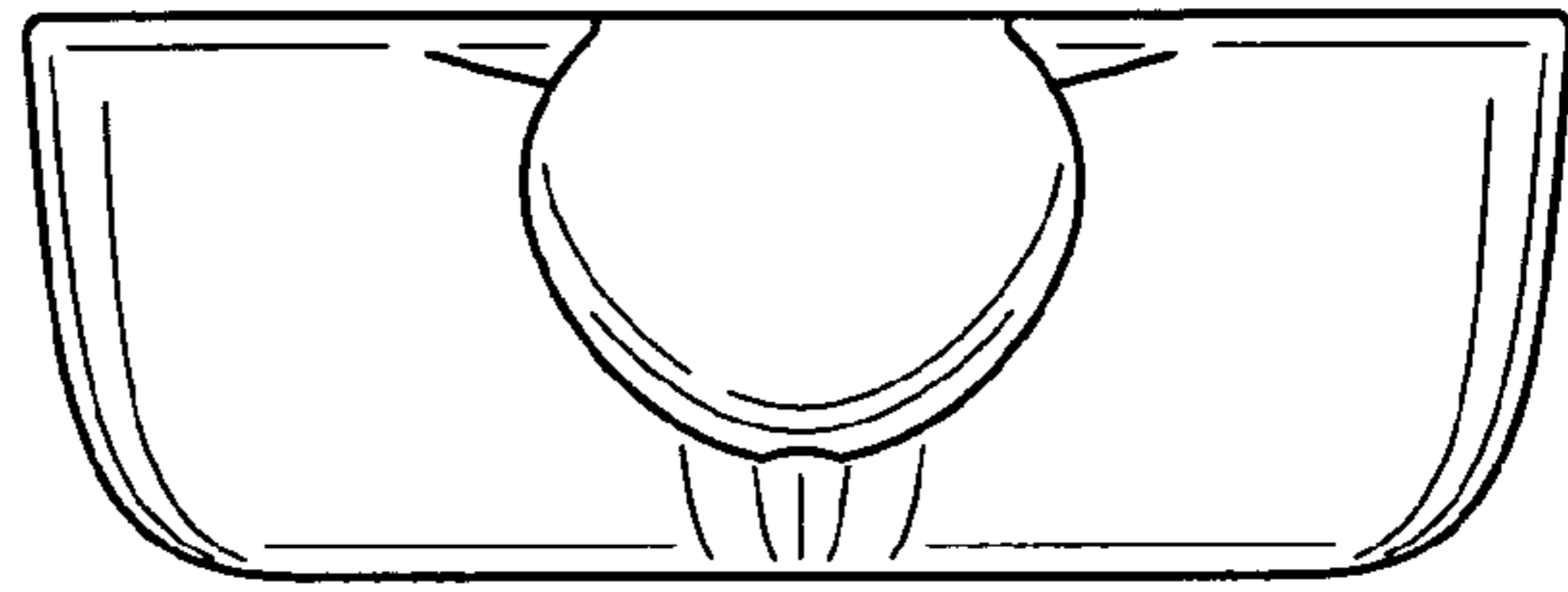

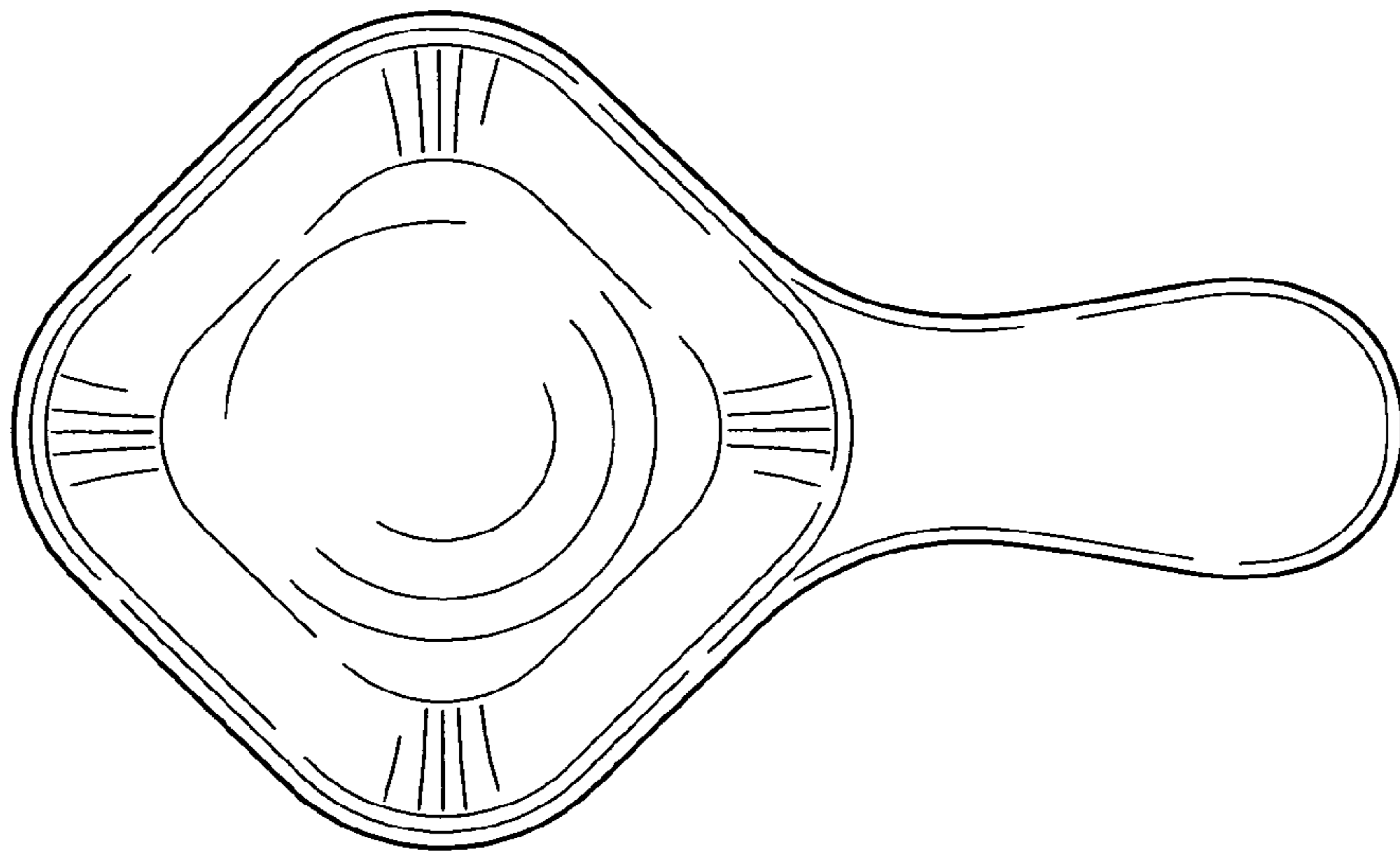

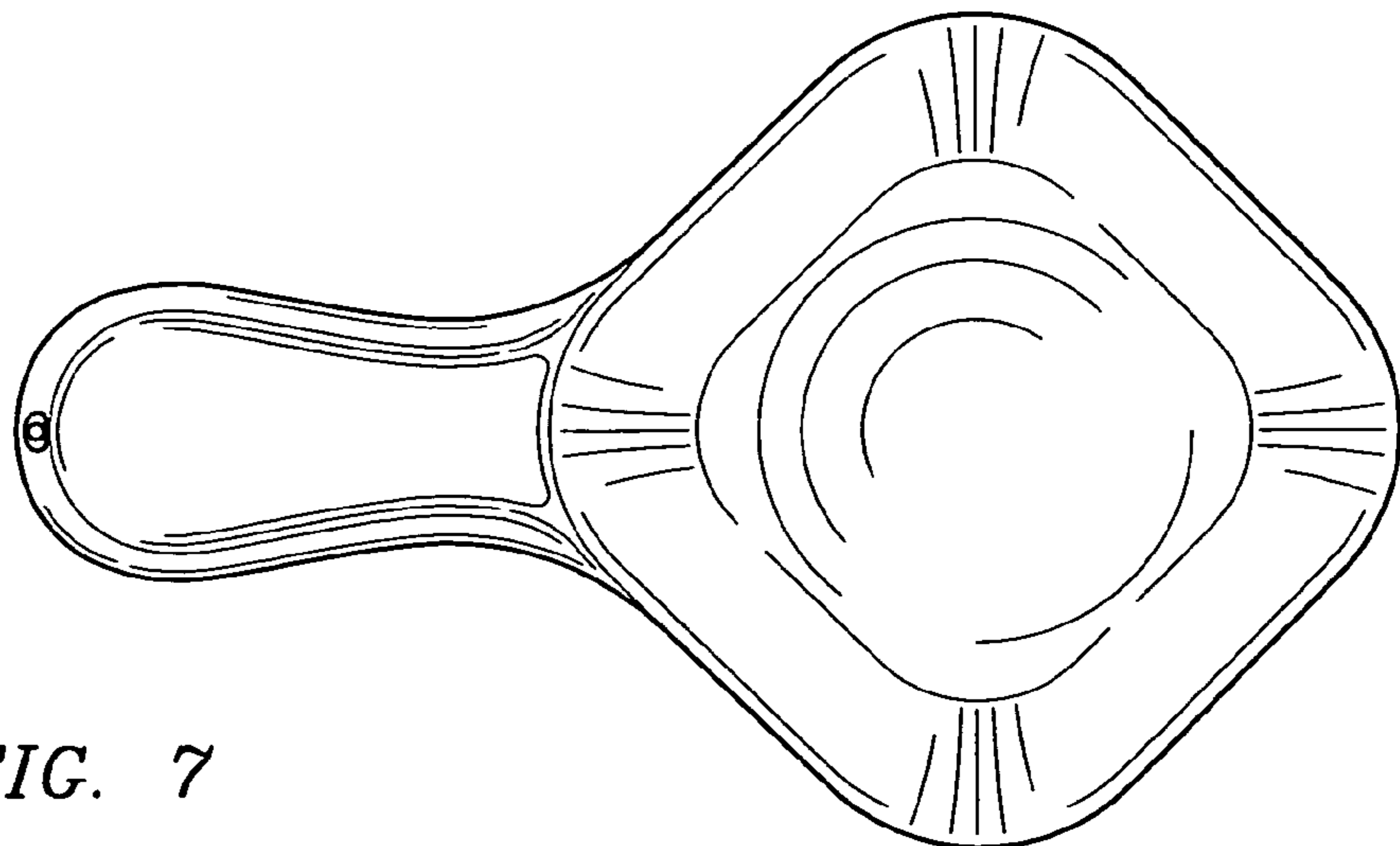
