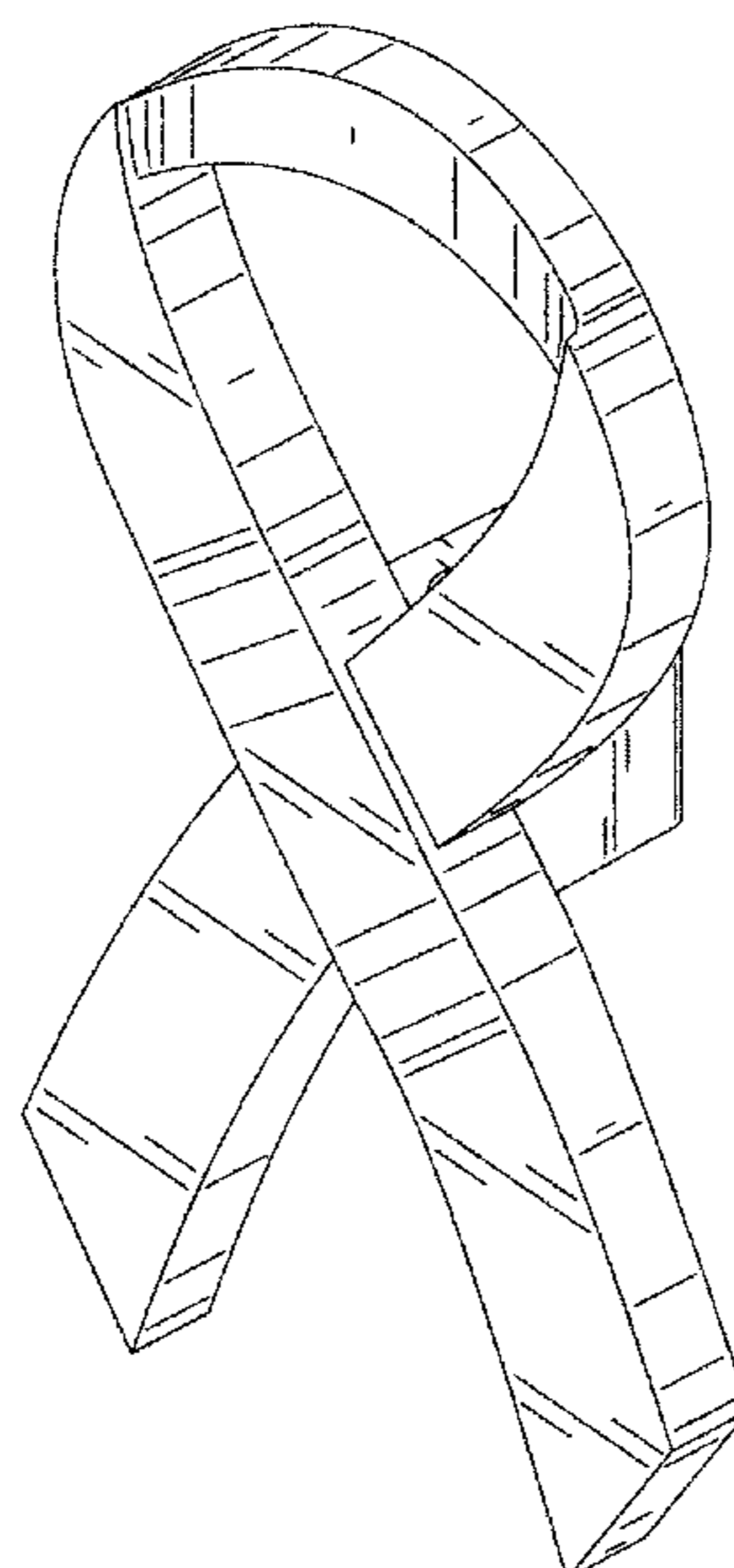
(57) **CLAIM**

The ornamental design for a ribbon display holder for a cord, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an embodiment of a ribbon display holder for a cord of the present invention; FIG. 2 is a front elevational view of the ribbon display holder for a cord of FIG. 1; FIG. 3 is a rear elevational view of the ribbon display holder for a cord of FIG. 1; FIG. 4 is a left side elevational view of the ribbon display holder for a cord of FIG. 1; FIG. 5 is a right side elevational view of the ribbon display holder for a cord of FIG. 1; FIG. 6 is a top plan view of the ribbon display holder for a cord of FIG. 1; and, FIG. 7 is a bottom plan view of the ribbon display holder for a cord of FIG. 1.

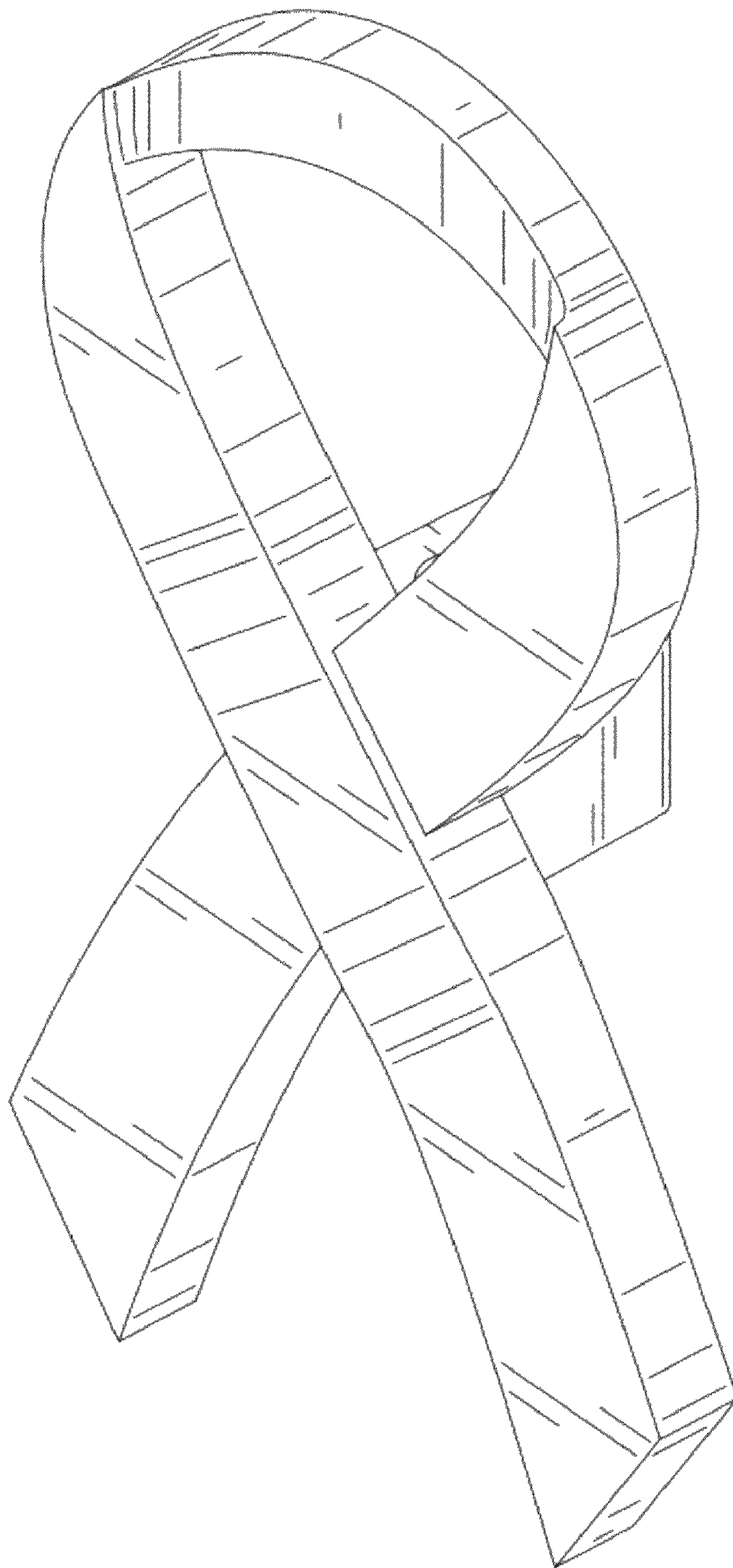

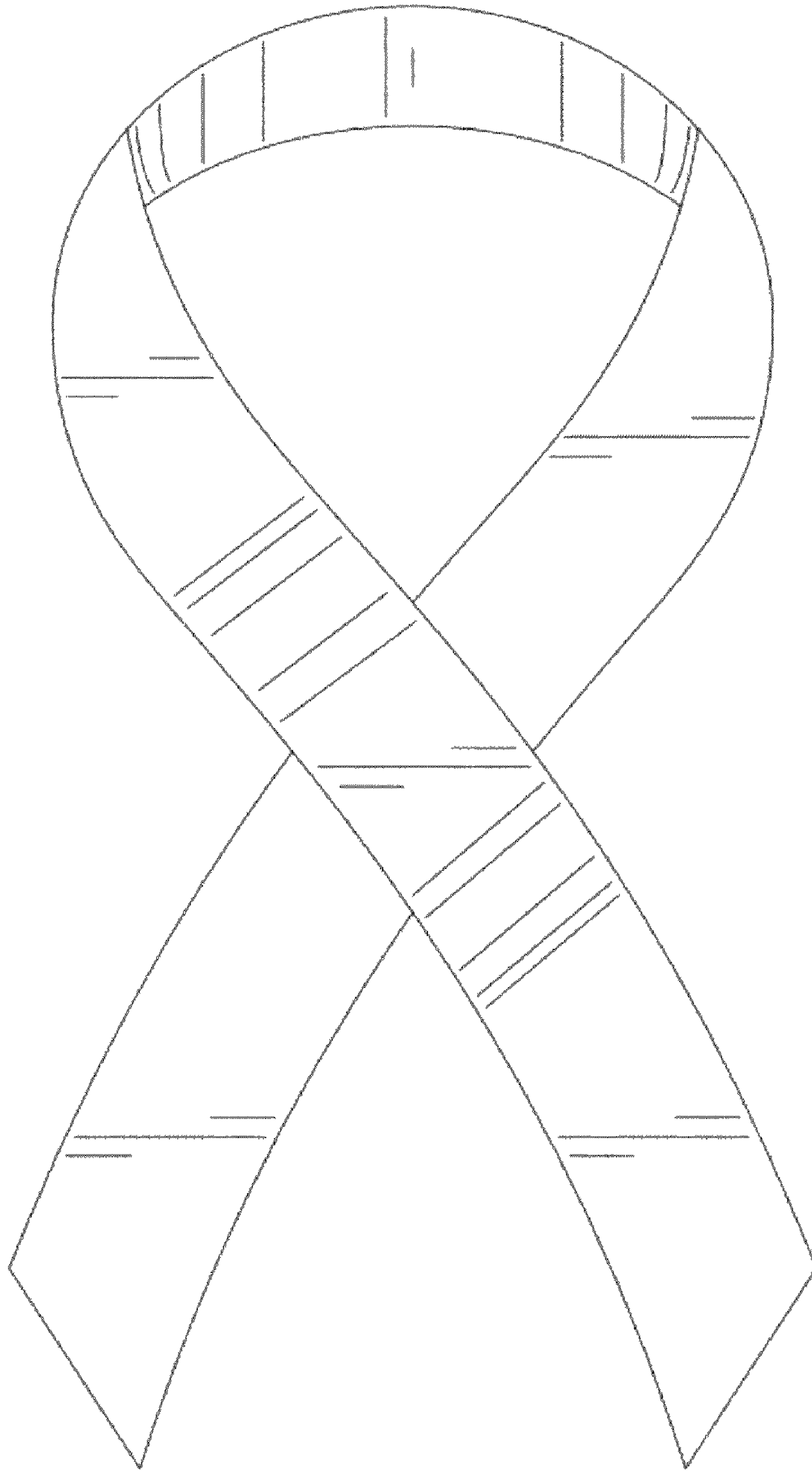

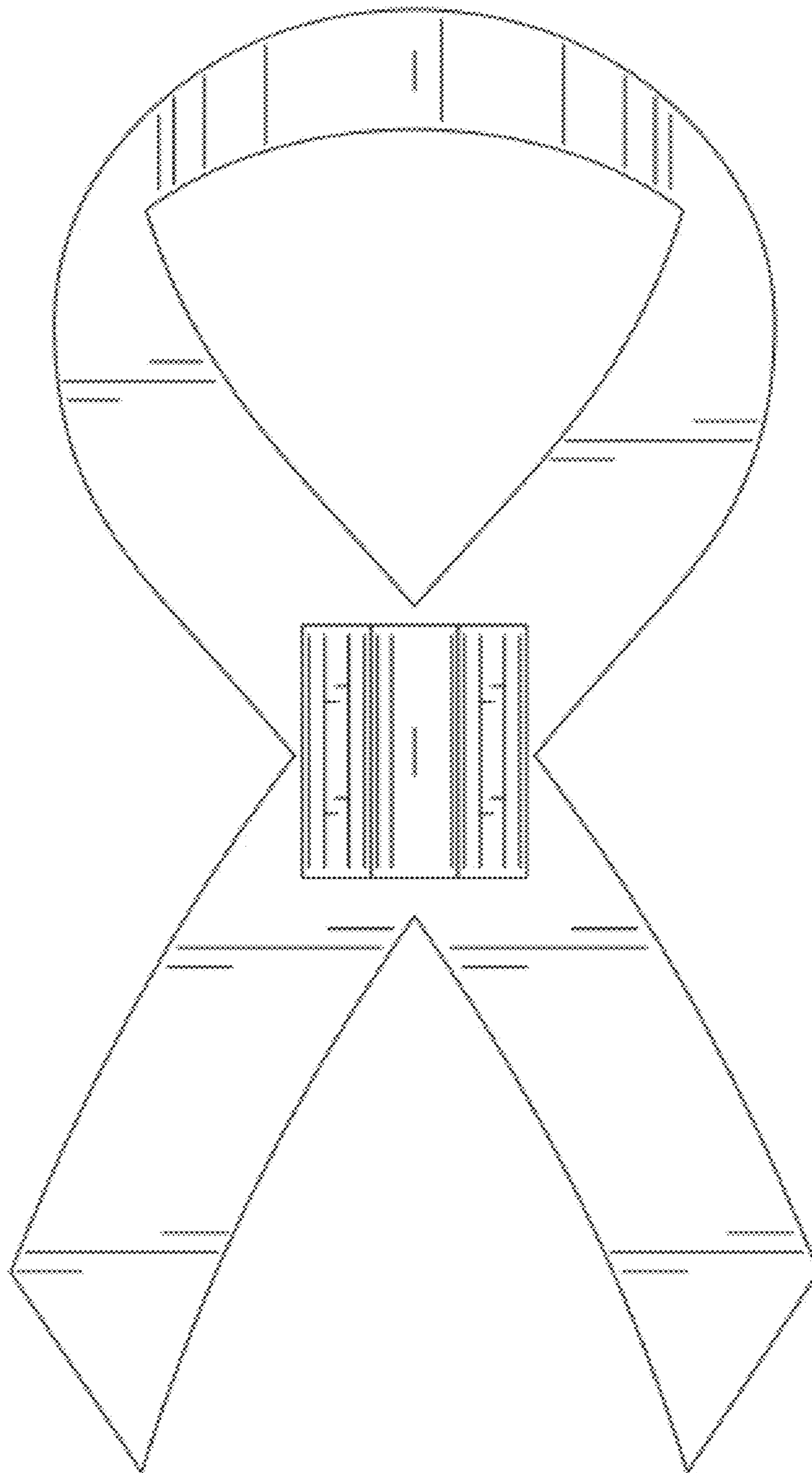

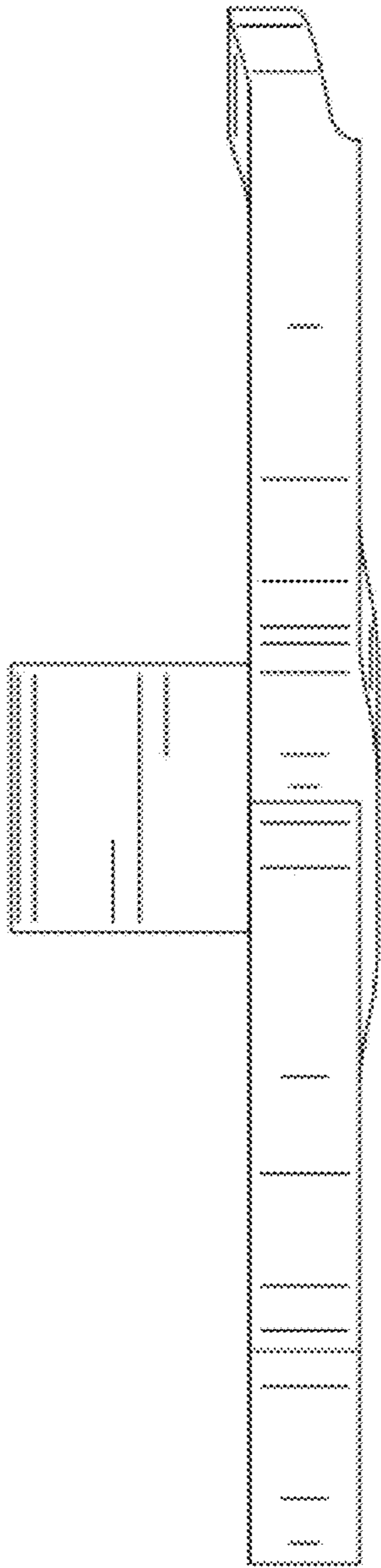

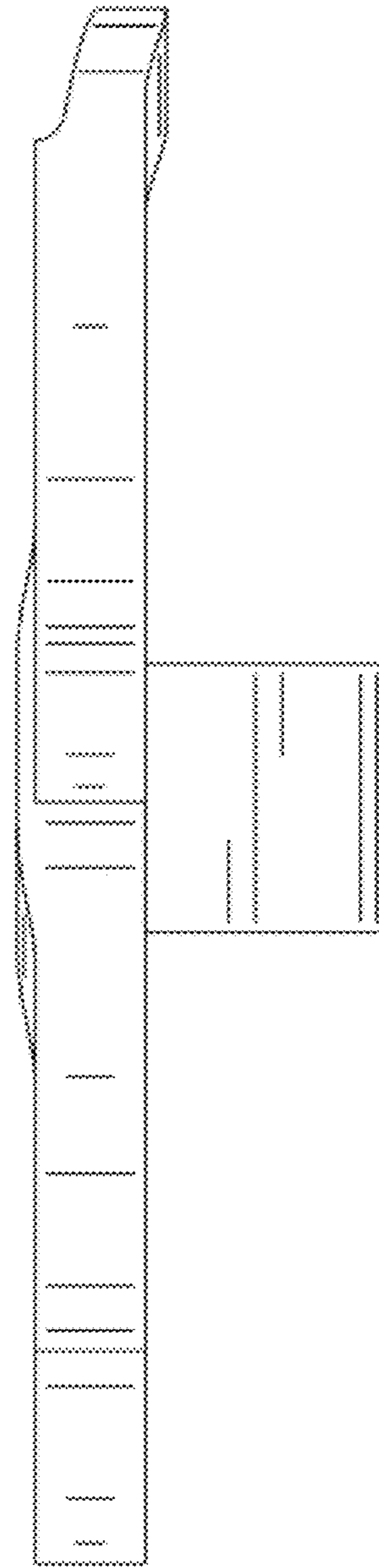

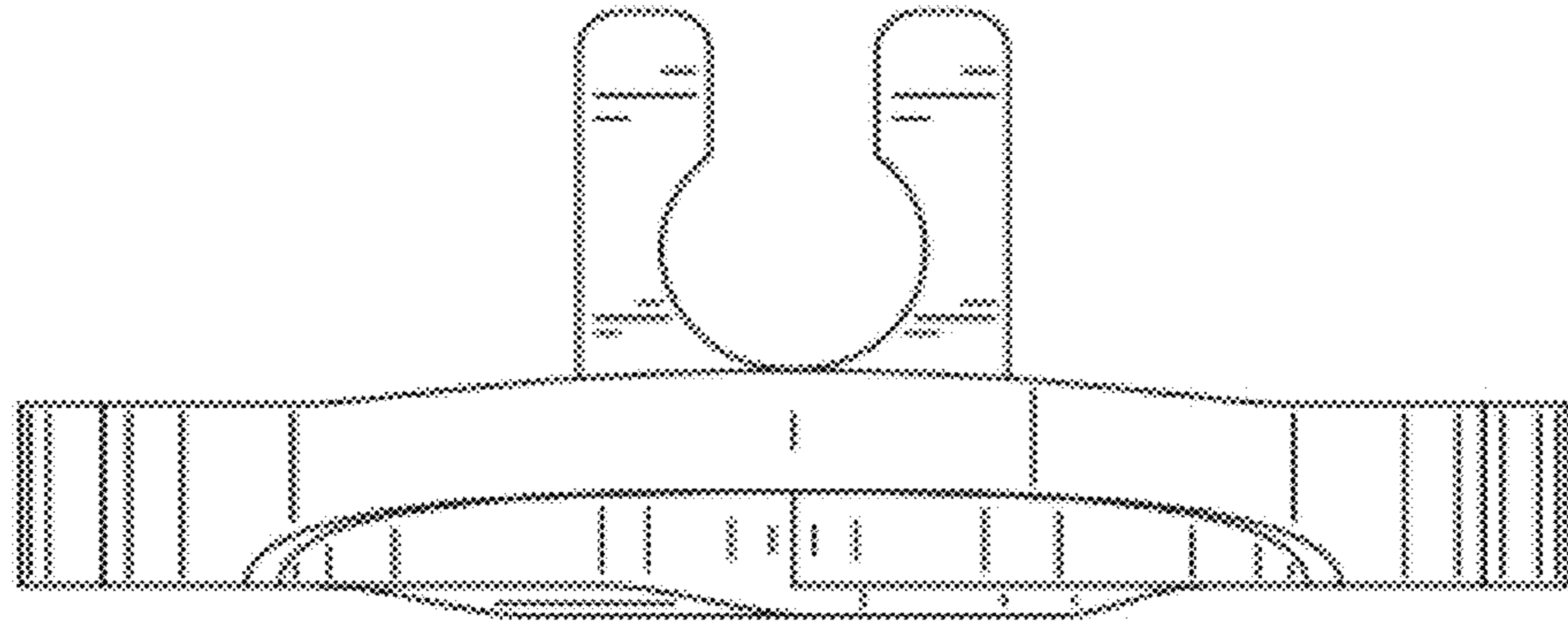

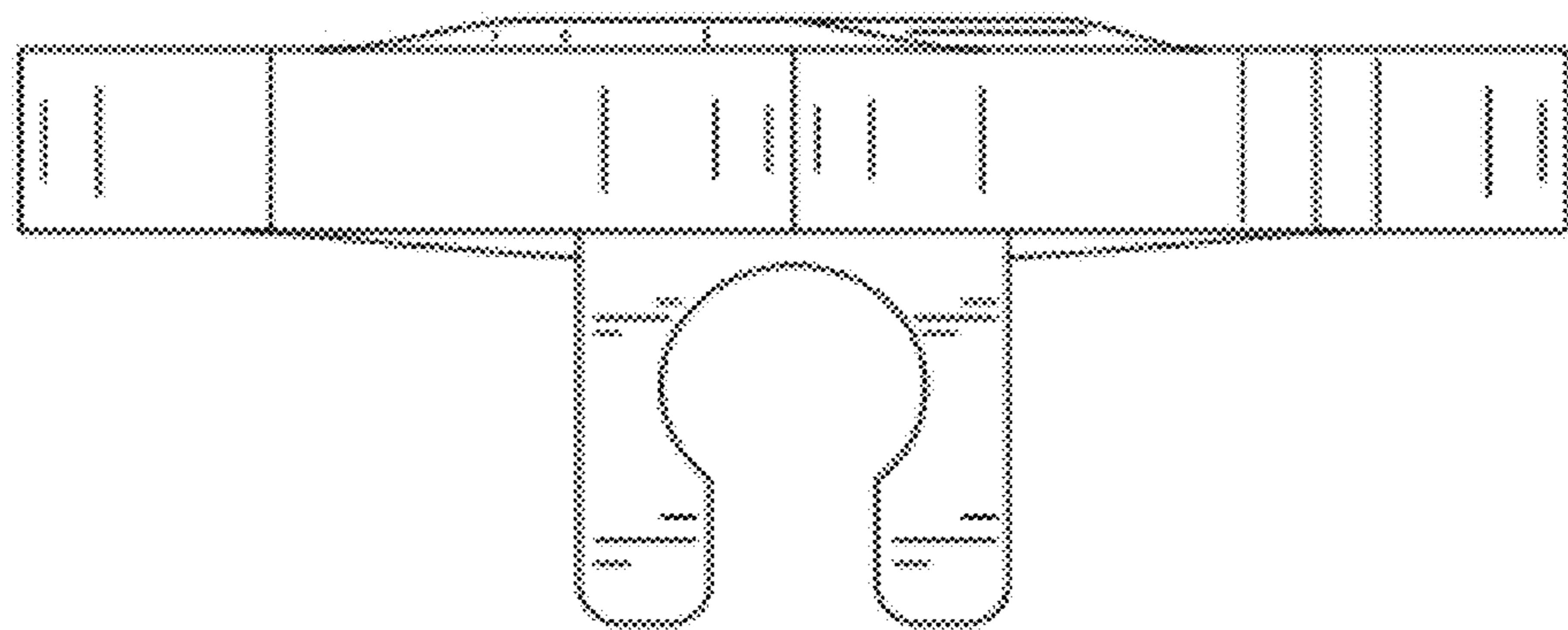
