DESCRIPTION

FIG. 1 is a front left perspective view of a first embodiment of
an automobile and/or toy replica thereof of our new design;

FIG. 3 is a left side view thereof;

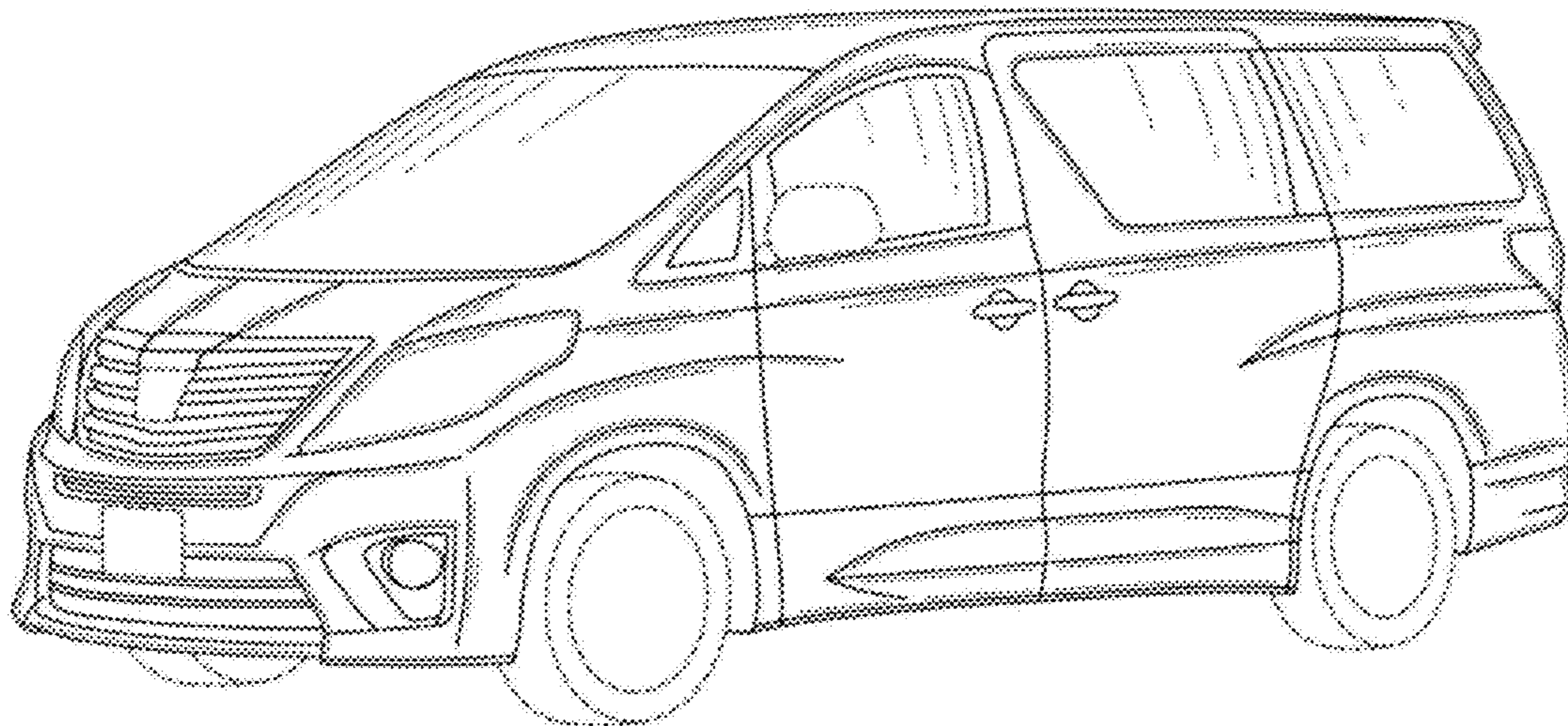
FIG. 4 is a right side view thereof;

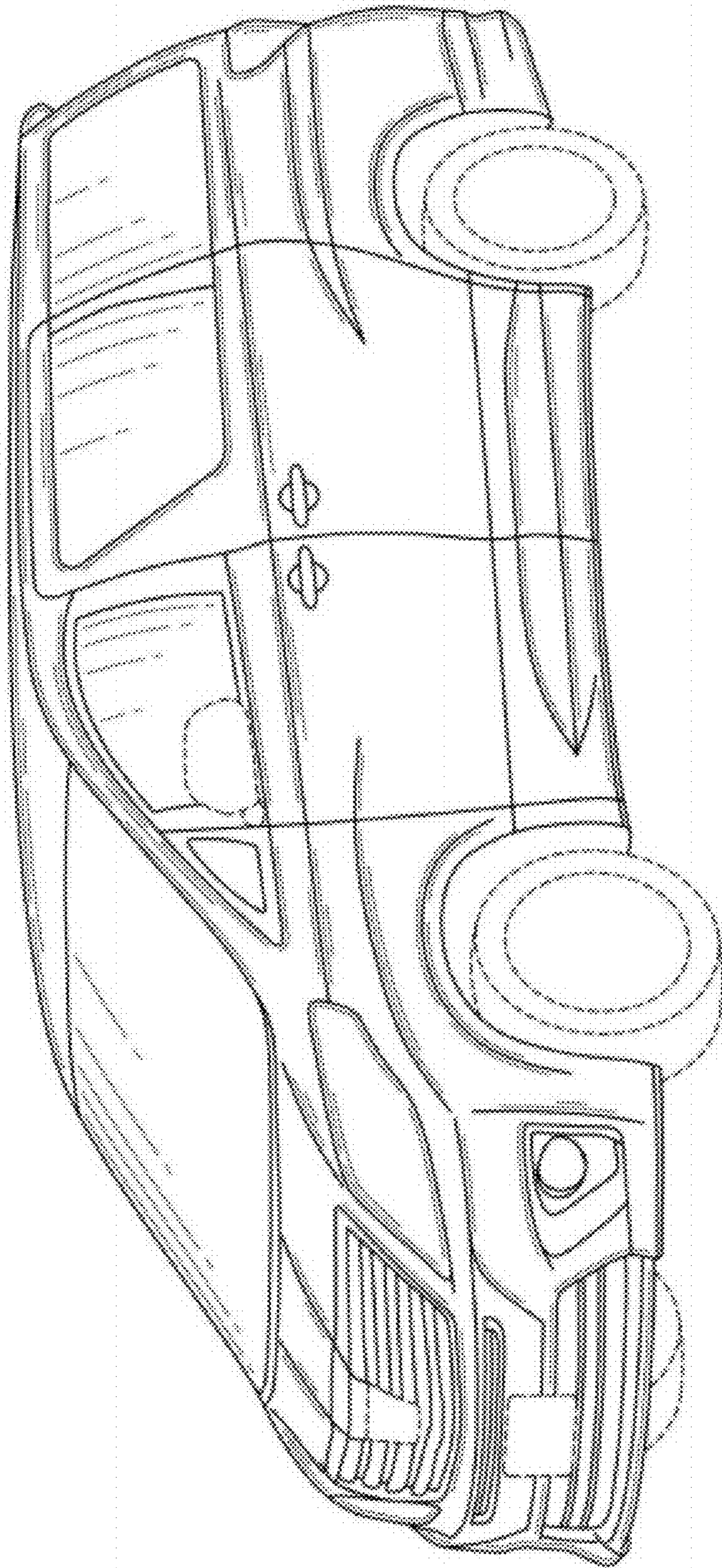

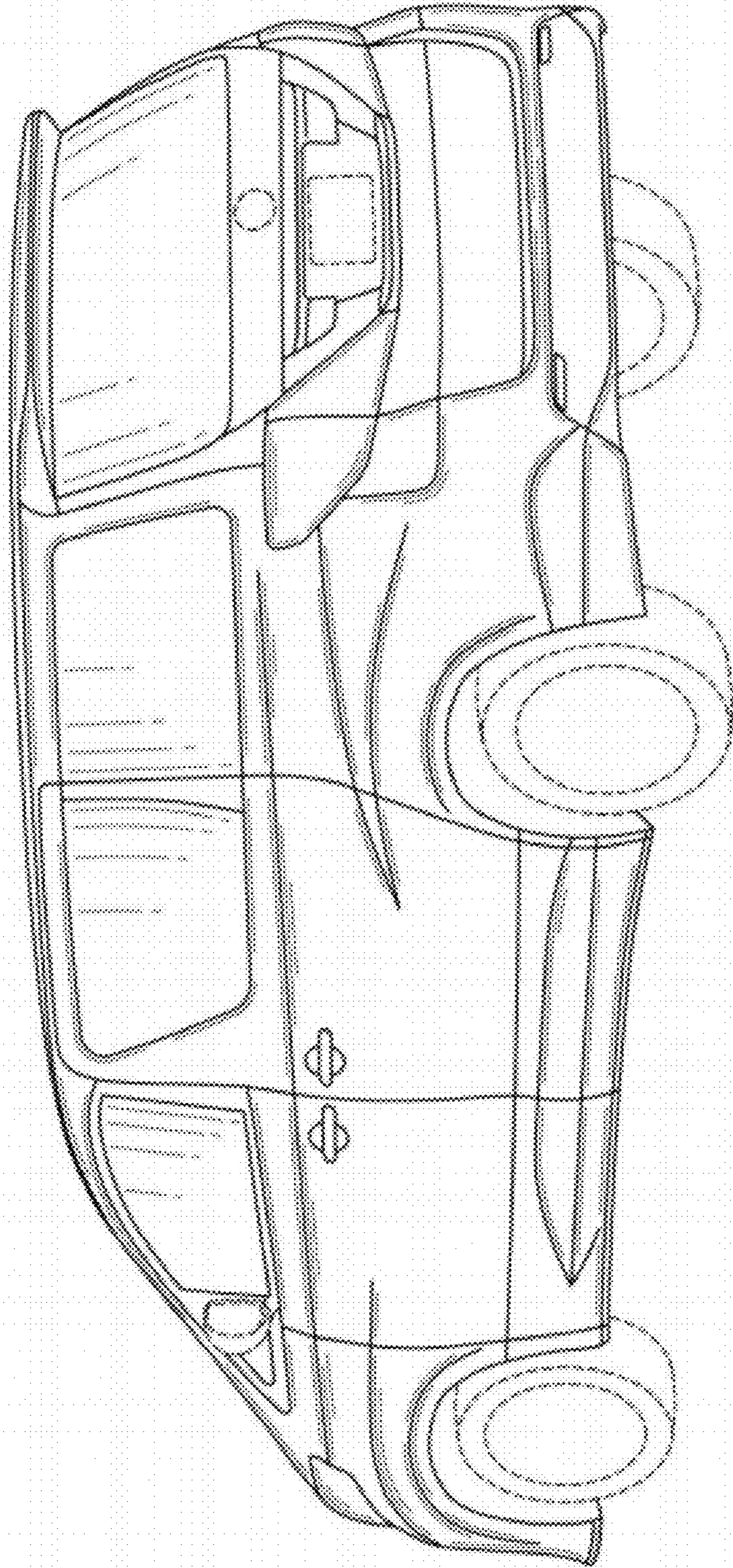

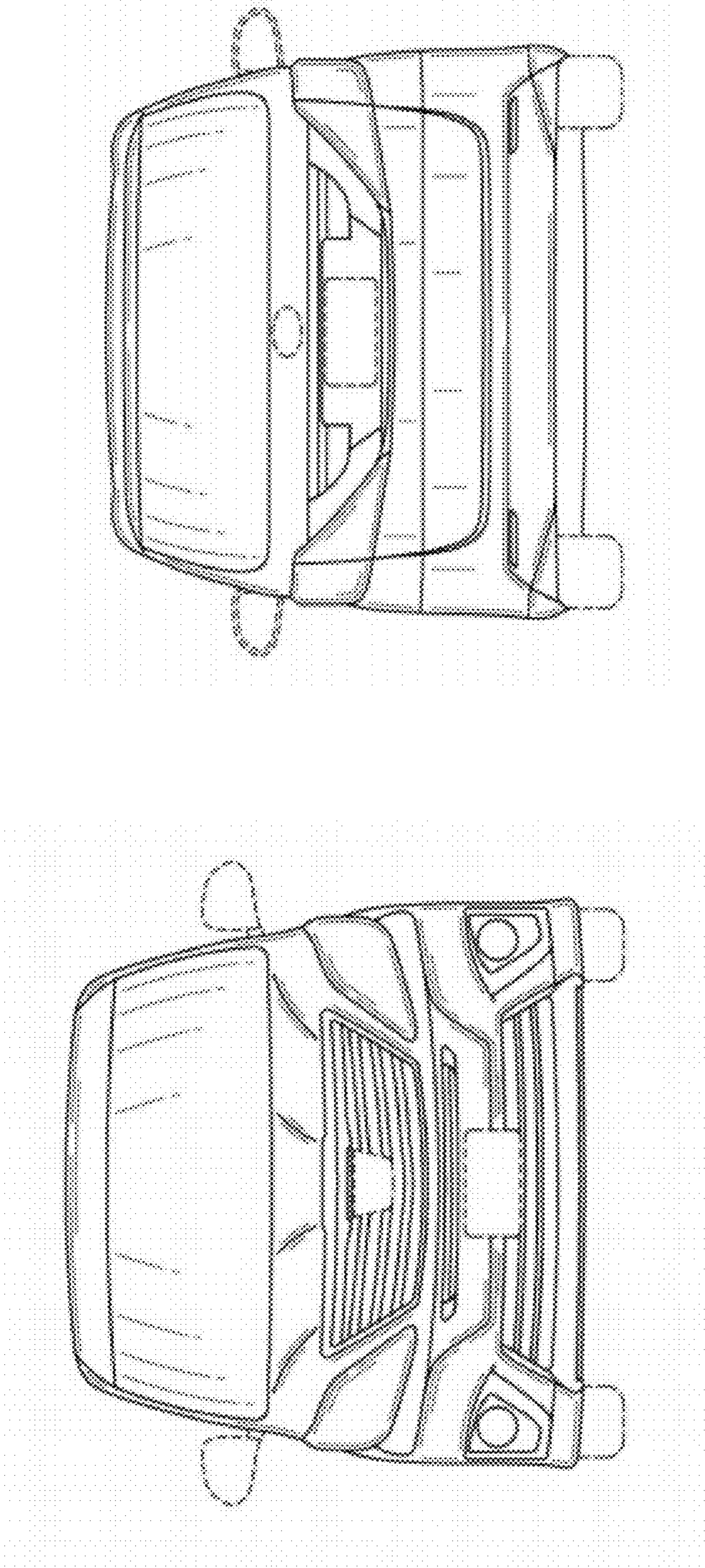

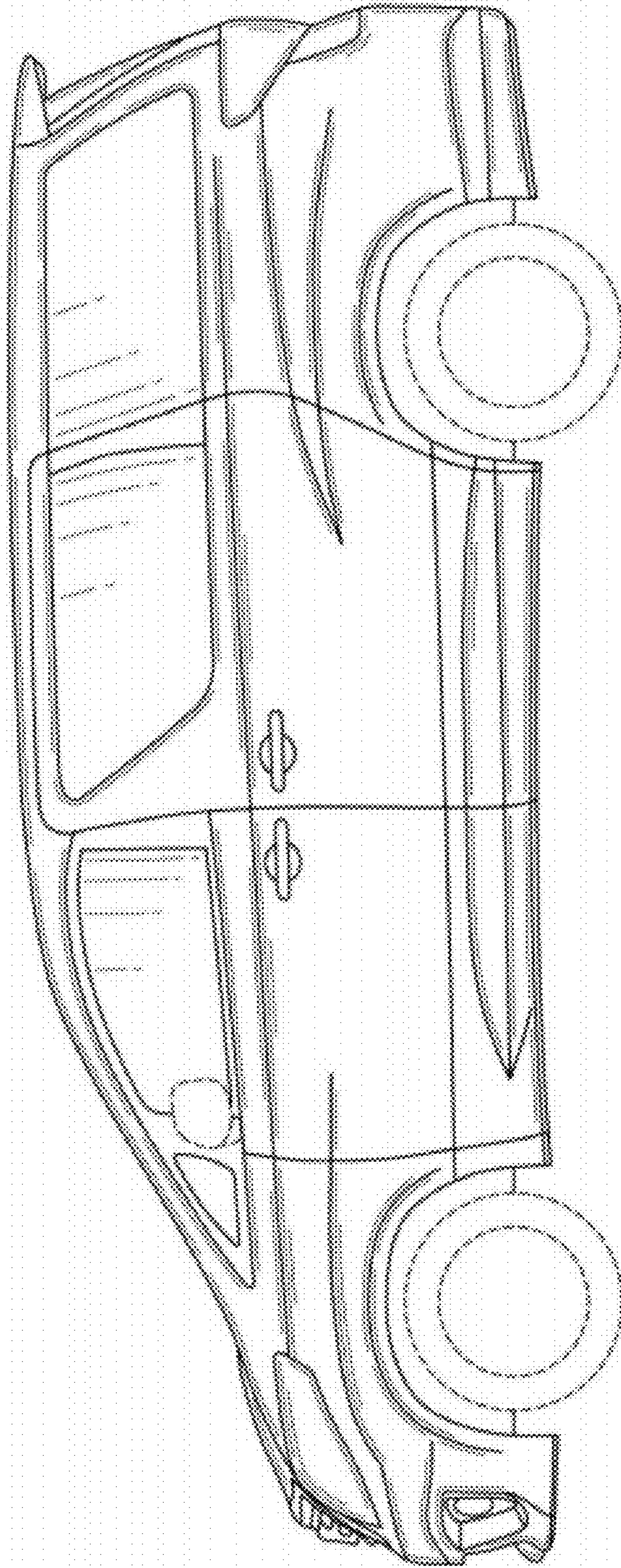

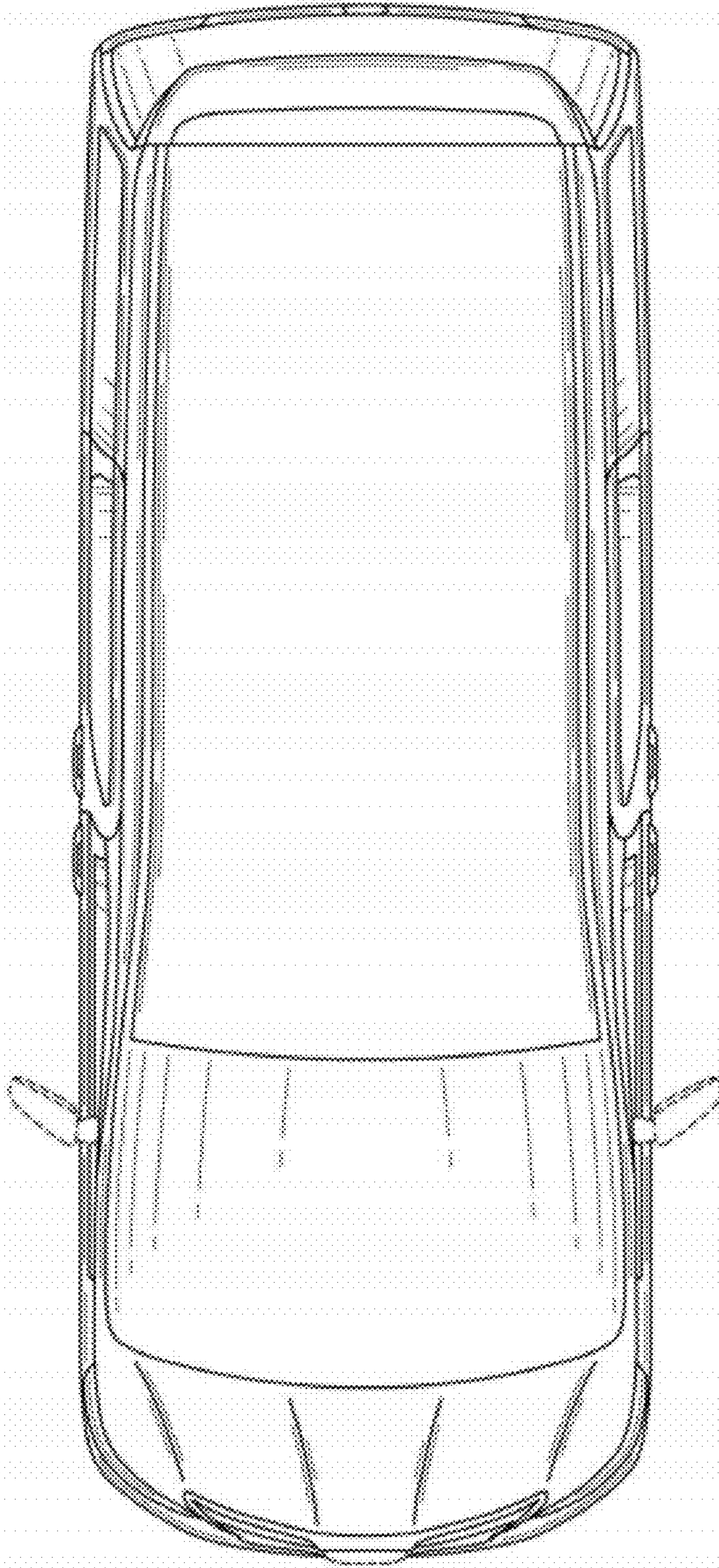
