This application contains subject matter related to the following co-pending U.S. design patent application:

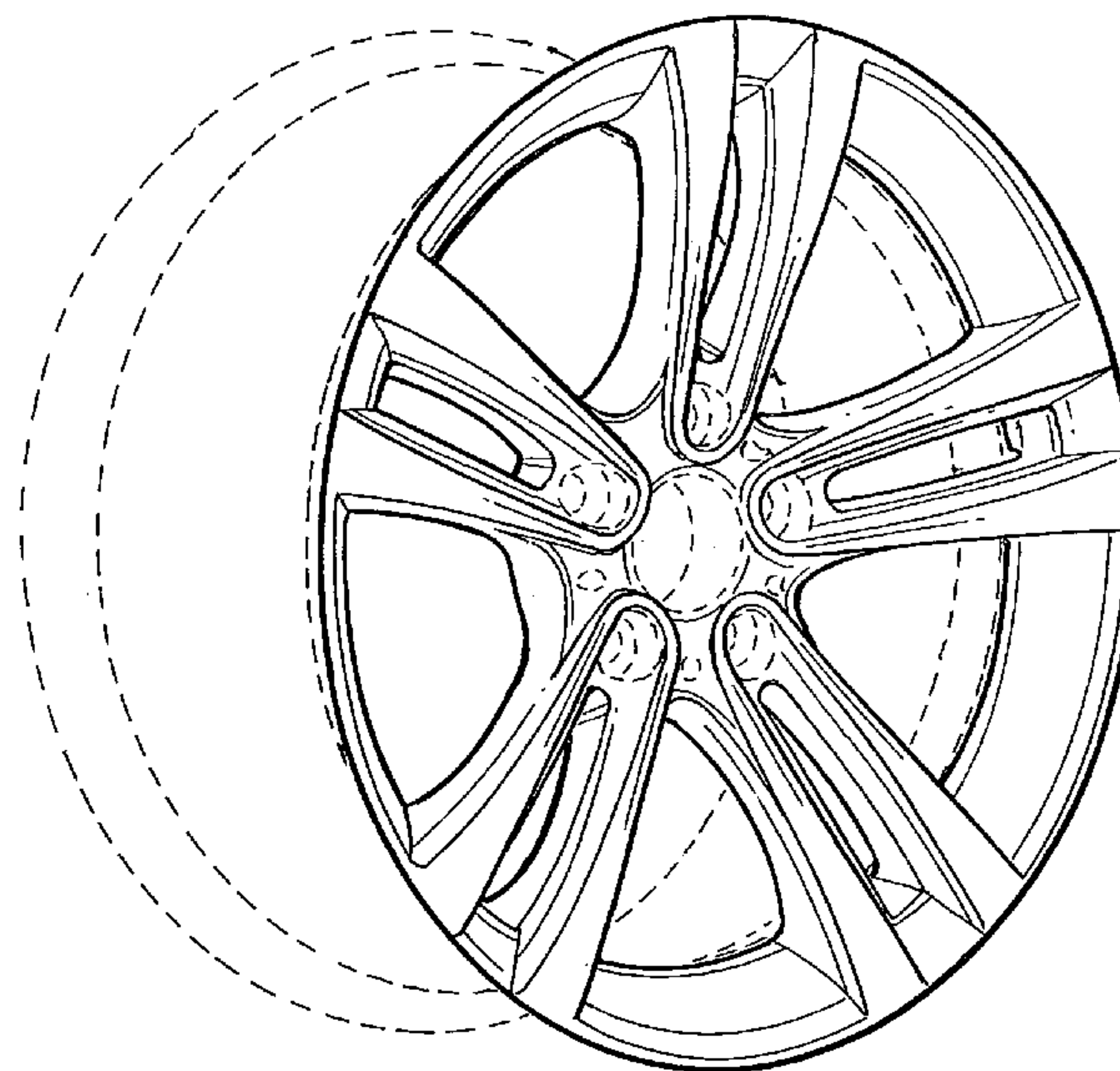
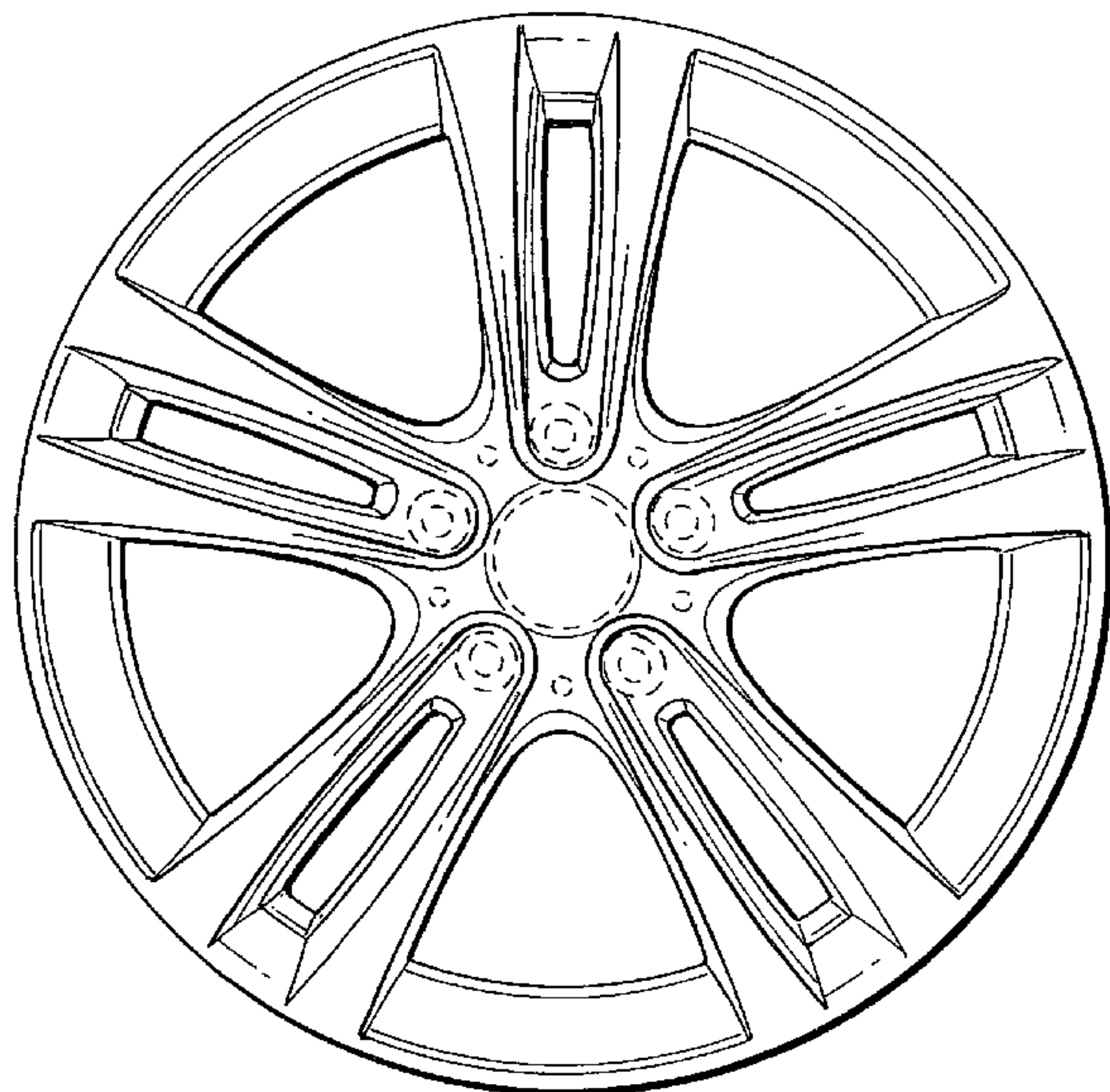
Application Ser. No. 29/347,270, filed Nov. 19, 2009 and entitled "Wheel or Wheel Cover."

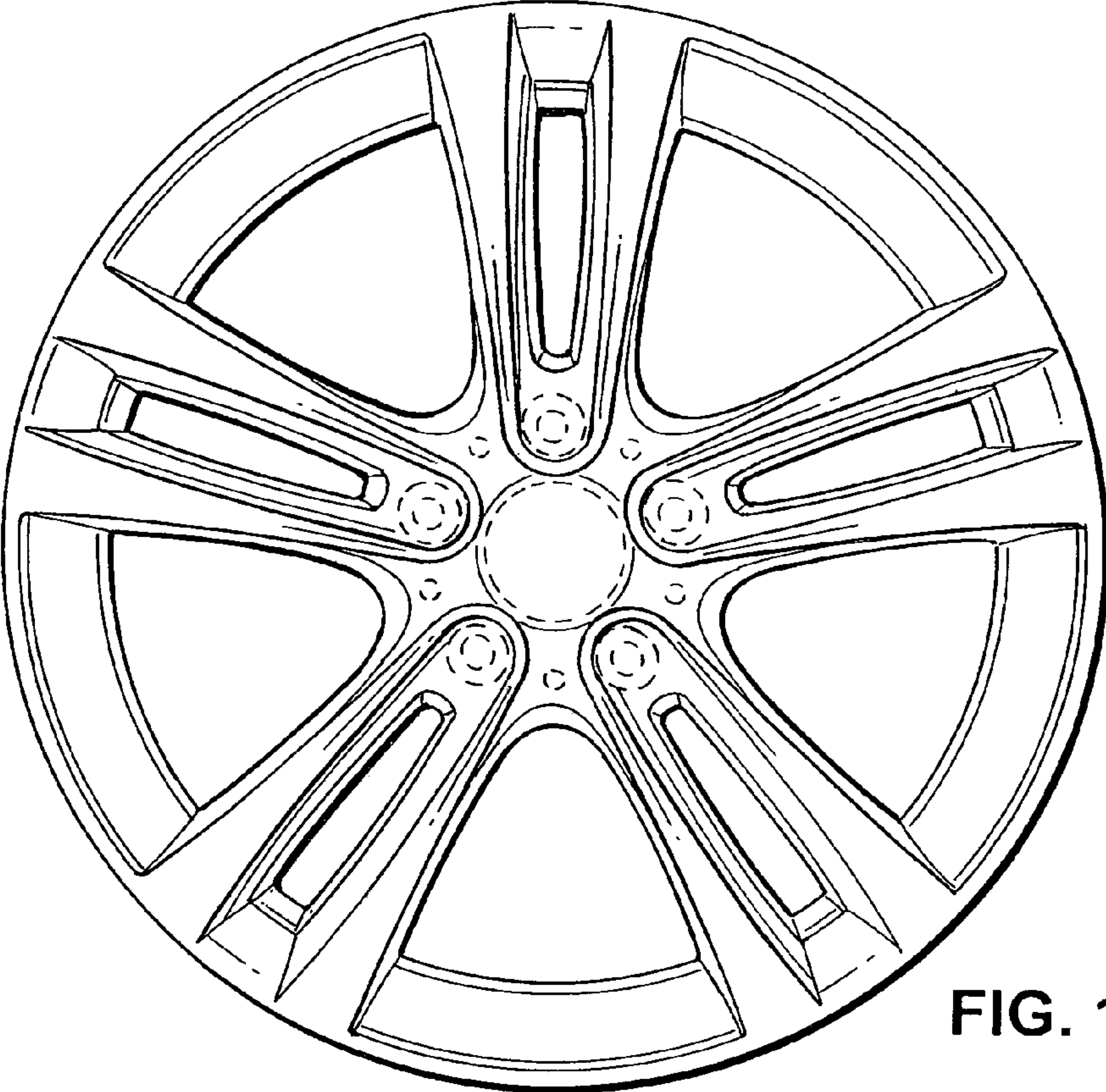

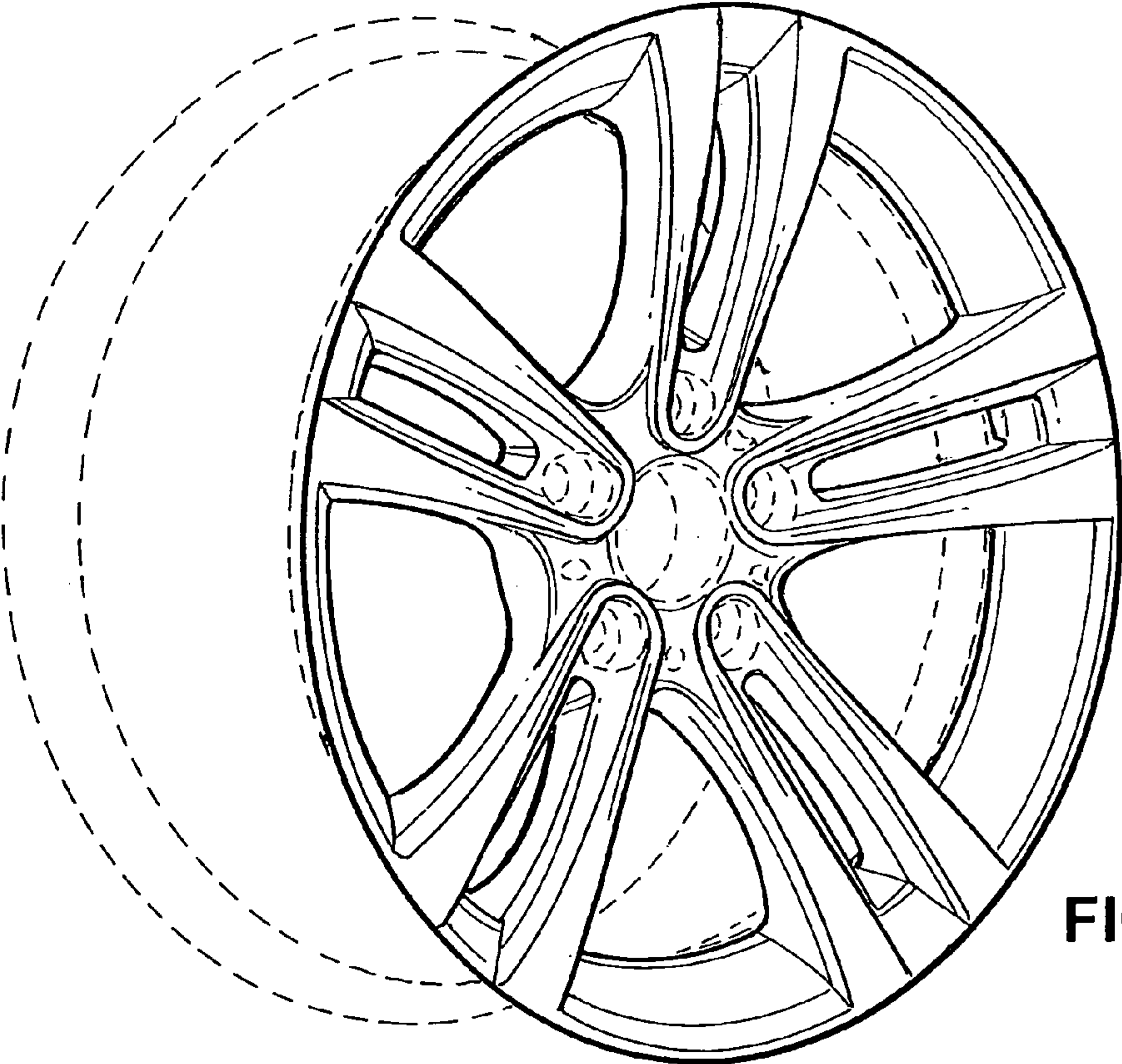
