(57) **CLAIM**

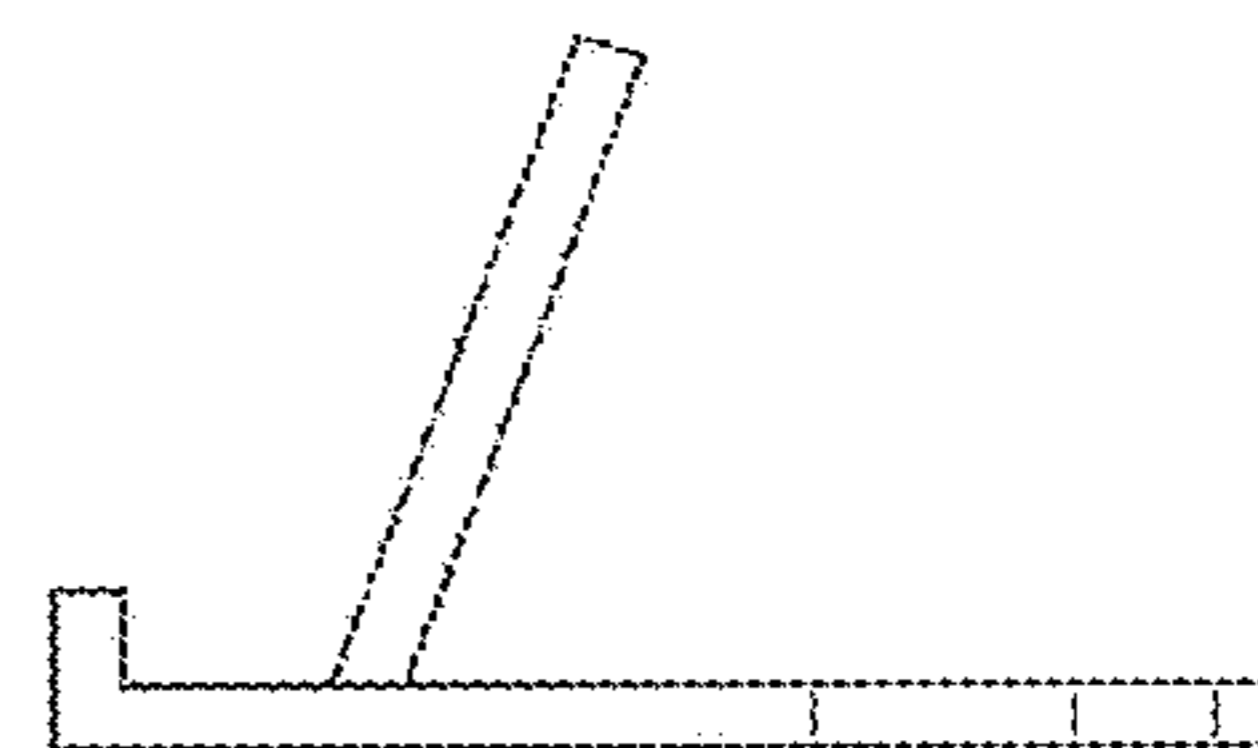
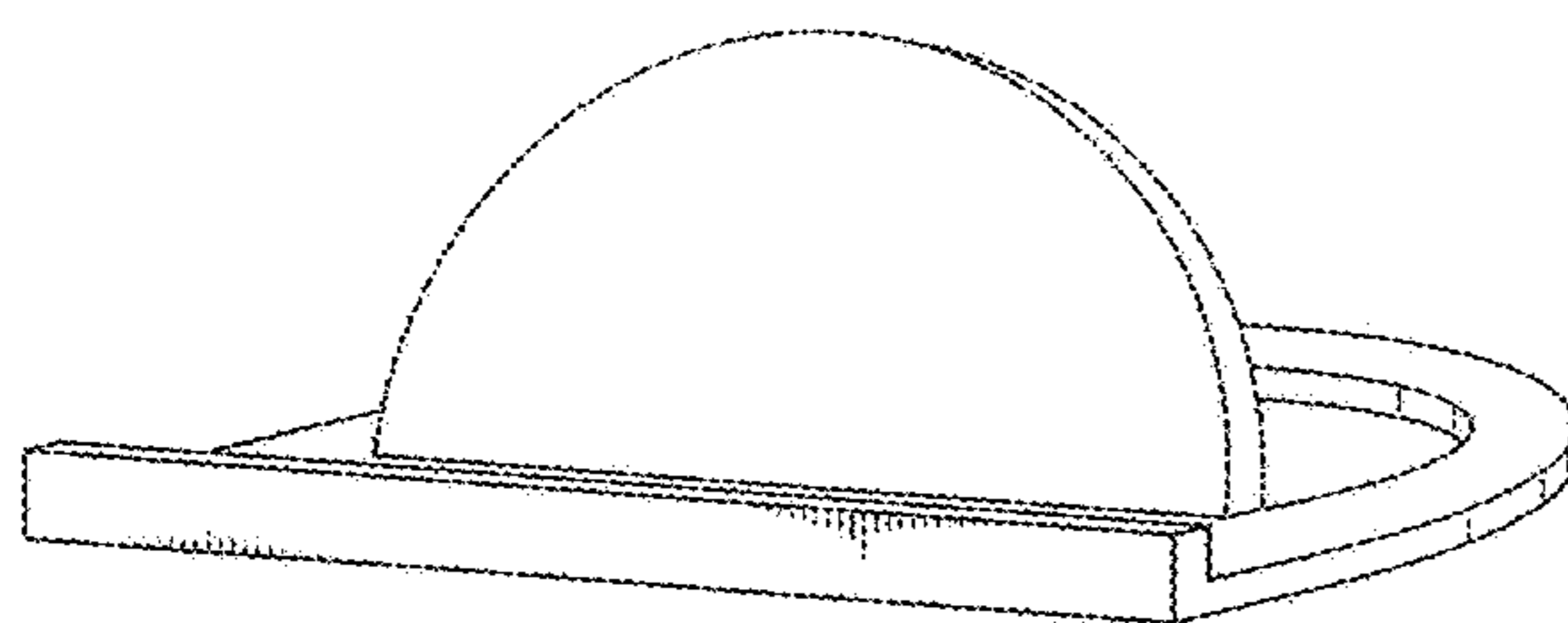
The ornamental design for a cellular phone holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cellular phone holder; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a right side view thereof, the left side view being a mirror image of the right side view; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view thereof.

In the drawings, the broken lines indicate portions of the cellular phone holder that form no part of the claimed design.

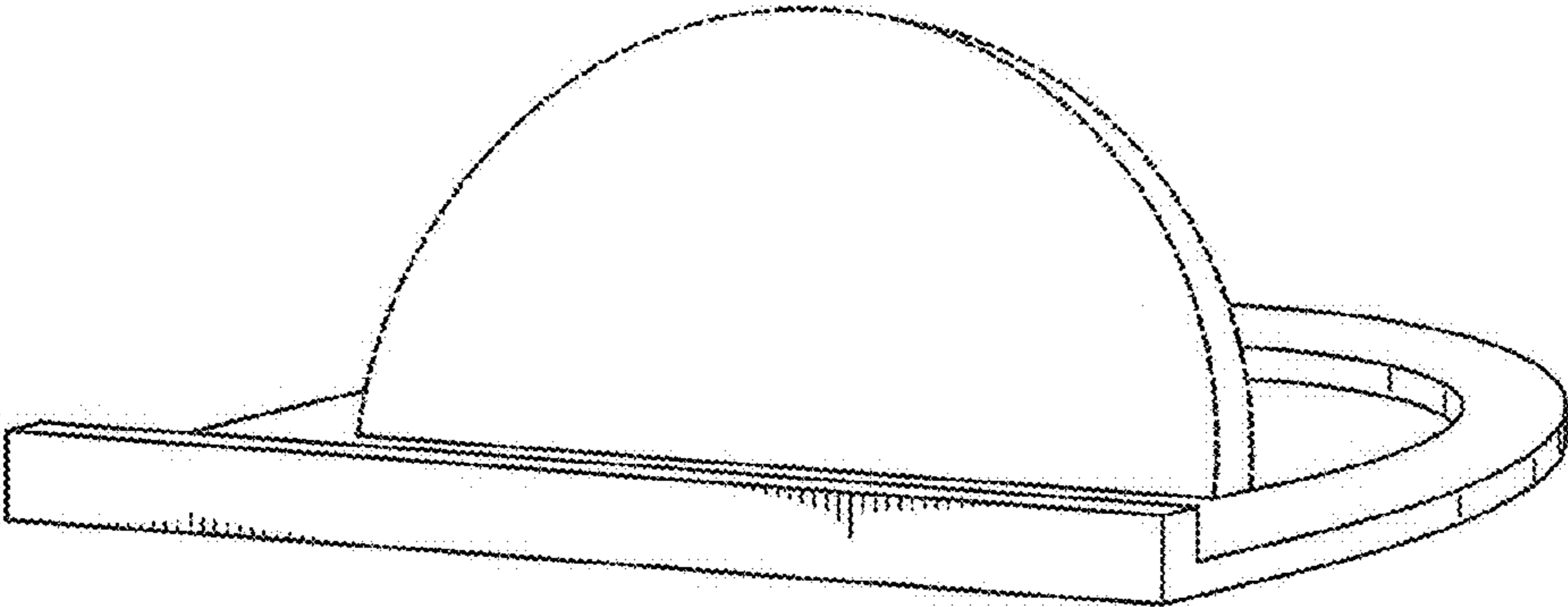

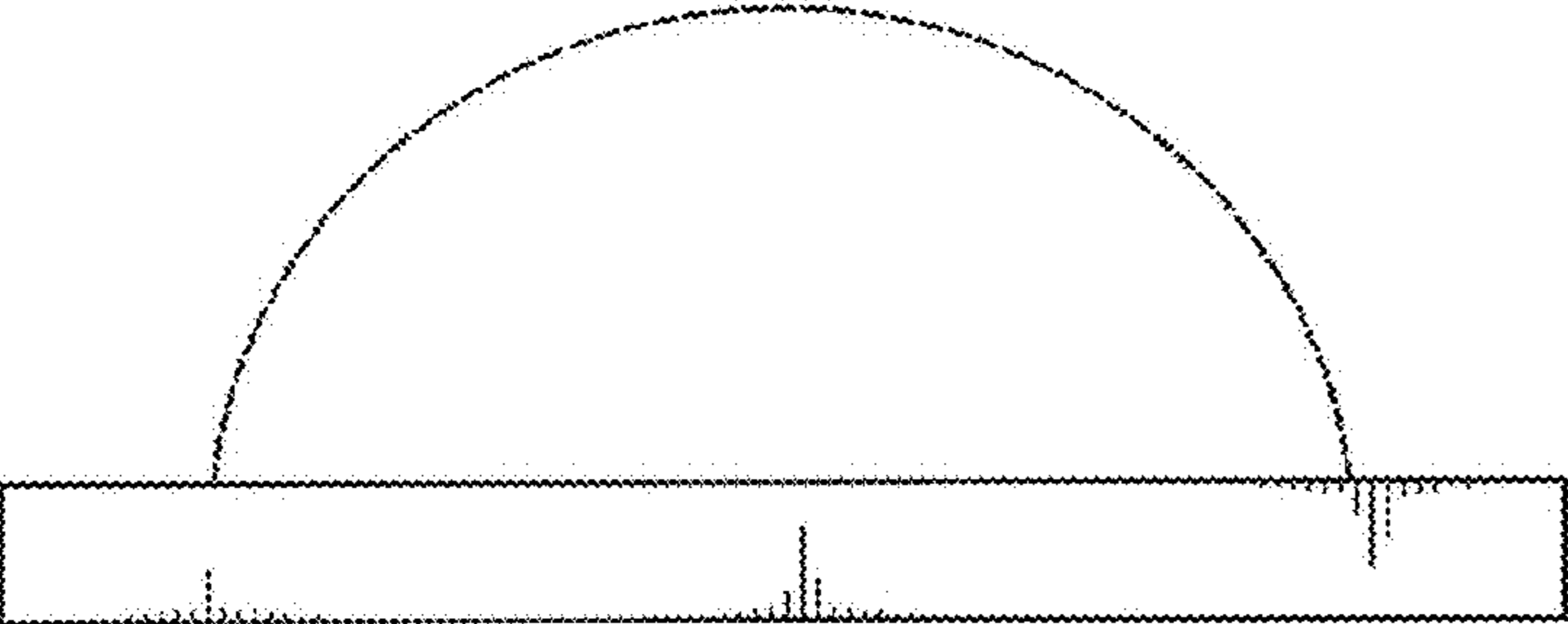

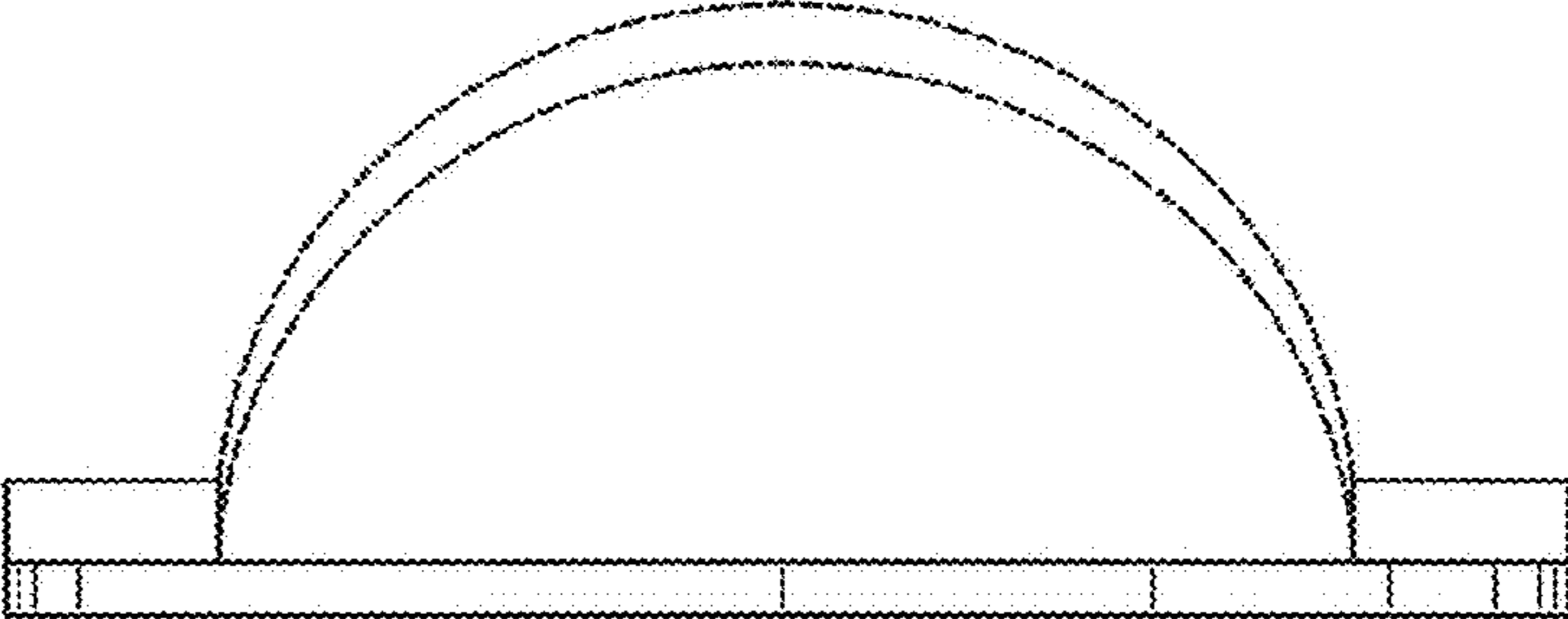

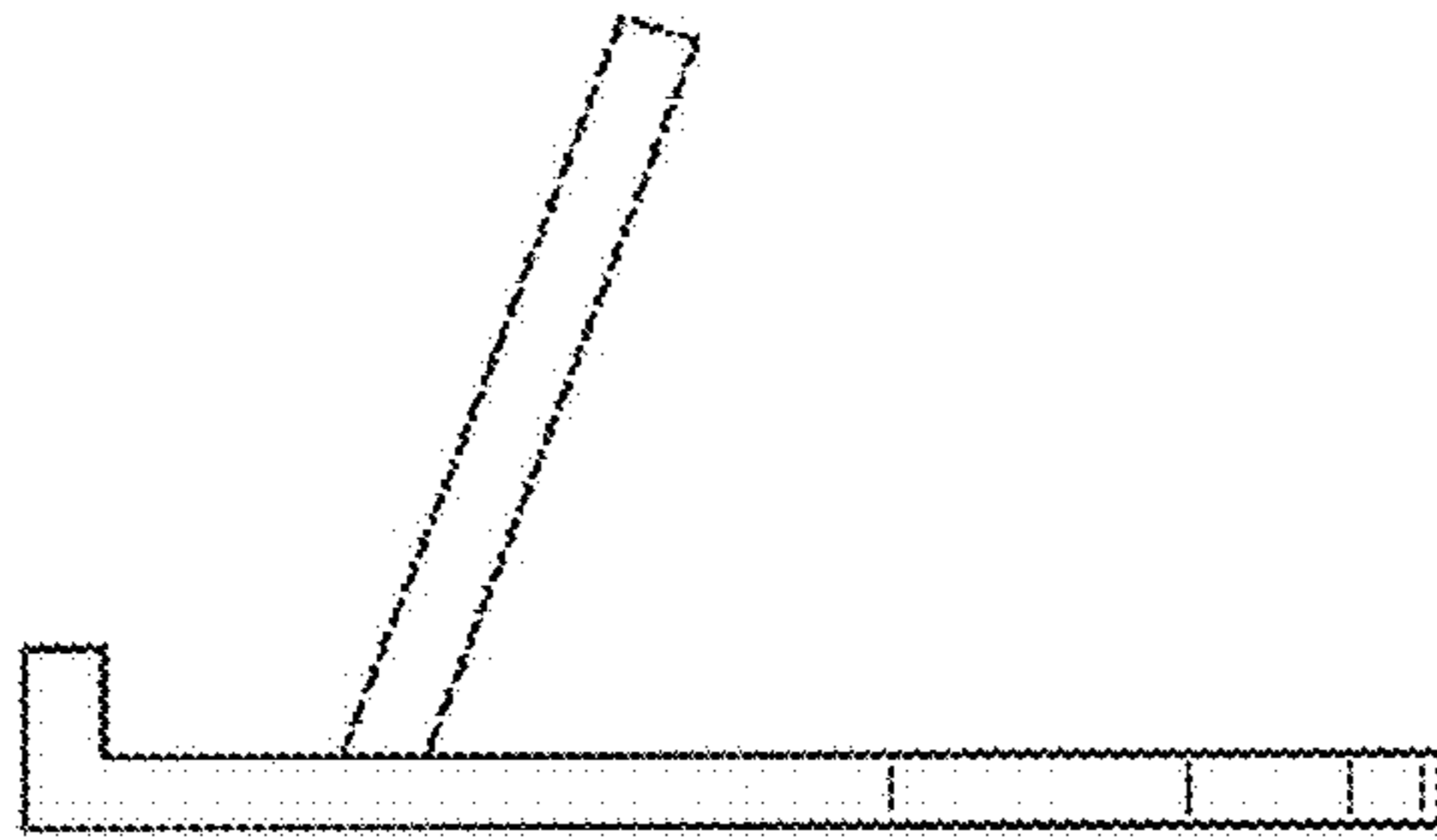

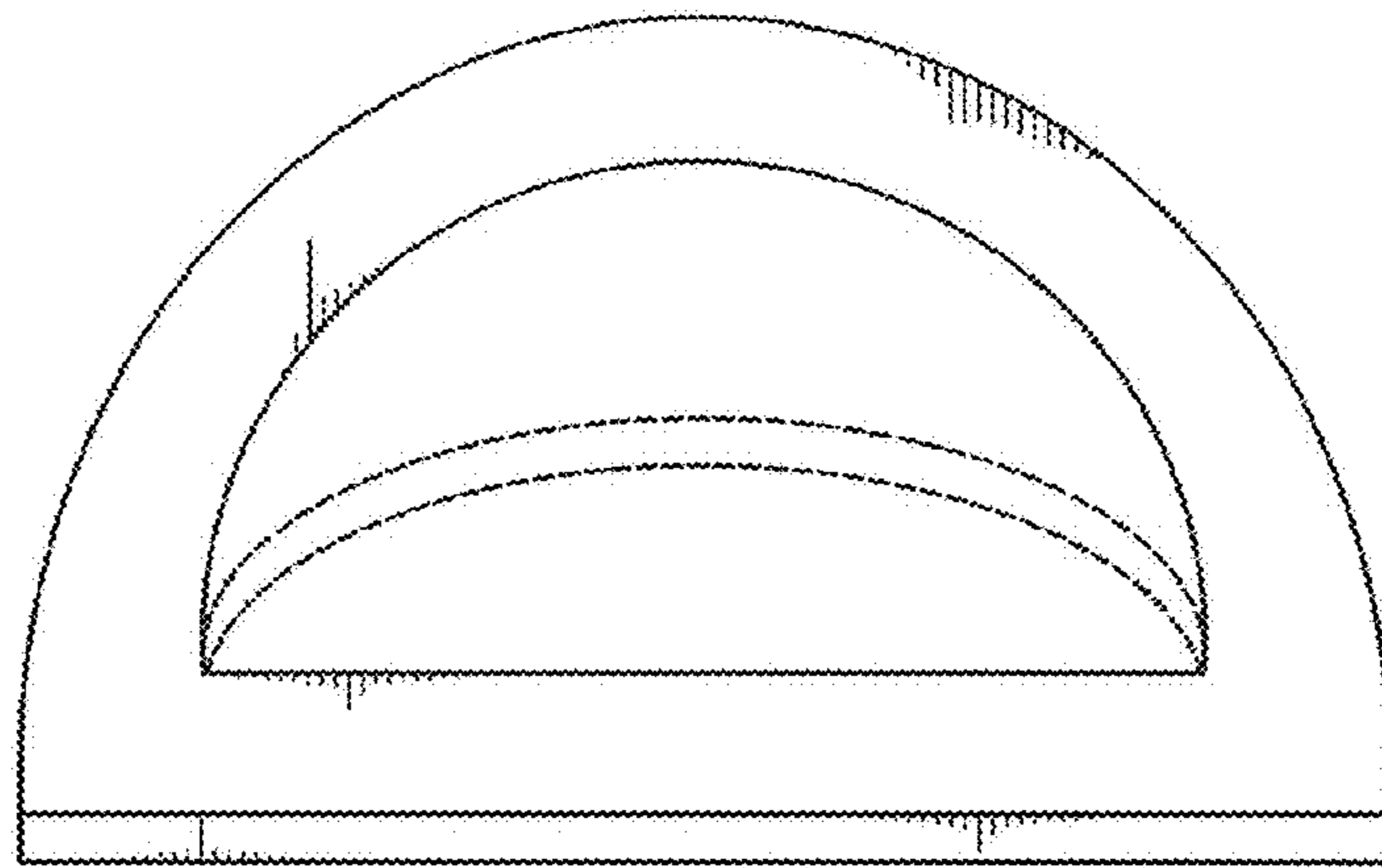

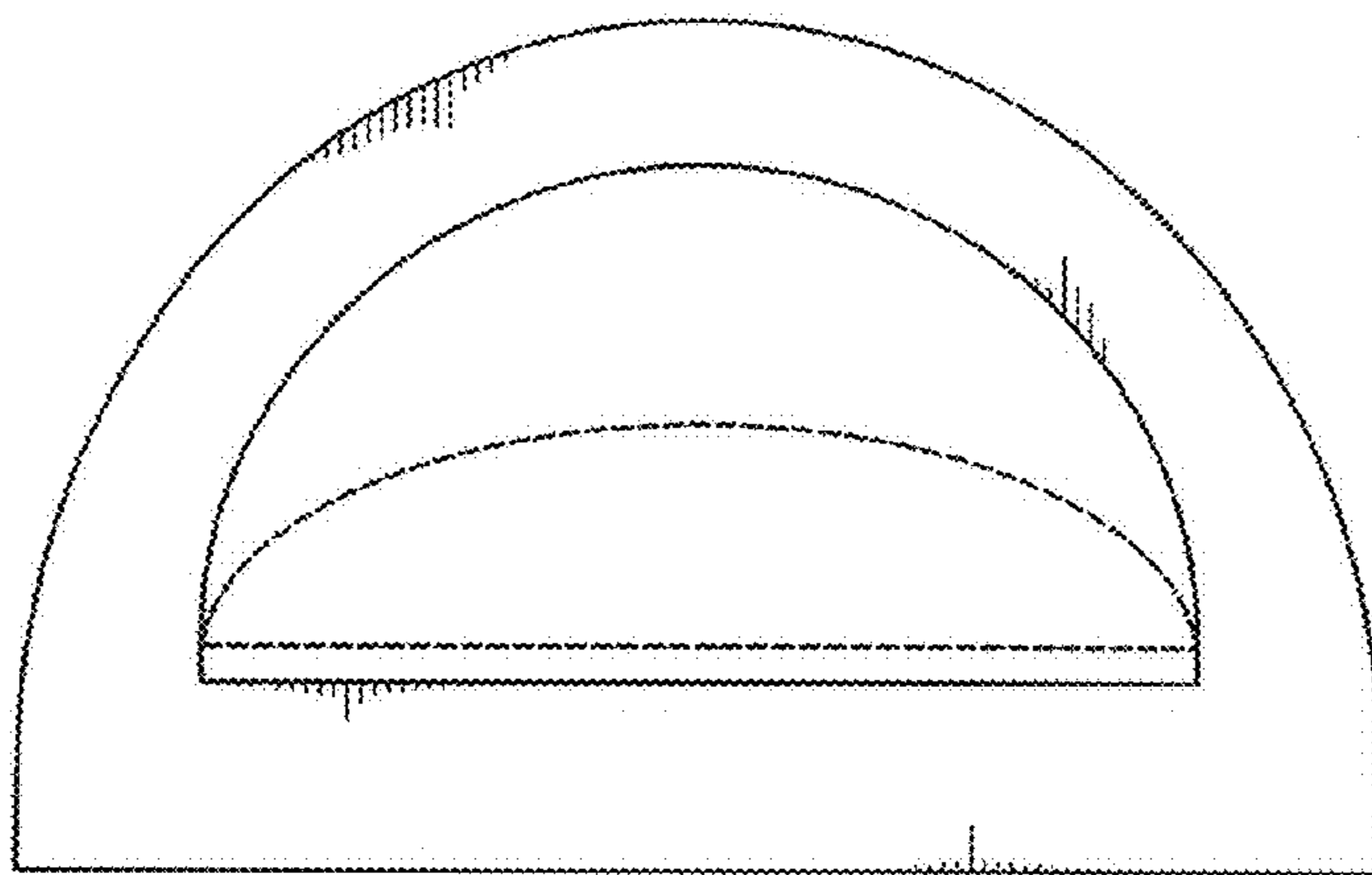
