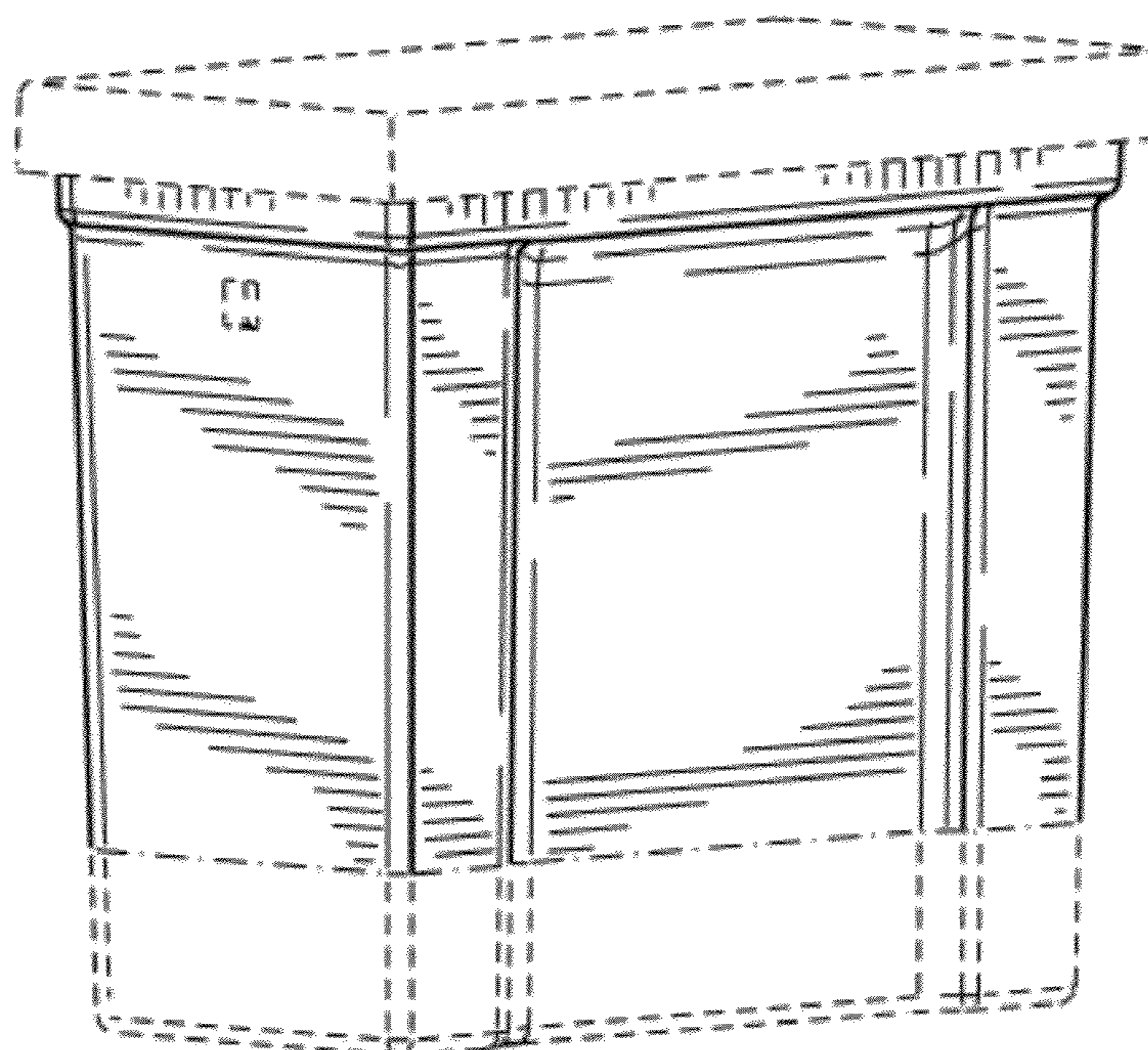
(57) **CLAIM**

We claim the ornamental design for a toilet tank, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the claimed design; FIG. 2 is a front elevation view of the claimed design of FIG. 1; FIG. 3 is a left-side elevation view of the claimed design of FIG. 1; FIG. 4 is a right-side elevation view of the claimed design of FIG. 1; FIG. 5 is a rear elevation view of the claimed design of FIG. 1; FIG. 6 is a top plan view of the claimed design of FIG. 1; and, FIG. 7 is a bottom plan view of the claimed design of FIG. 1. 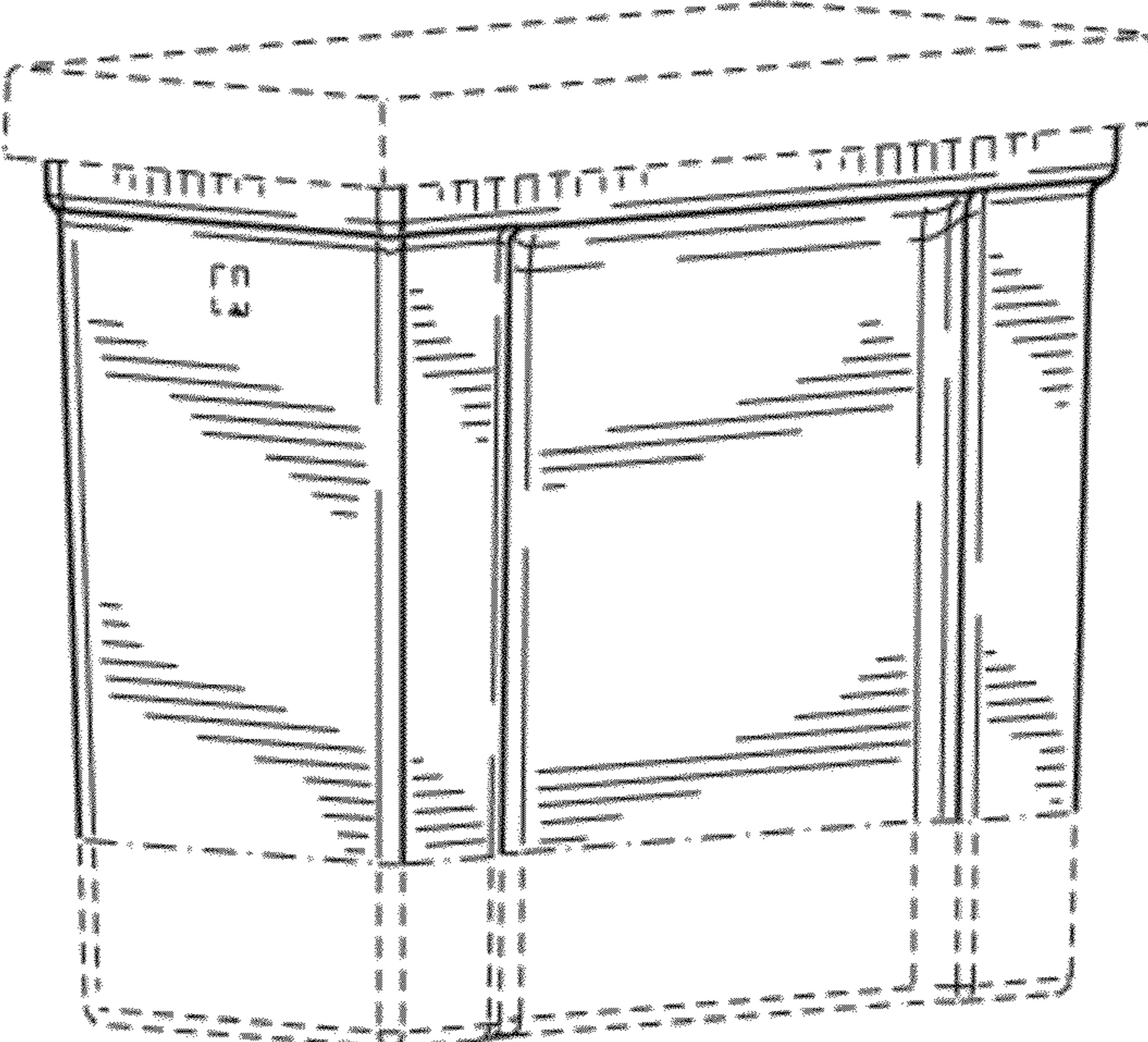

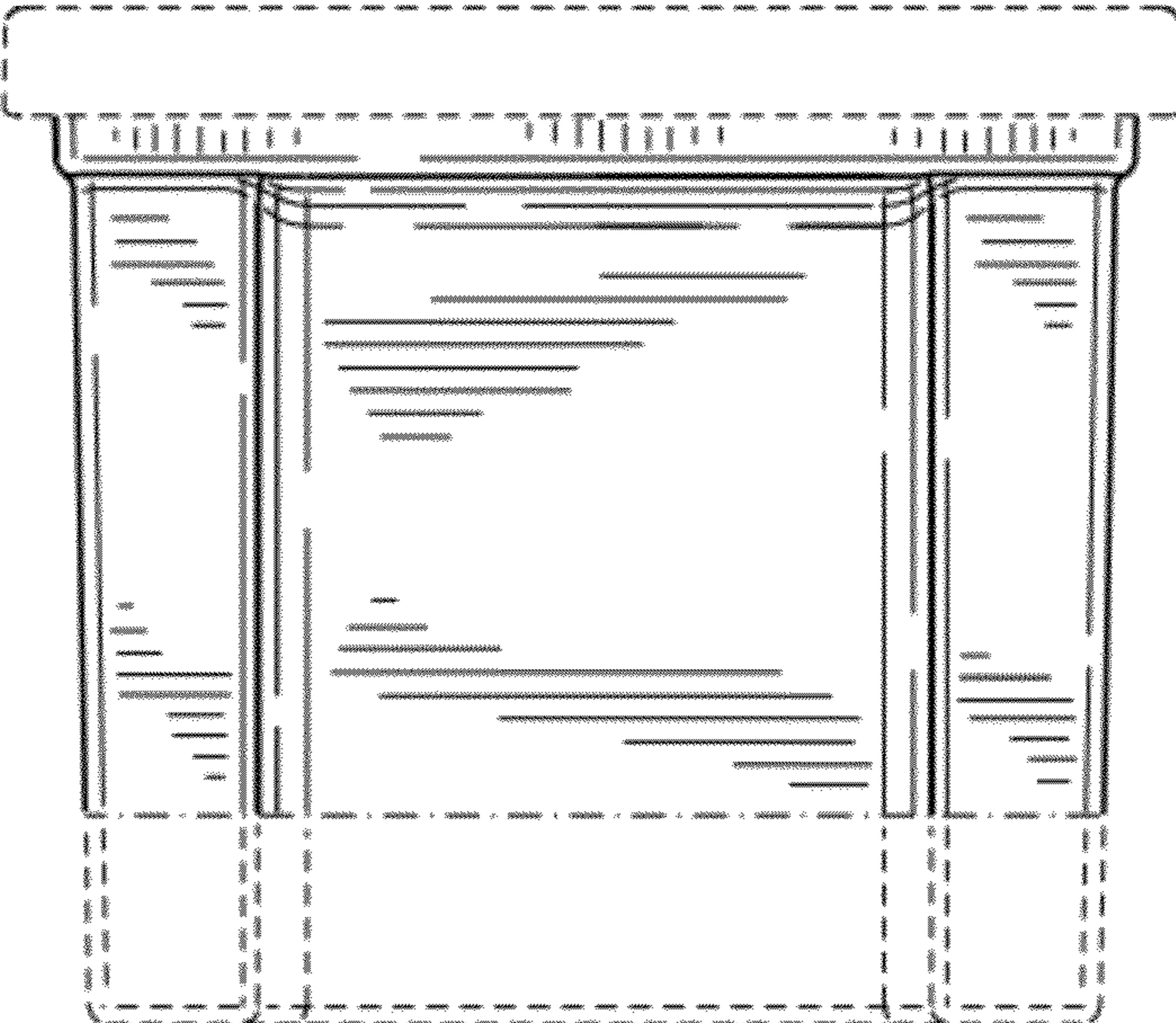

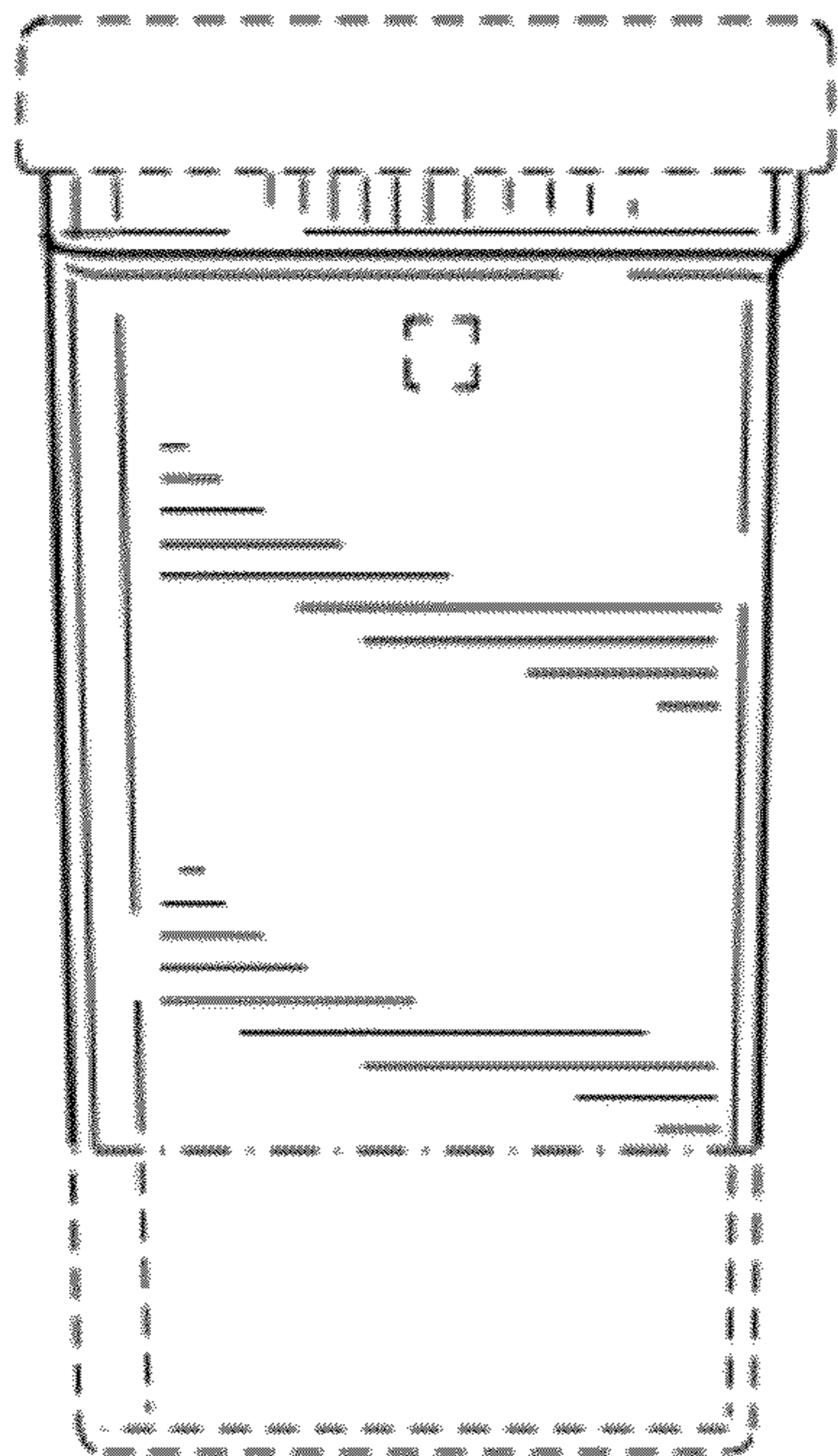

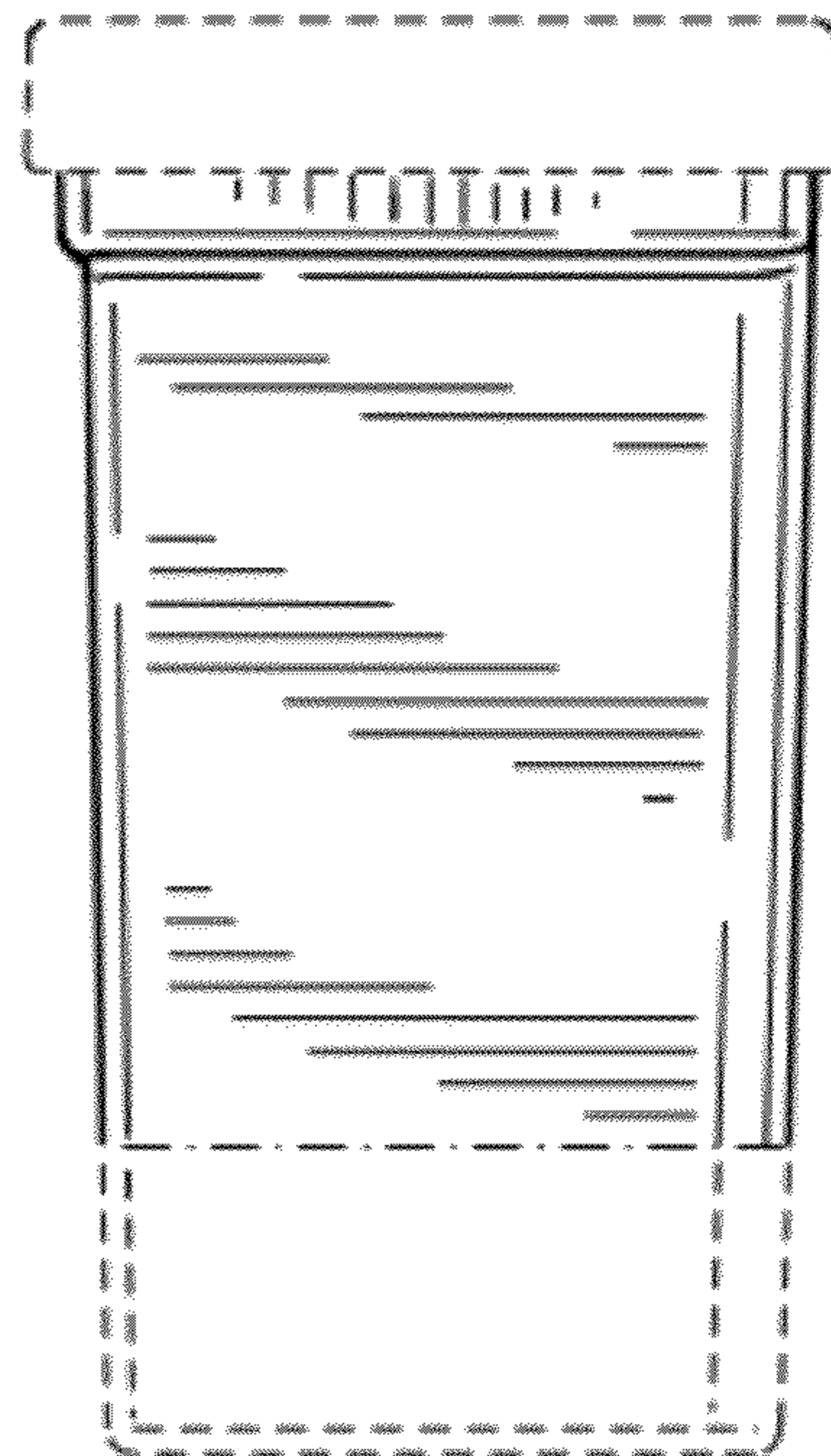

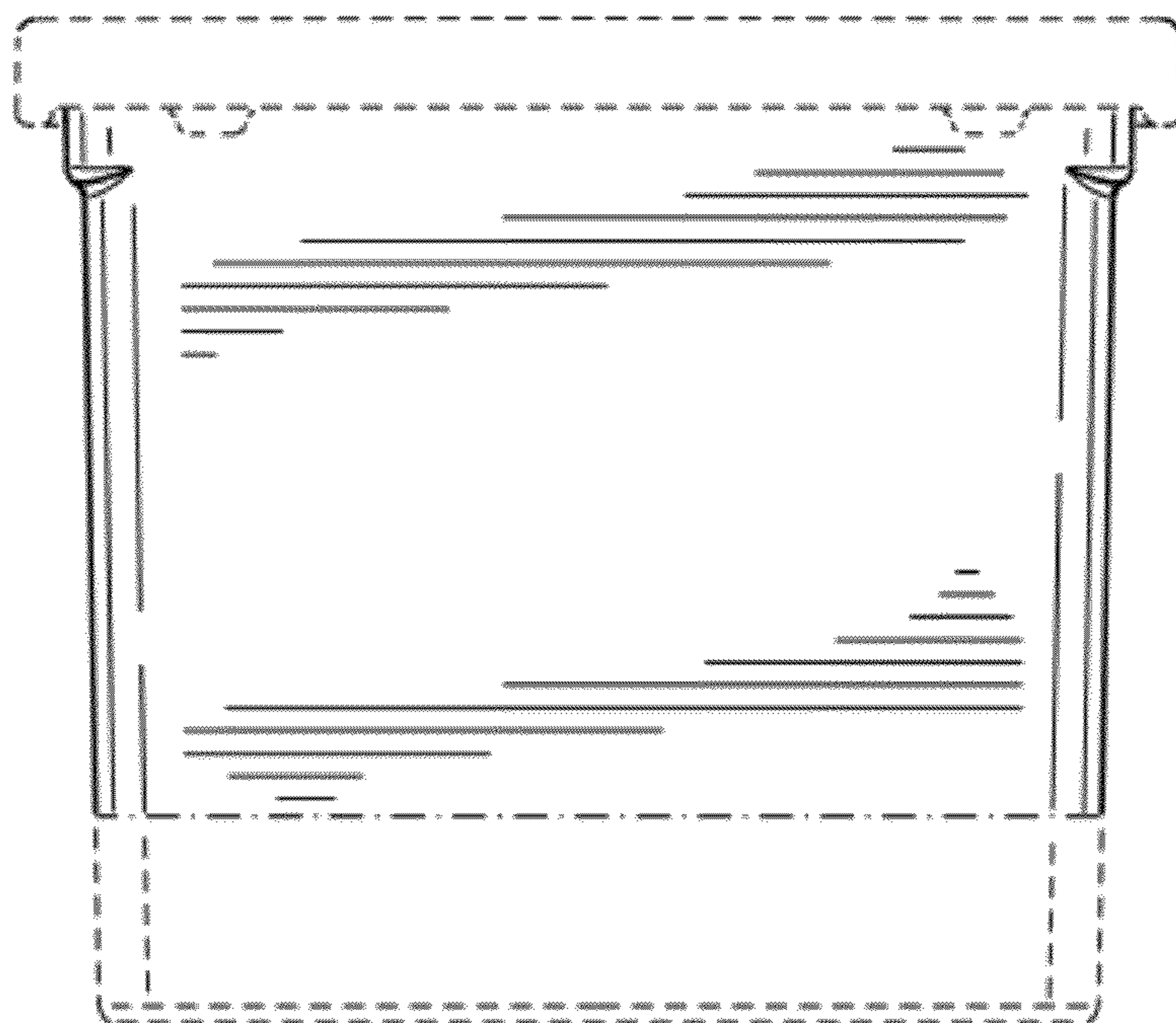

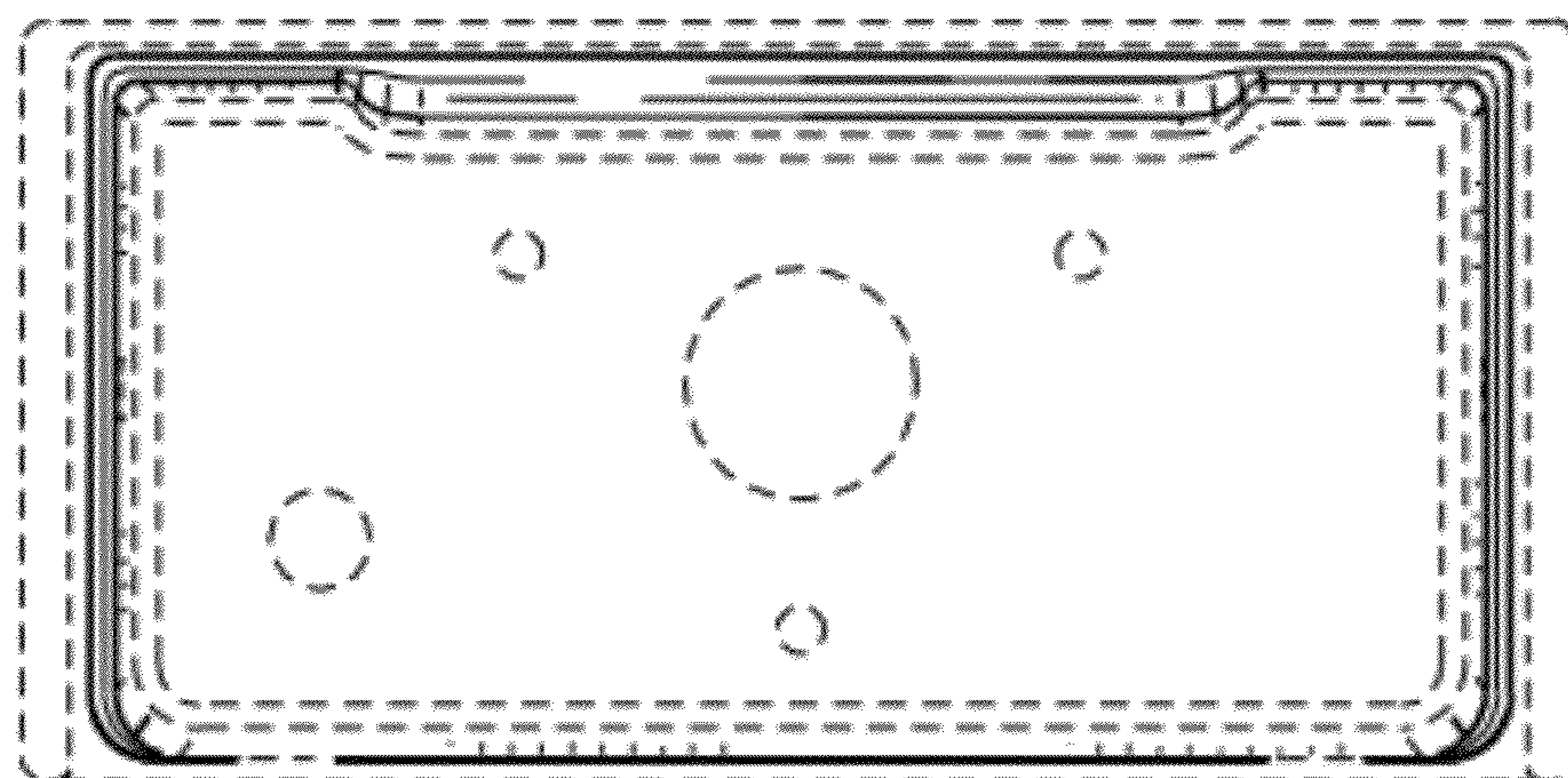
