(57) **CLAIM**

We claim the ornamental design for a multifunctional handle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a design of the multifunctional handle;

FIG. 2 is a front elevation view of the multifunctional handle of FIG. 1;

FIG. 3 is a rear elevation view of the multifunctional handle of FIG. 1;

FIG. 4 is a first side elevation view of the multifunctional handle of FIG. 1;

FIG. 5 is a second side elevation view of the multifunctional handle of FIG. 1;

FIG. 6 is a top plan view of the multifunctional handle of FIG. 1; and,

FIG. 7 is a bottom plan view of the multifunctional handle of FIG. 1.

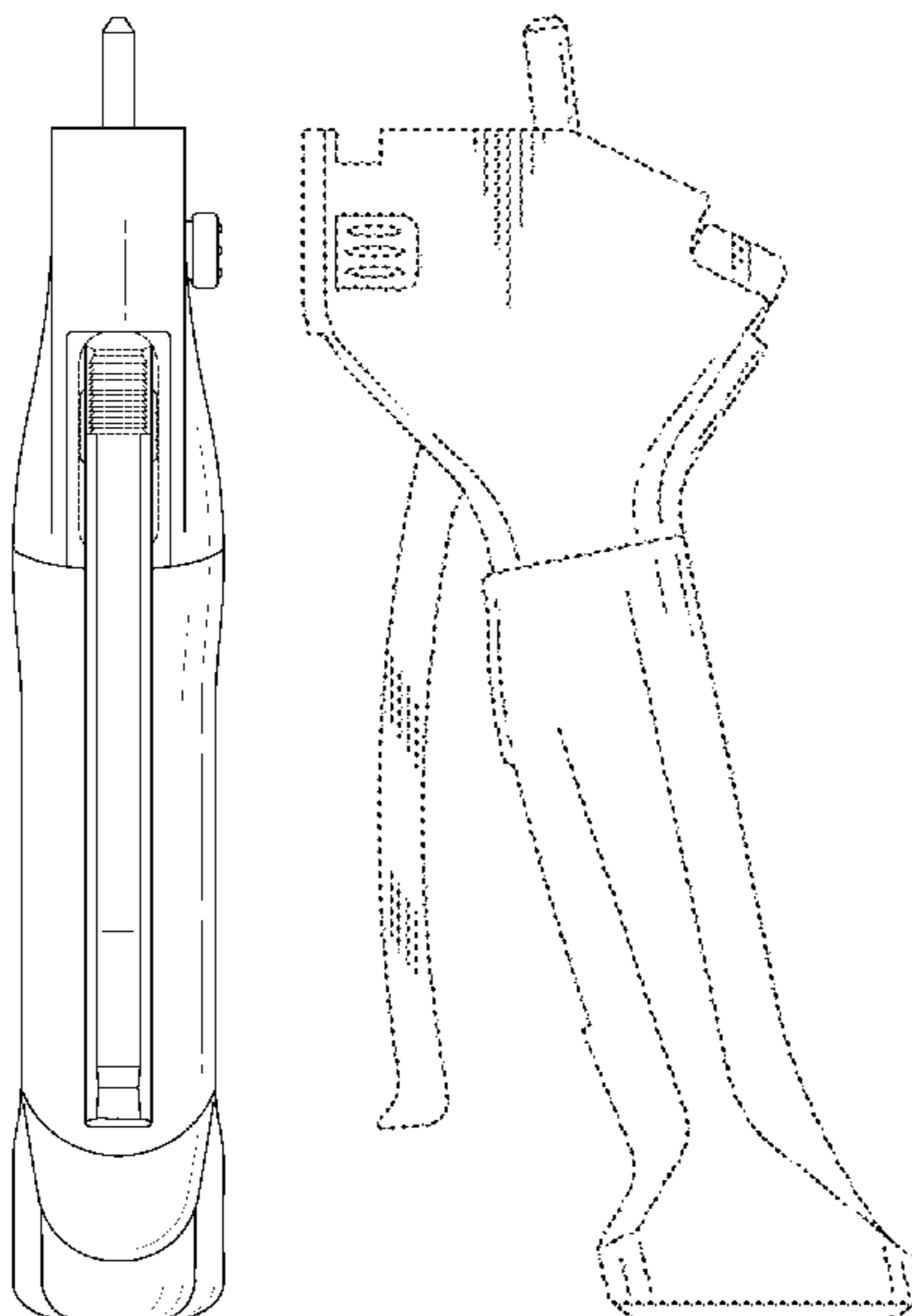

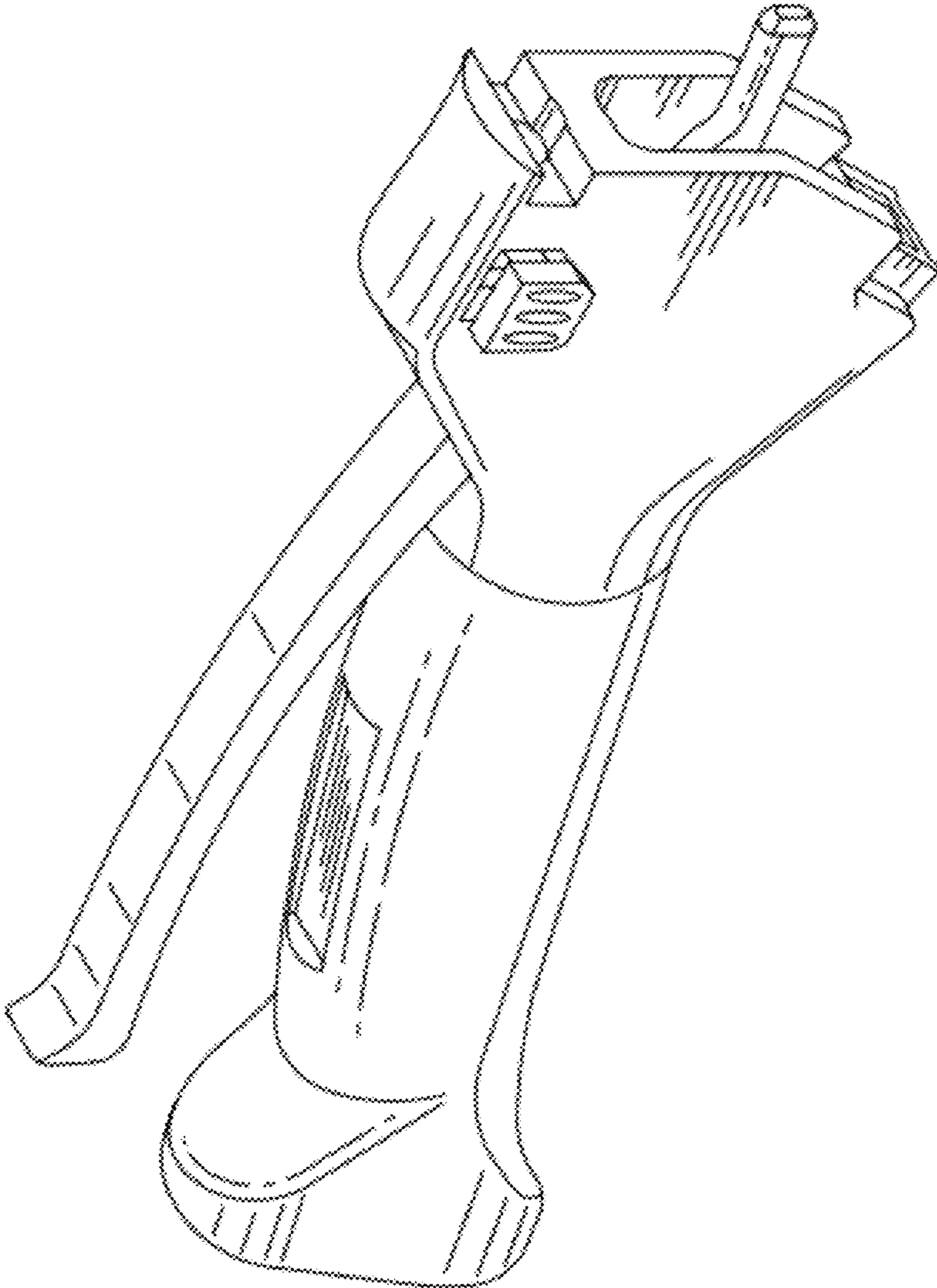

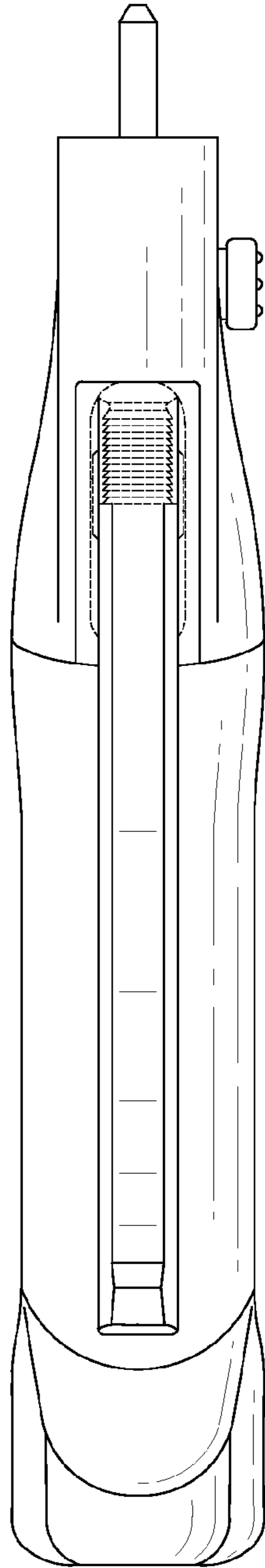

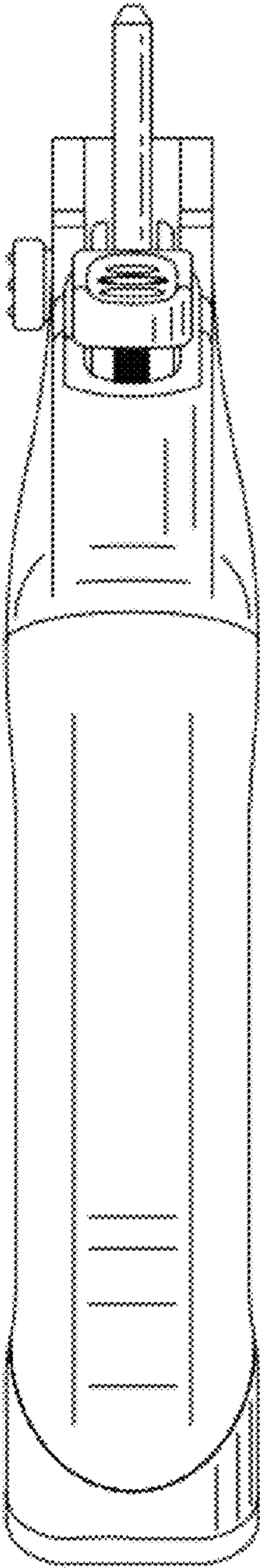

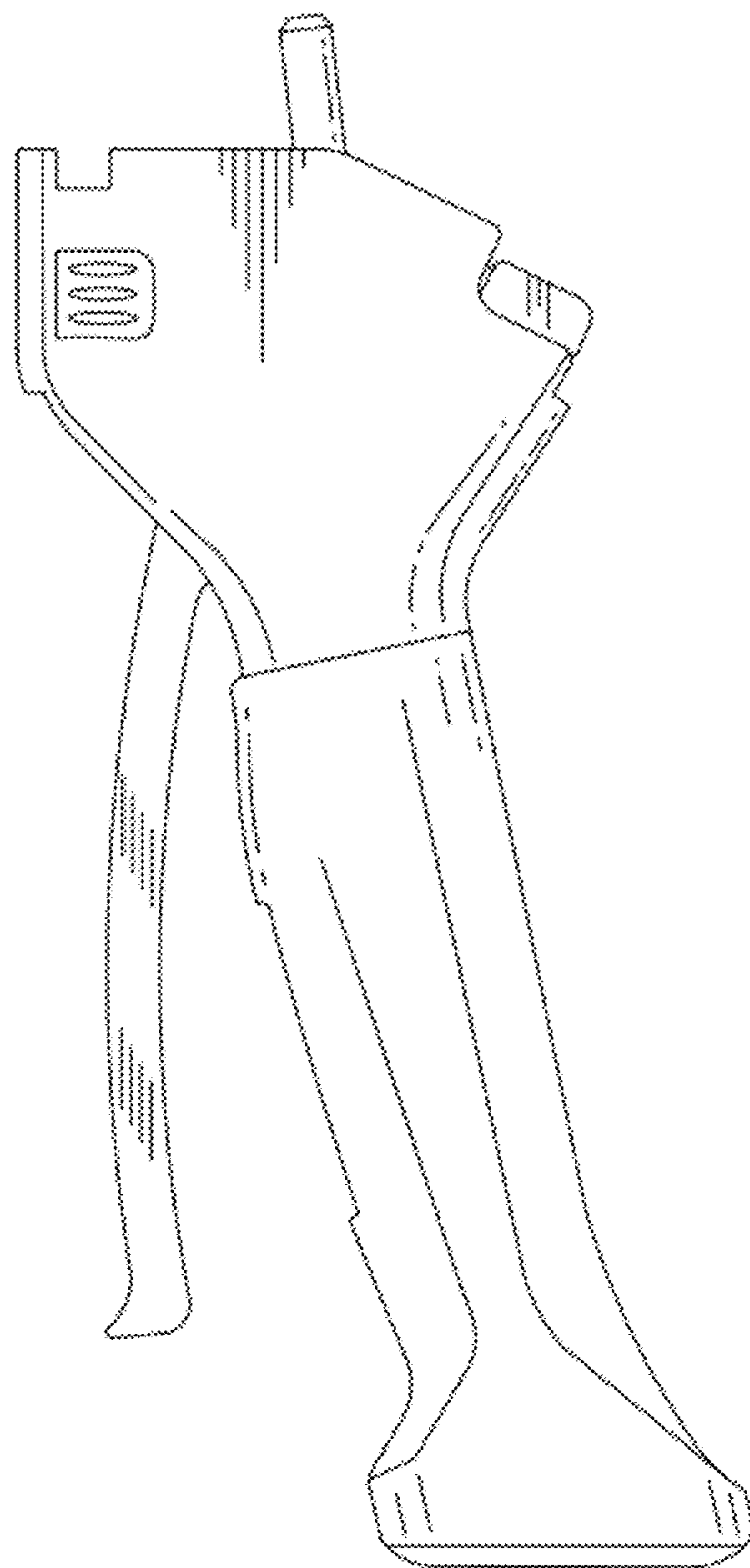

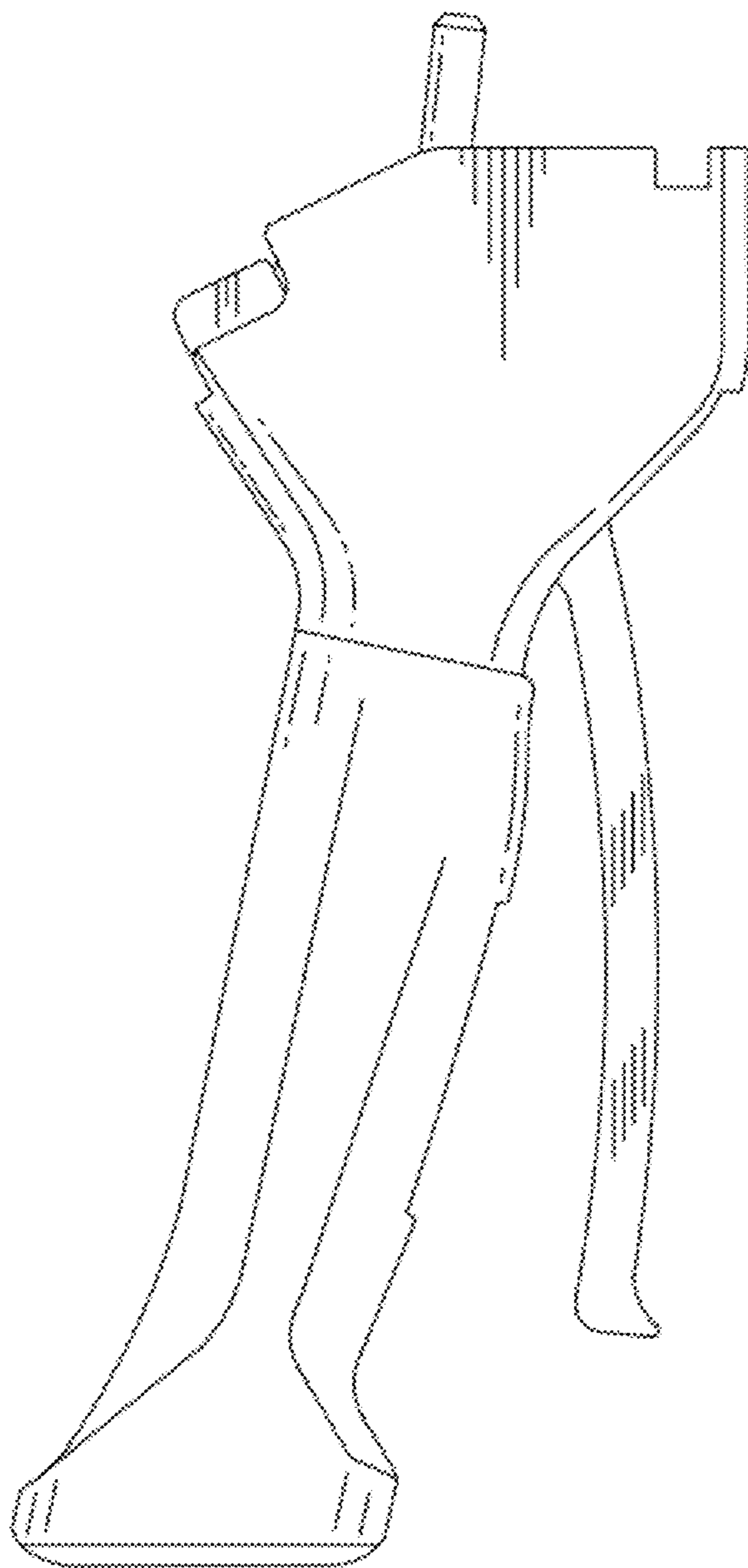

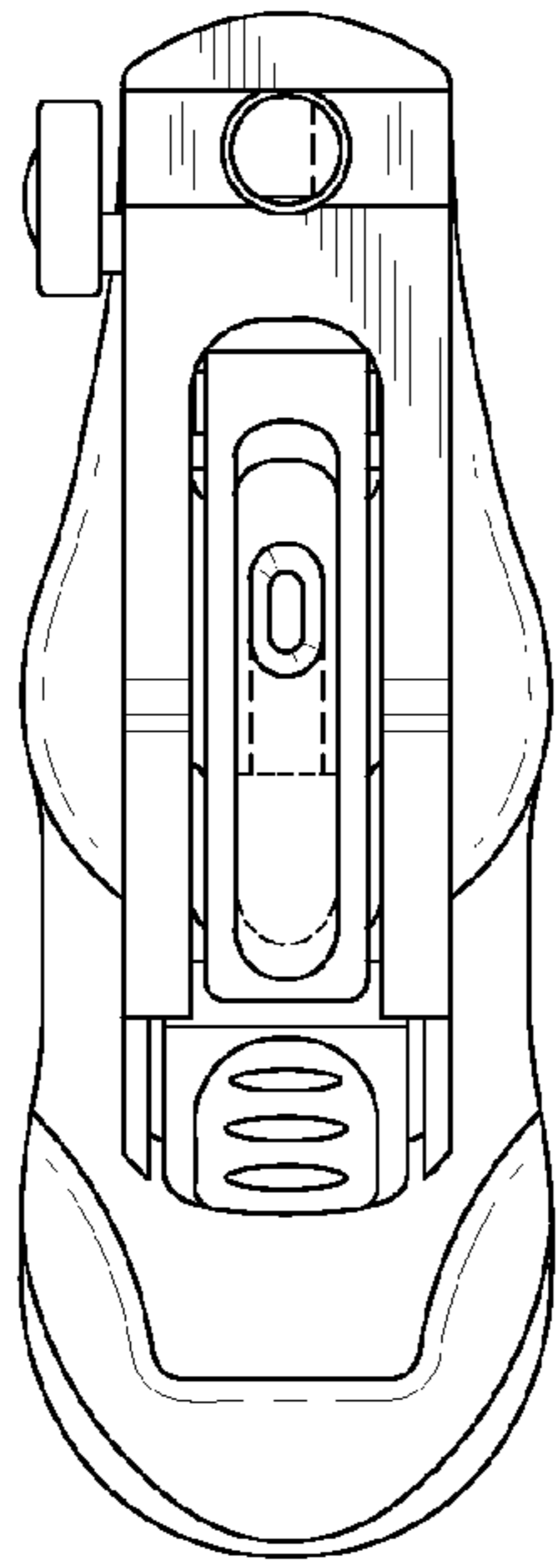

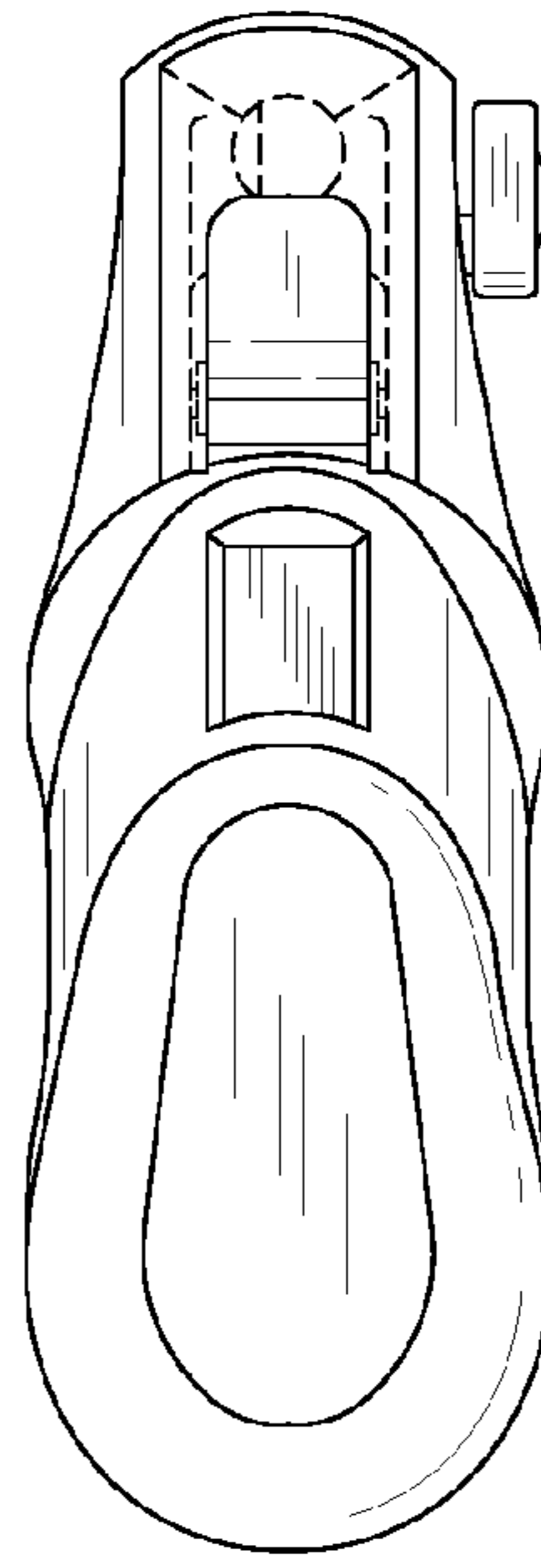
