The ornamental design for a landscape edger, as shown and described.

DESCRIPTION

FIG. 1 is a front top perspective view of a landscape edger showing my new design.

FIG. 2 is a top plan view thereof.

FIG. 3 is a side elevation view thereof.

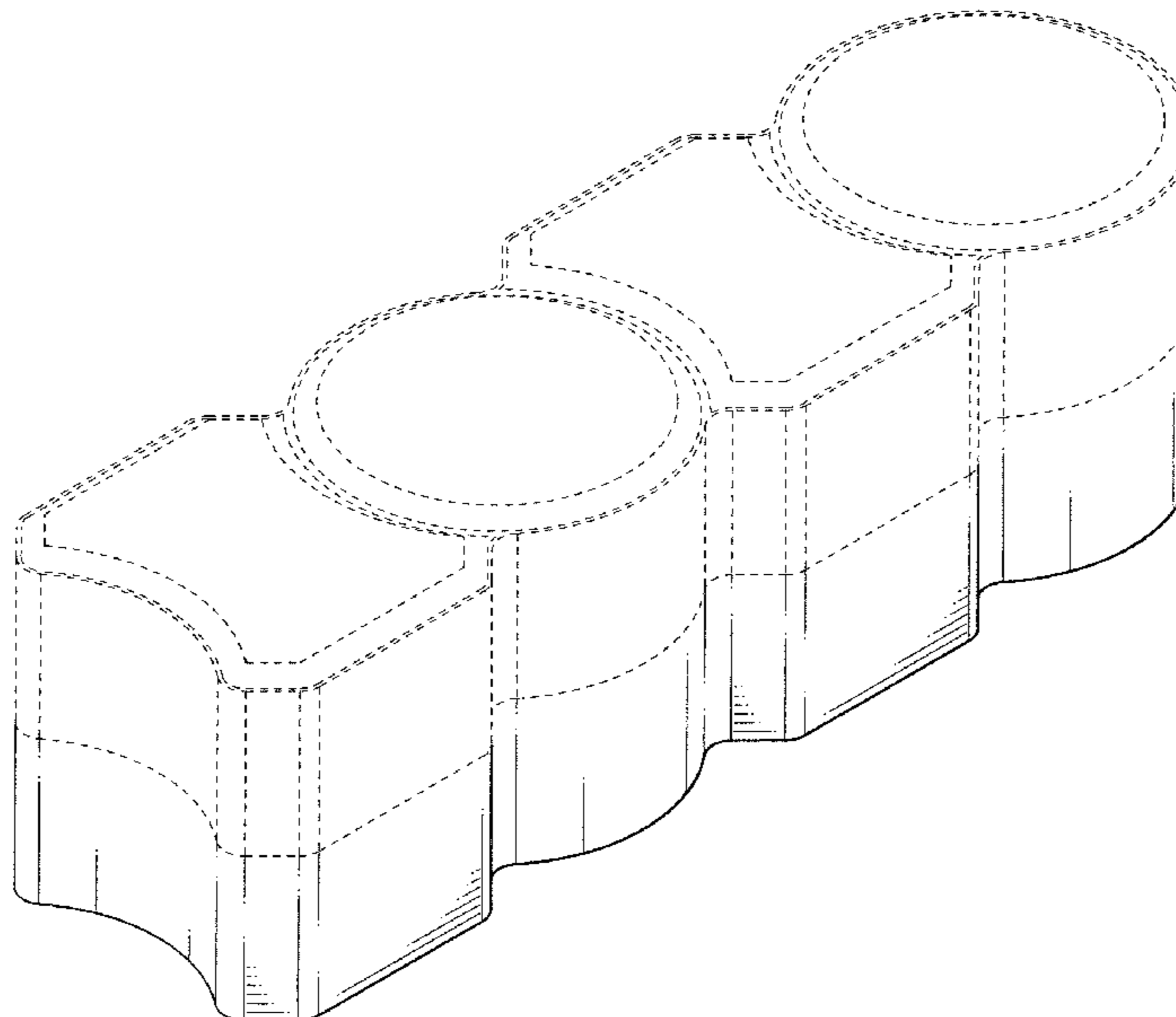
FIG. 4 is a front end elevation view thereof.

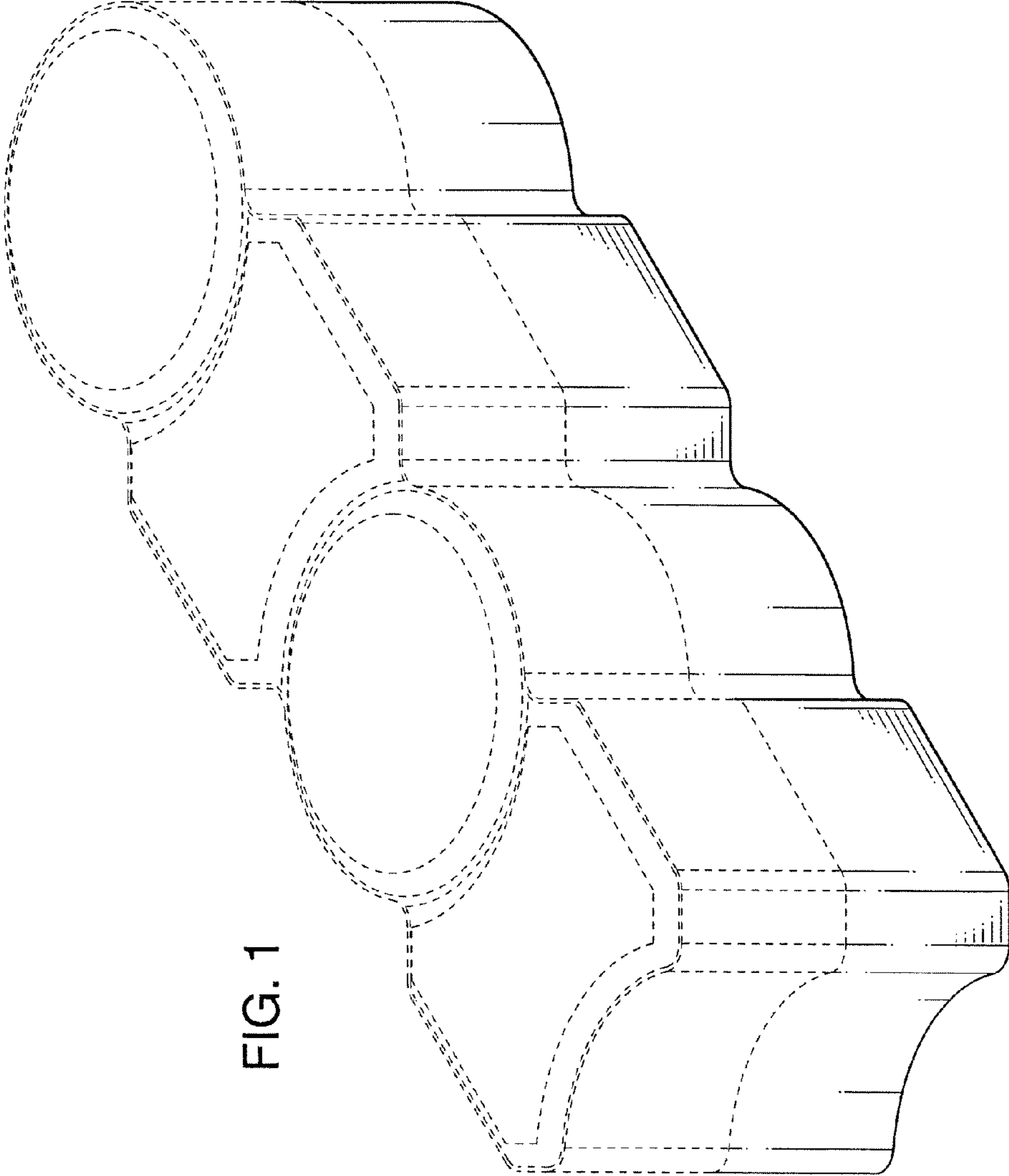

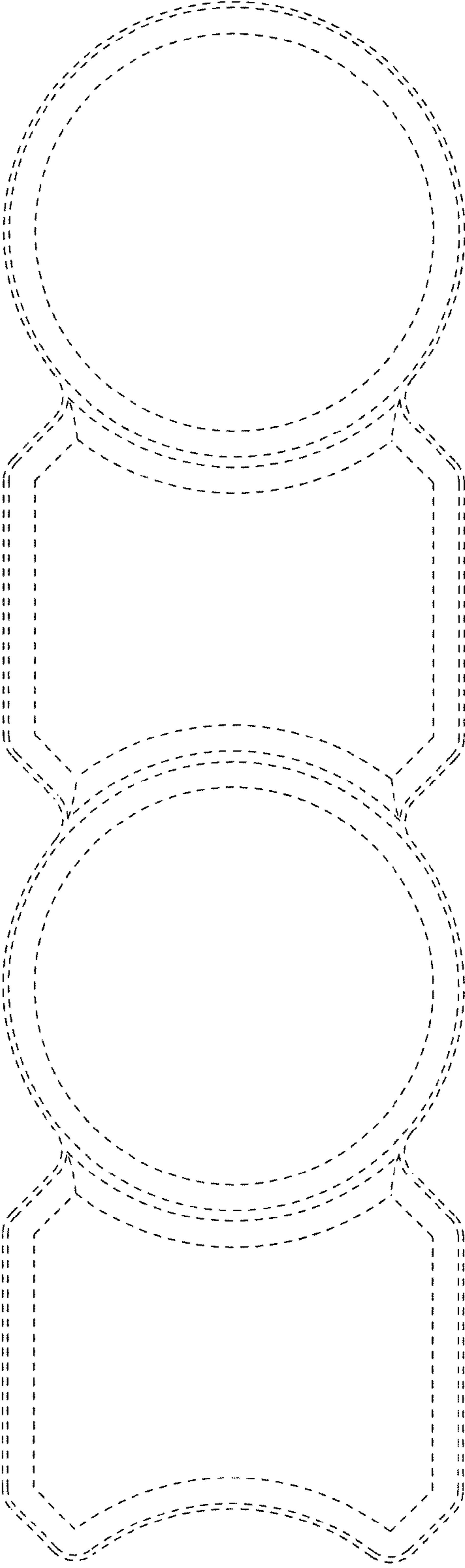

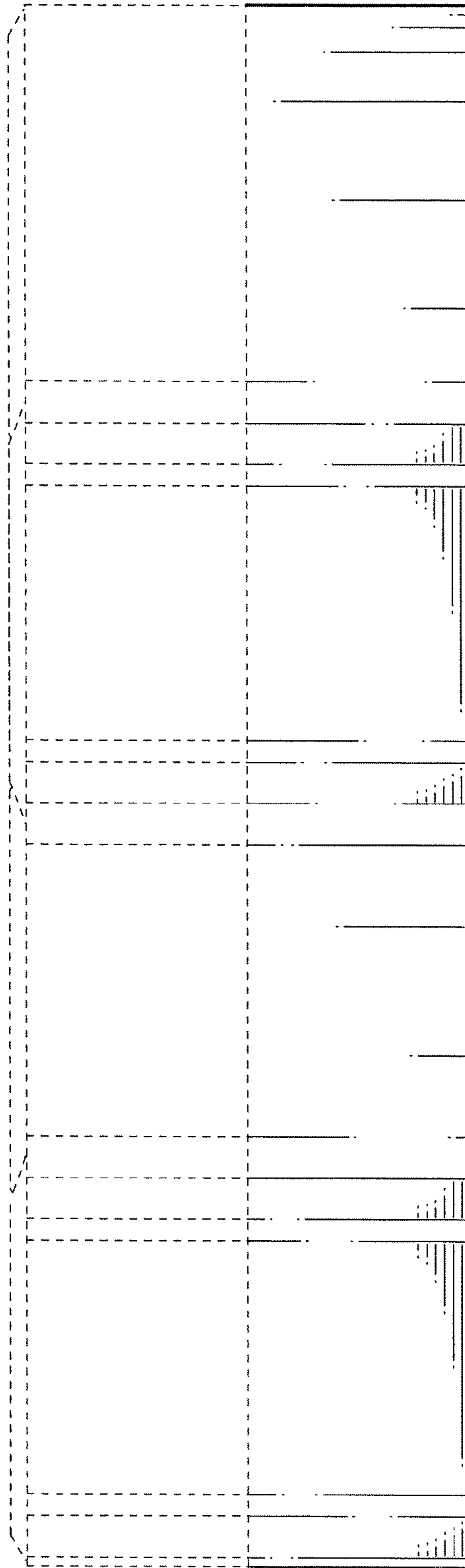

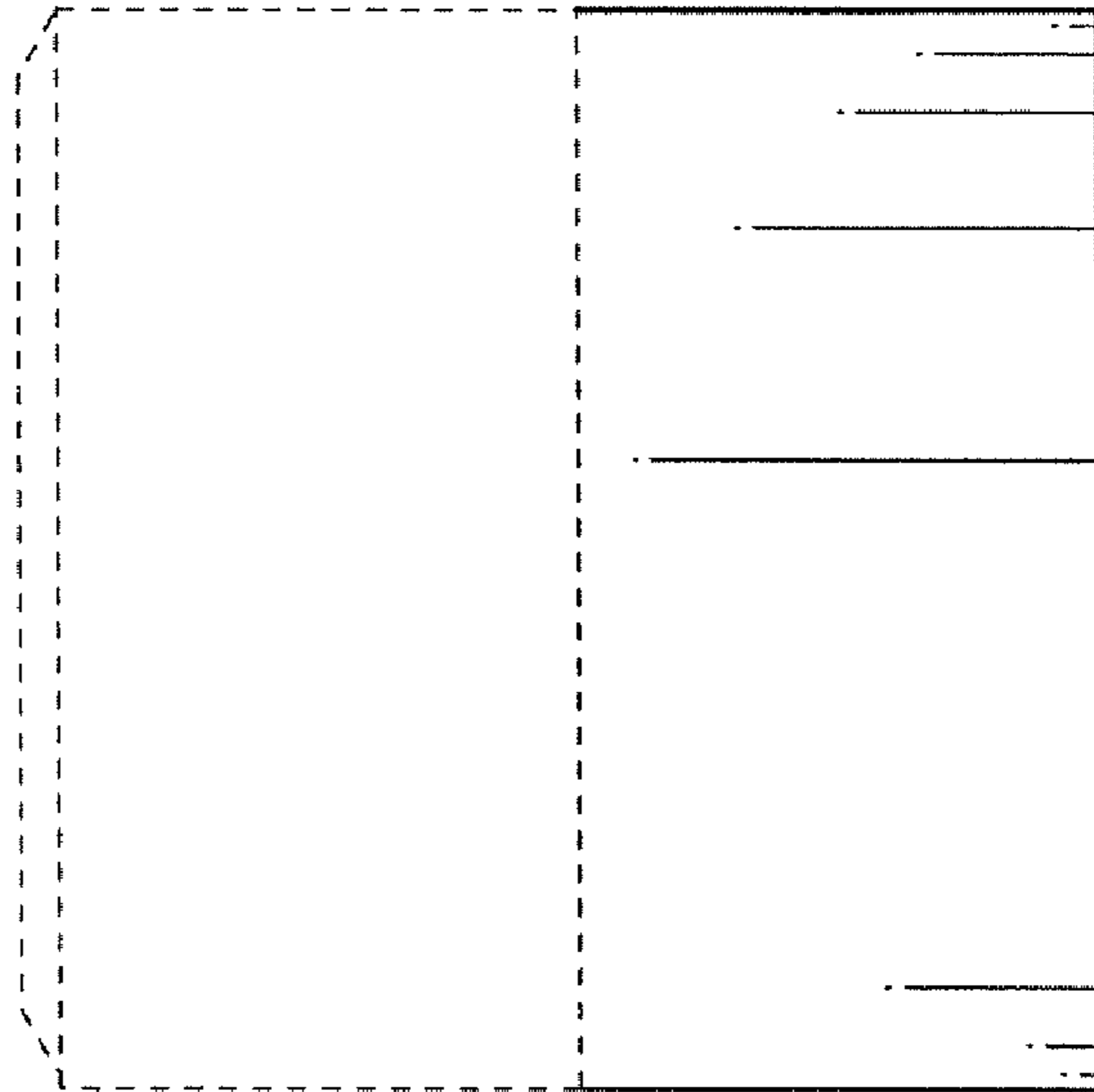

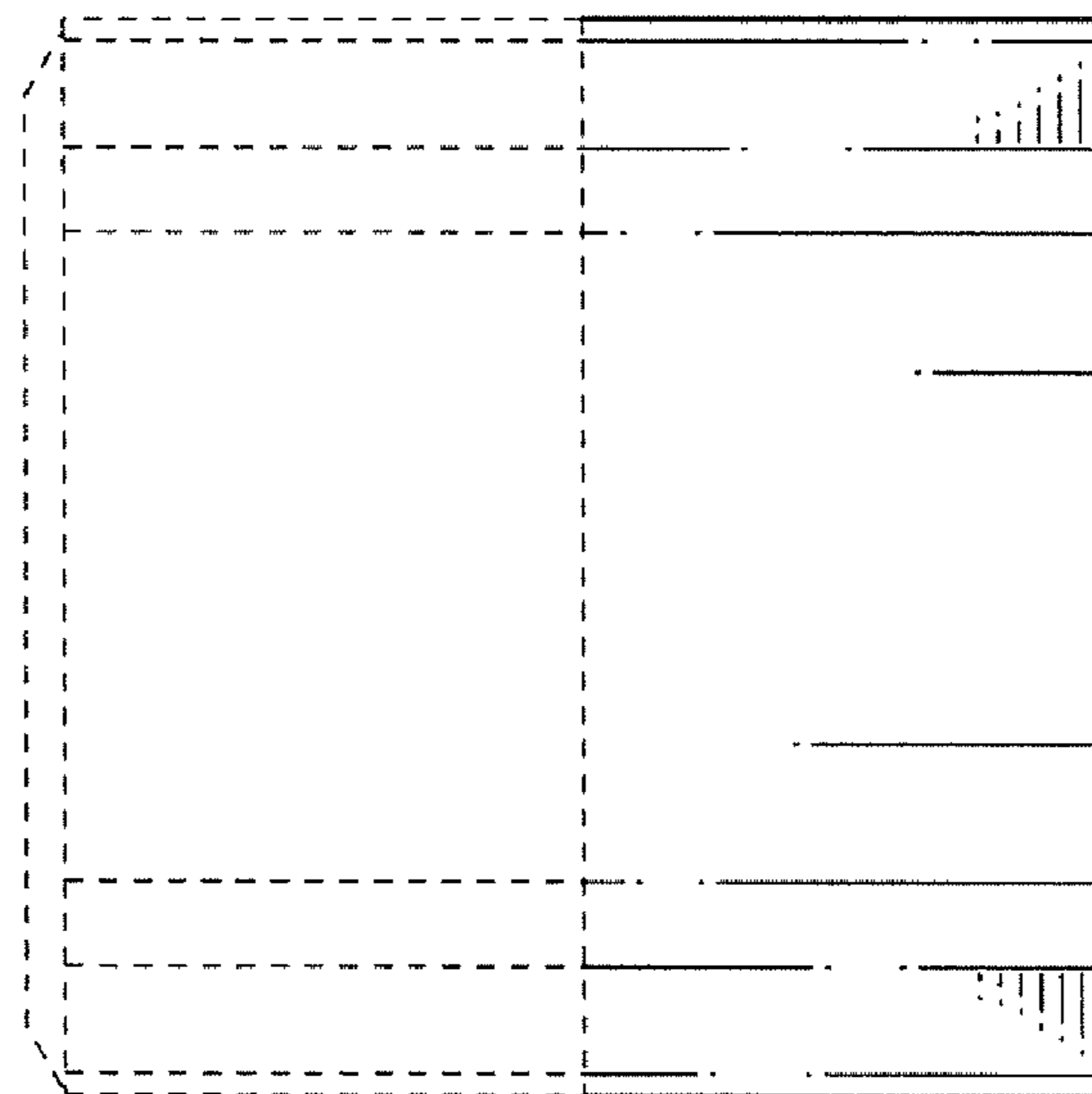

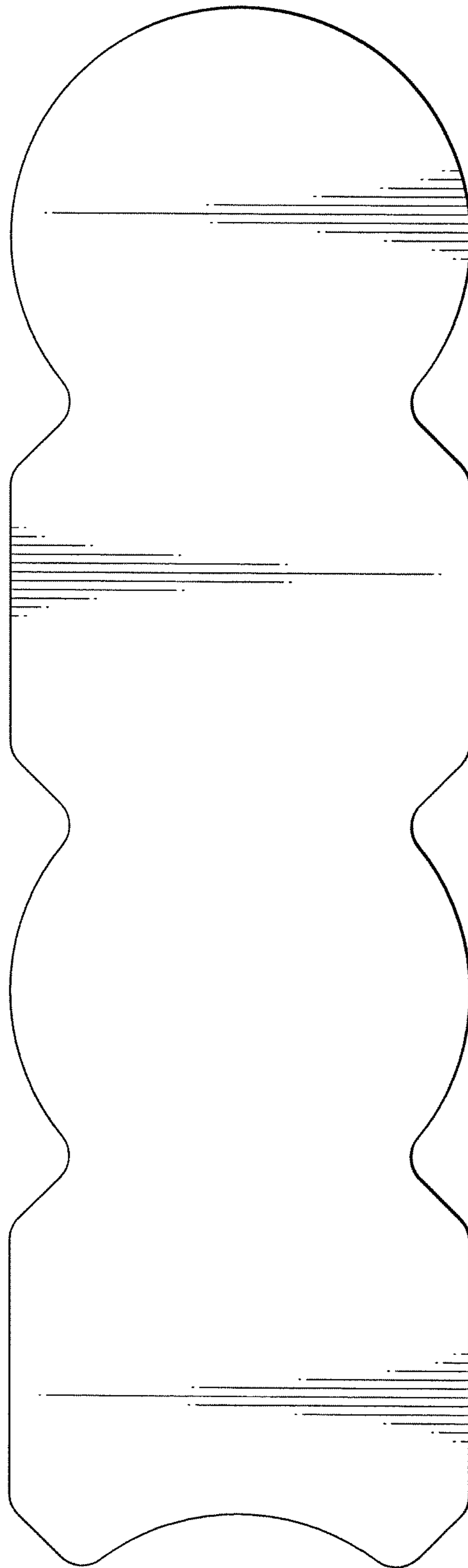
