(57) **CLAIM**

The ornamental design for a "glove with index finger grip and impact guard," as shown and described.

**DESCRIPTION**

FIG. 4 is a left side elevational view thereof

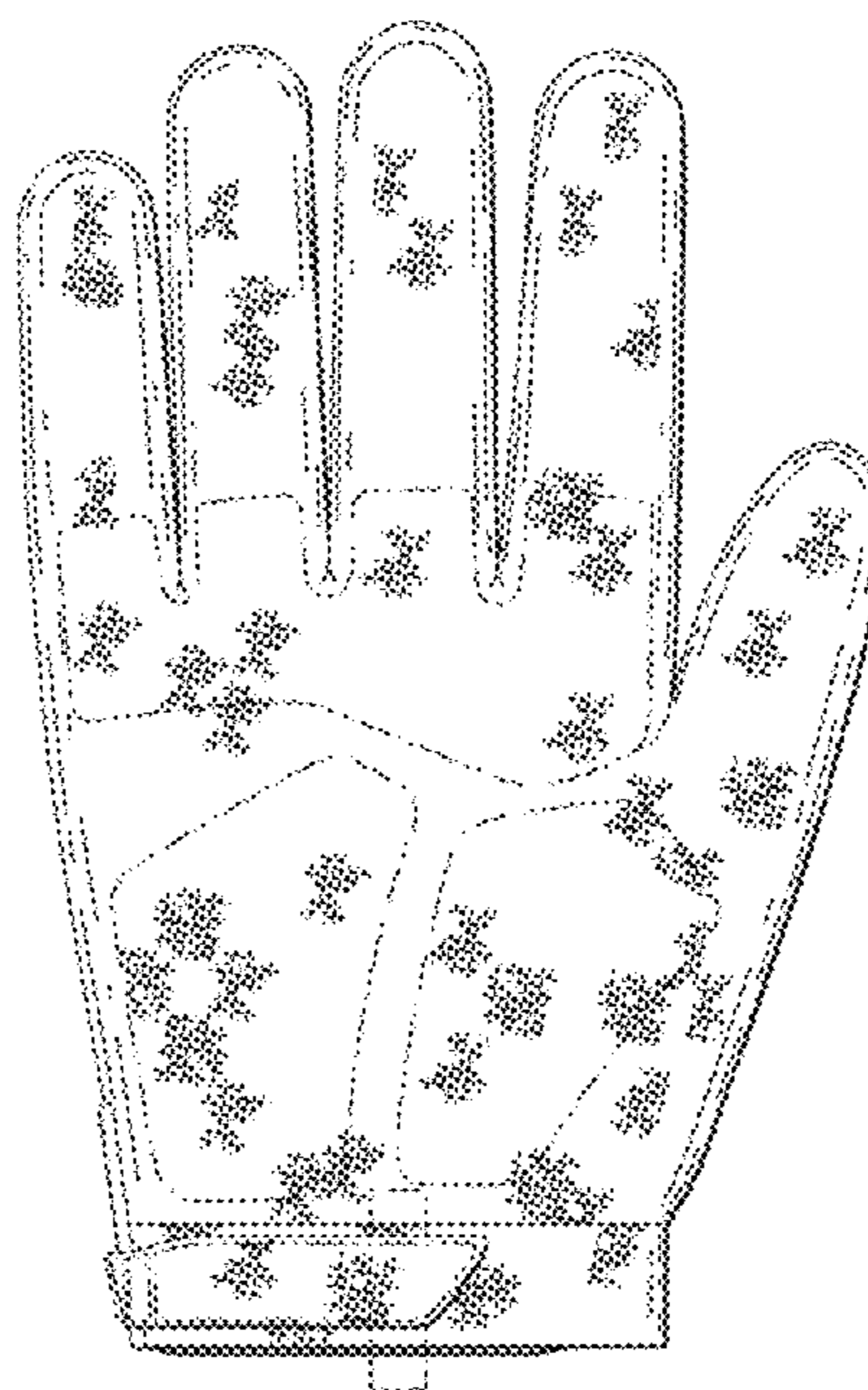
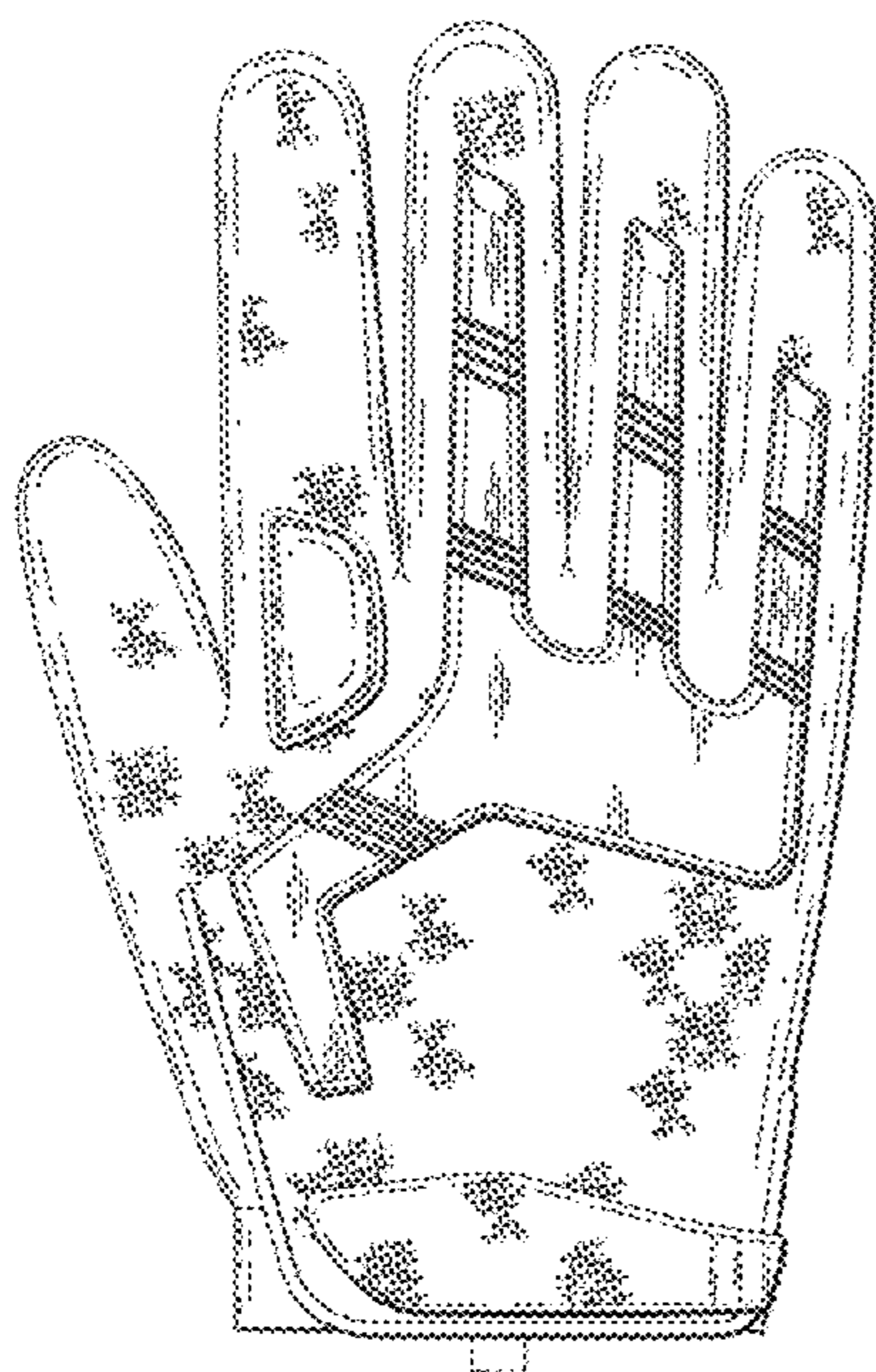
FIG. 5 is a right side elevational view thereof;

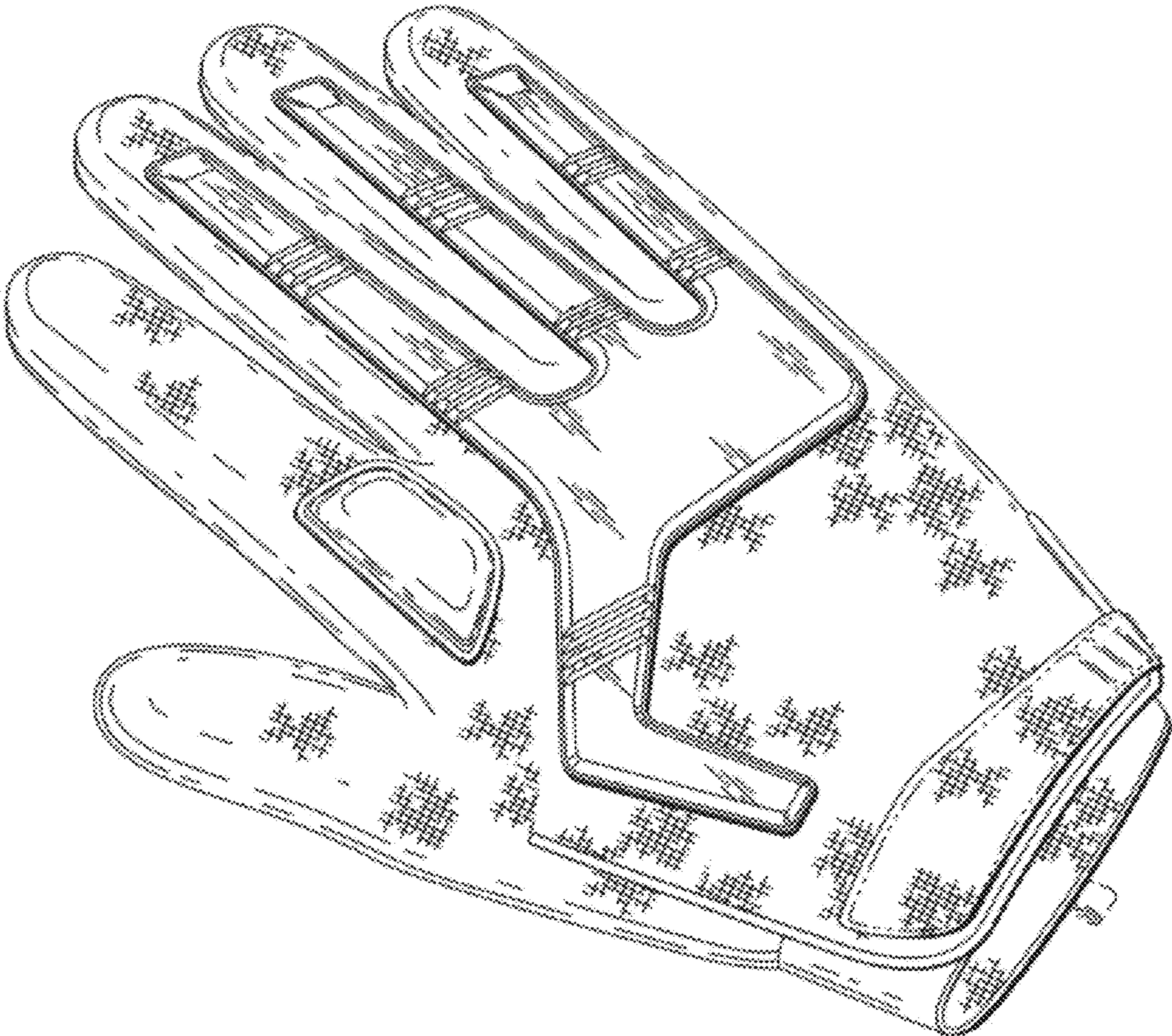

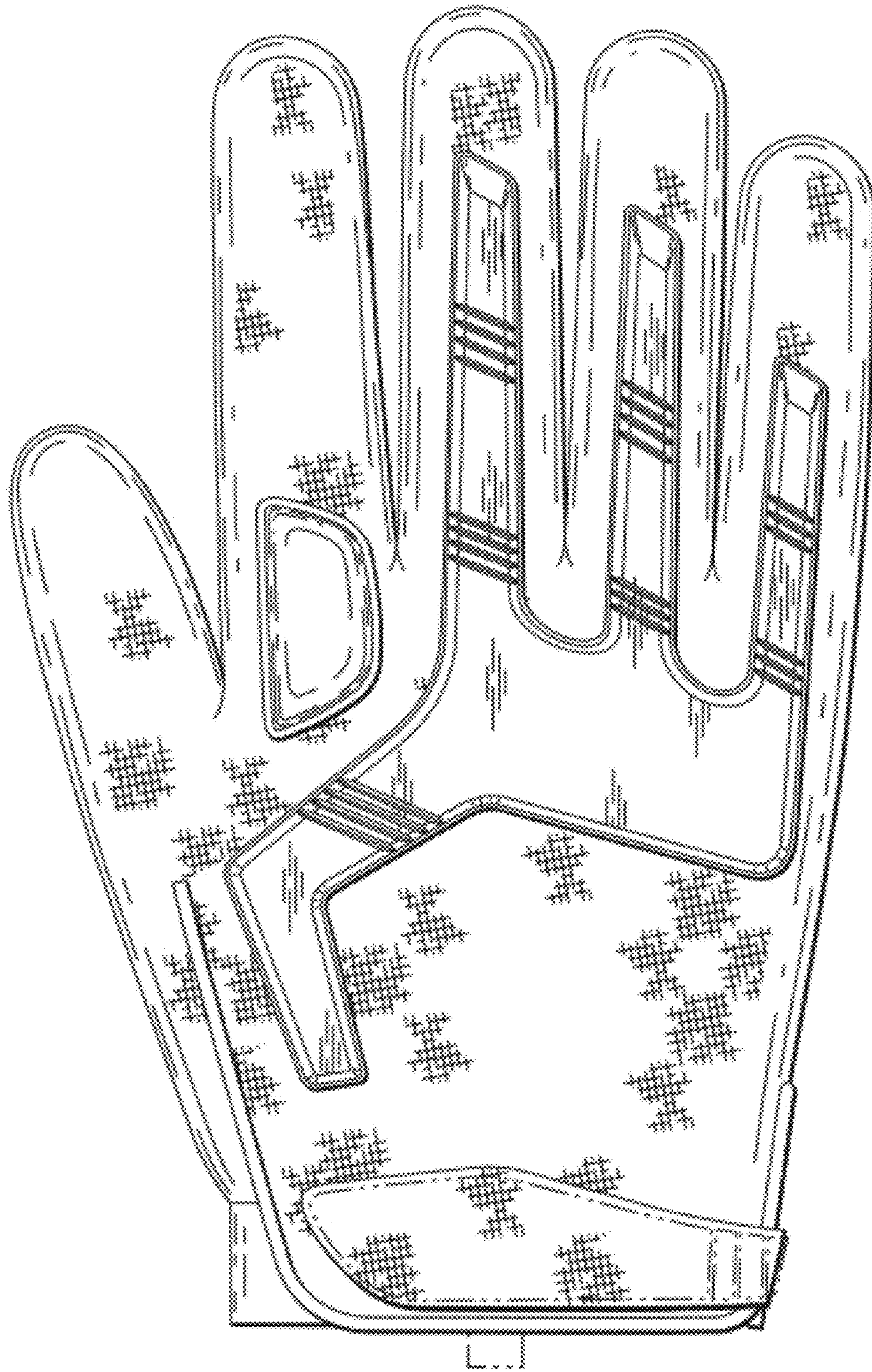

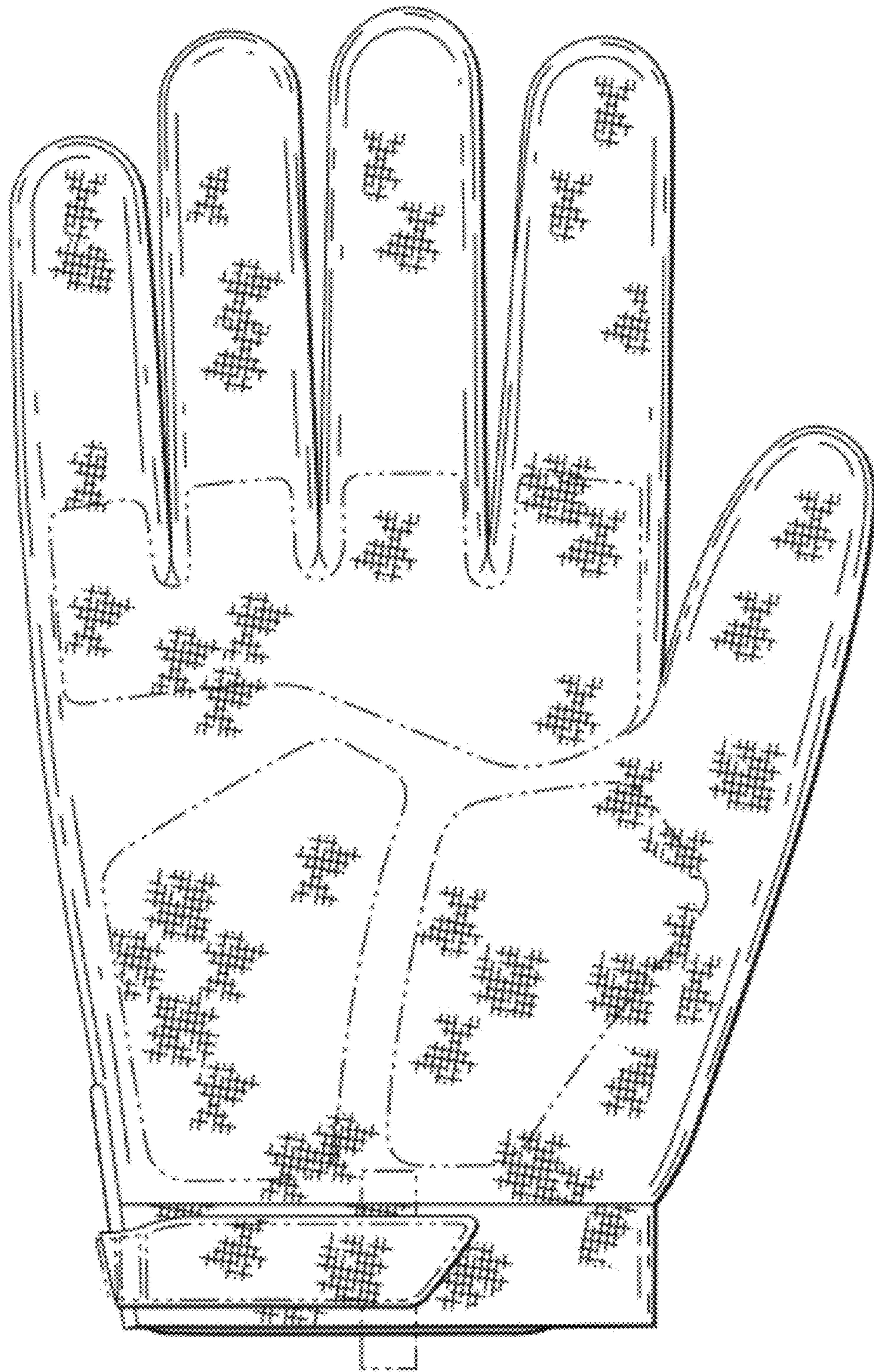

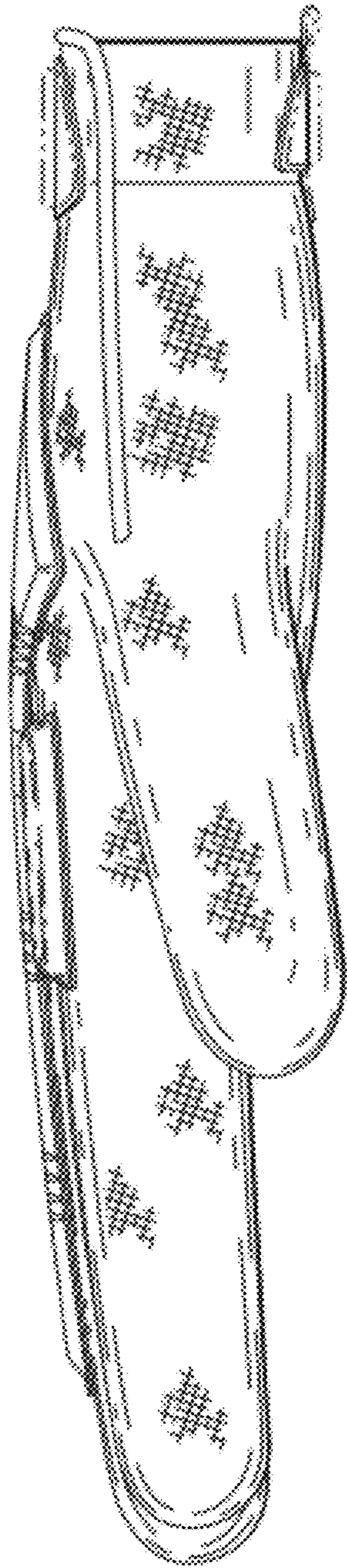

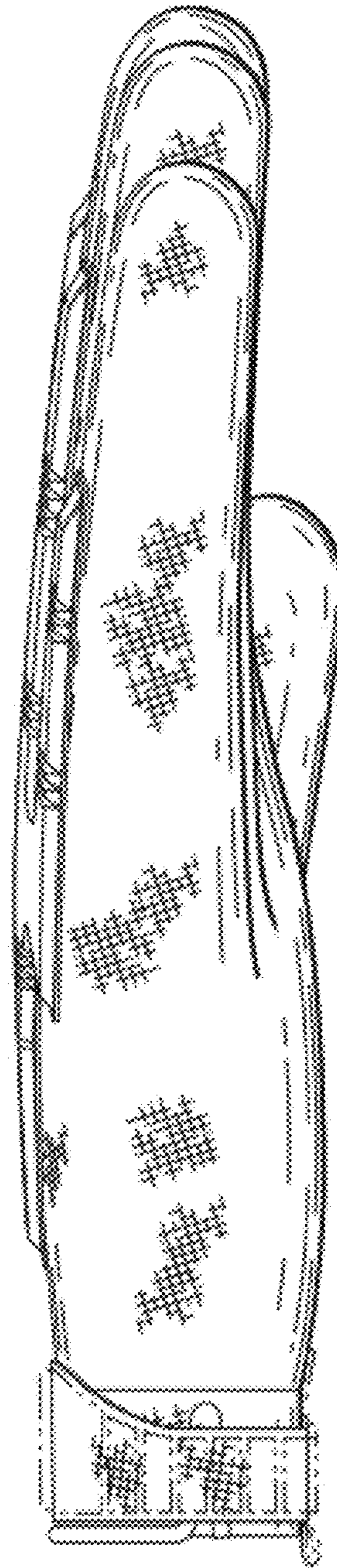
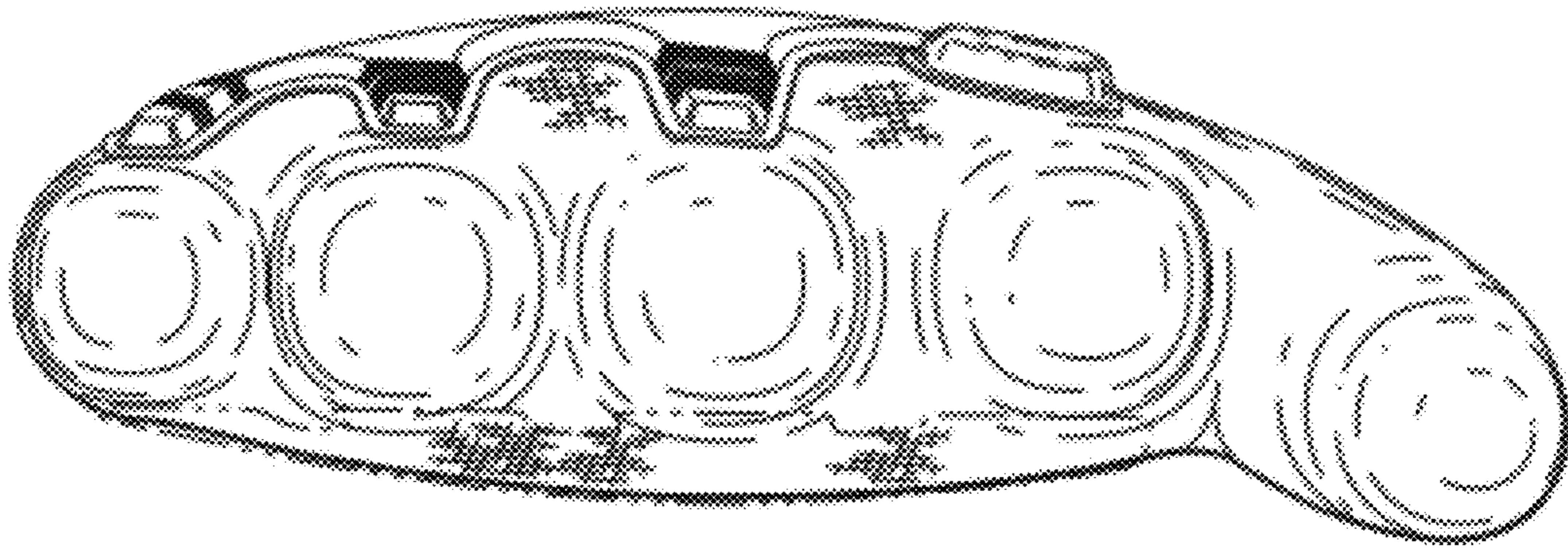
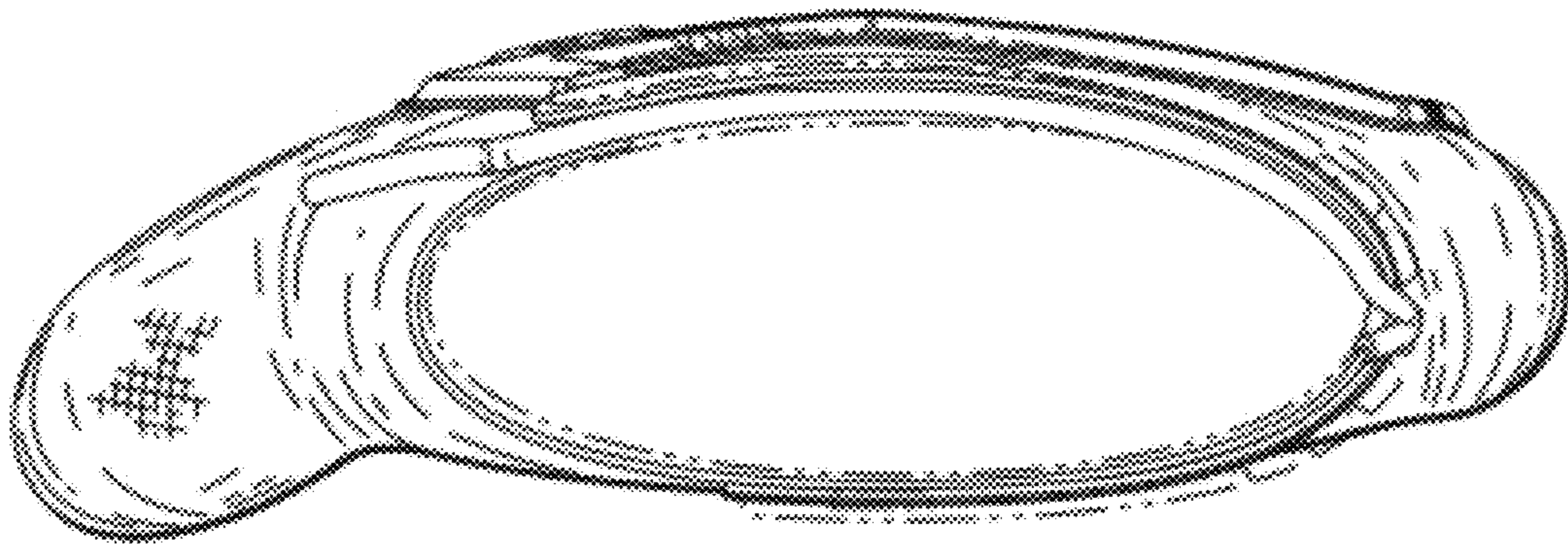
