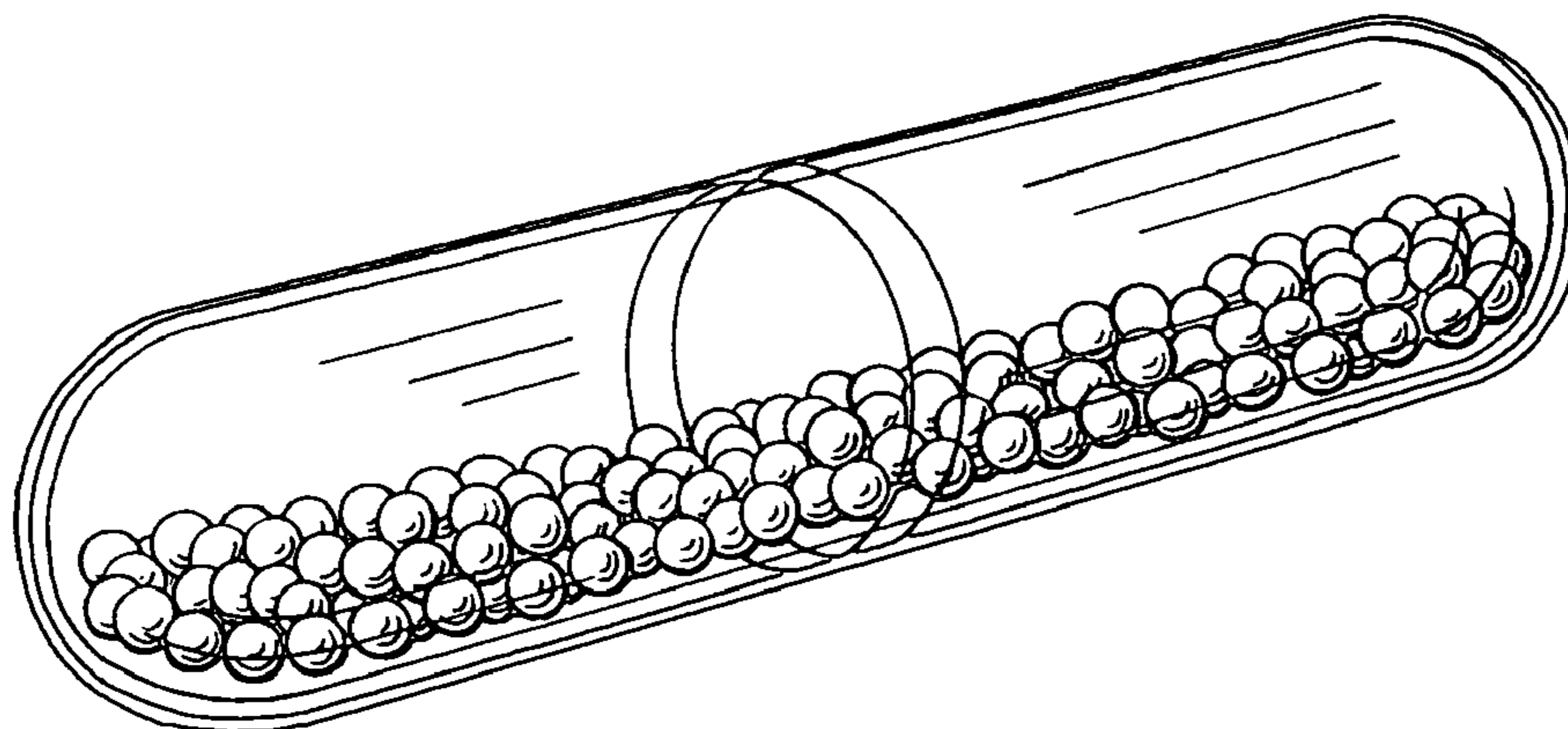
(57) **CLAIM**

We claim the ornamental design for the rollable toy for pets, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the invention, showing our new design;
FIG. 2 is a side elevational view thereof; the opposite side being identical;
FIG. 3 is a top plan view thereof; the bottom being identical; and,
FIG. 4 is an end elevational view thereof; the opposite end being identical.

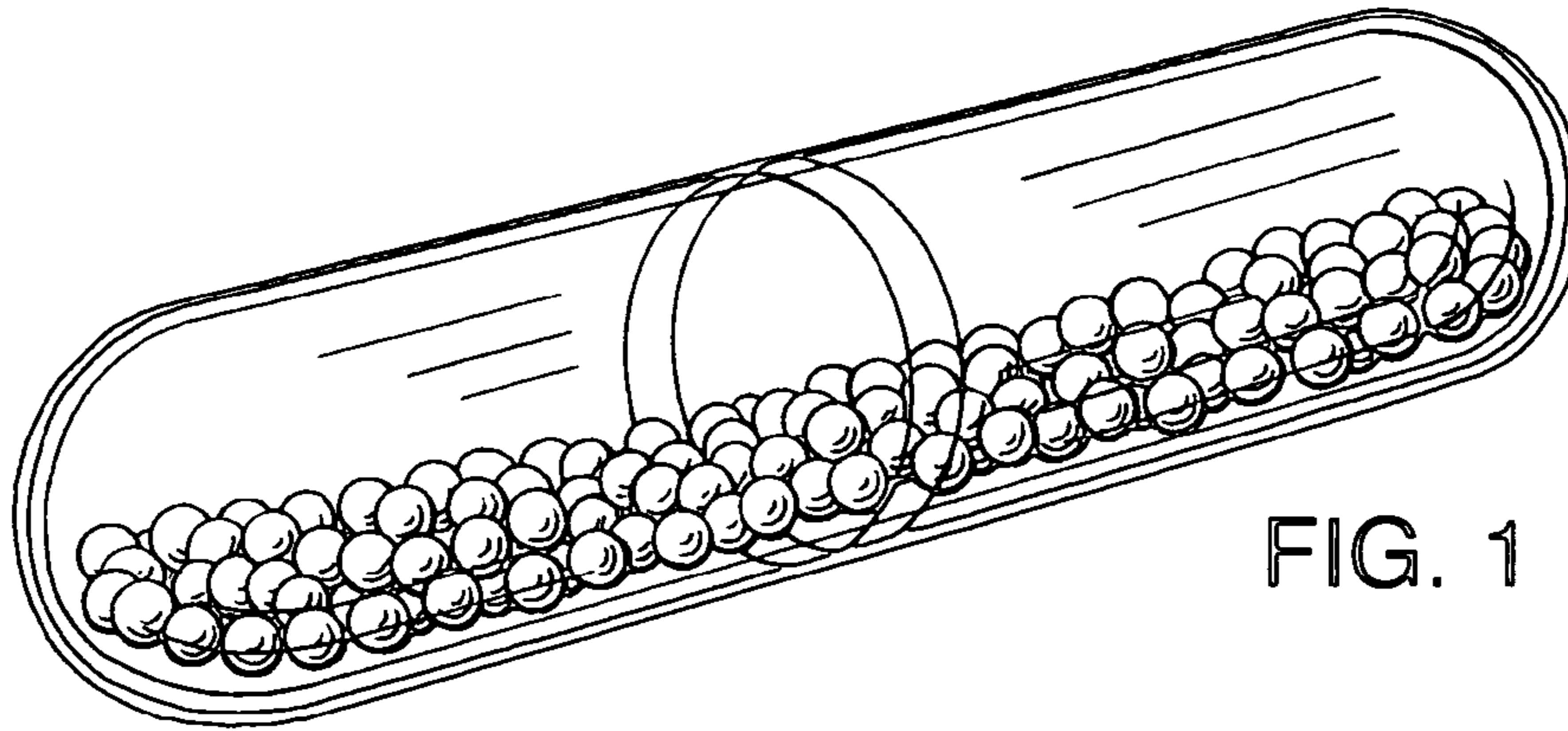

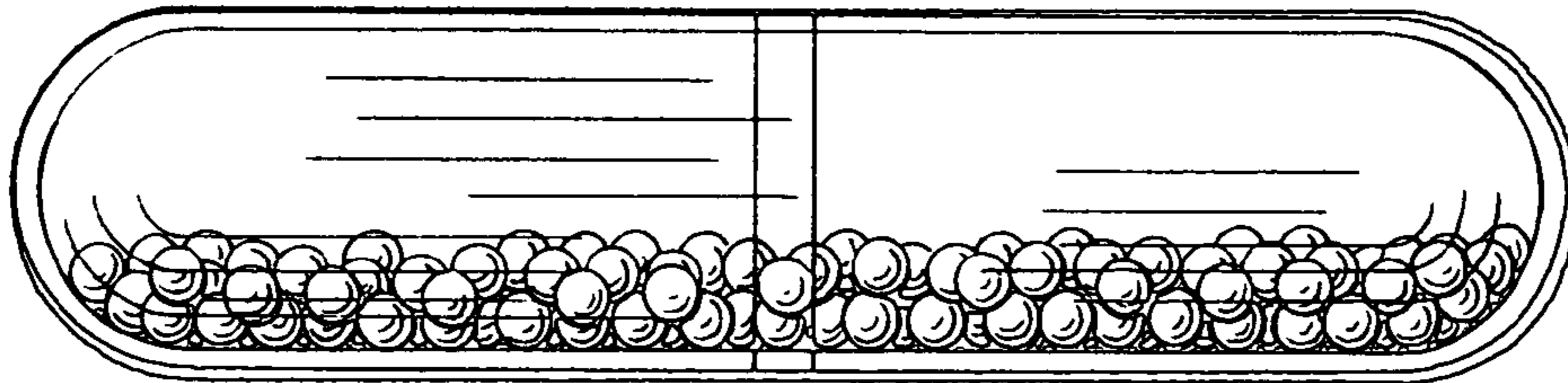

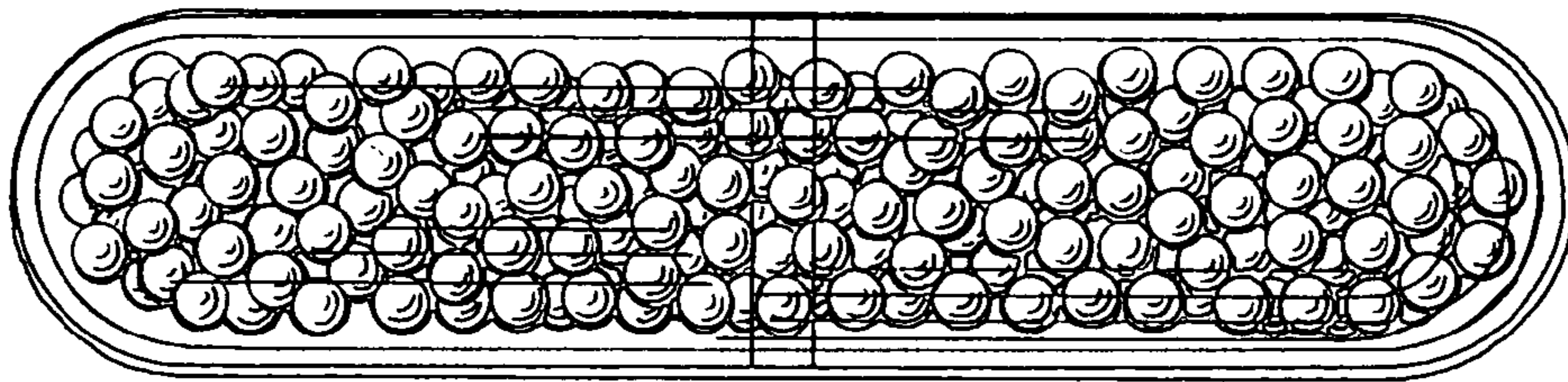

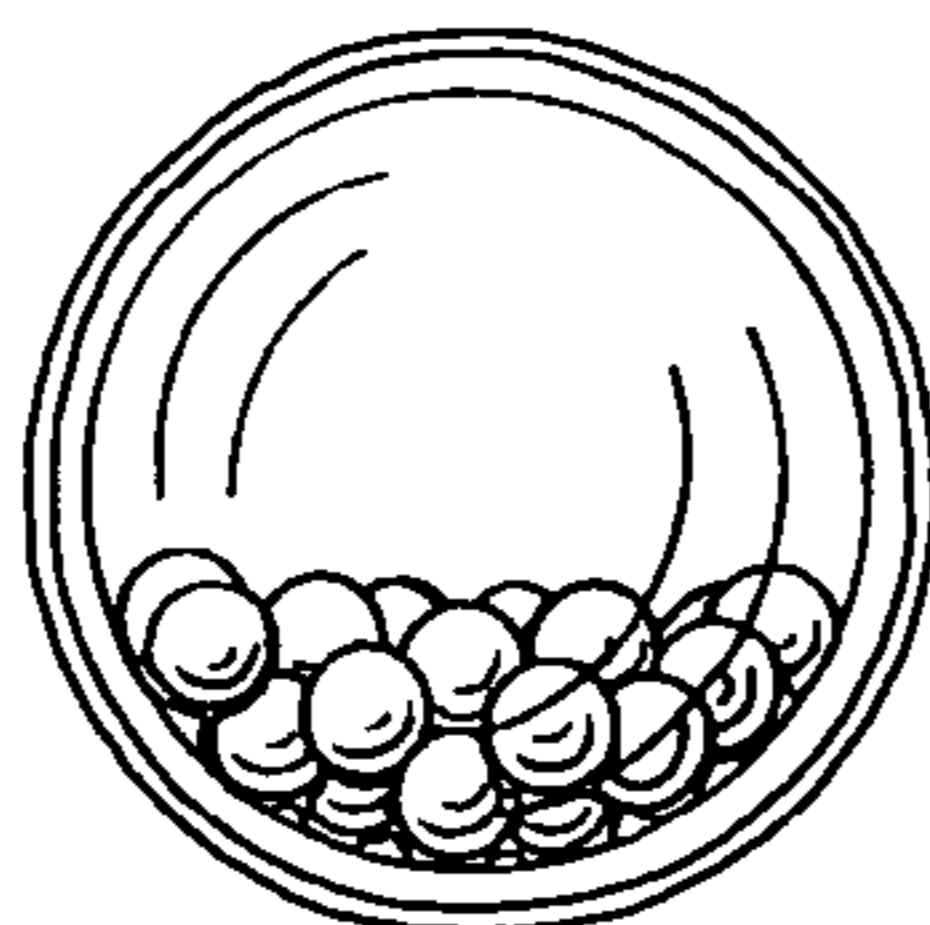
