DESCRIPTION

FIG. 1 is a perspective view of a cleat bottom according to the present invention;

FIG. 4 is a right side view of the cleat bottom of FIG. 1;

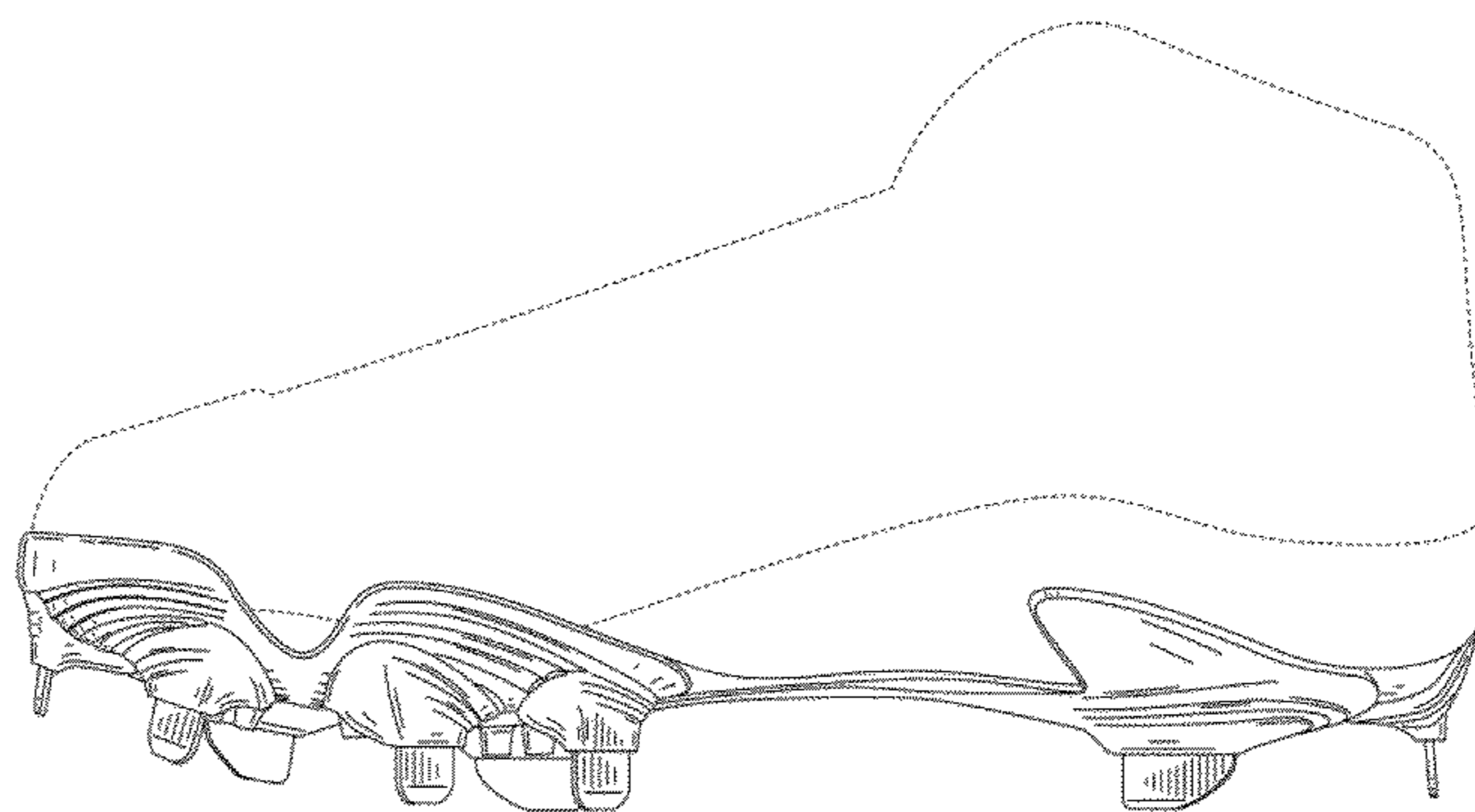
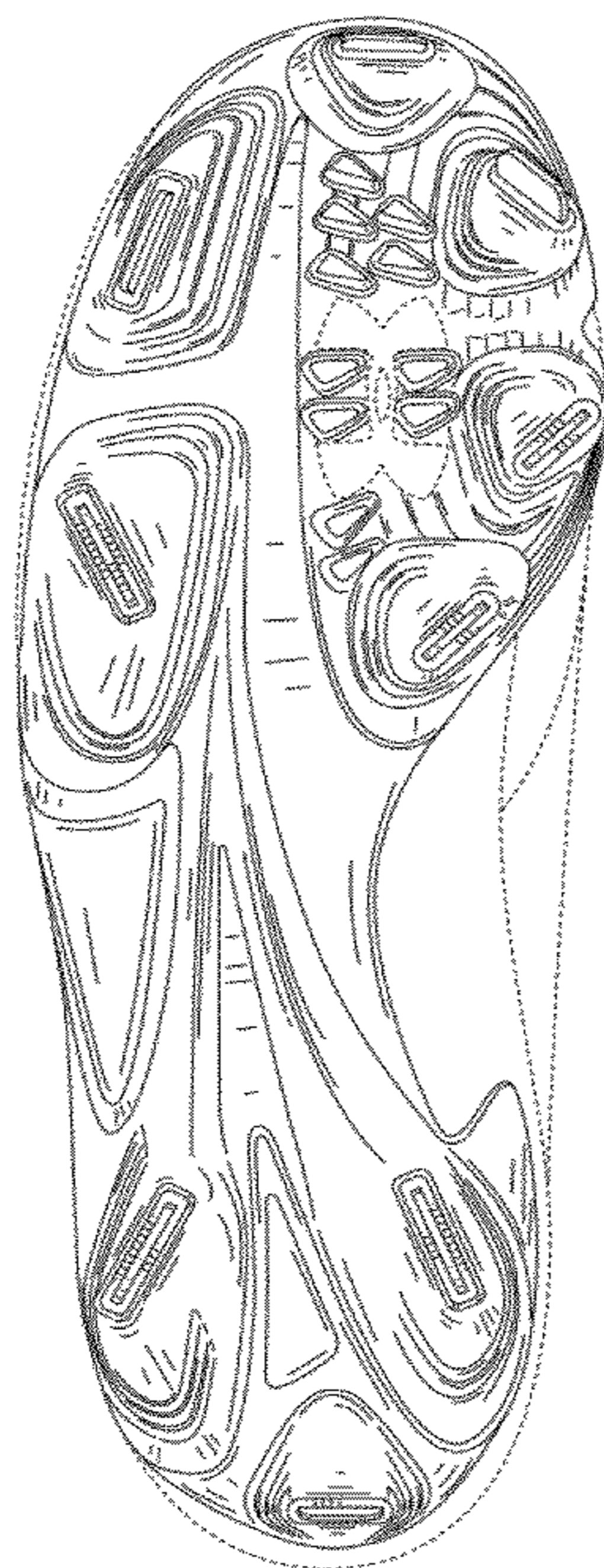
FIG. 5 is a left side view of the cleat bottom of FIG. 1;

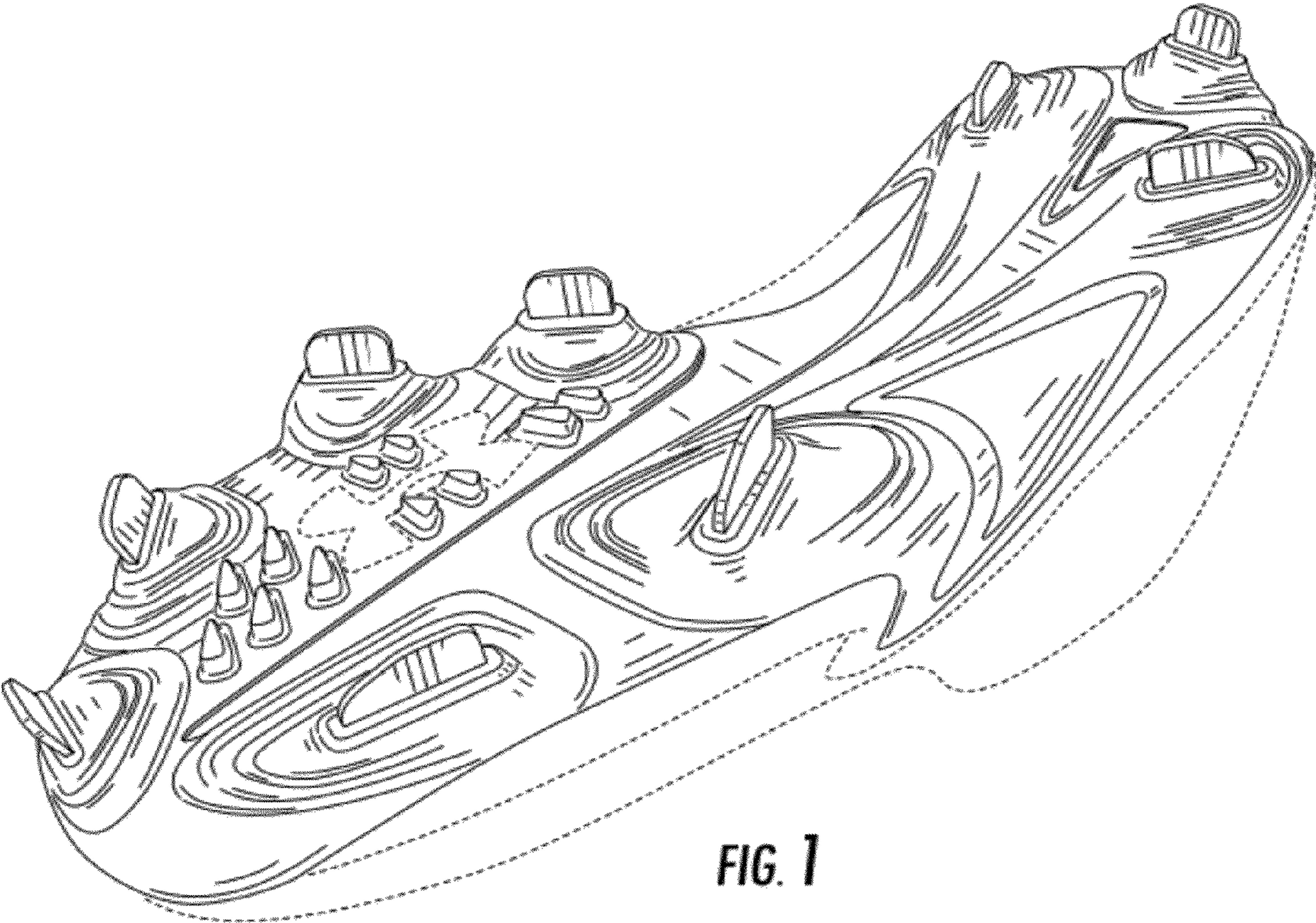

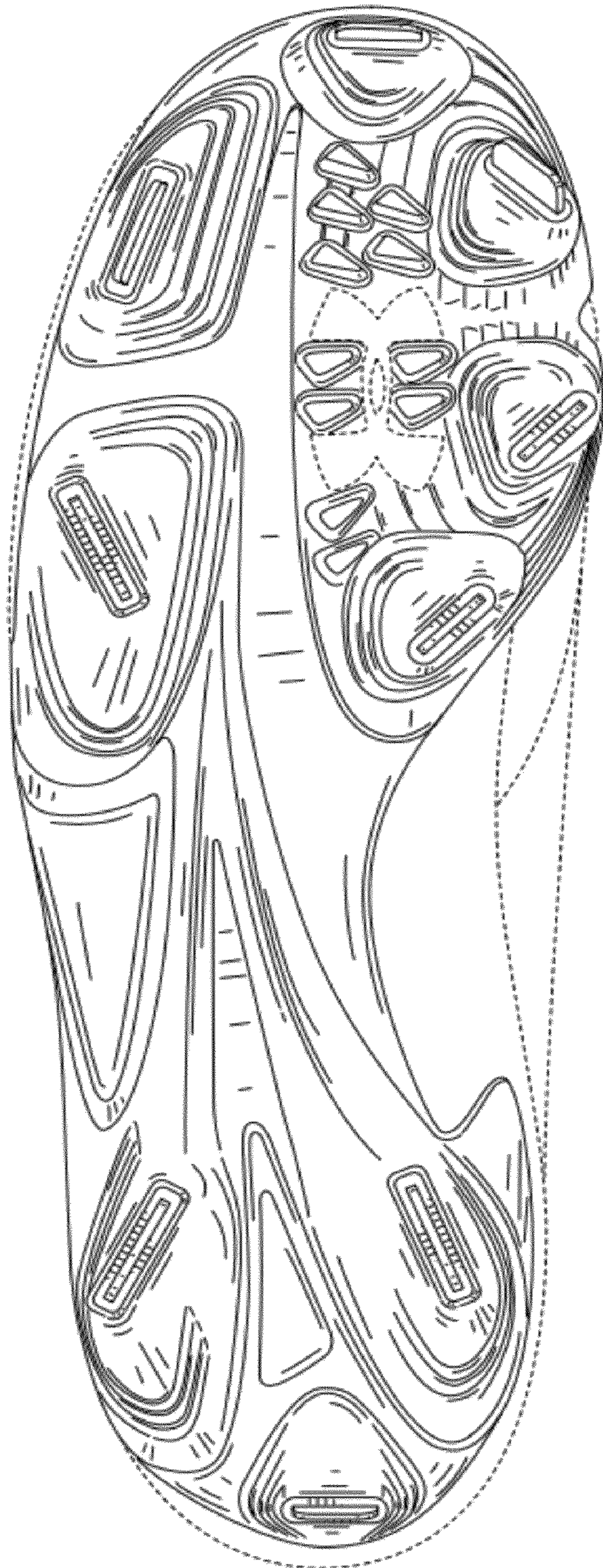

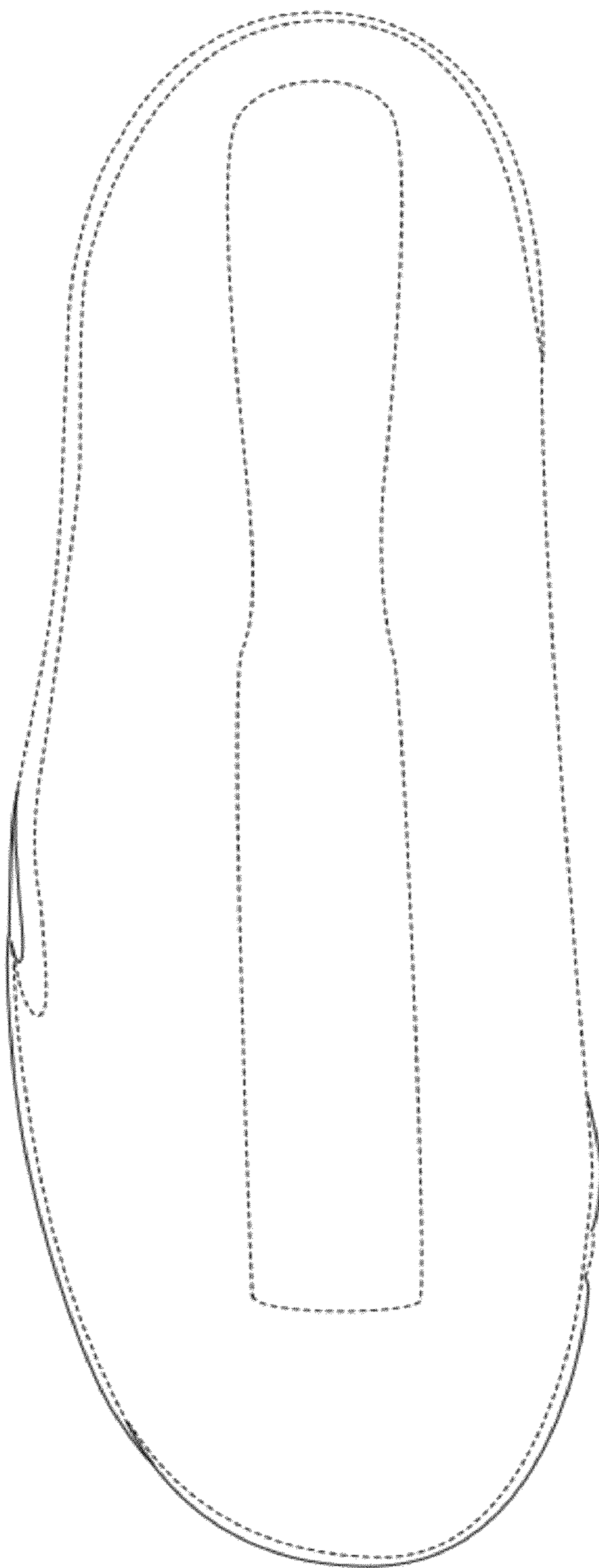

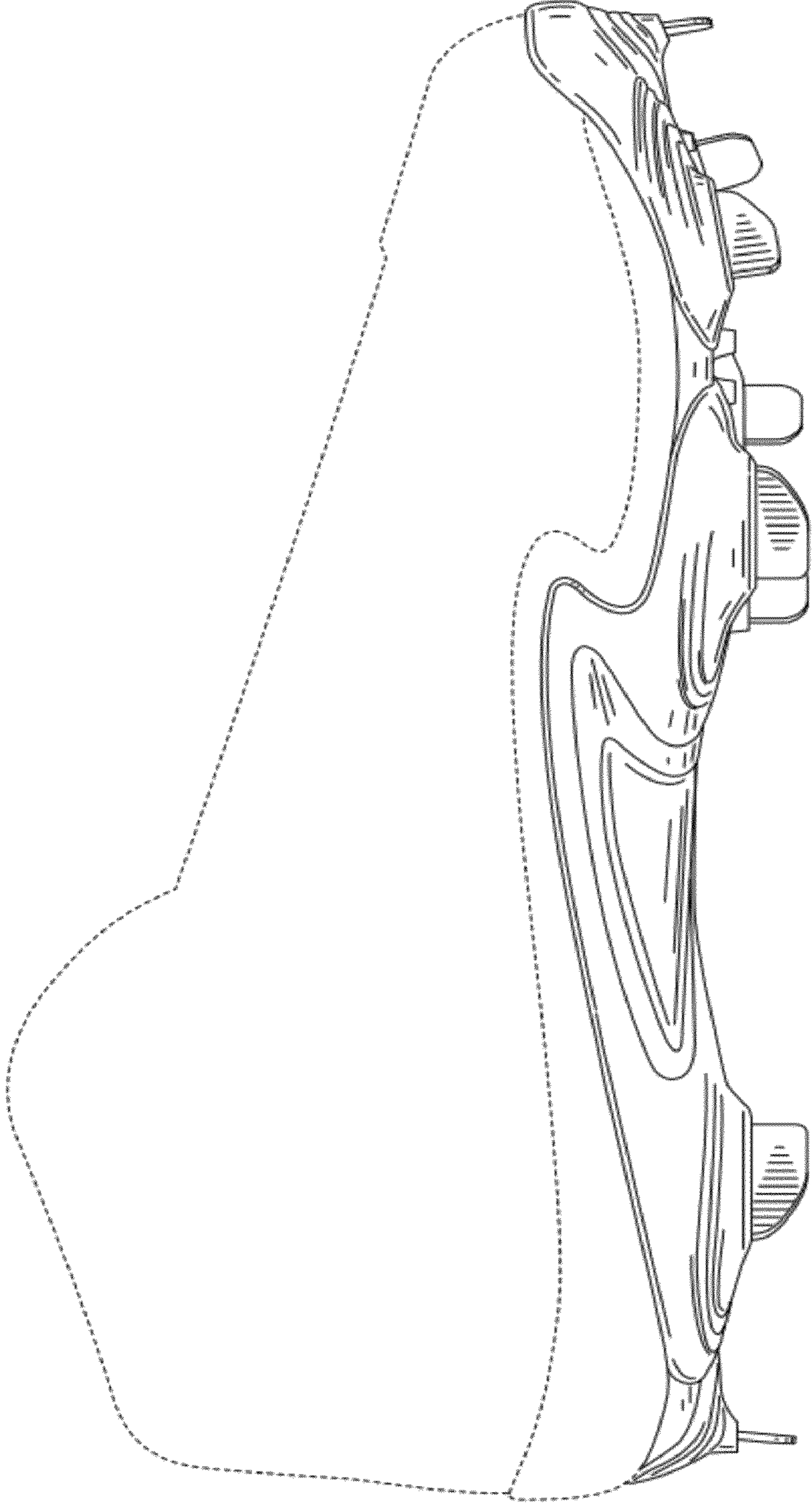

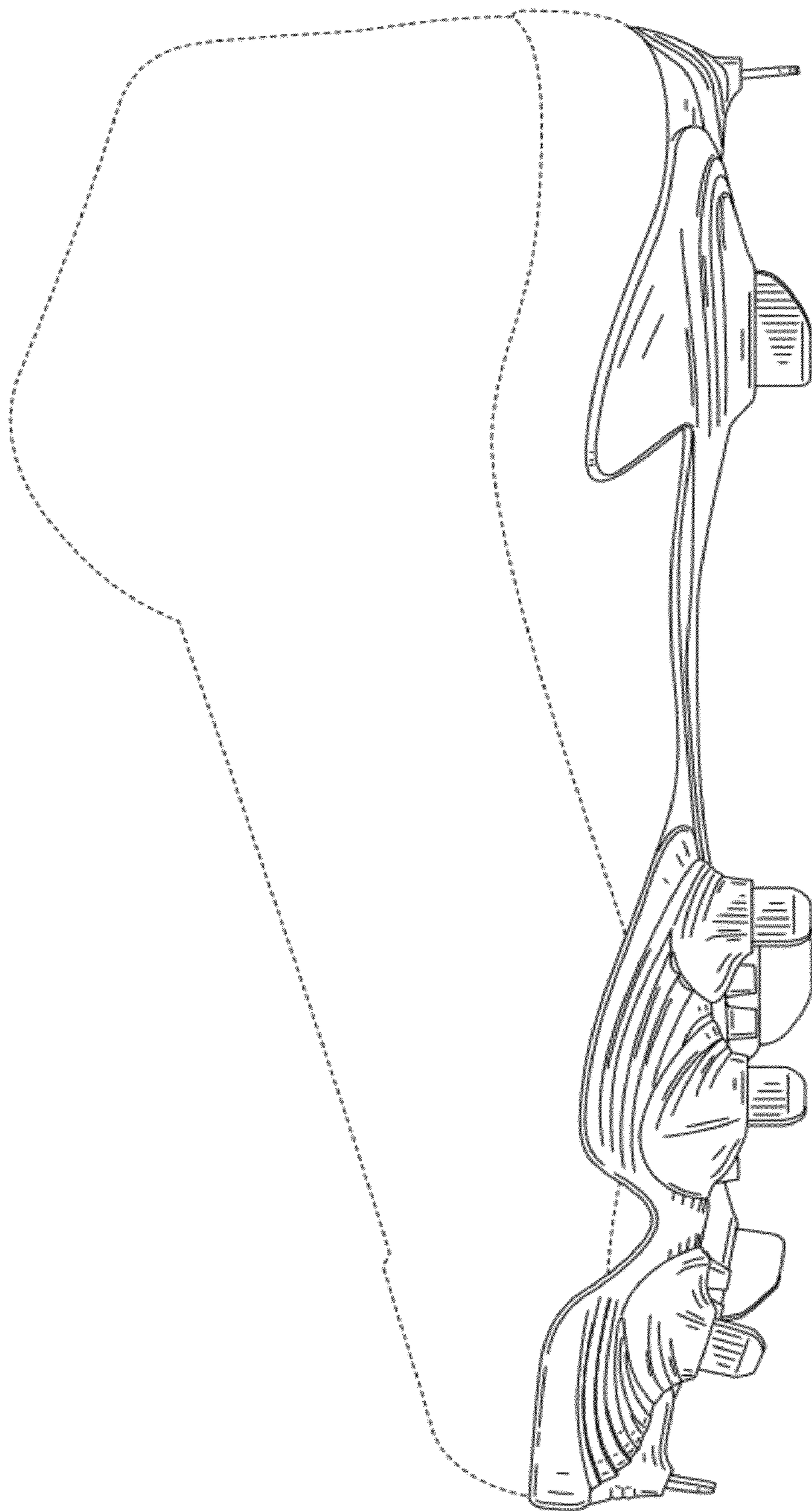

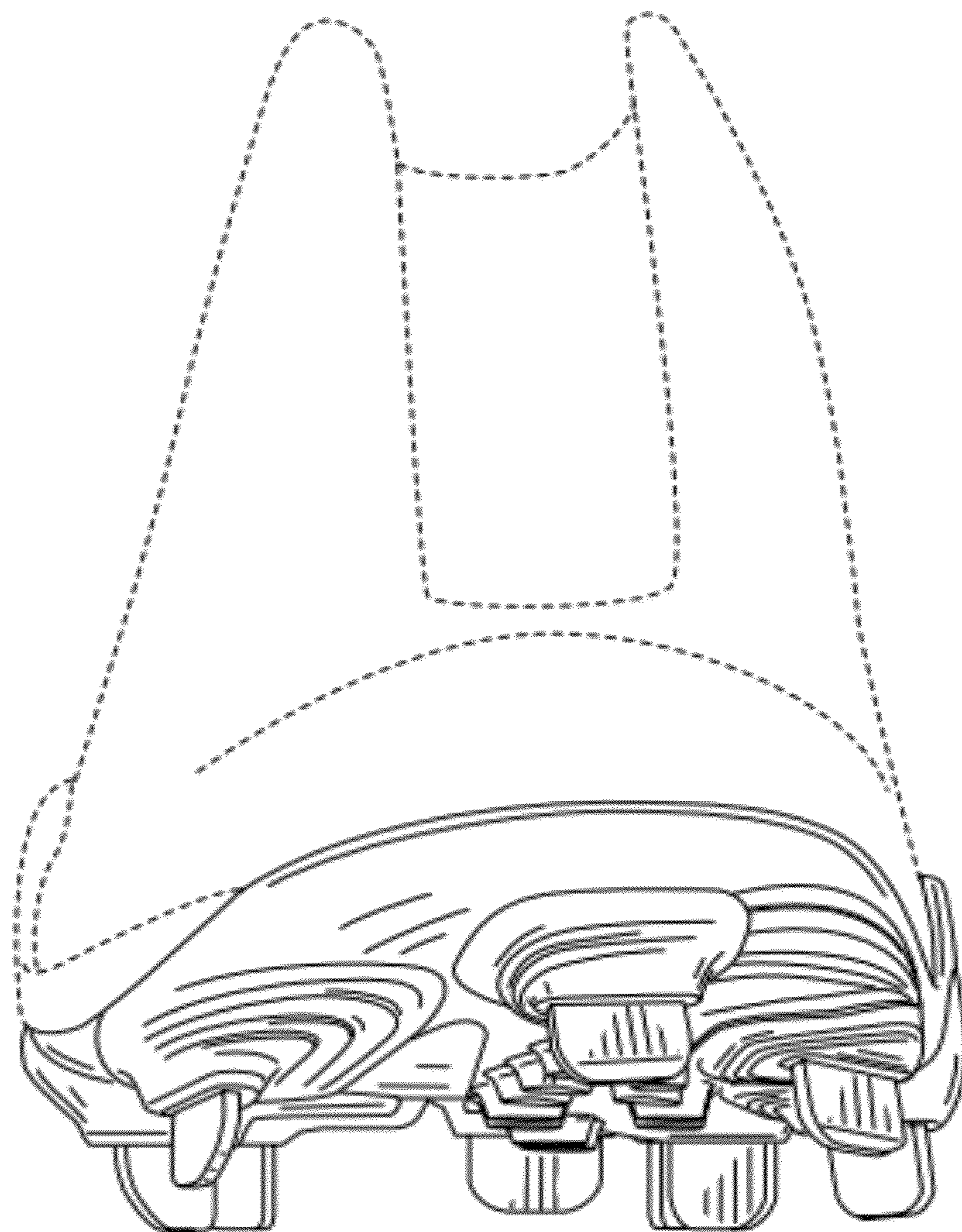

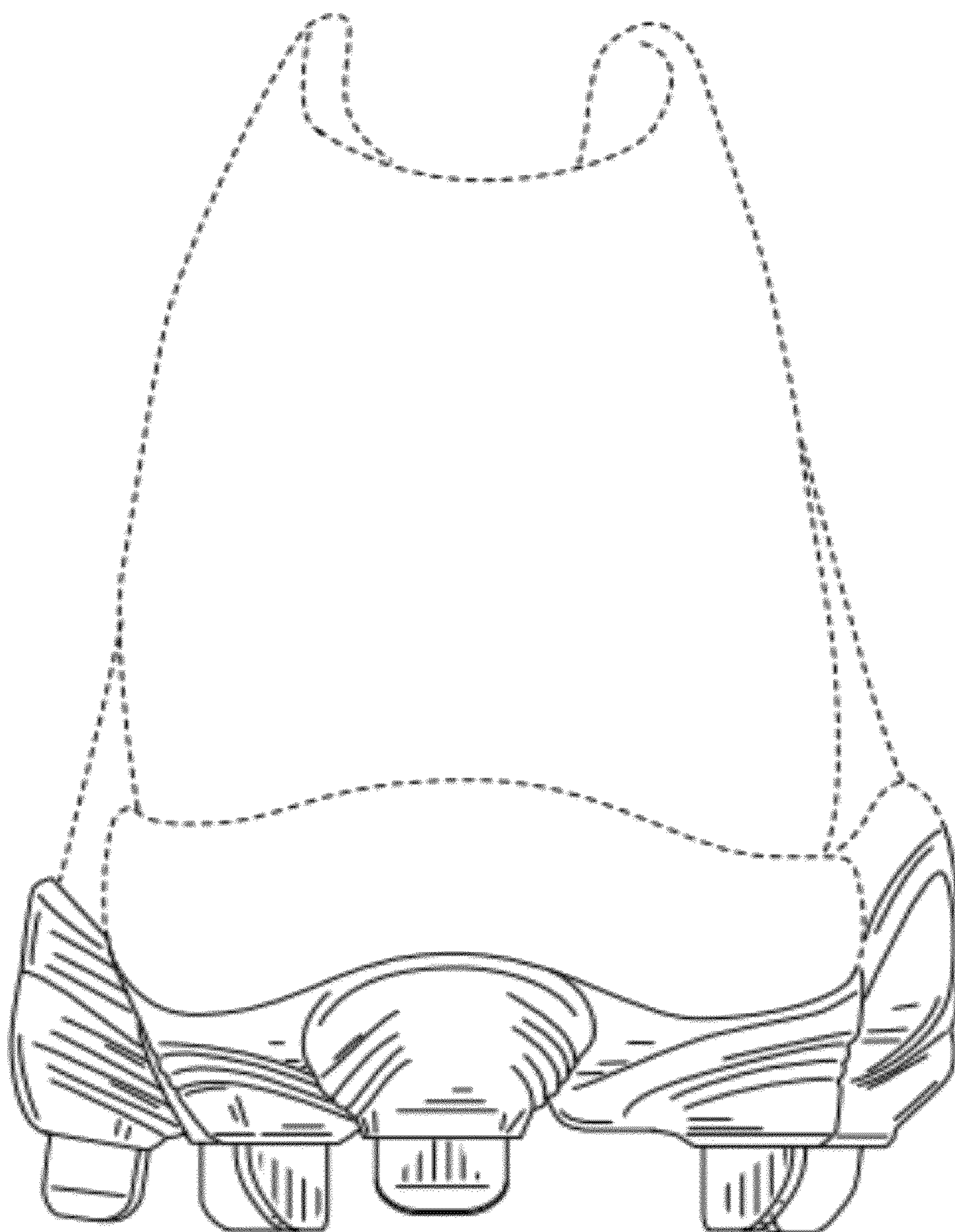
