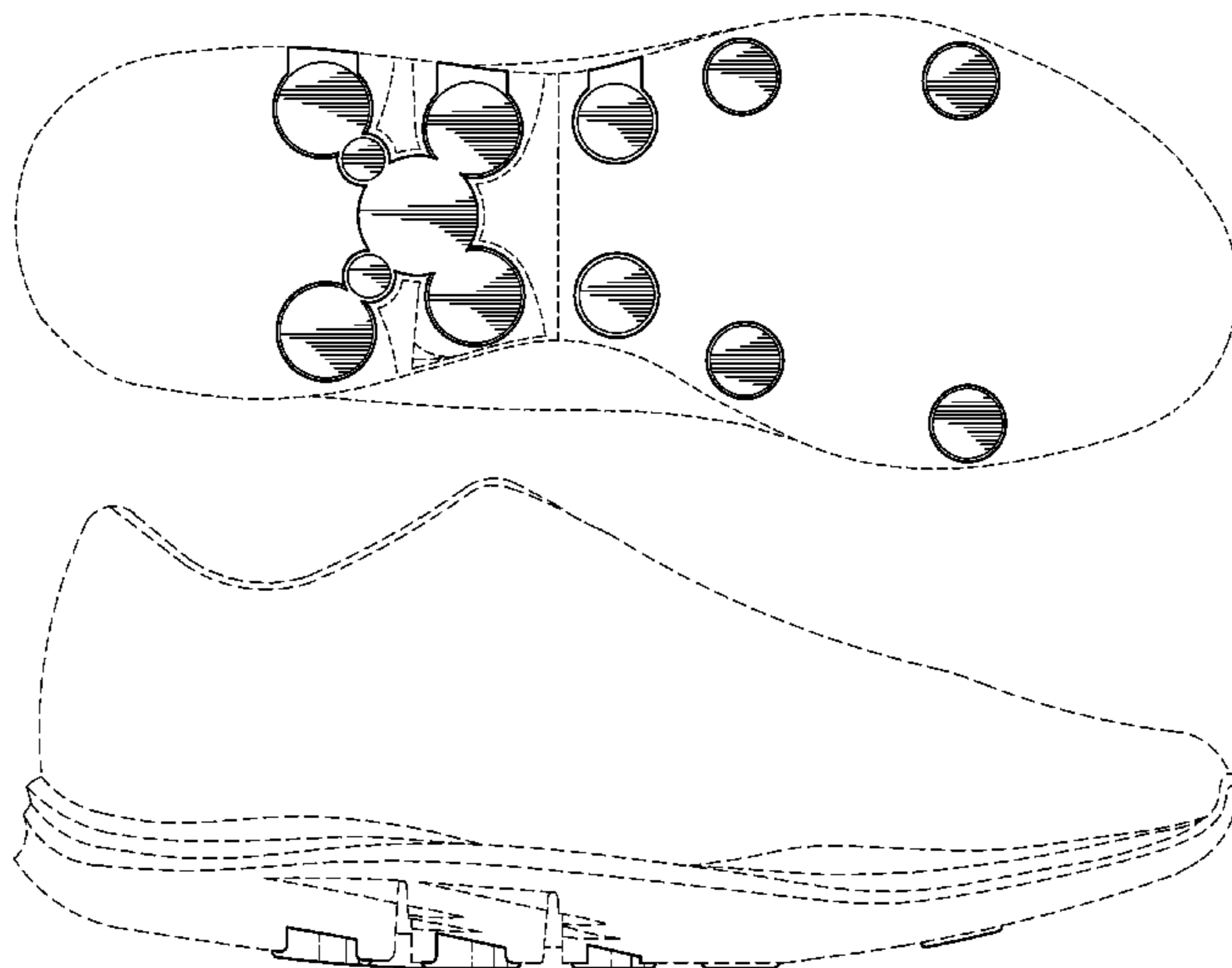
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a shoe bottom in accordance with my new design.
 FIG. 2 is a bottom plan view thereof;

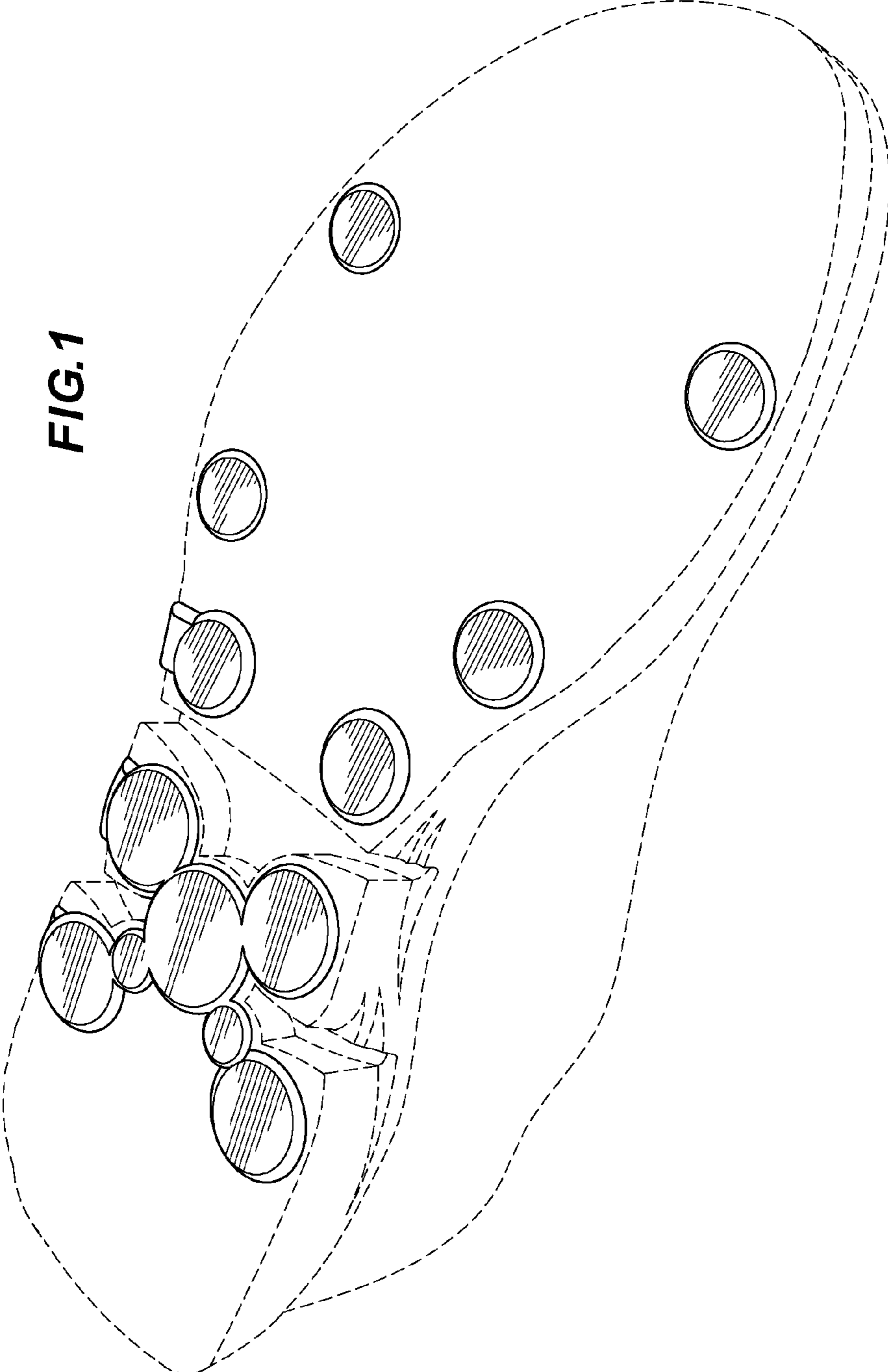

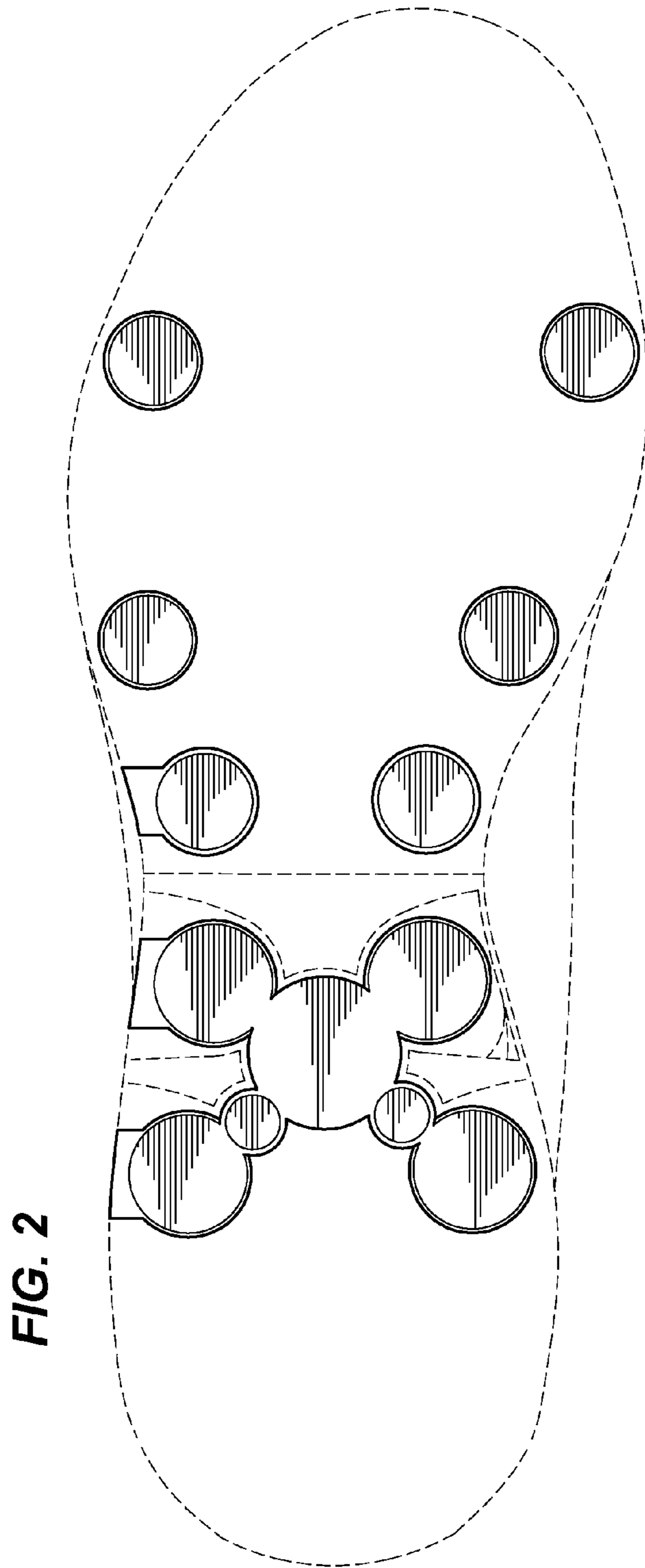
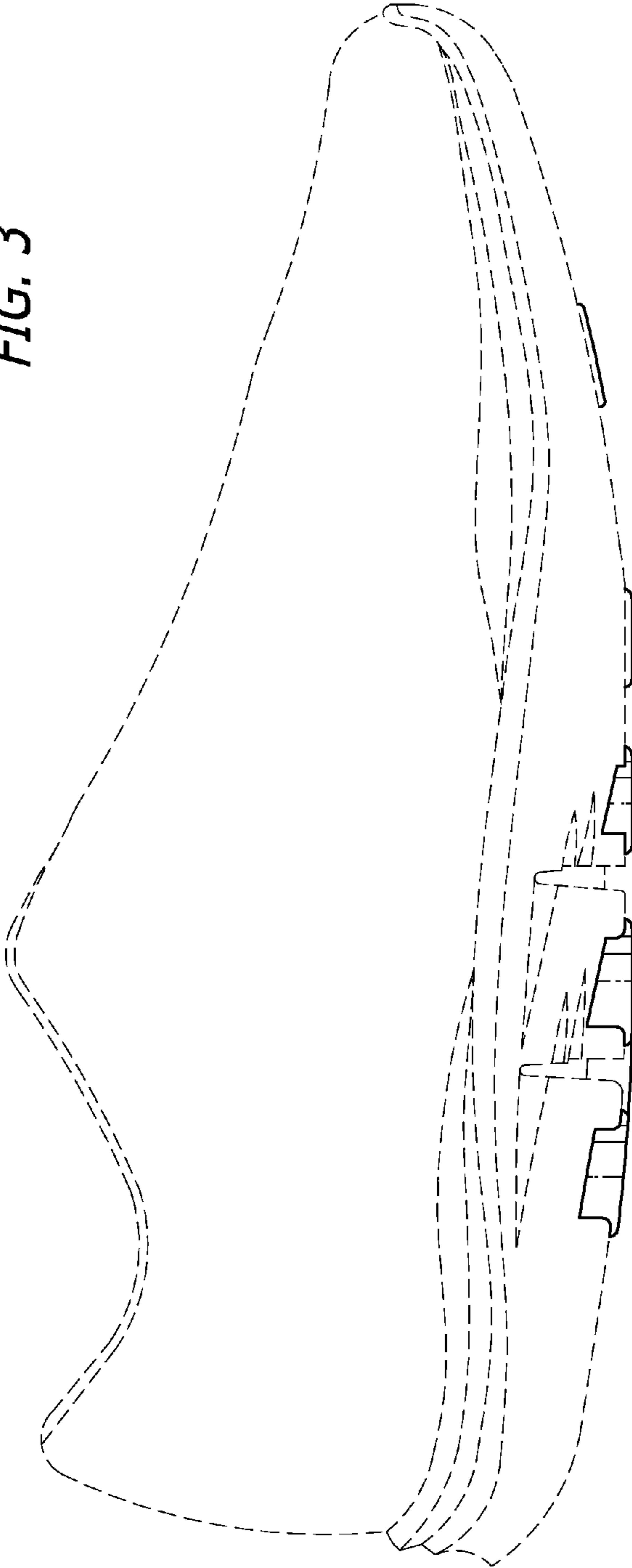

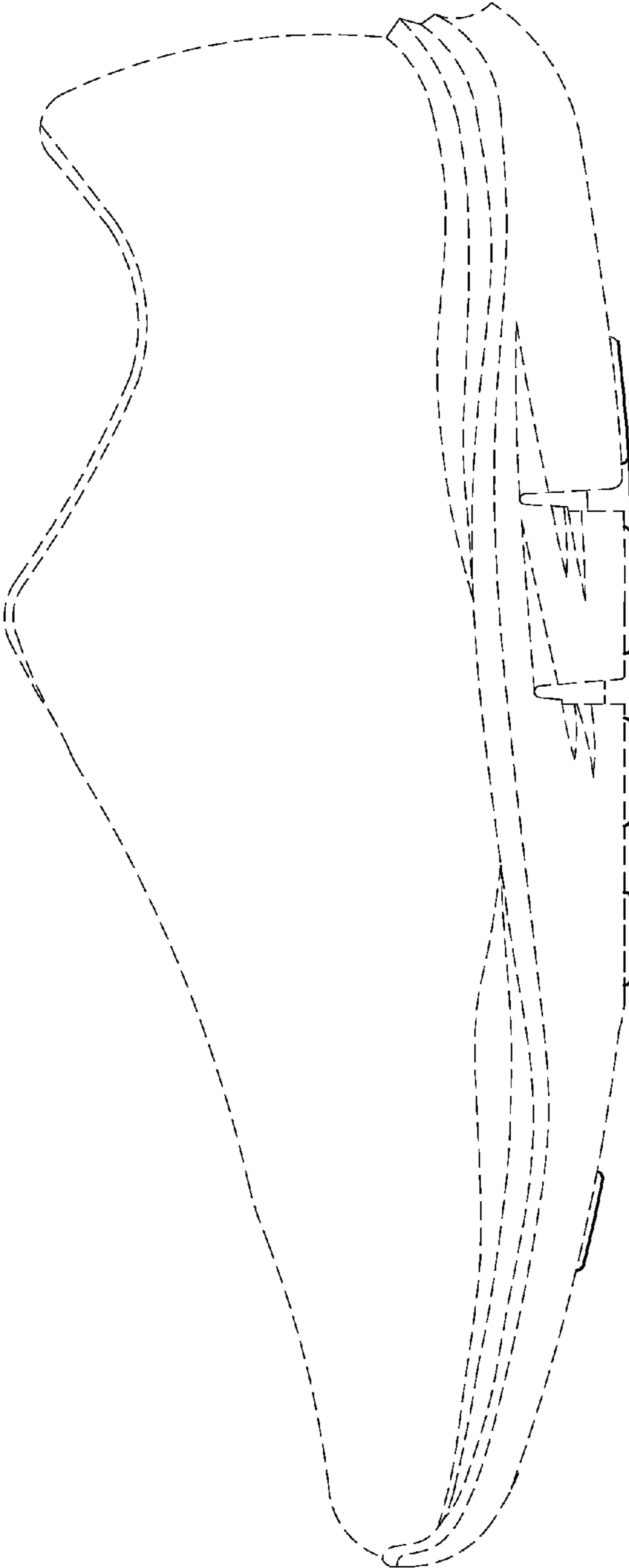

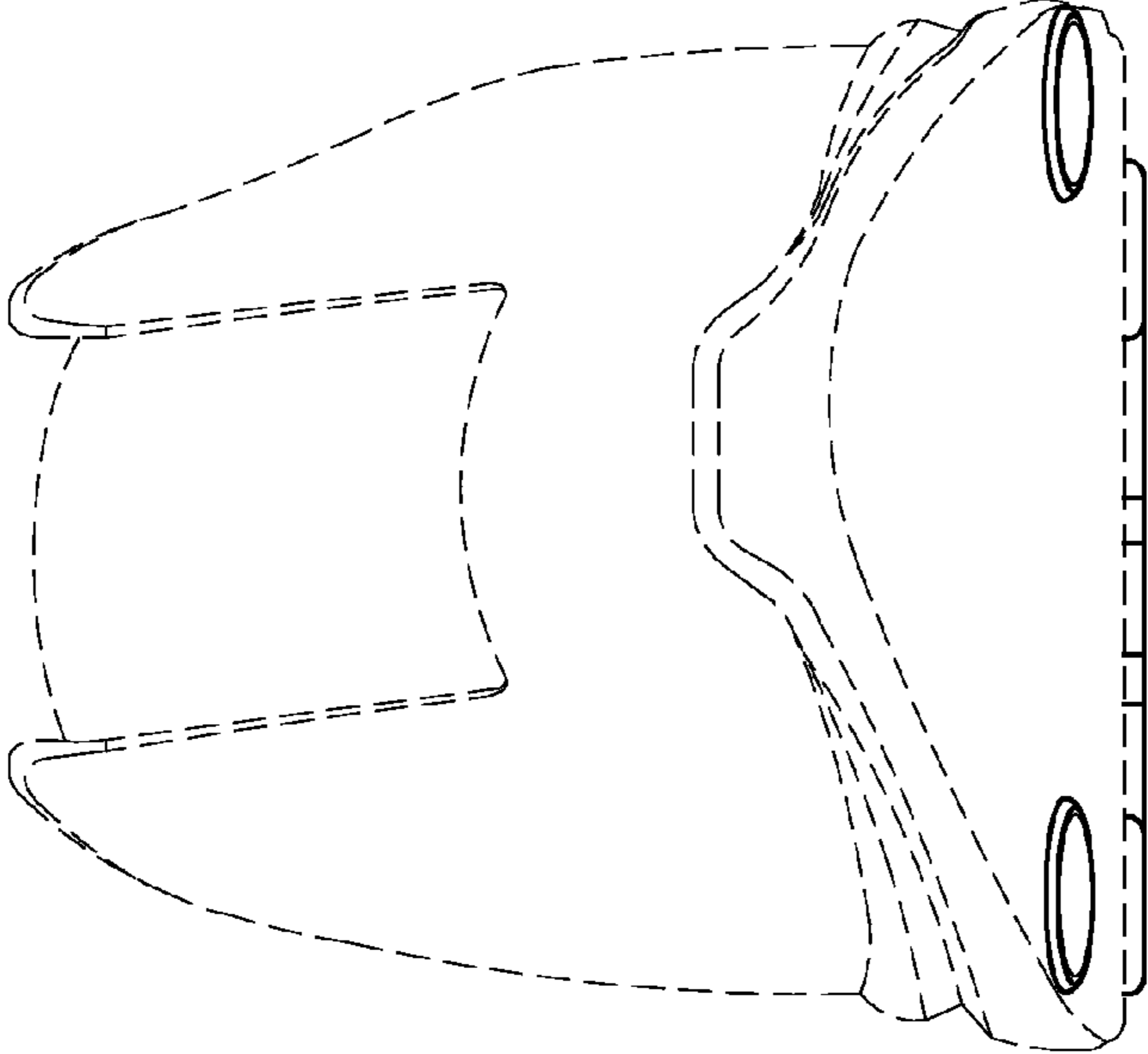

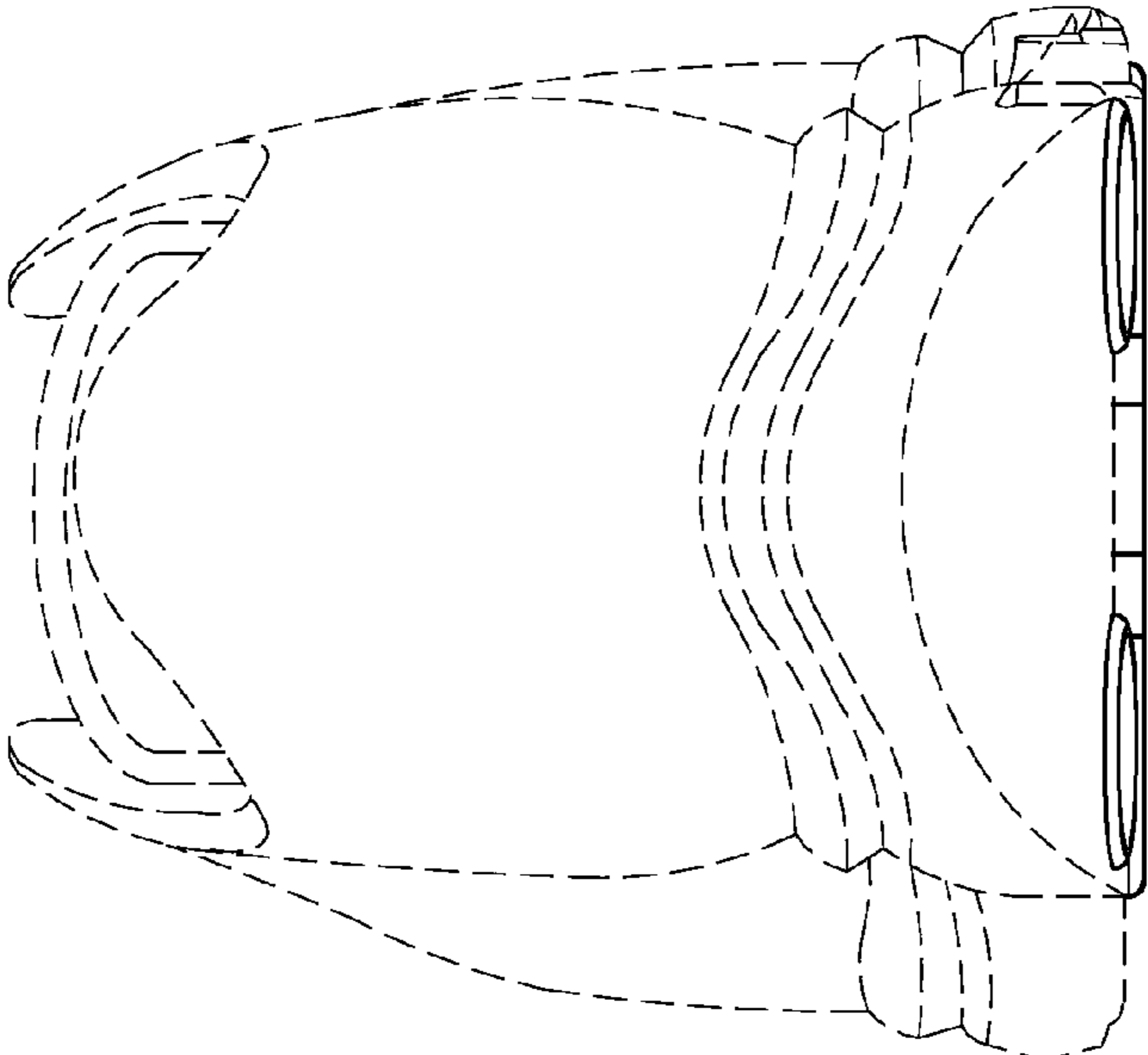
