The ornamental design for a luggage sleeve with top, as
shown and described.

DESCRIPTION

FIG. 1 is an isometric view from the front, left and top of a
luggage sleeve with top showing my new design; the broken
lines depicting the indicia and luggage form no part of my
design;

FIG. 2 is an isometric view of the front, left and top thereof;
FIG. 3 is a front view thereof, the rear view being a mirror
image thereof;

FIG. 4 is a left side view thereof;

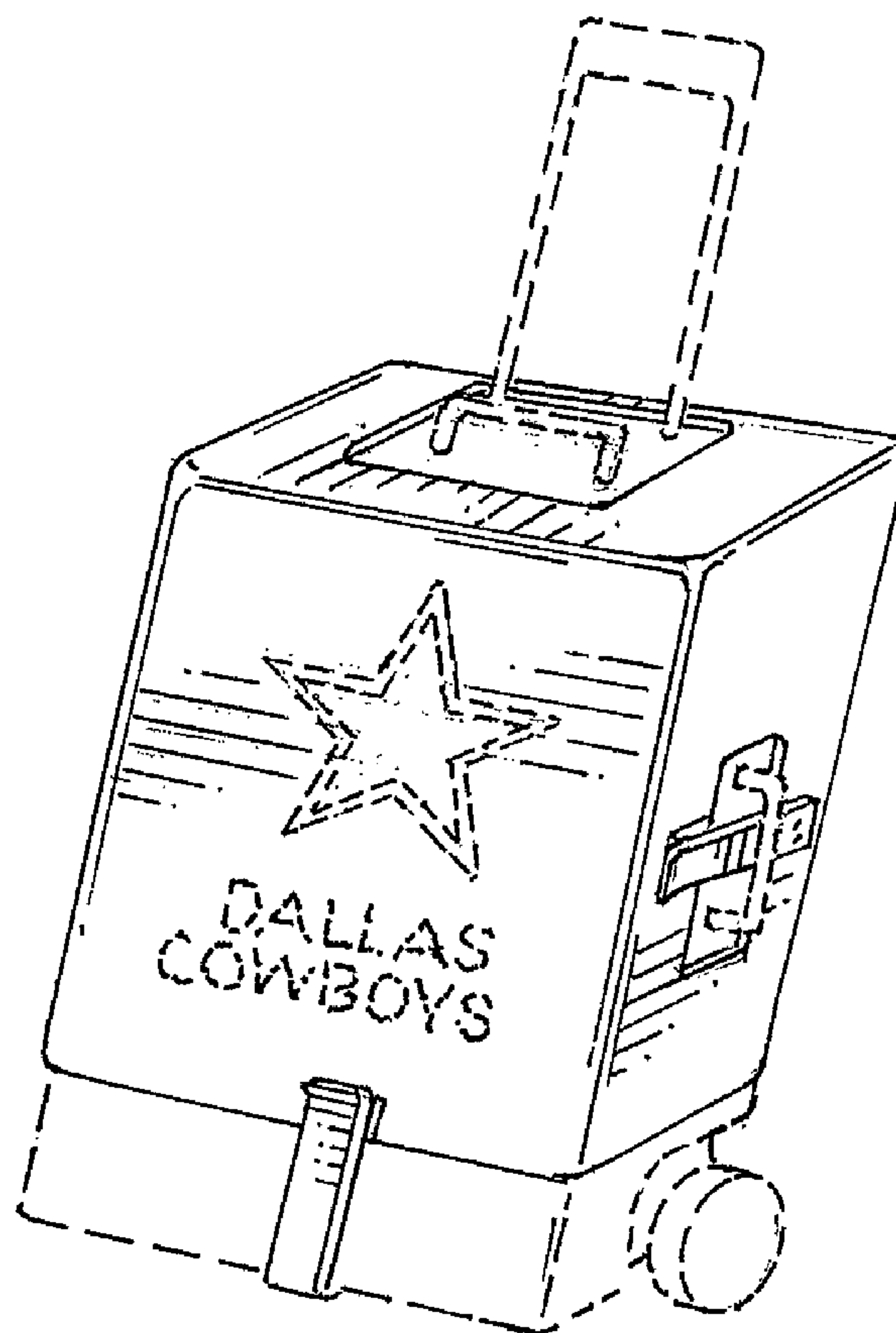
FIG. 5 is a right side view thereof;

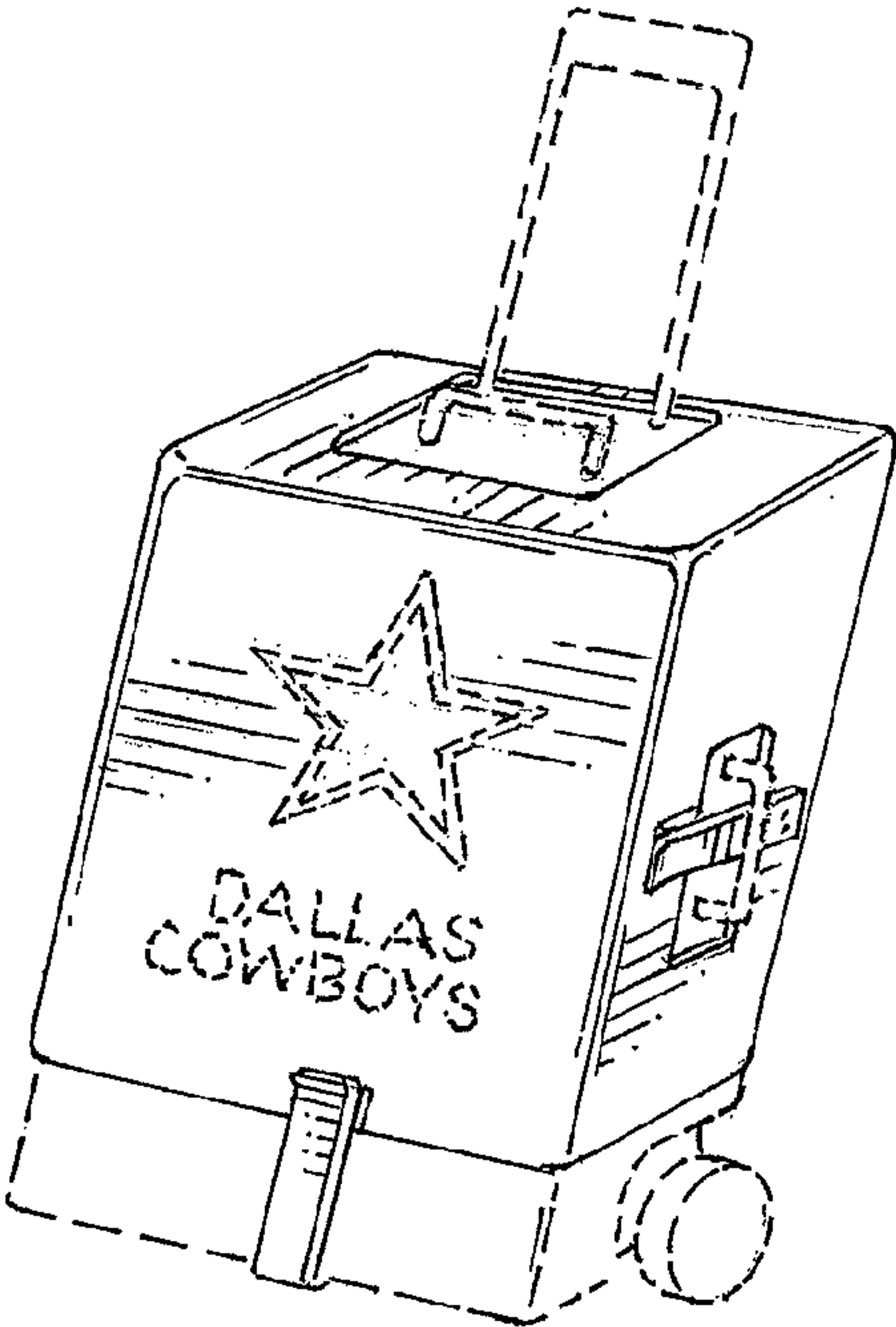

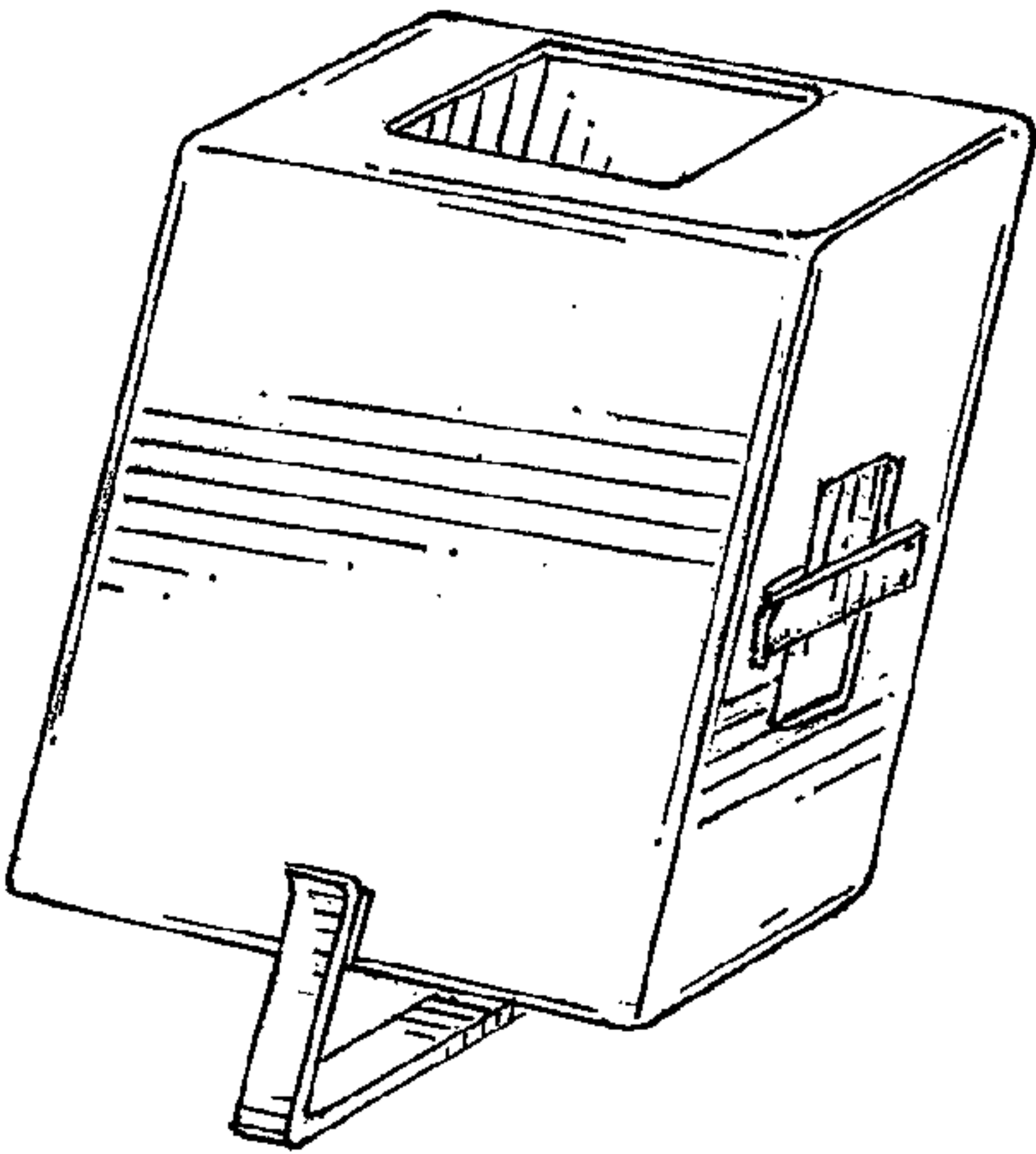

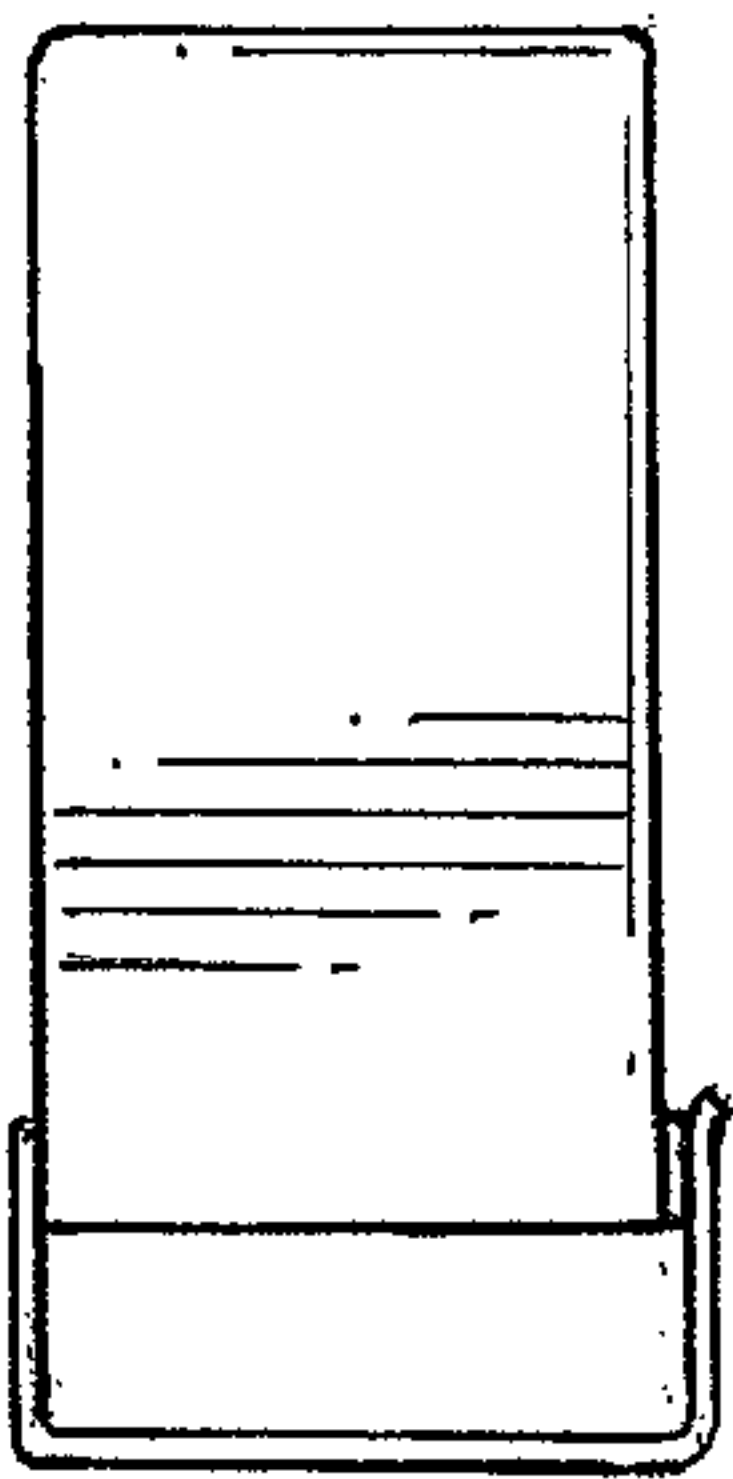

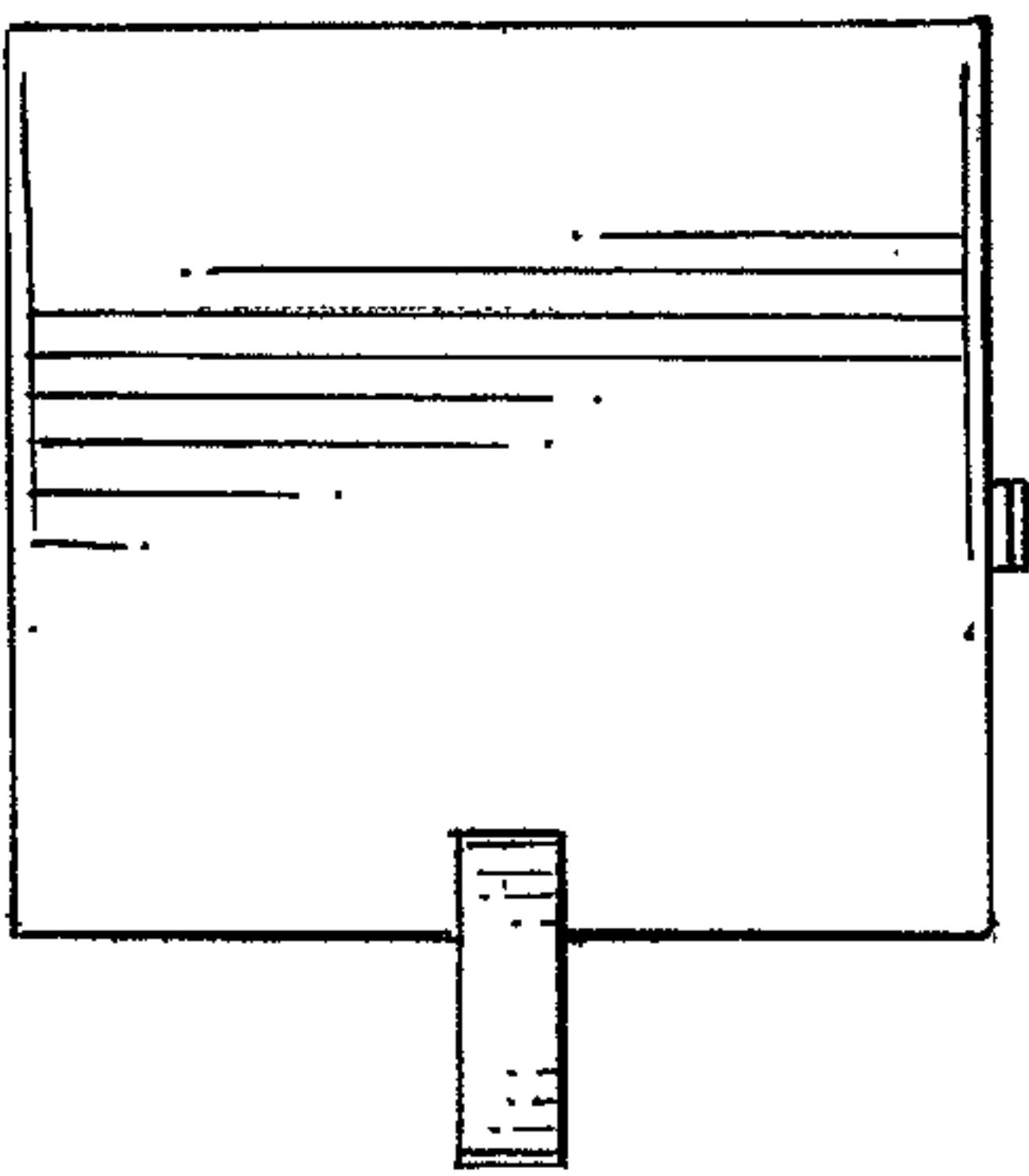

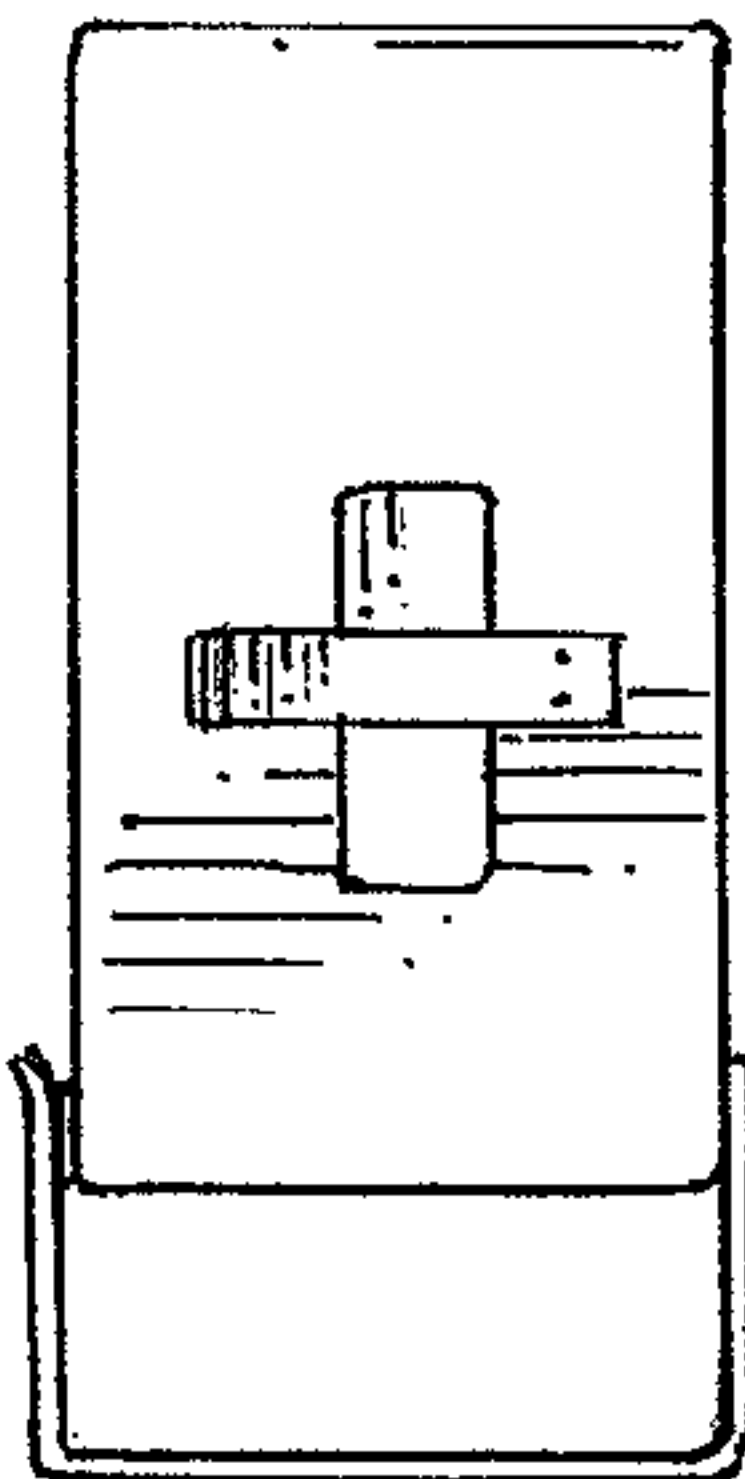

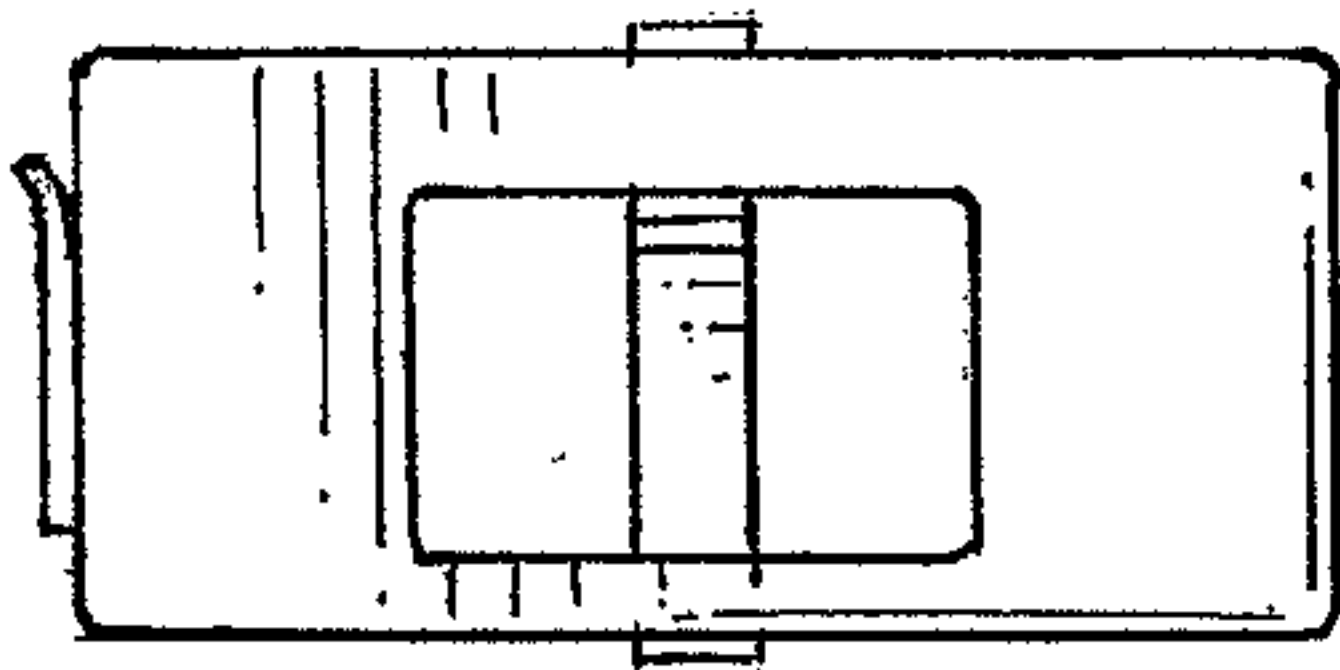

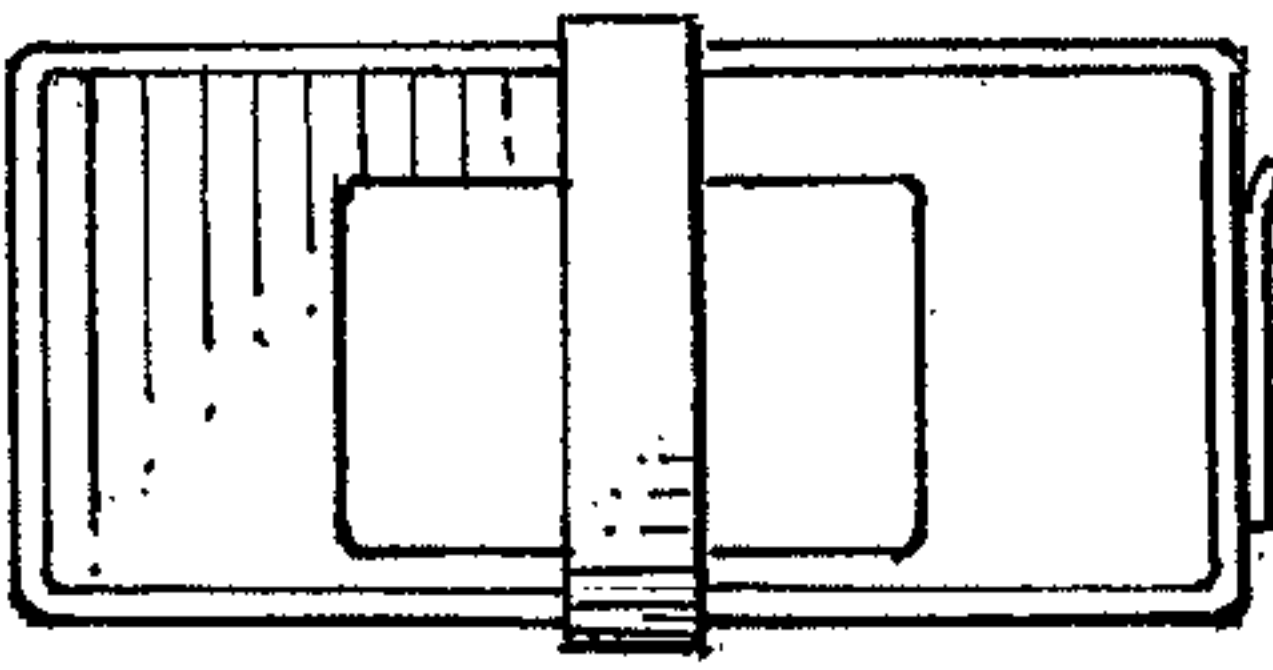
