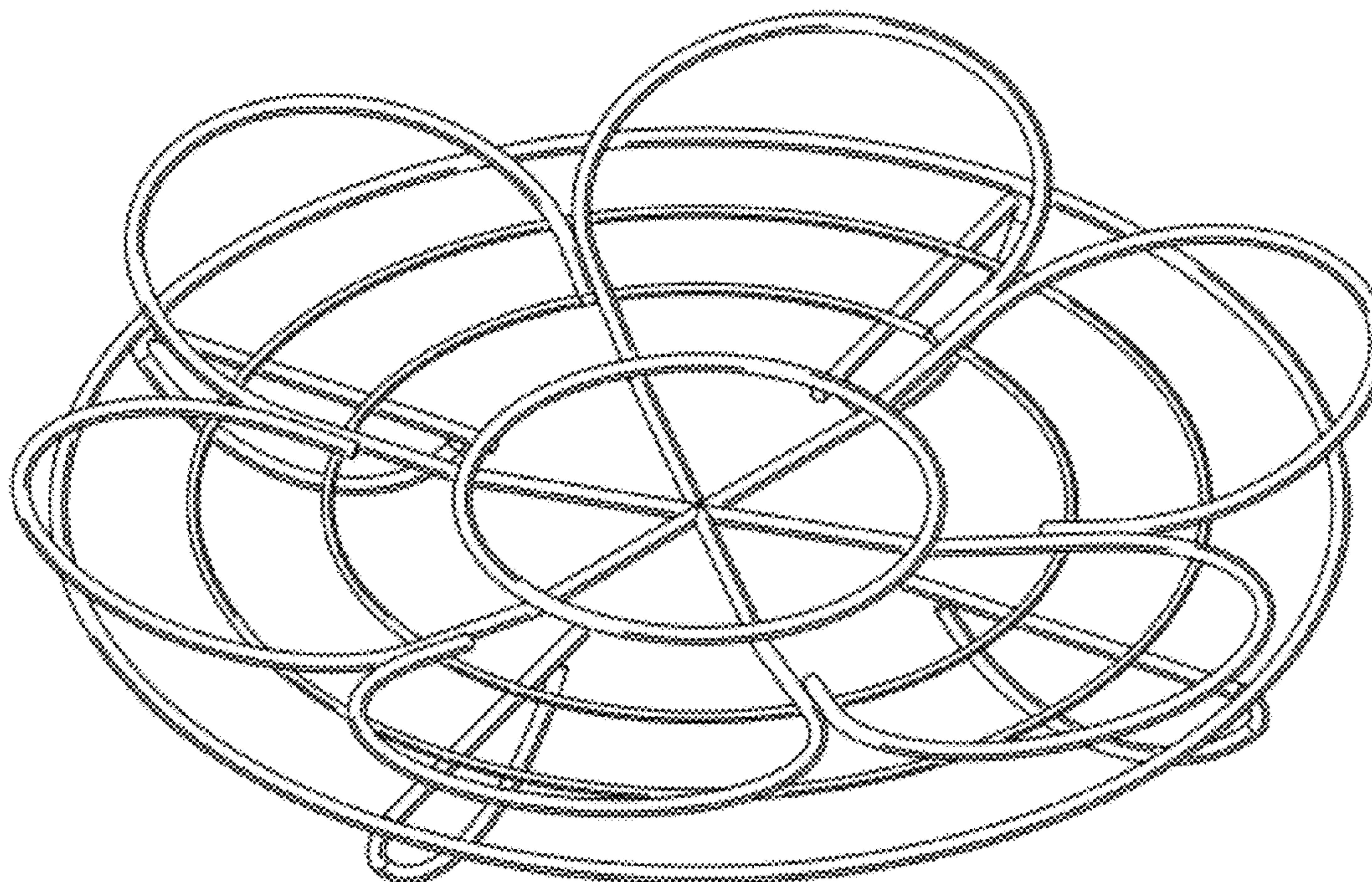
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a canning basket, showing my new design;
FIG. 2 is a top view of the canning basket;
FIG. 3 is a front view of the canning basket, the back view being a mirror image;
FIG. 4 is a left side view of the canning basket, the right side view being a mirror image; and,
FIG. 5 is a bottom view of the canning basket.

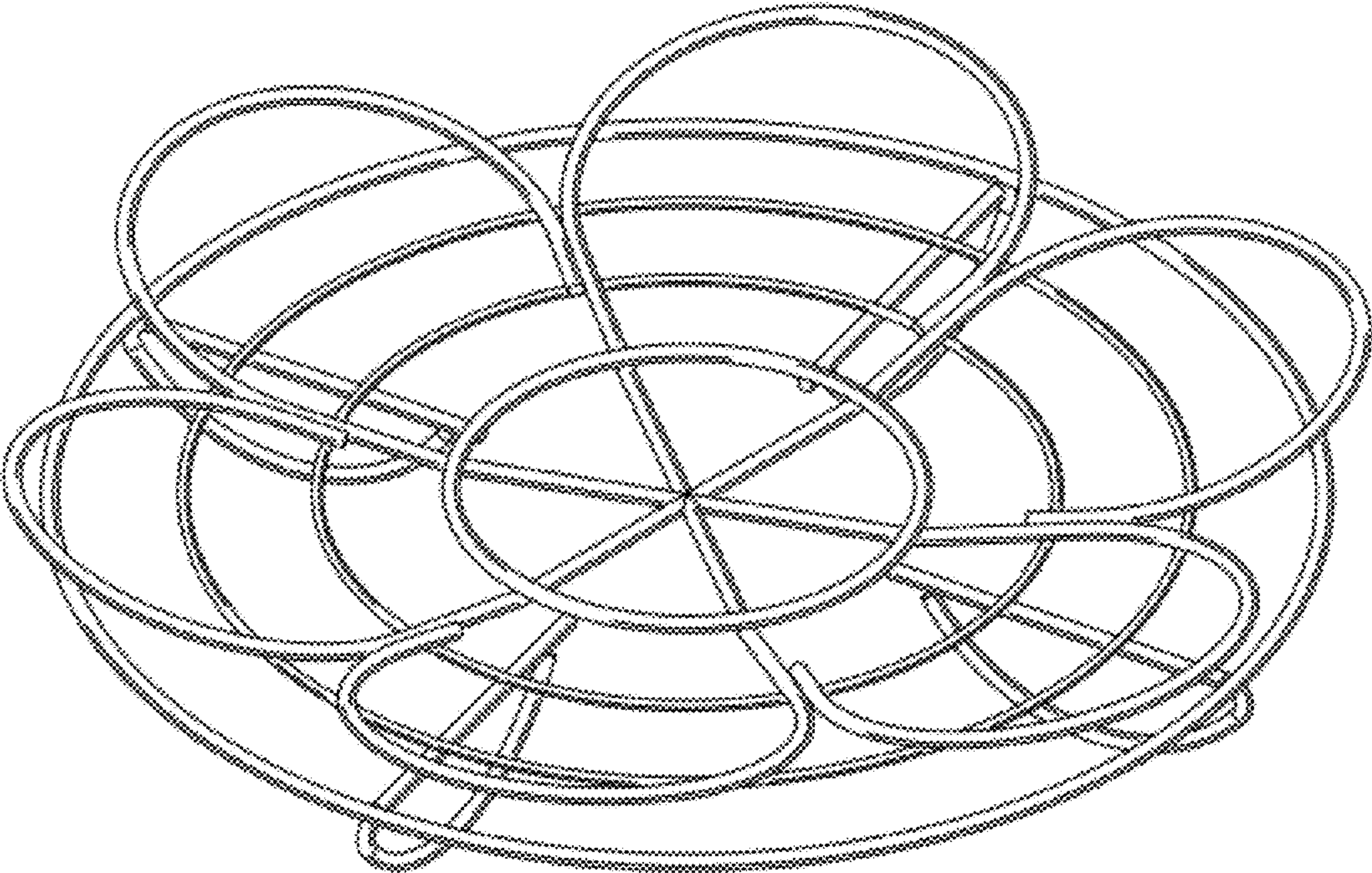

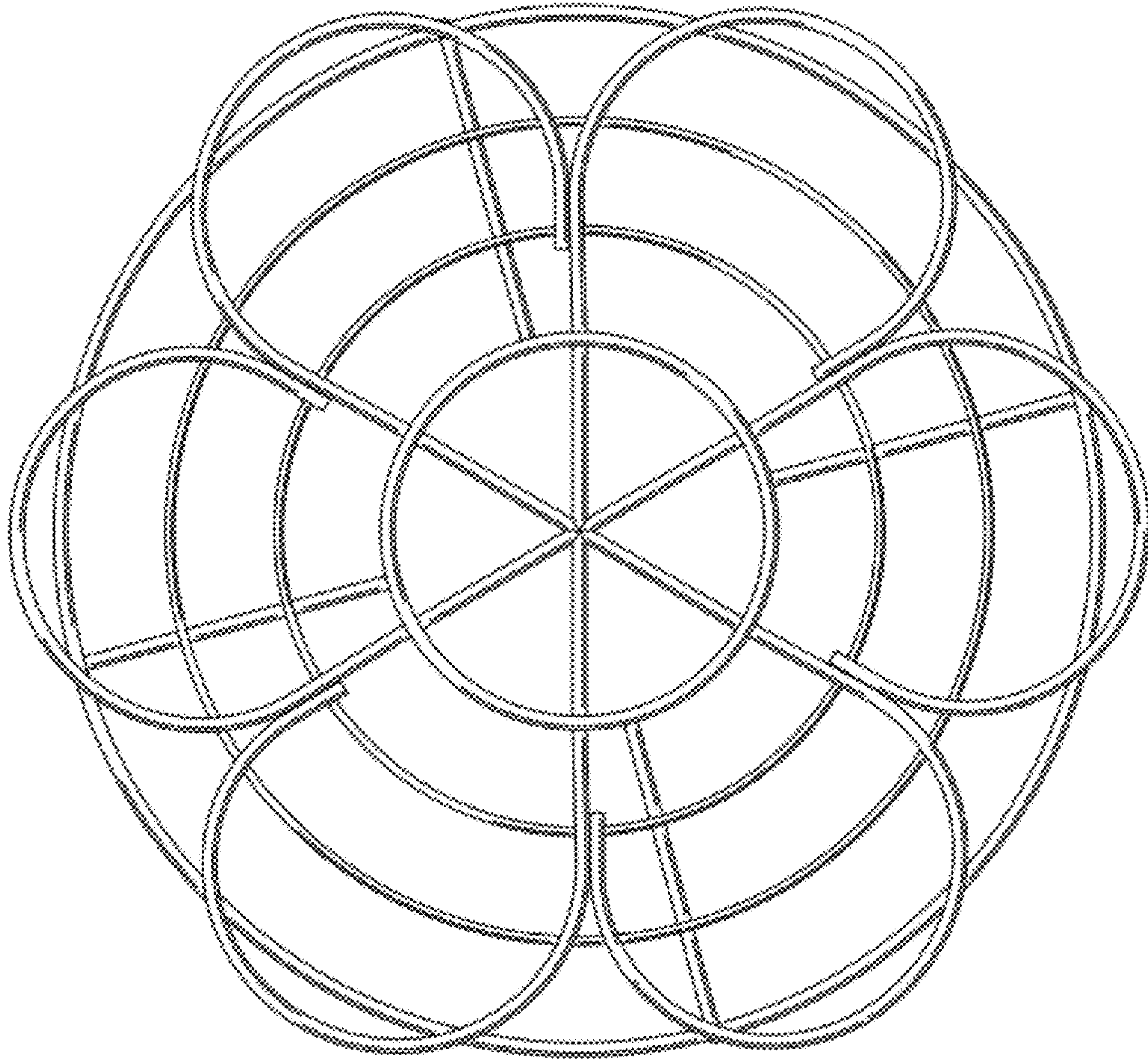

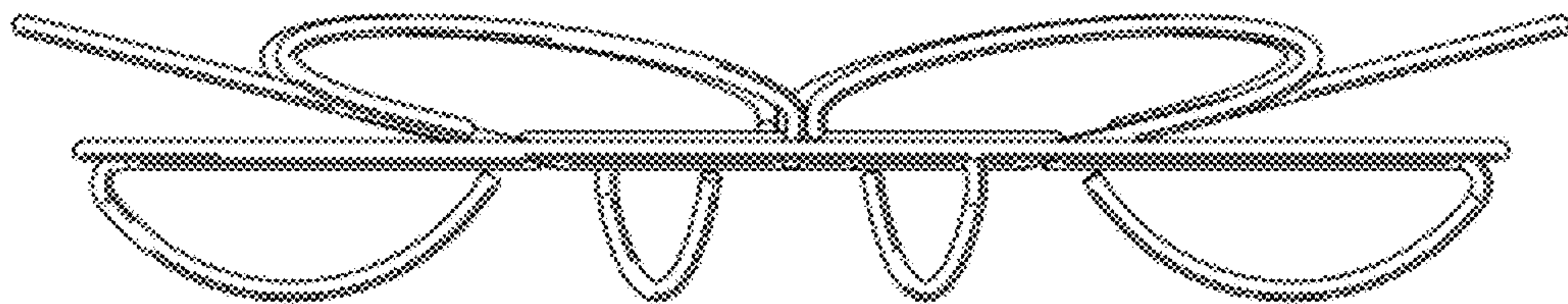

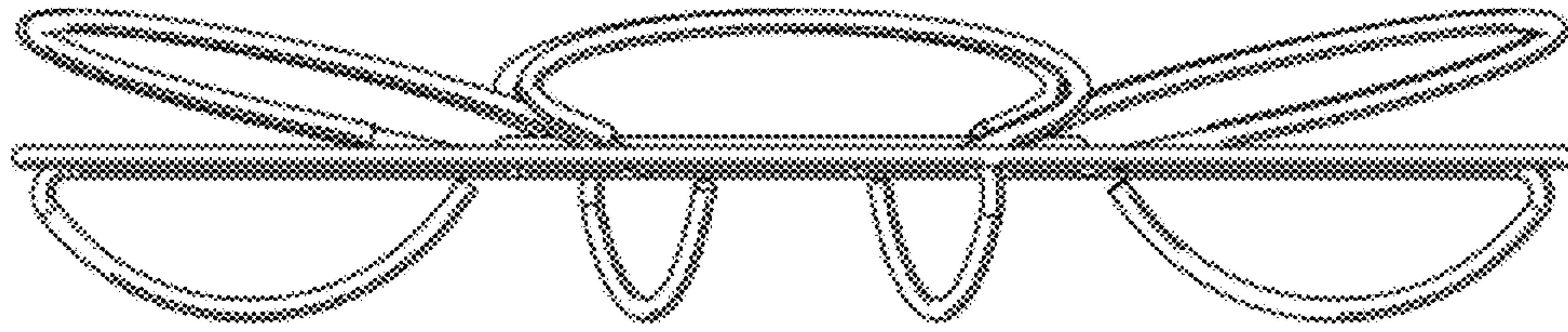

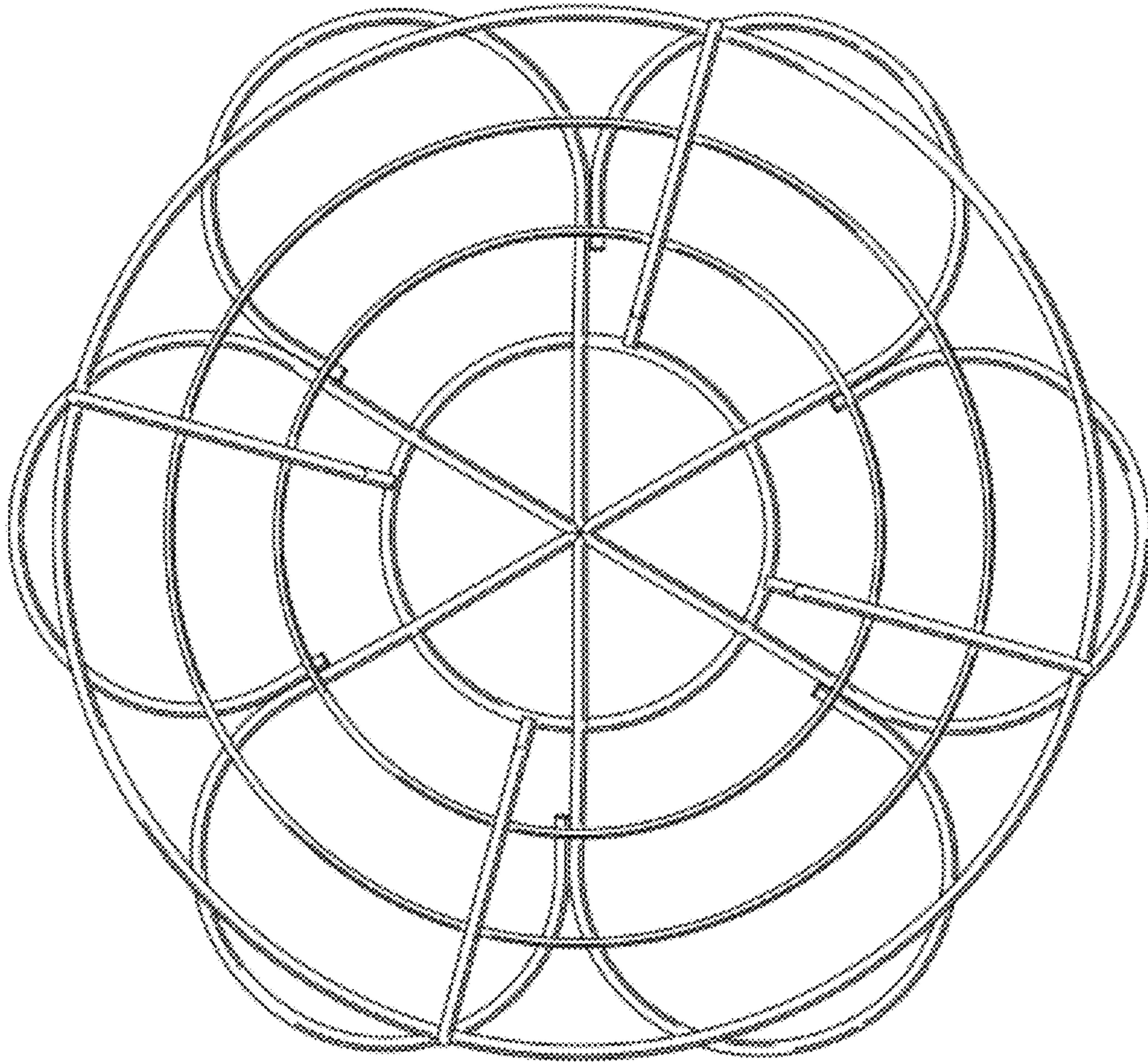
