FIG. 6 illustrates a bottom view thereof;

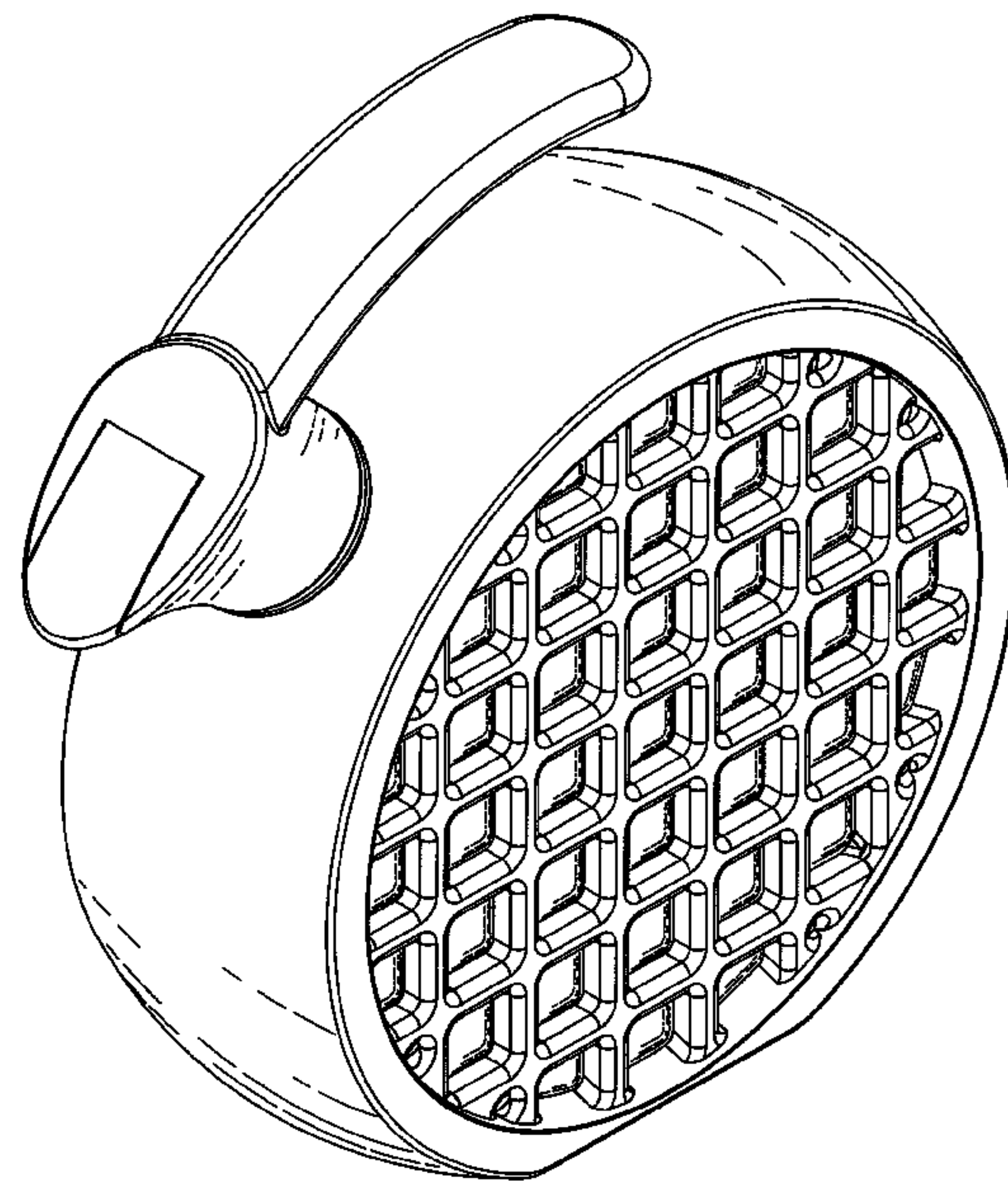
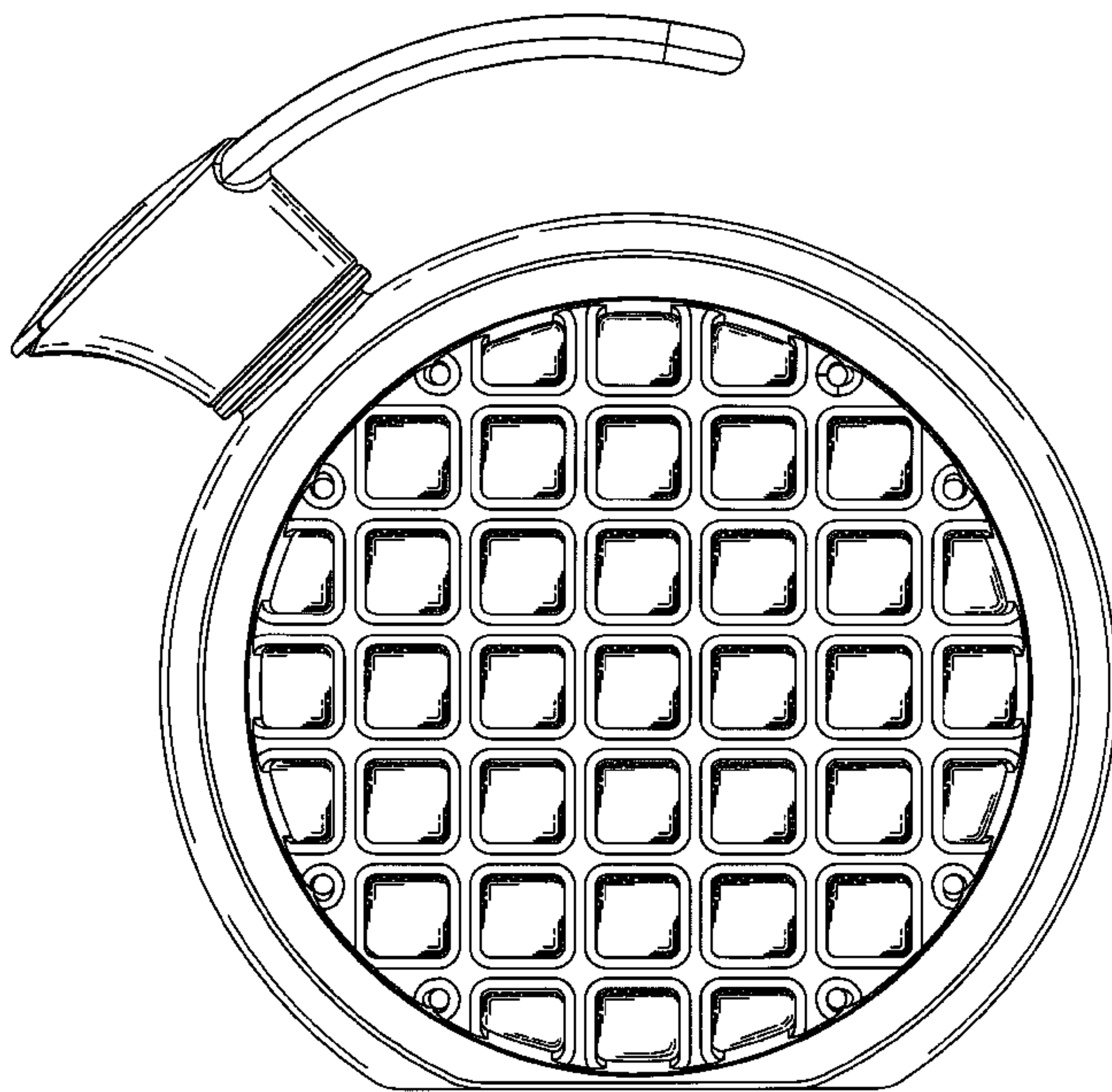
FIG. 7 illustrates a cross-sectional view thereof, taken along line 7-7 of FIG. 1;

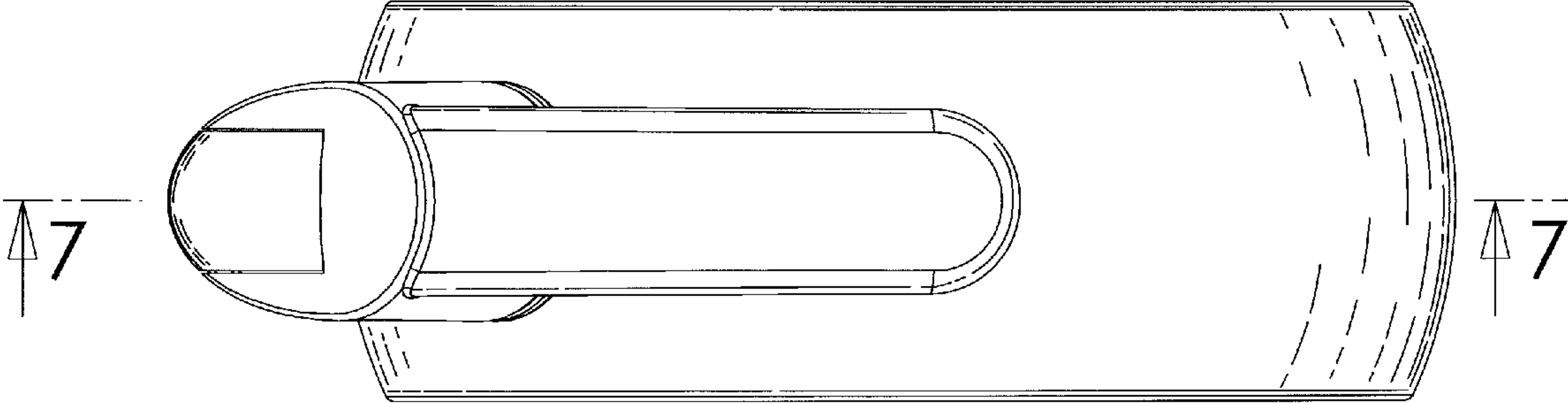

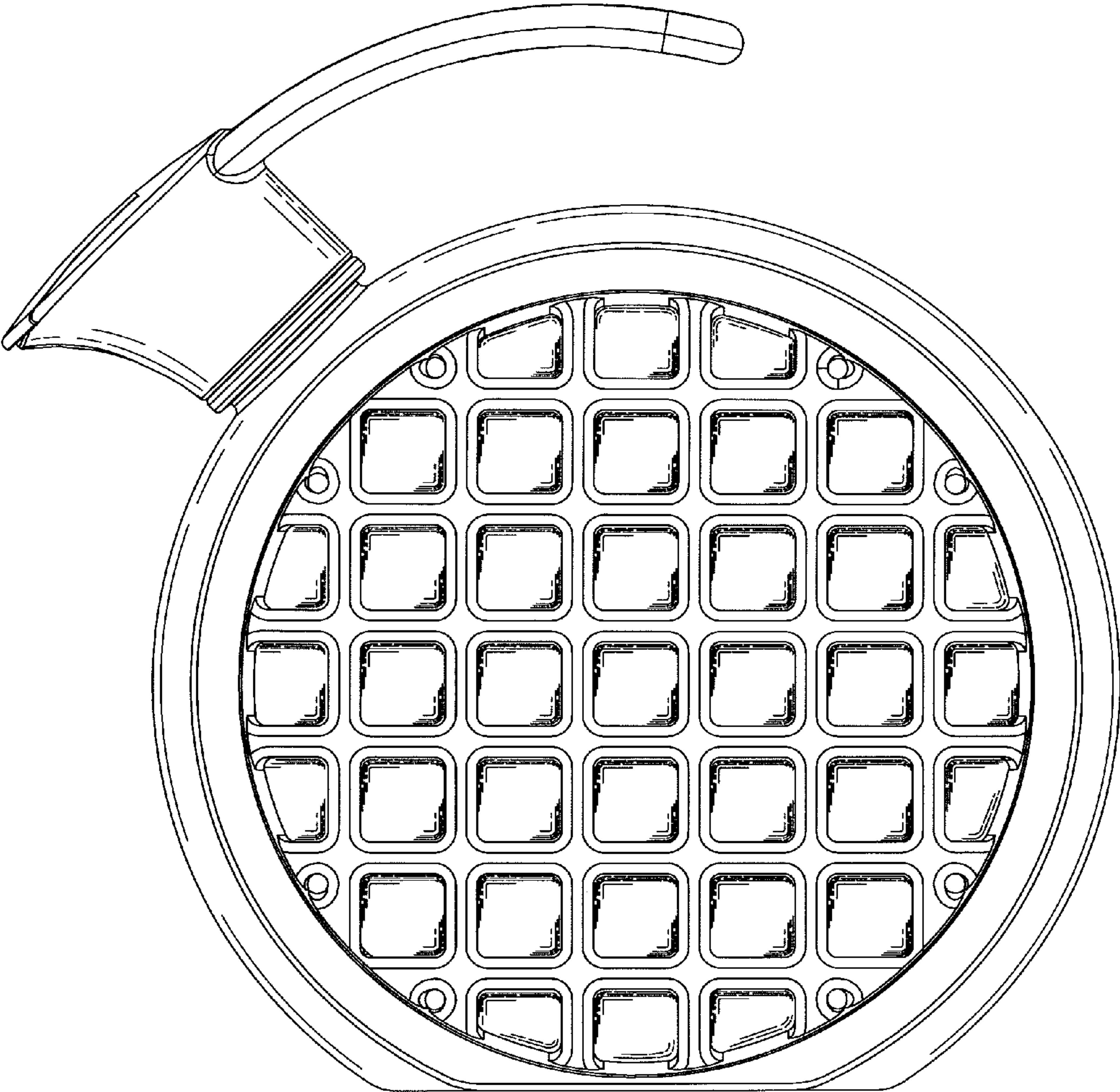

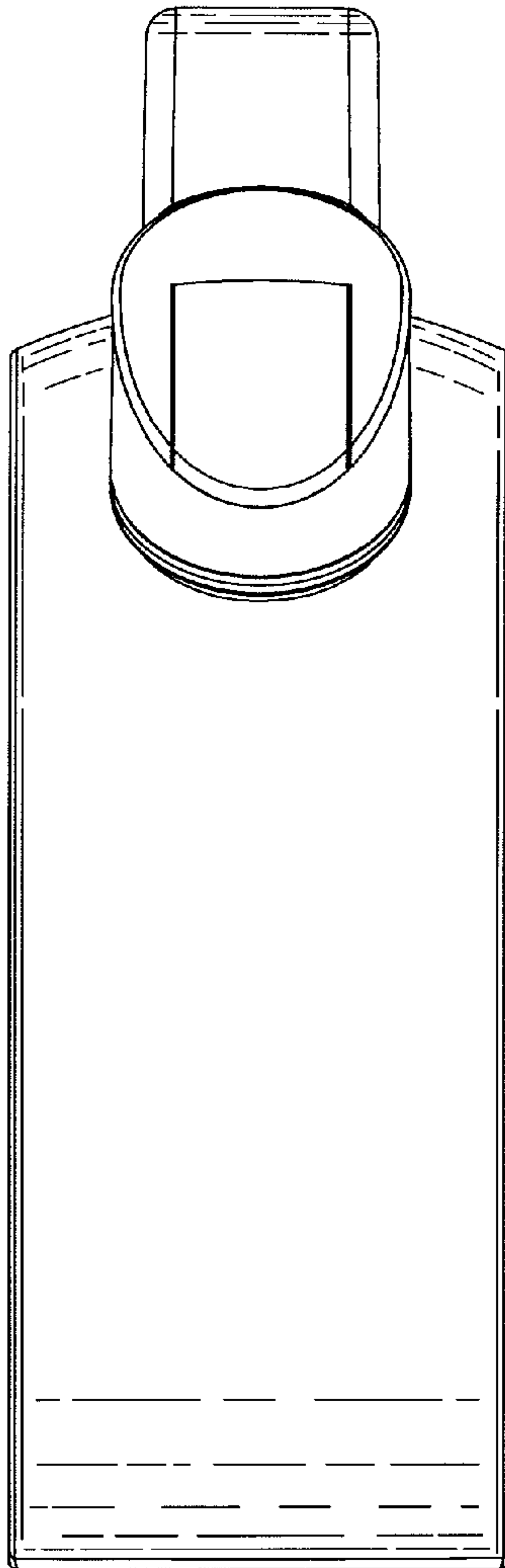

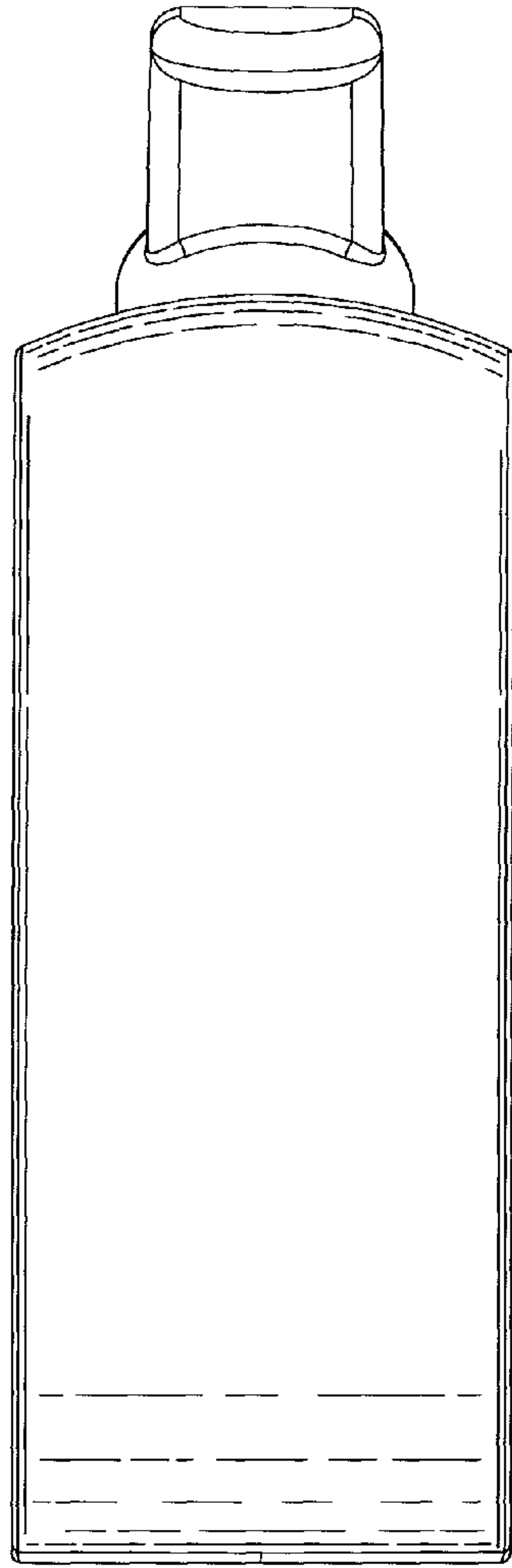

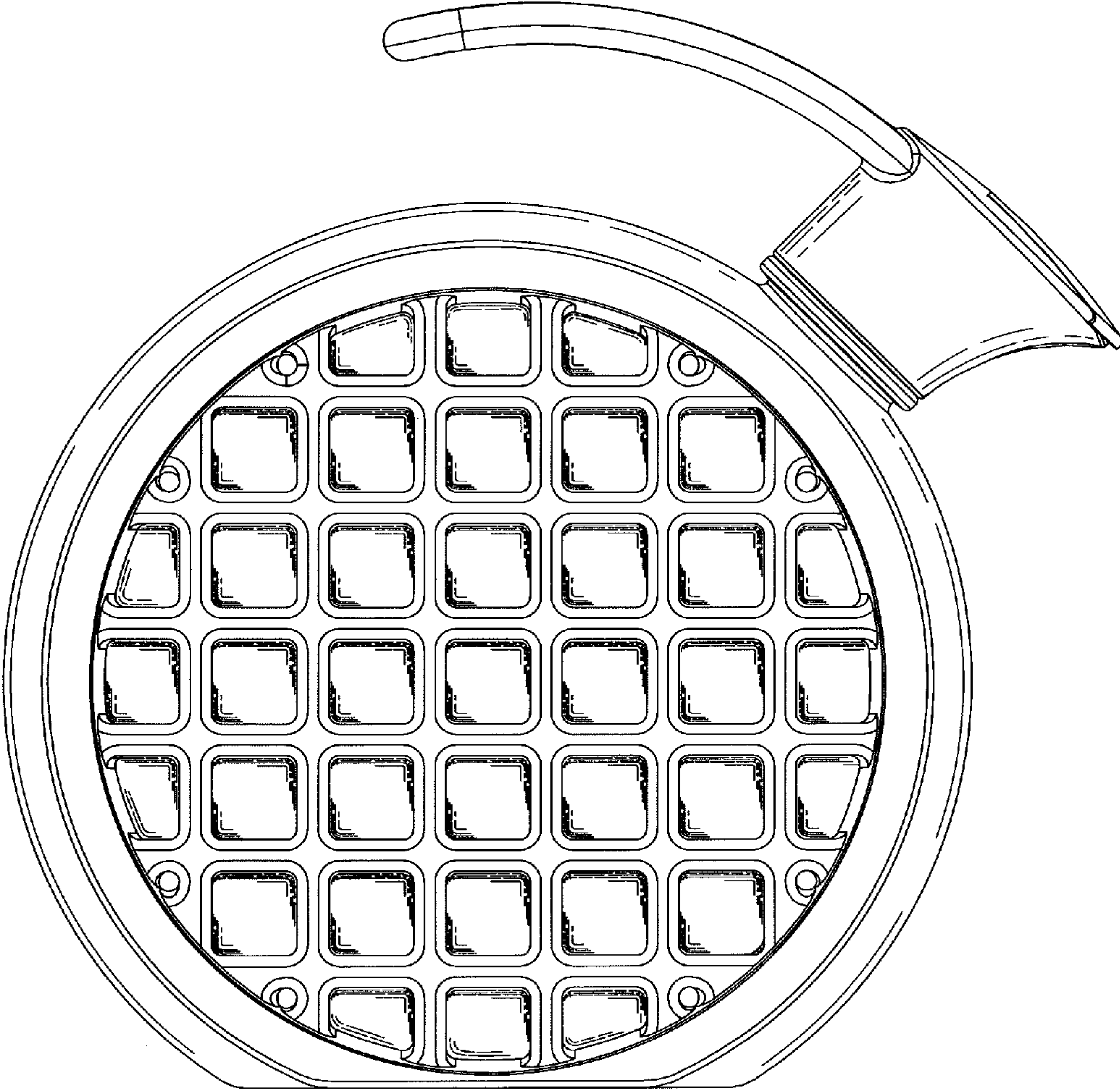

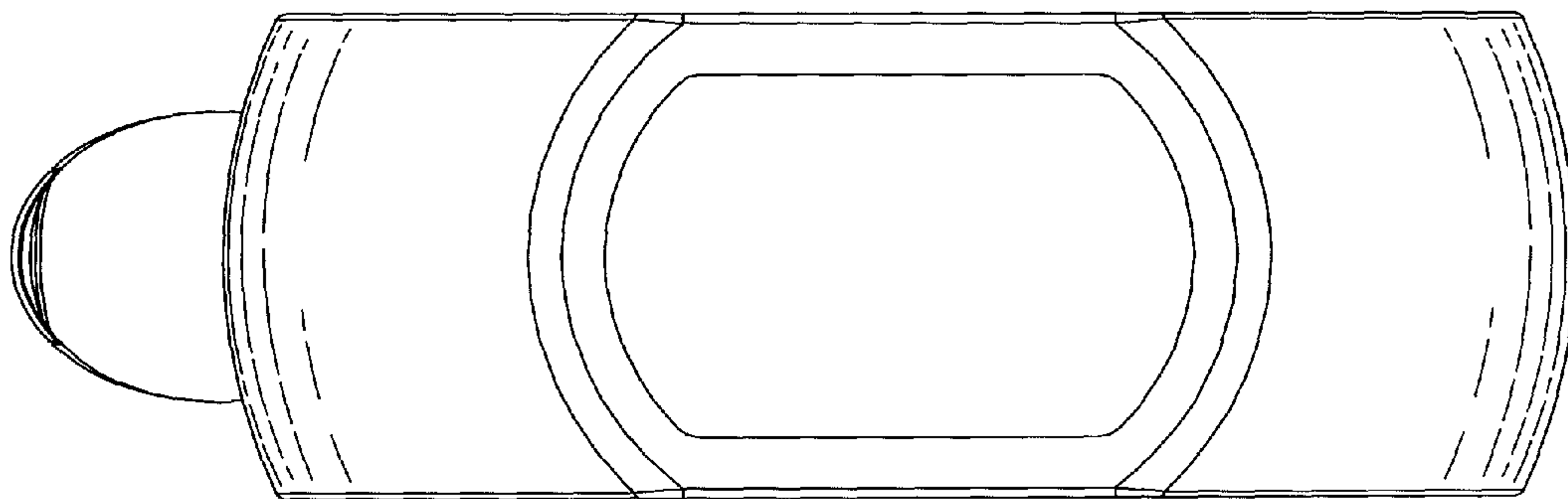

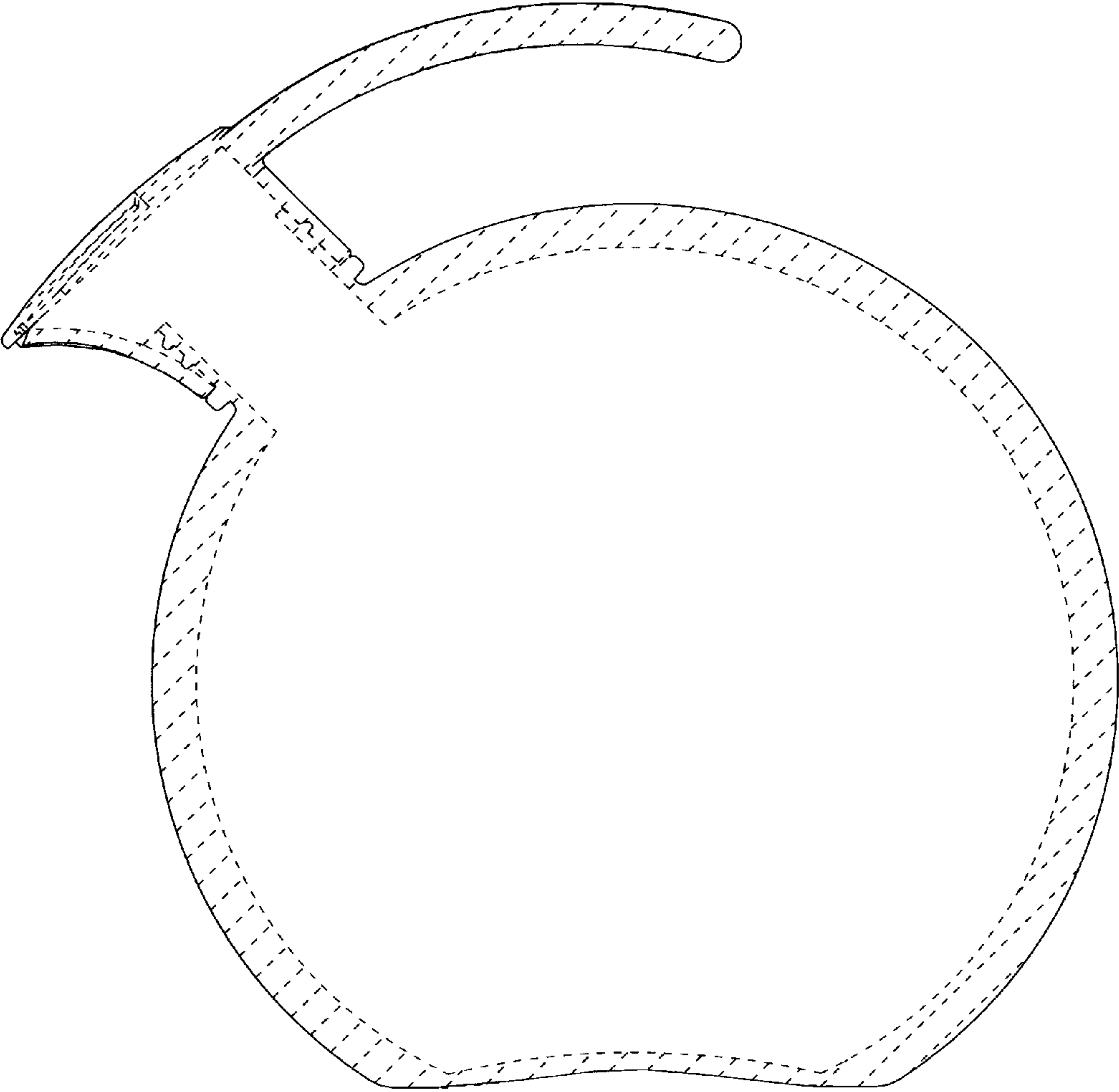

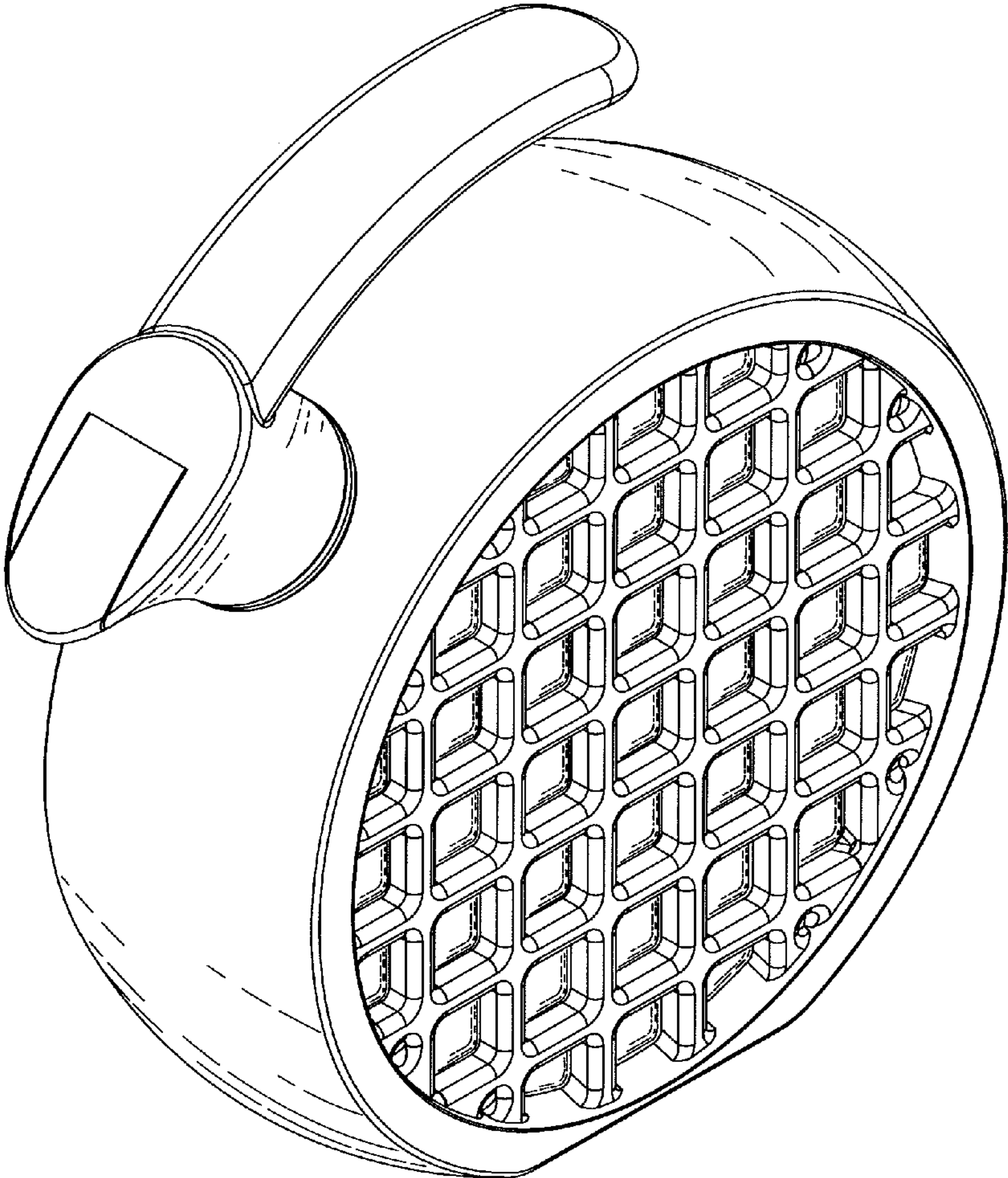

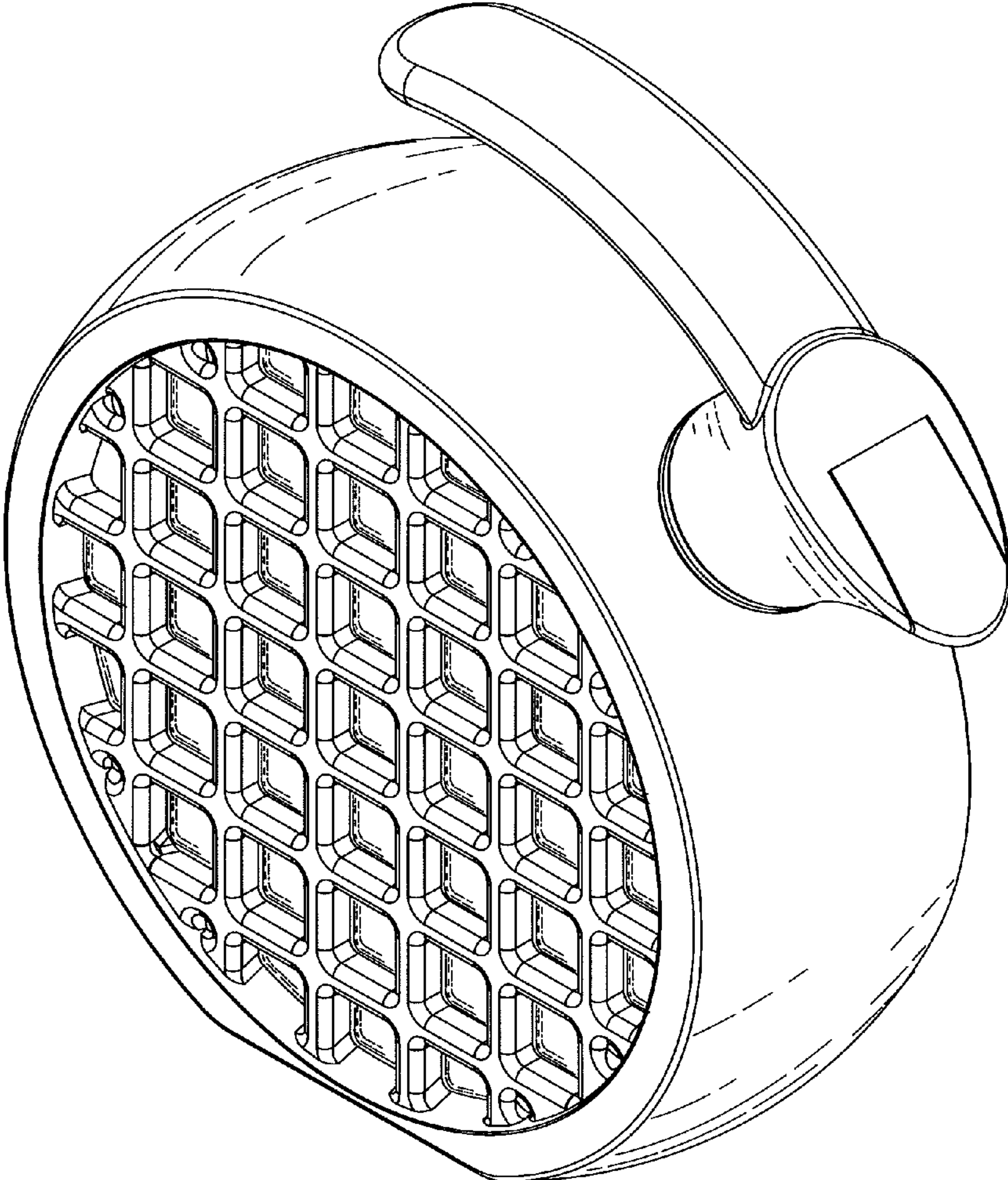
