FIG. 4 shows a plan view of the first side of the packaging;

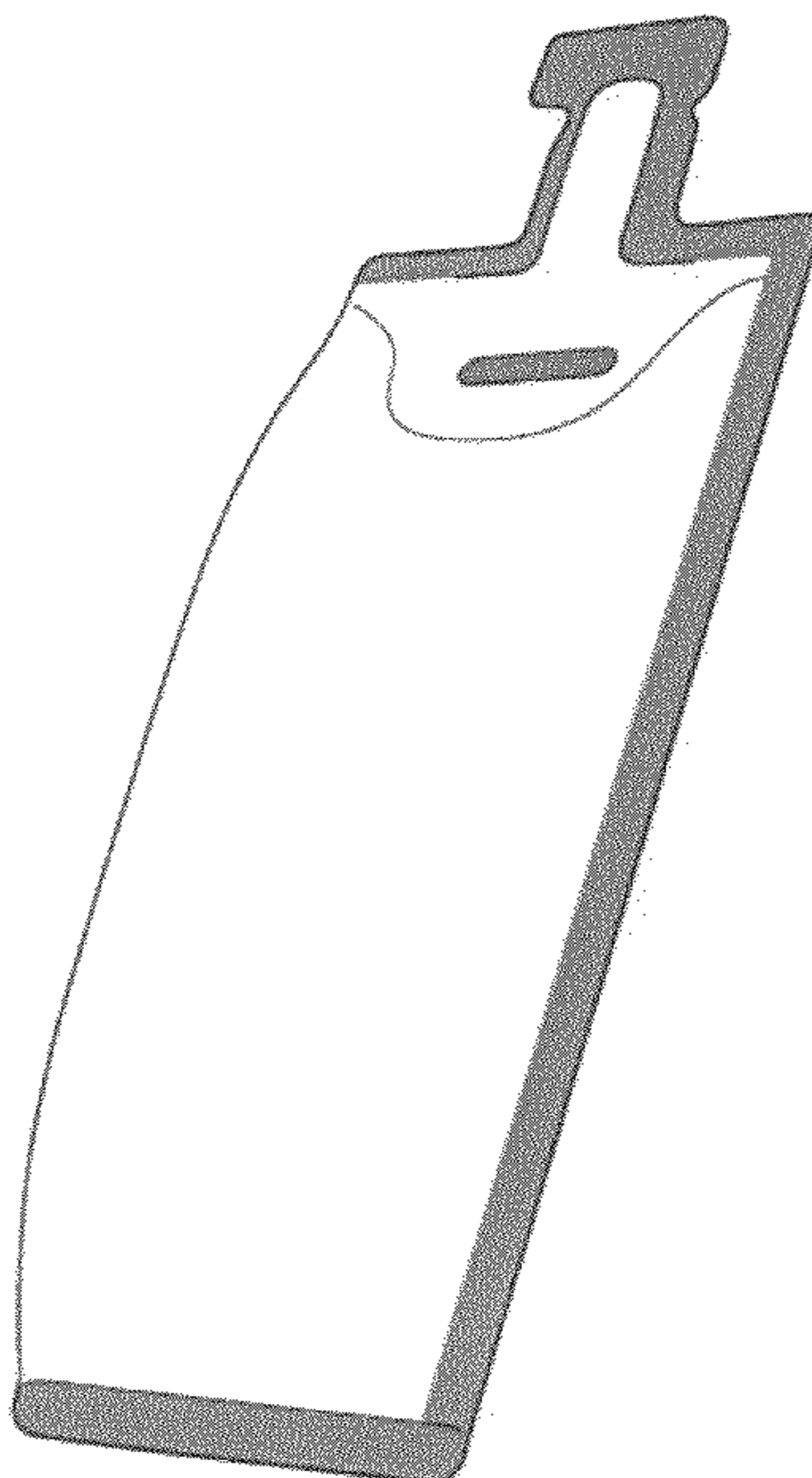
FIG. 5 shows a right side view of the packaging;

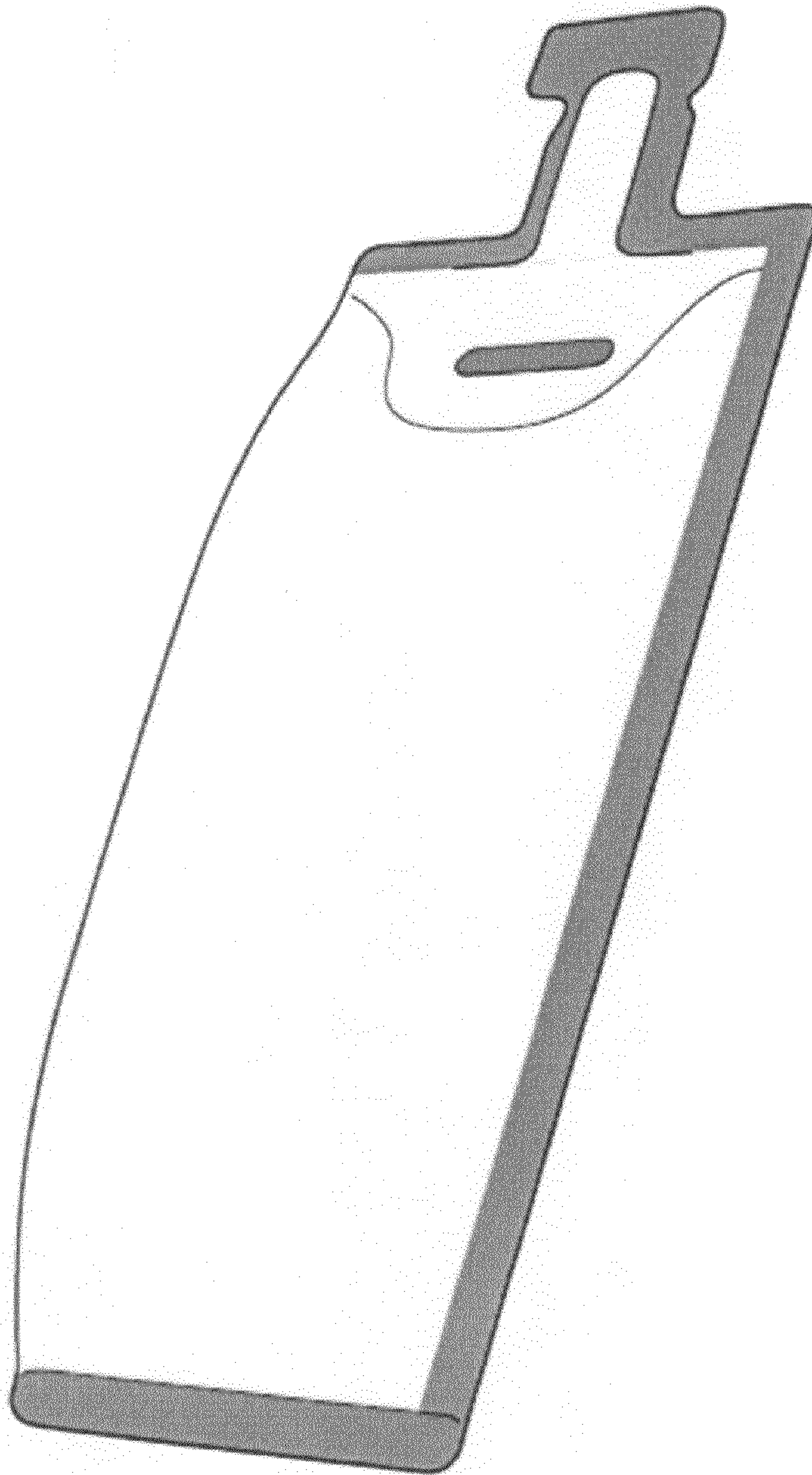

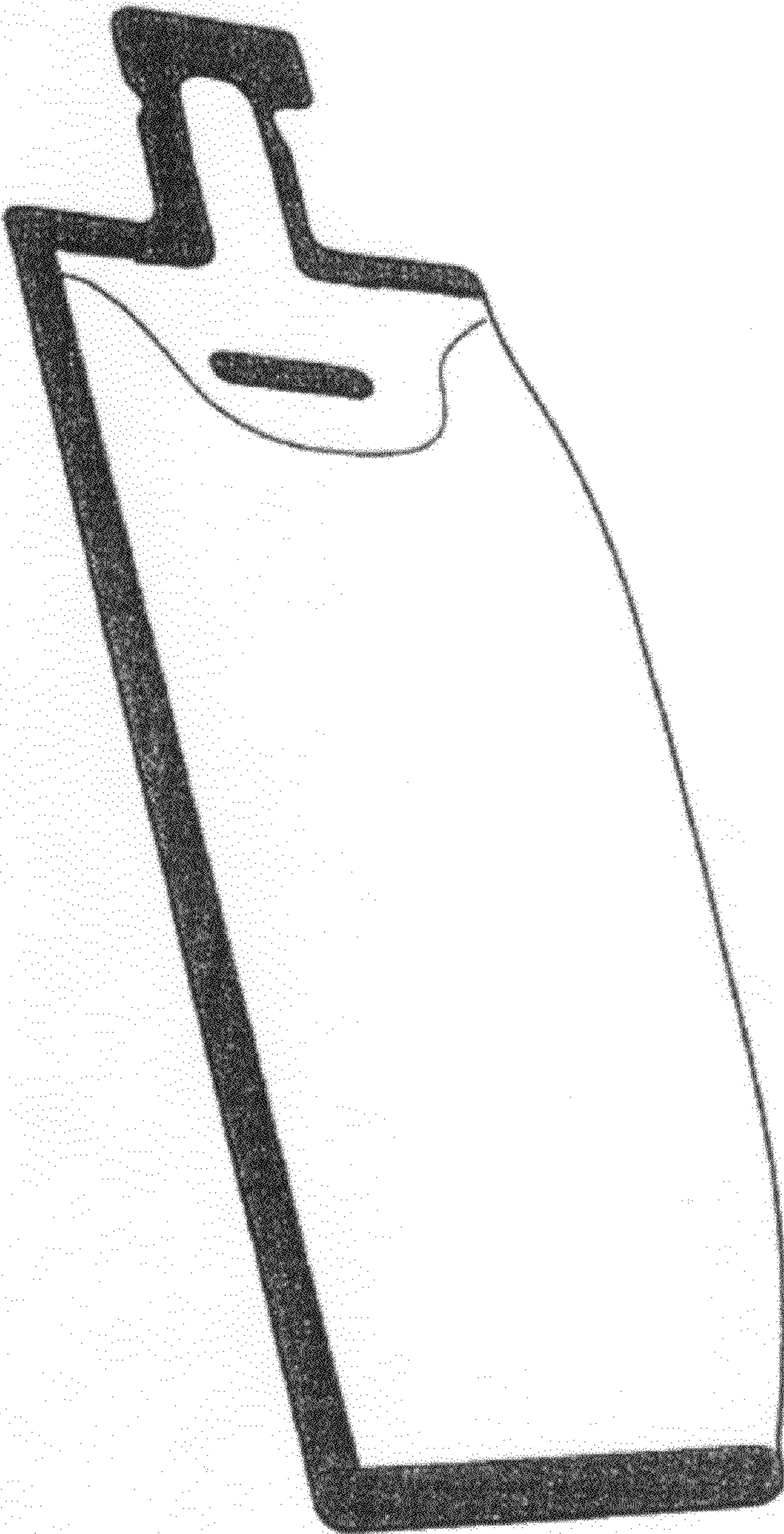

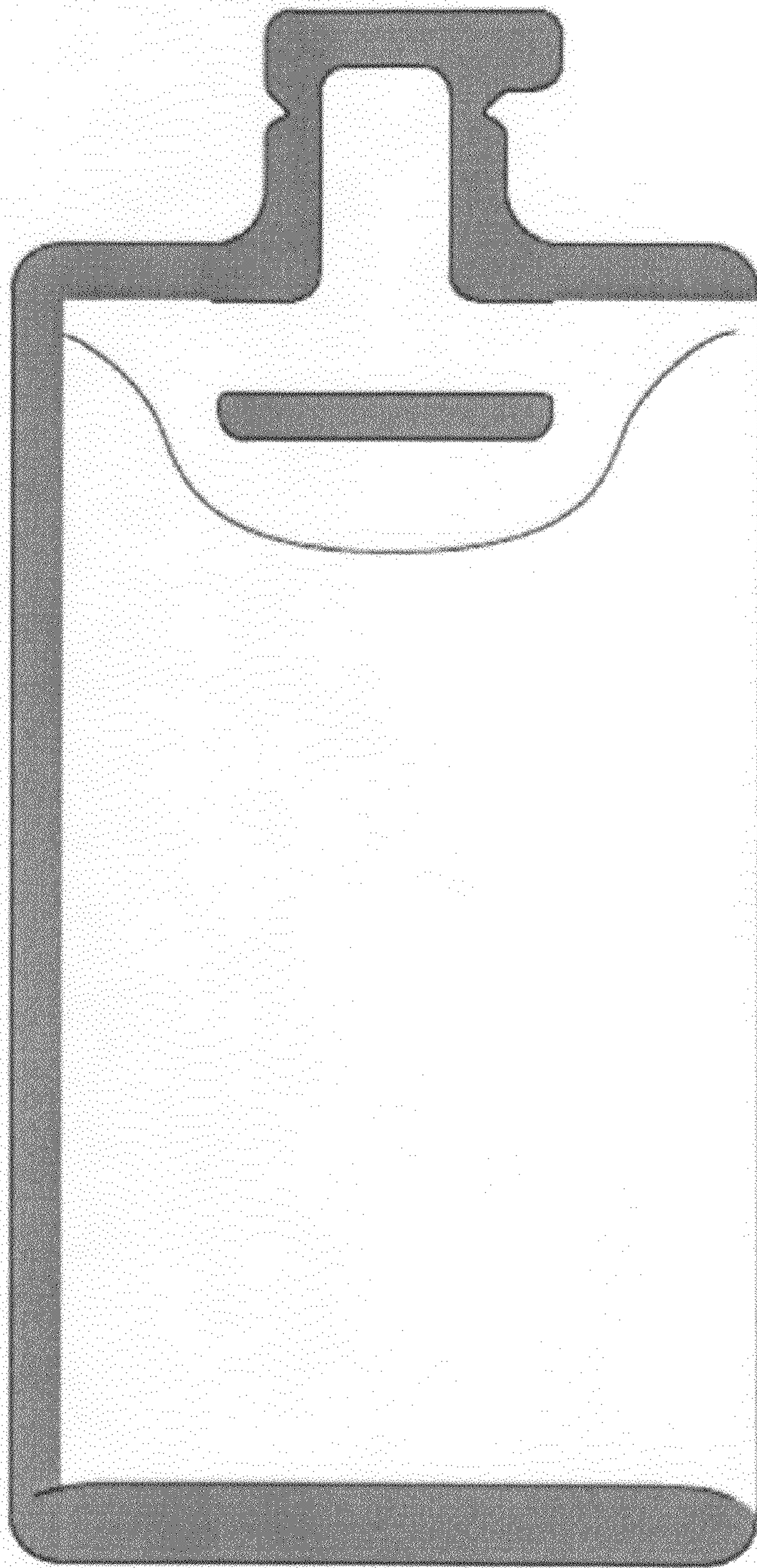

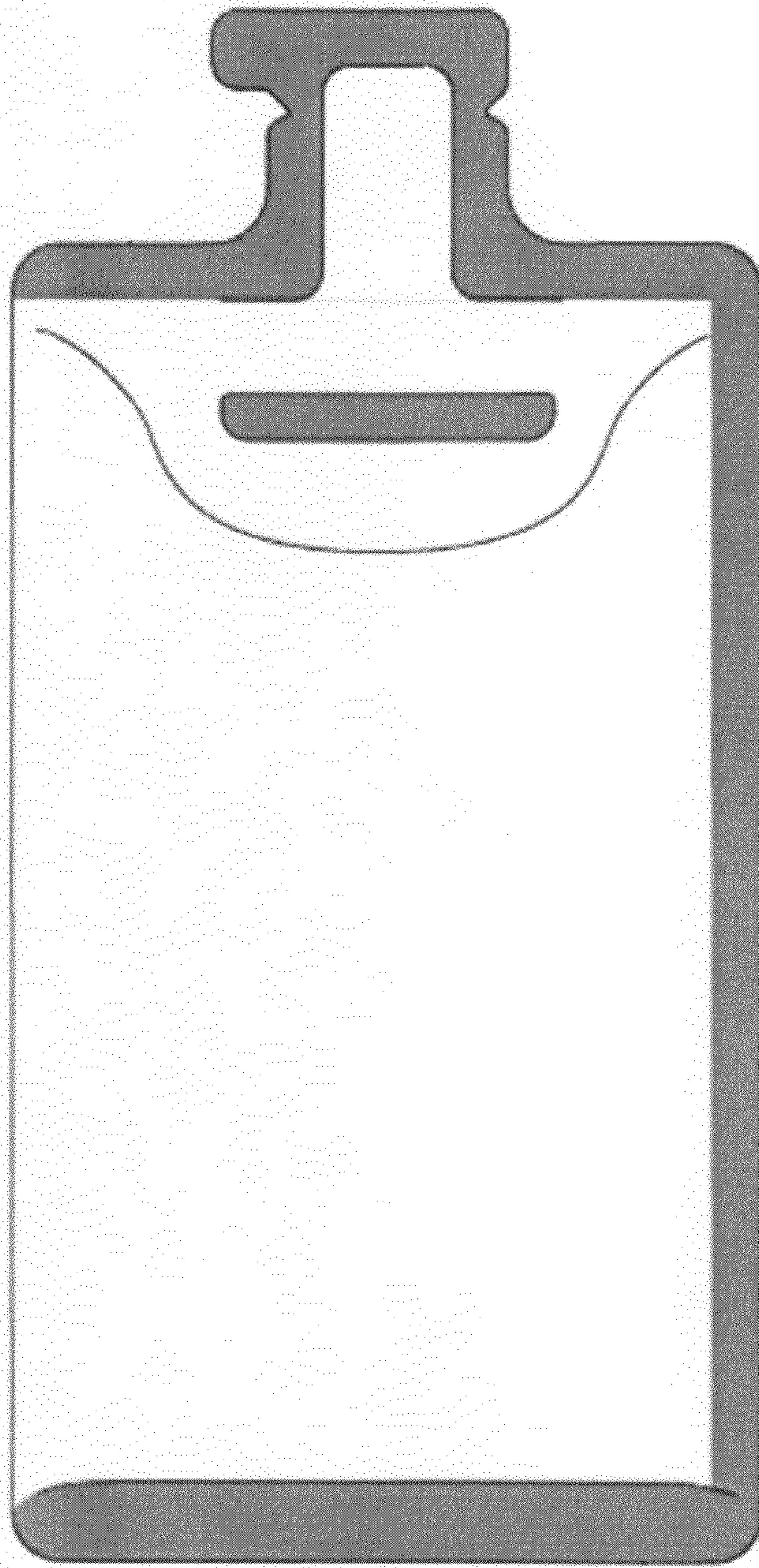

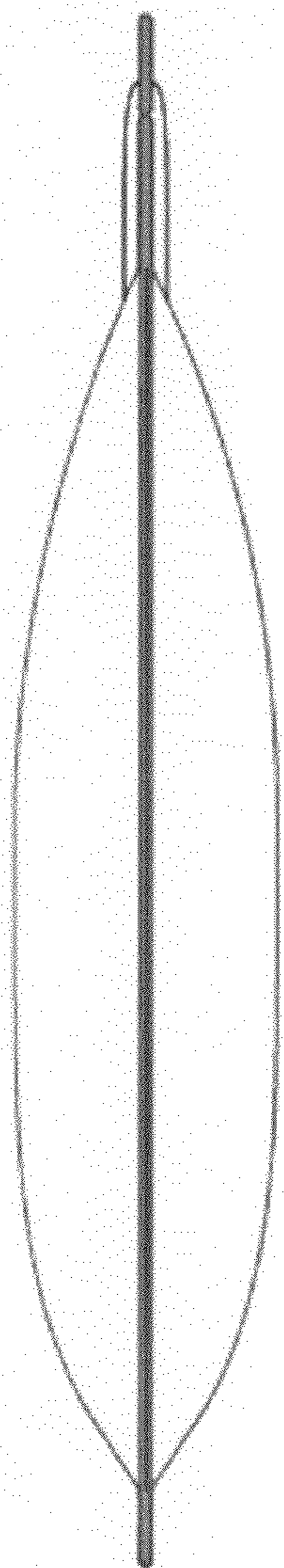

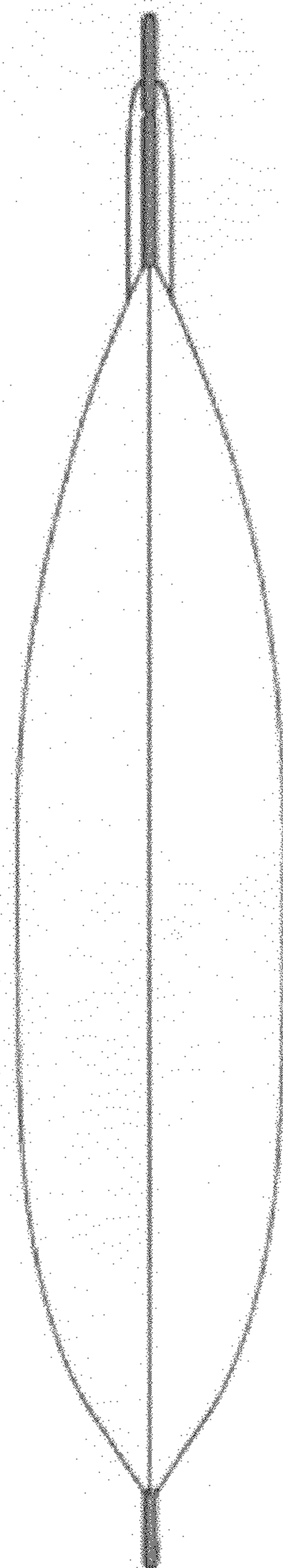

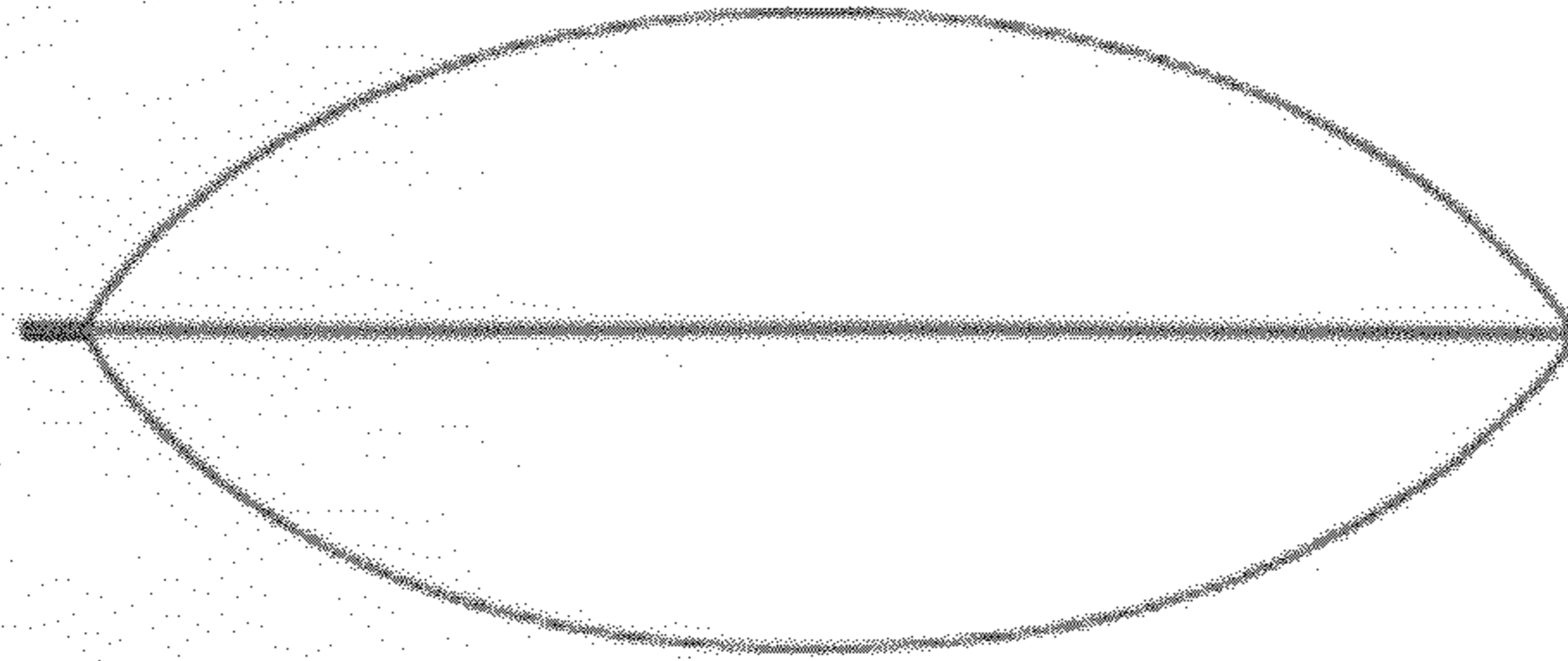

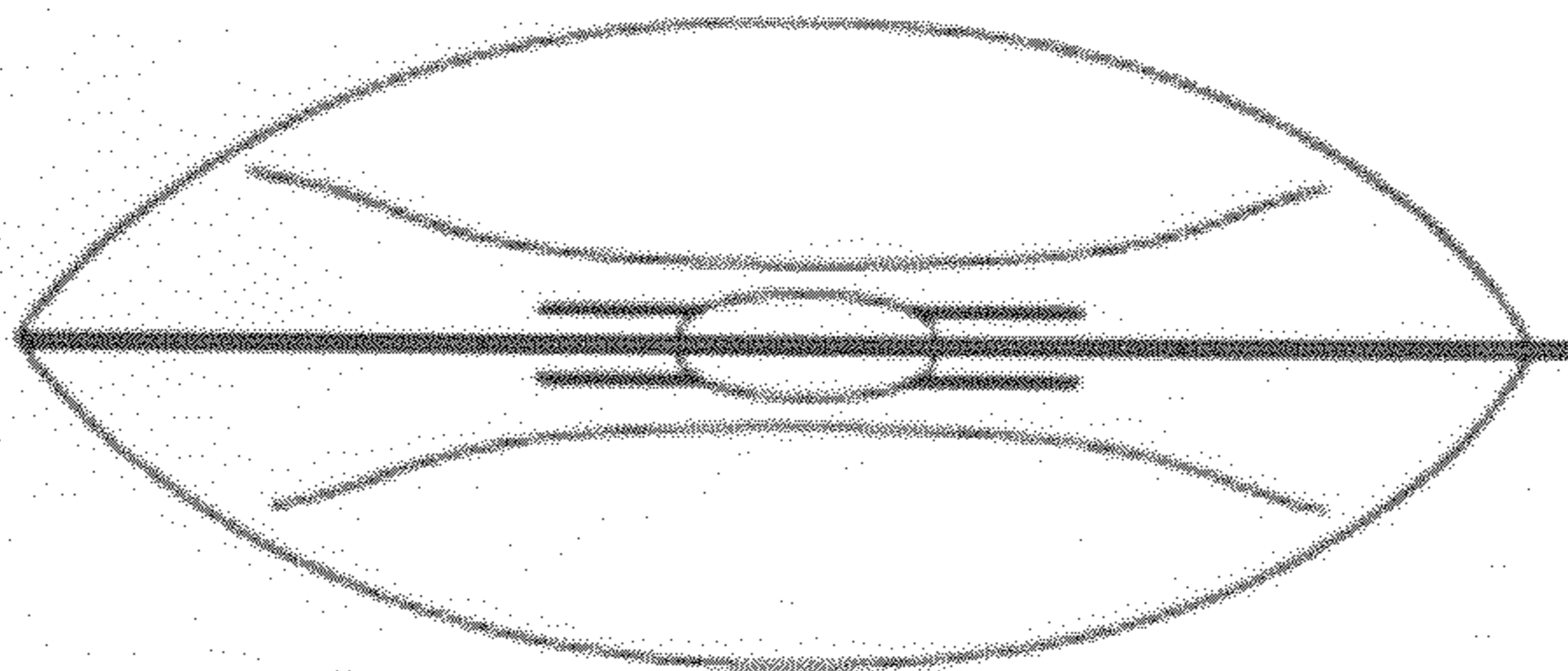
