FIG. 2 is an elevation of the watch case bottom shown with unclaimed environmental structures that are shown in broken lines.

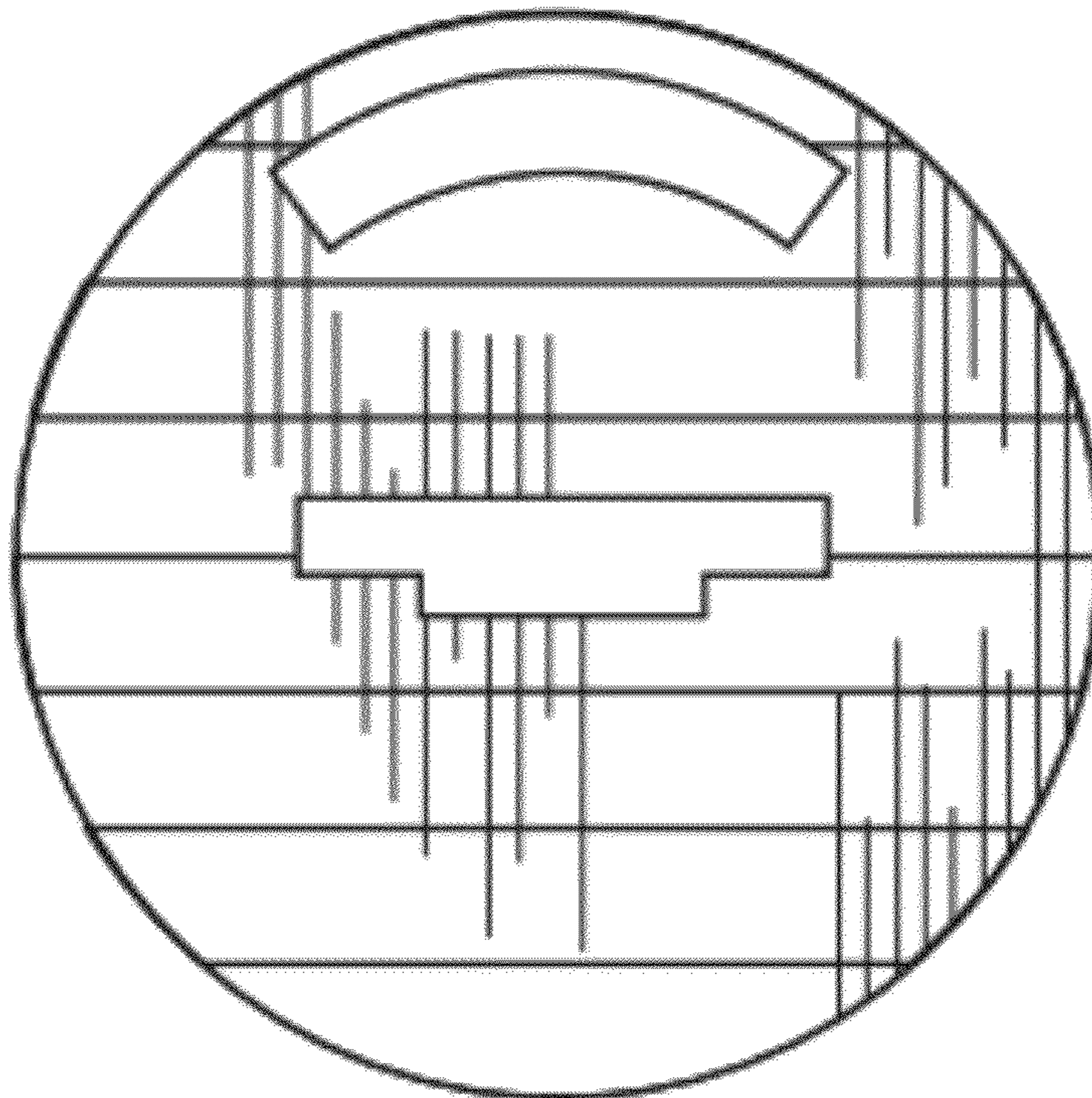
The broken lines form no part of the claimed design and are for illustrative purposes only.

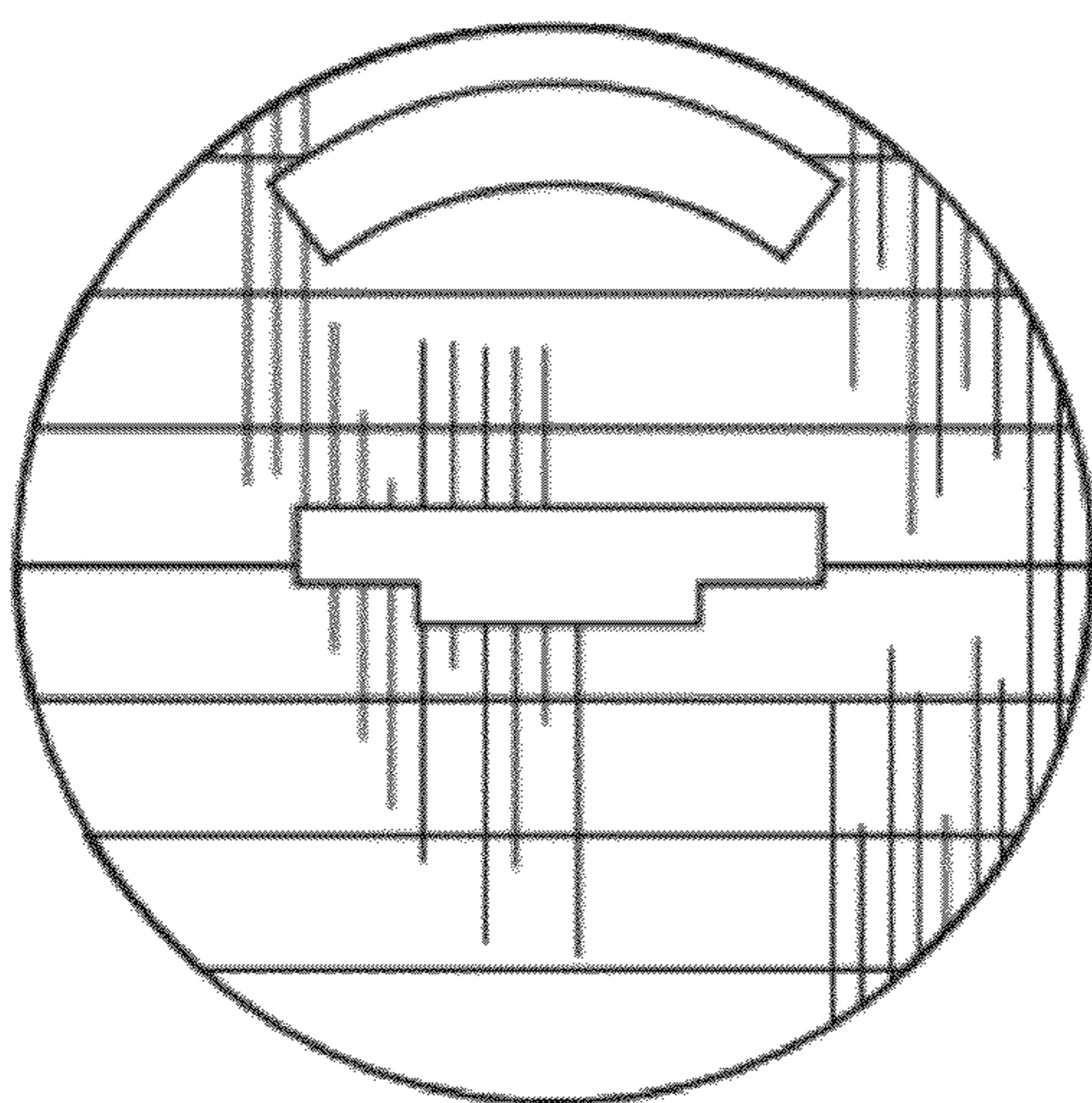

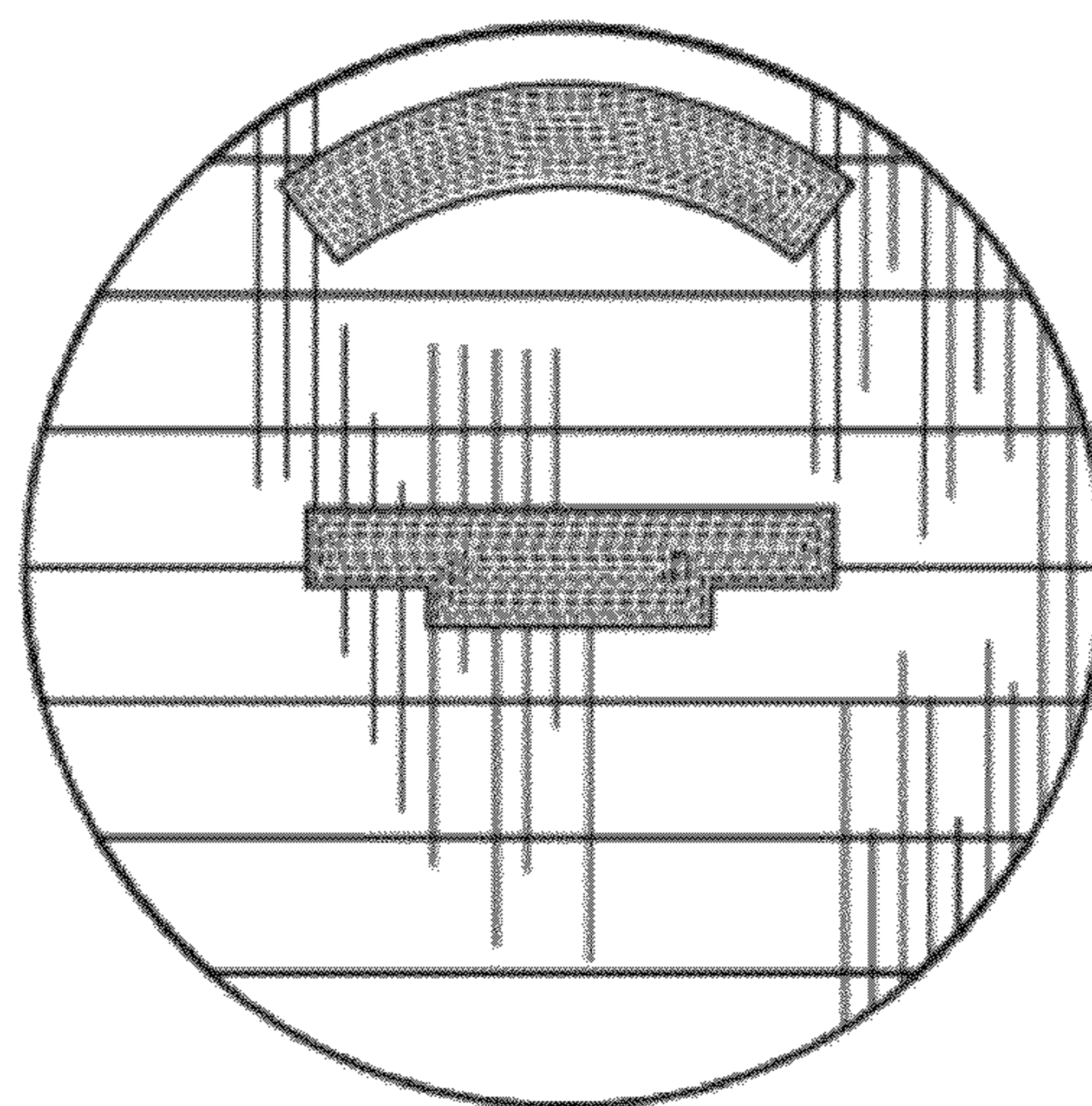
