(57) **CLAIM**

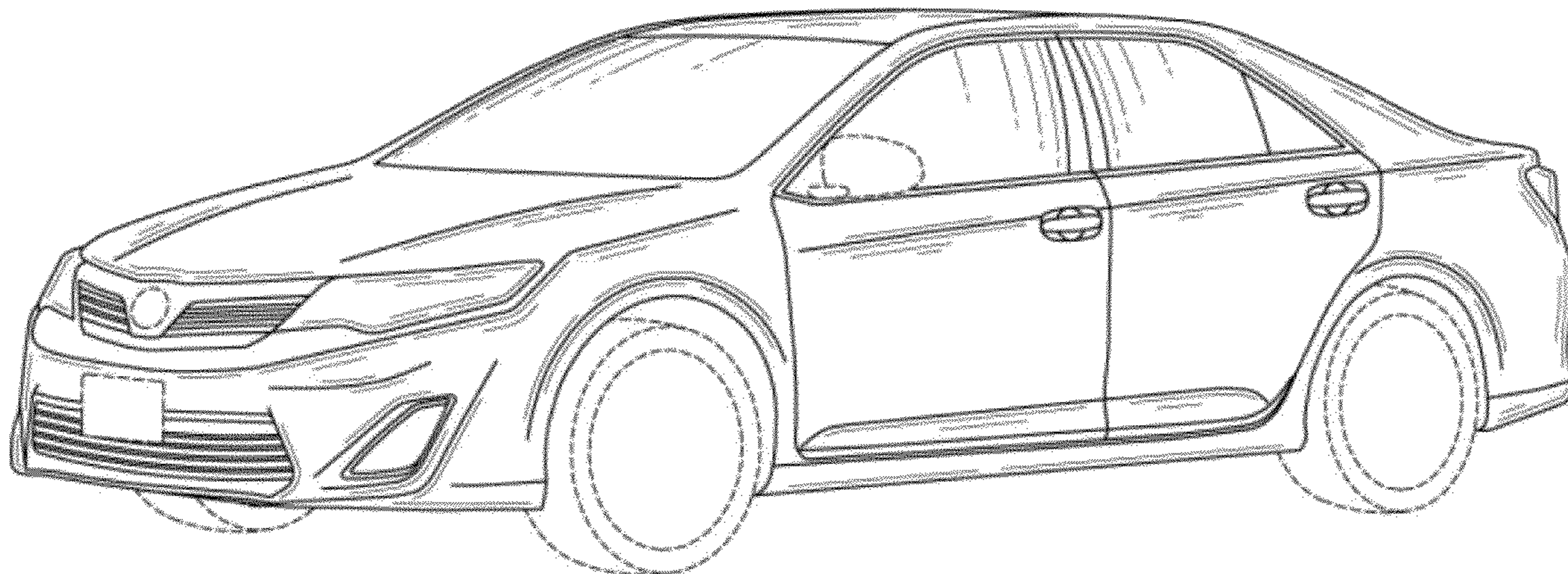
The ornamental design for an automobile and/or toy replica thereof, as shown and described.

**DESCRIPTION**

FIG. 1 is a left front perspective view of an automobile and/or a toy replica thereof of our new design; FIG. 2 is a left, rear perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof, the right side elevation view being a mirror image; and, FIG. 6 is a top plan view thereof.

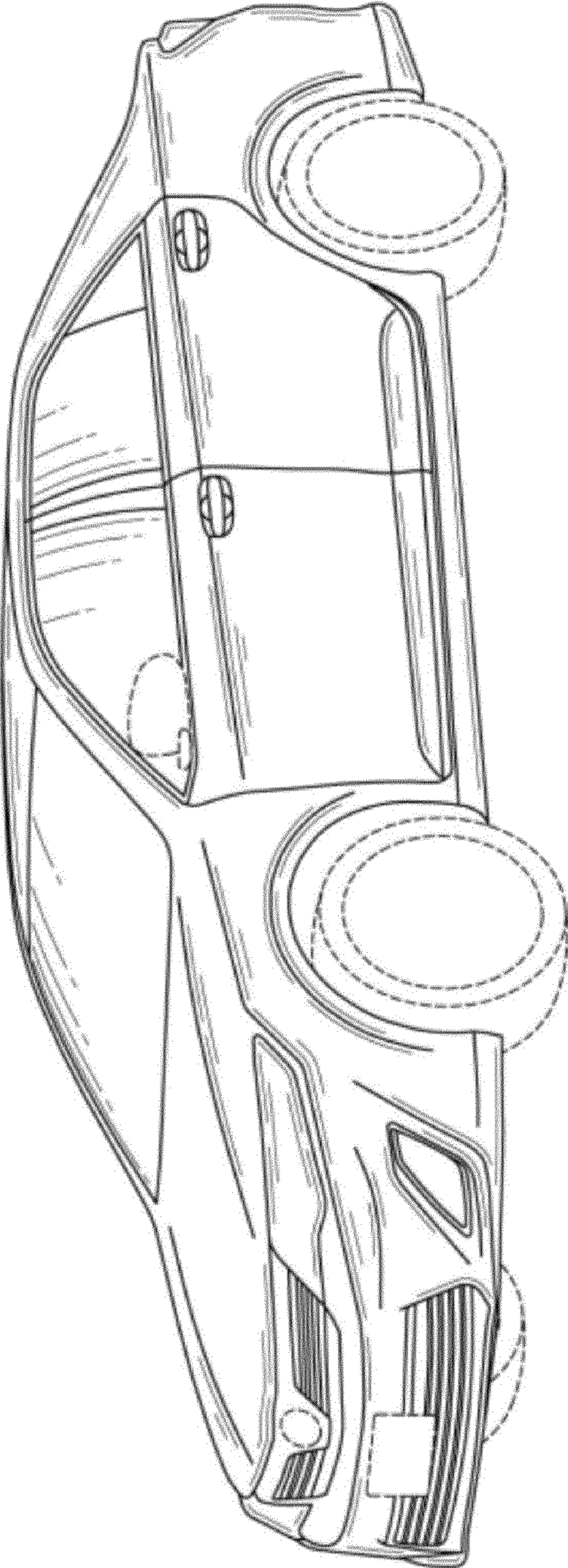

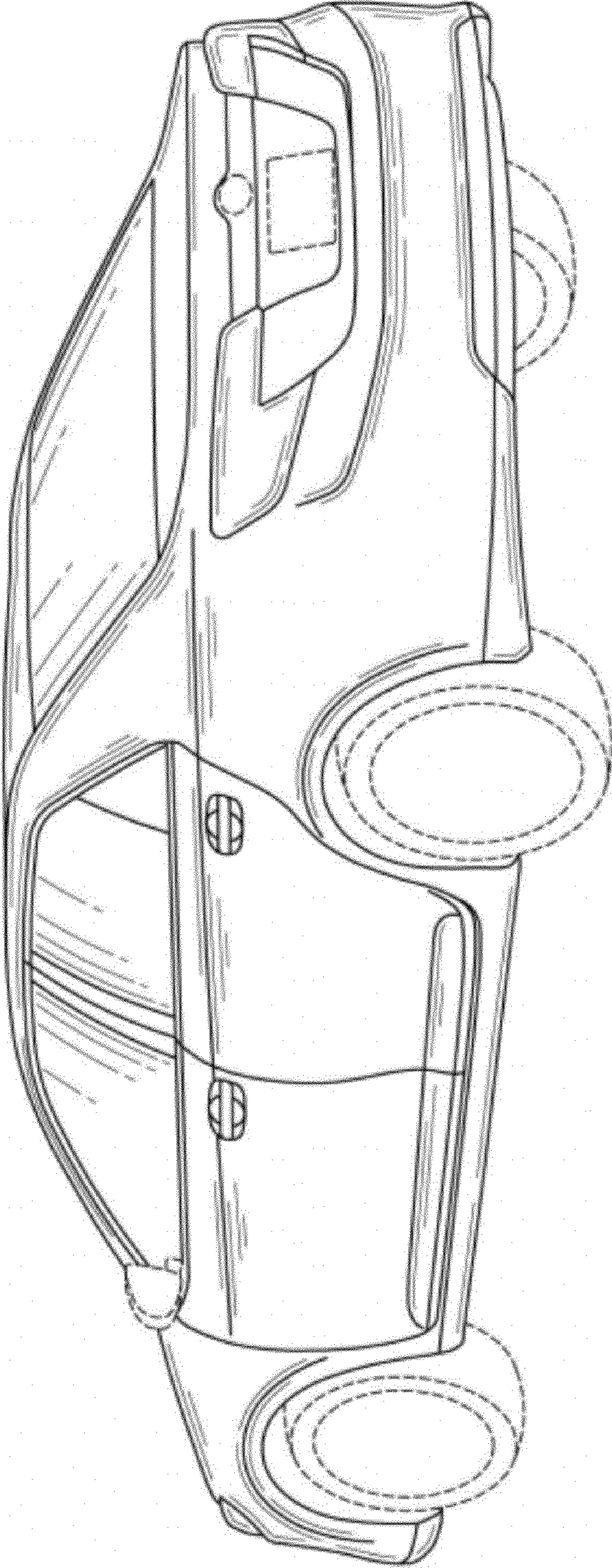

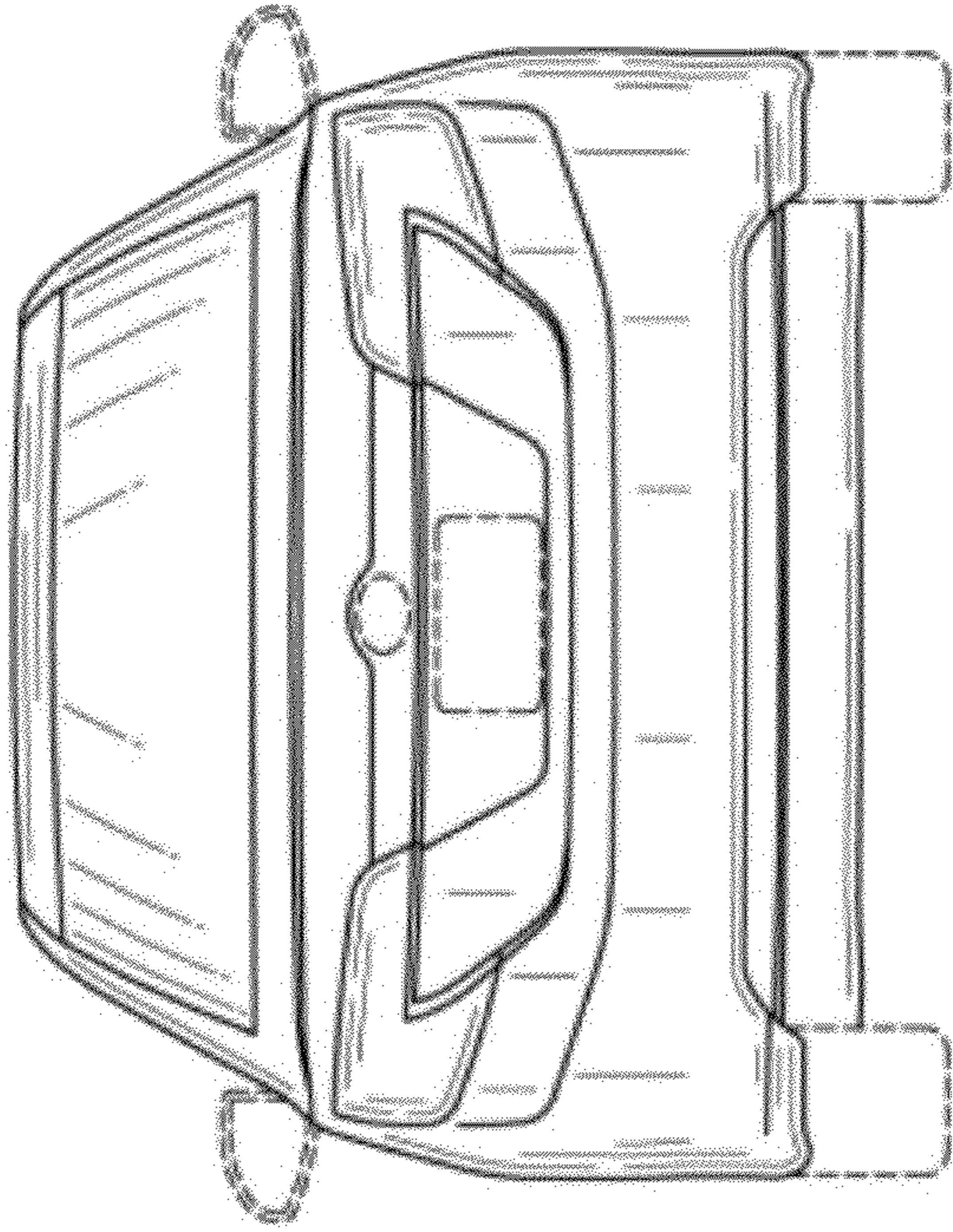

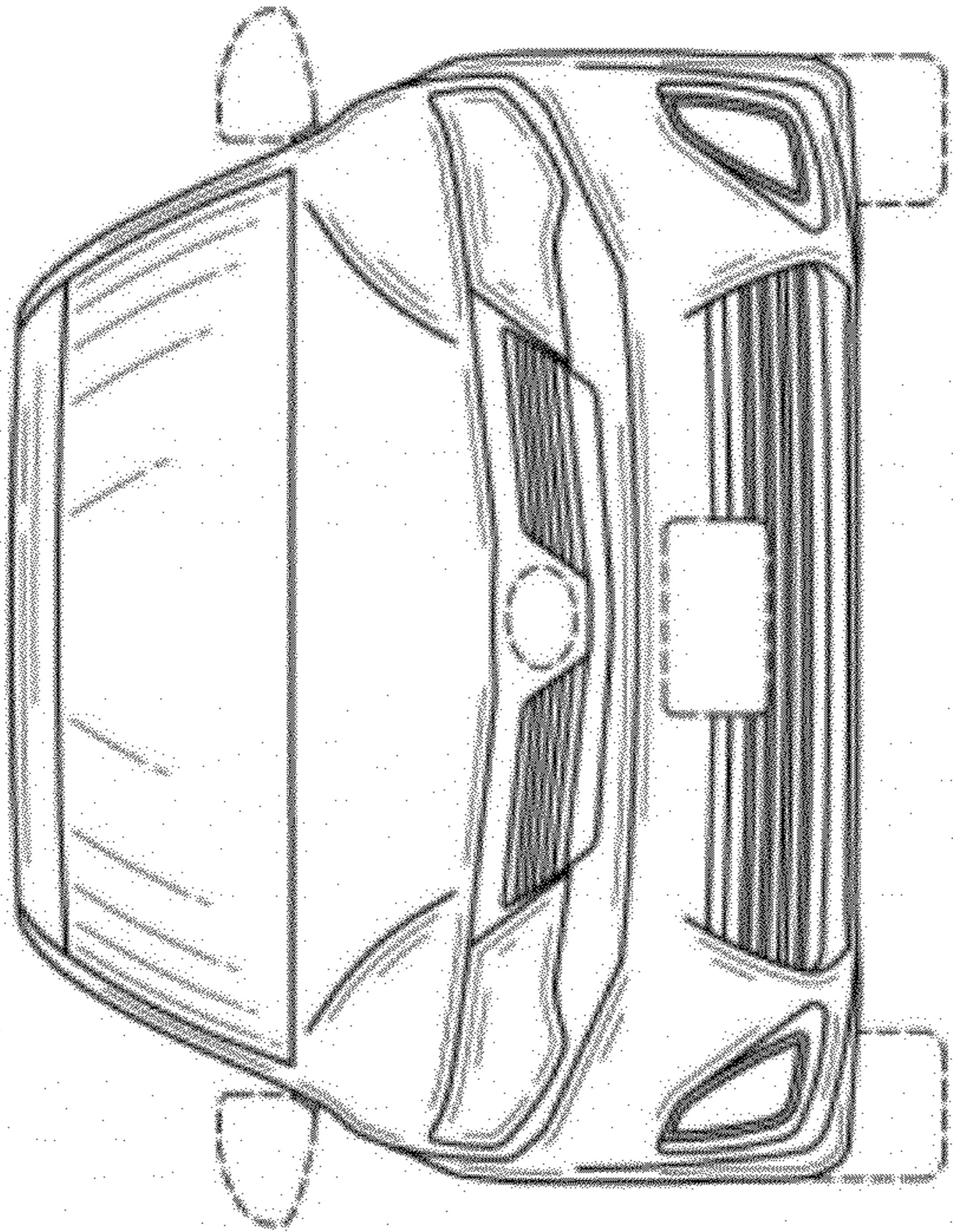

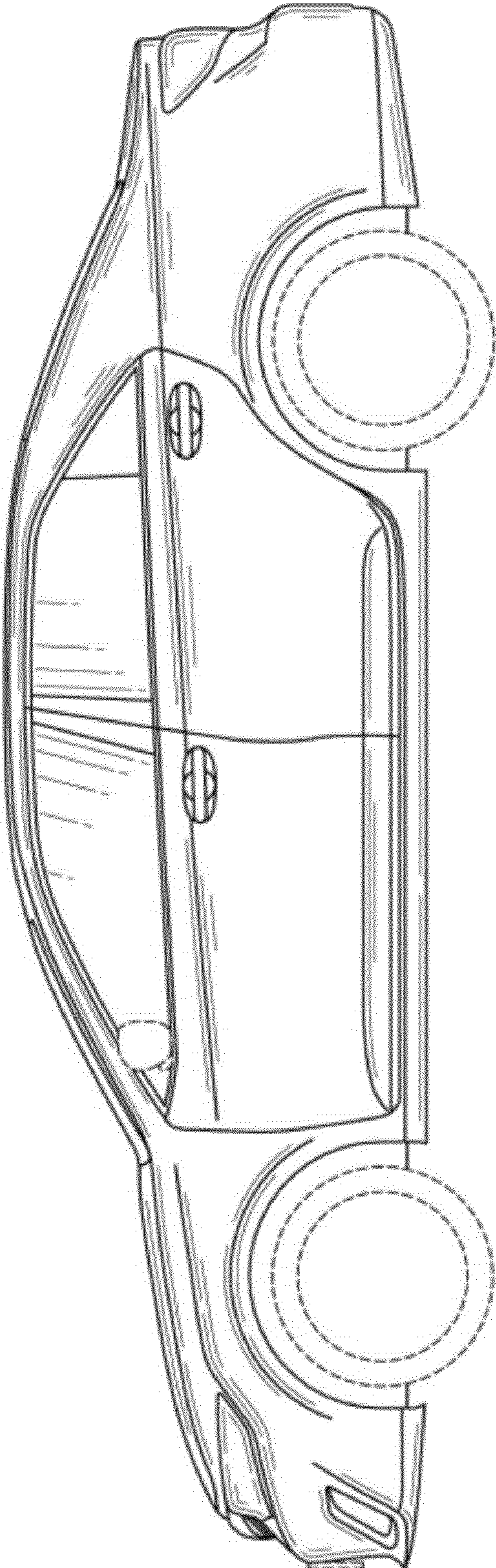

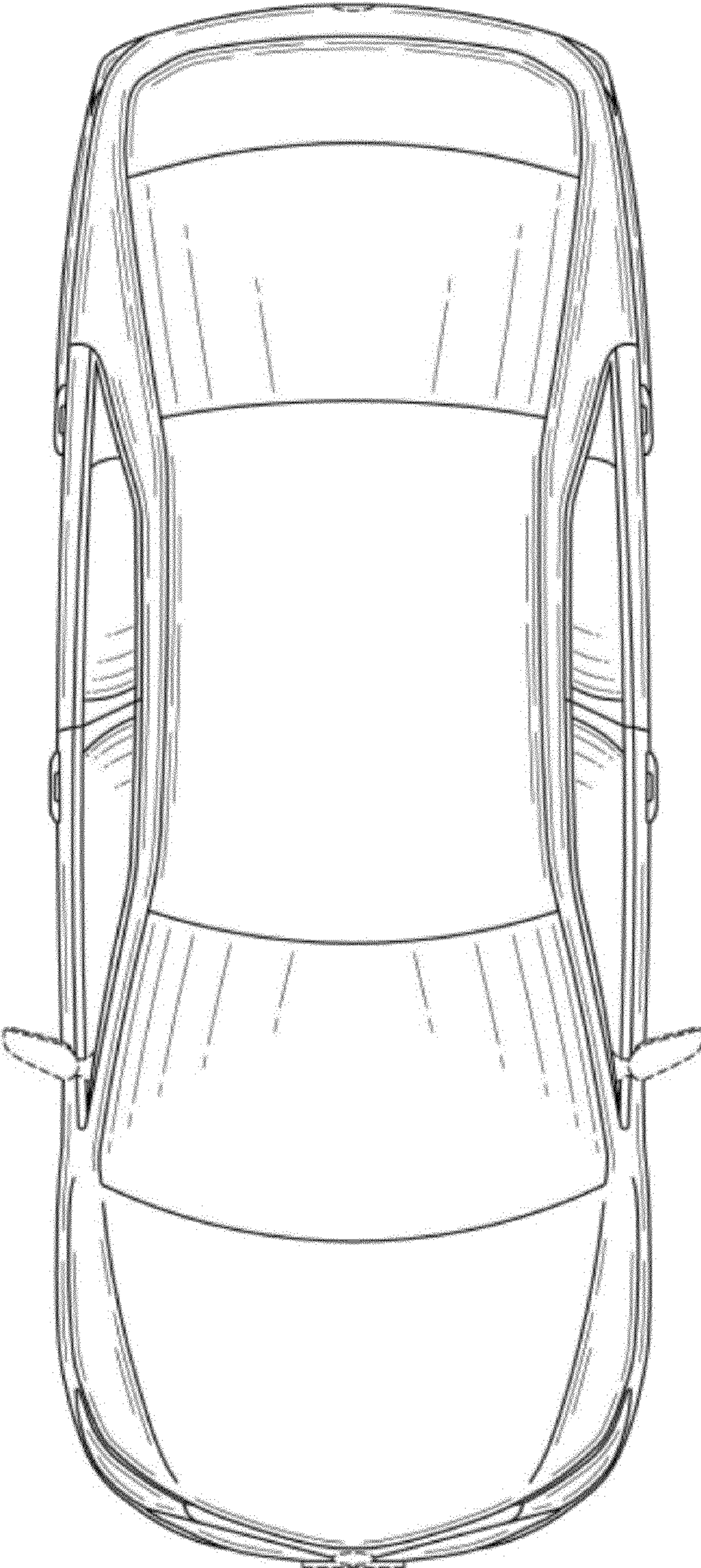
