The ornamental design for a terminal for portable mobile communication, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of terminal for portable mobile communication;  
FIG. 2 is a front view of the terminal for portable mobile communication of FIG. 1;  
FIG. 3 is a rear view of the terminal for portable mobile communication of FIG. 1;

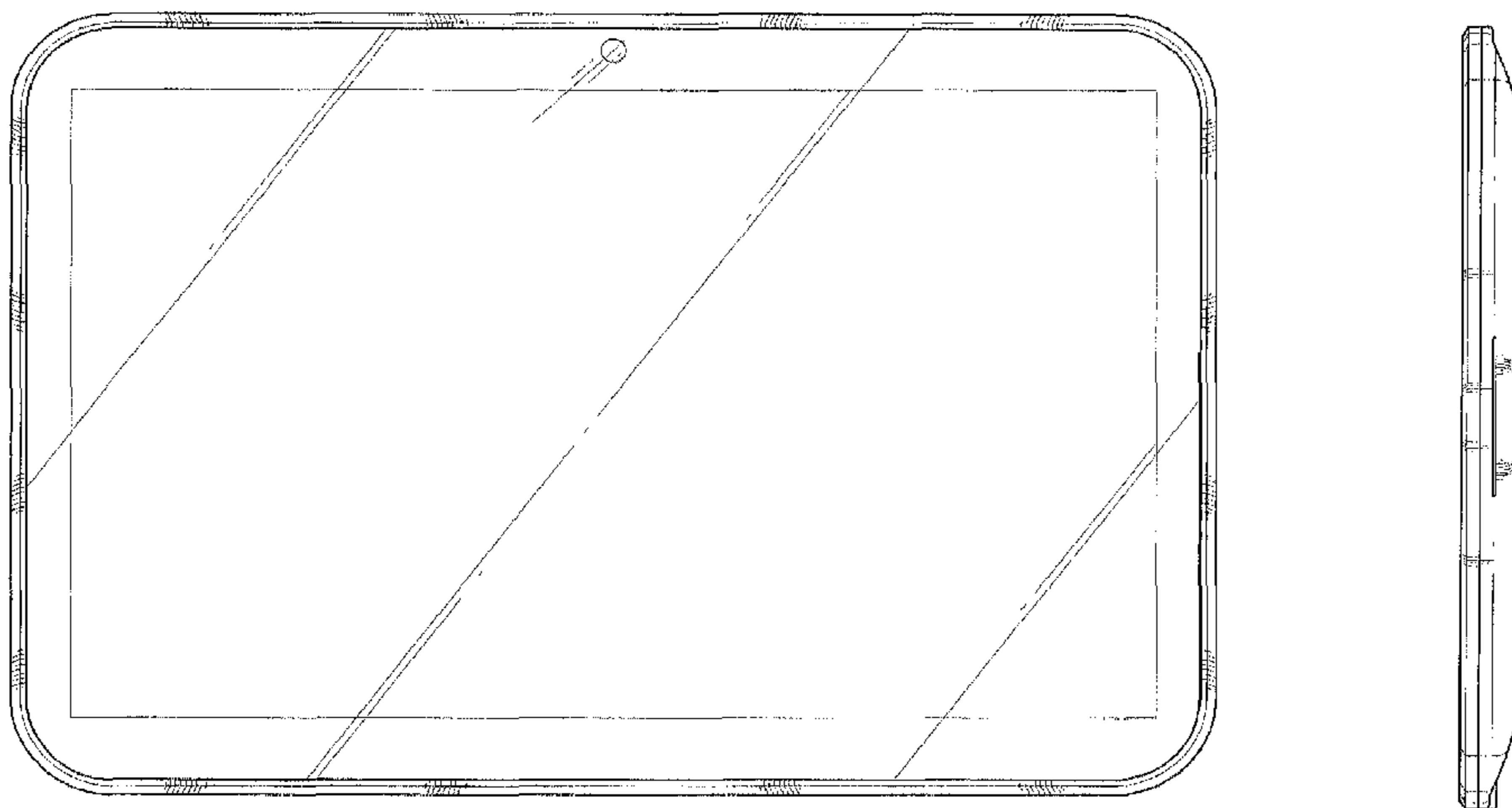

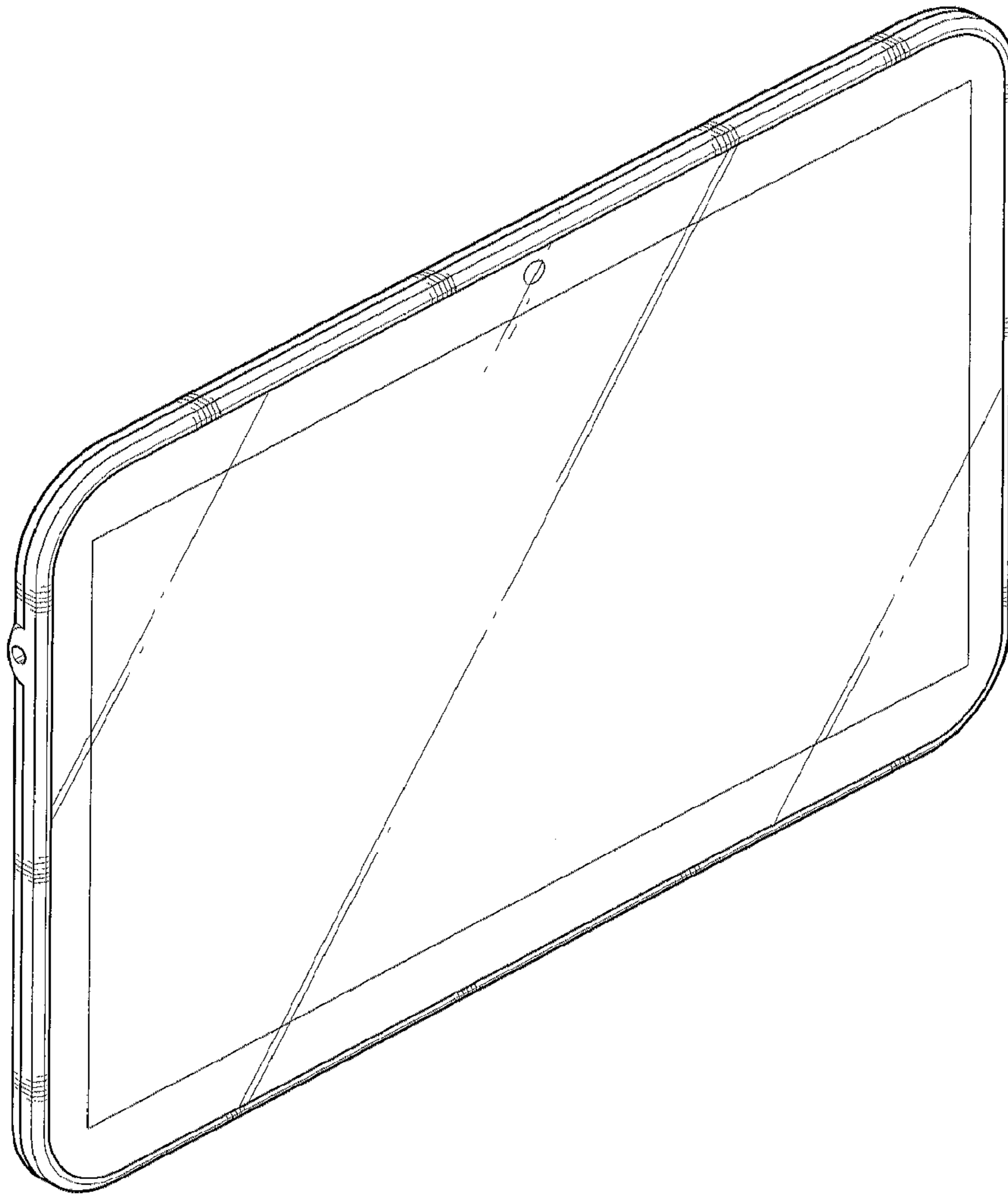

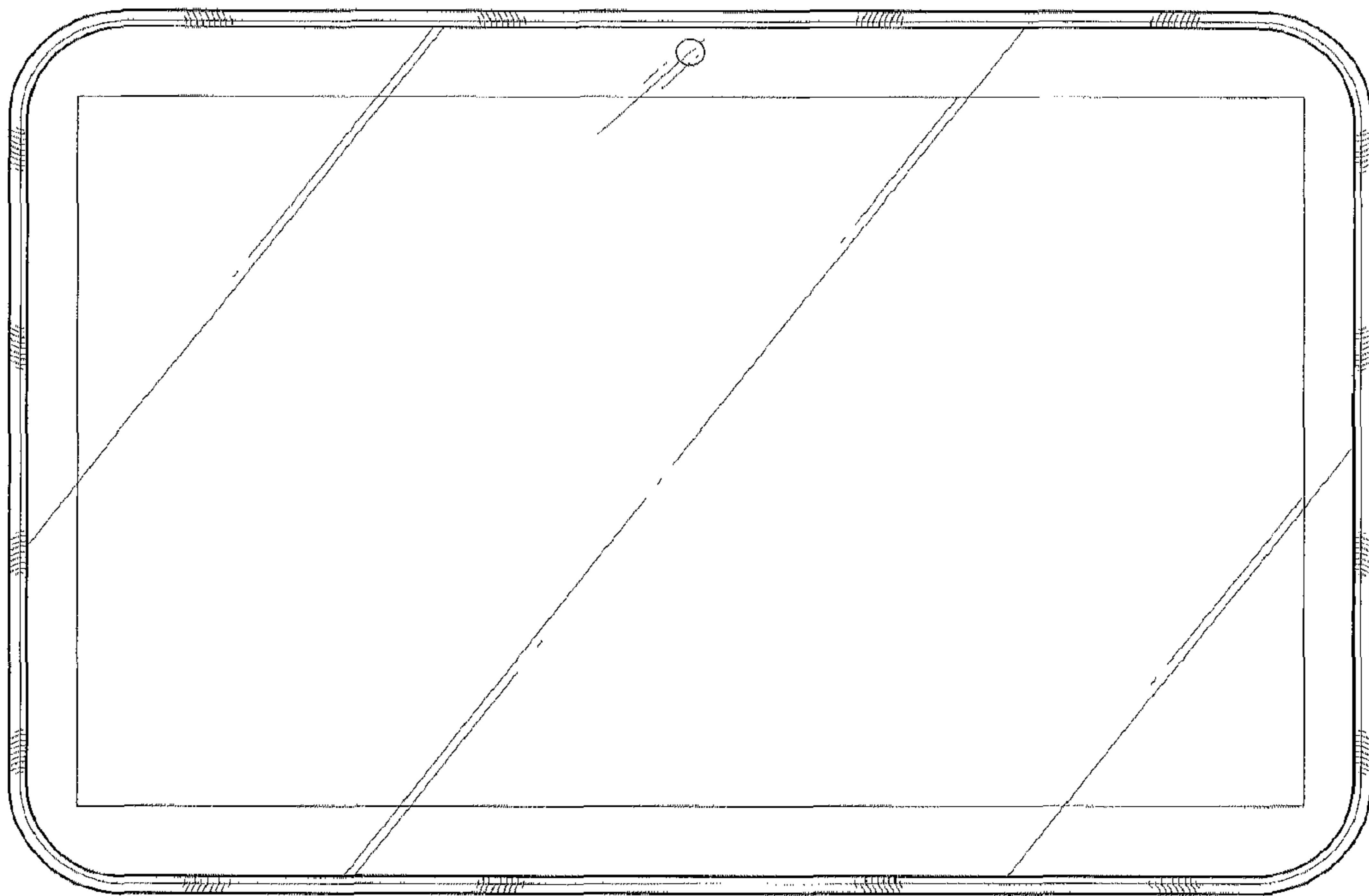
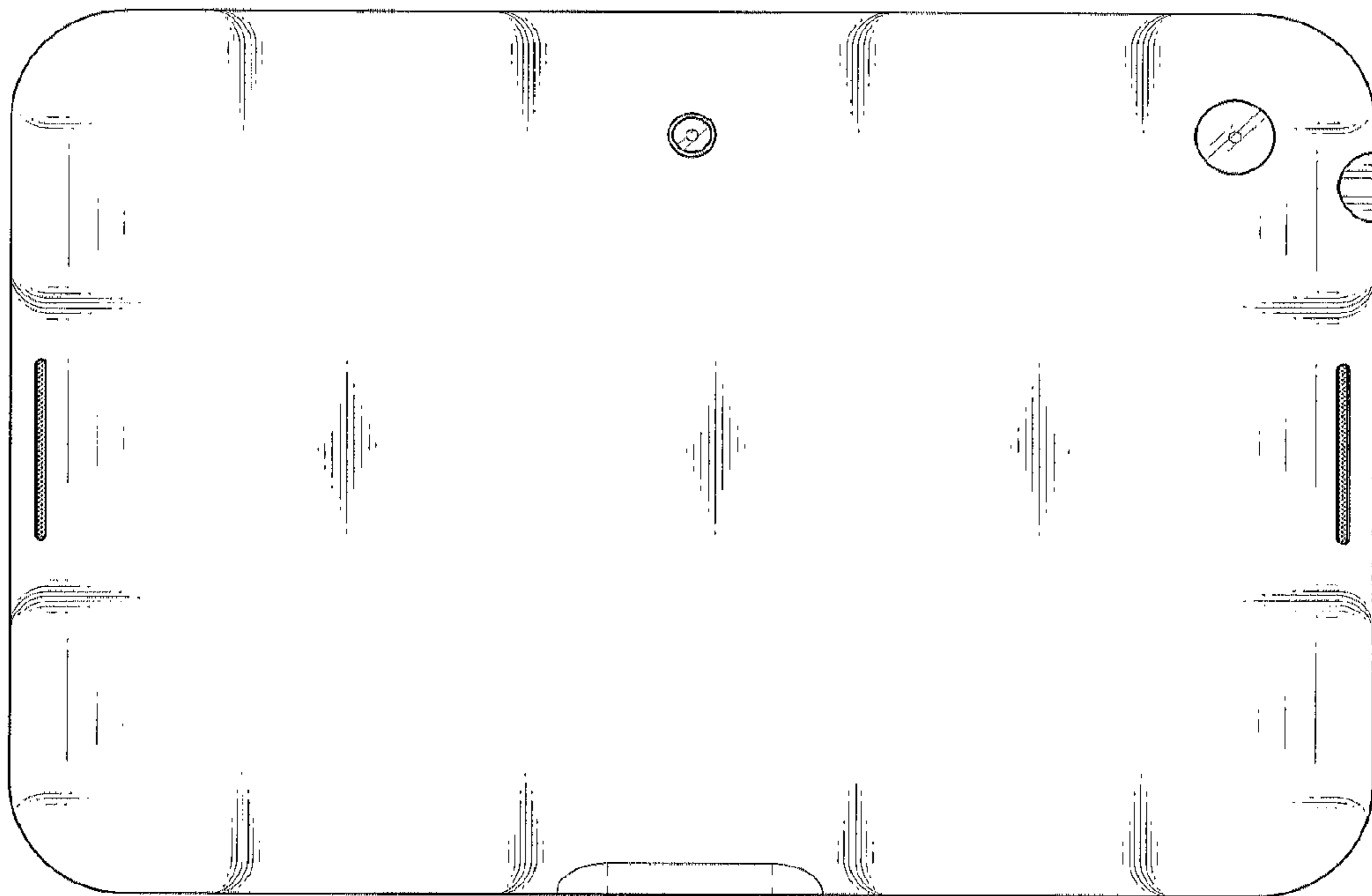
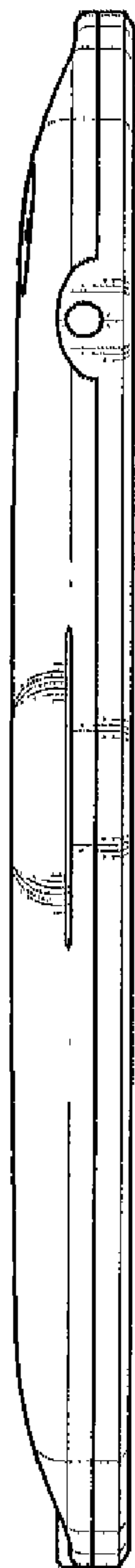

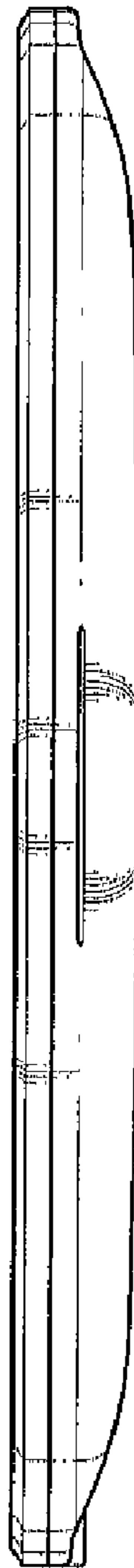

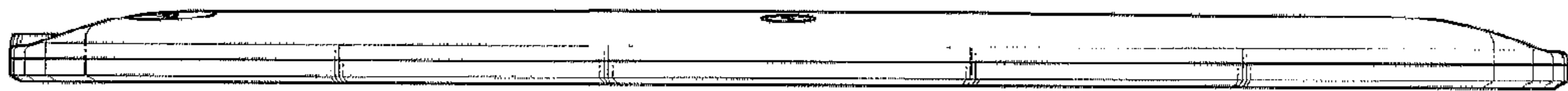
