(57) **CLAIM**

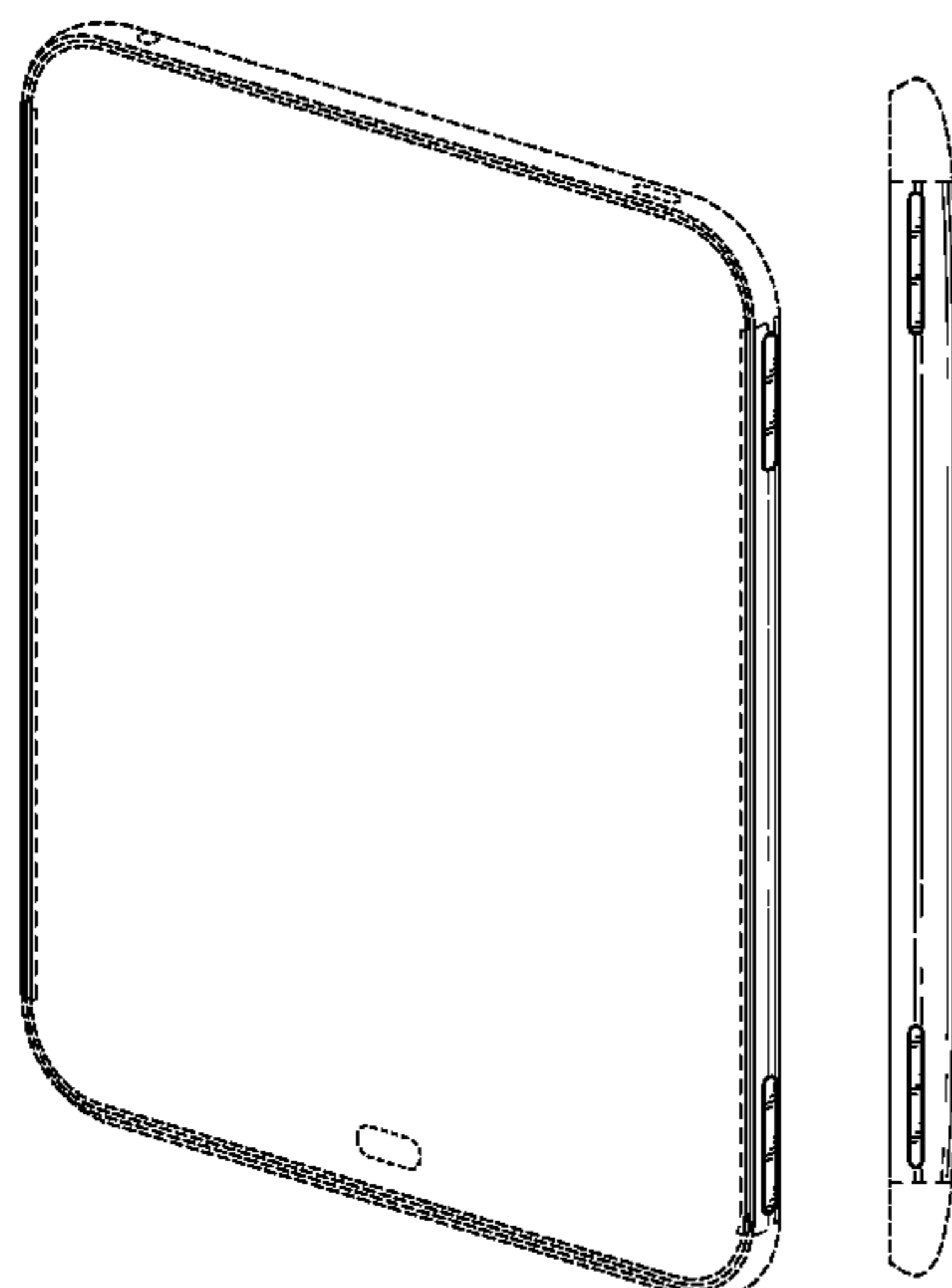
The ornamental design for a mobile computing device housing with side features, as shown and described.

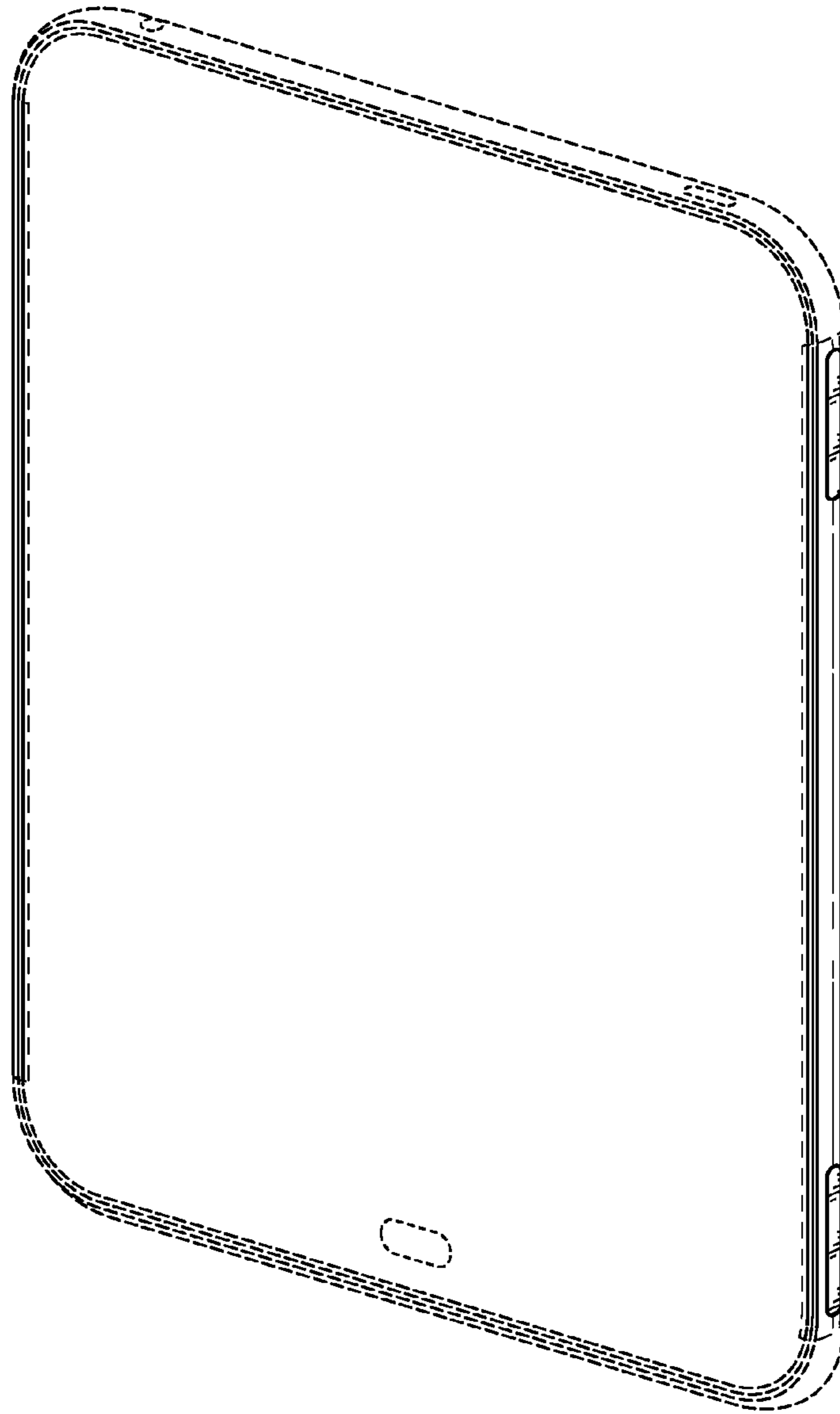

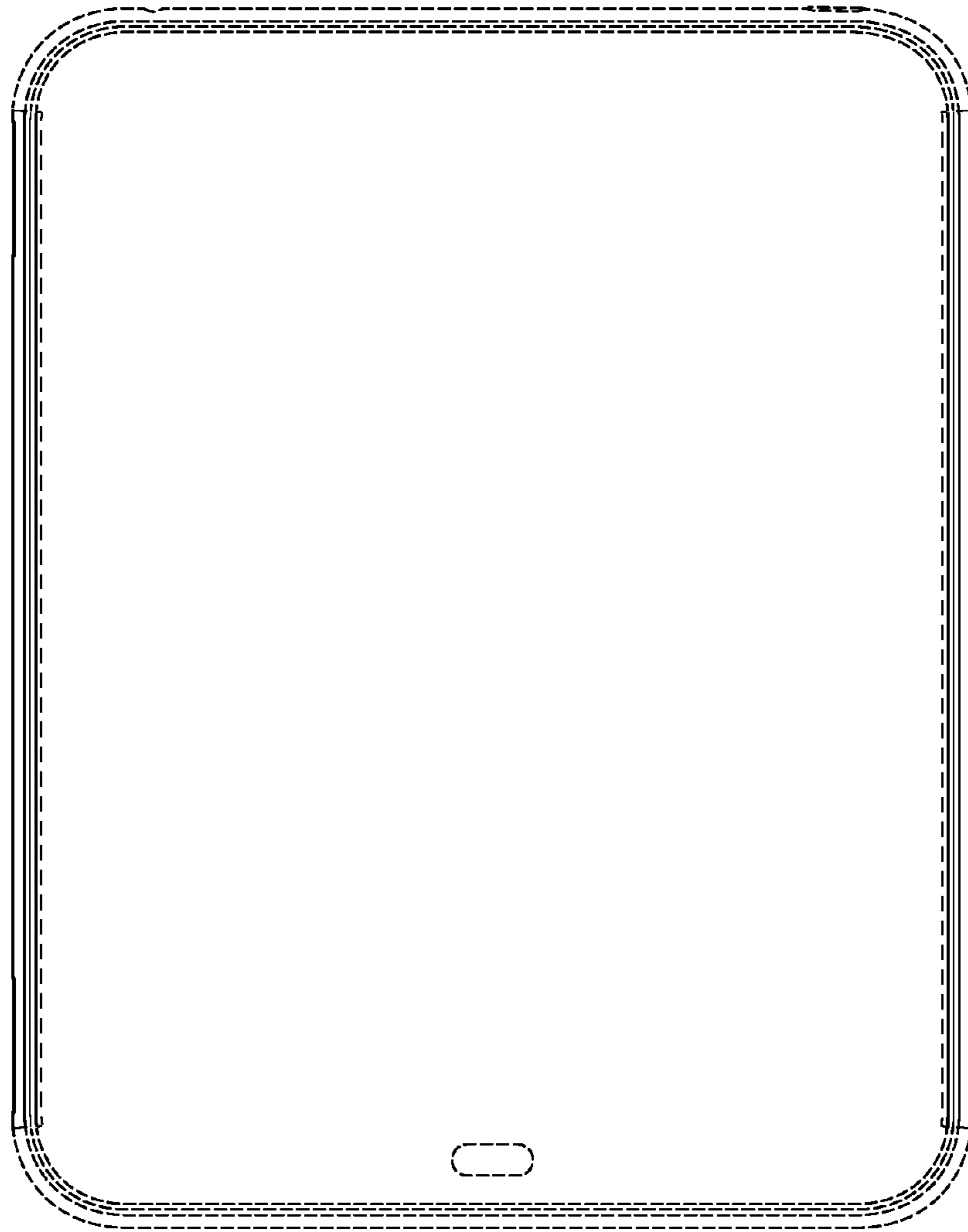

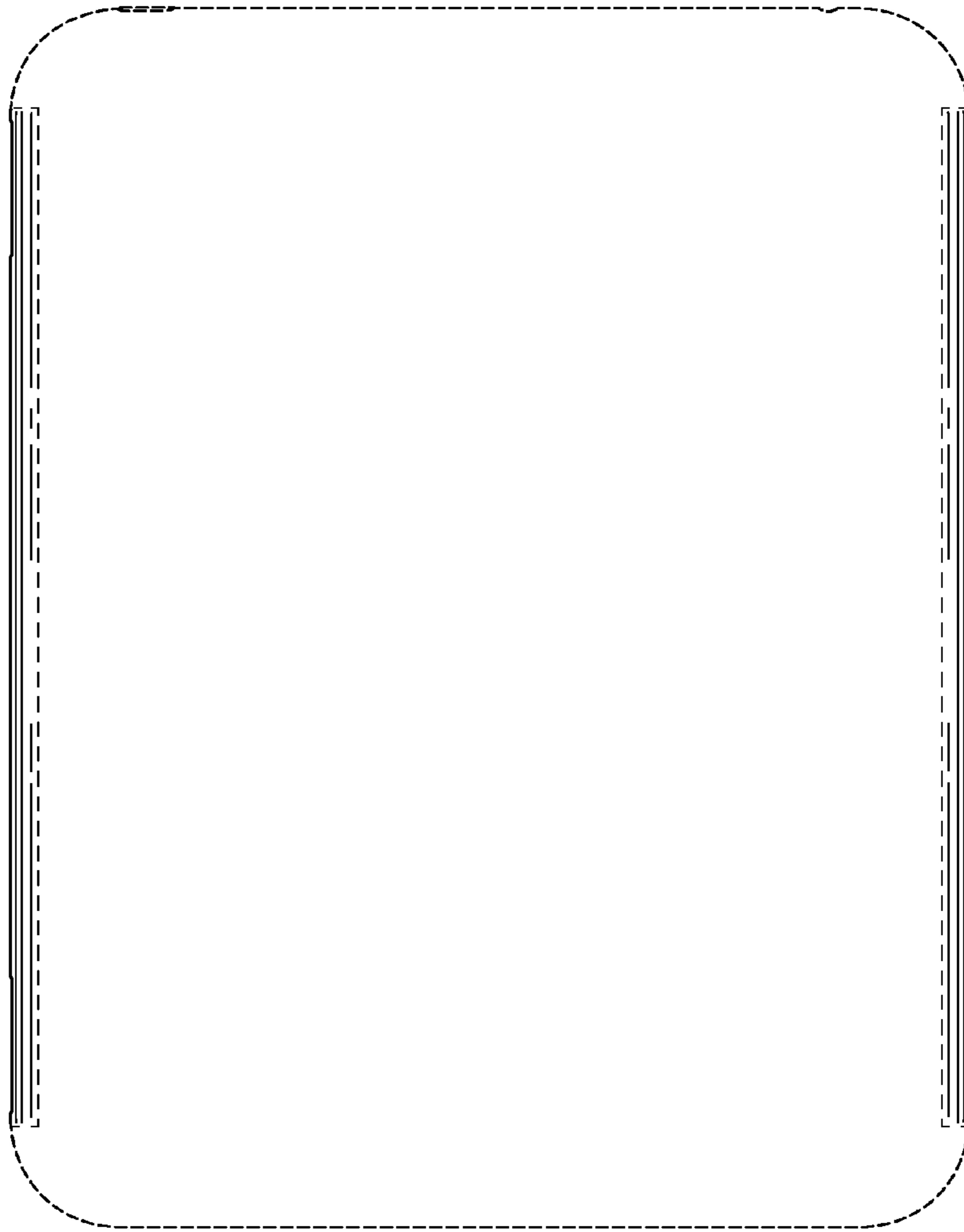

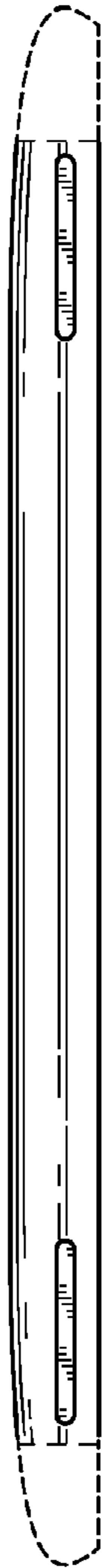

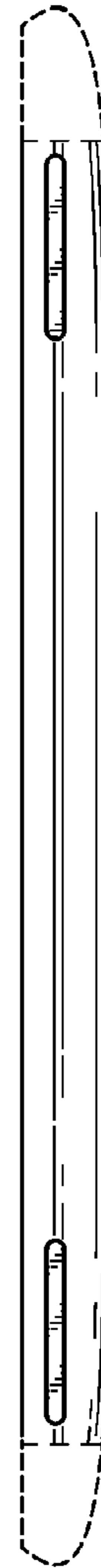
