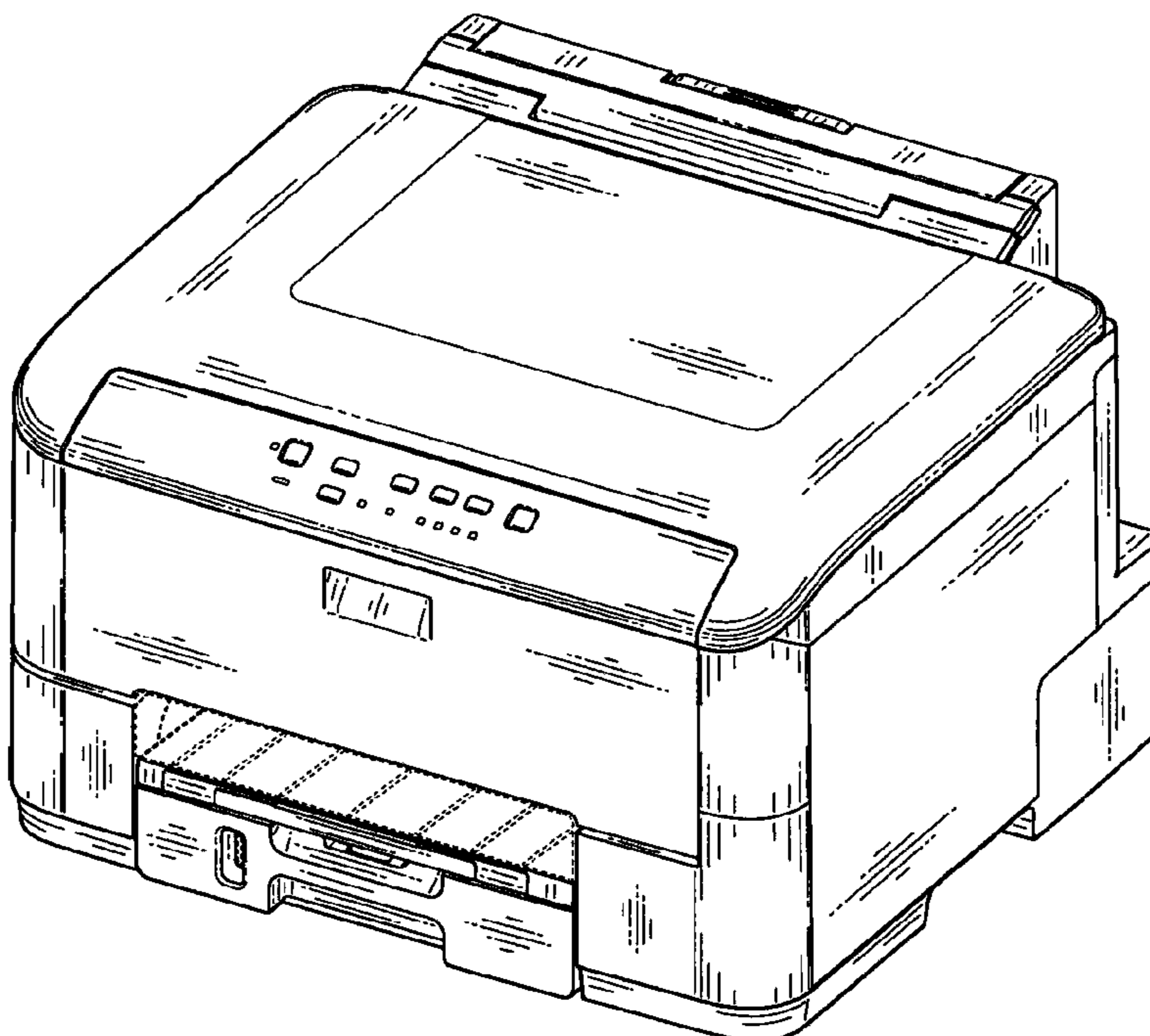
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a printer, as viewed from the top, front and right side, embodying our new design;

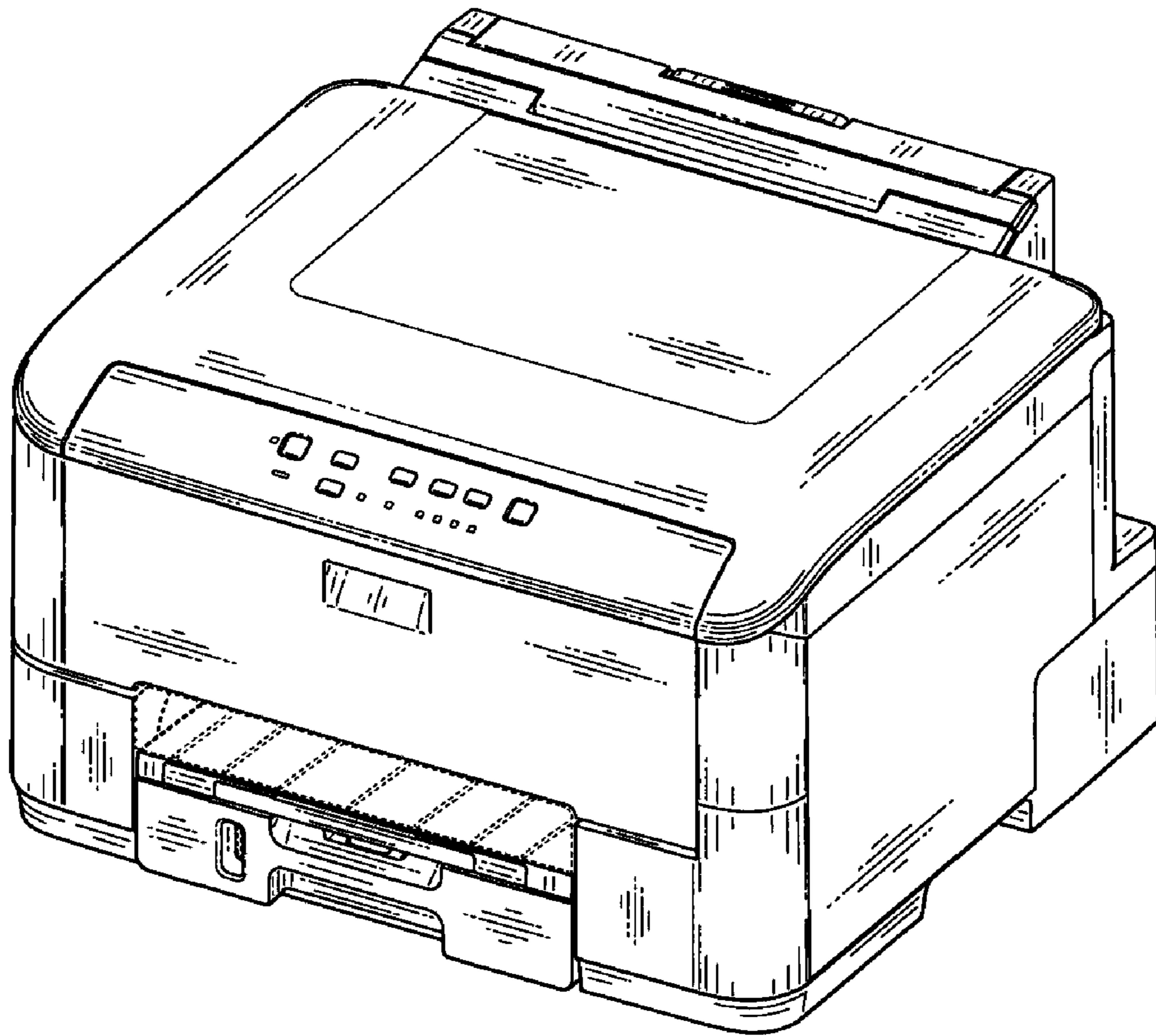

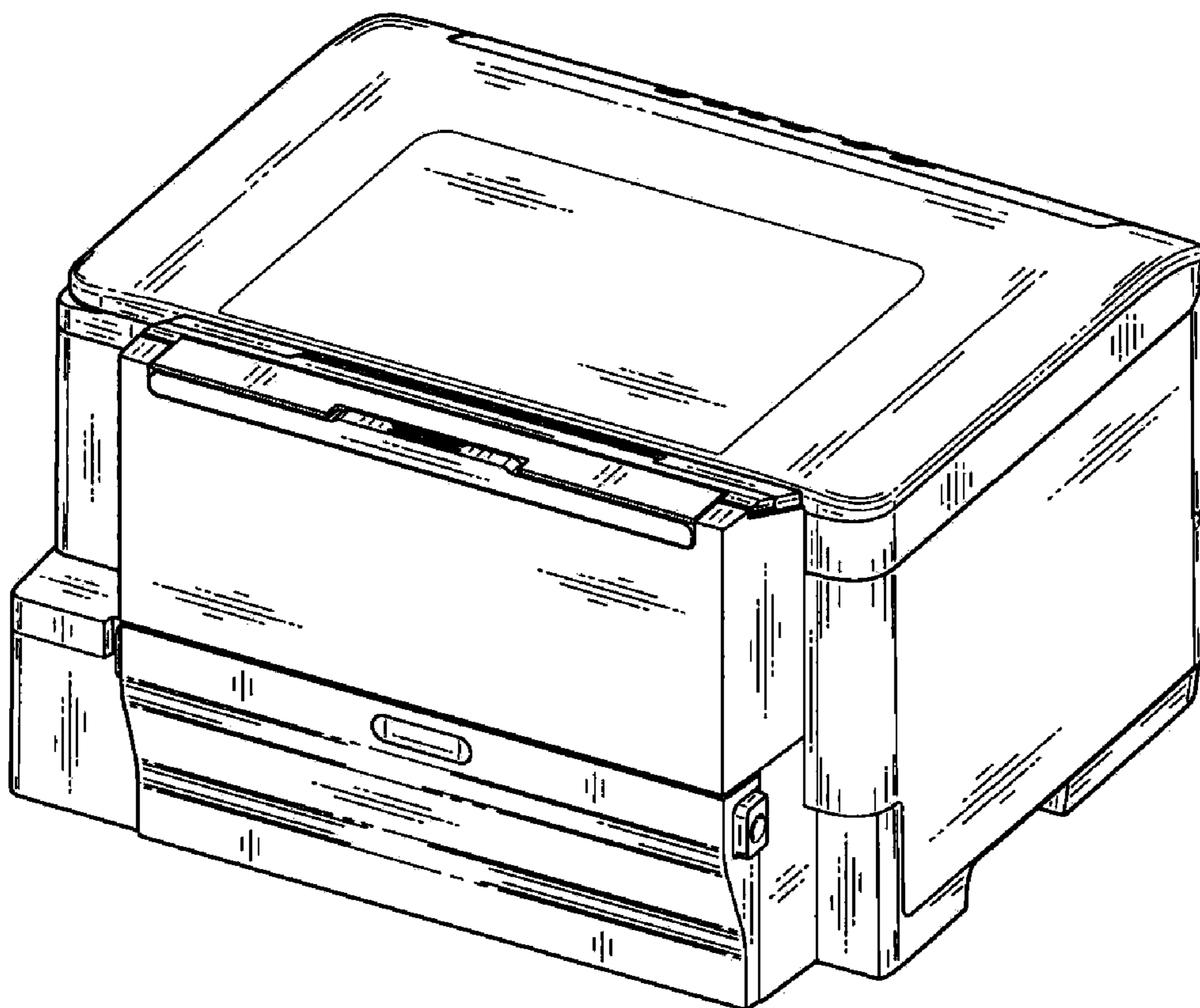

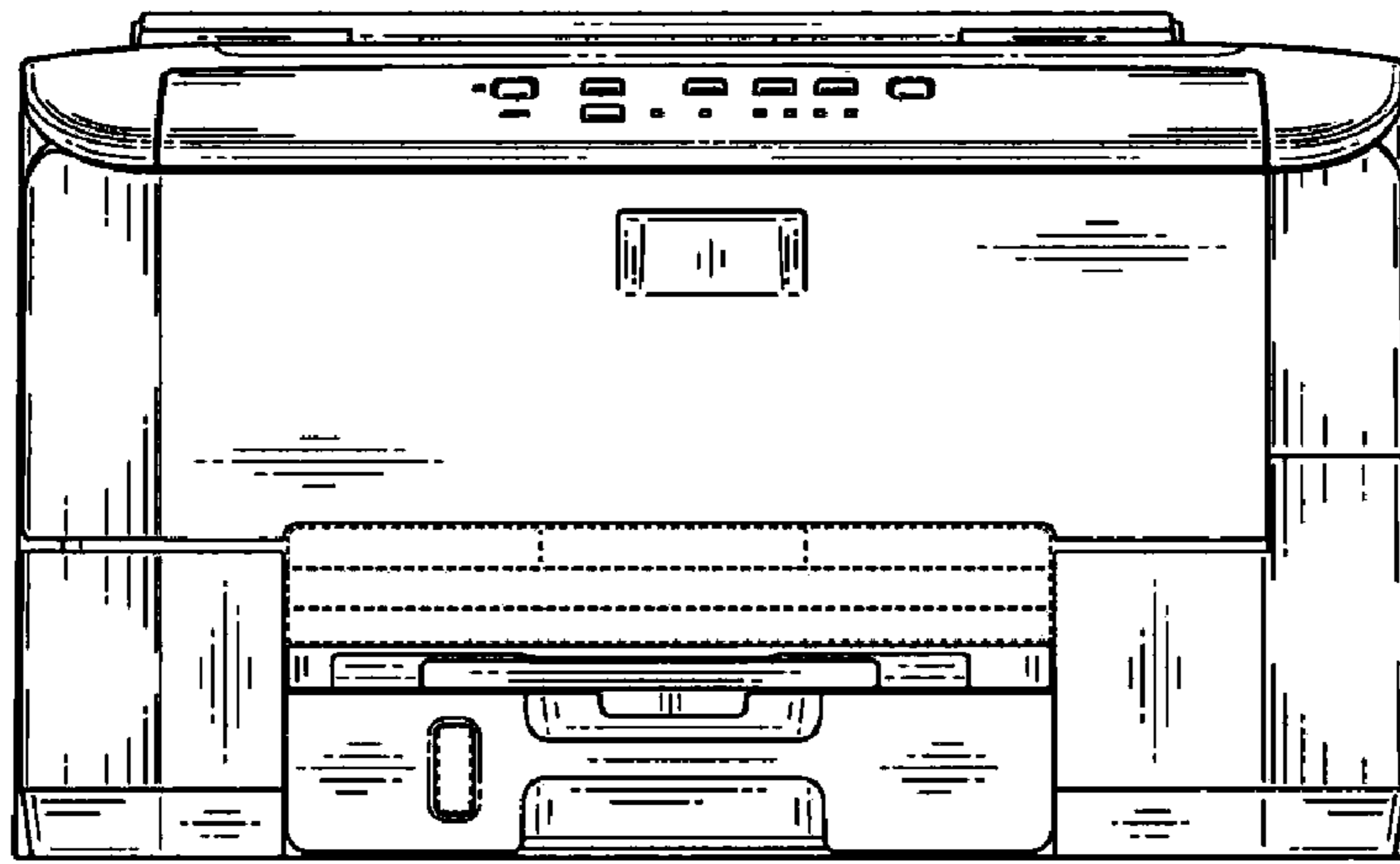

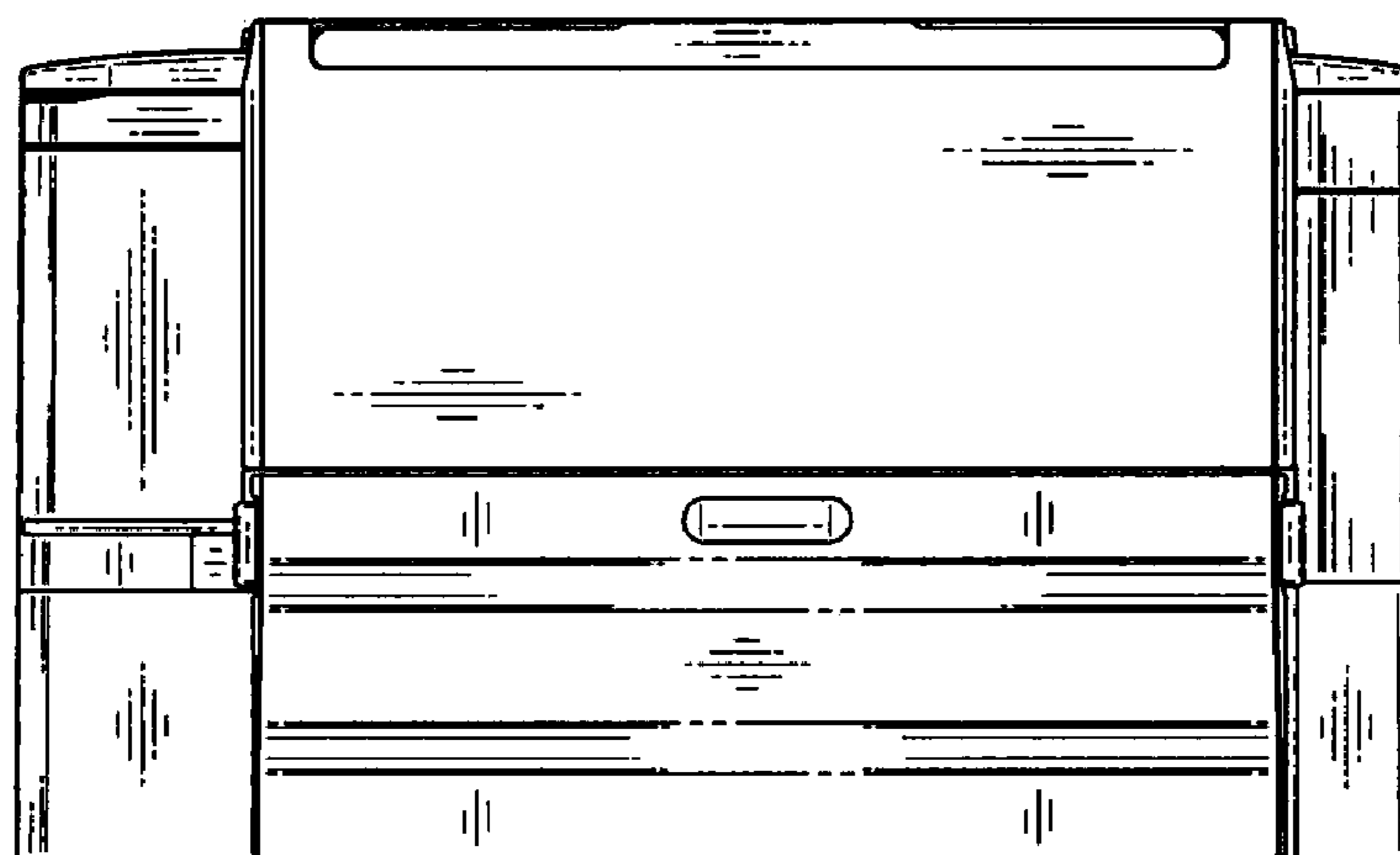

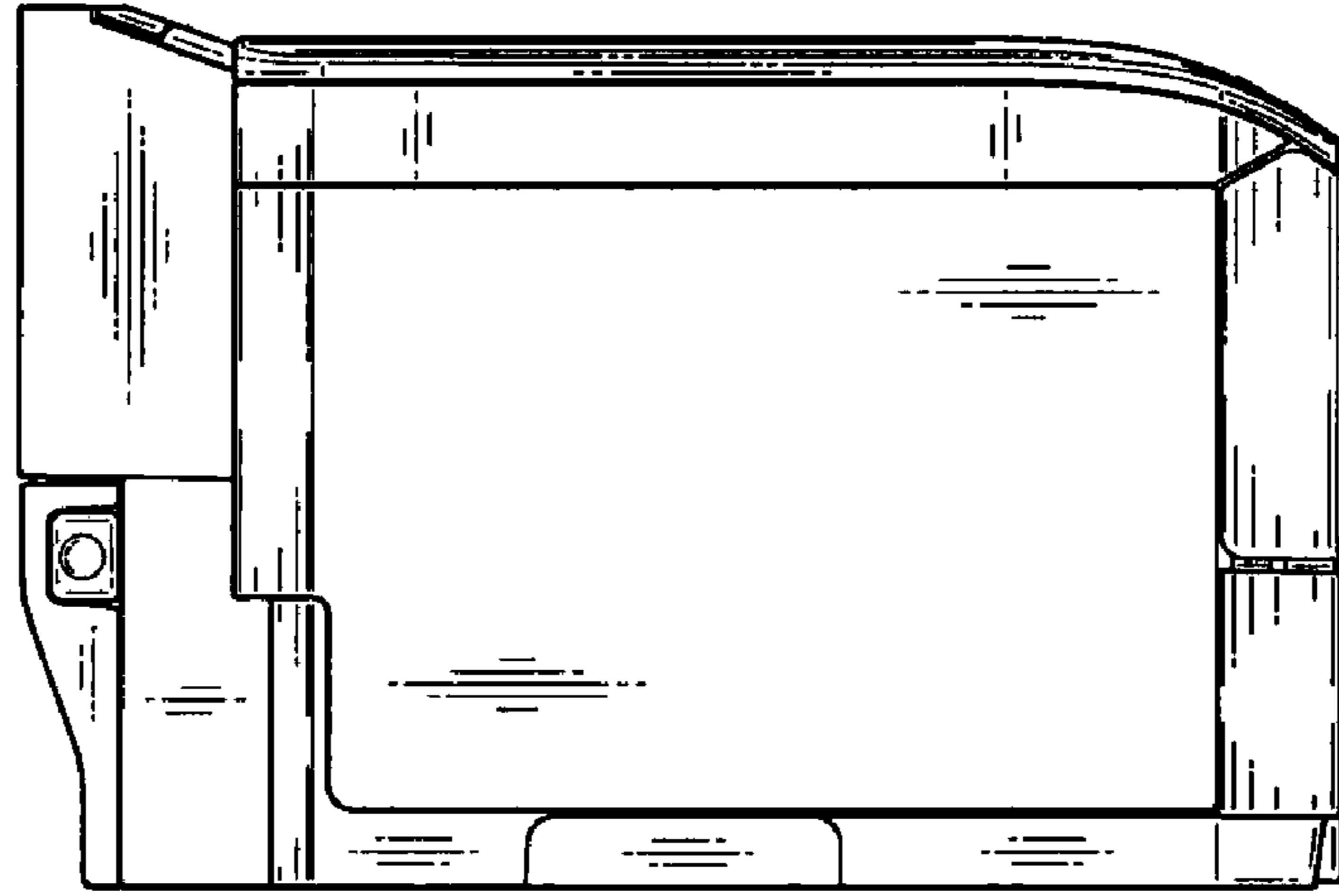

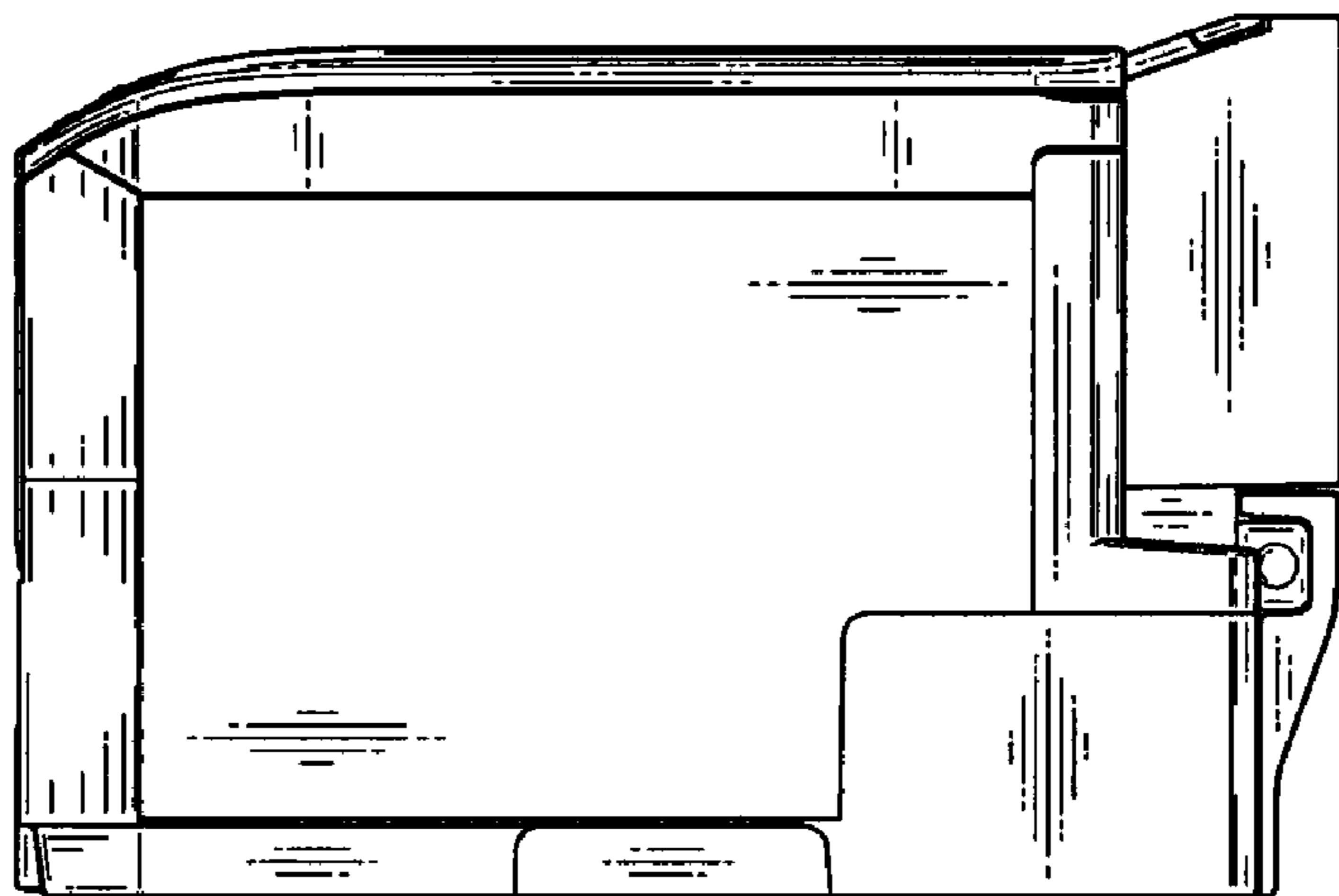

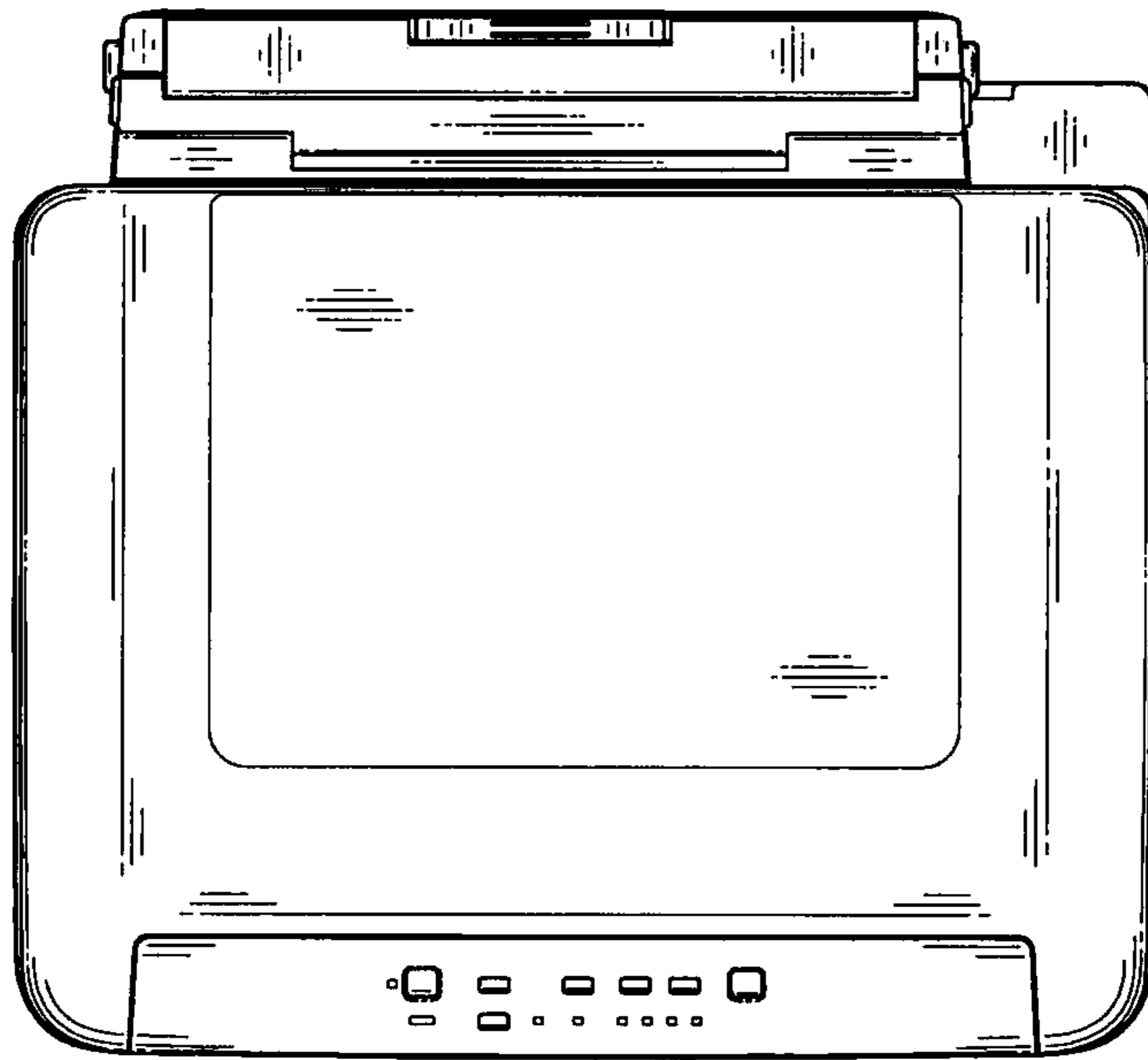

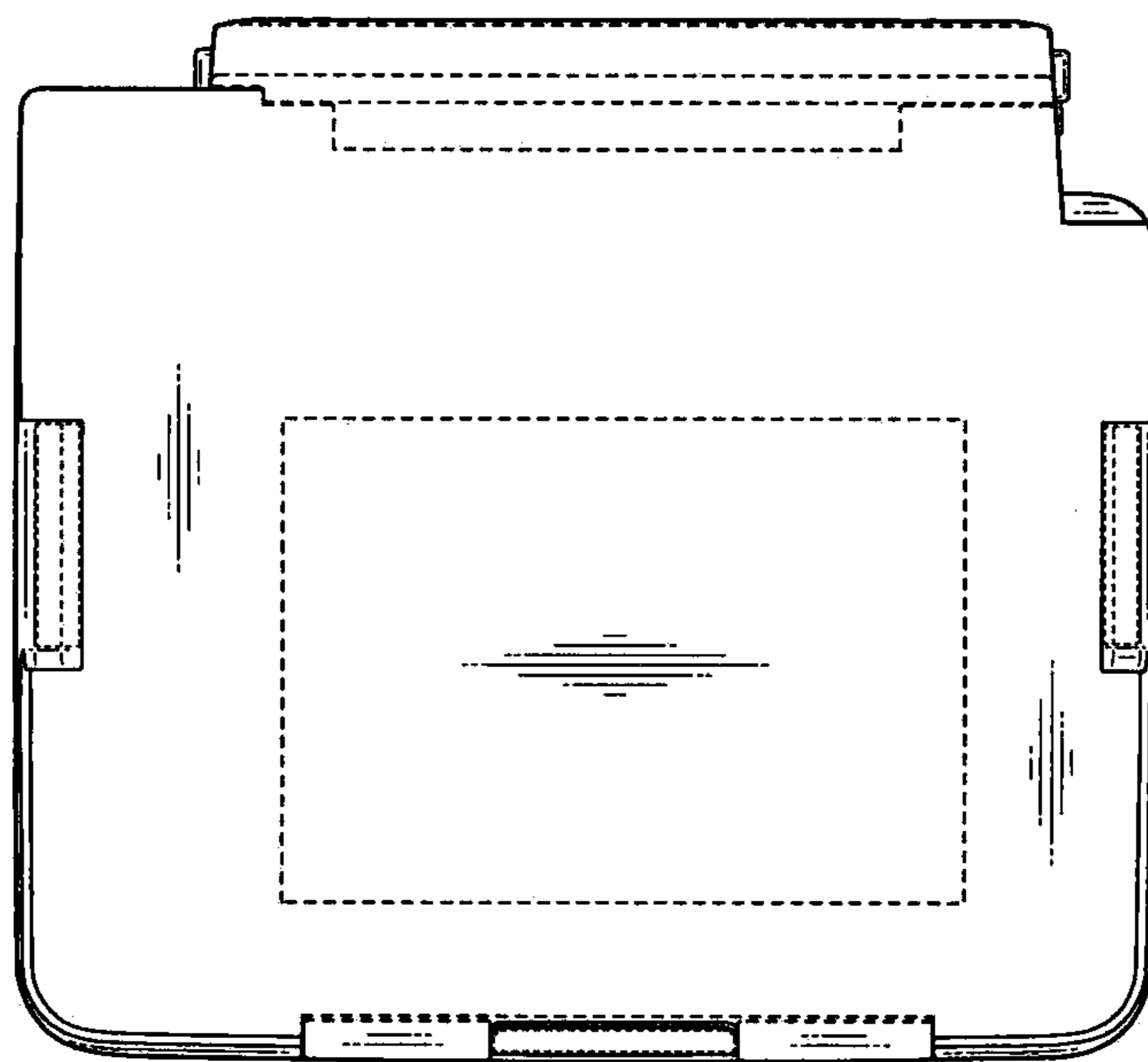
