The ornamental design for a marker, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing our new design for a marker;

FIG. 11 is a right side view of the marker of FIG. 8;

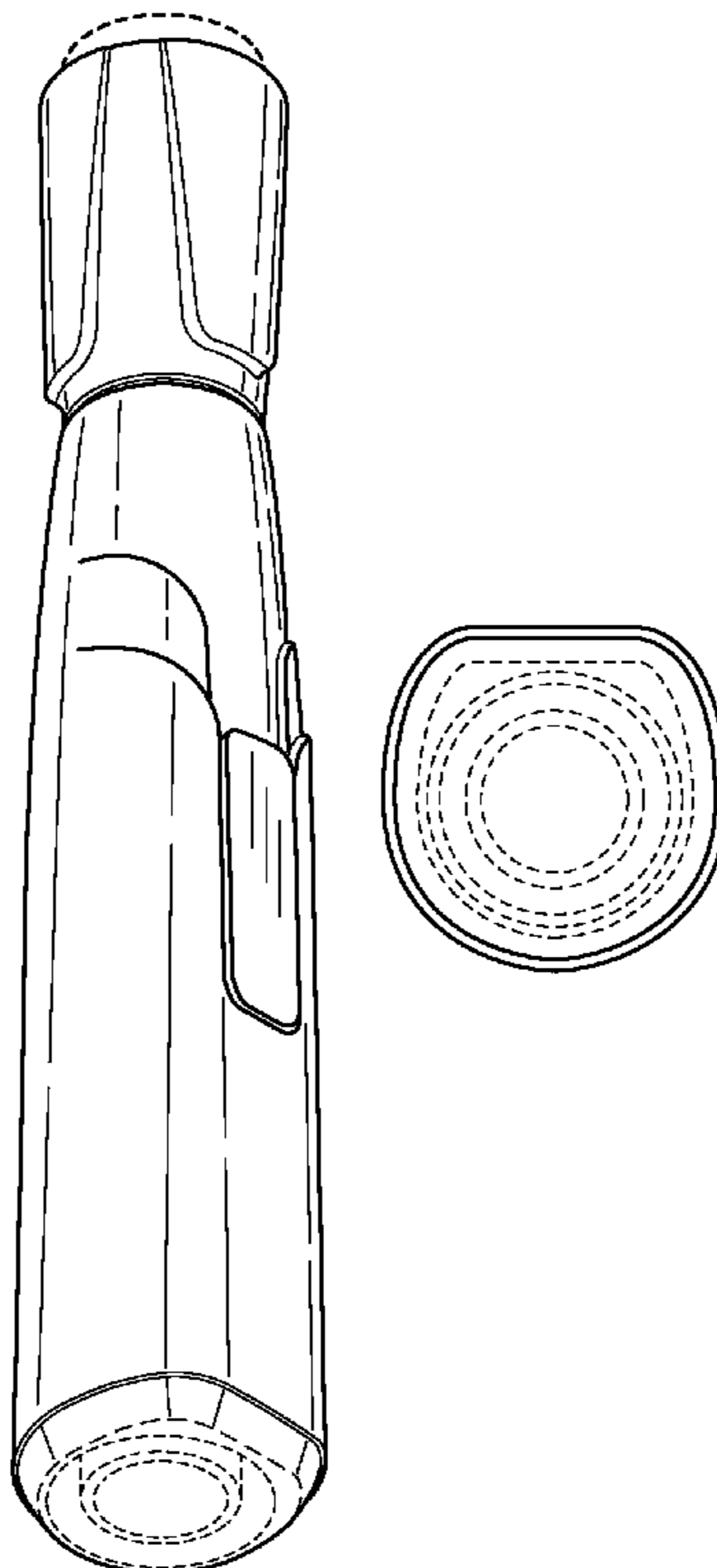
FIG. 12 is a left side view of the marker of FIG. 8;

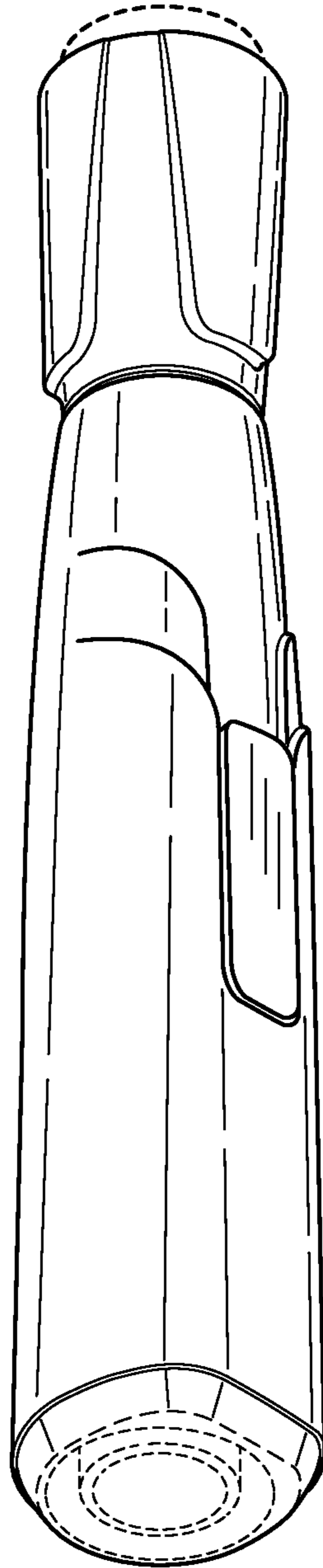

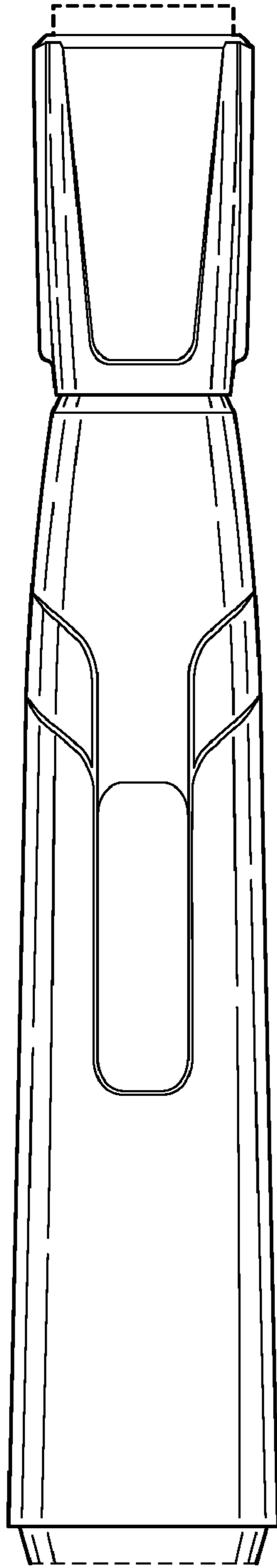

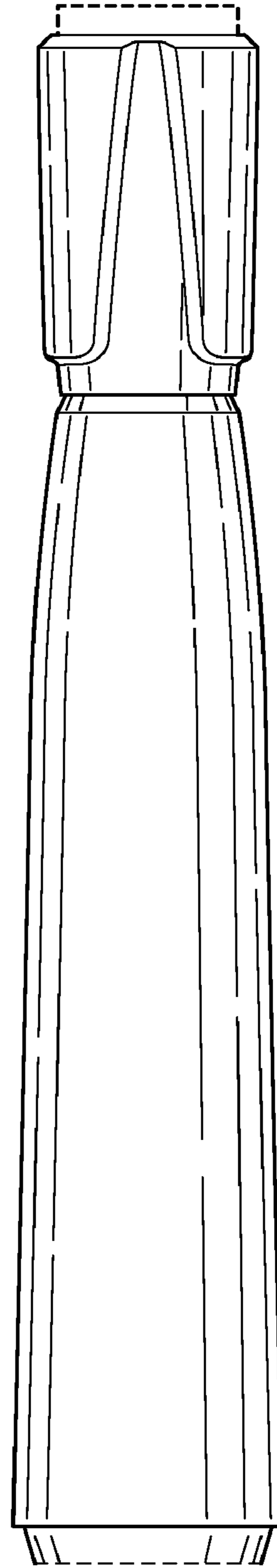

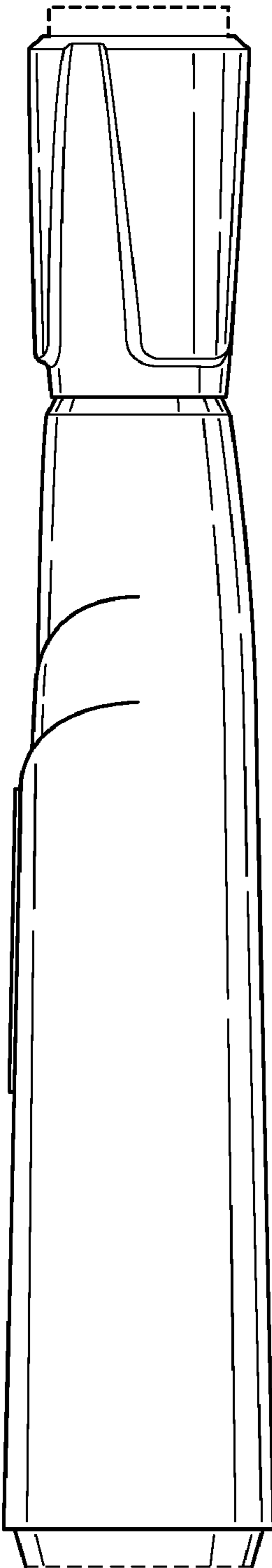

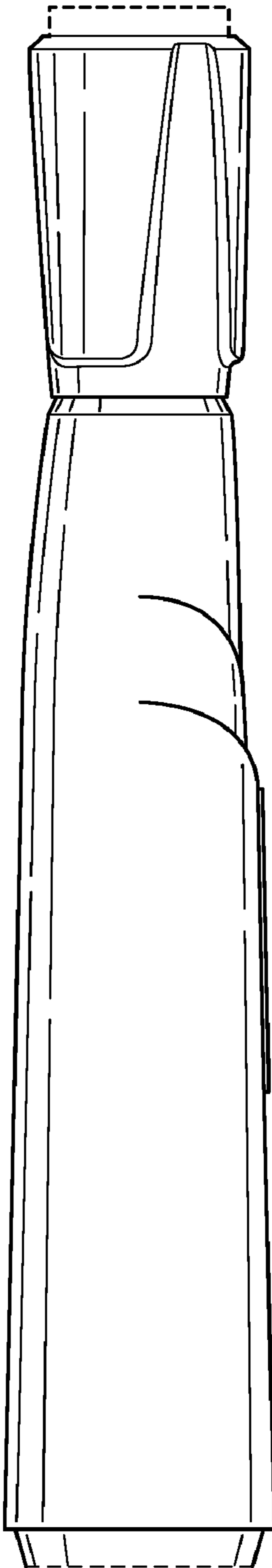

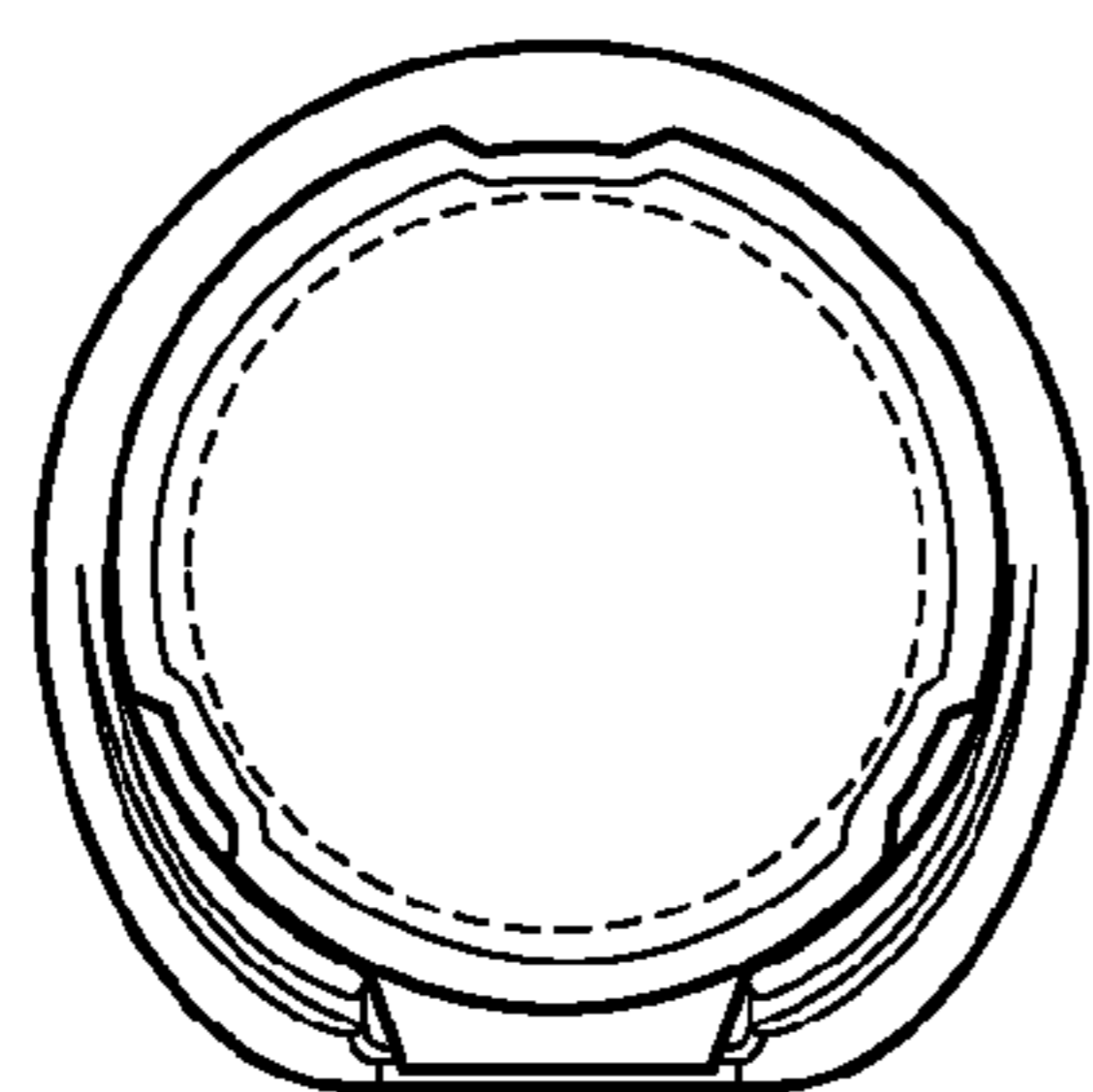

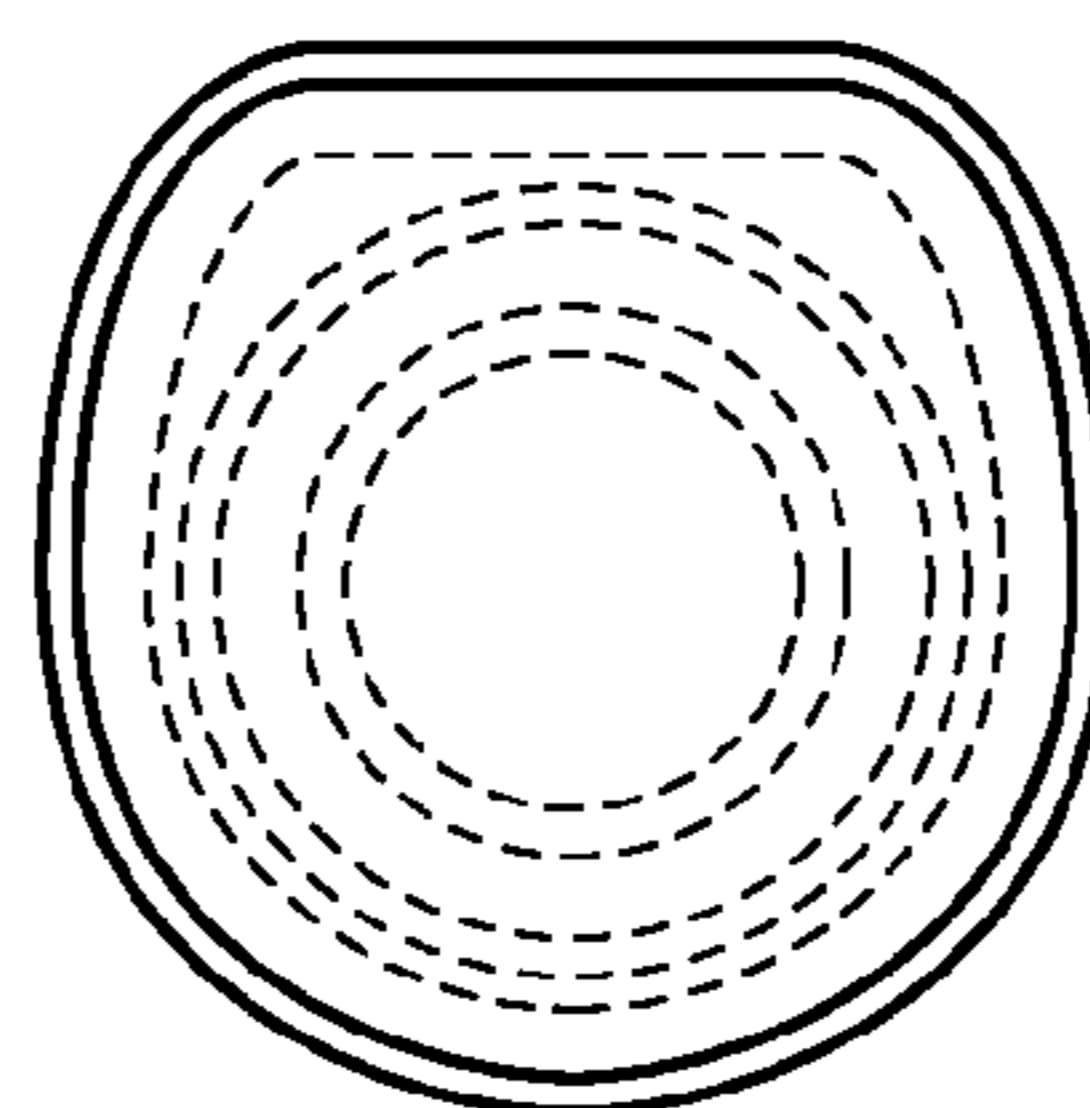

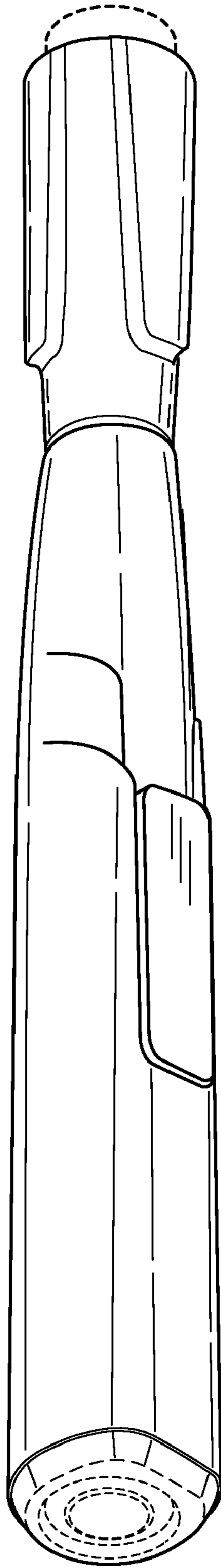

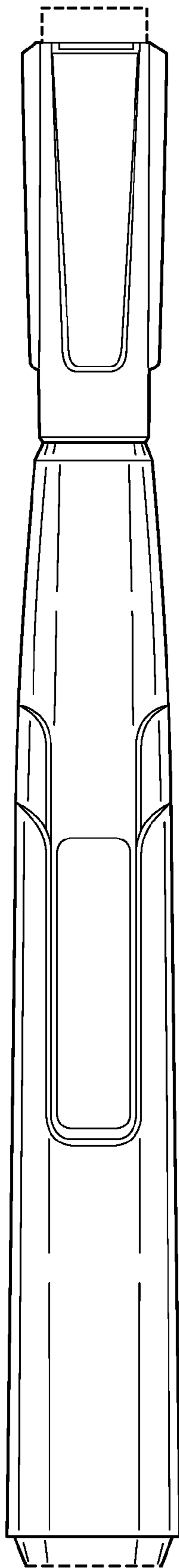

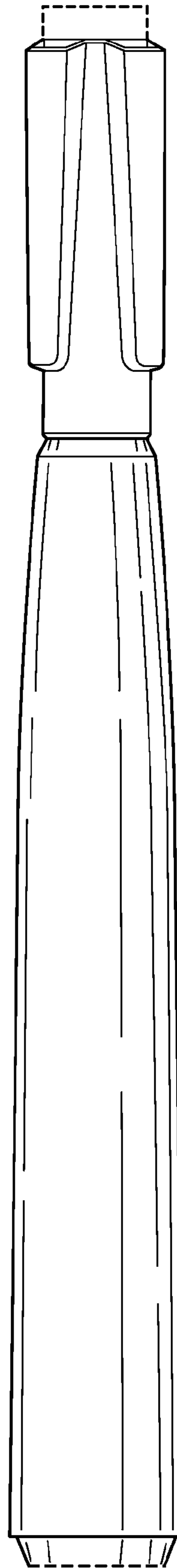

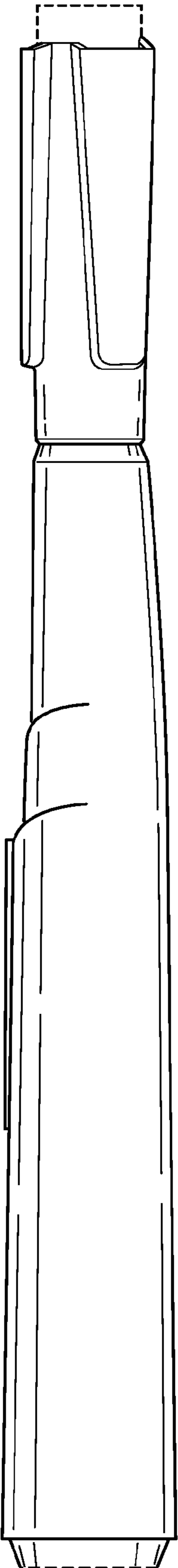

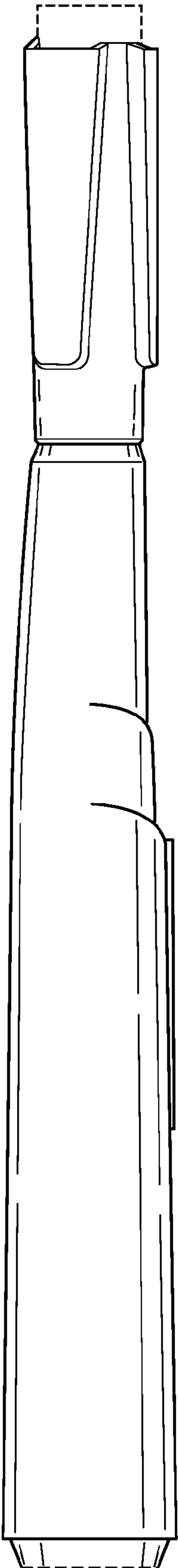

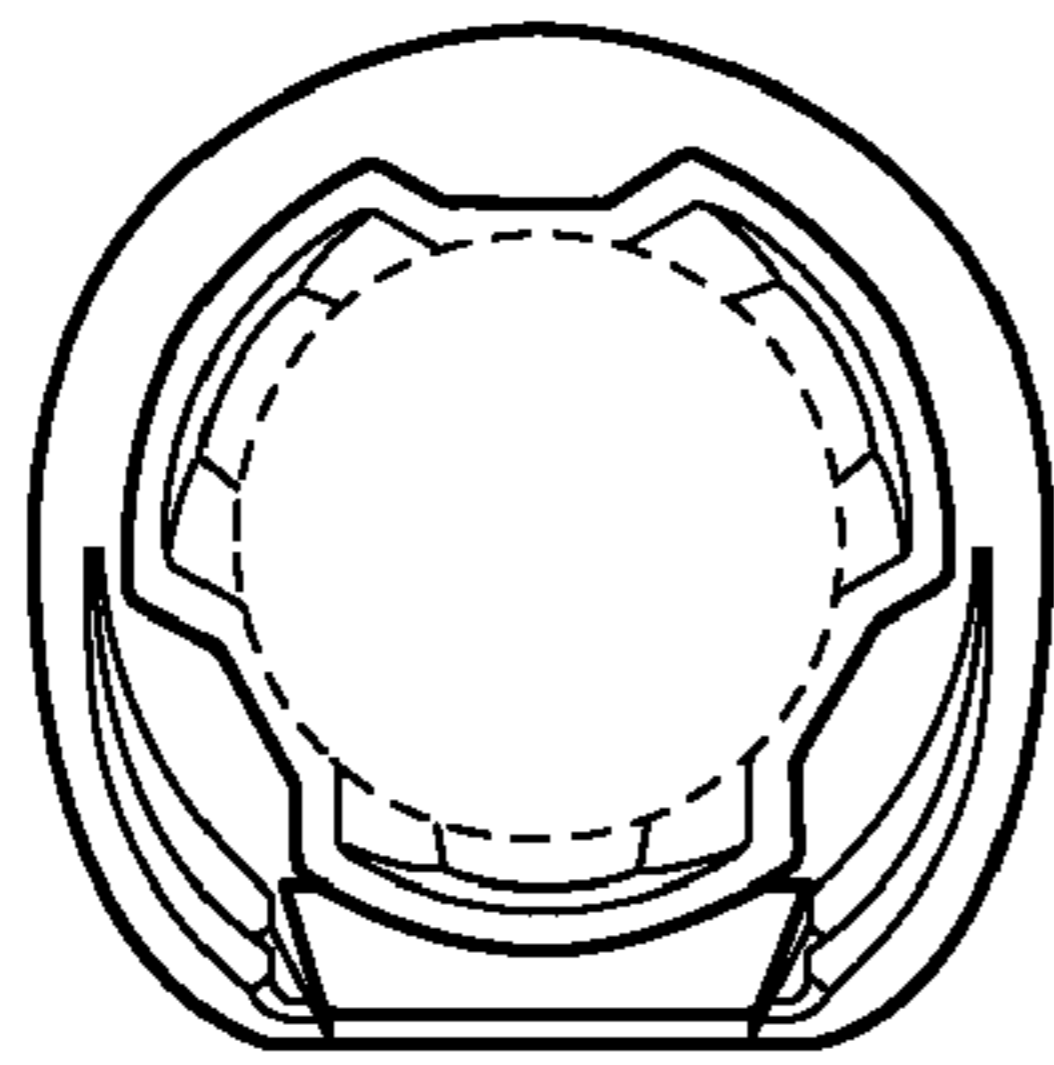




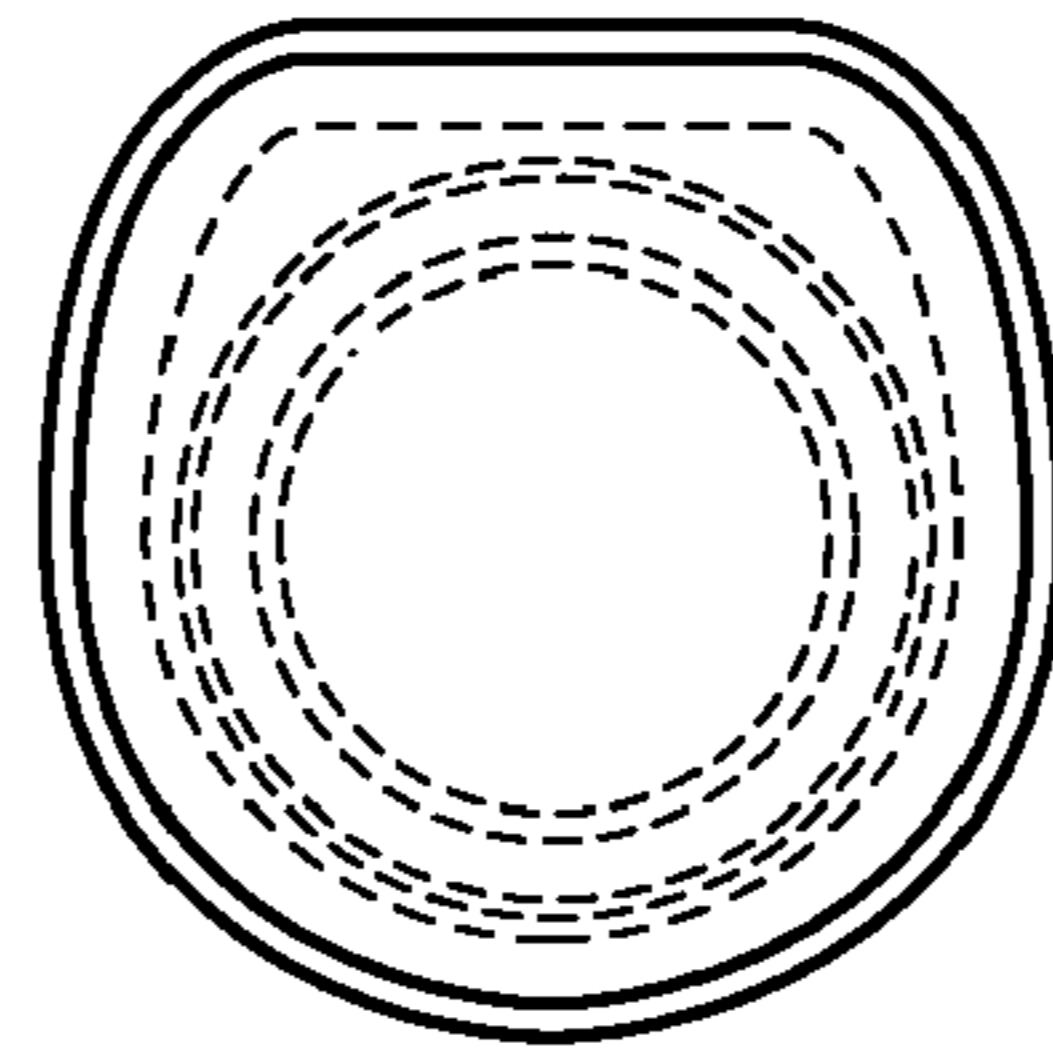
