FIG. 2 is a rear view of the animal toy design.

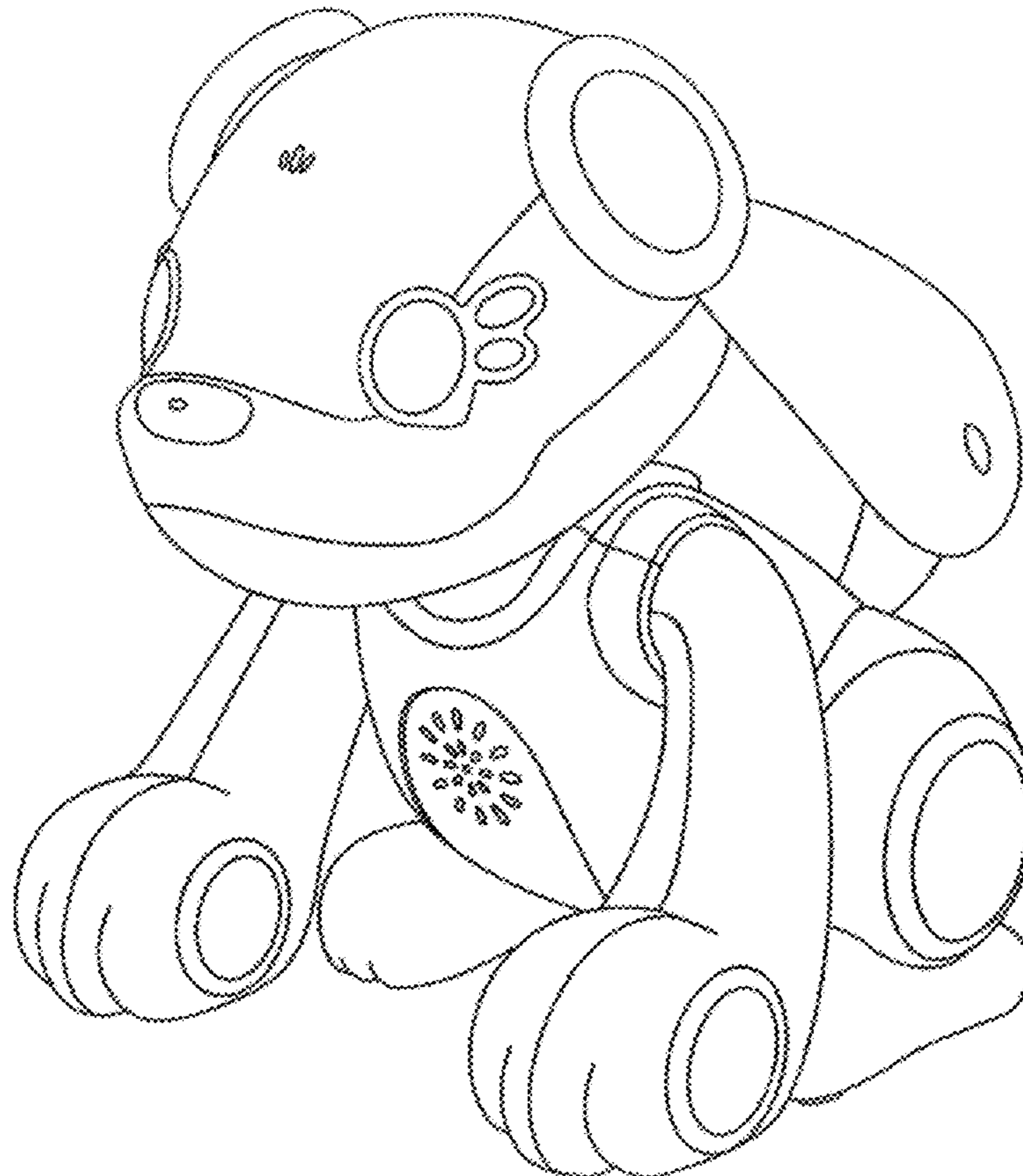
FIG. 3 is a right side view of the animal toy design.

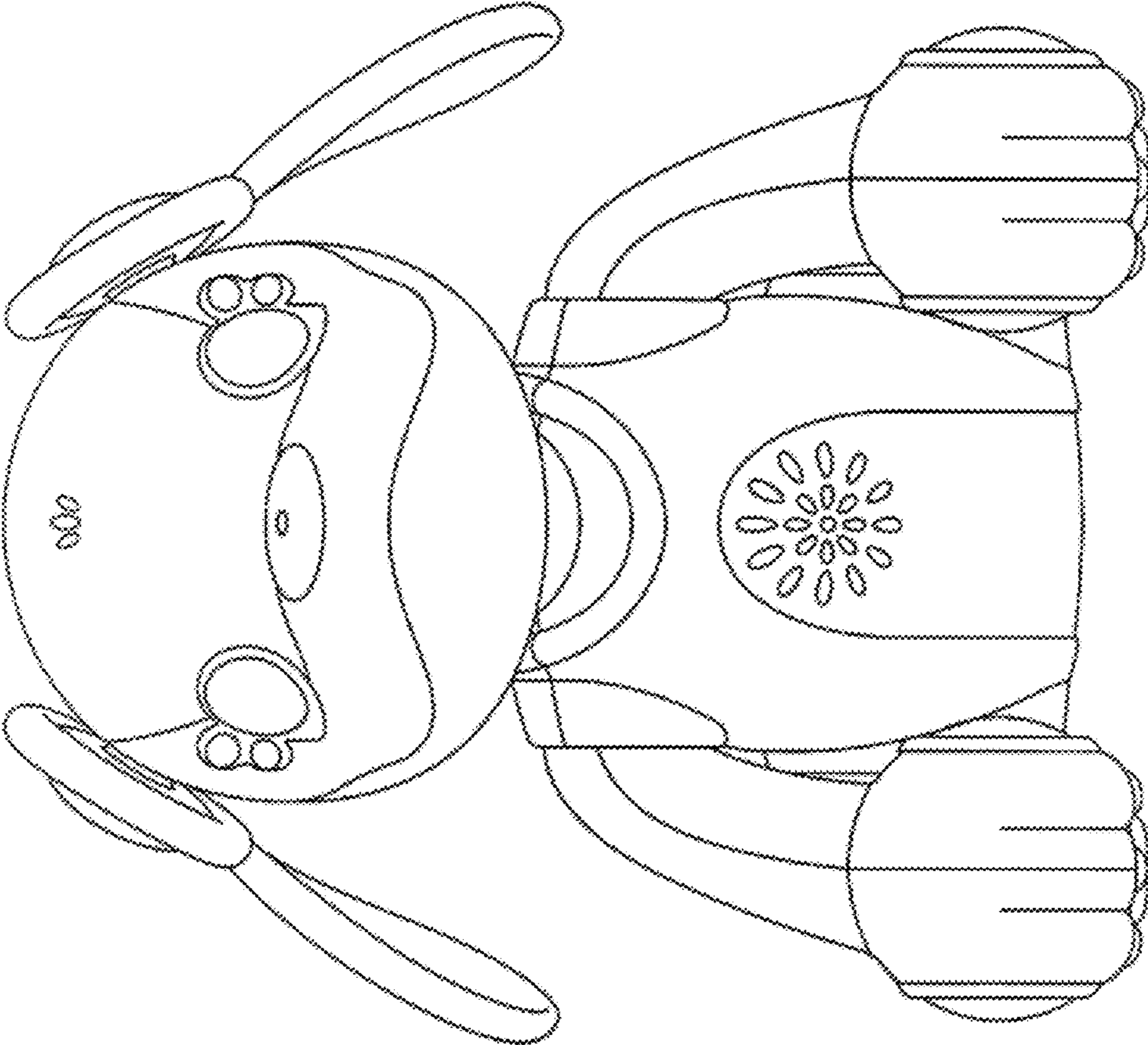

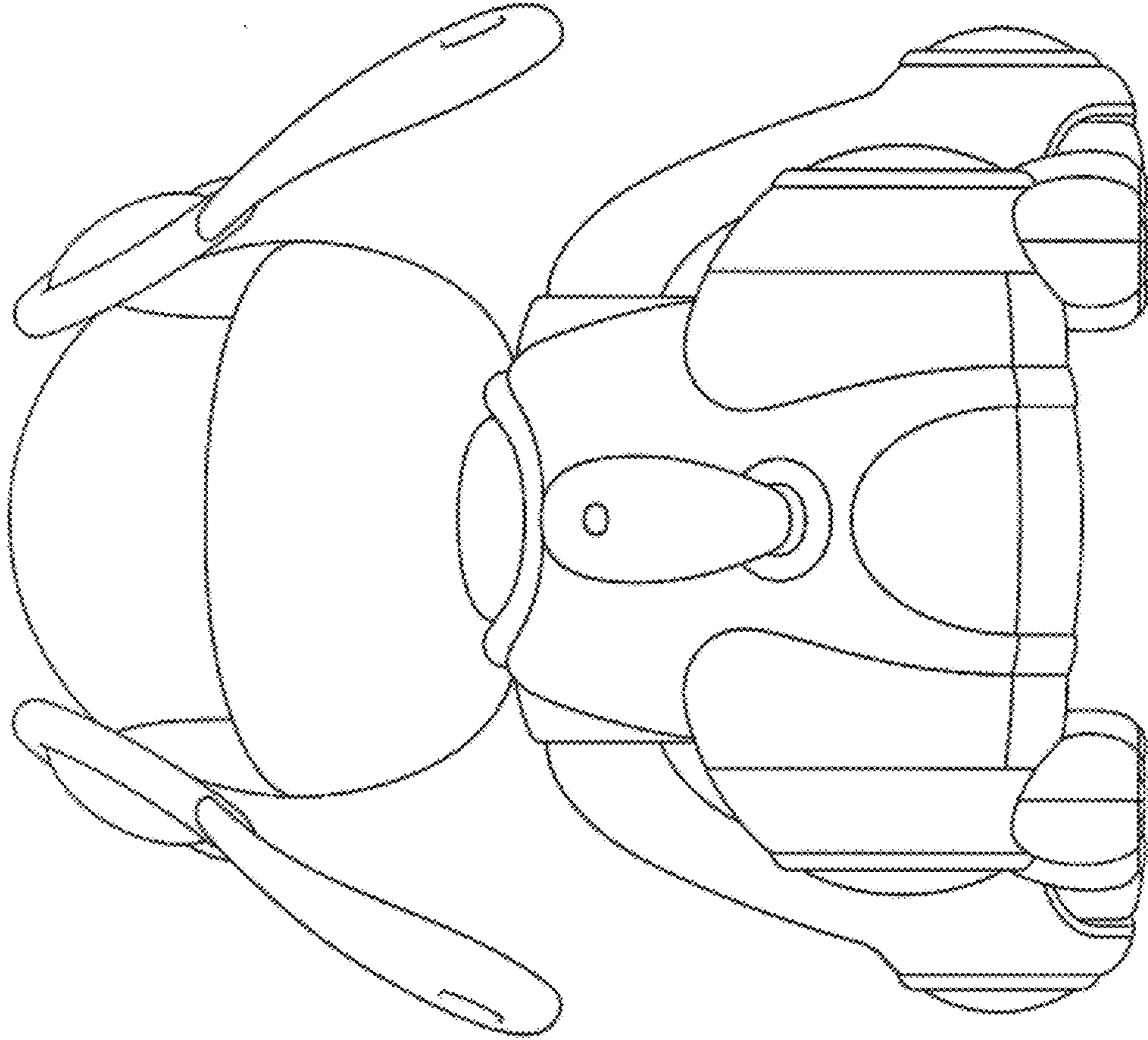

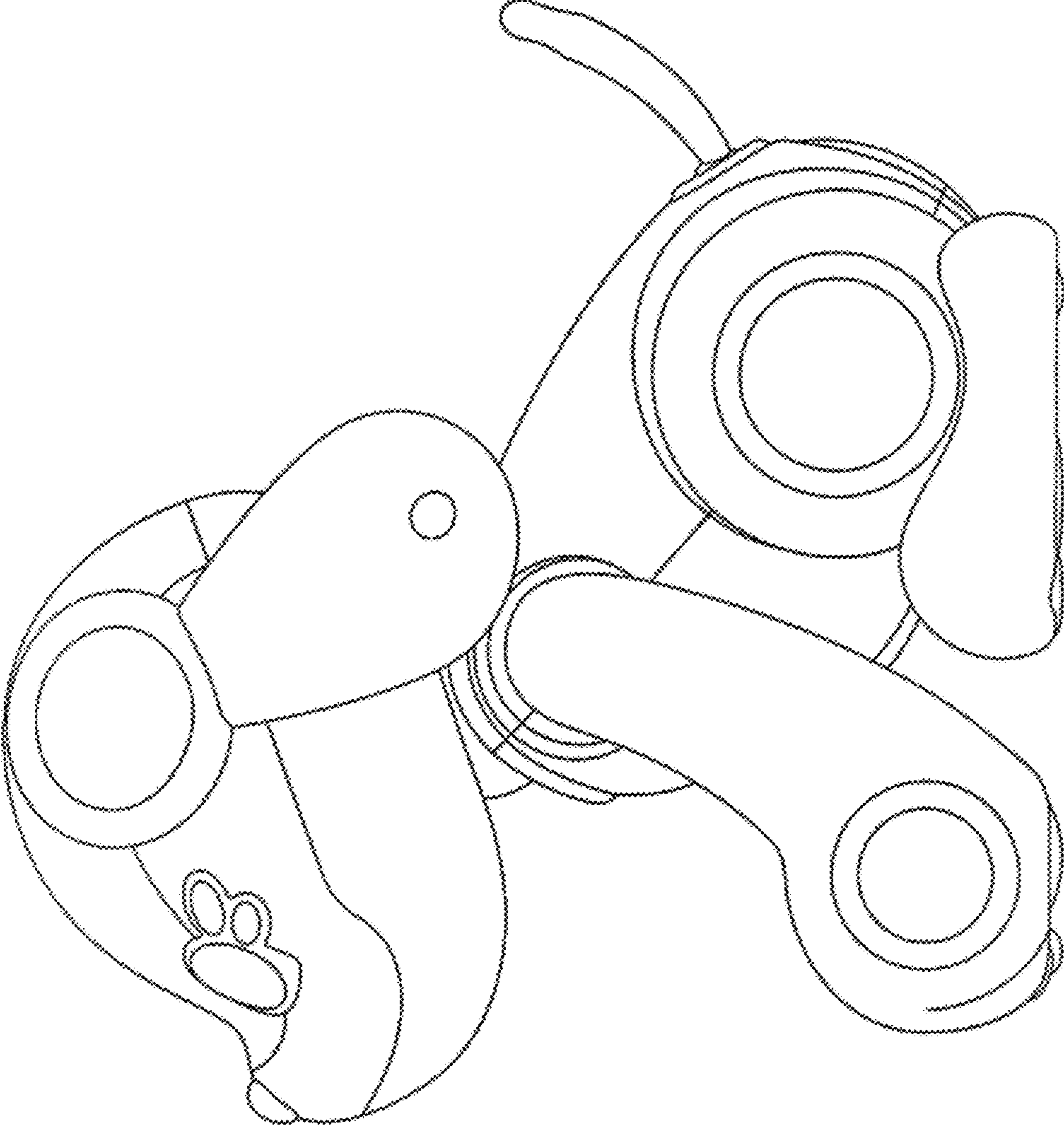

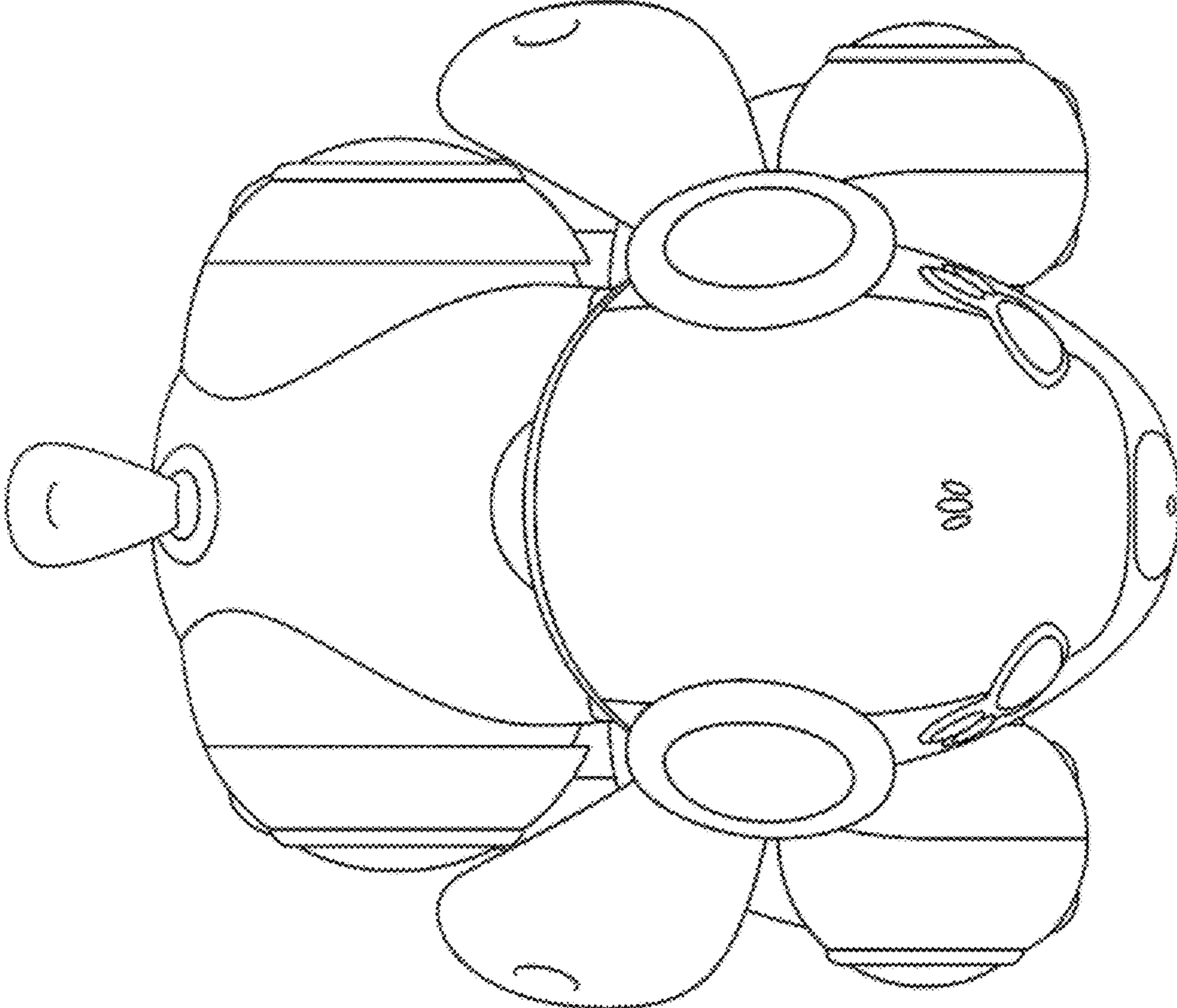

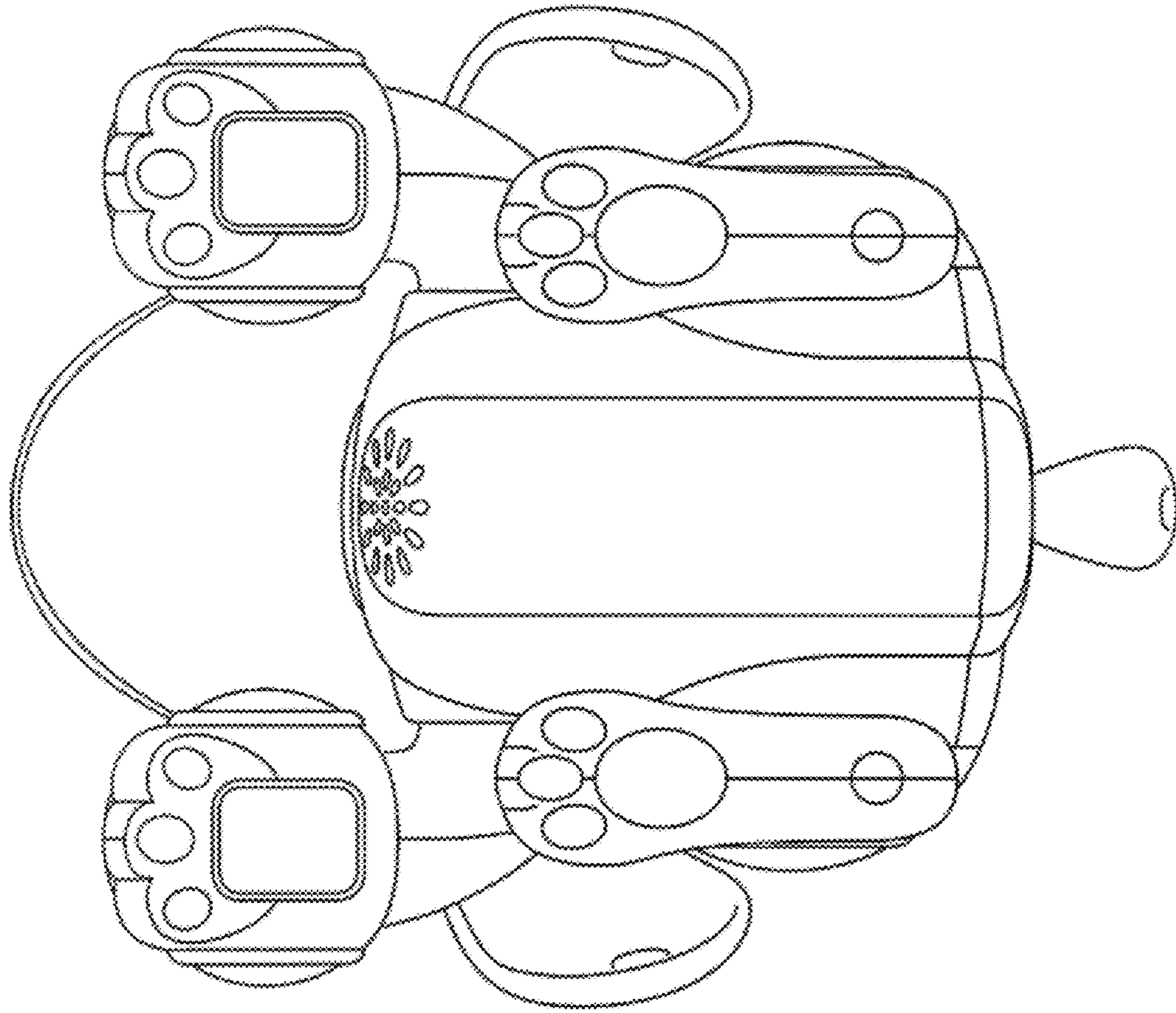

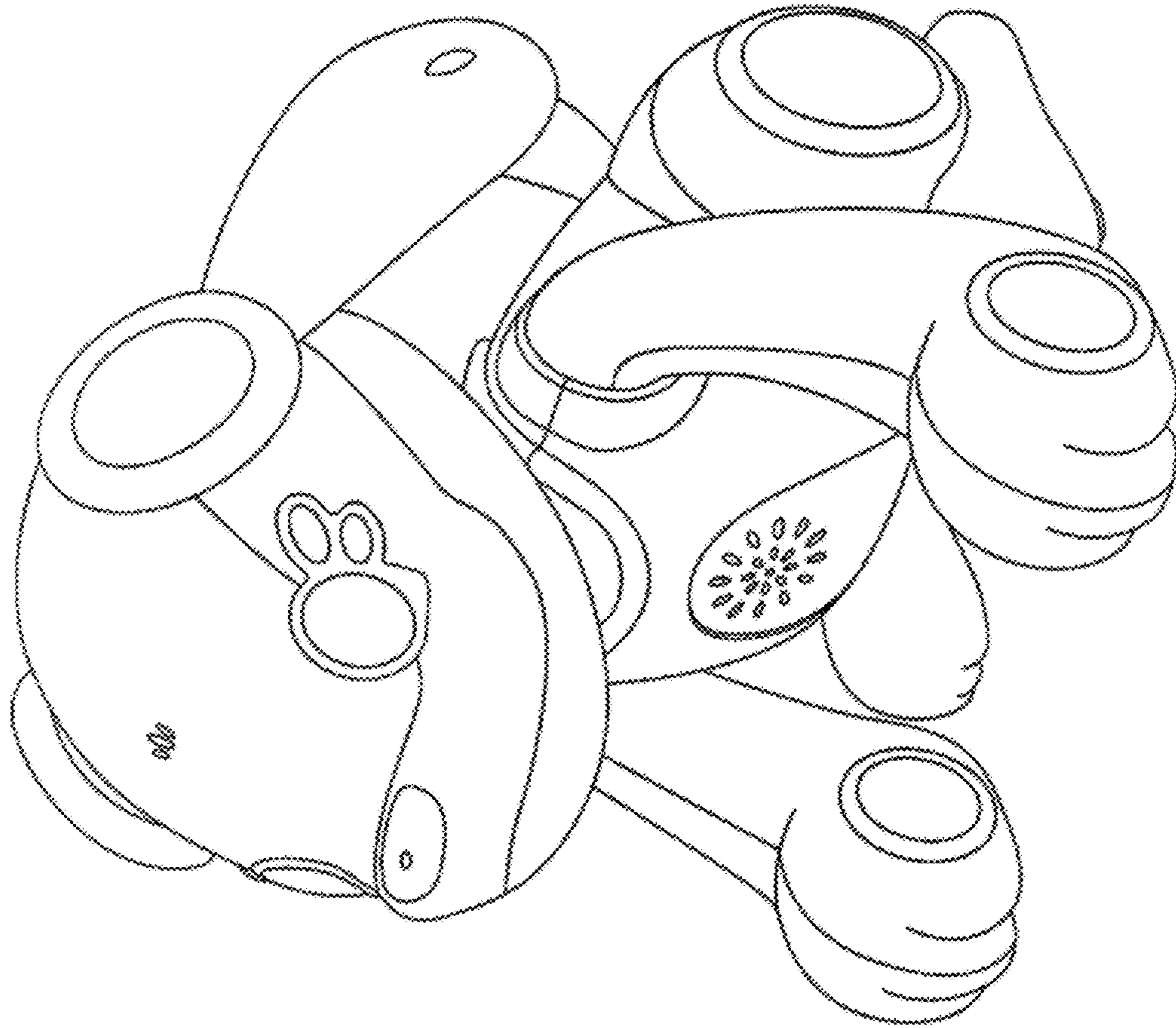
