The ornamental design for a golf club head cover, as shown and described.

DESCRIPTION

FIG. 12 is a bottom view thereof;

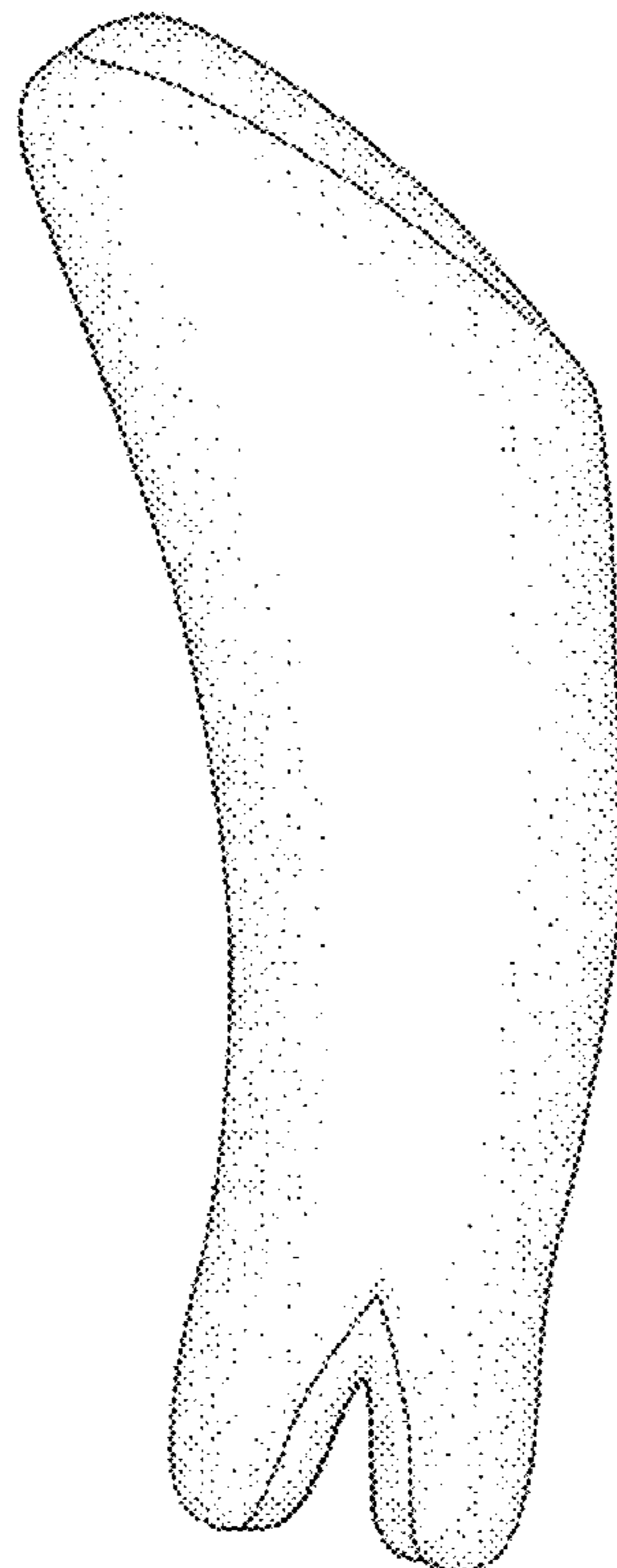
FIG. 13 is a left side view thereof, the right side being a mirror image;

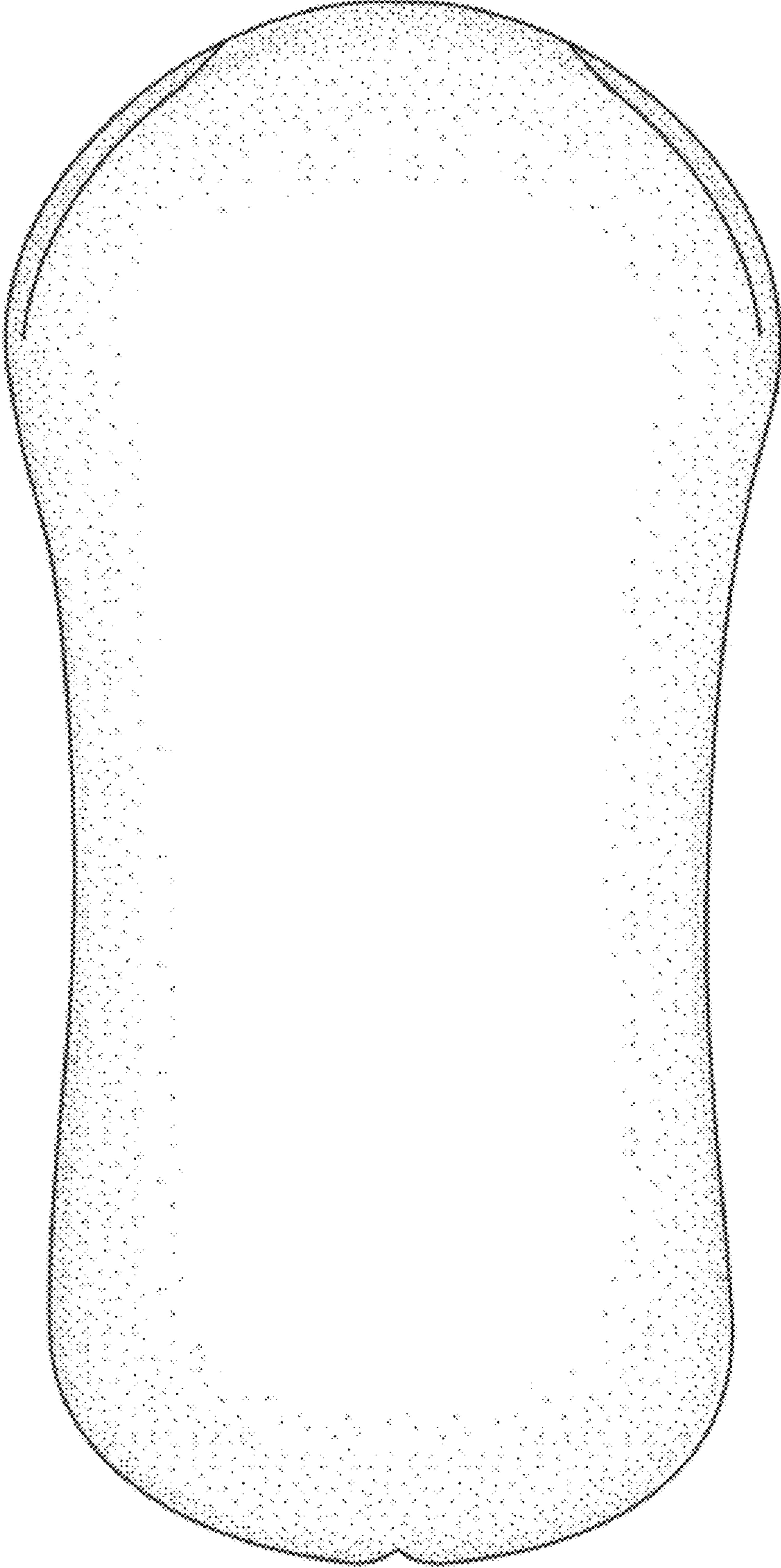

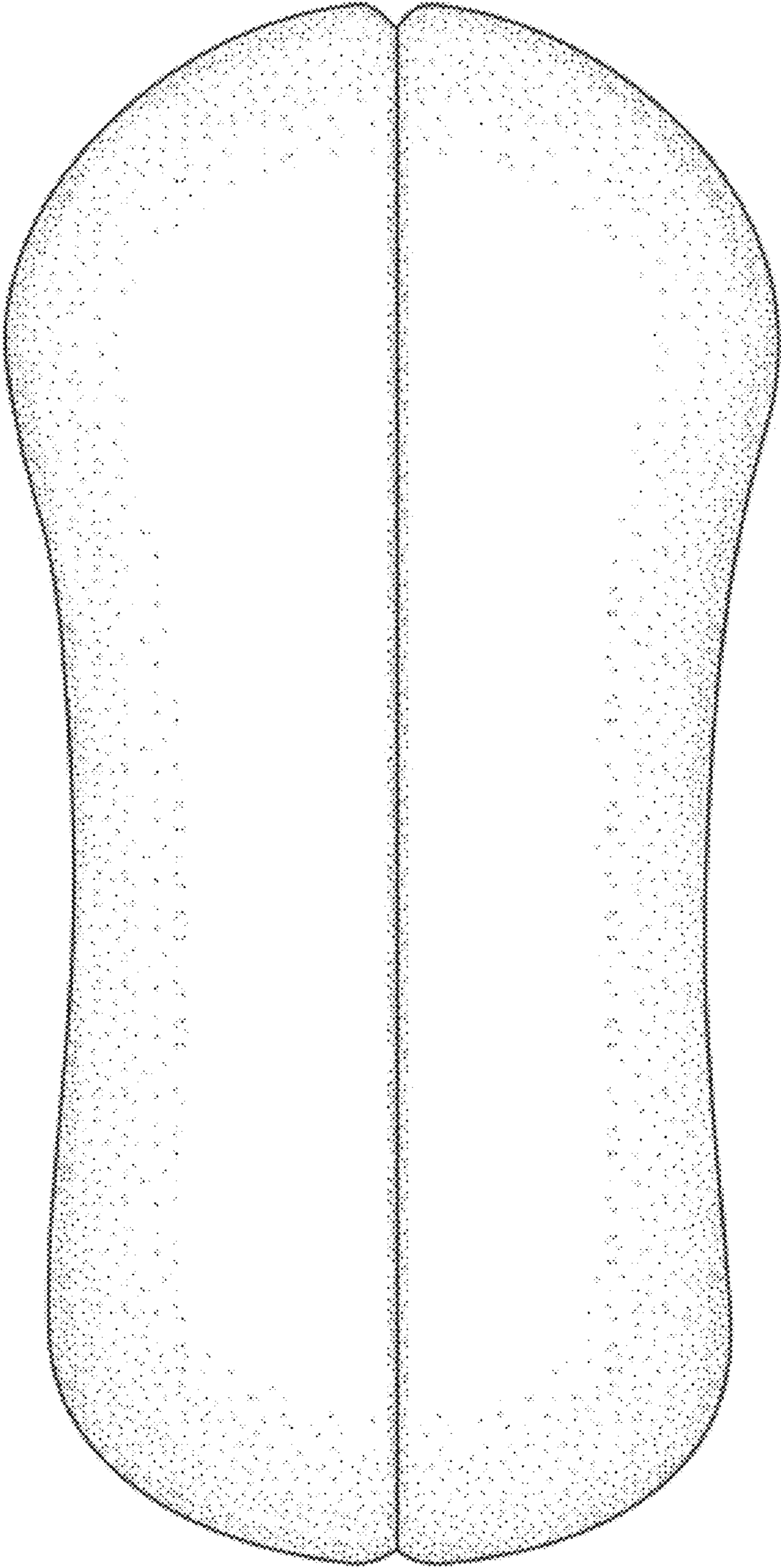

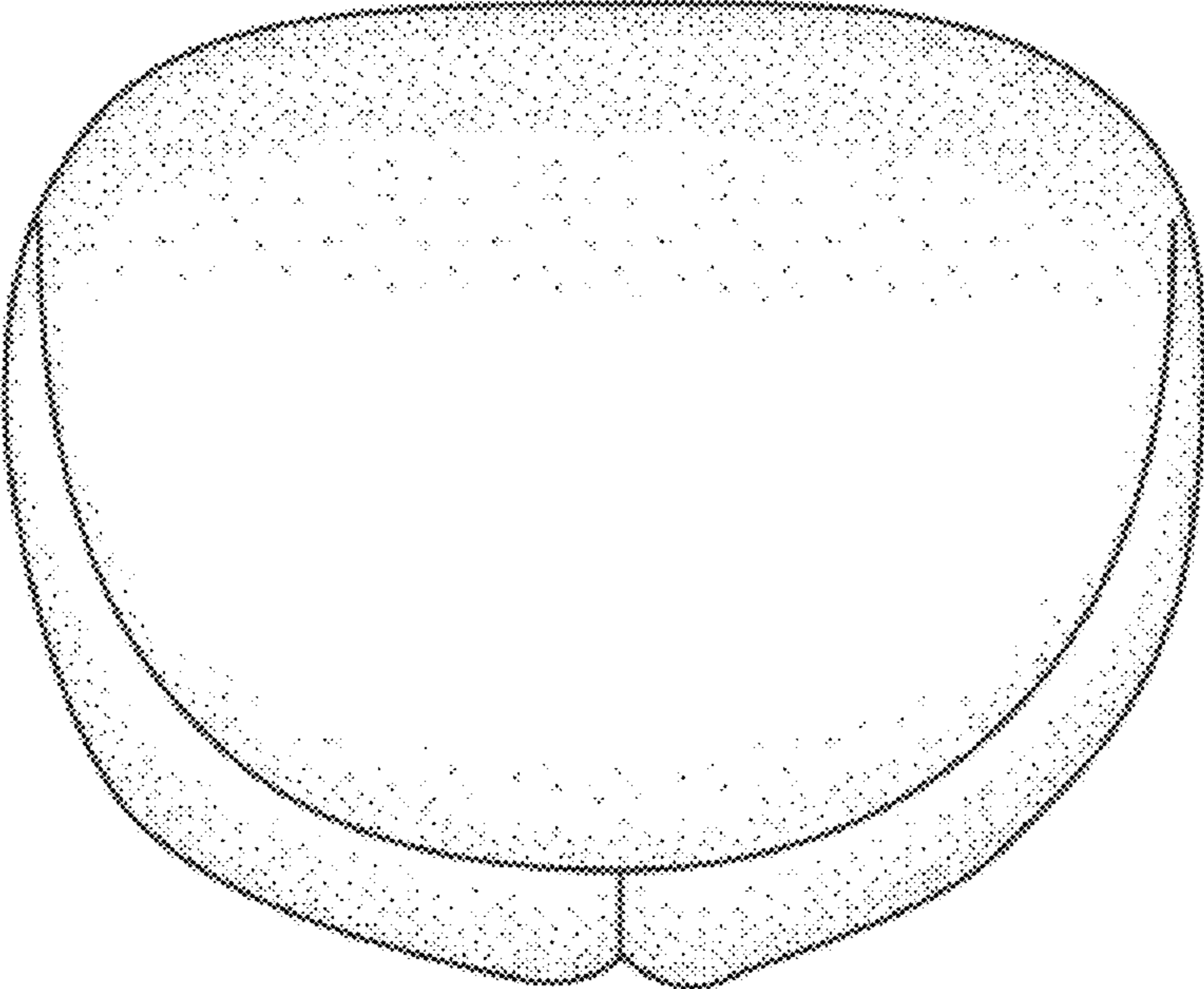

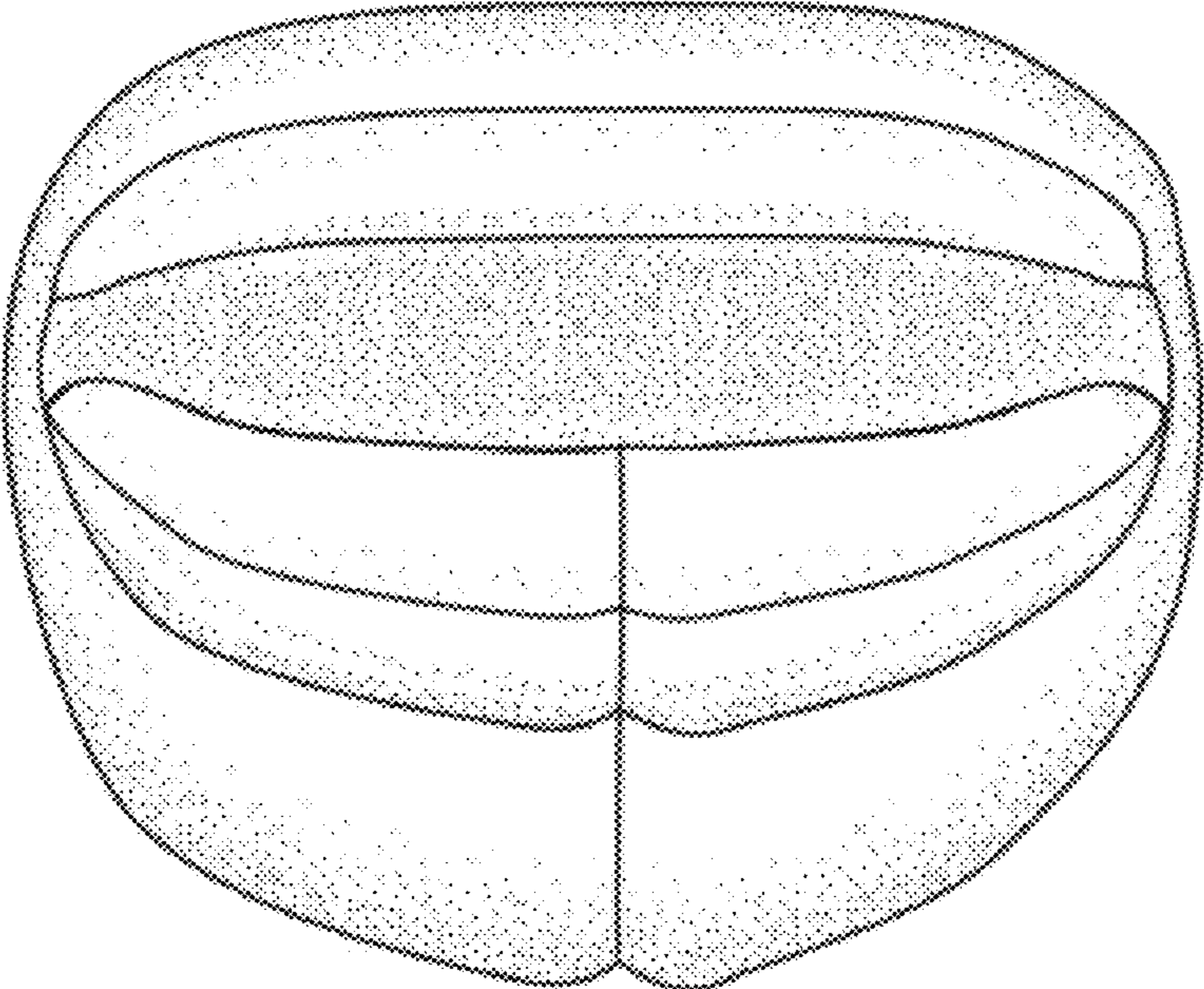

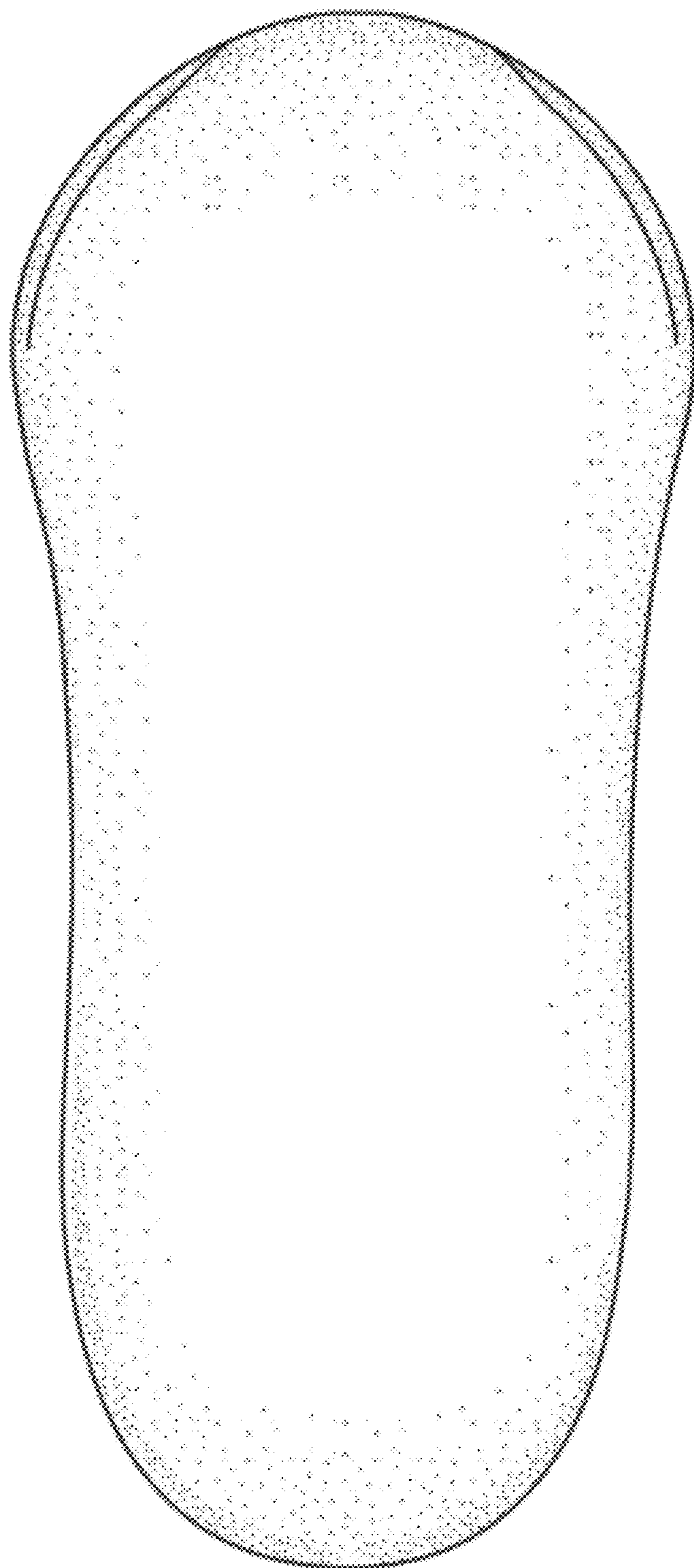

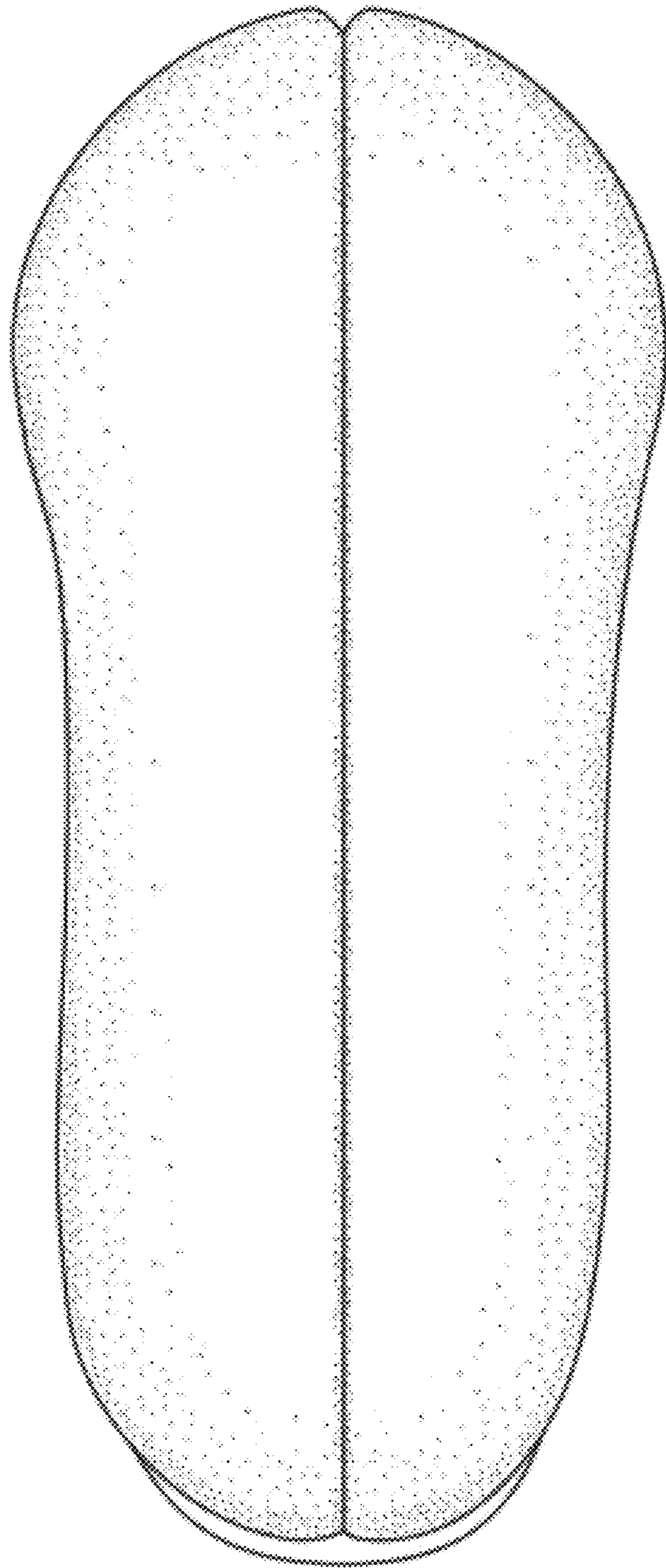

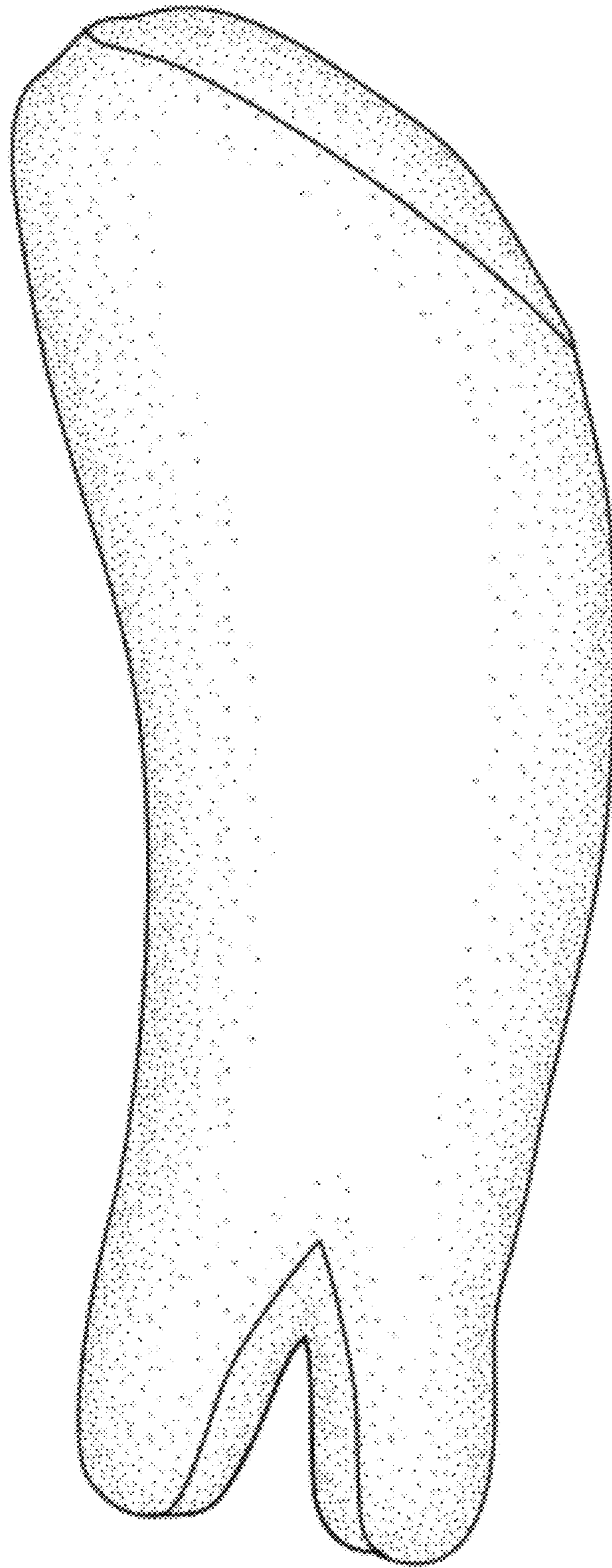

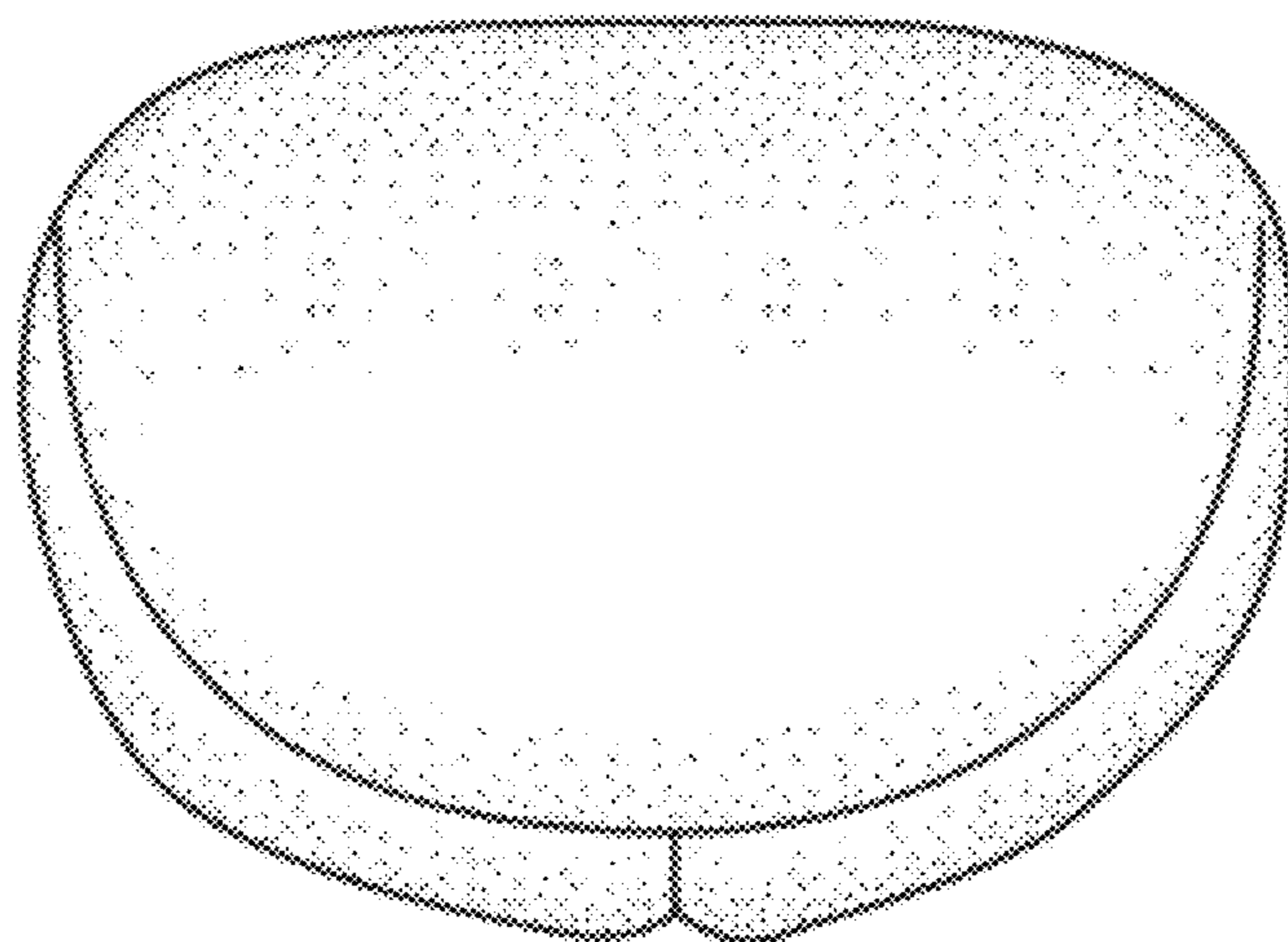

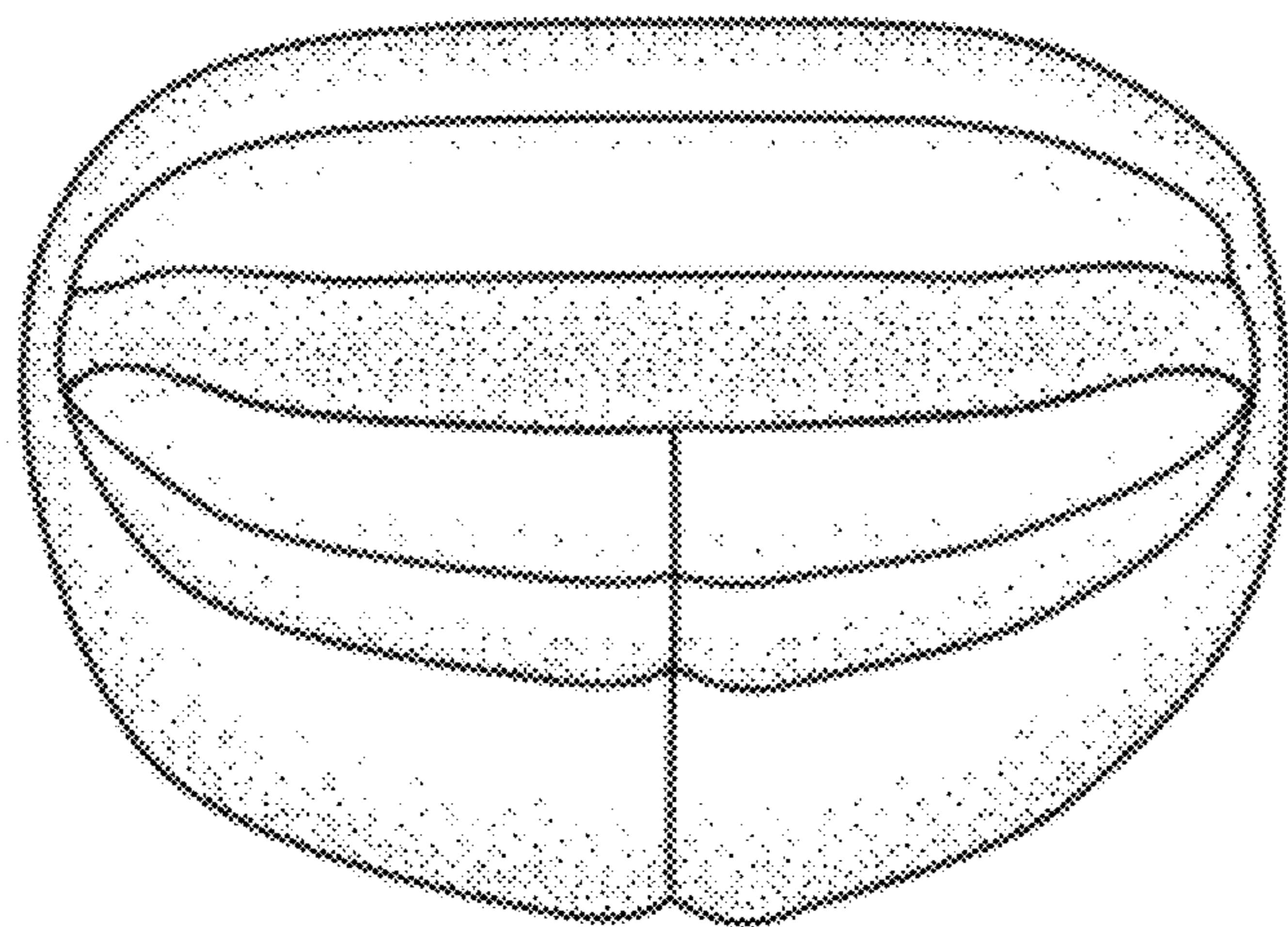

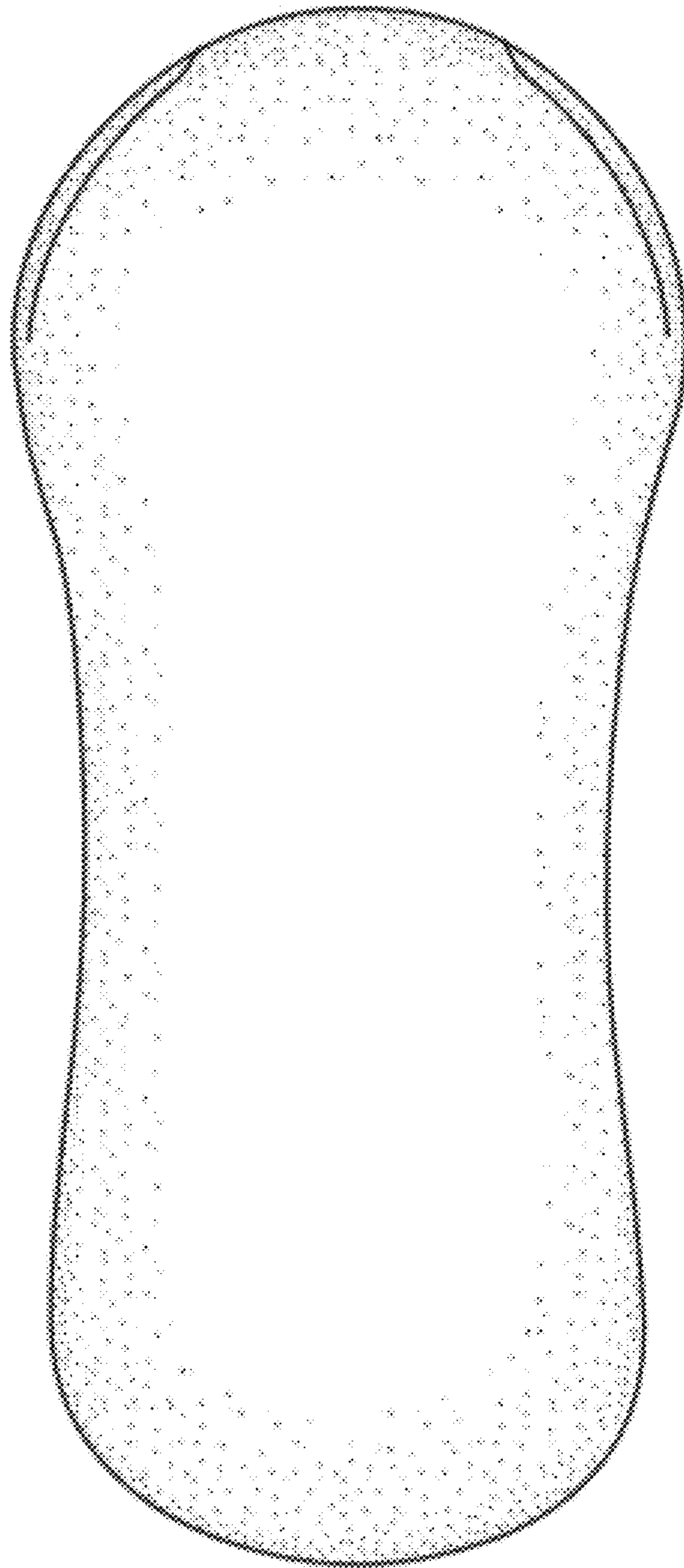

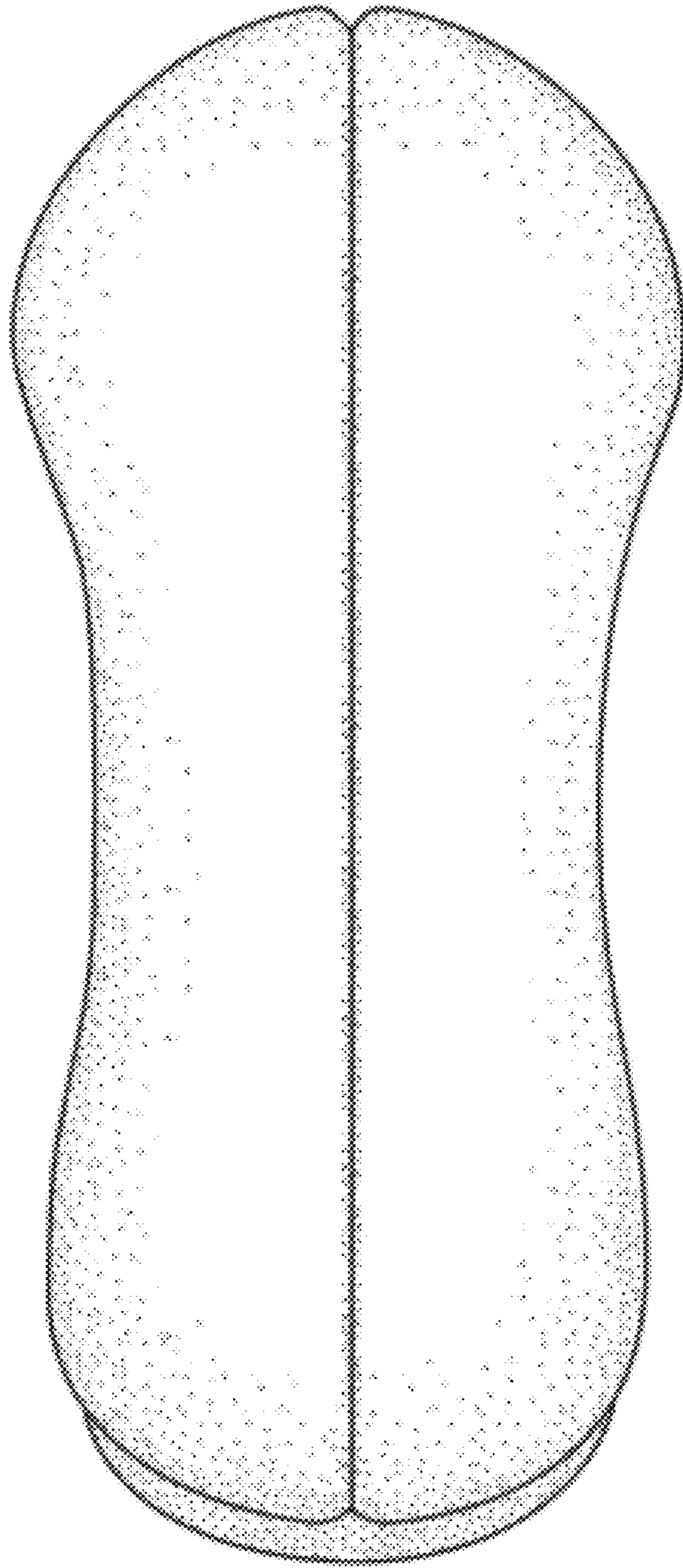

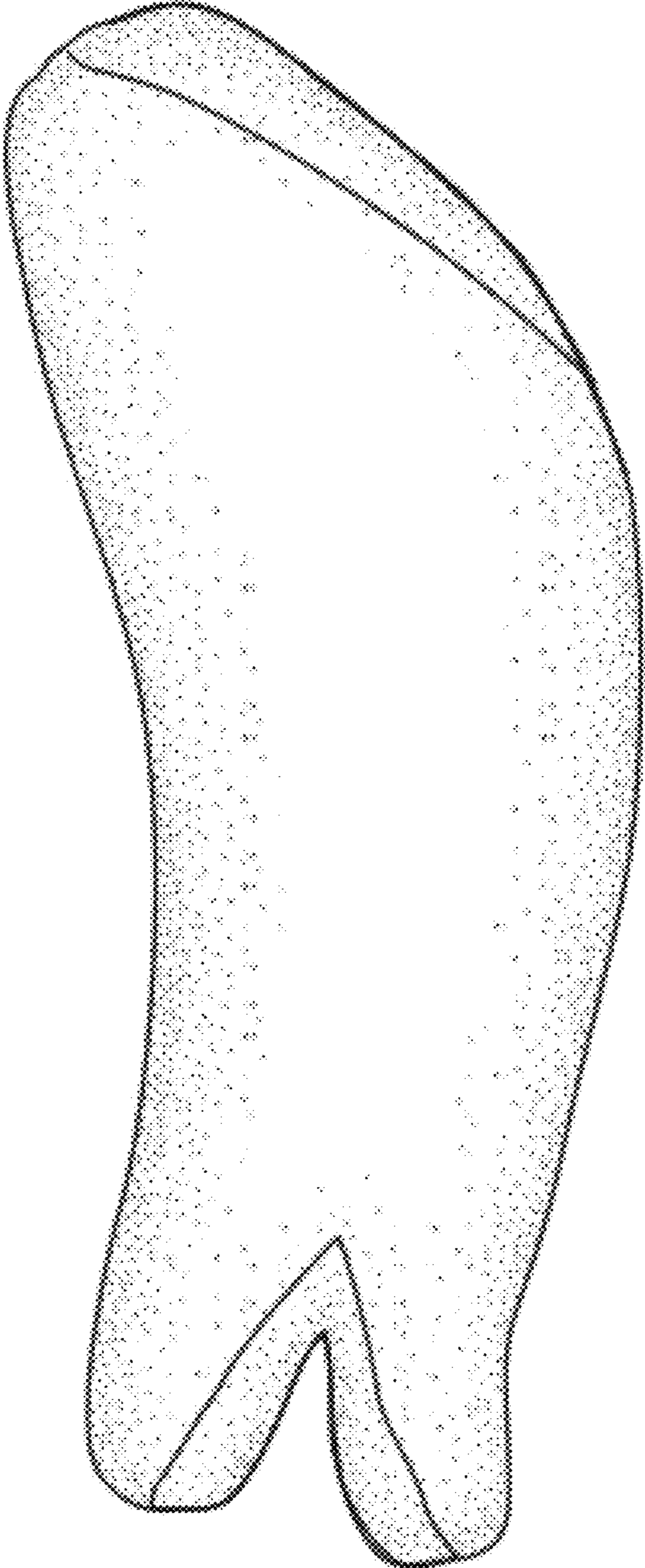

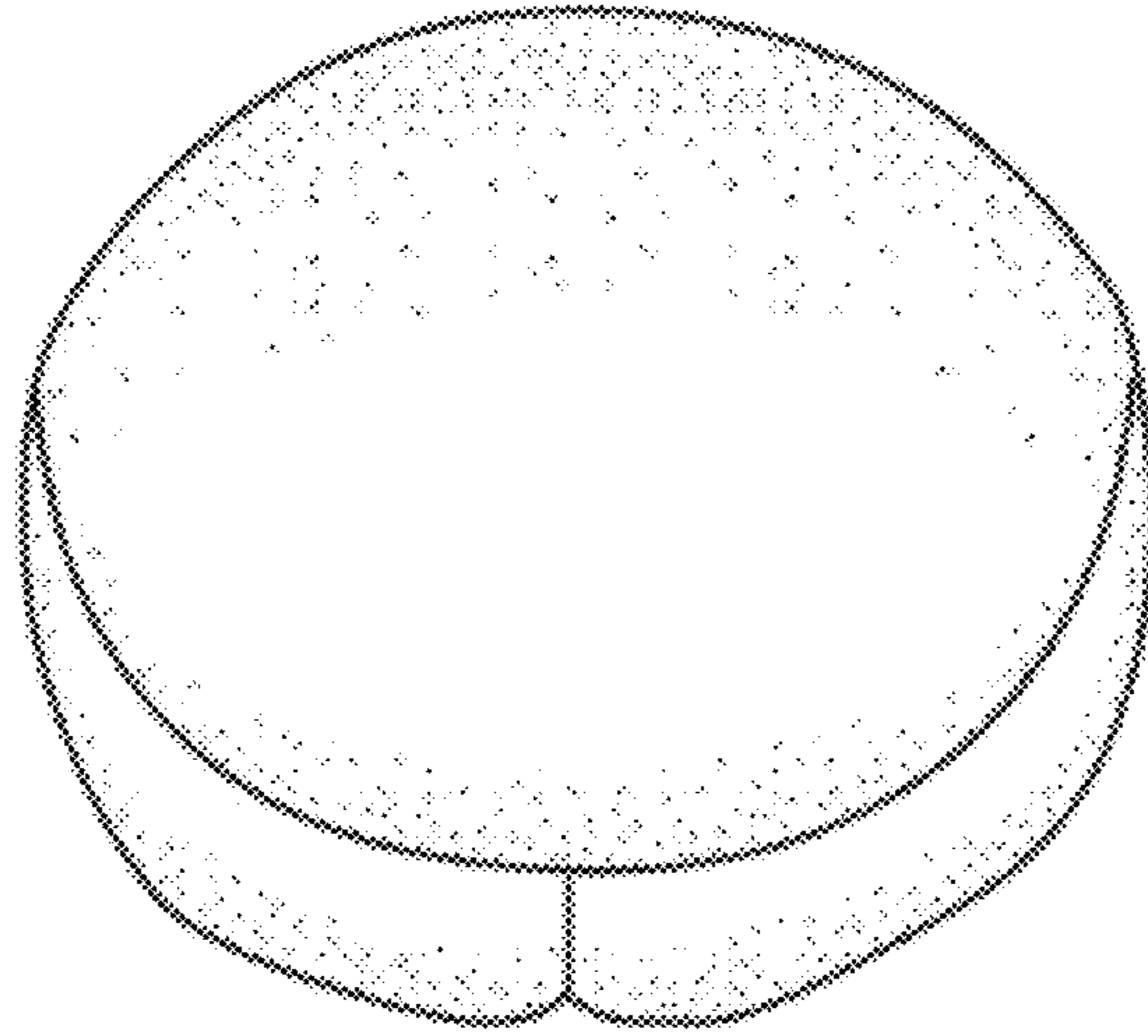

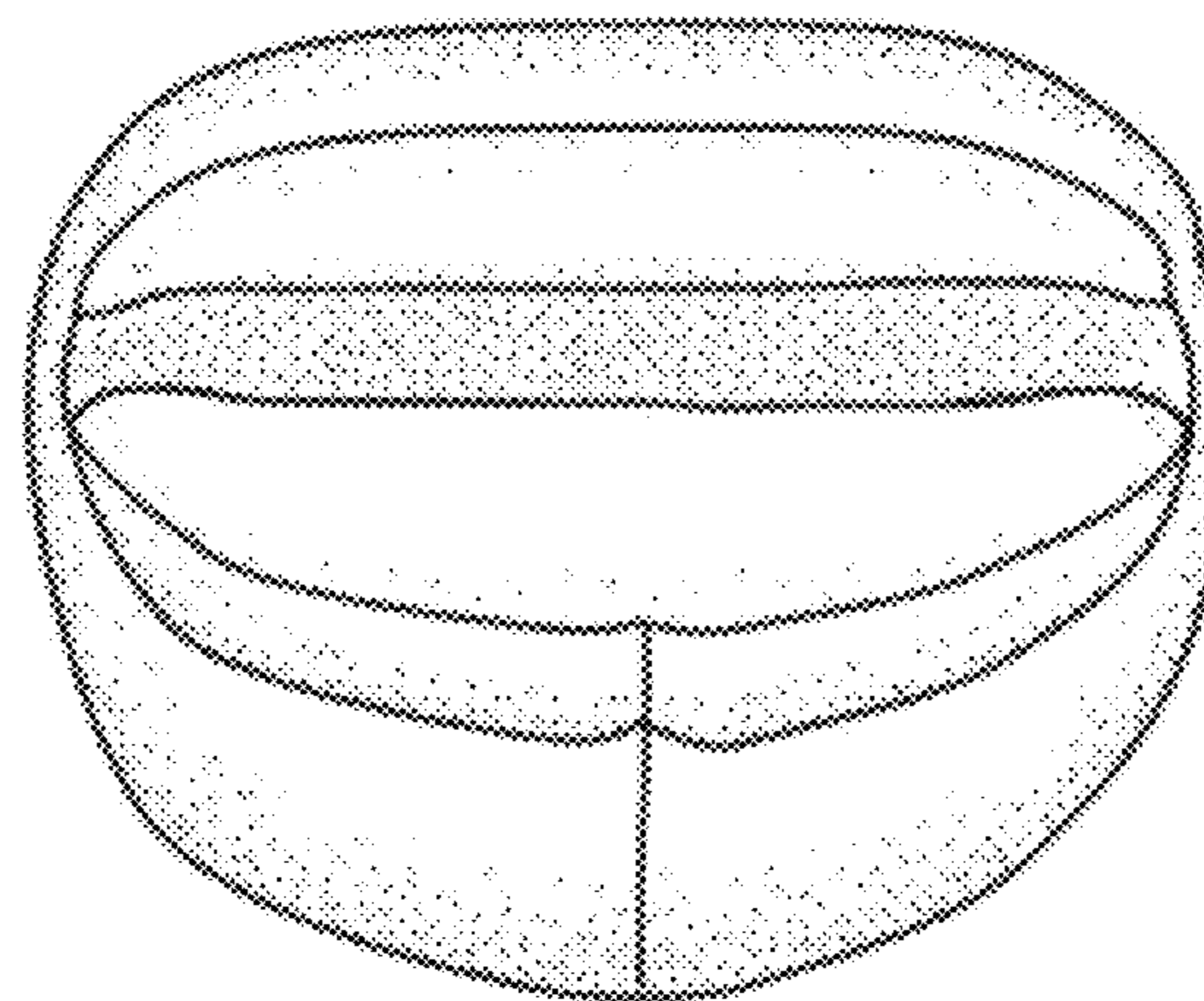
