(57) **CLAIM**

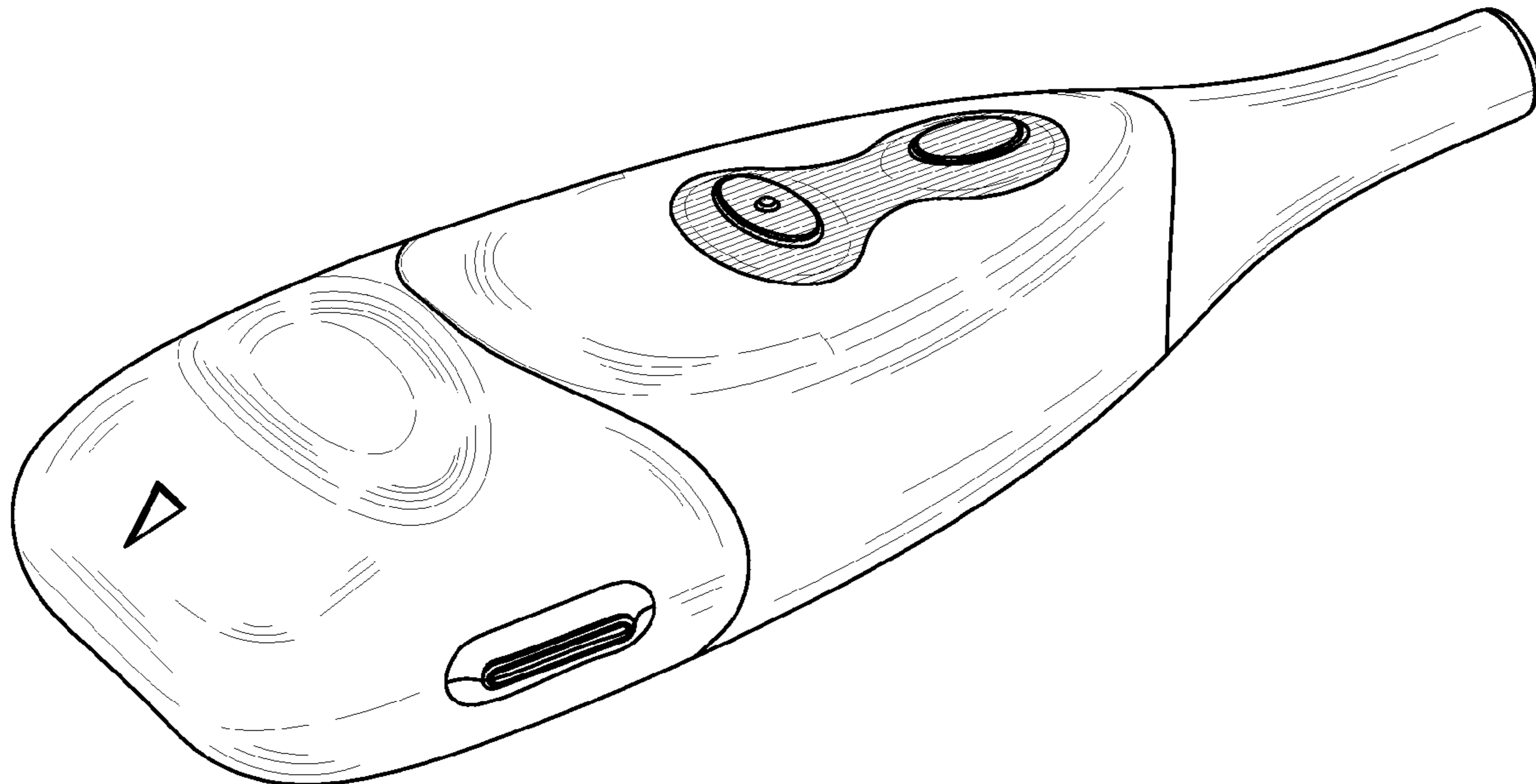
The ornamental design for a neonatal intensive care unit probe, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a neonatal intensive care unit probe showing my new design;  
FIG. 2 is side perspective view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a side elevation view thereof;  
FIG. 5 is another side elevation view thereof;  
FIG. 6 is a bottom perspective view thereof;  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is an enlarged end thereof.

The switch area on the neonatal intensive care unit probe has been shaded to represent the color blue which forms part of the claimed design.

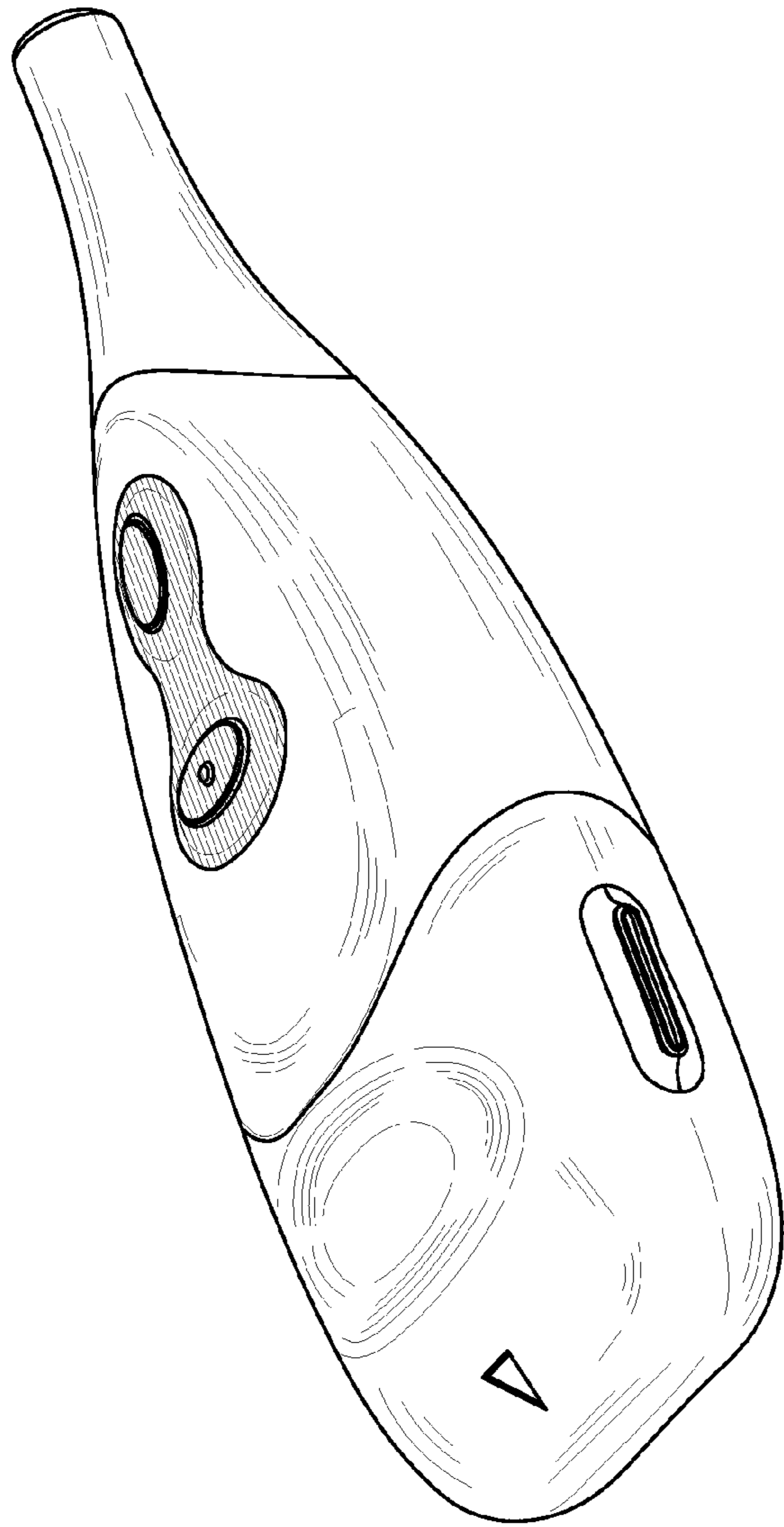

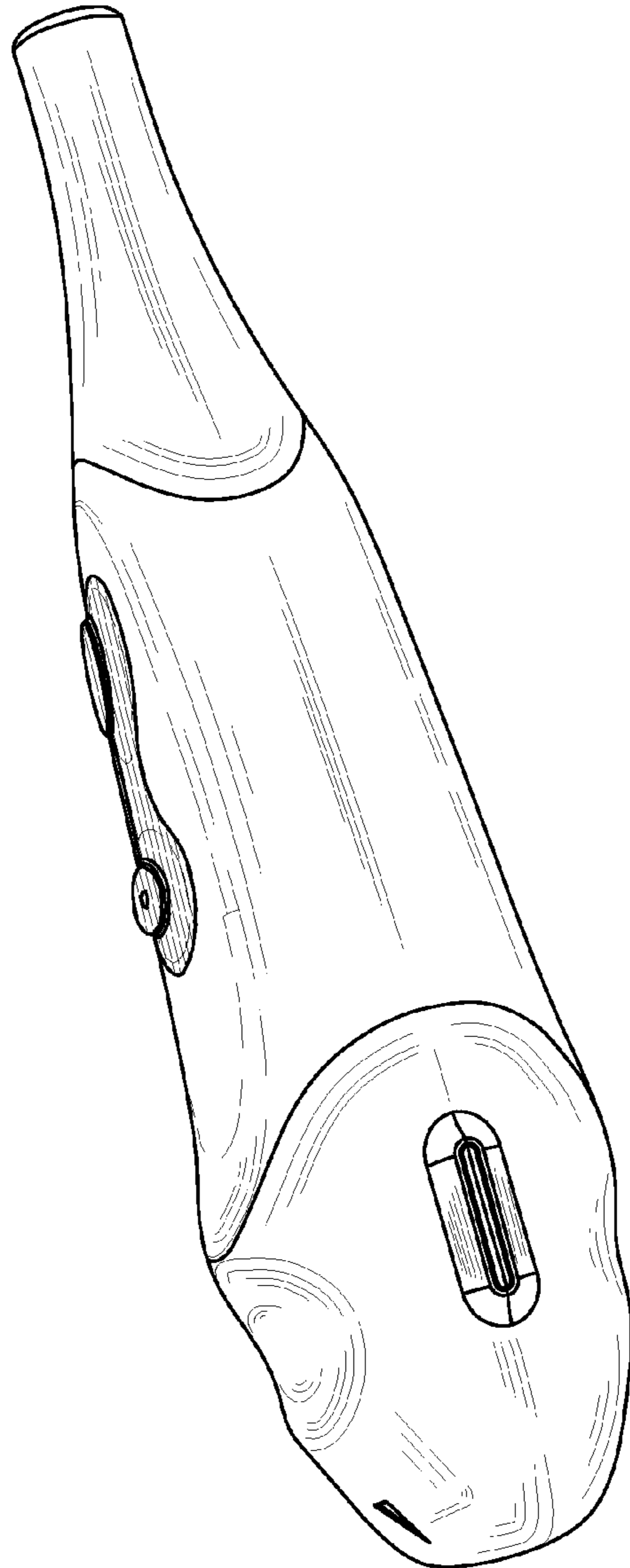

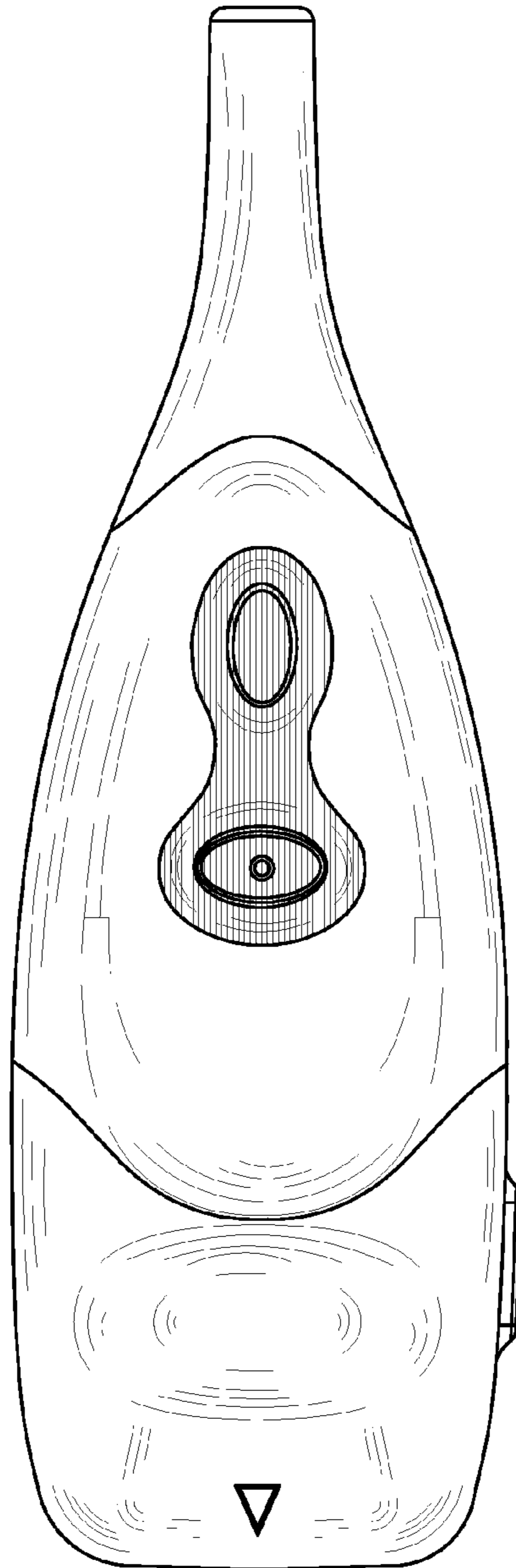

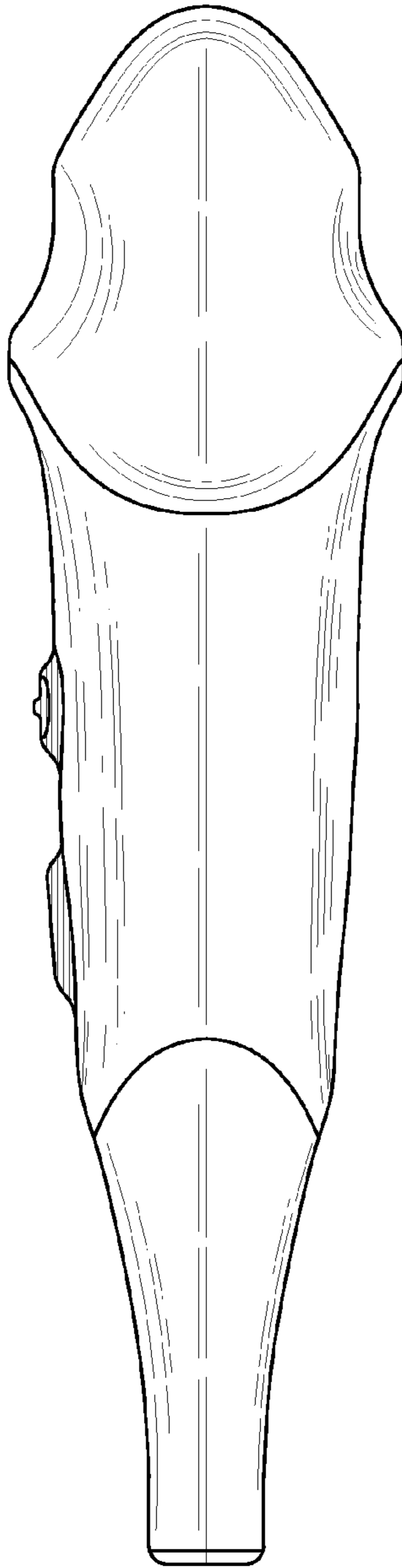

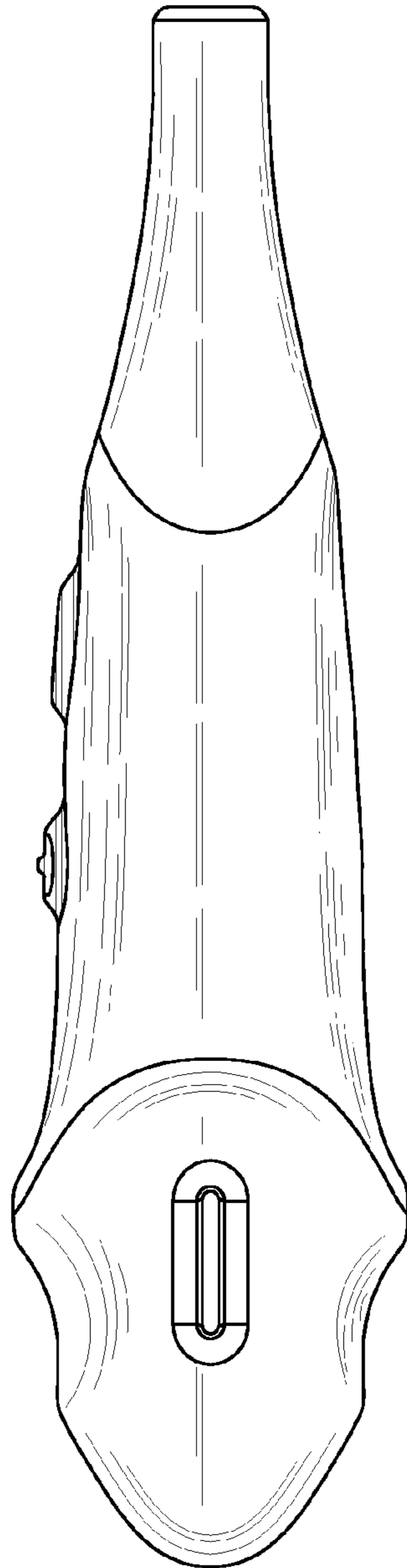

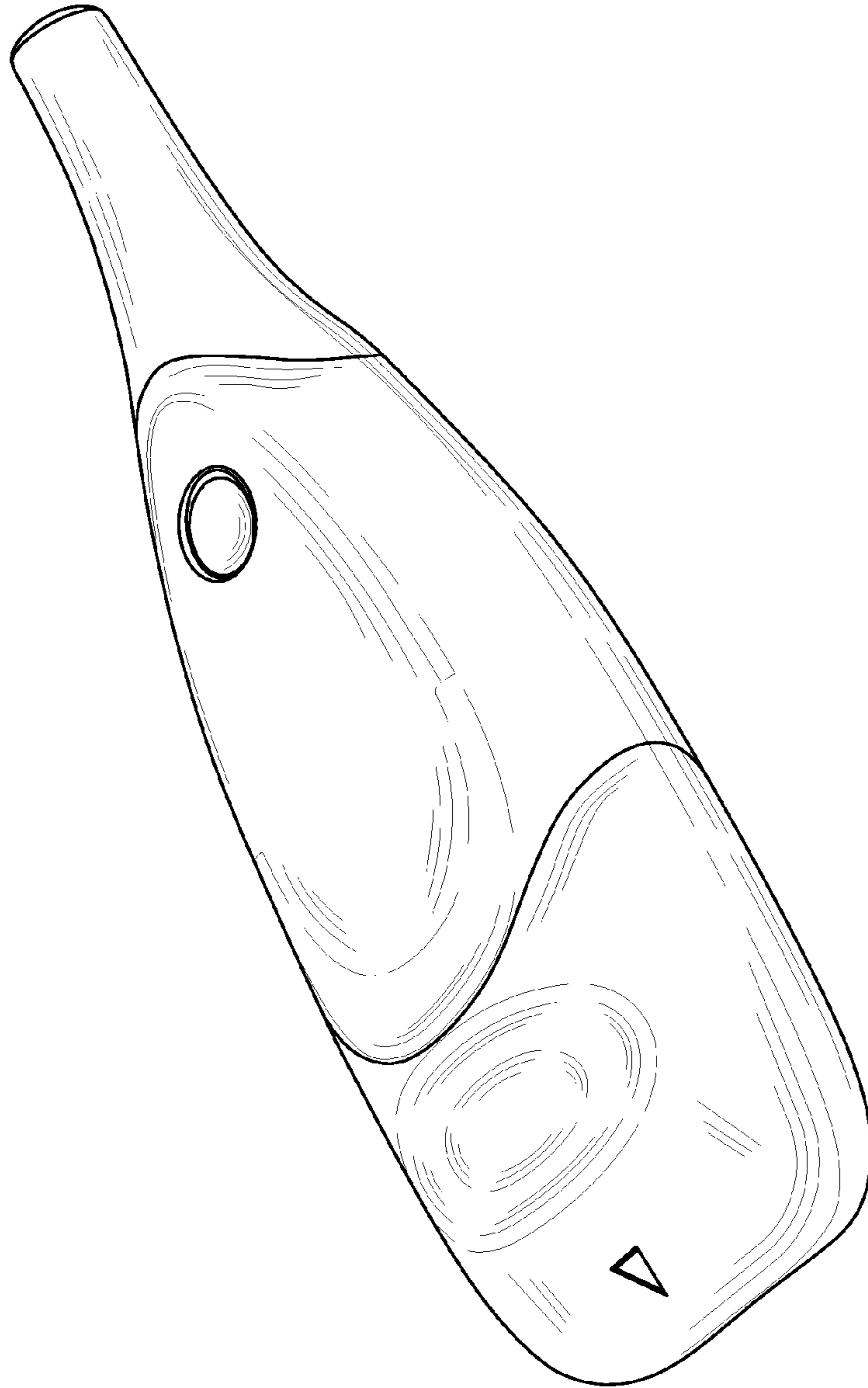

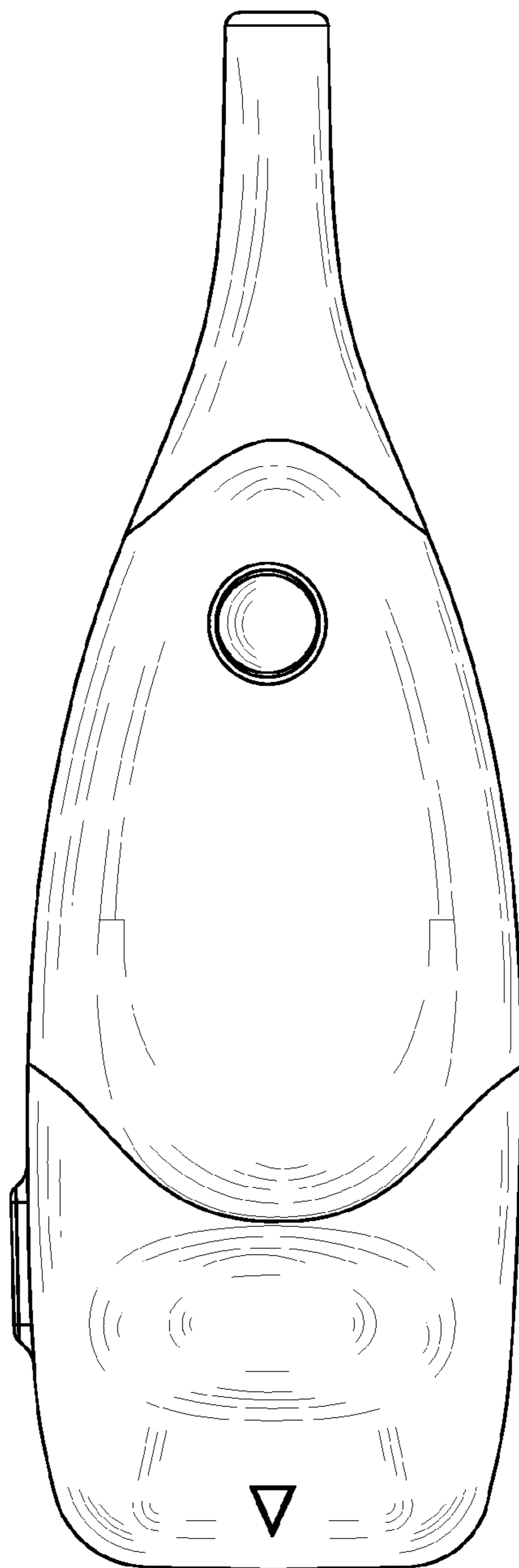

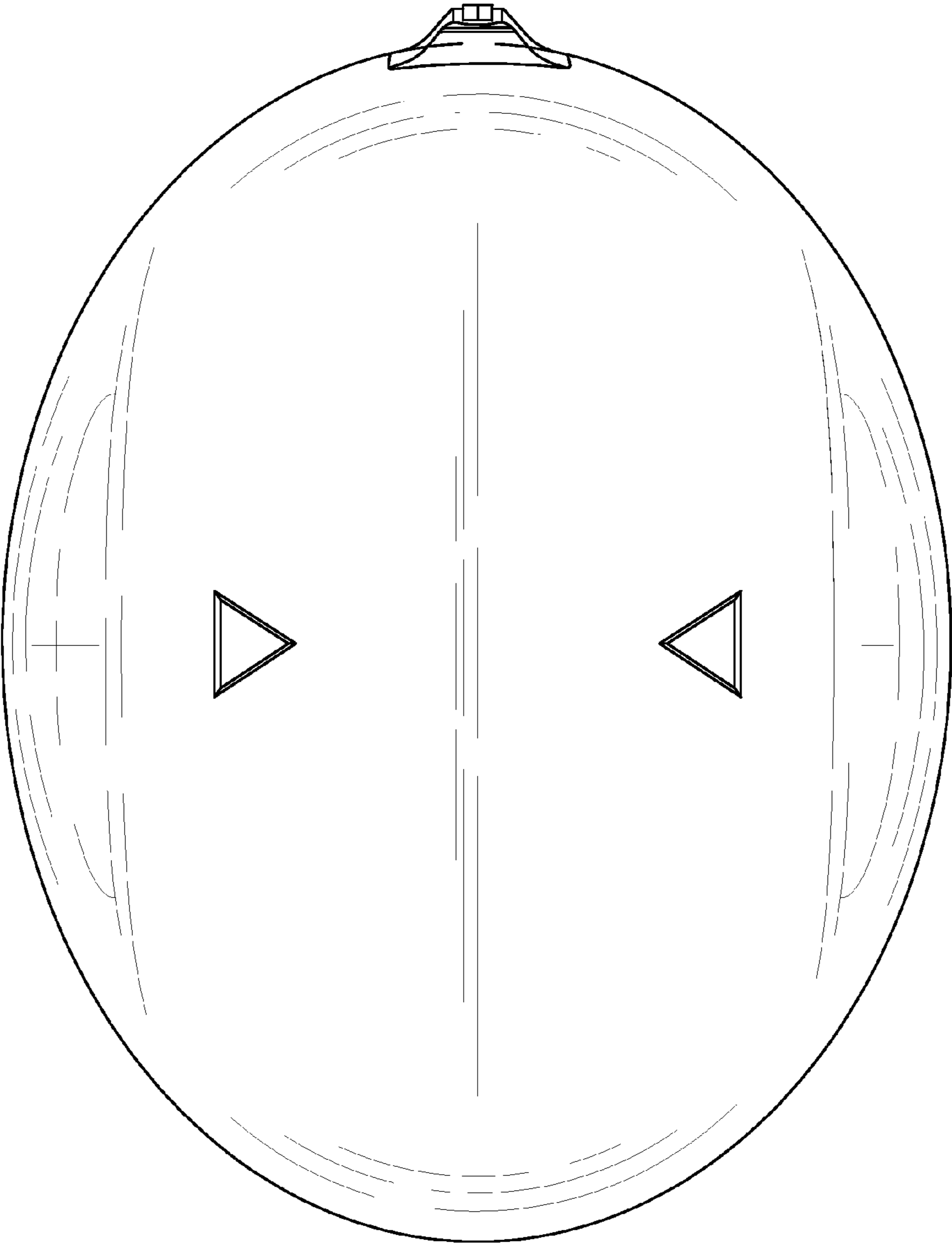
