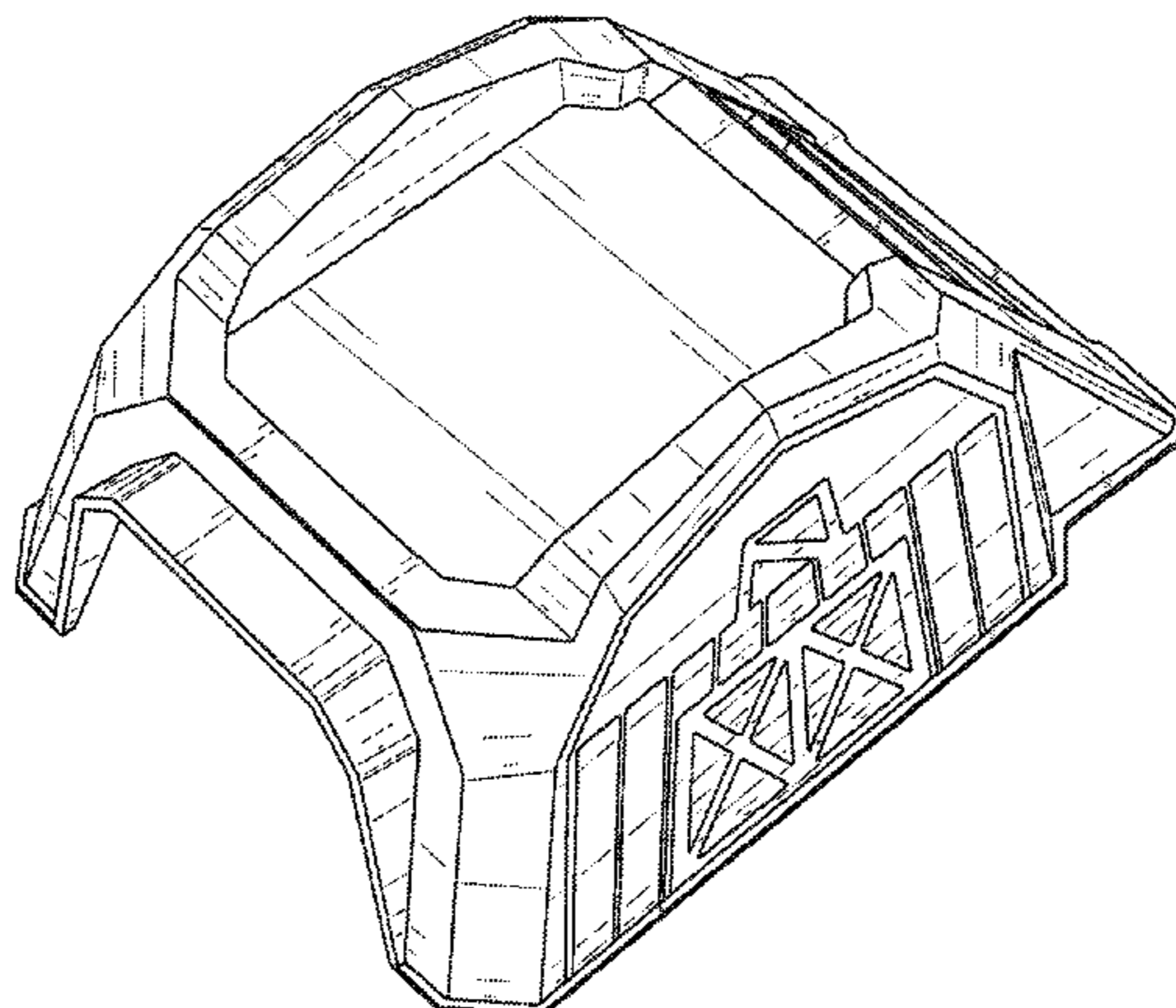
What is claimed is the ornamental design for a pet habitat, as shown and described.

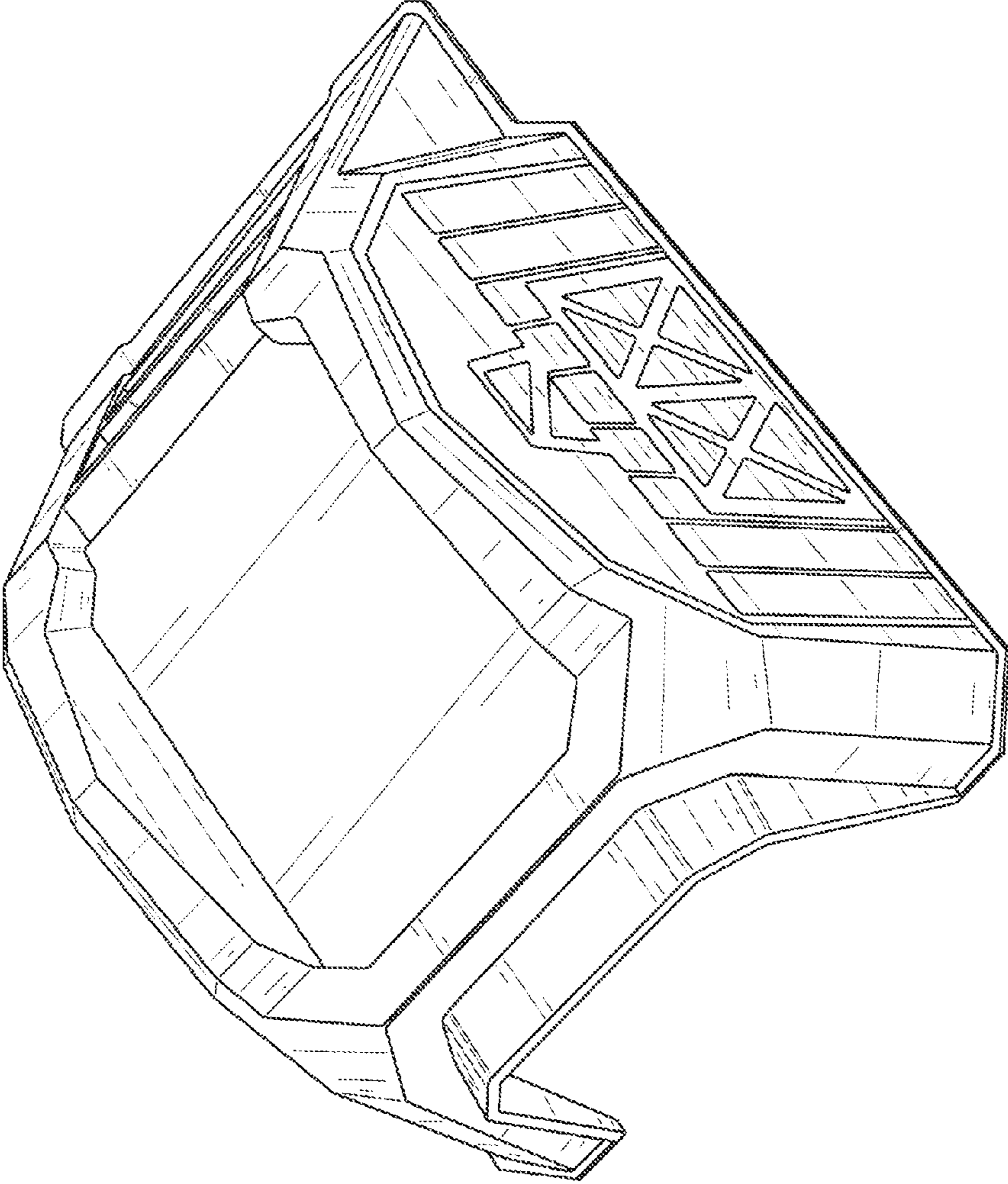

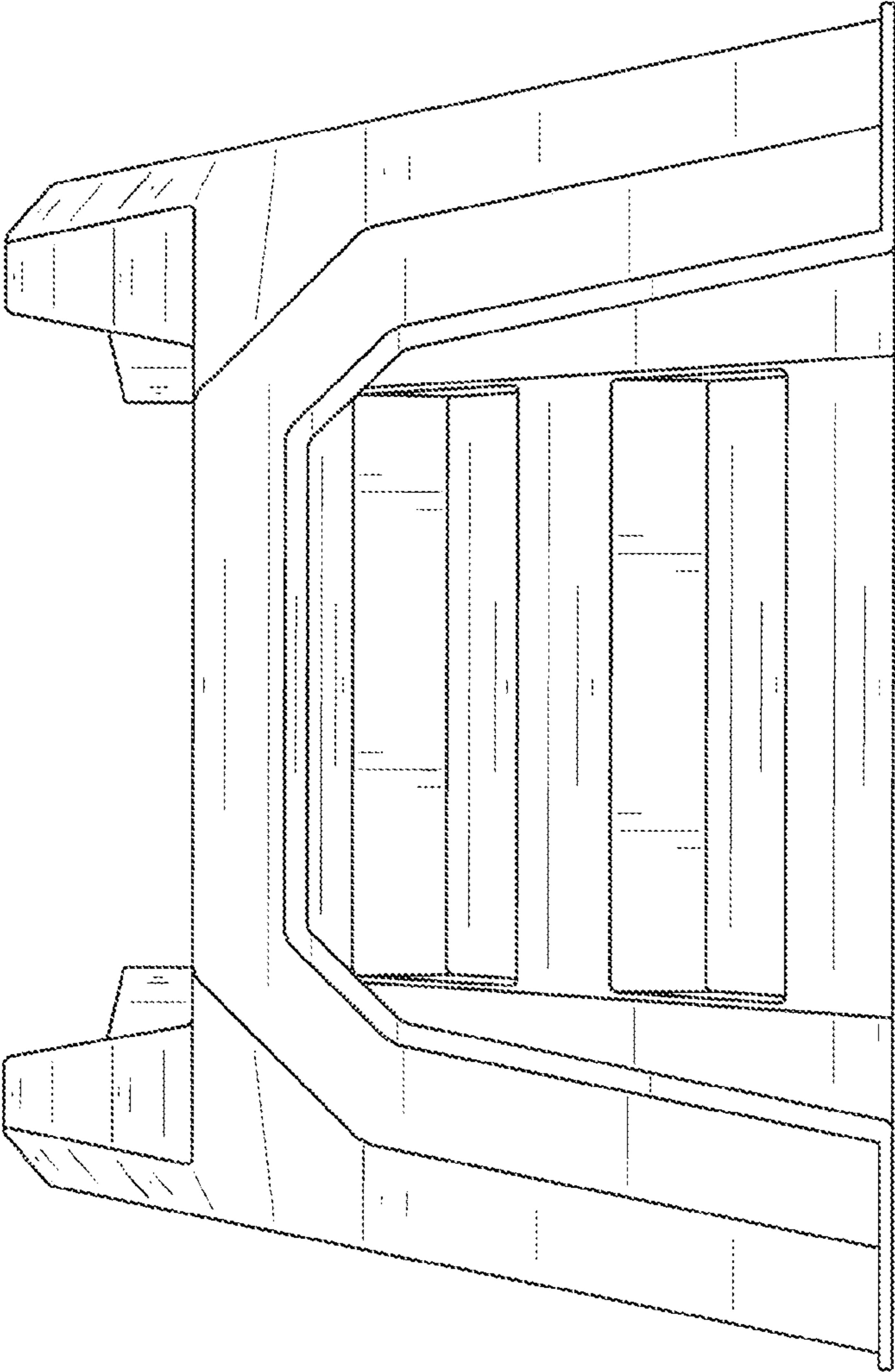

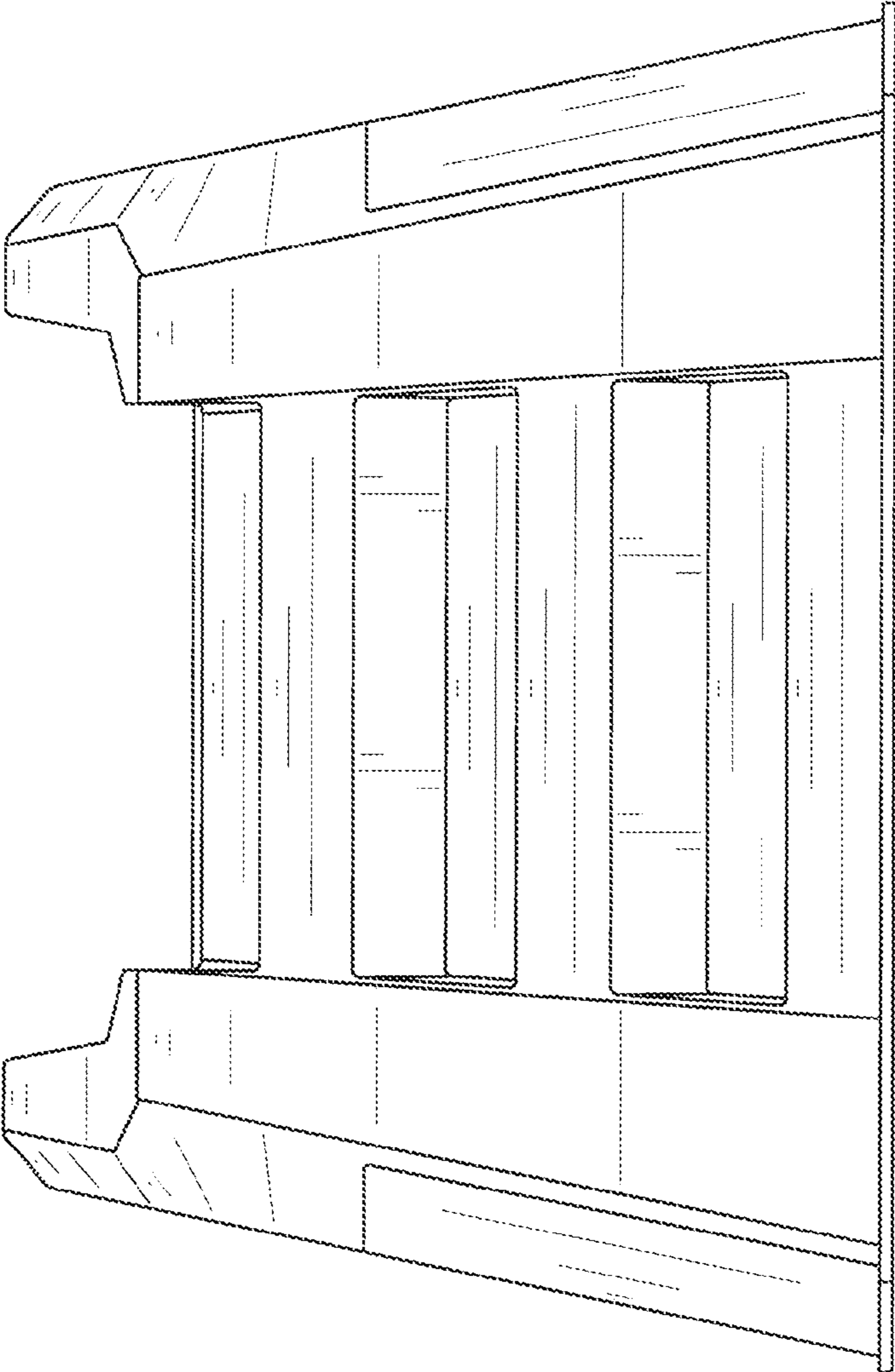

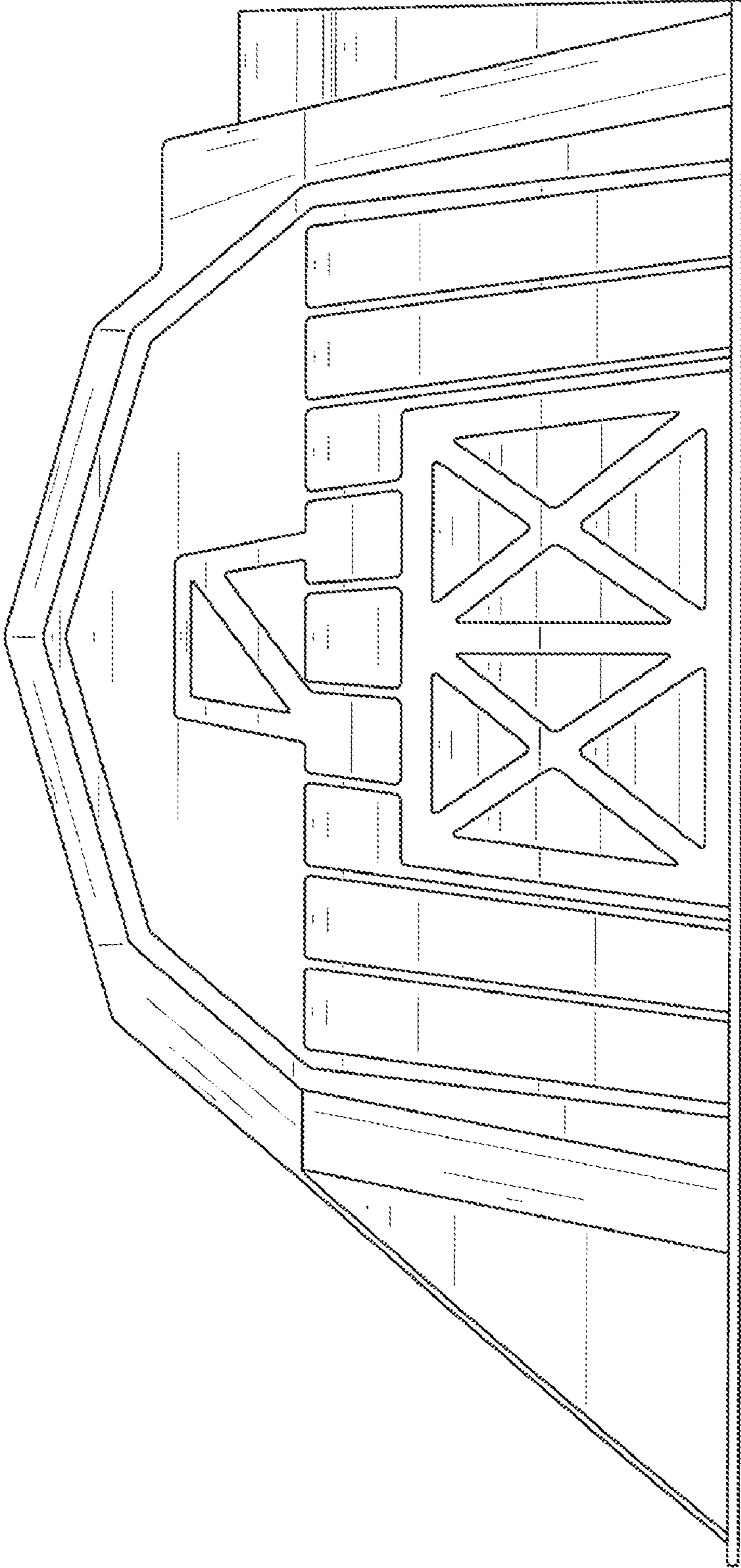

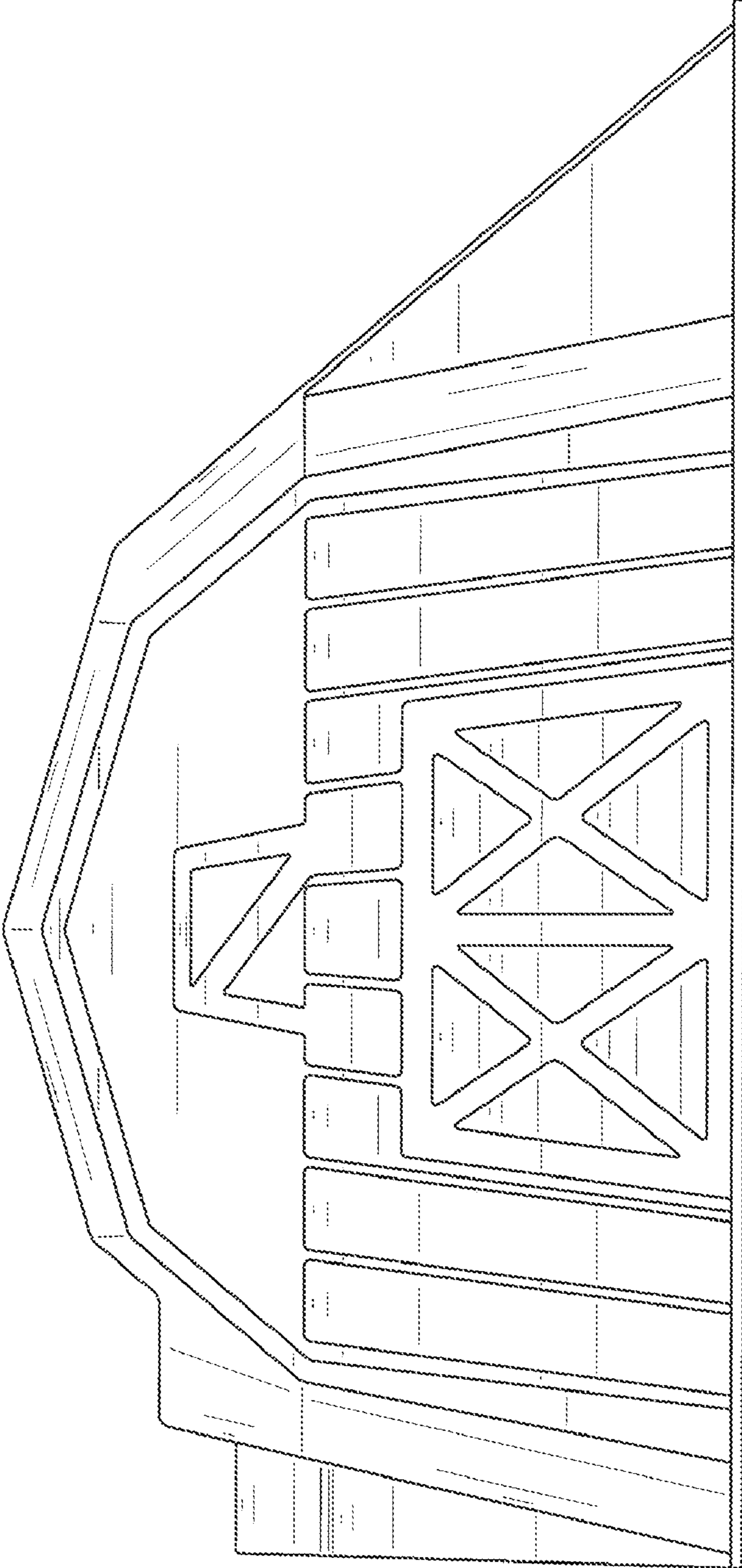

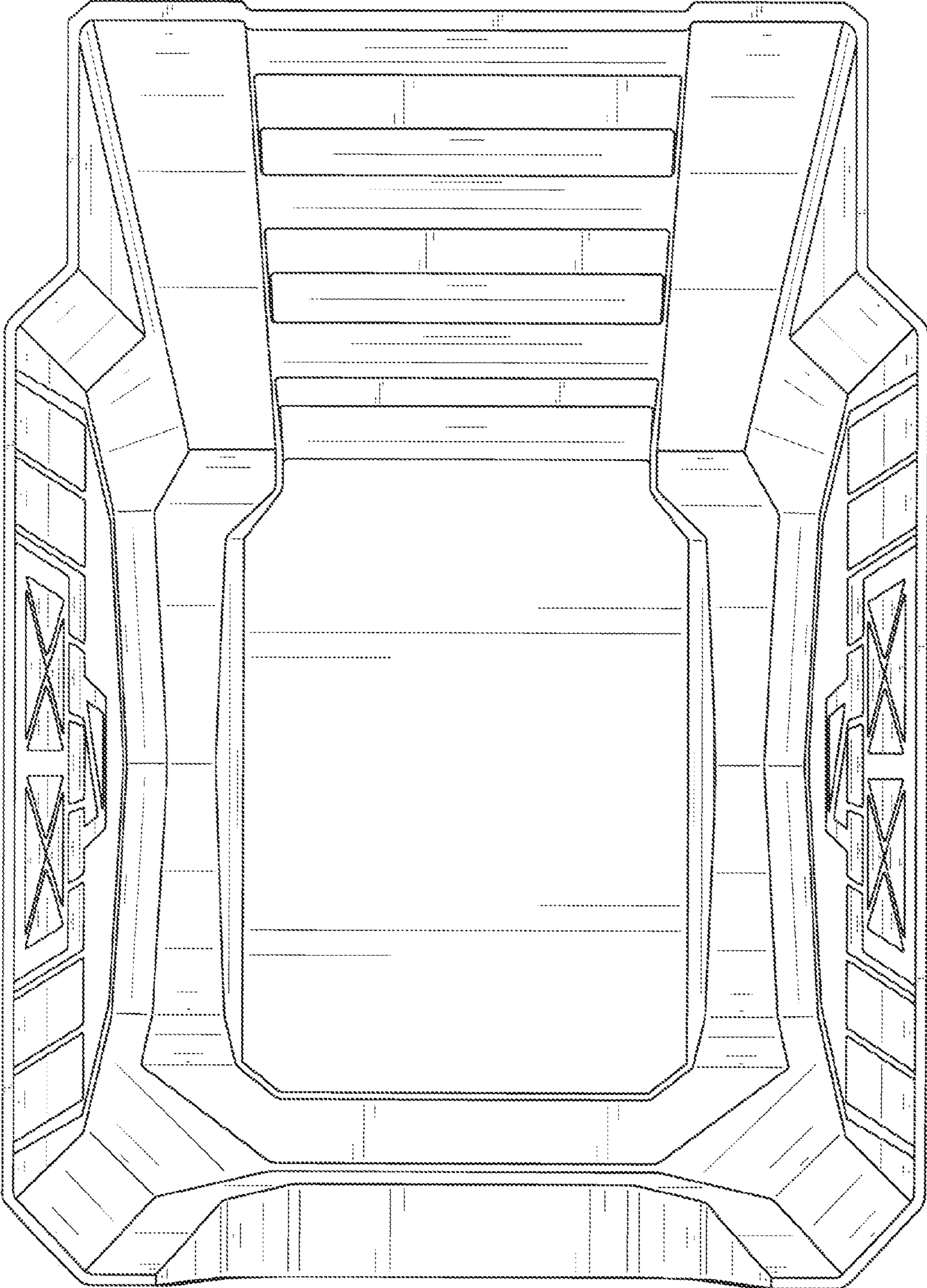

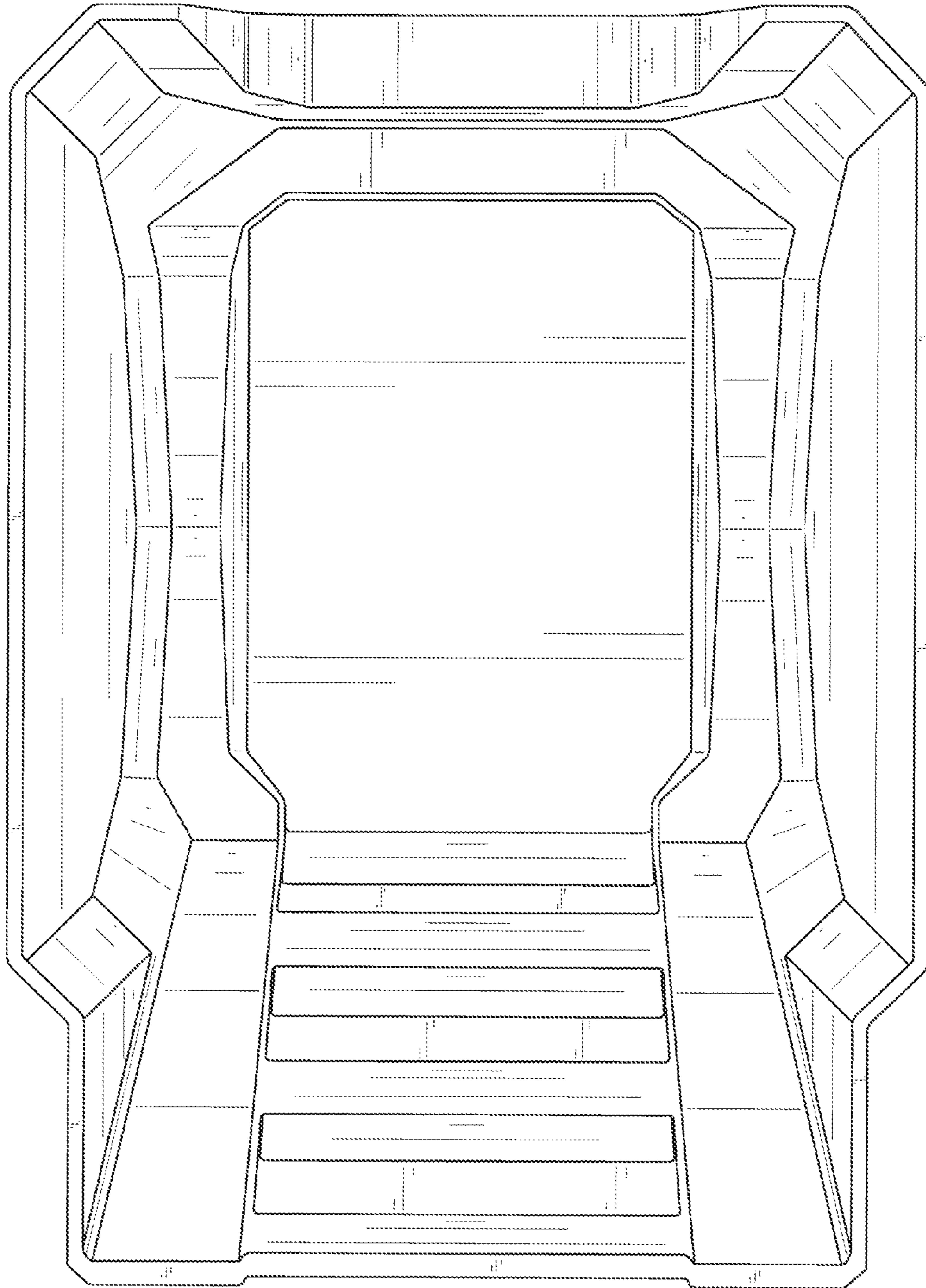
