The ornamental design for a disposable panty, as shown and described.

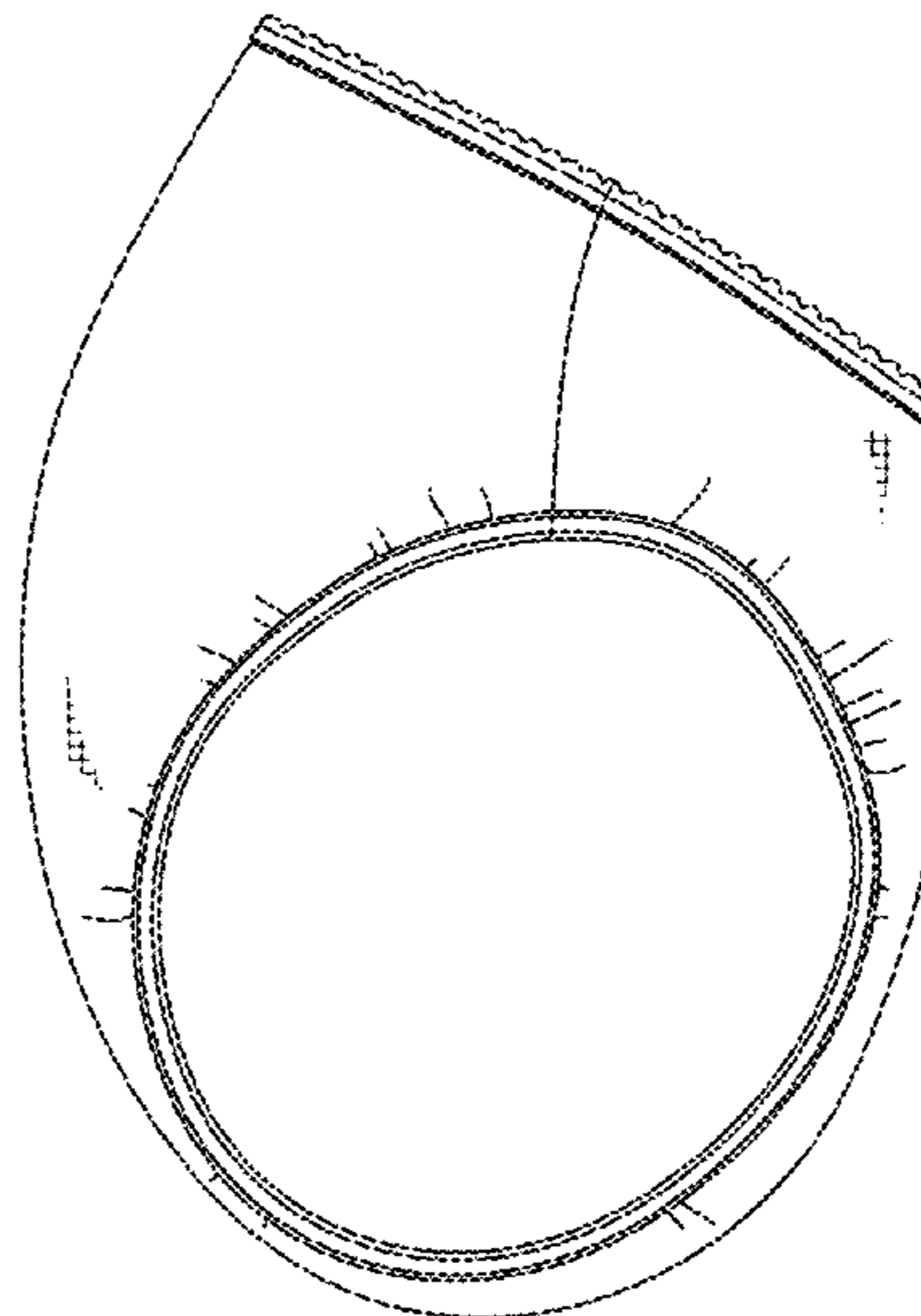
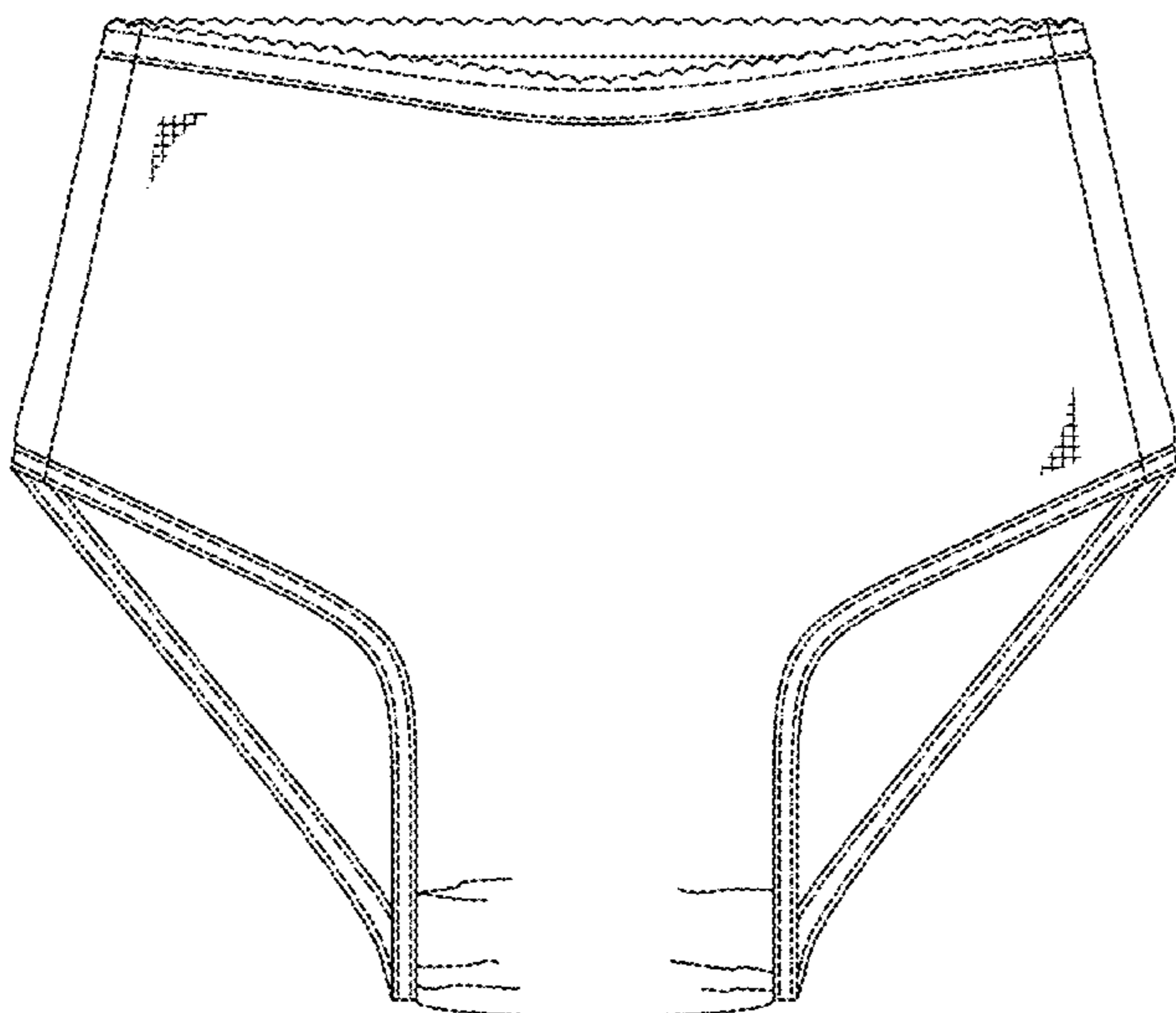
**DESCRIPTION**

FIG. 1 is a front view of a disposable panty of my new design, showing the disposable panty in its folded position; FIG. 2 is a front view of the disposable panty shown in FIG. 1 in its expanded position; FIG. 3 is a rear view of the disposable panty shown in FIG. 1 in its expanded position; FIG. 4 is a side view of the disposable panty shown in FIG. 1 in its expanded position; the opposite side of the view shown in FIG. 4 is a mirror image of the side view shown; FIG. 5 is a top view of the disposable panty shown in FIG. 1 in its expanded position; and, FIG. 6 is a bottom view of the disposable panty shown in FIG. 1 in its expanded position.

The even broken lines shown in the drawings represent stitching, which forms a part of the claimed design.

The uneven broken lines depicting a pad, shown in FIG. 5, forms no part of the claimed design.

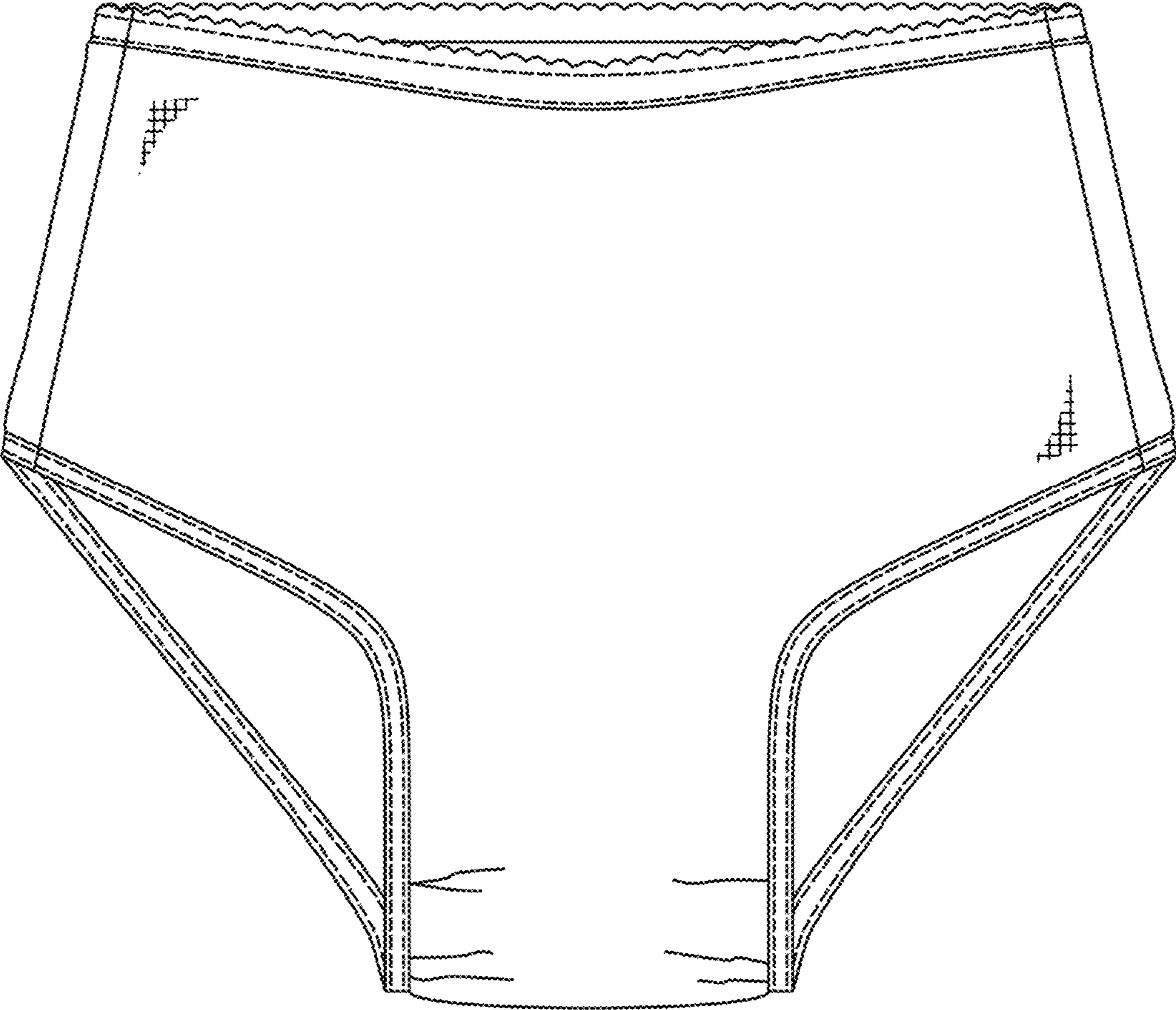

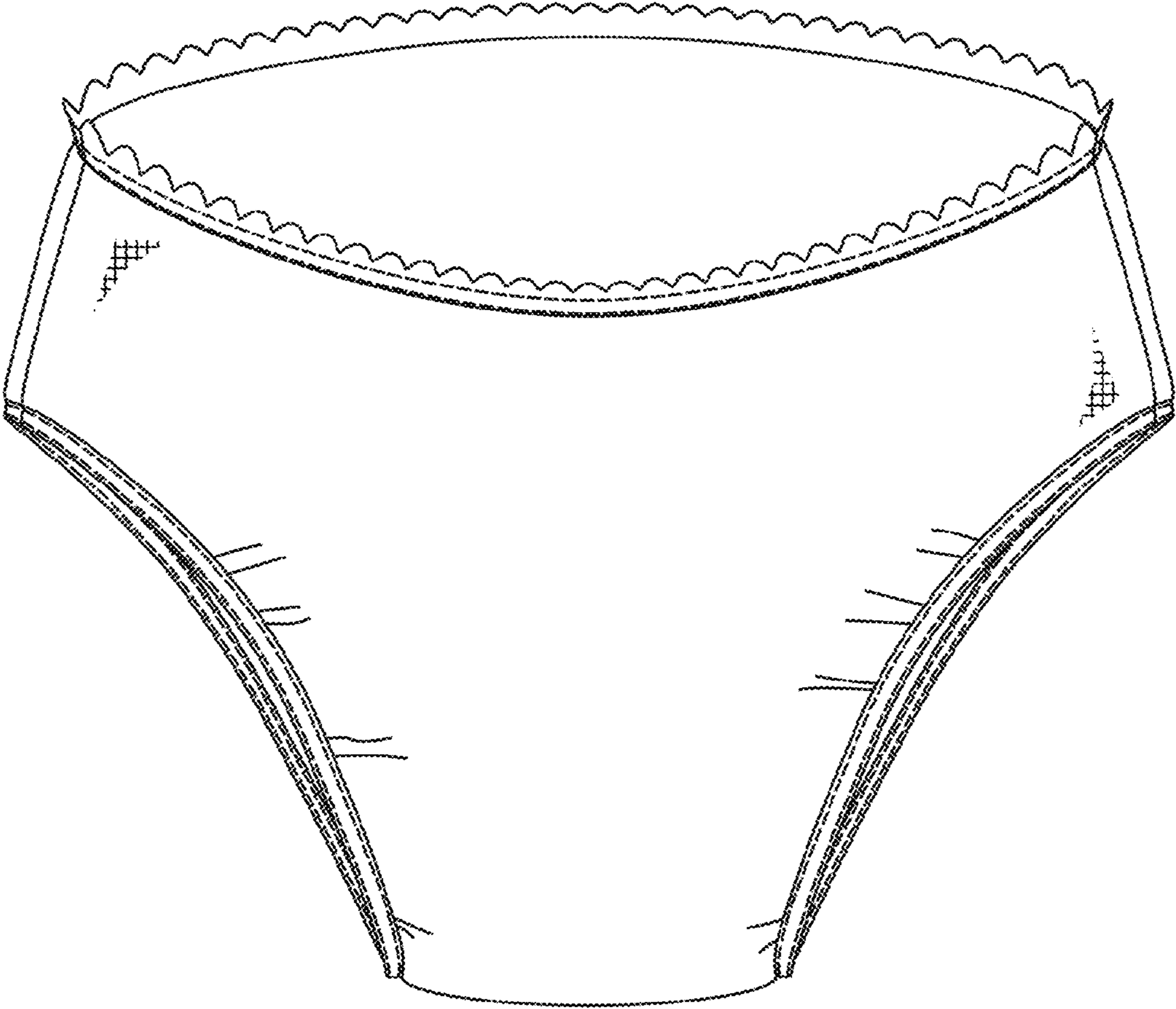

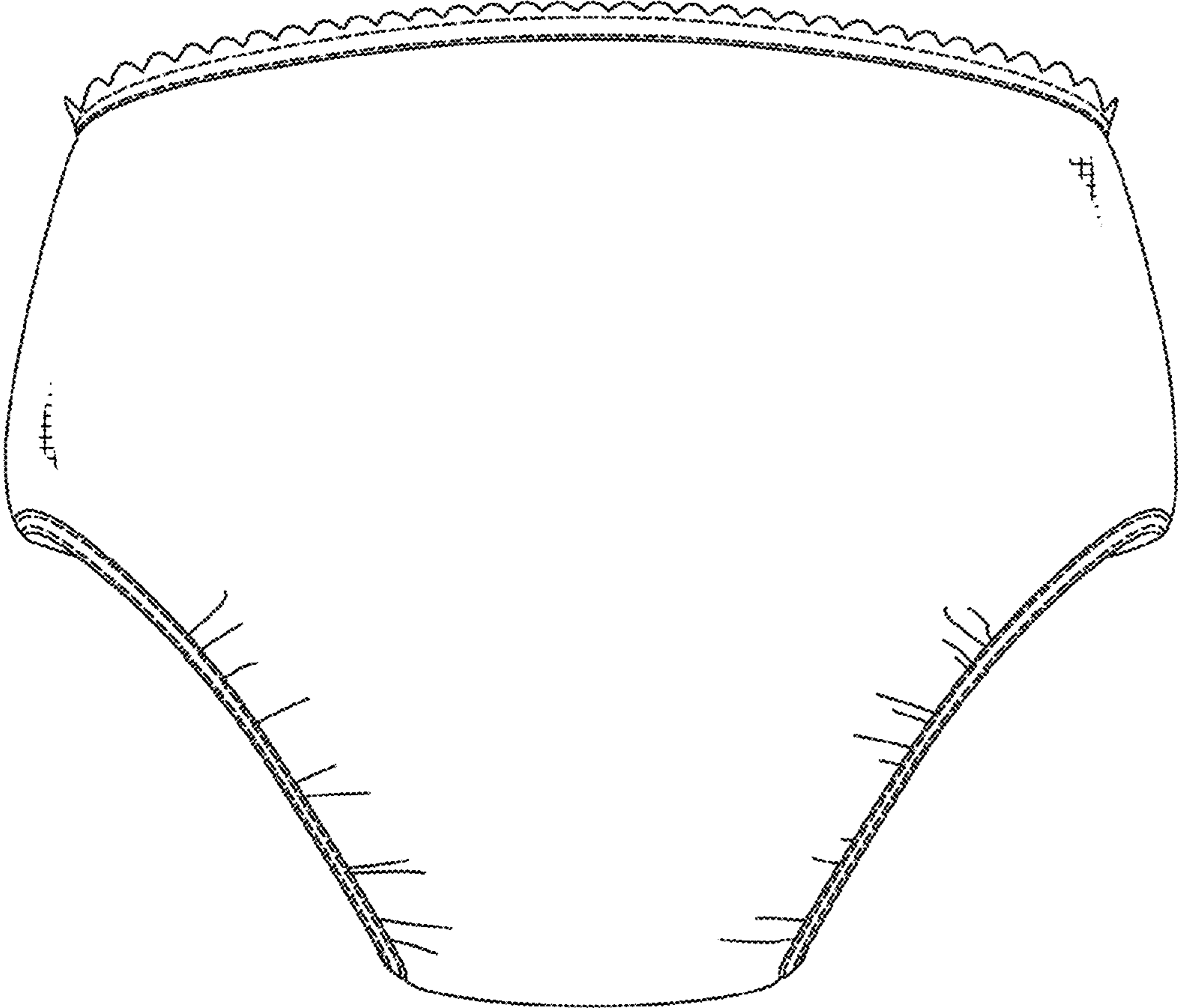

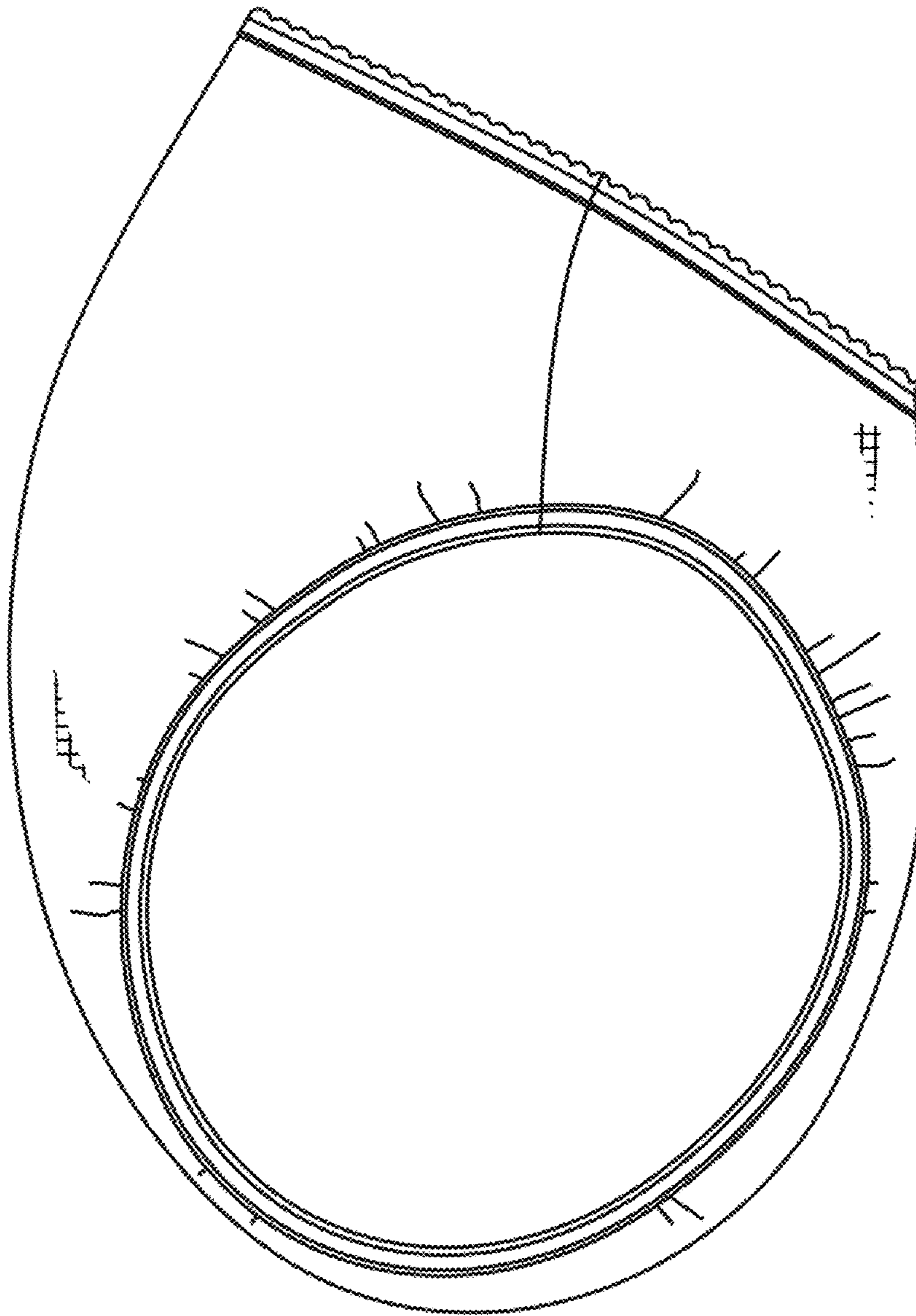

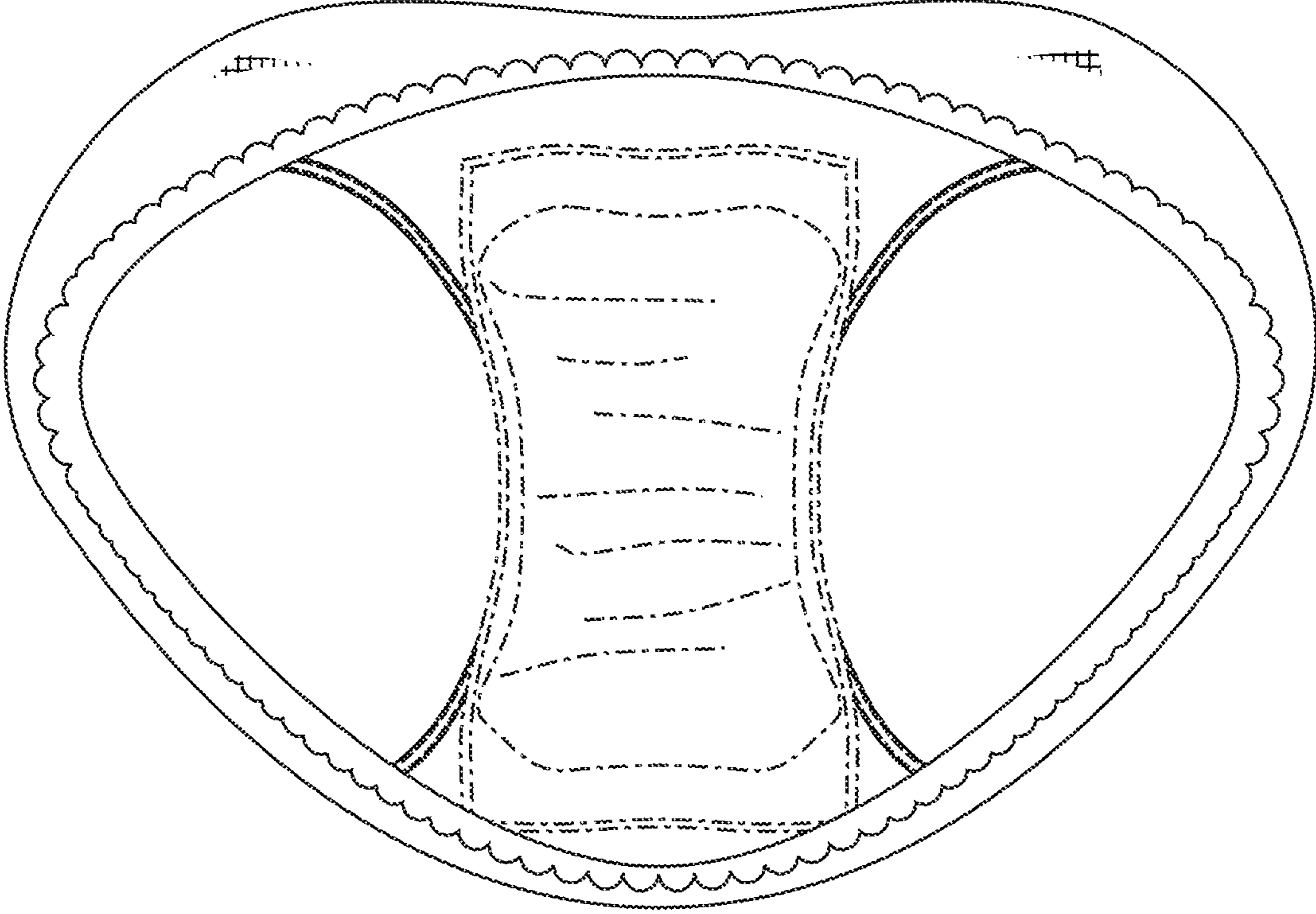

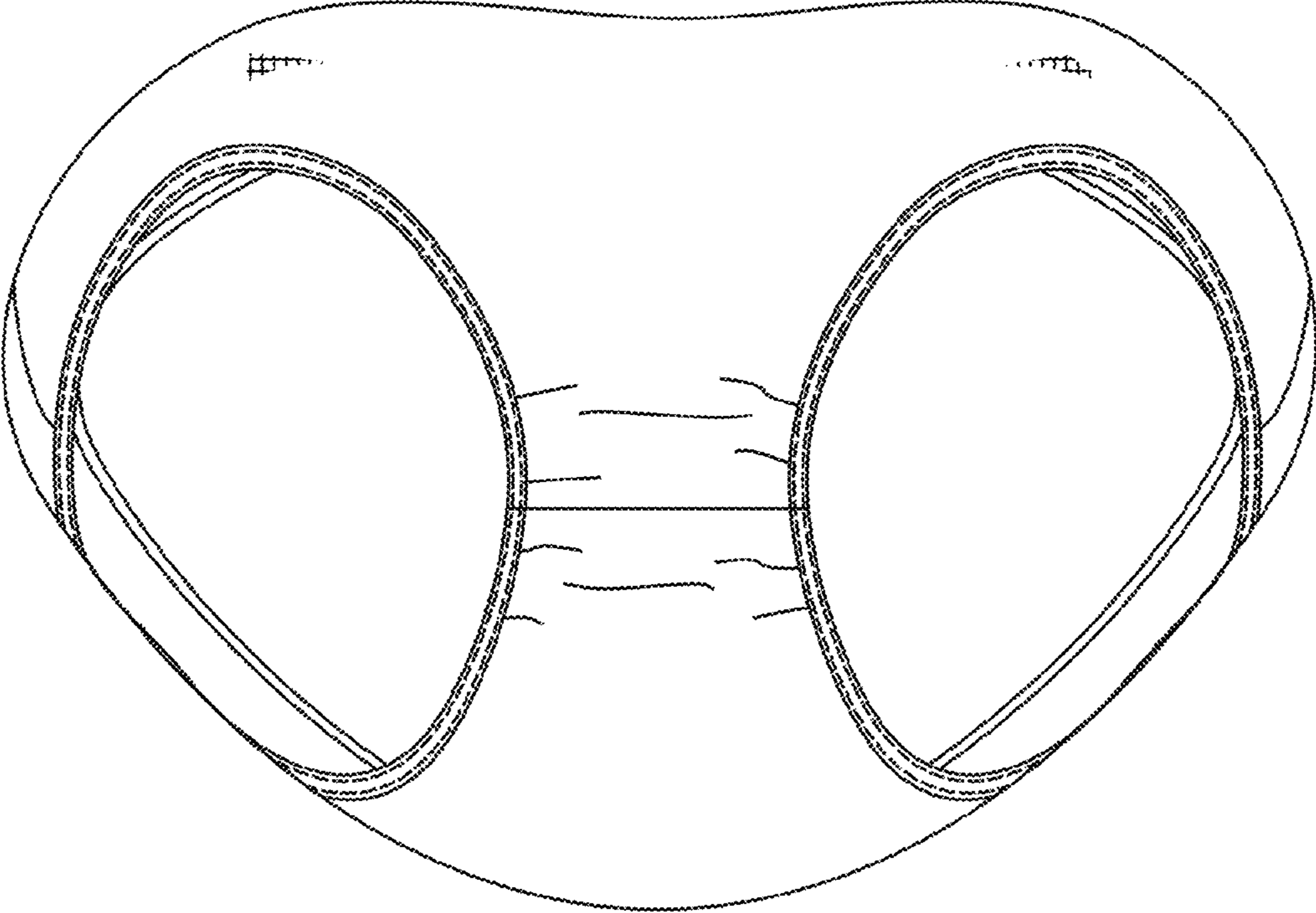
