**DESCRIPTION**

FIG. 1 is a front elevation view of a burping bib showing my new design;

FIG. 2 is a rear elevation view thereof;

FIG. 4 is a left side elevation view thereof;

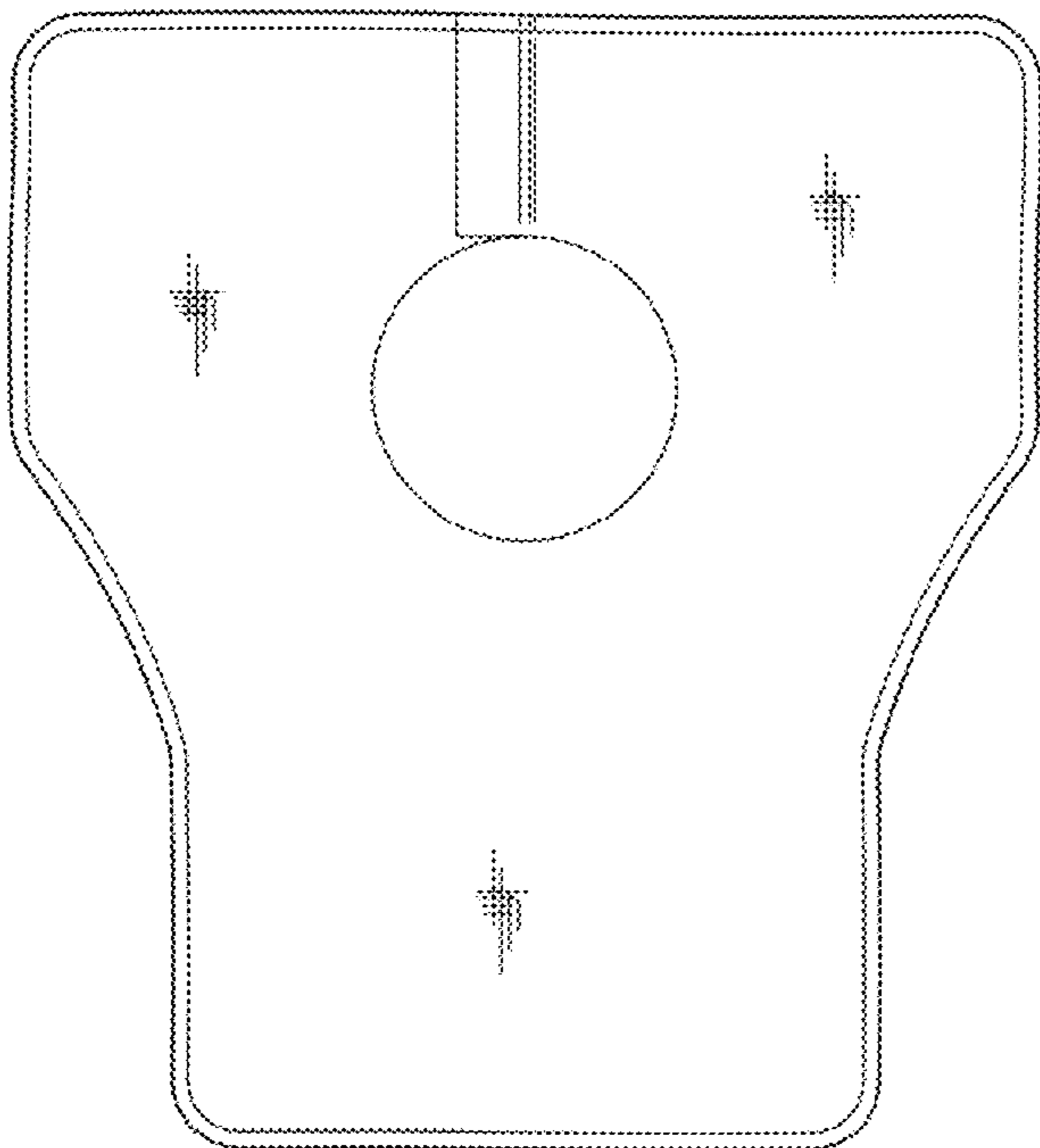
FIG. 5 is a top plan view thereof;

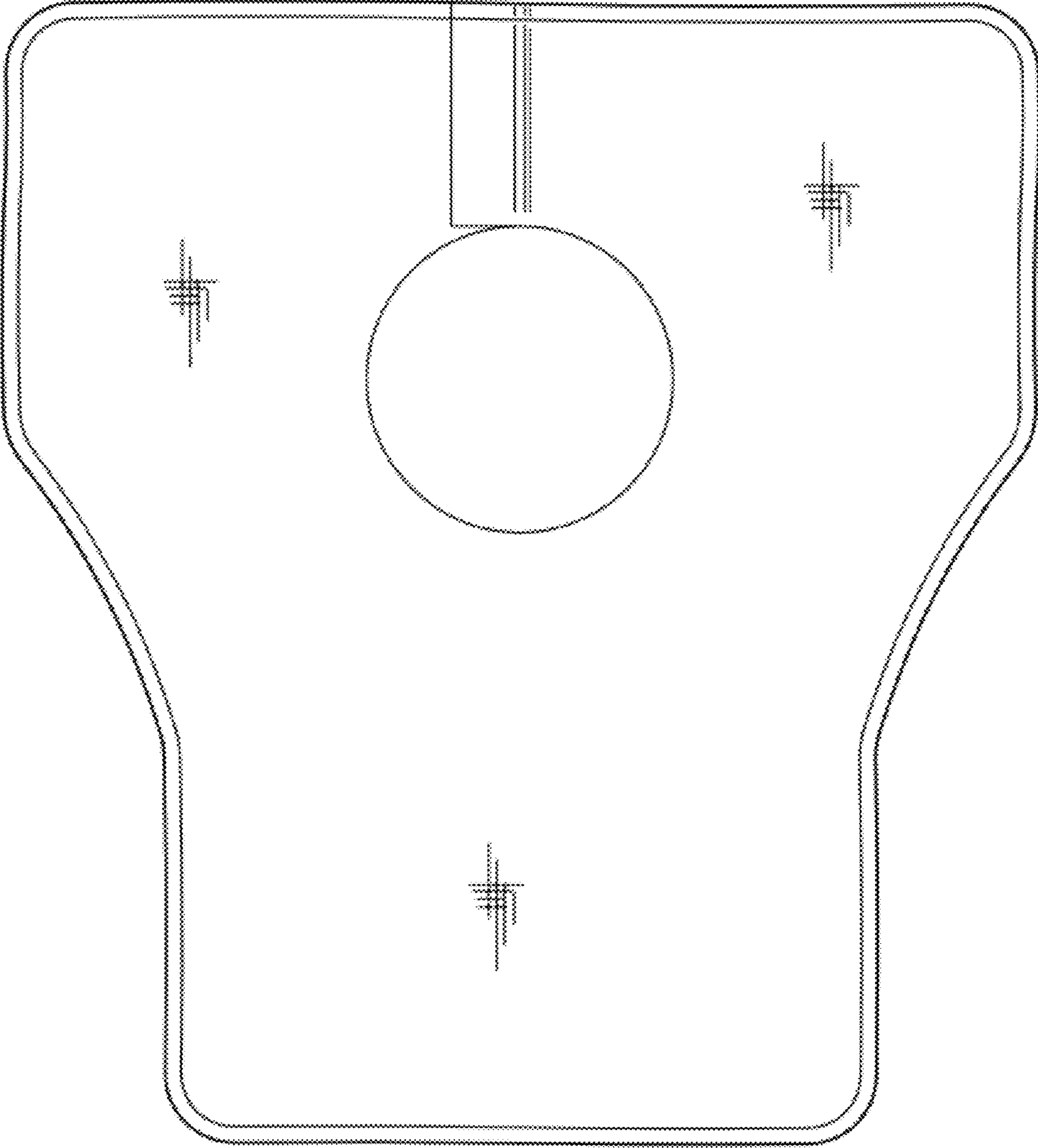

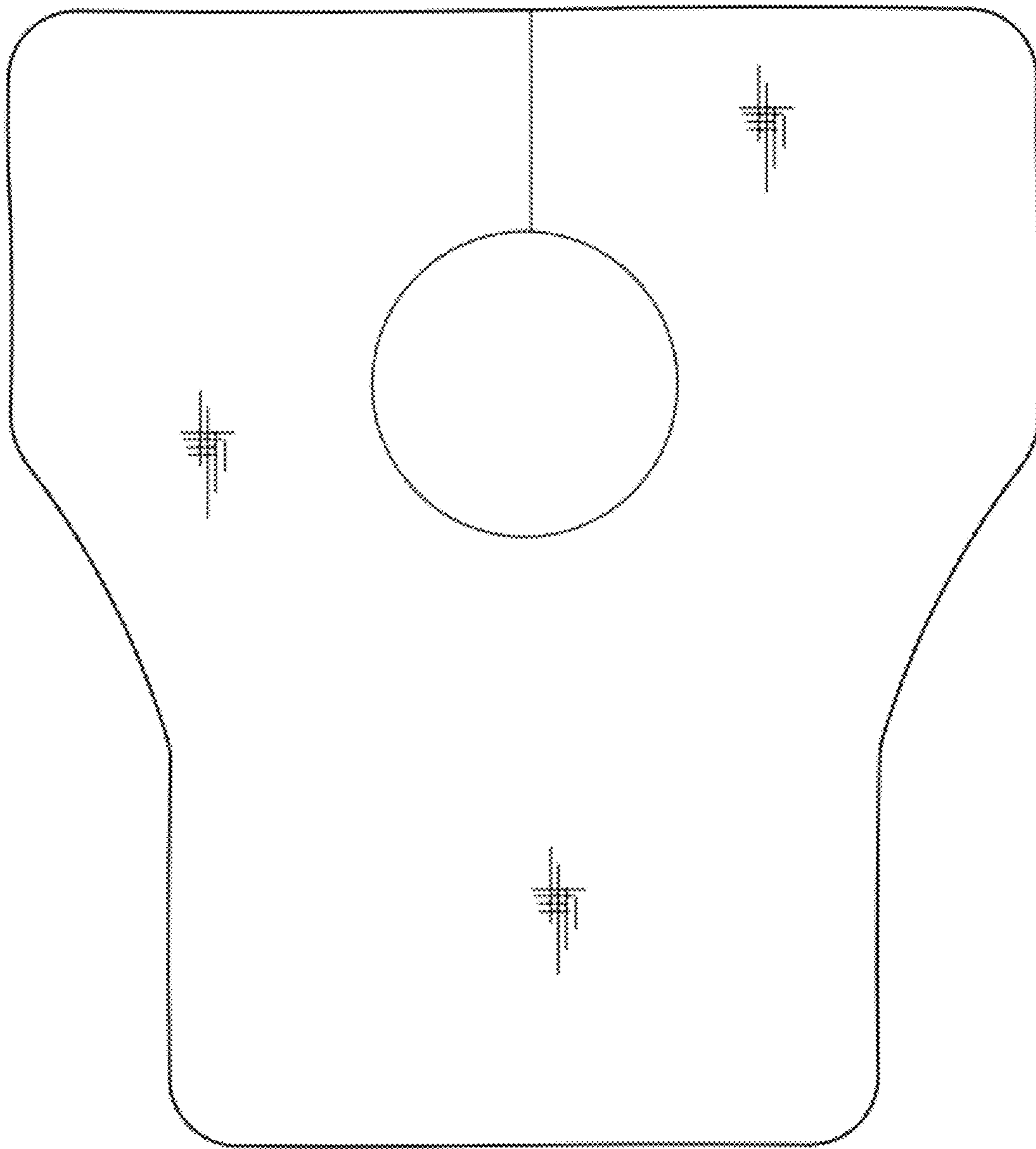

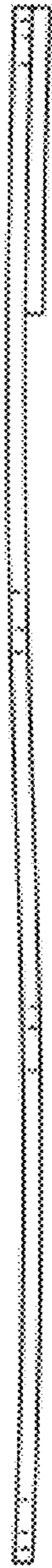

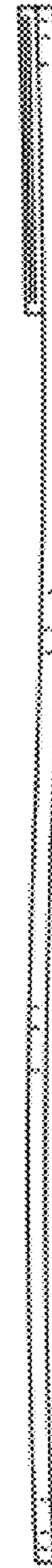

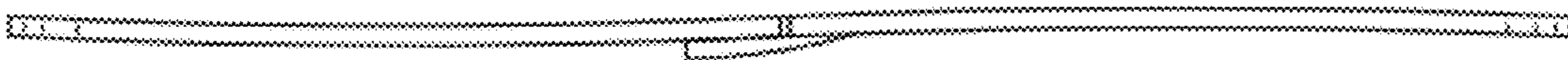

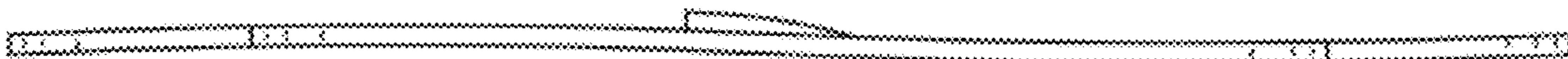
