(57) **CLAIM**

We claim the ornamental design for a bedside caddy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bedside caddy, showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

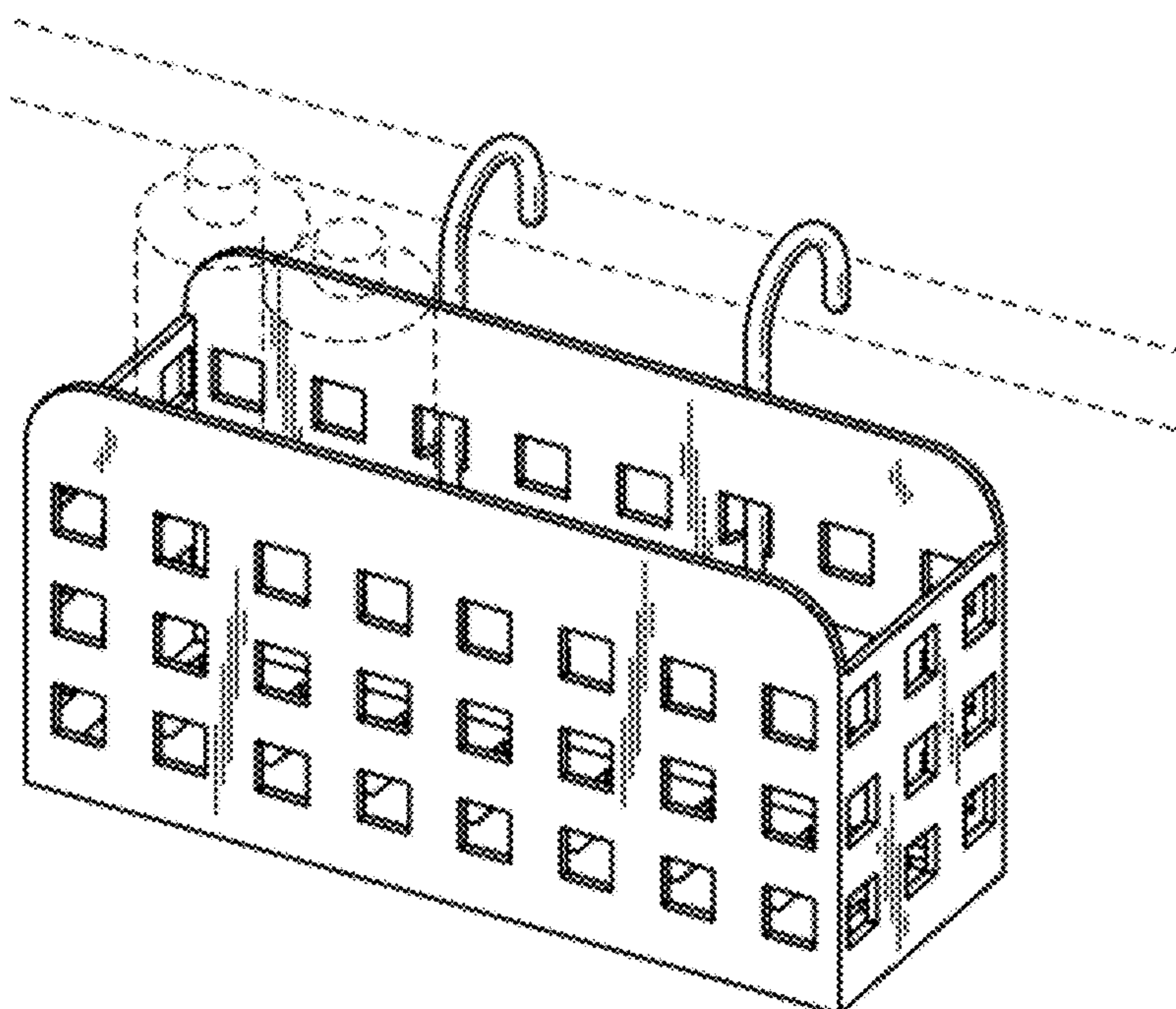
FIG. 4 is a top plan view thereof;

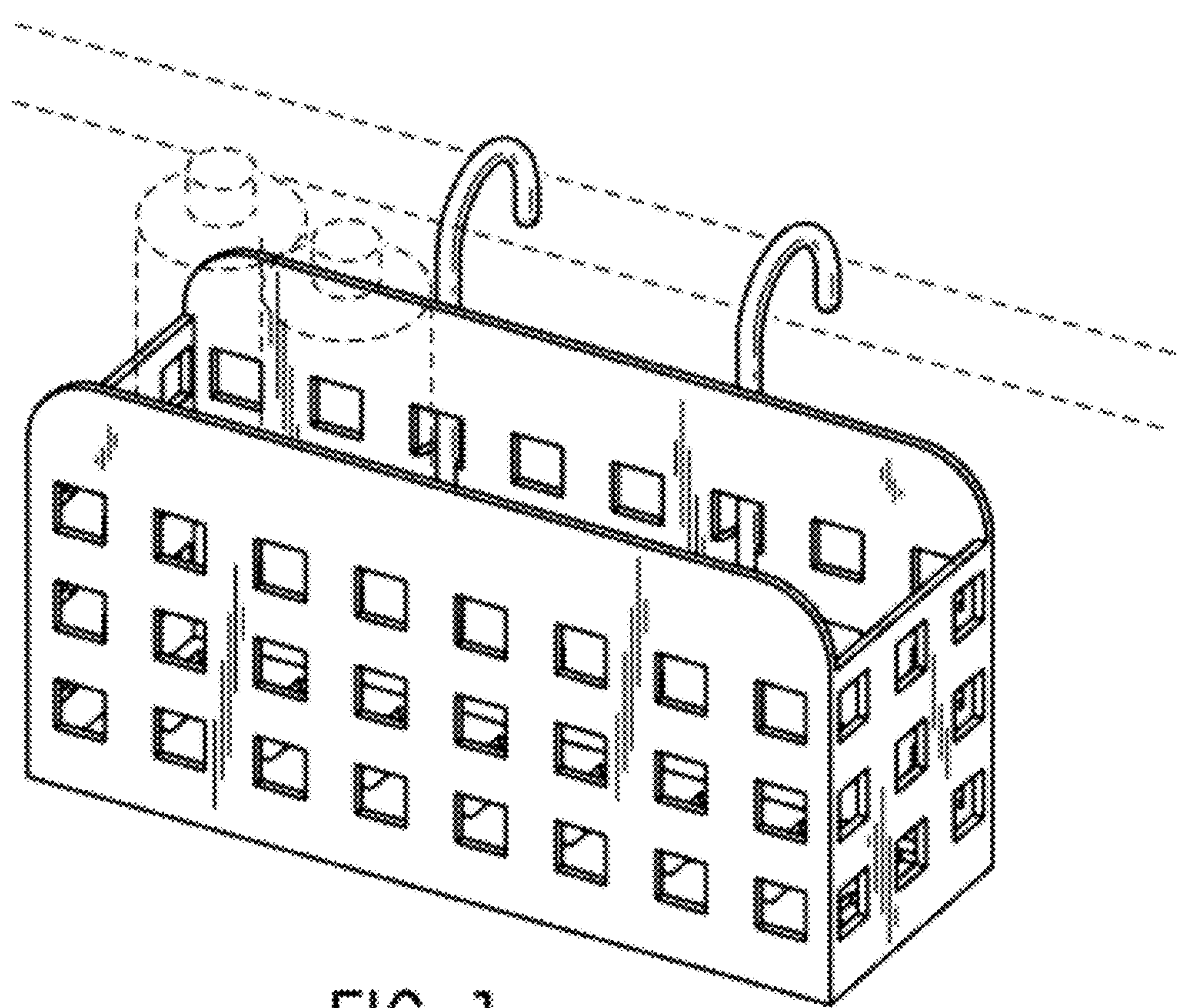

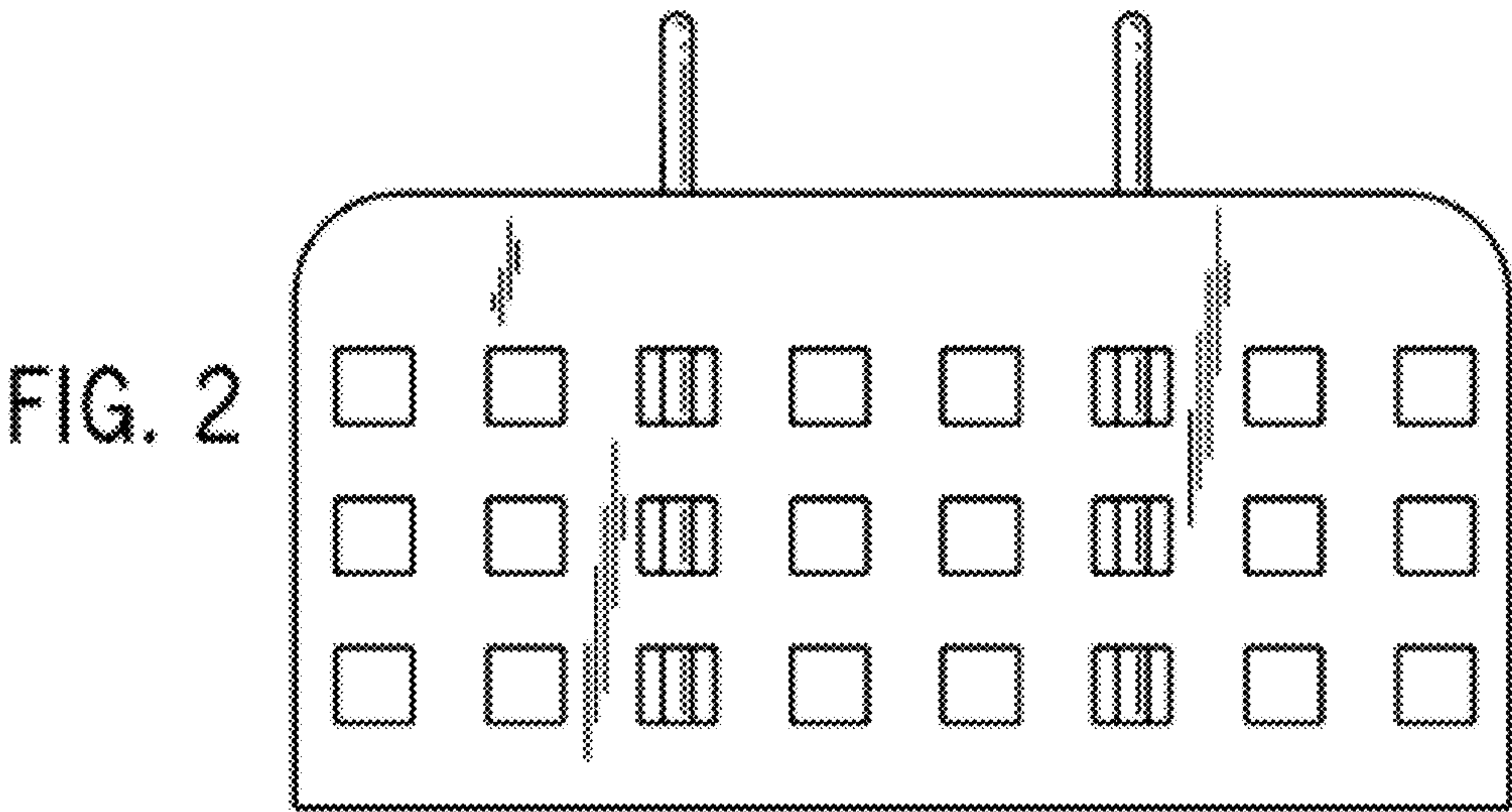

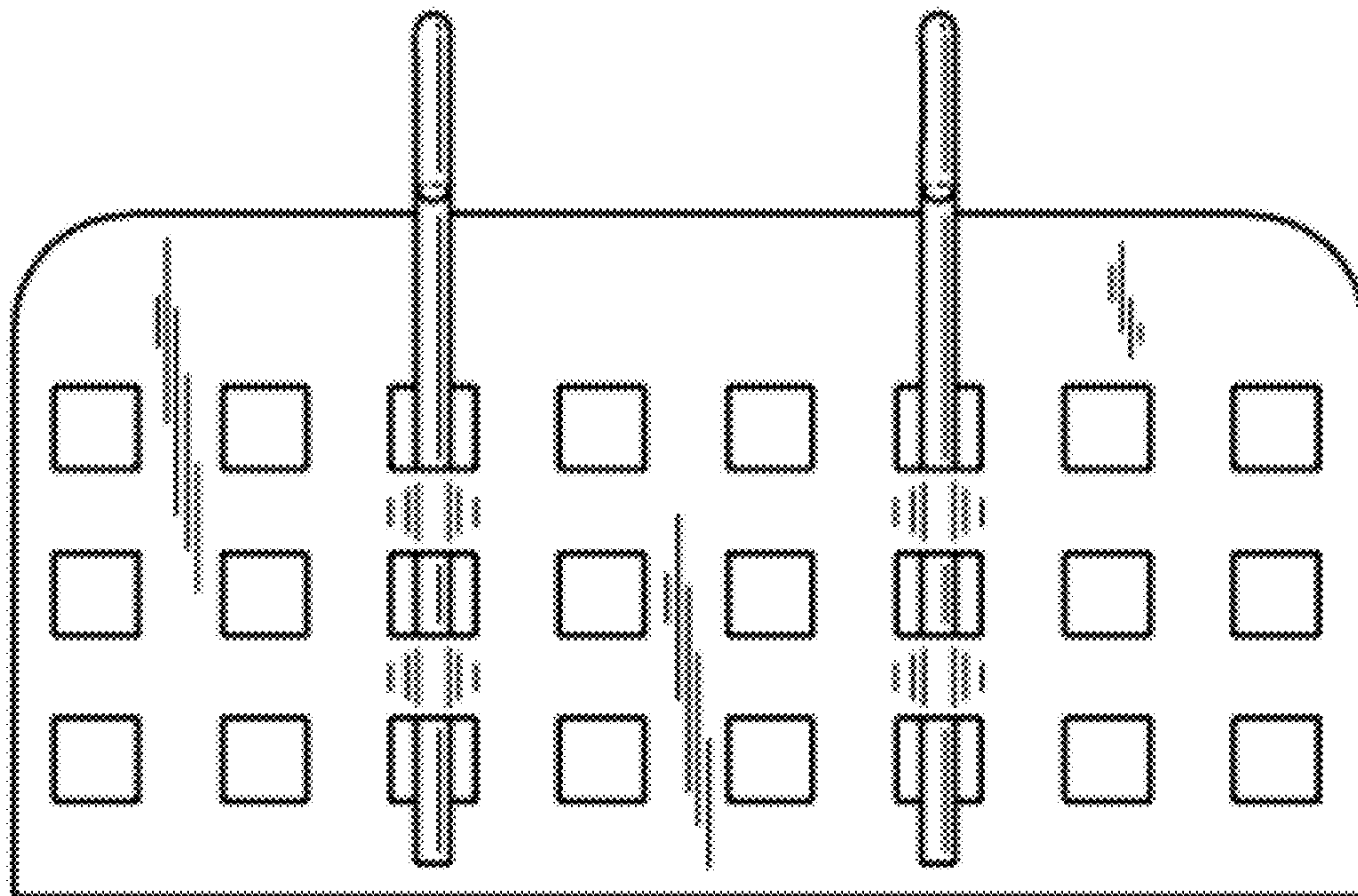

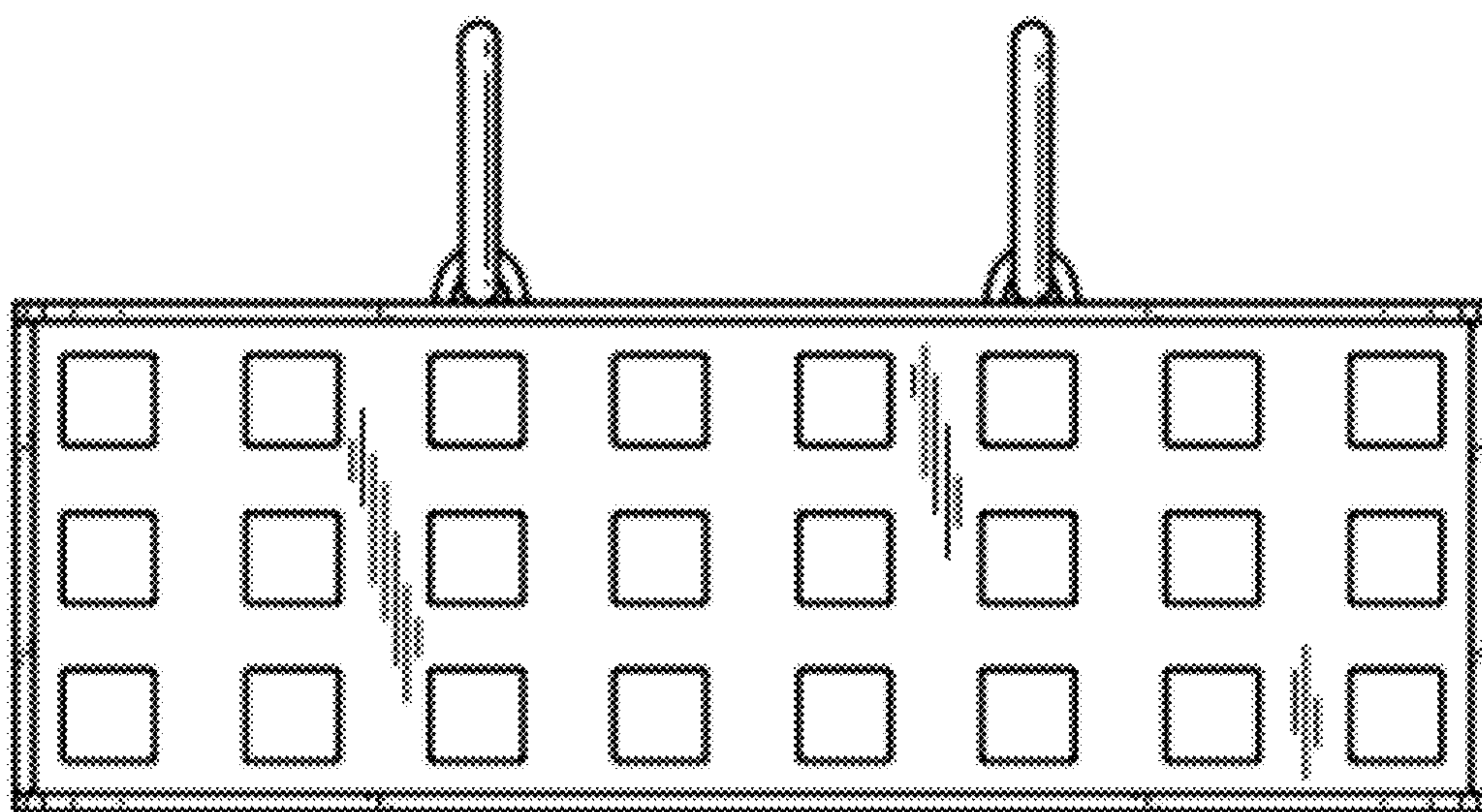

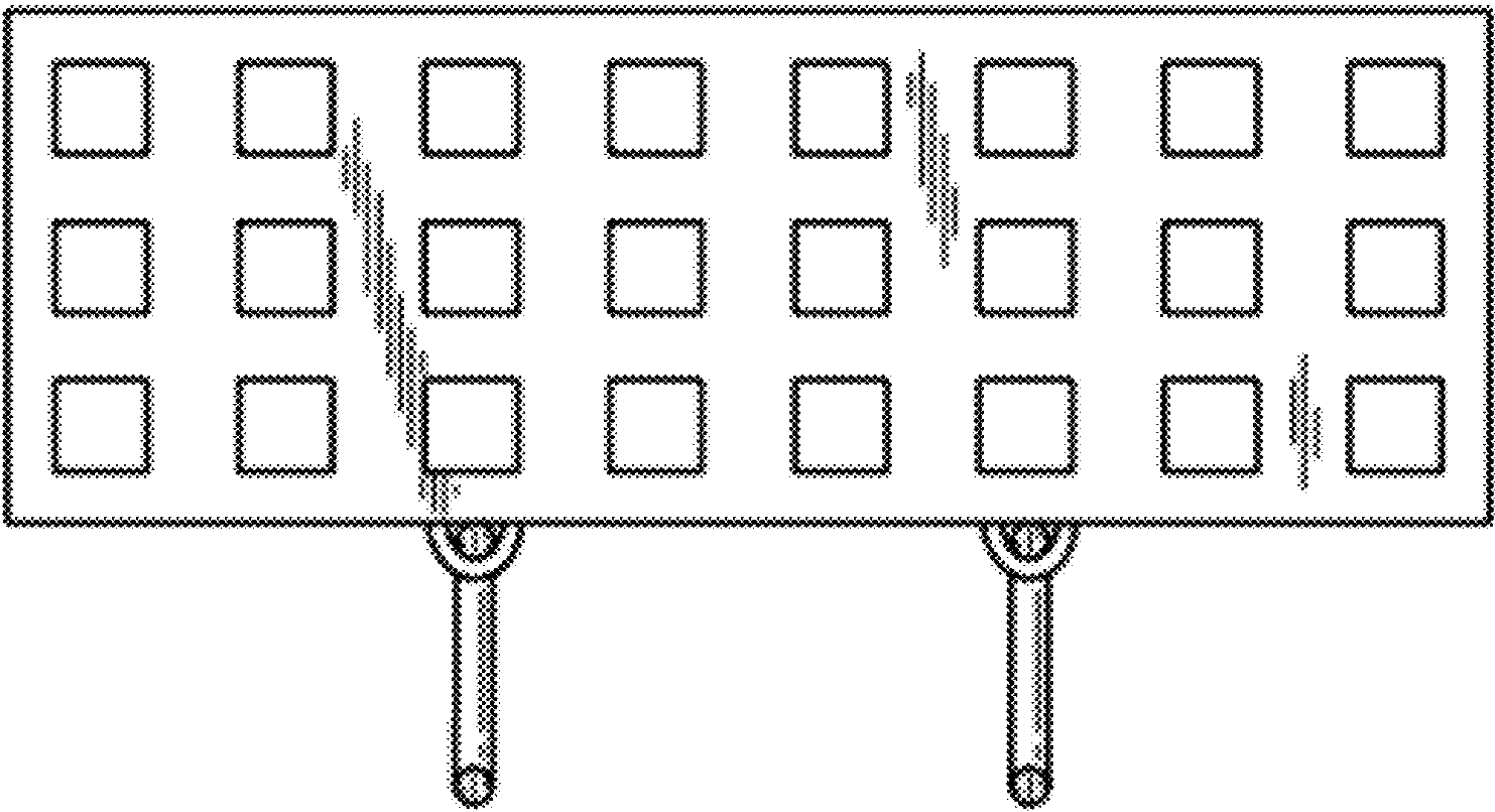

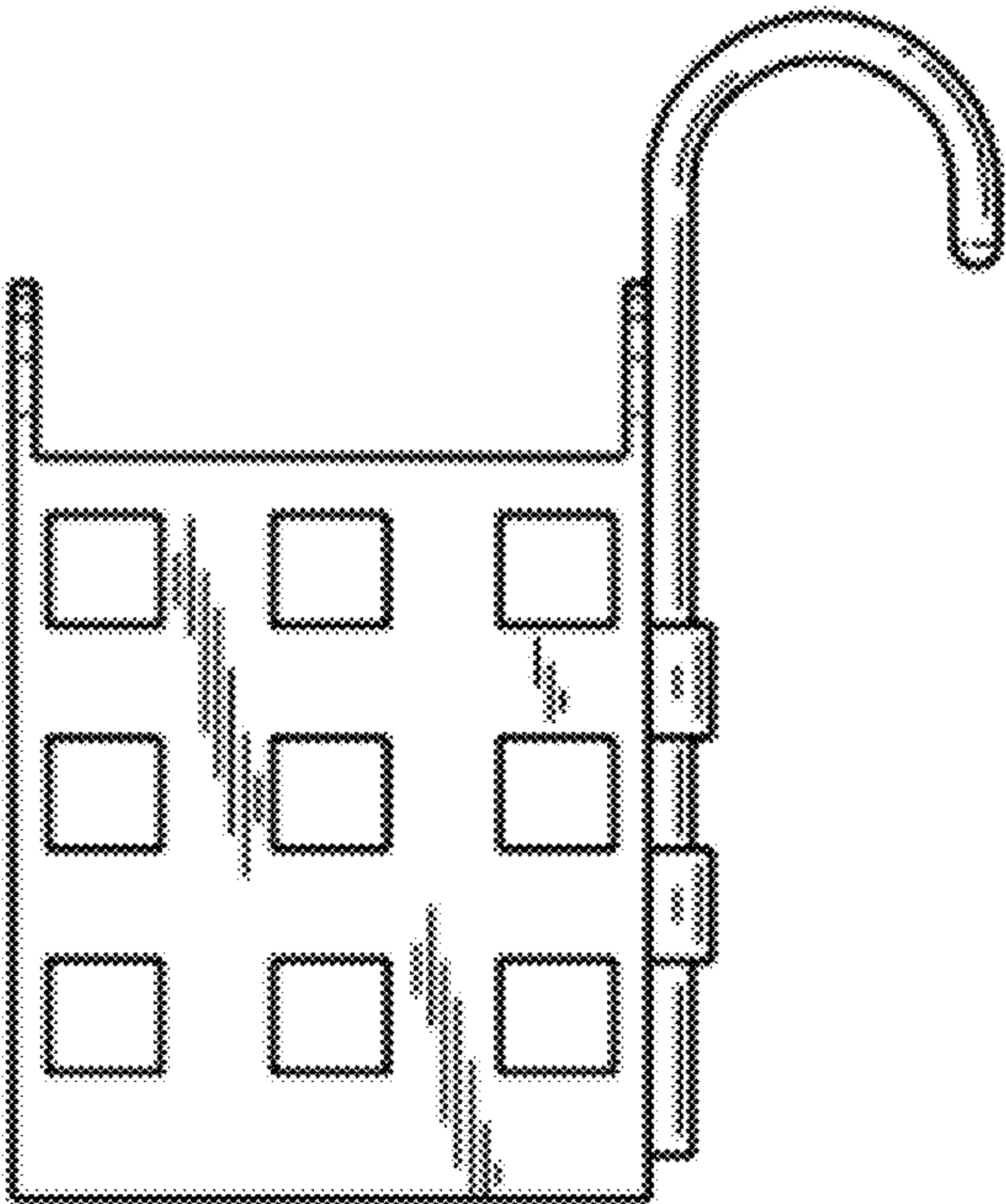
