(57) **CLAIM**

The ornamental design for a material with bubble pattern, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a first embodiment of the material with bubble pattern.

FIG. 2 is a side view of the material with bubble pattern illustrated in FIG. 1.

FIG. 3 is an end view of the material with bubble pattern illustrated in FIG. 1.

FIG. 4 is a bottom plan view of the material with bubble pattern illustrated in FIG. 1.

FIG. 5 is an enlarged sectional view of the material with bubble pattern taken in the direction of line 5-5 in FIG. 1.

FIG. 6 is a side view of the material with bubble pattern illustrated in FIG. 5.

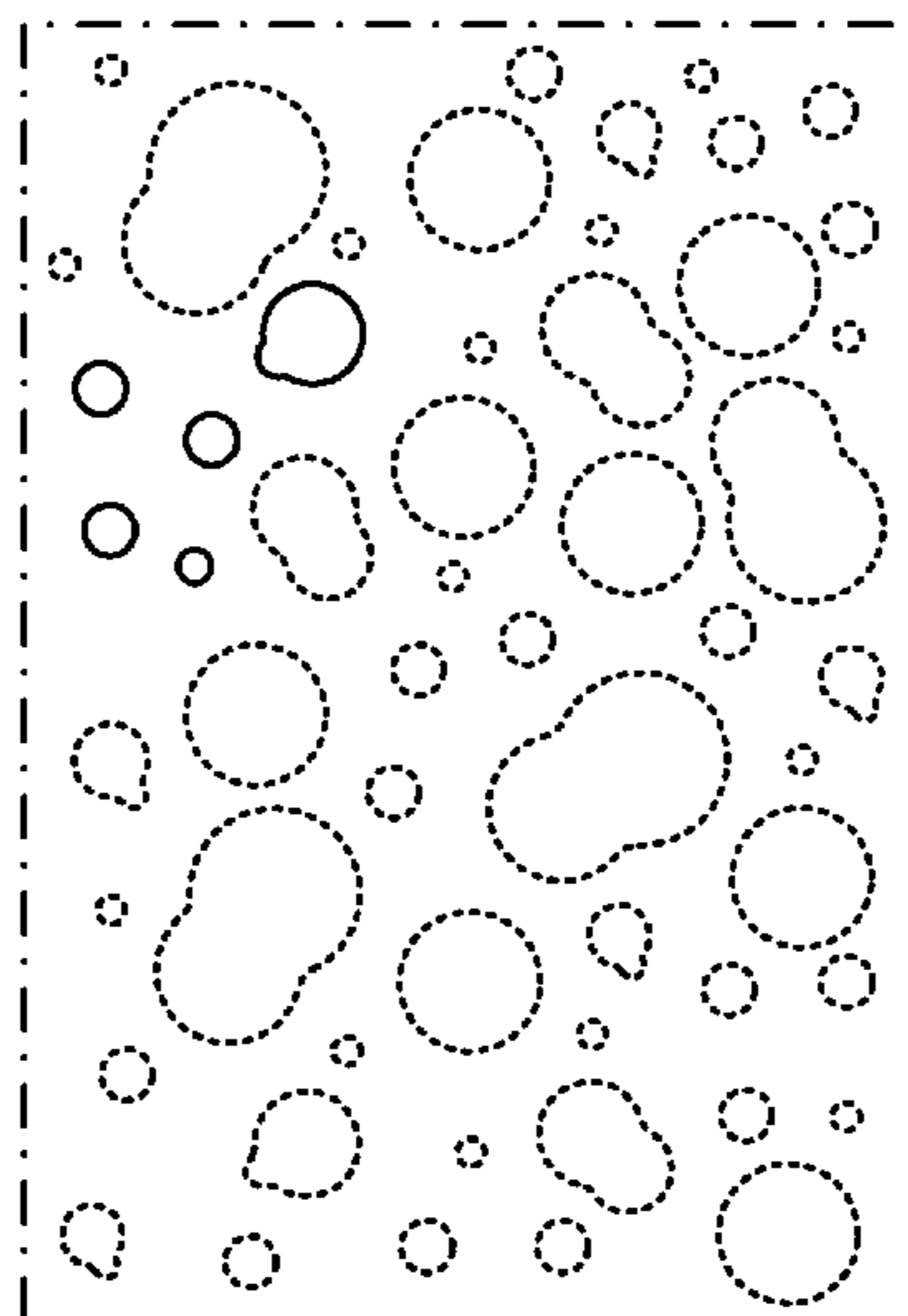
FIG. 7 is an end view of the material with bubble pattern illustrated in FIG. 5.

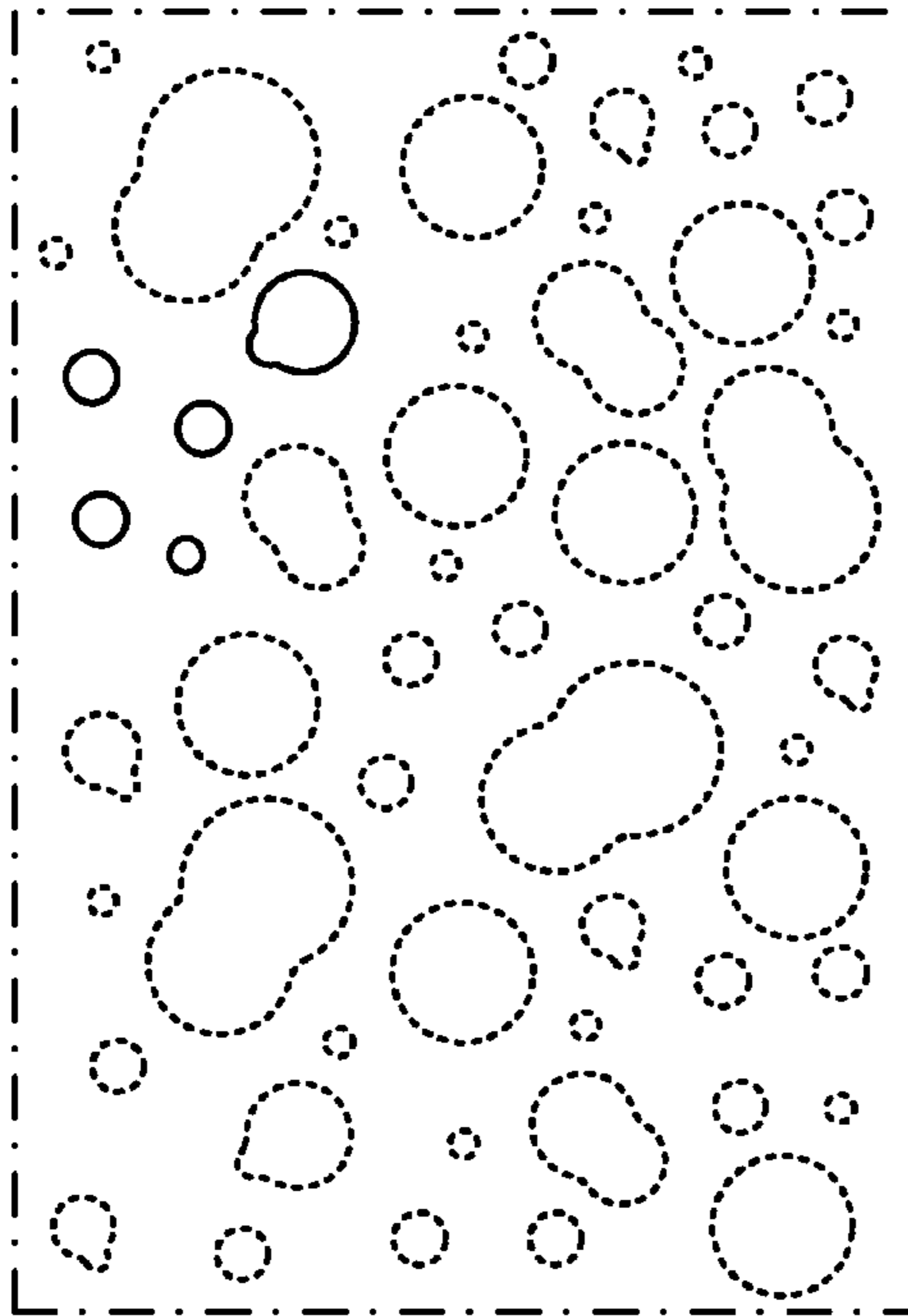

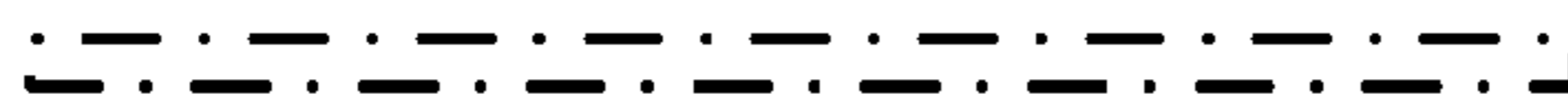

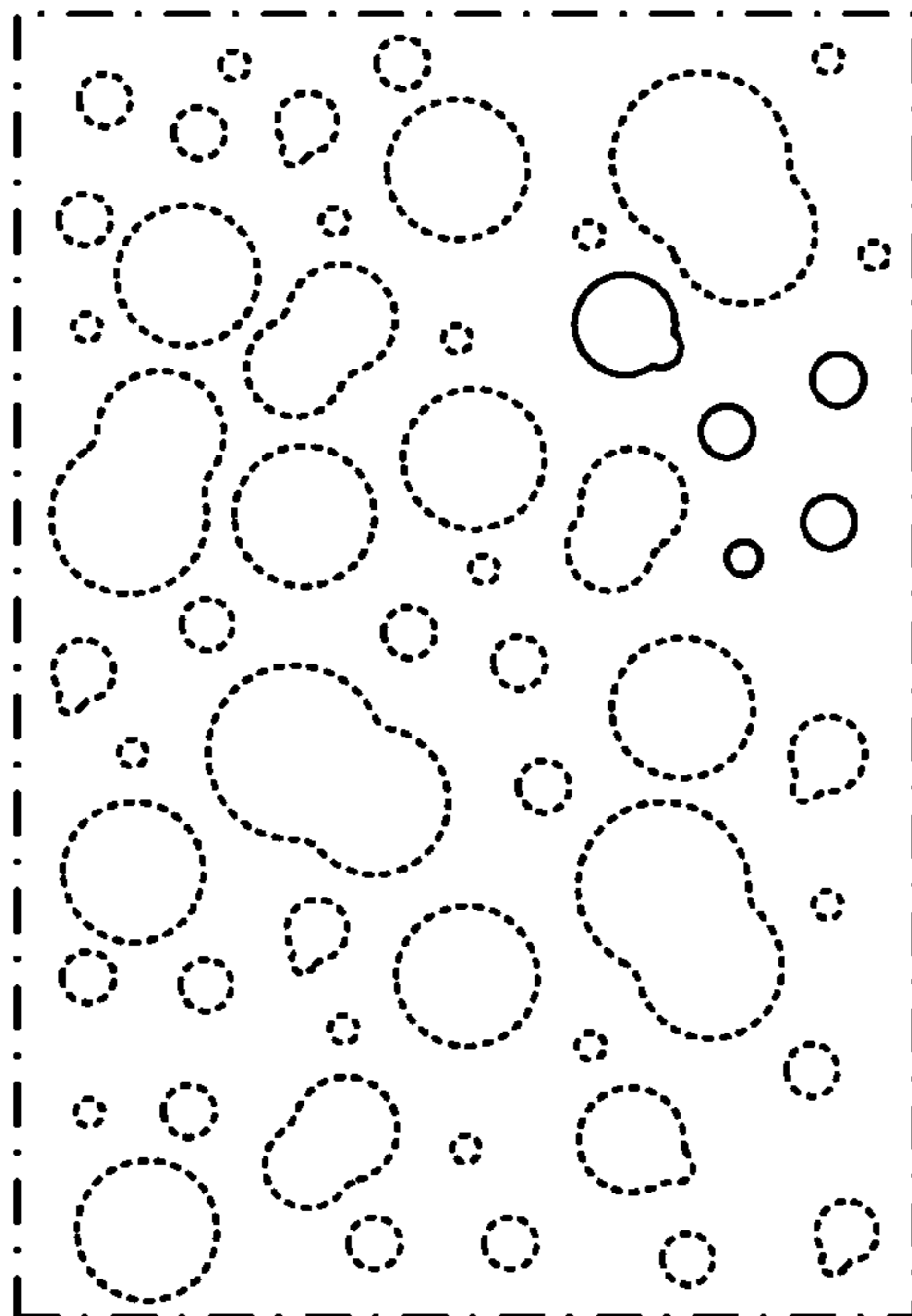

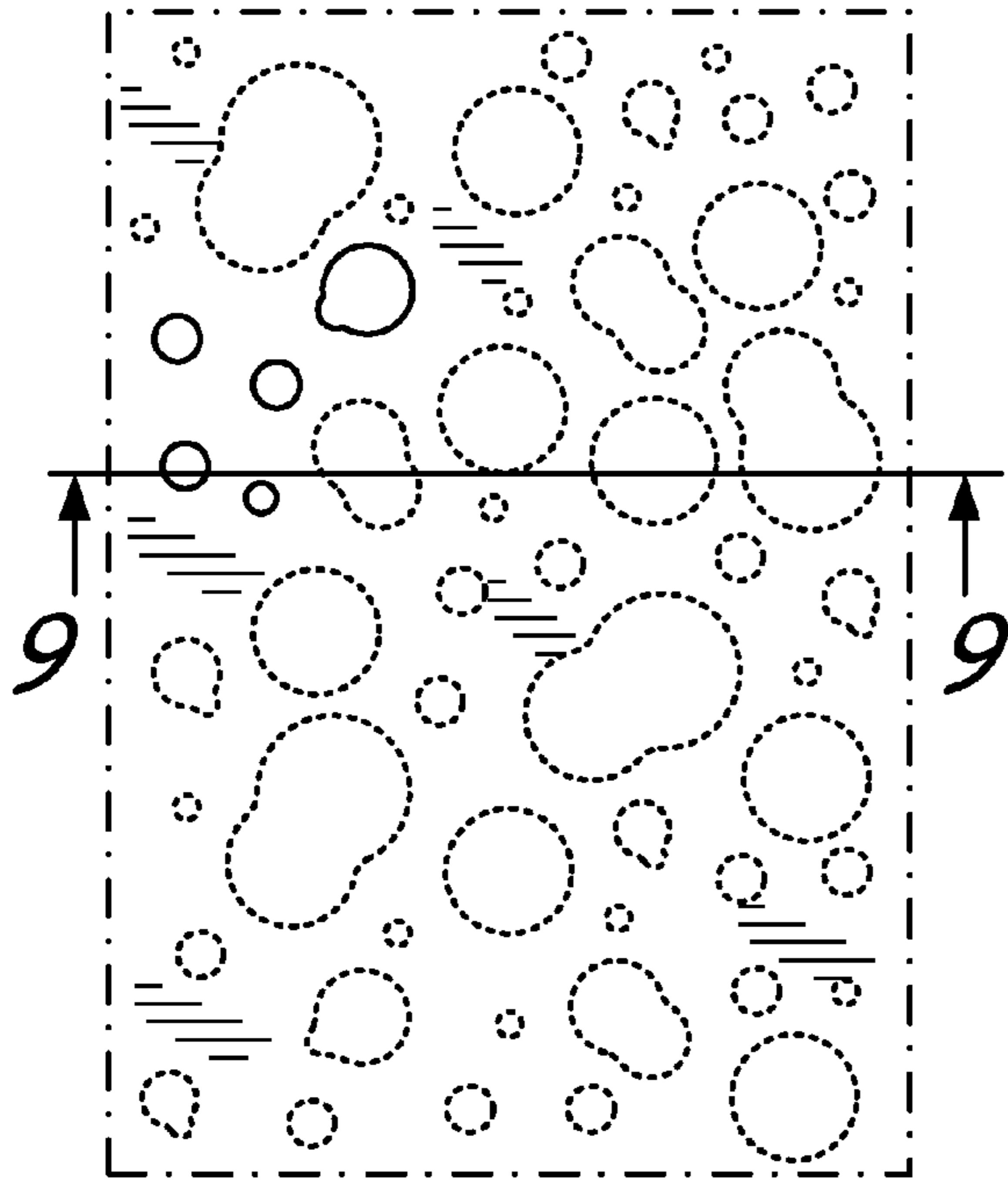

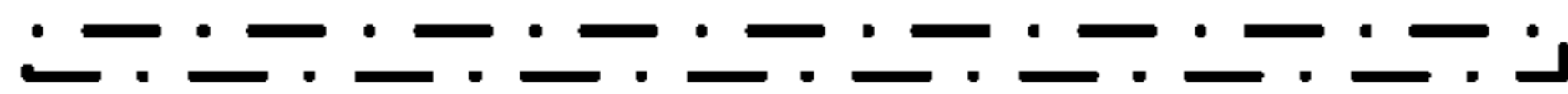

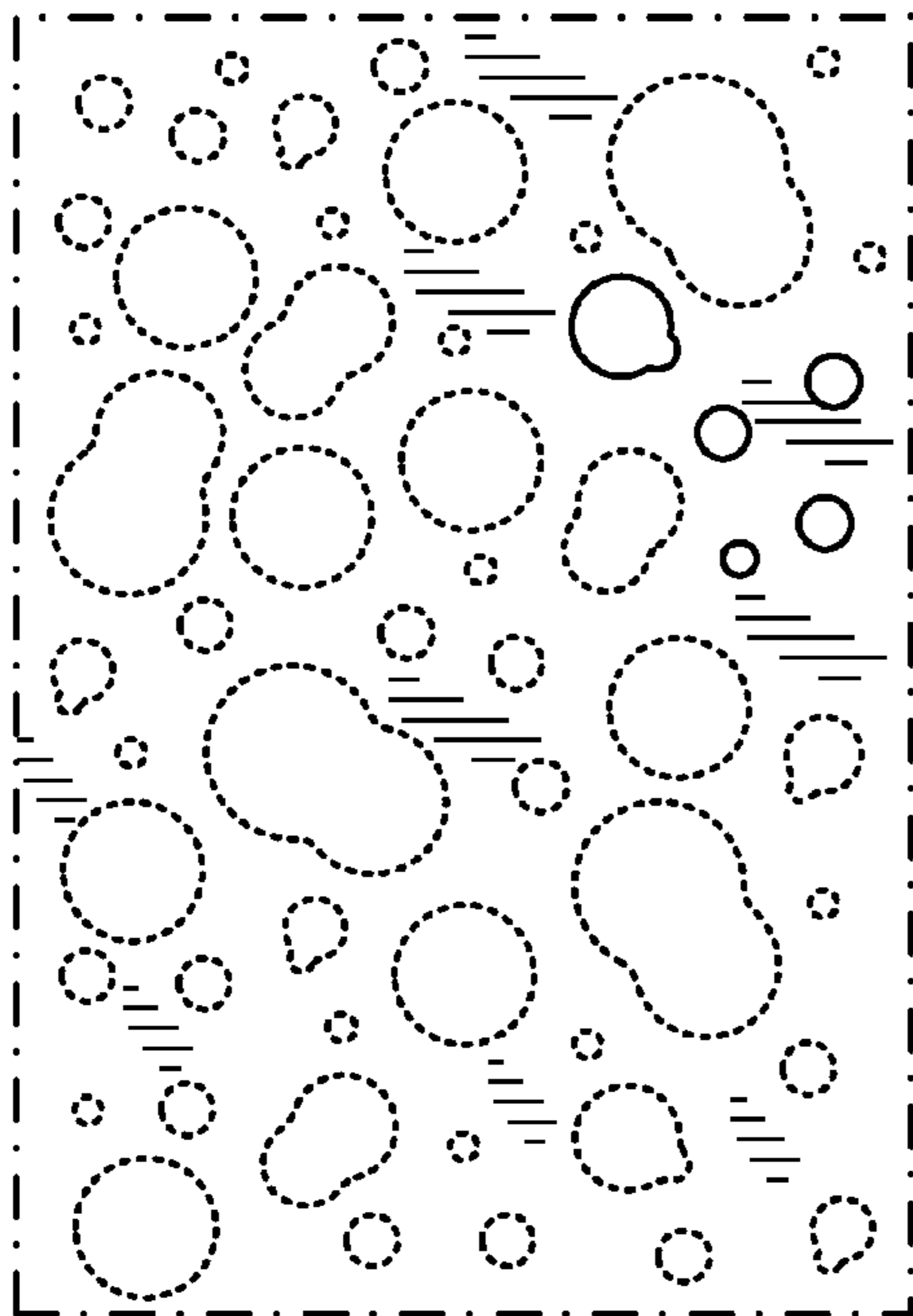
