(57) **CLAIM**

The ornamental design for the food press, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side elevation view of a food press showing my new design;  
FIG. 2 is a left side elevation view thereof, the right side being a mirror image thereof;  
FIG. 3 is a back side elevation view thereof;  
FIG. 4 is the left side elevation view of FIG. 2 with the piston of said press elevated in the cylinder thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is an elevated perspective view thereof.

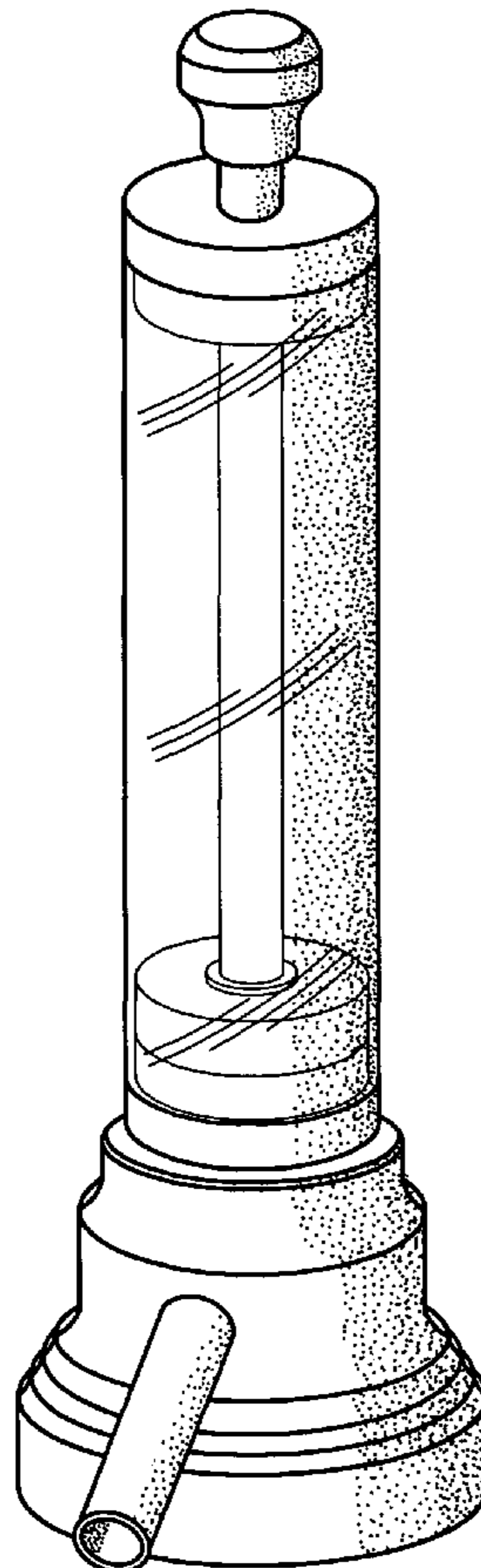

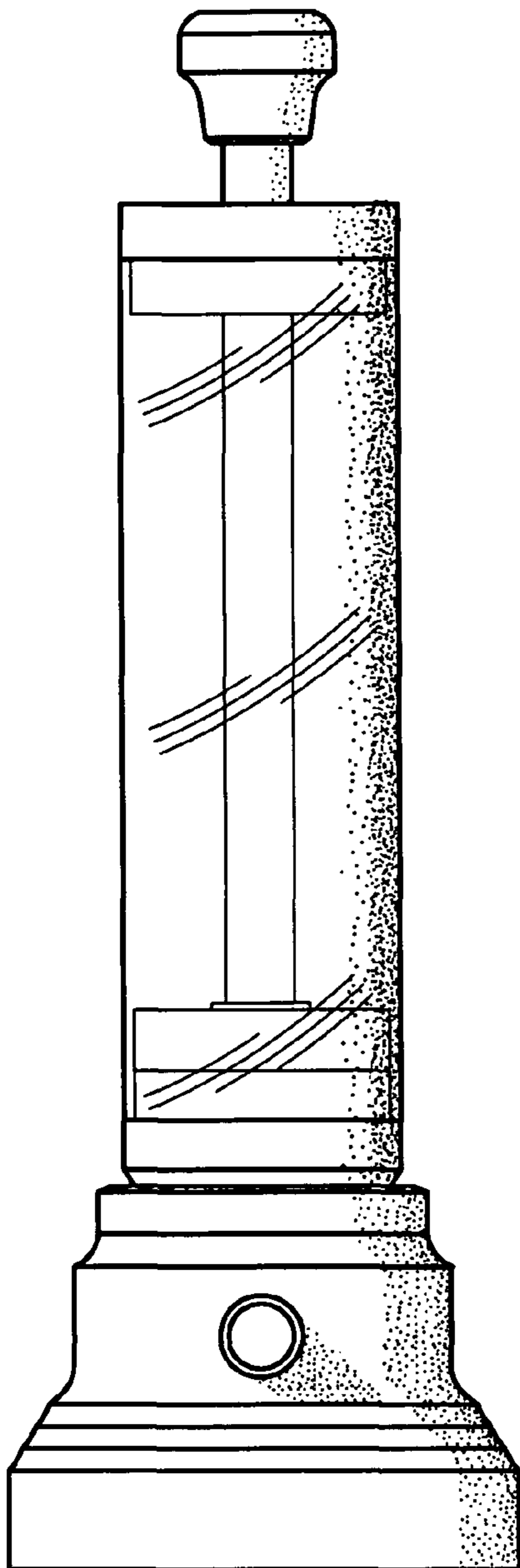

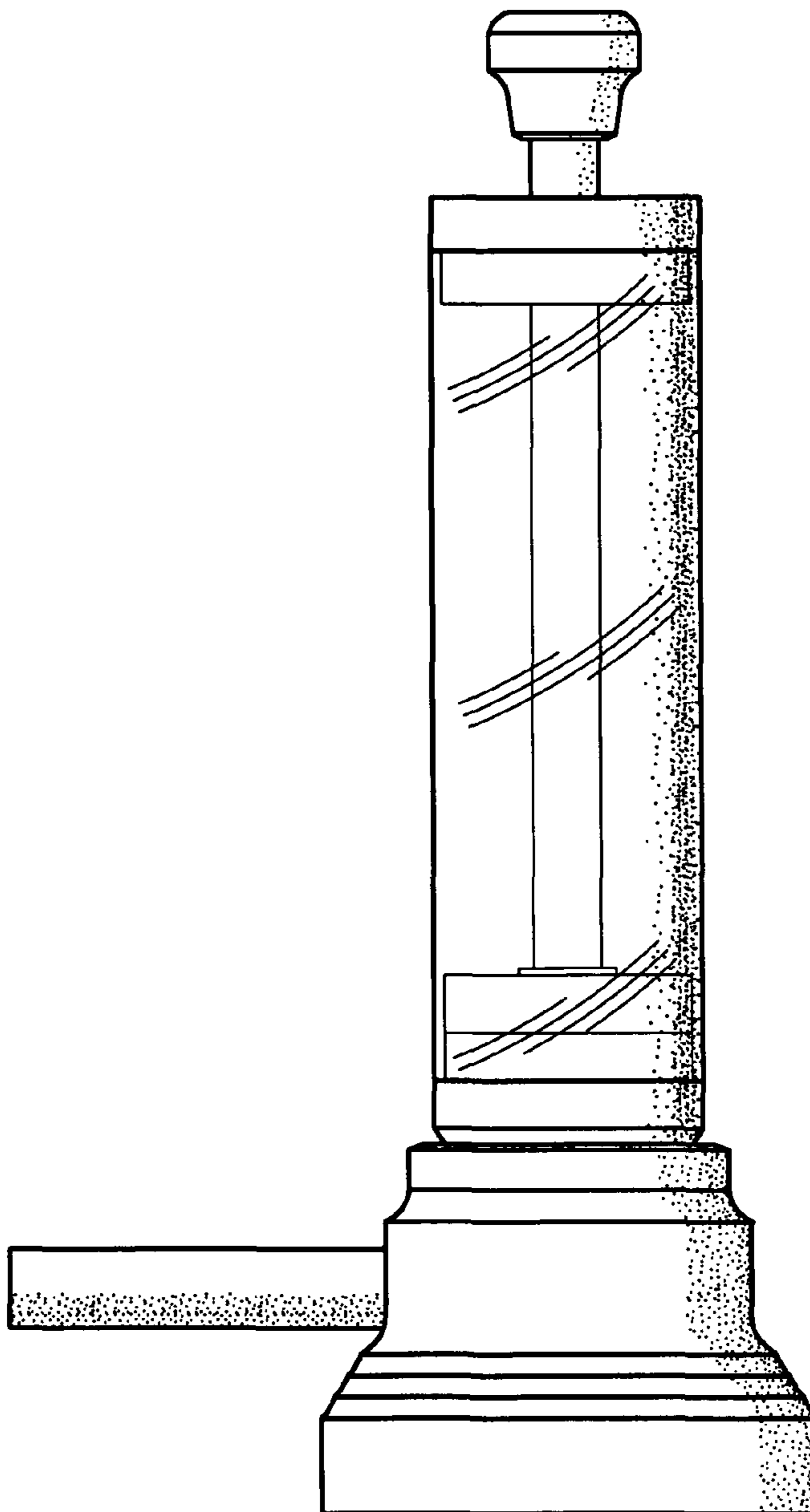

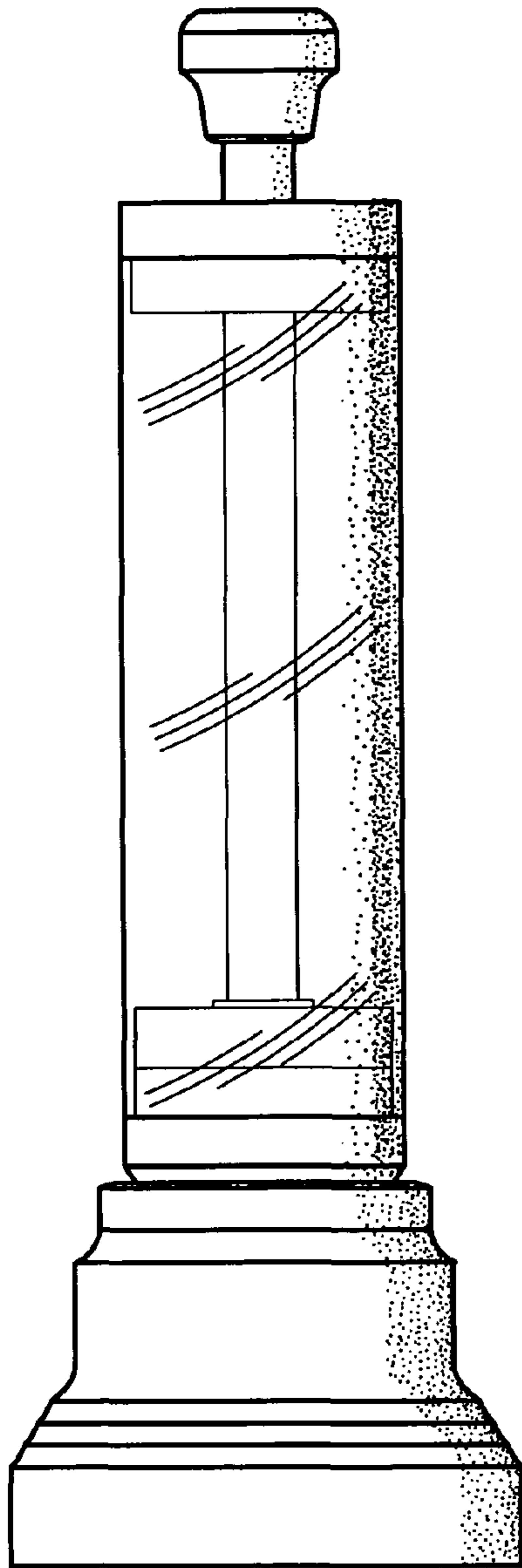

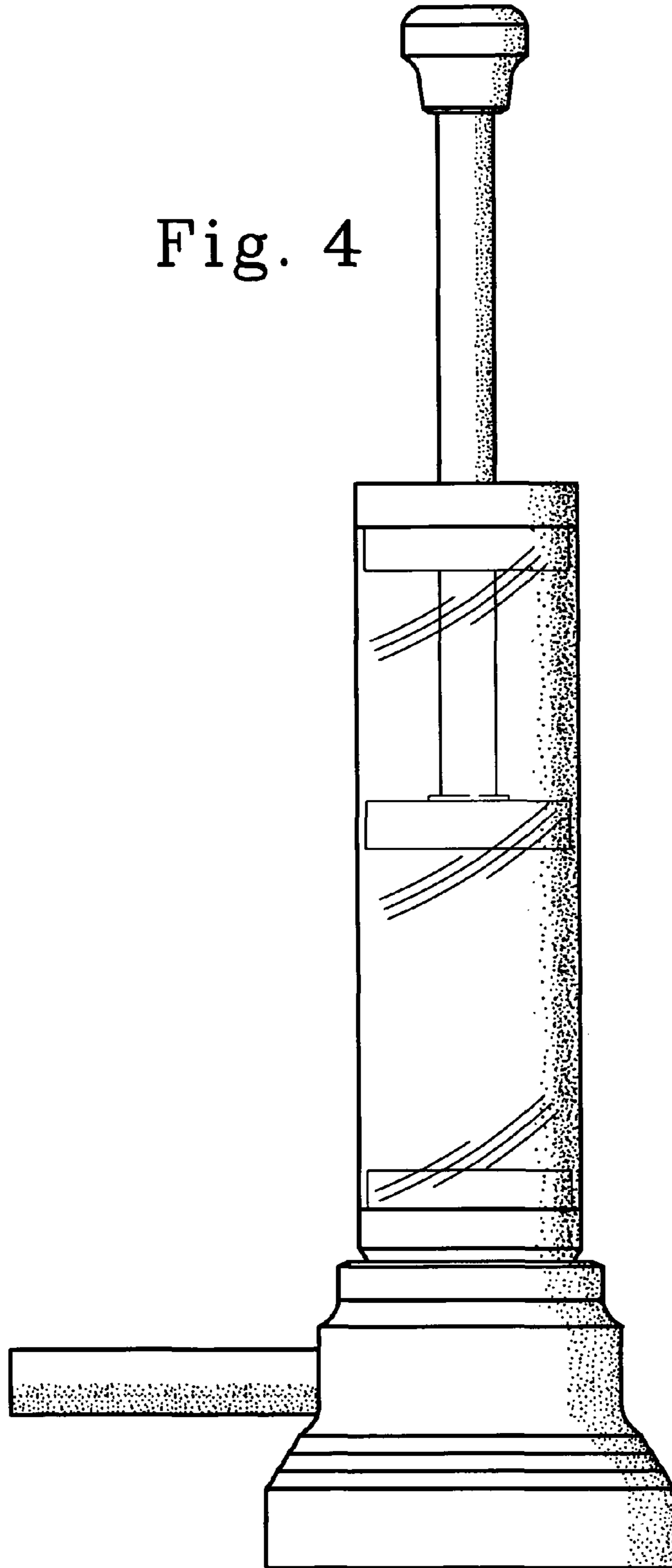

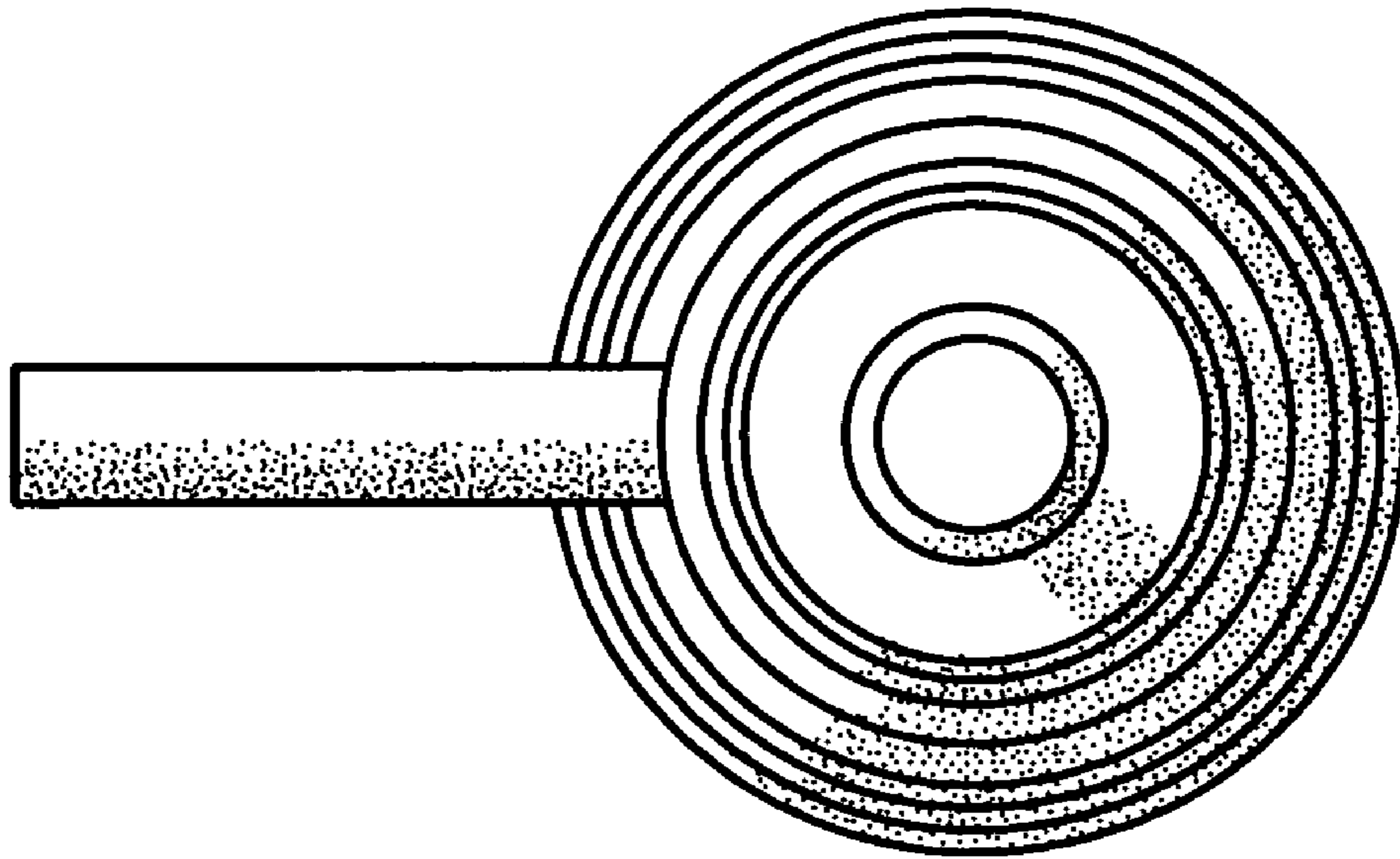

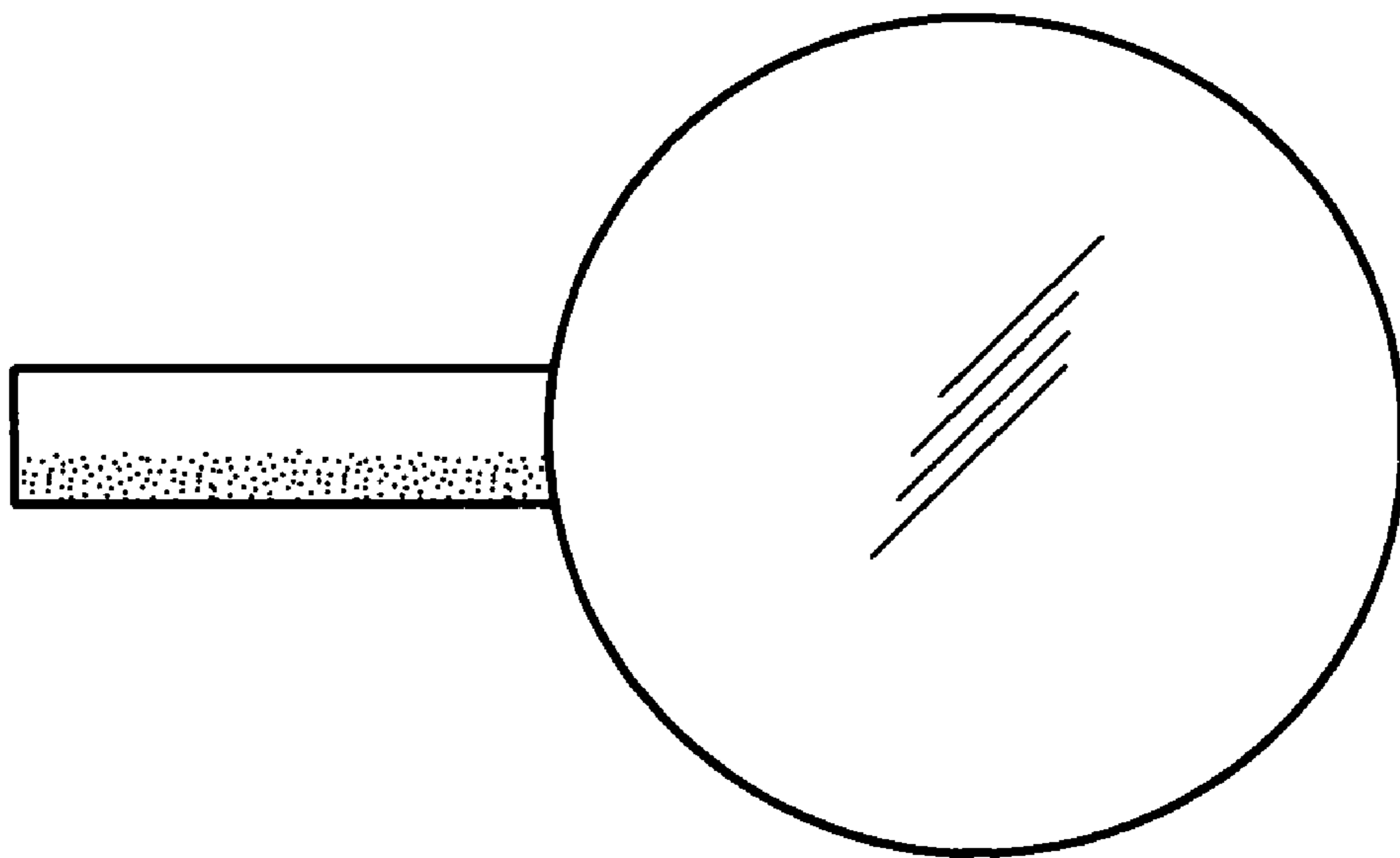
