The ornamental design for a bottle, as shown and described.

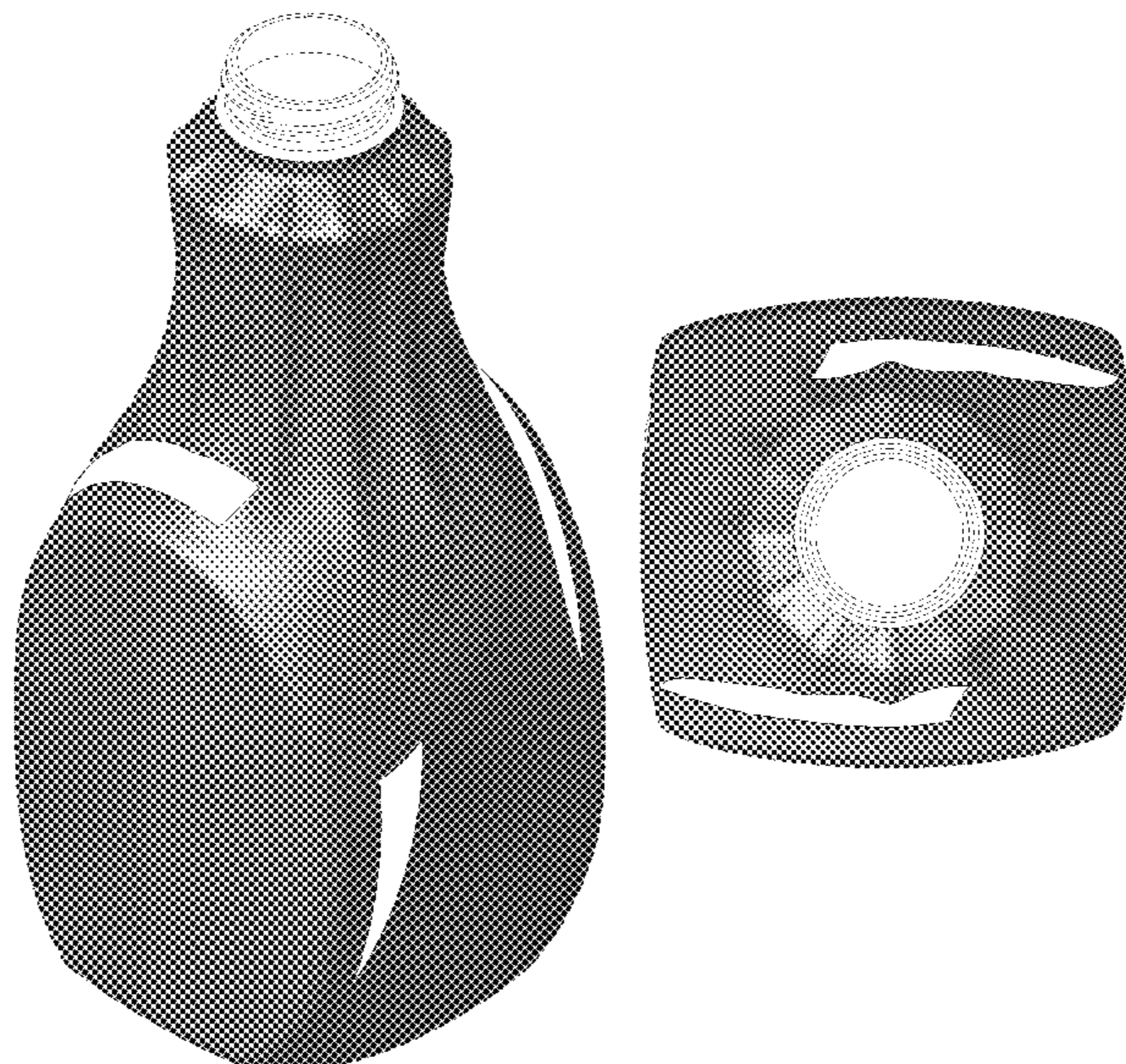
DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a bottle showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof; and,
FIG. 6 is a top plan view thereof.

The dash-dash-dash-type broken lines shown in the drawing views are included for the purpose of illustrating environmental structure and form no part of the claimed design.

The dot-dash-dot-dash-dot-dash type broken lines shown in the drawing views define the unclaimed boundaries of the claimed design.

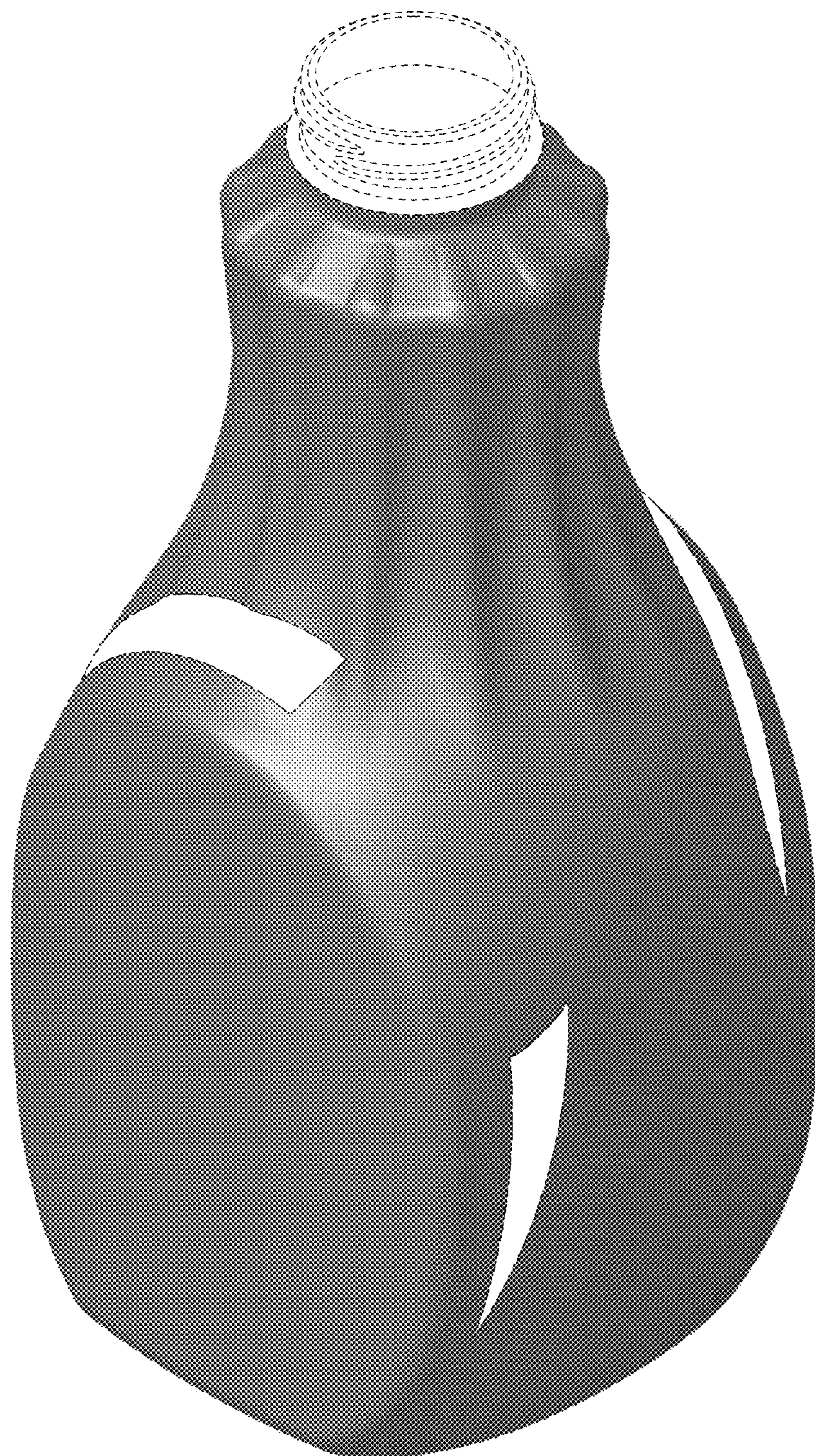

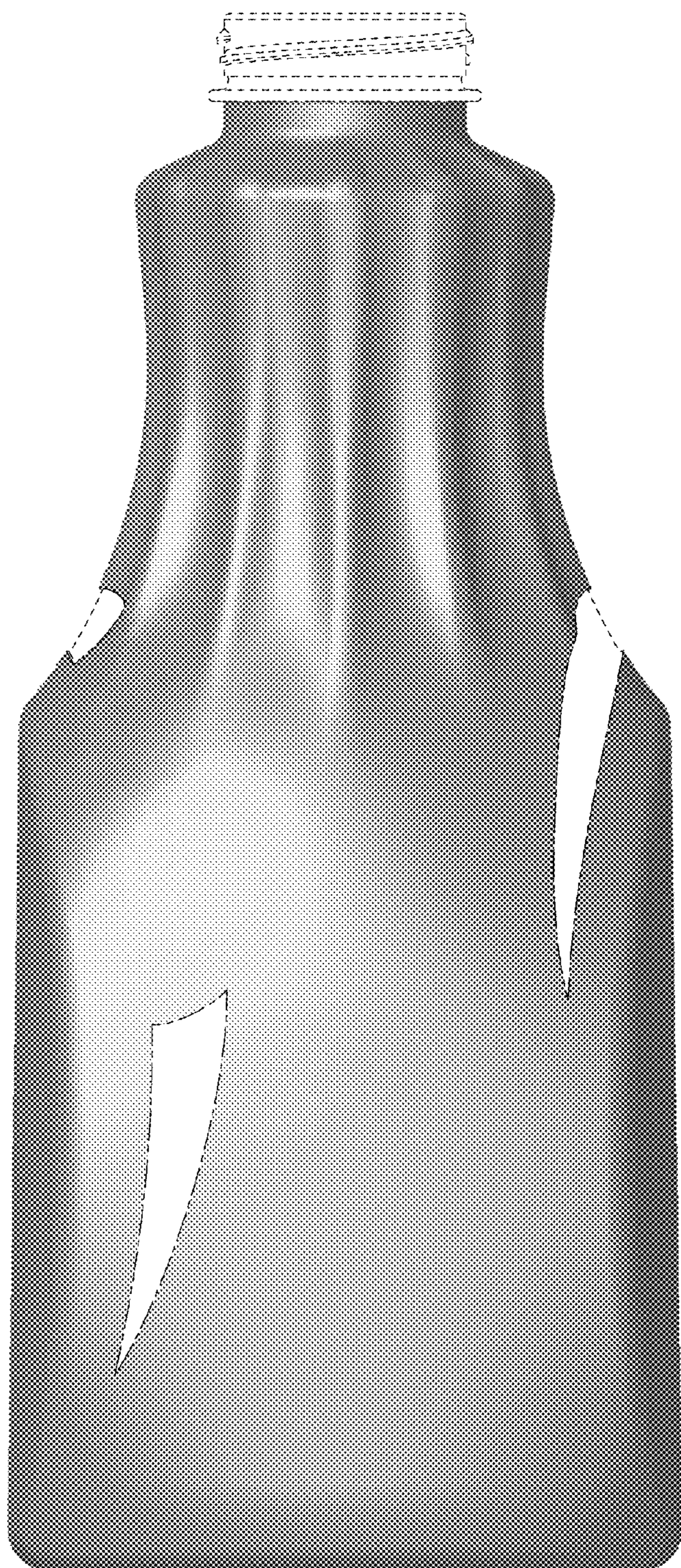

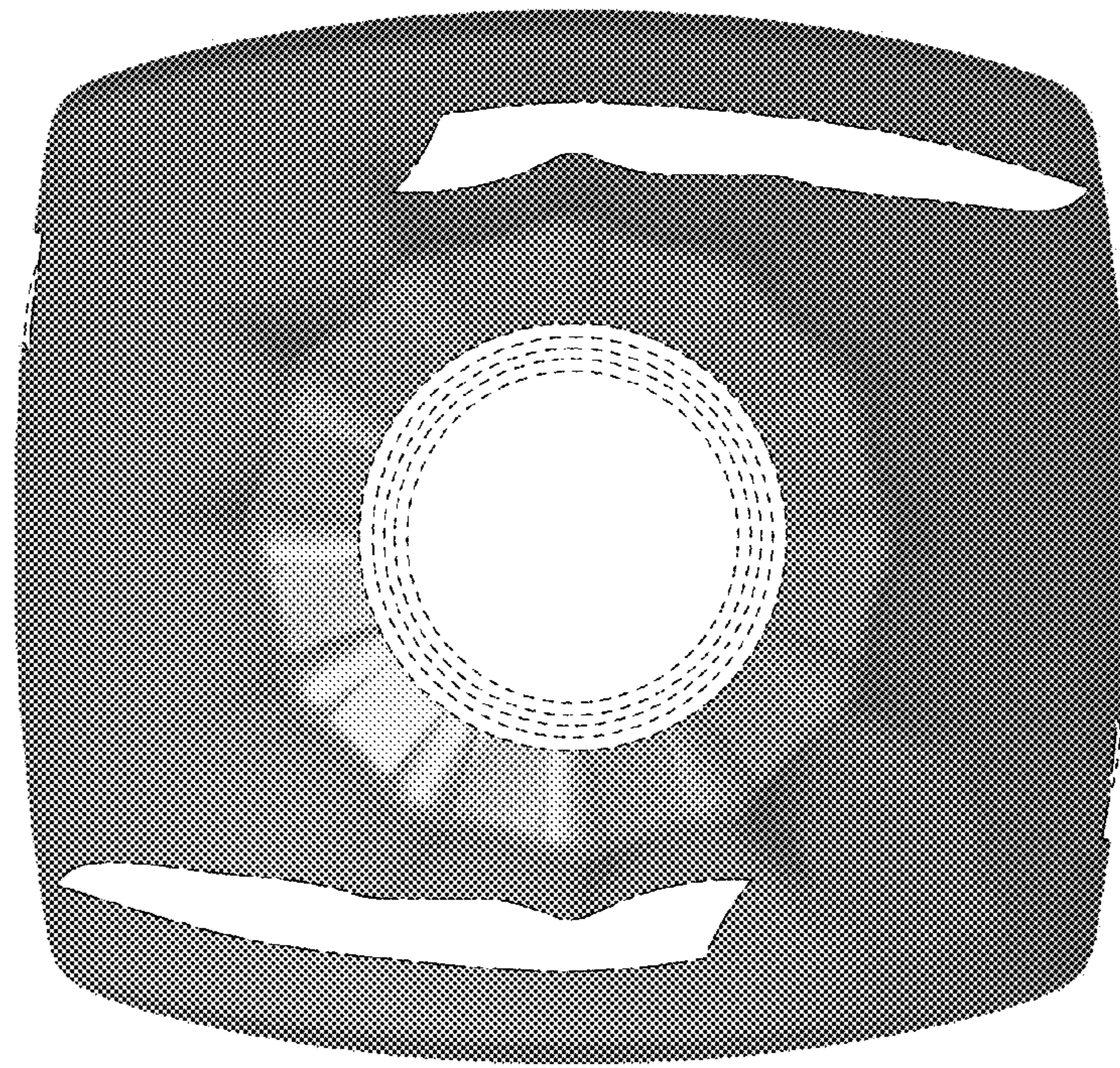
