FIG. 18 is a front view thereof;

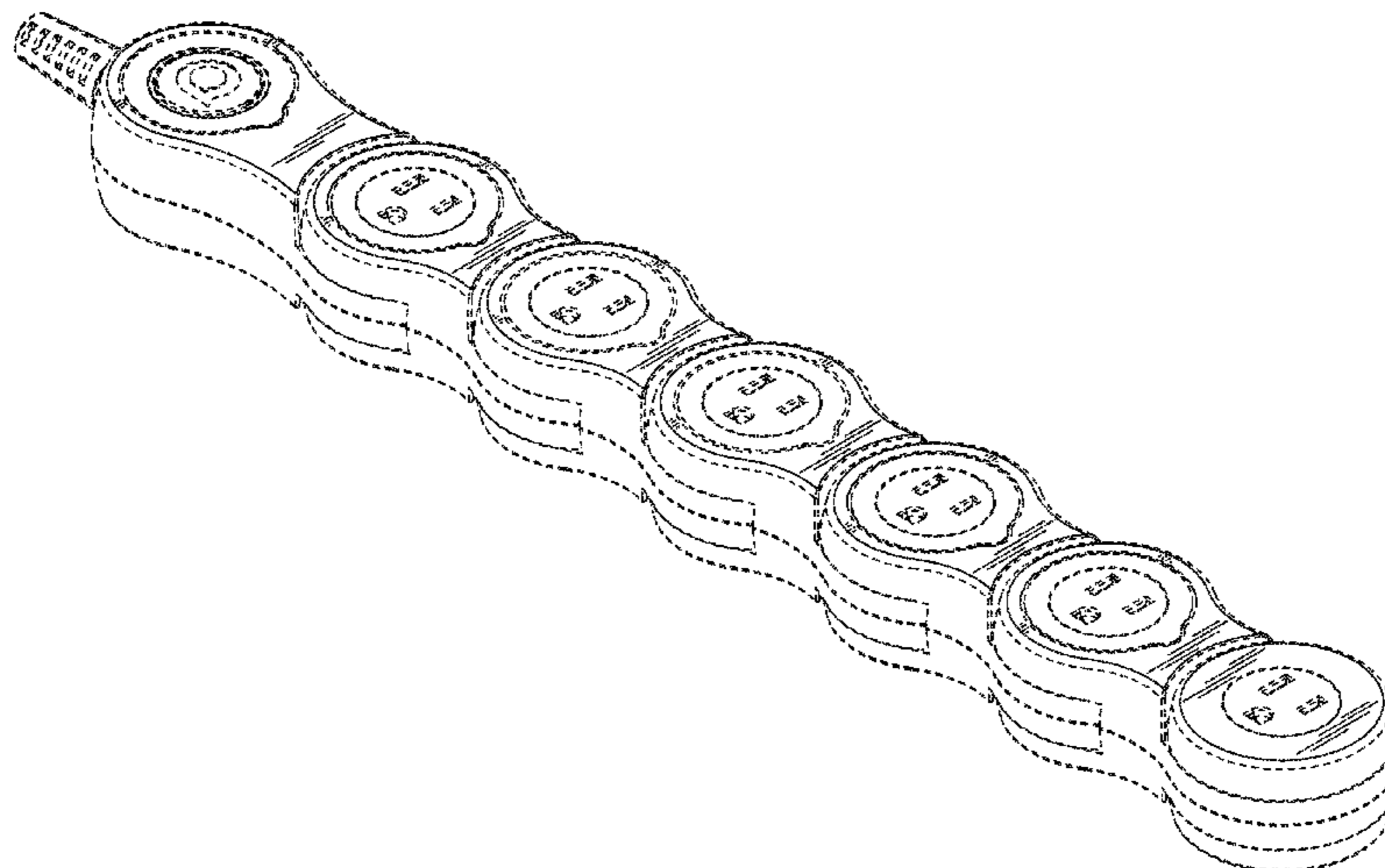
FIG. 19 is a back view thereof;

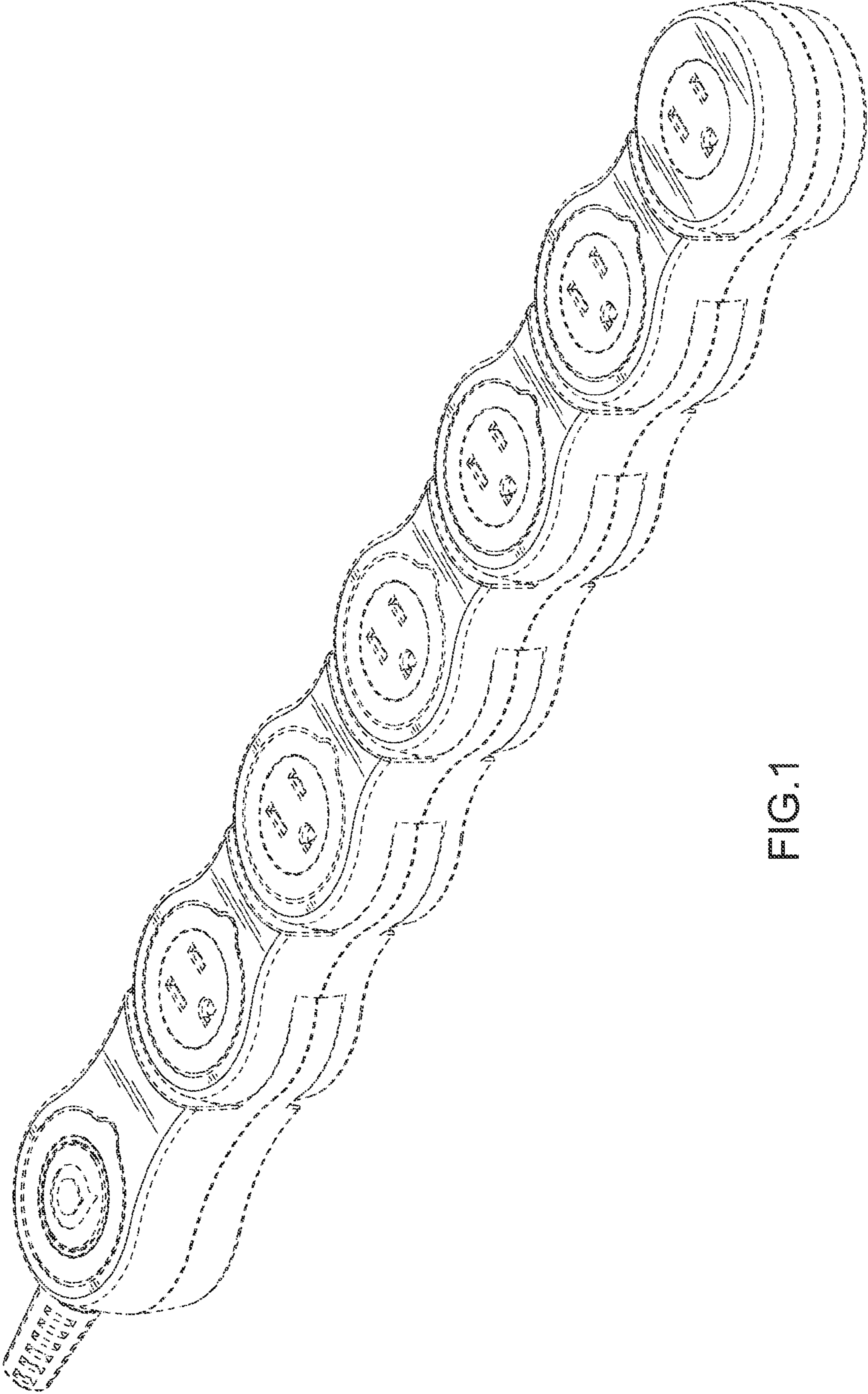

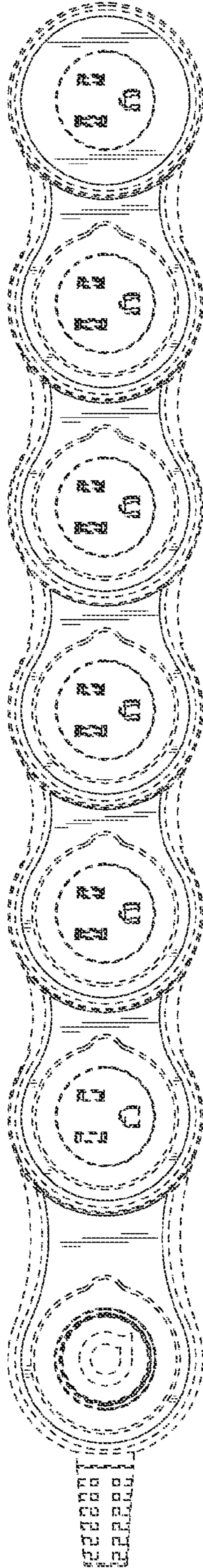

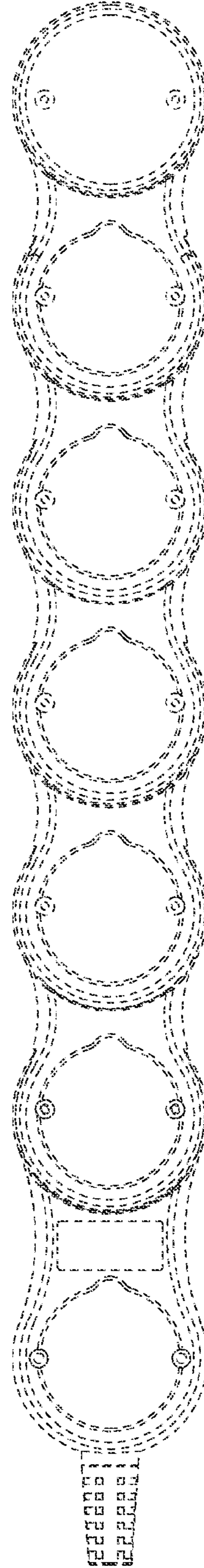

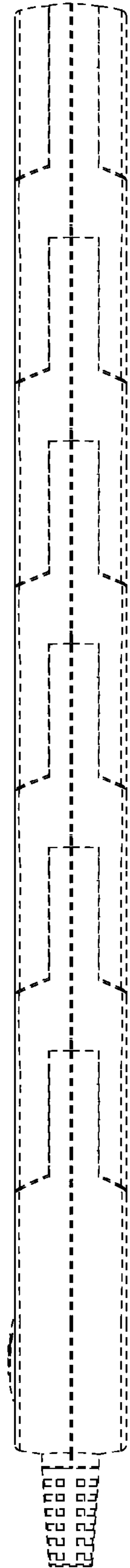

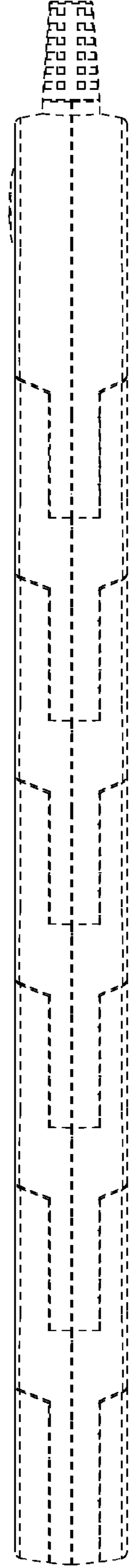

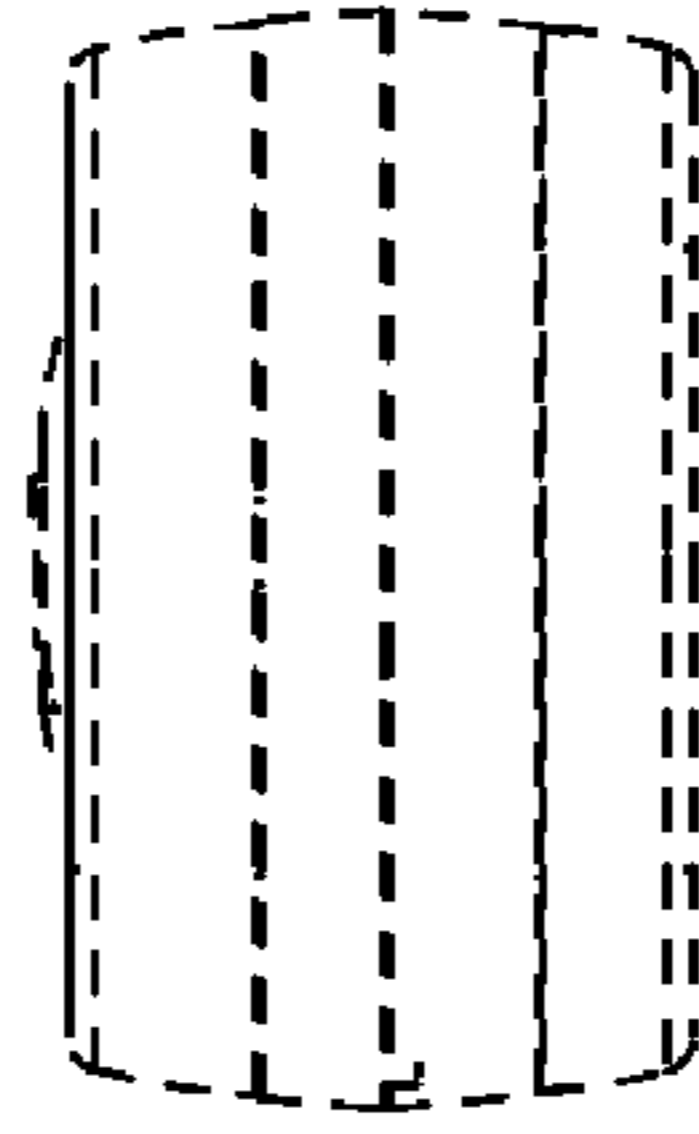

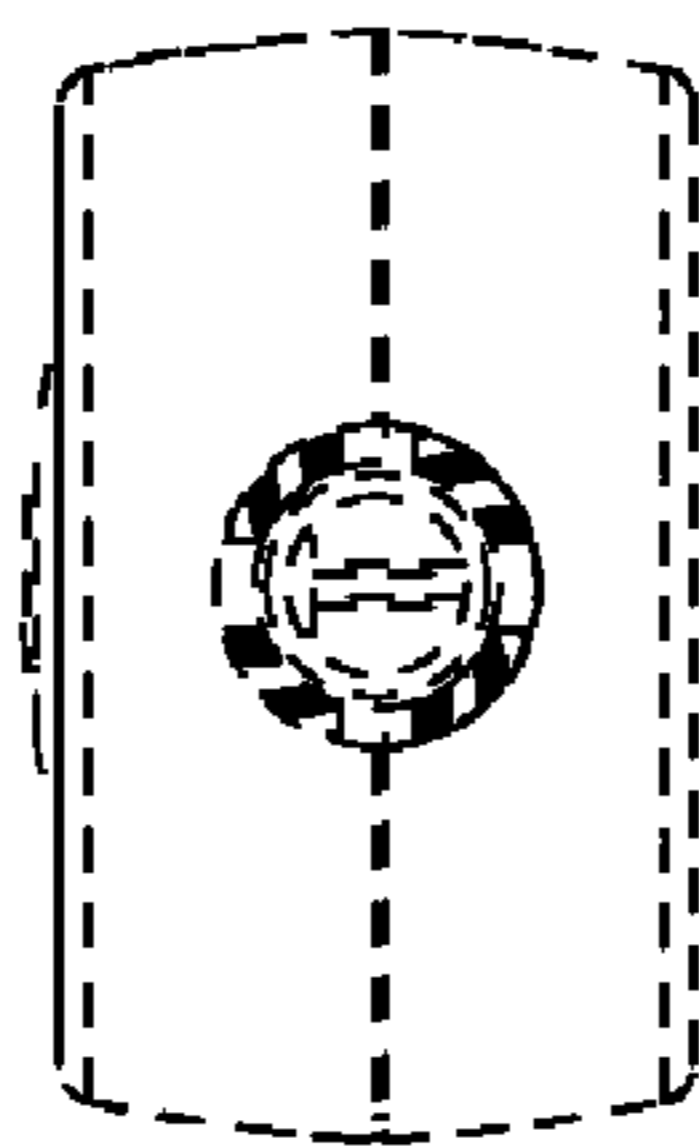

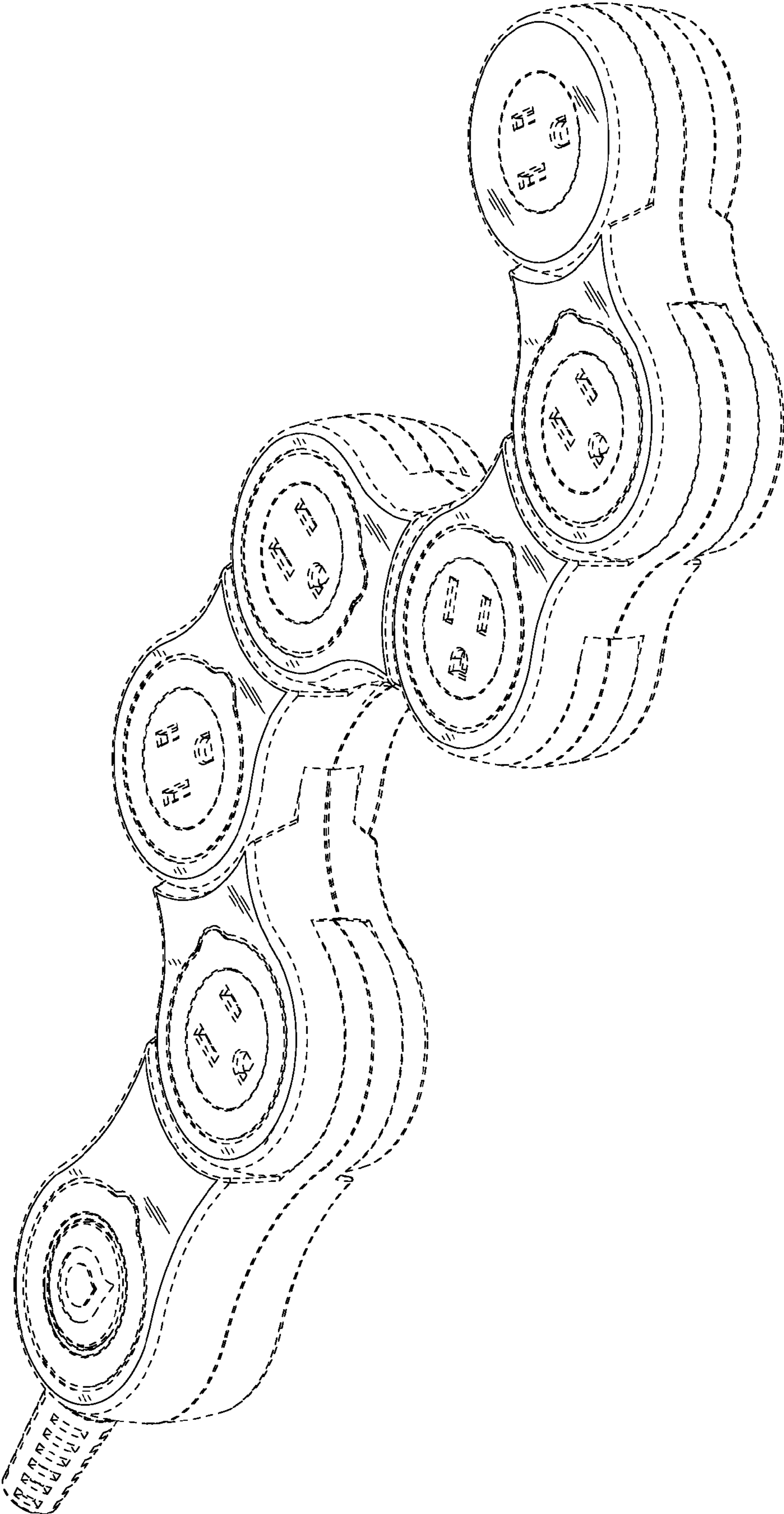

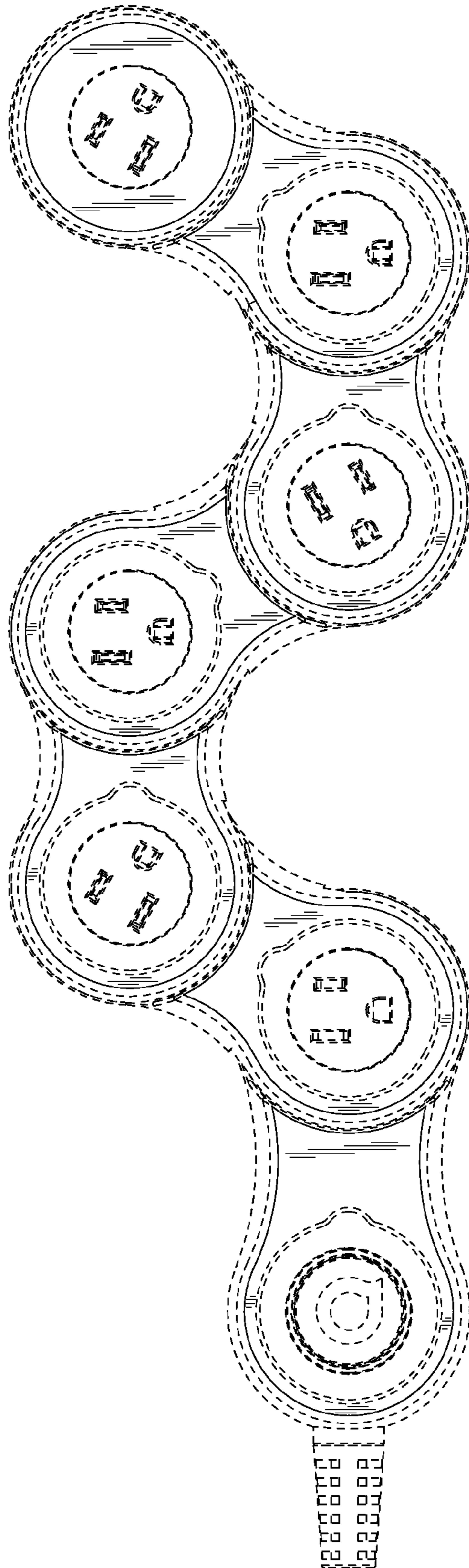

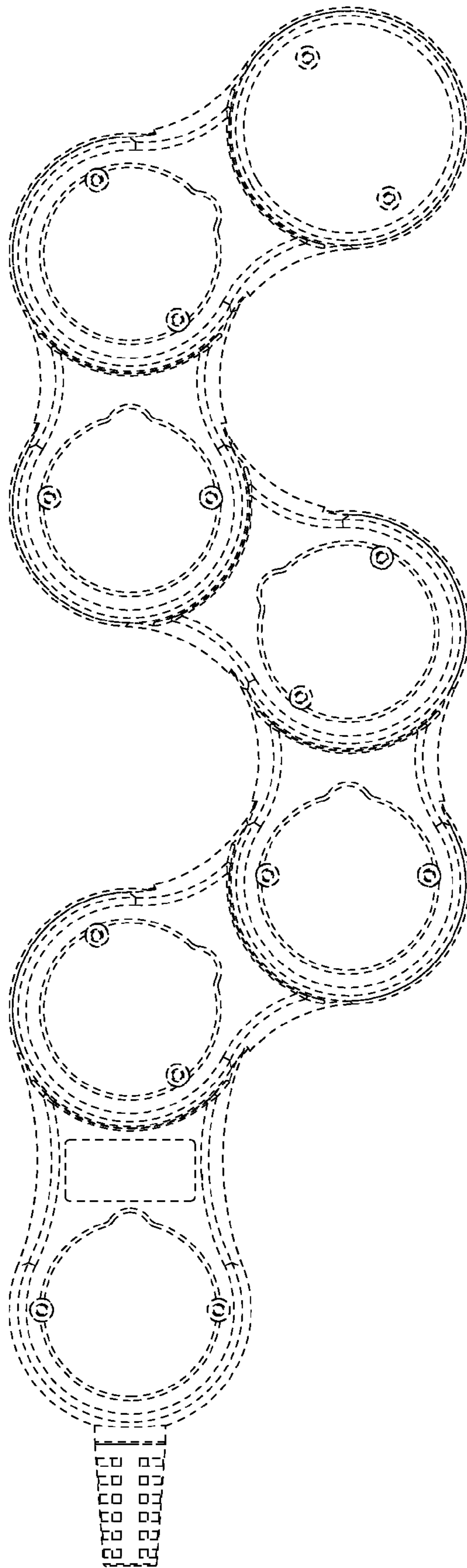

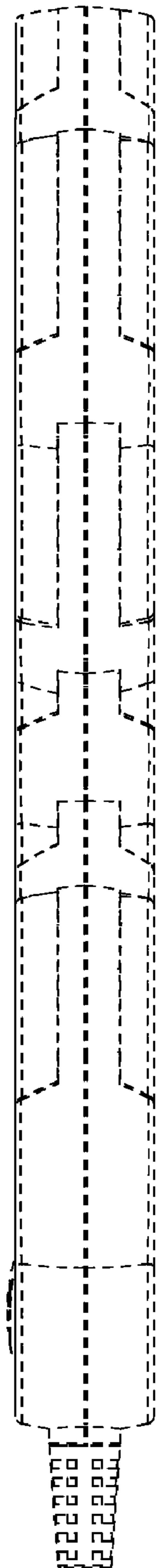

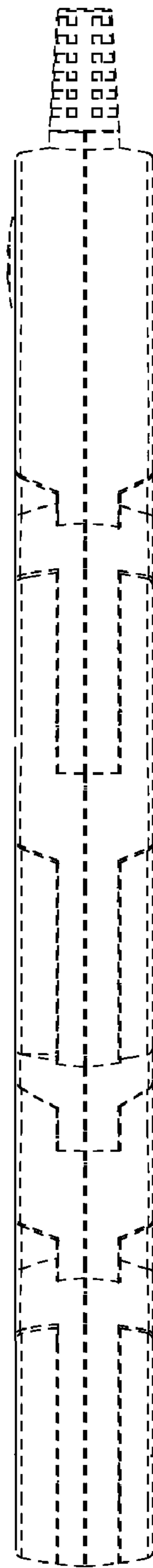

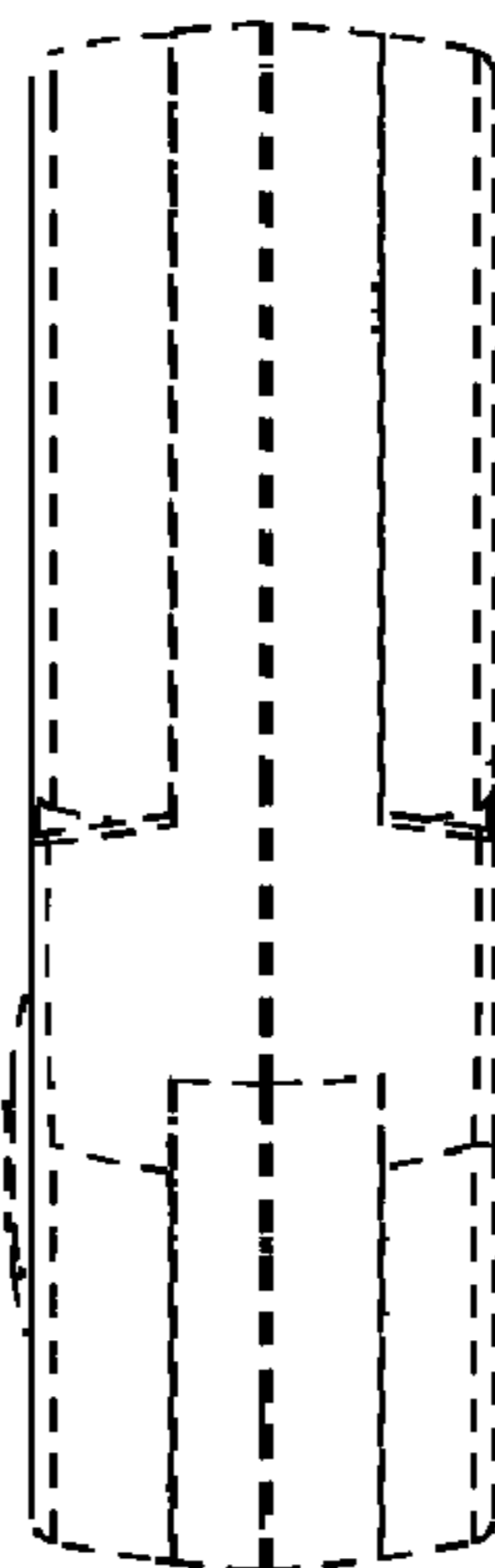

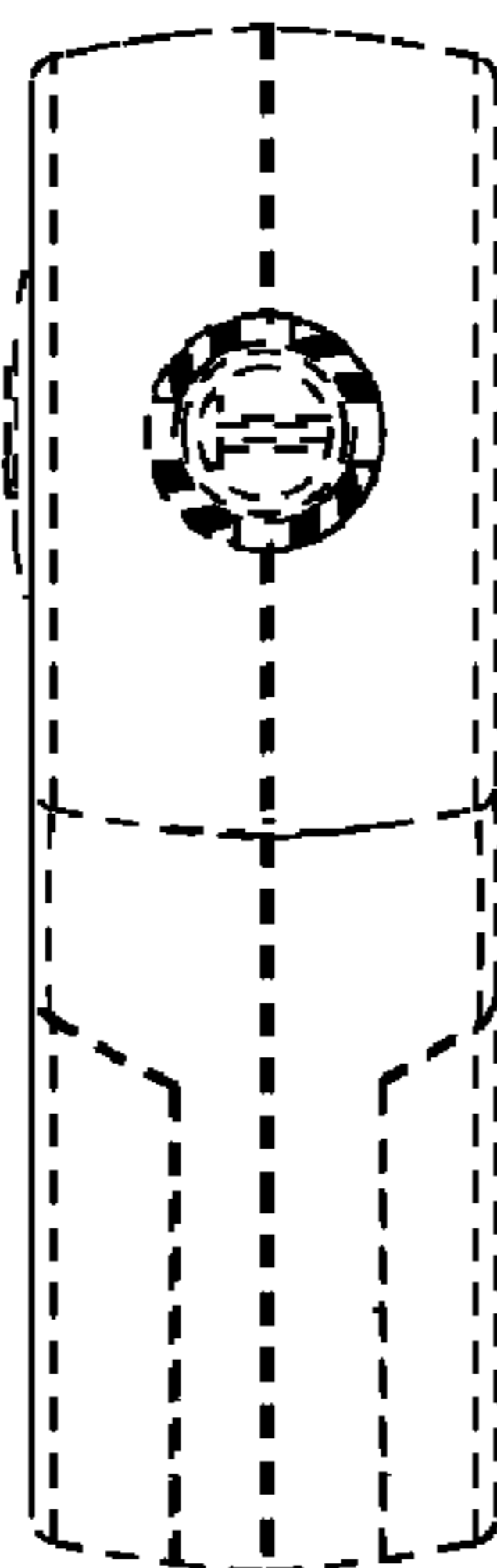

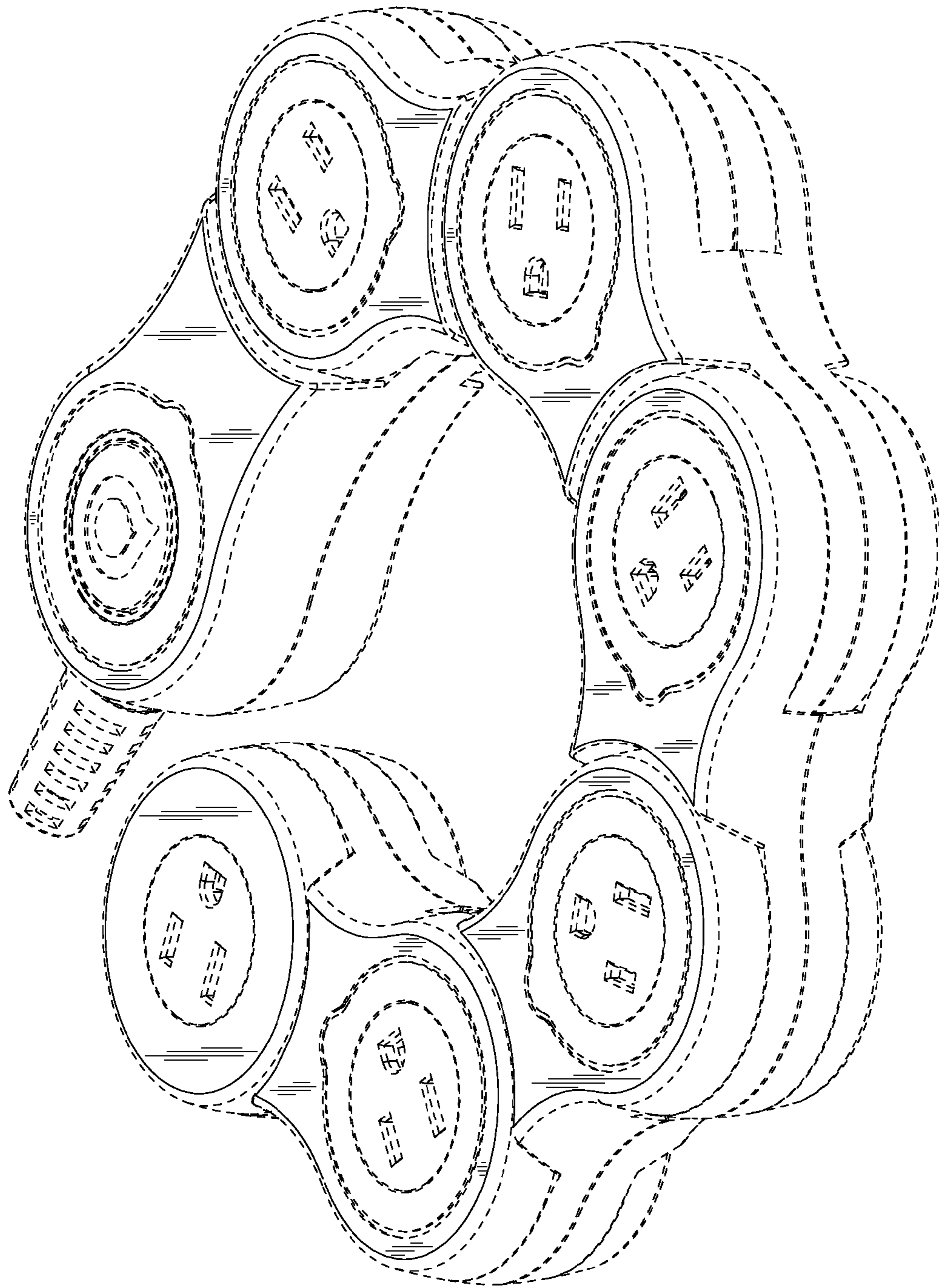

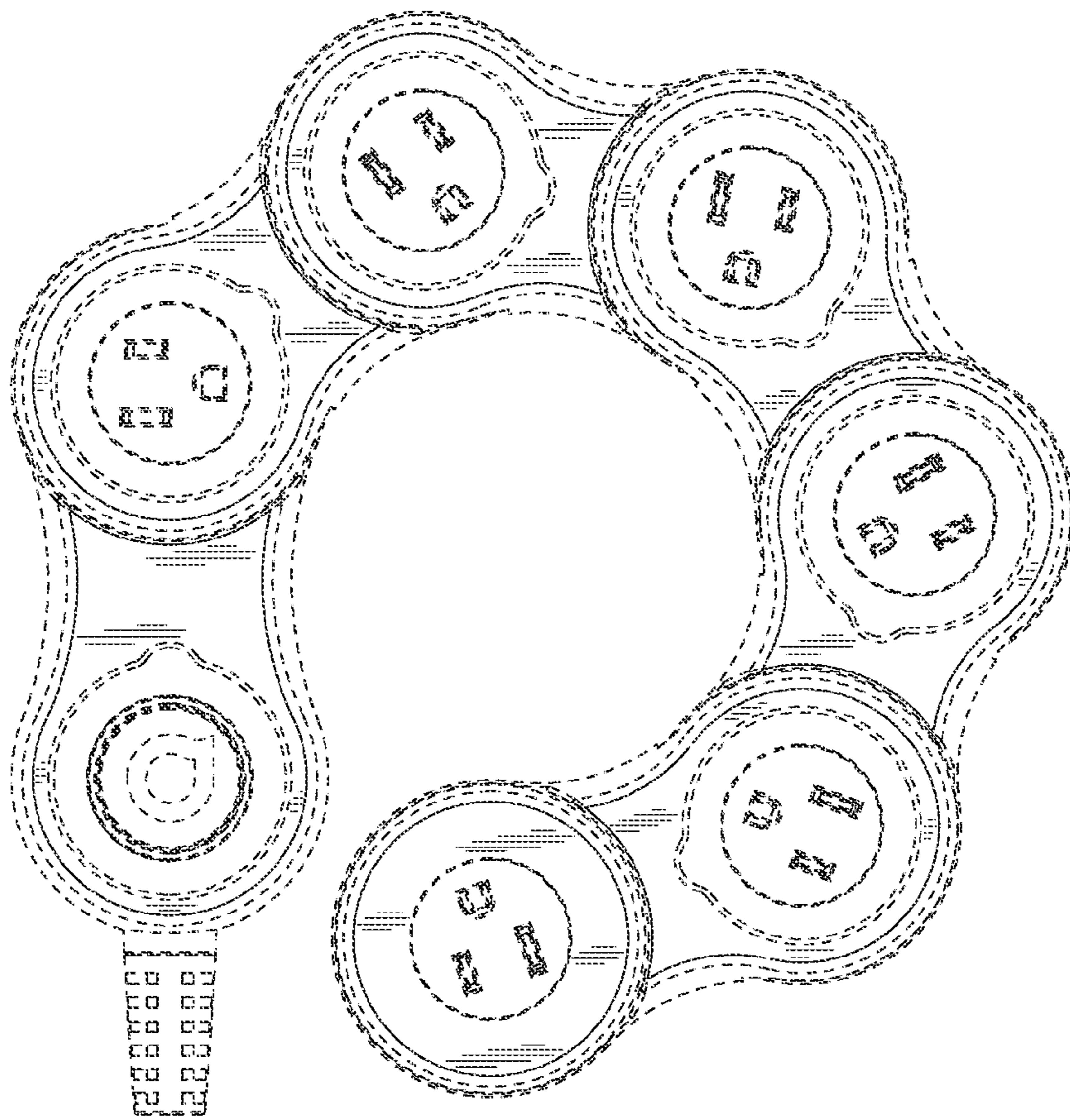

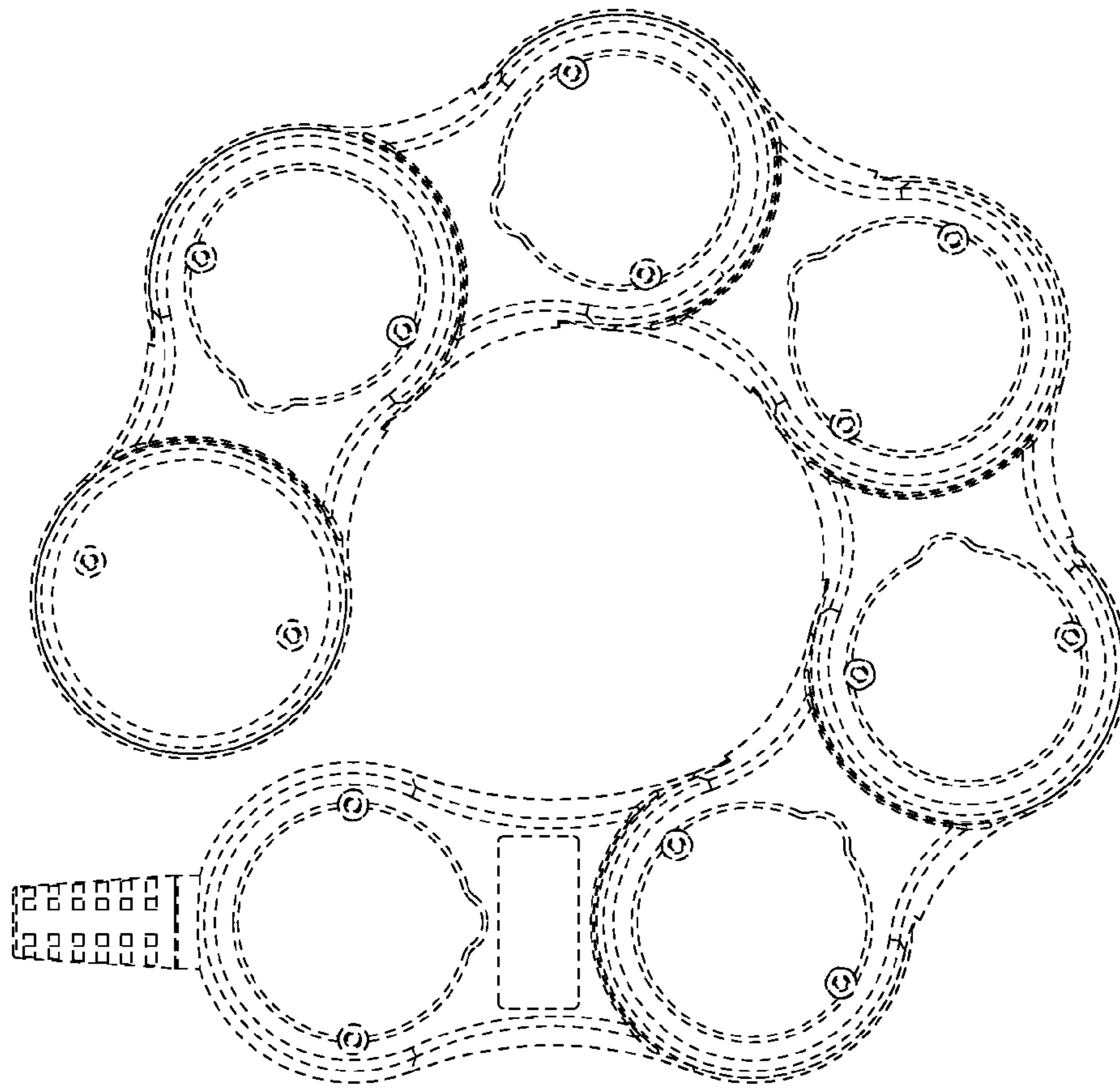

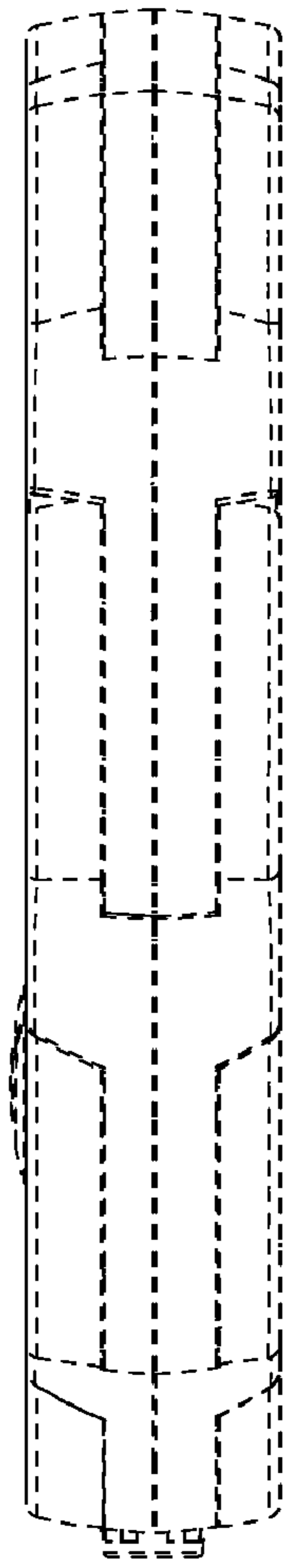

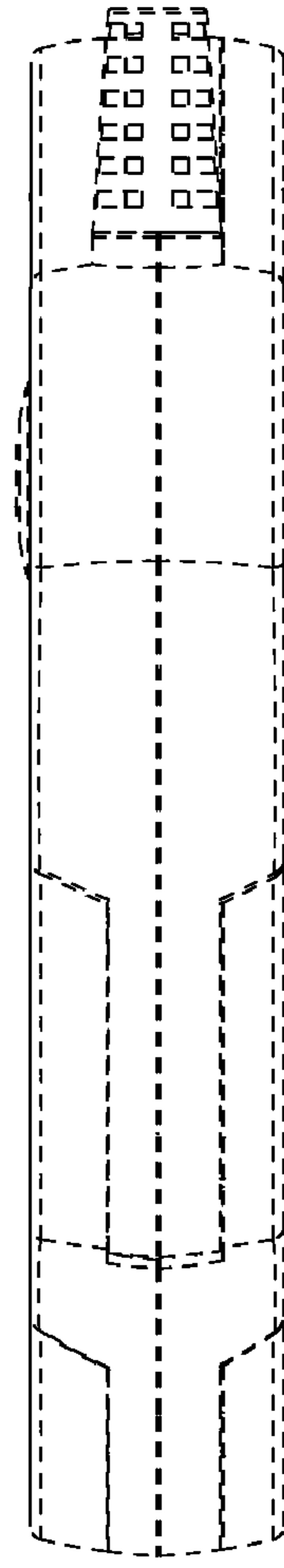

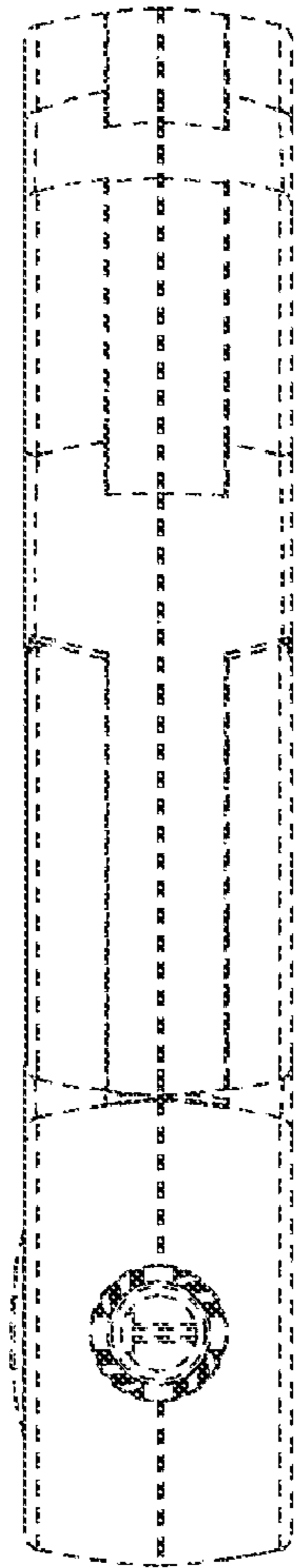

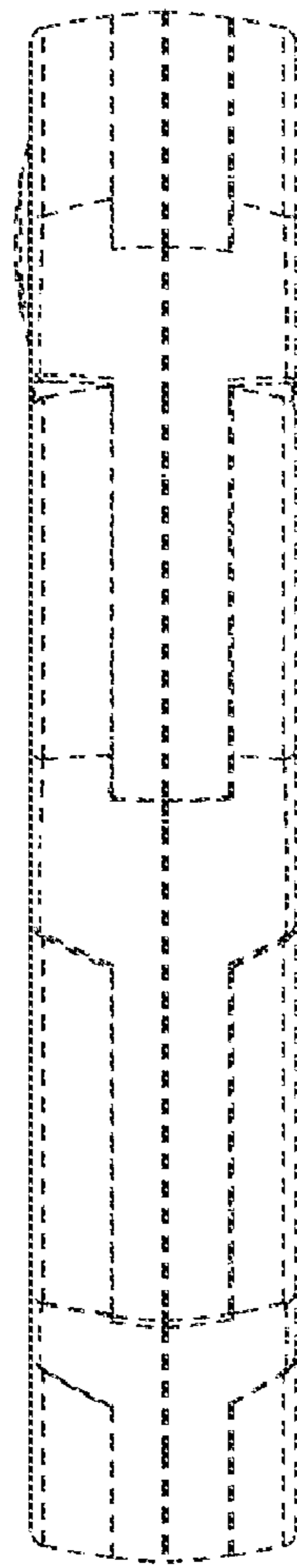
