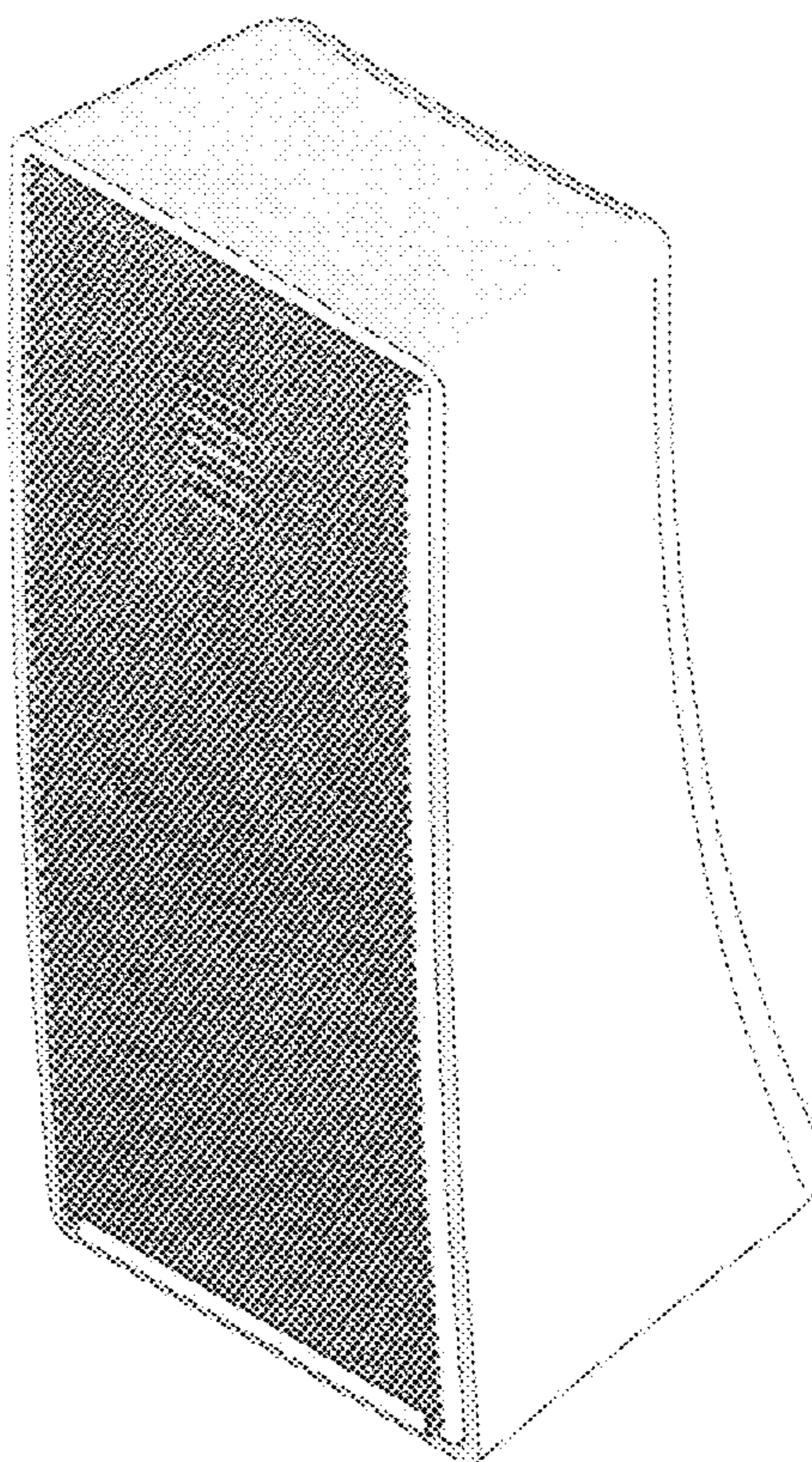
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top front and right side perspective view of the speaker showing our new design;  
FIG. 2 is a top back and right perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a right-side elevational view thereof, the left side being a mirror image;  
FIG. 5 is a rear elevational view thereof;

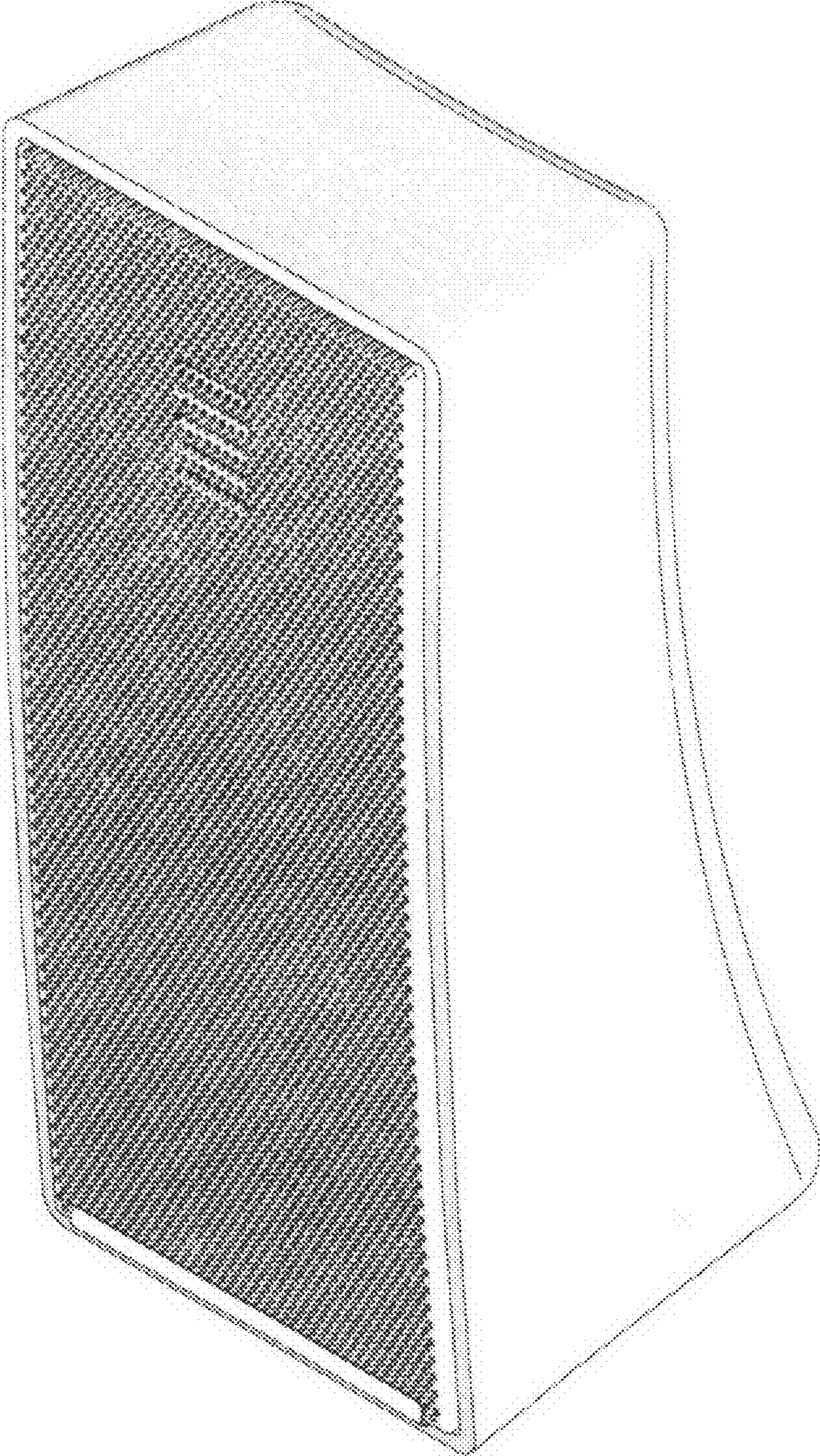

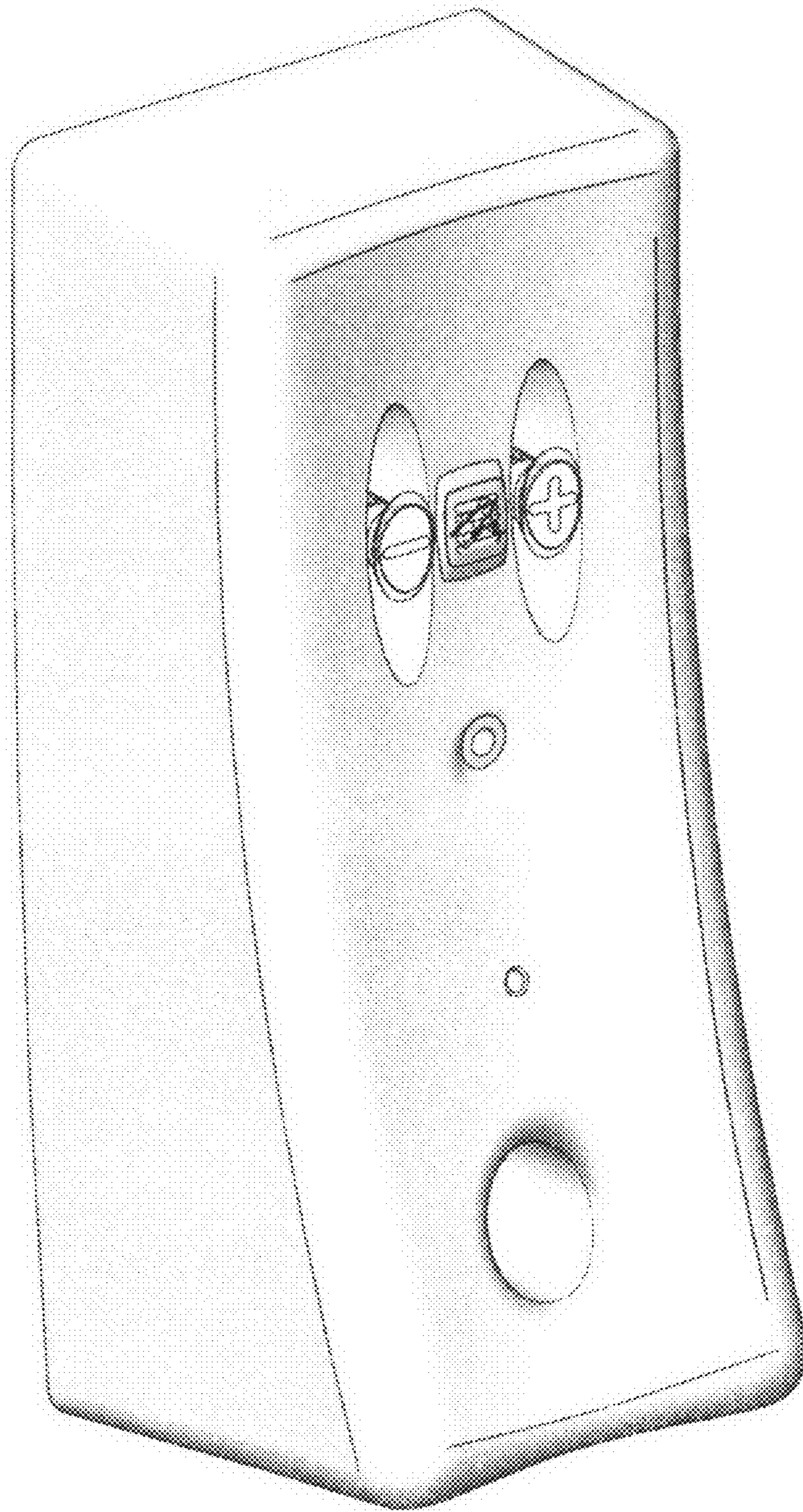

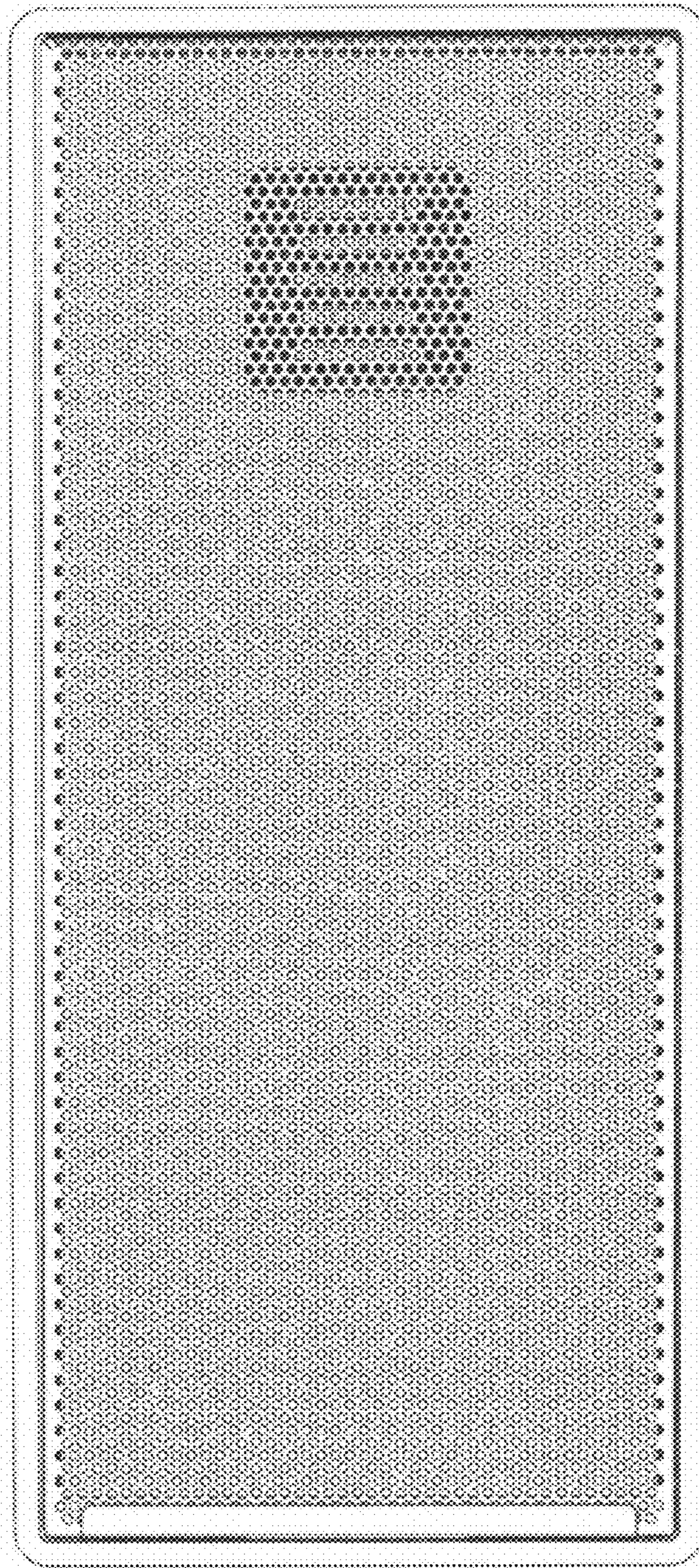

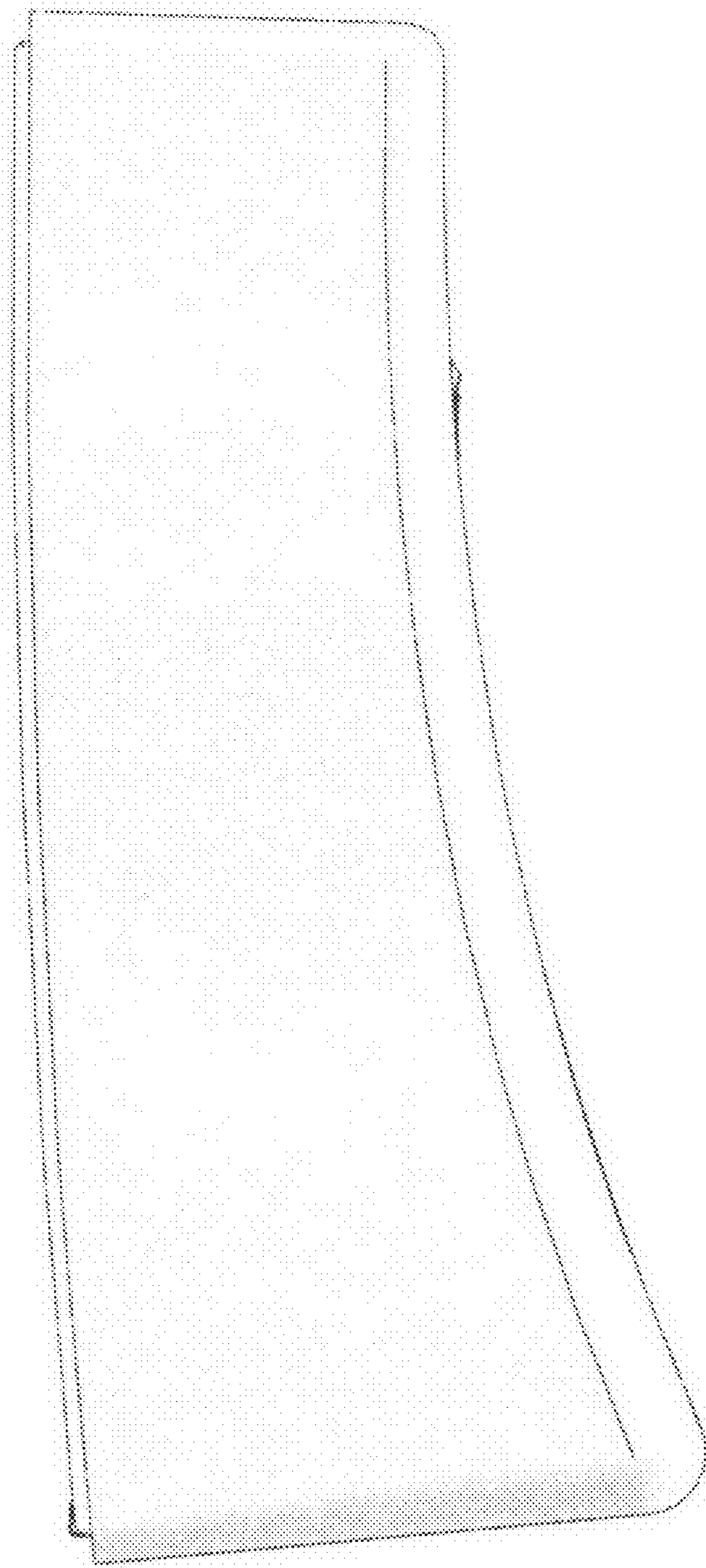

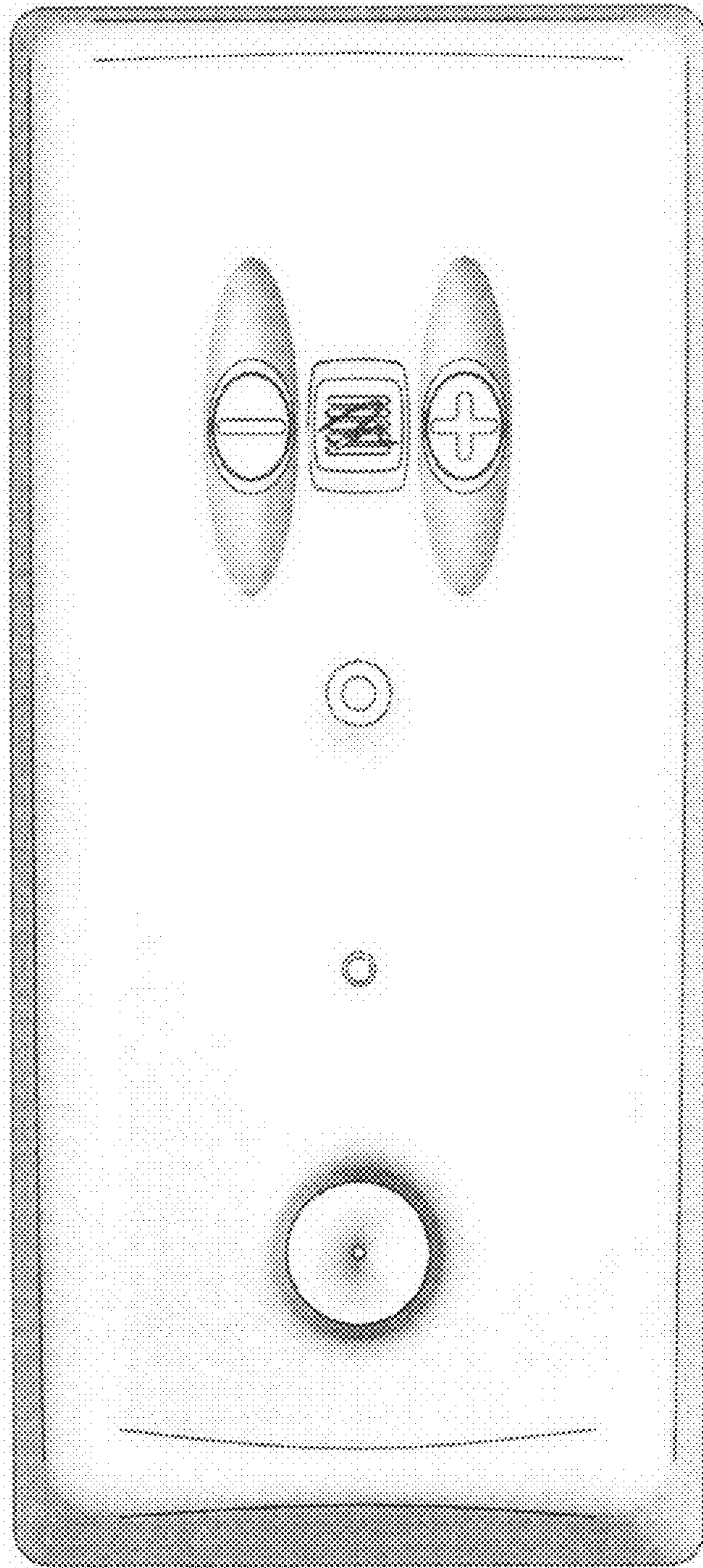

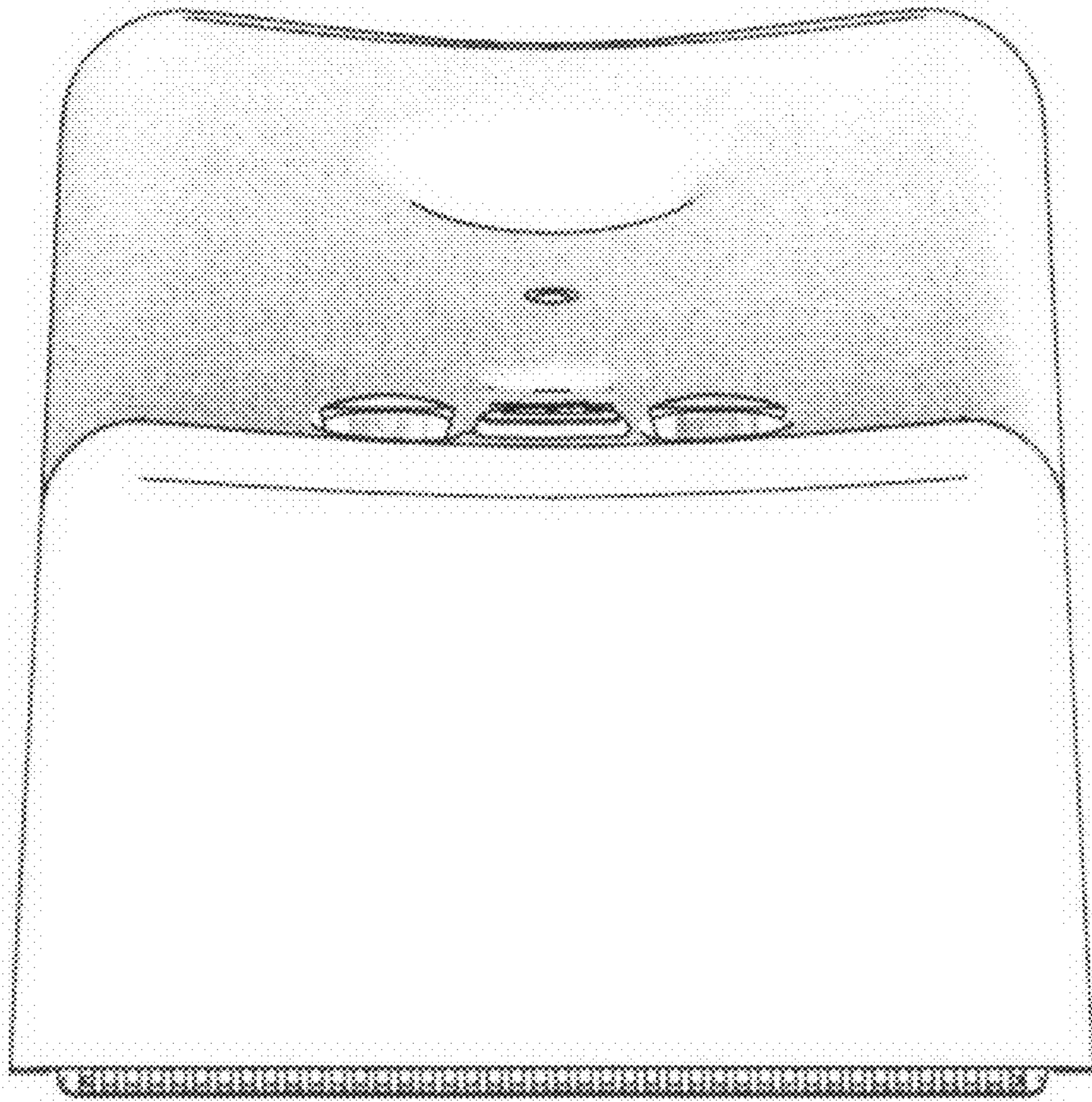

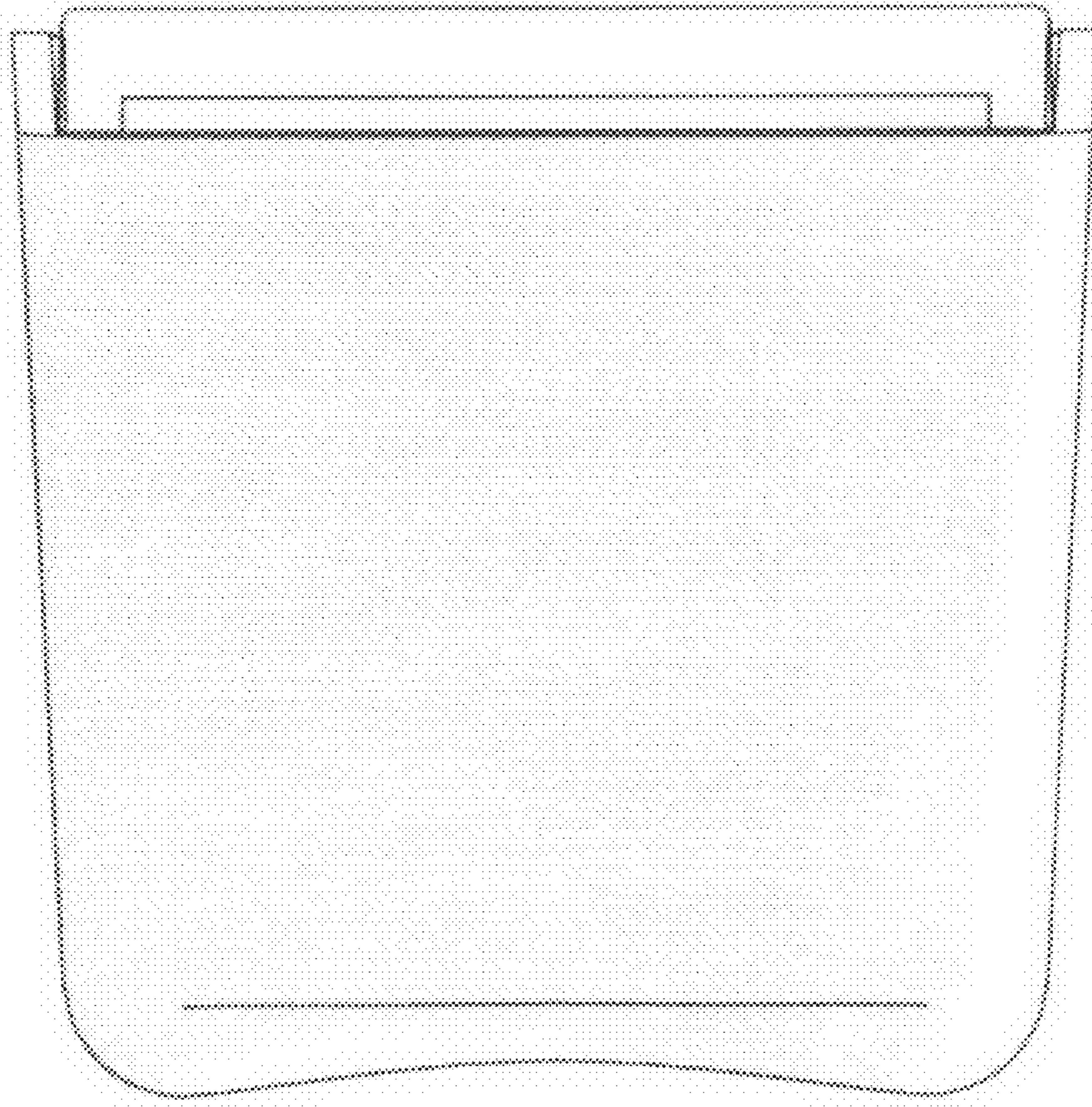
