DESCRIPTION

FIG. 1 is a front, side perspective view of a laptop computer in an open configuration;

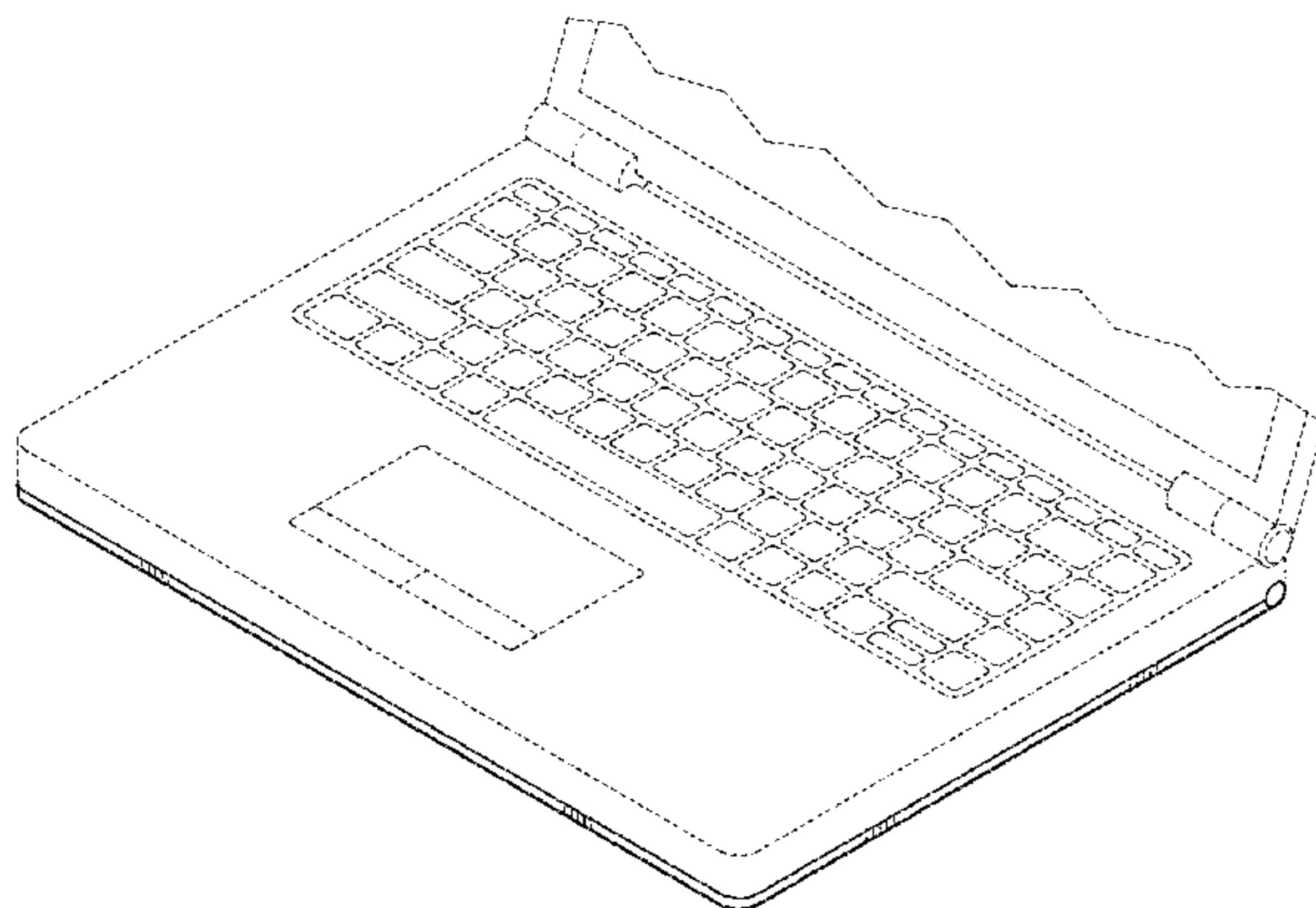


FIG. 2 is a bottom, rear, and side perspective view thereof in a closed configuration;

The broken lines shown in the drawings depicting a hinge coupling the lower portion and the upper portion of the laptop computer are included for additional clarity and form no part of the claimed design.

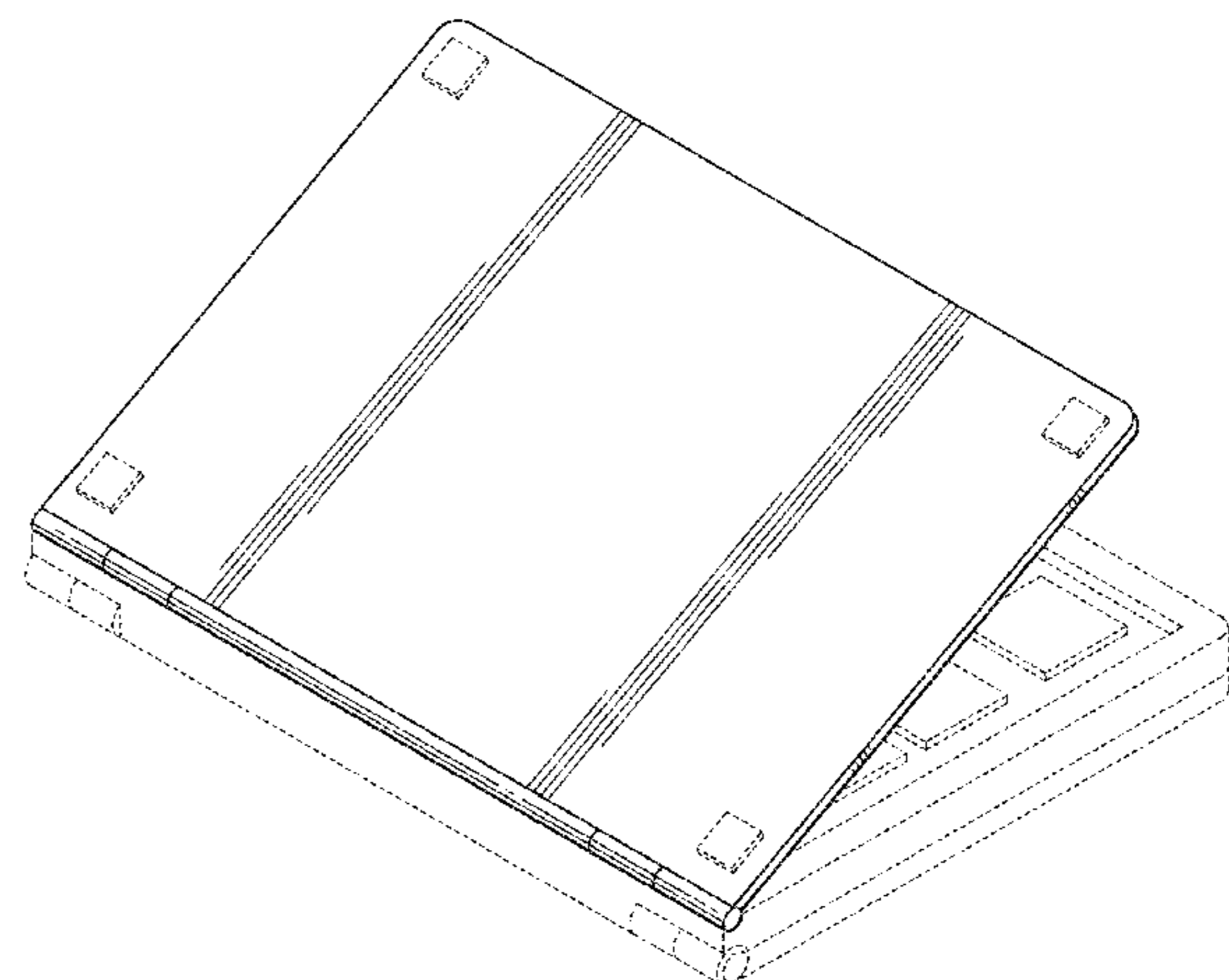

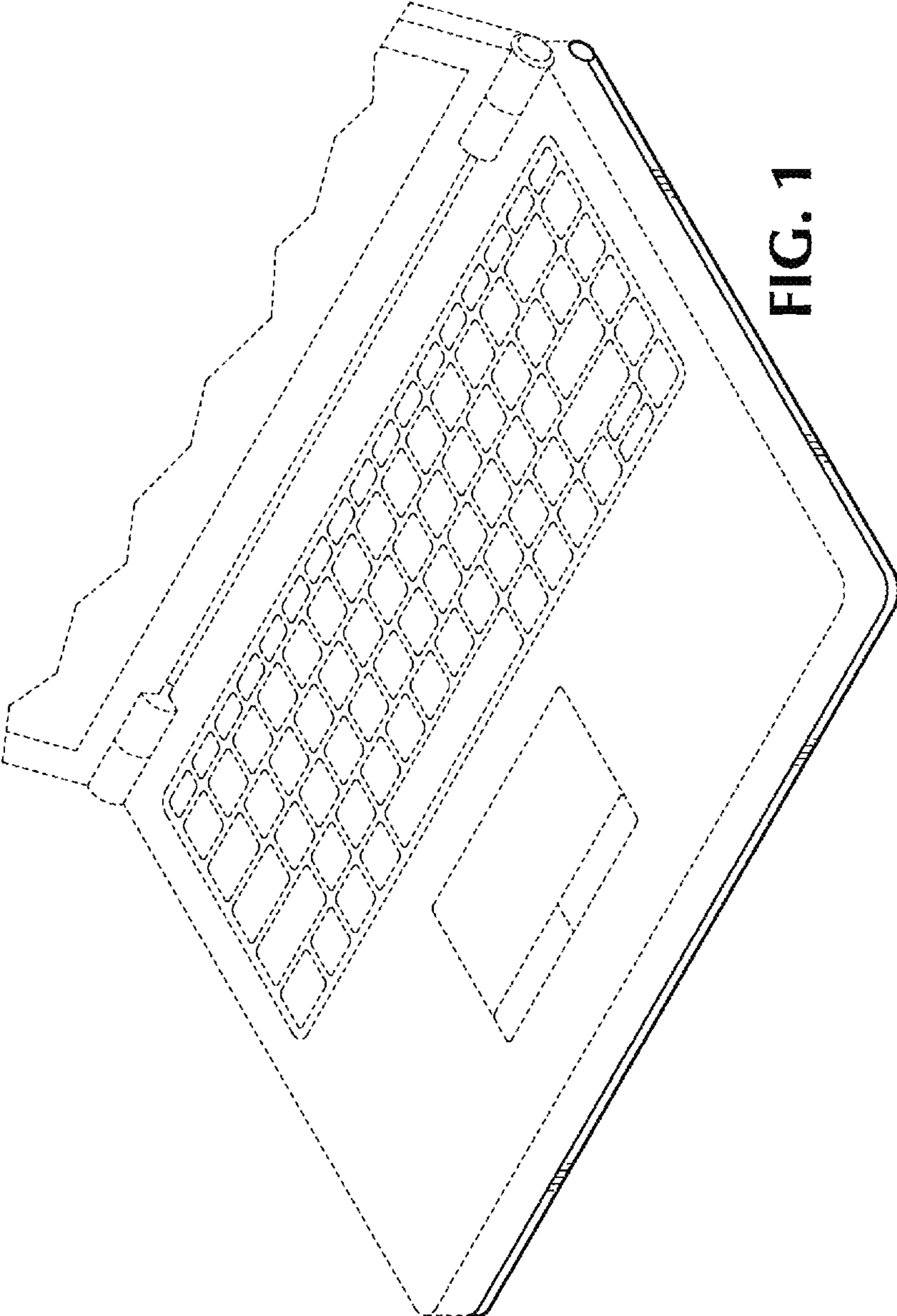

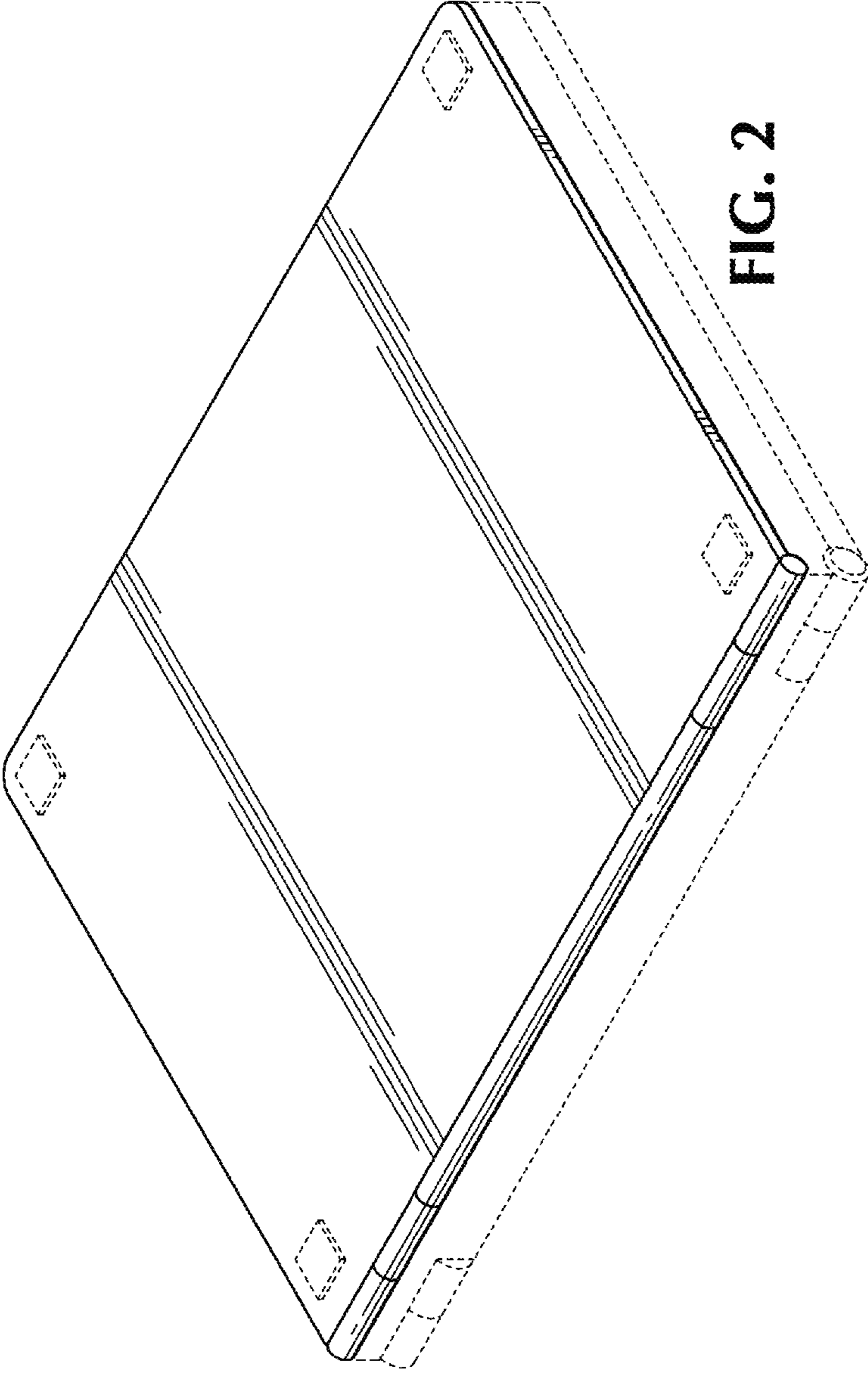

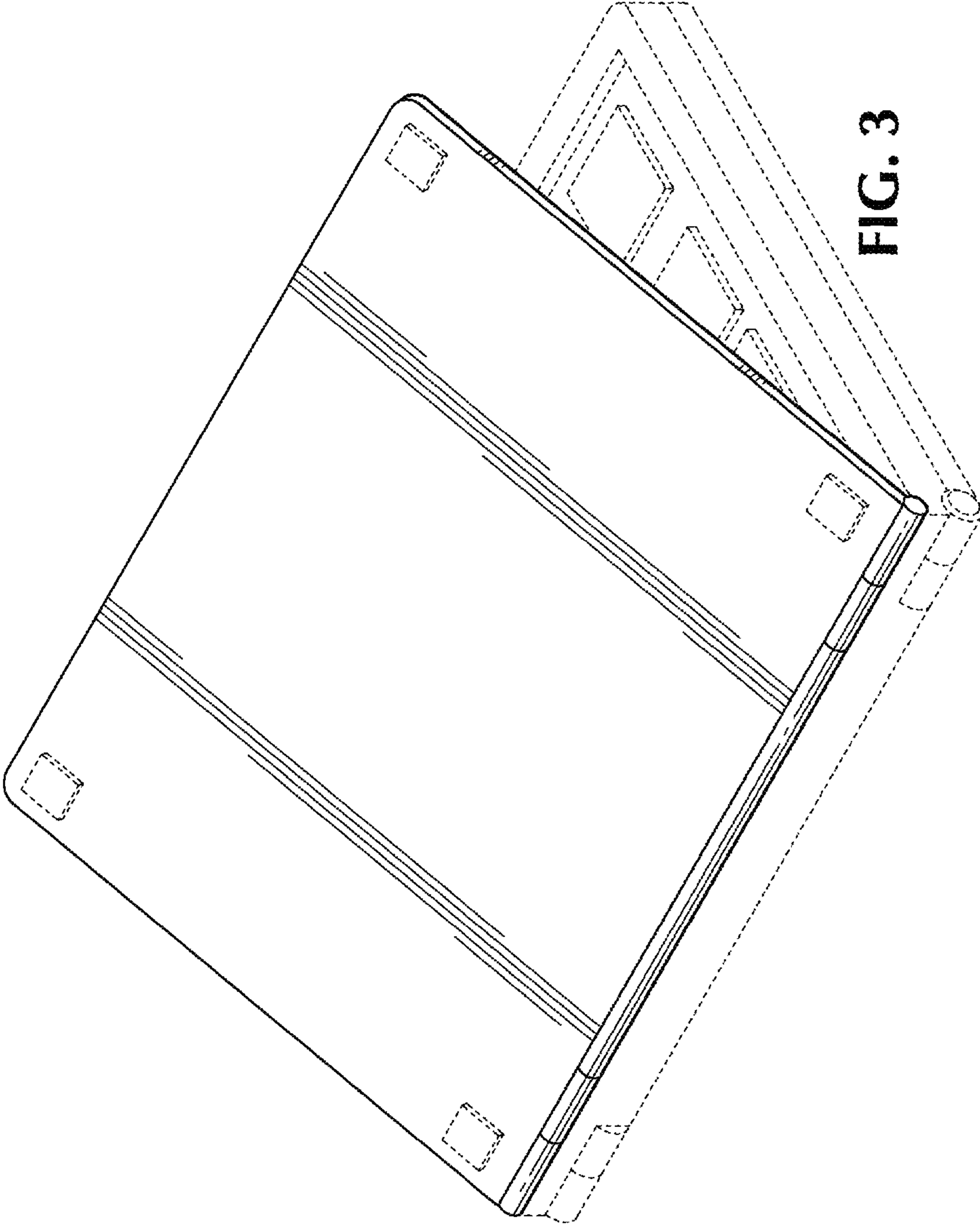
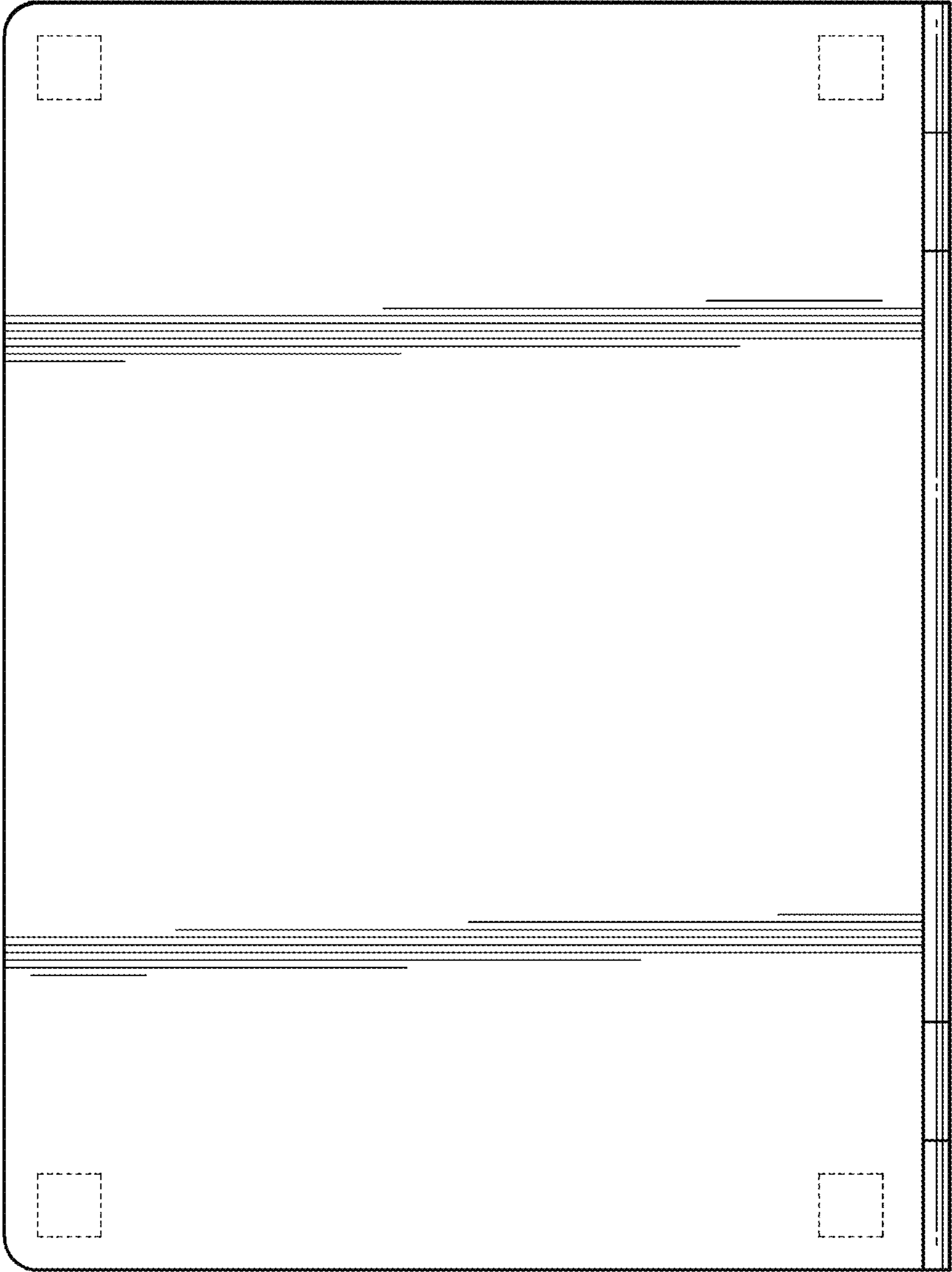

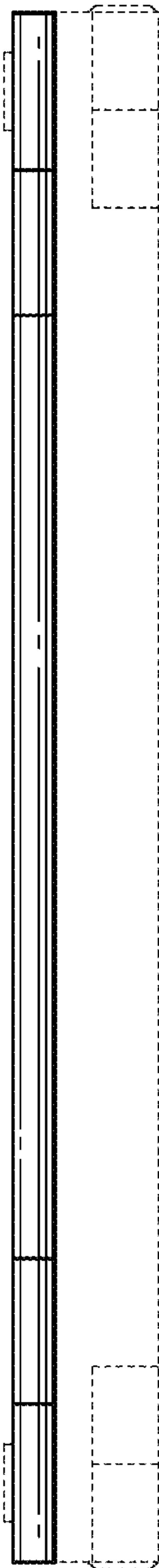

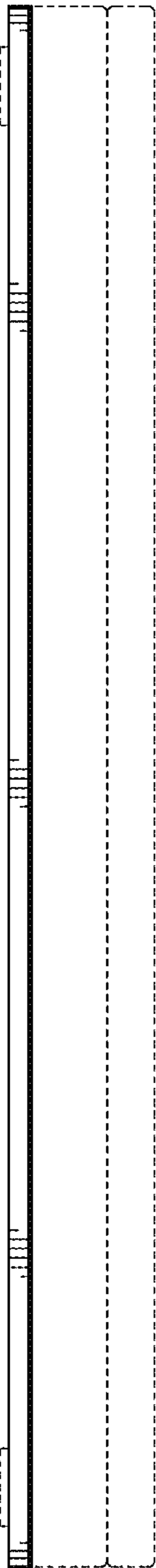

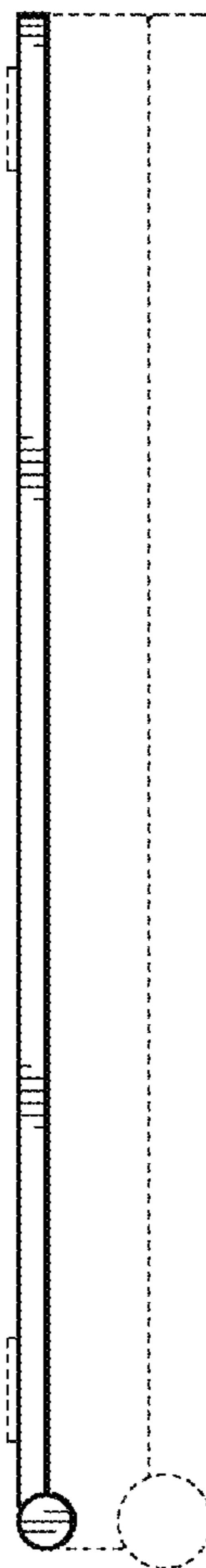

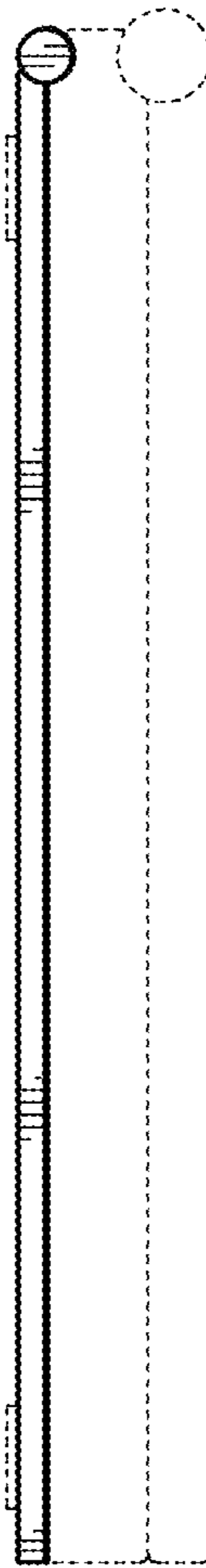
