The ornamental design for a patient monitoring device with graphical user interface, as shown and described.

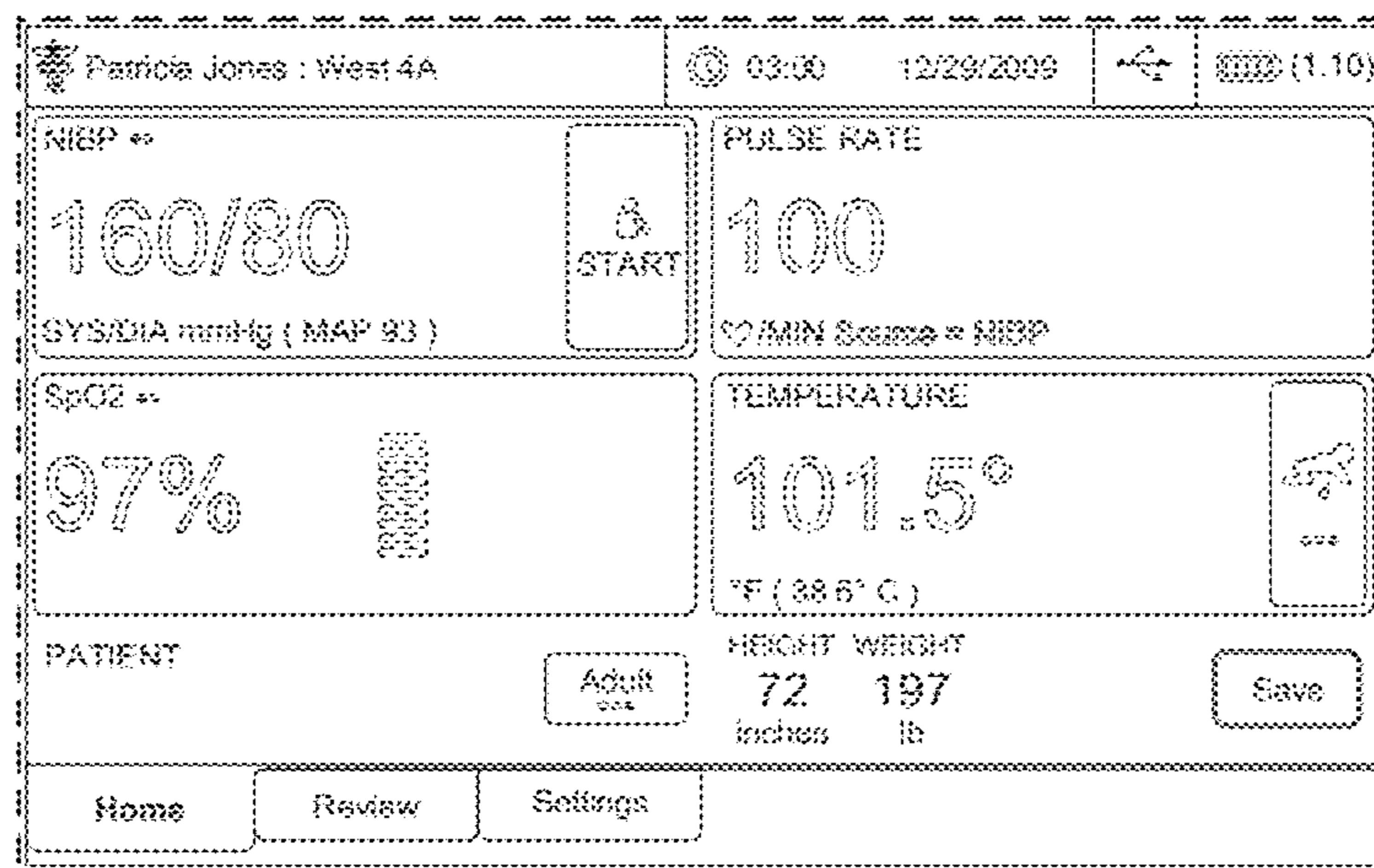
DESCRIPTION
