(57) **CLAIM**

The ornamental design for a headlight for a vehicle, as shown
and described.

DESCRIPTION

This application contains subject matter related to the follow-
ing co-pending U.S. design patent application:

Application Ser. No. 29/347,801, filed herewith and entitled
“Vehicle, Toy, and/or Replicas Thereof”.

FIG. 1 is a right perspective view of a first embodiment of a
headlight for a vehicle according to my design;

FIG. 2 is a left perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a right side view thereof; and

FIG. 5 is a top view thereof.

FIG. 6 is a left perspective view of a second embodiment of
the headlight for a vehicle according to my design, with the

FIG. 7 is a right perspective view thereof;

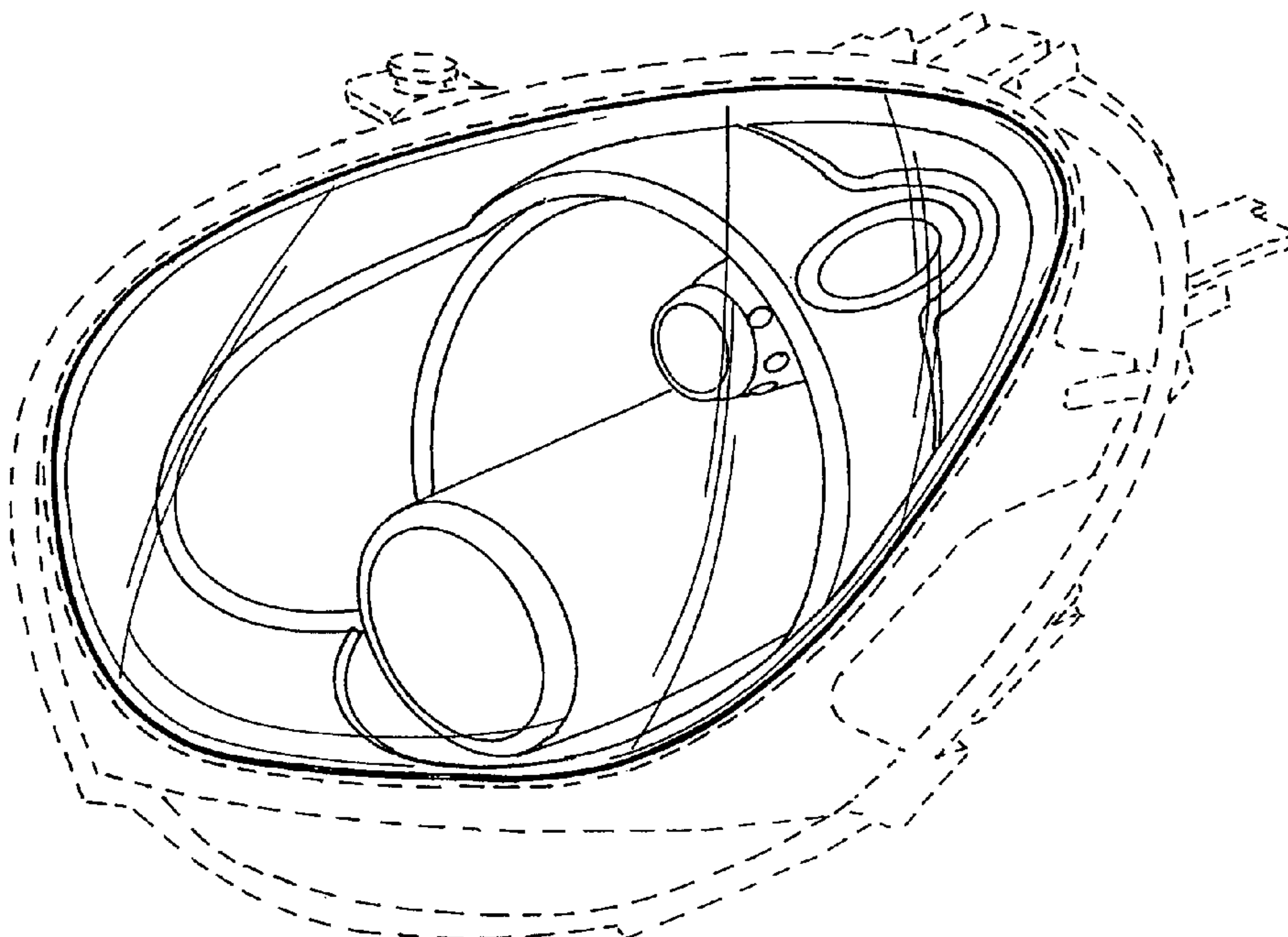
FIG. 8 is a front view thereof;

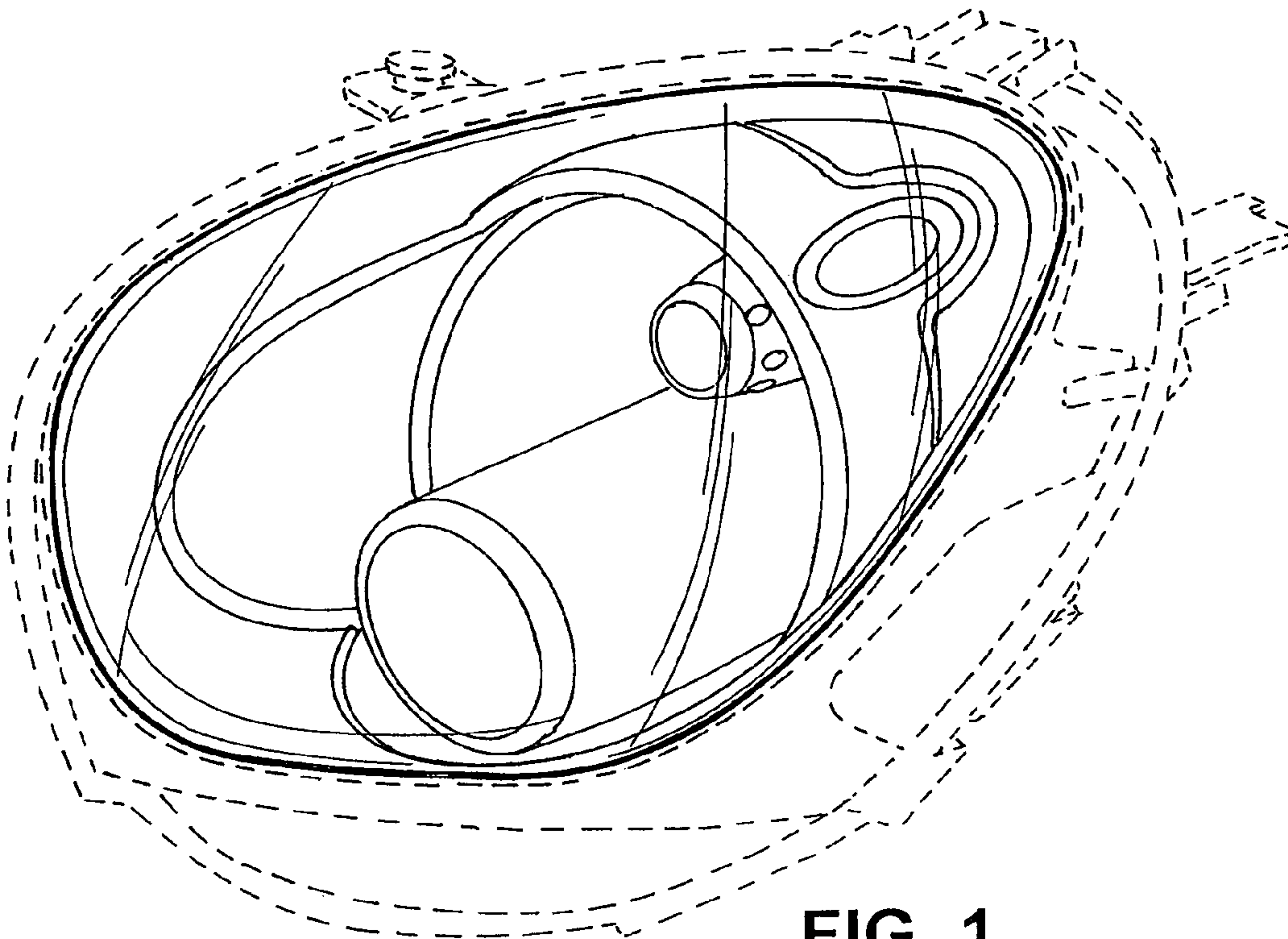

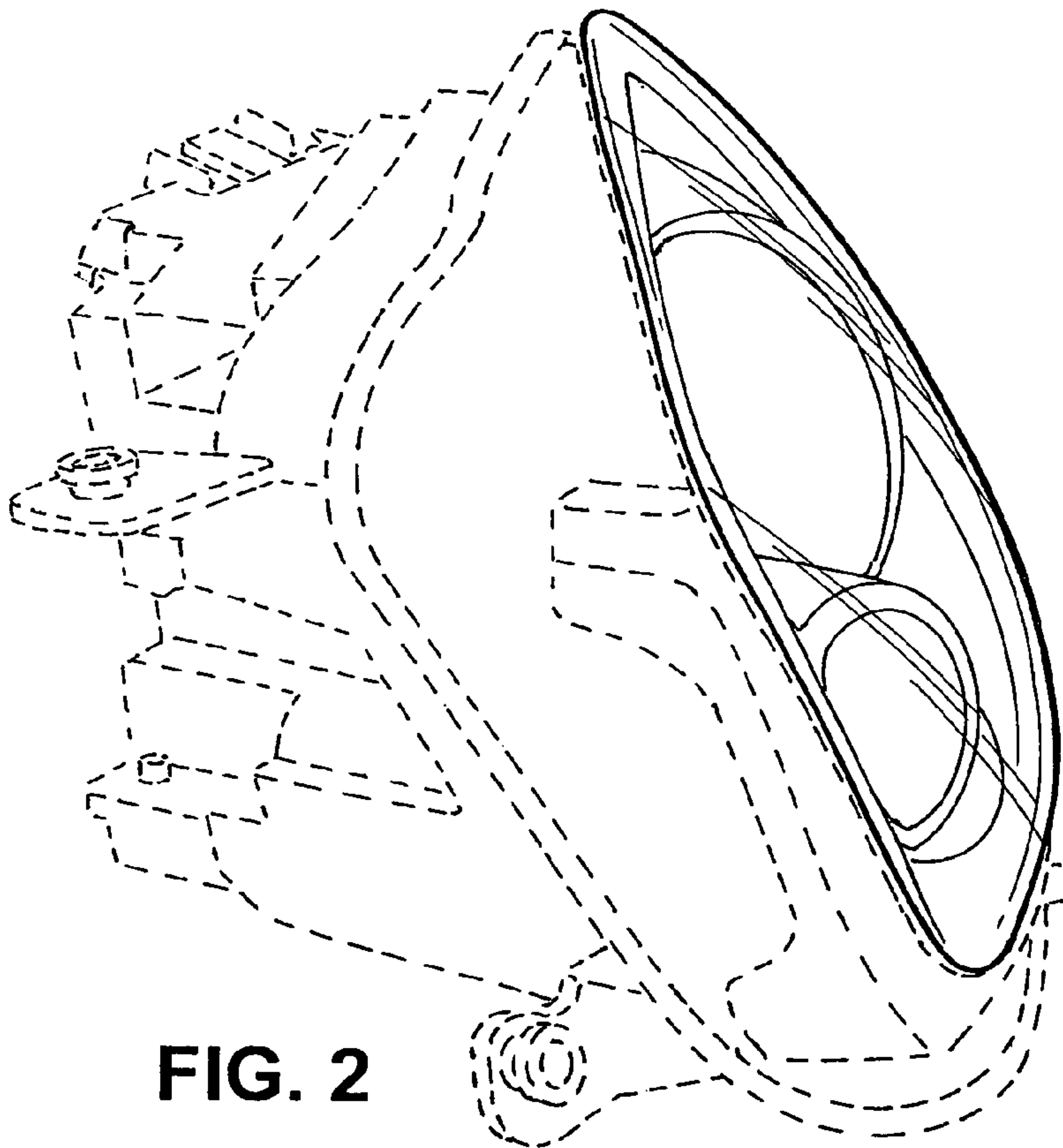

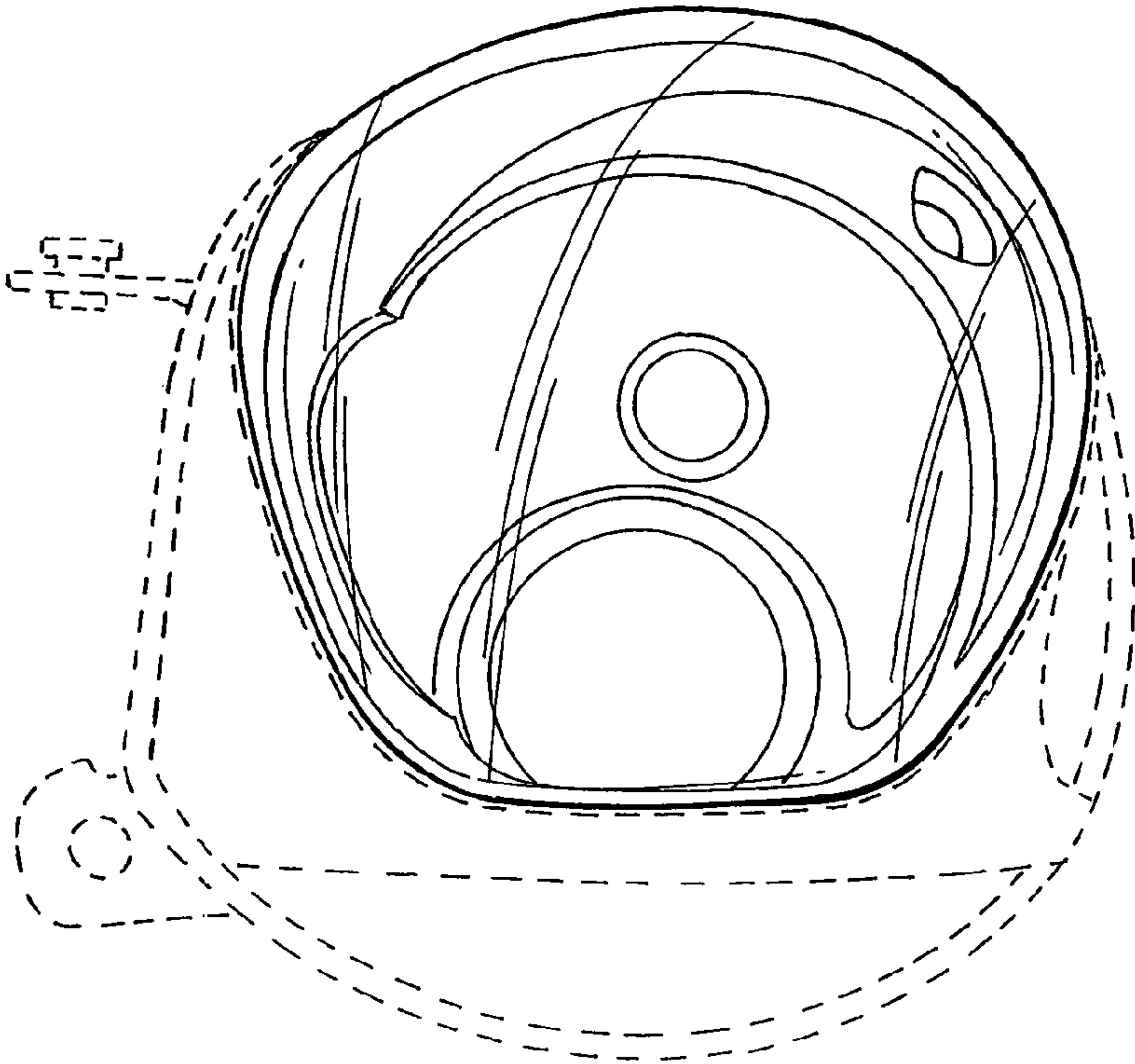

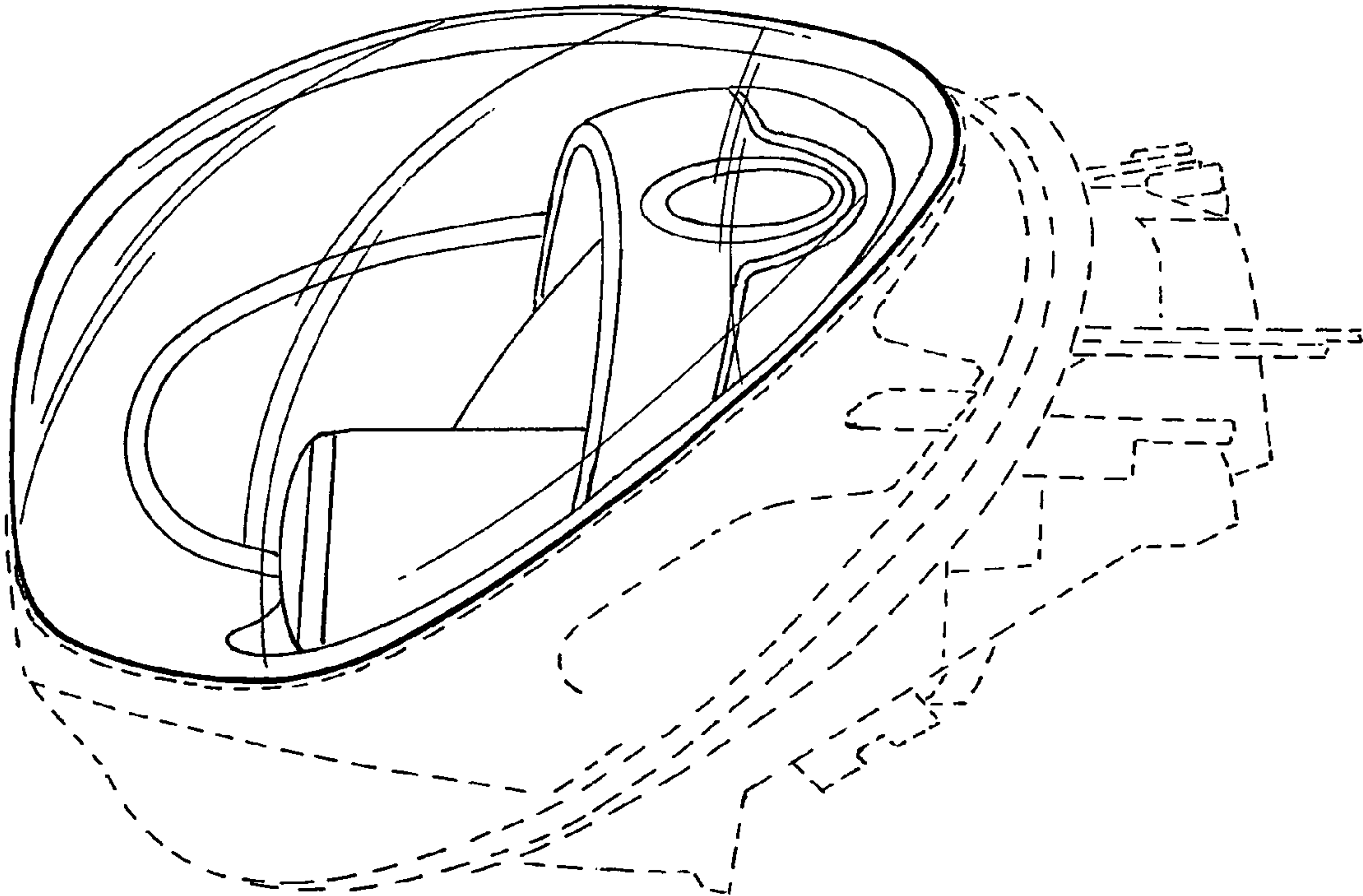

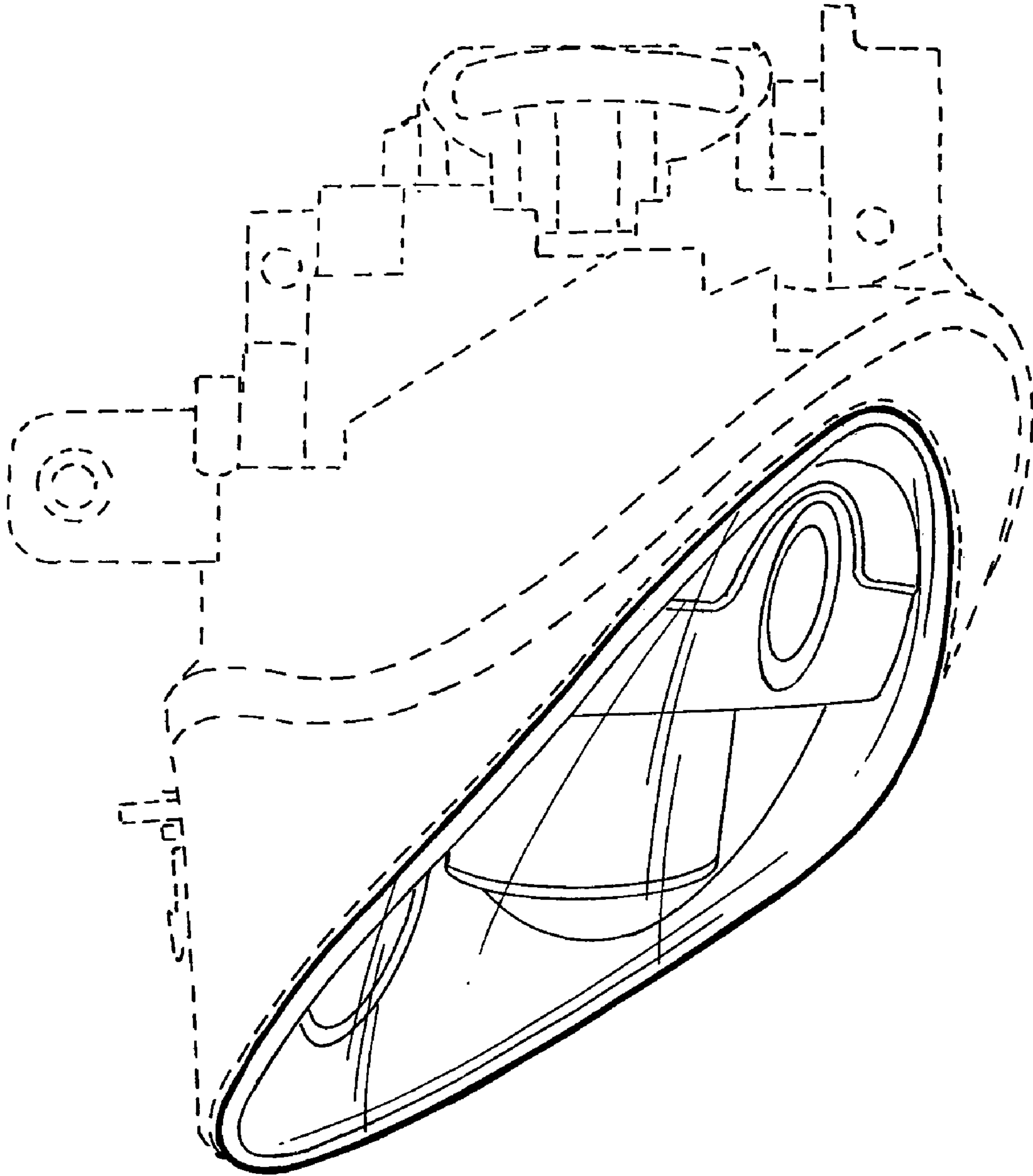

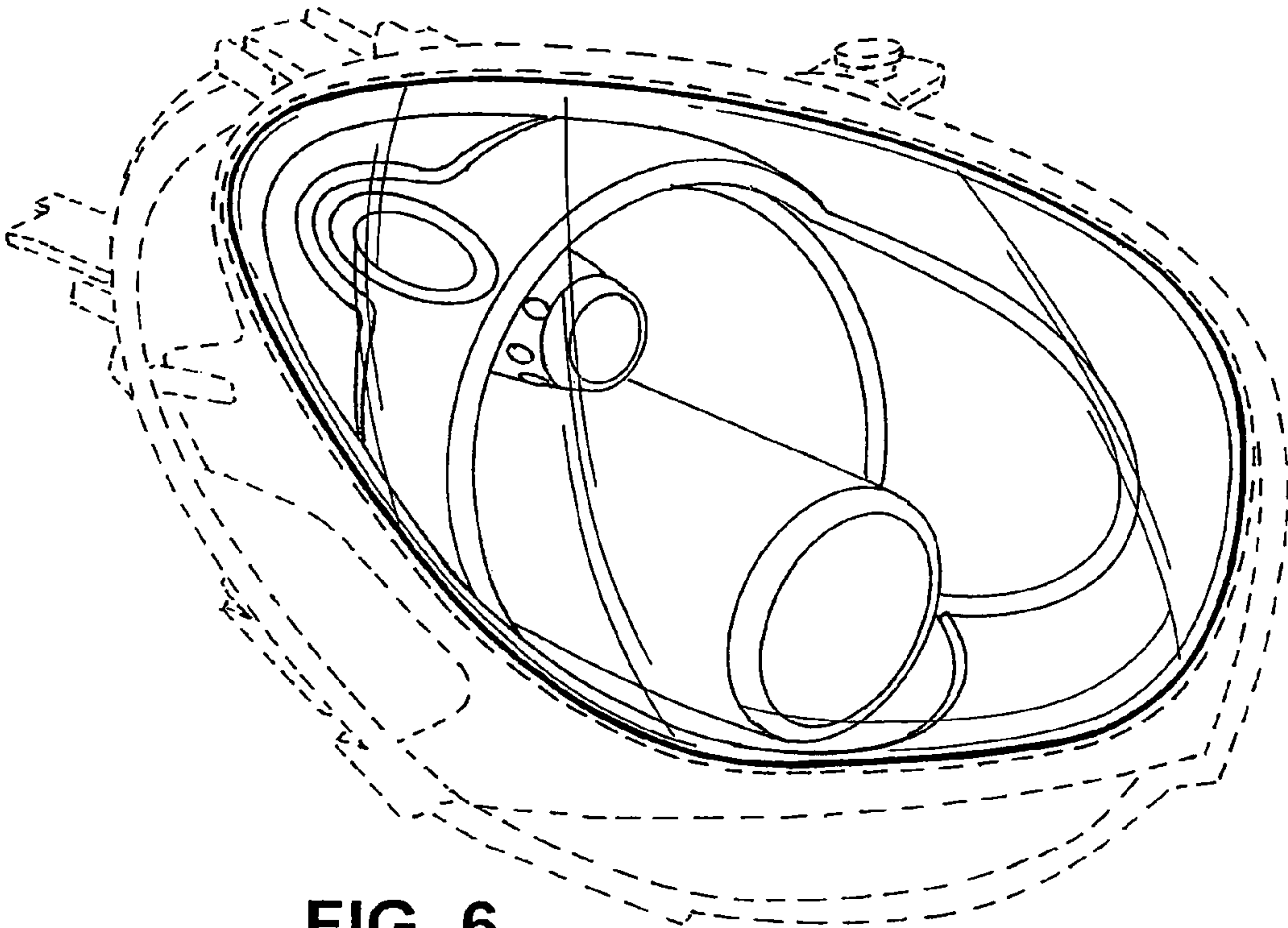

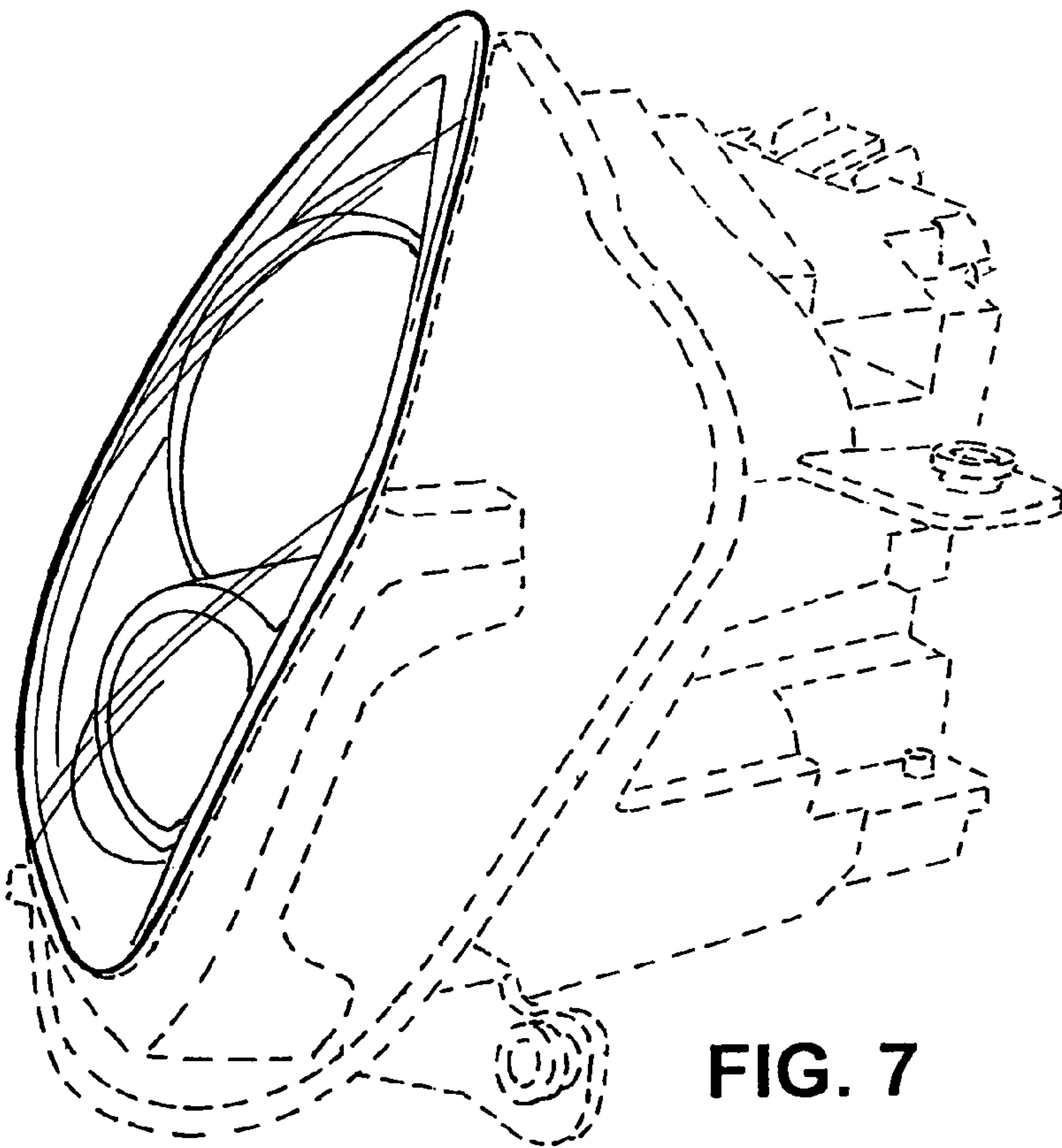

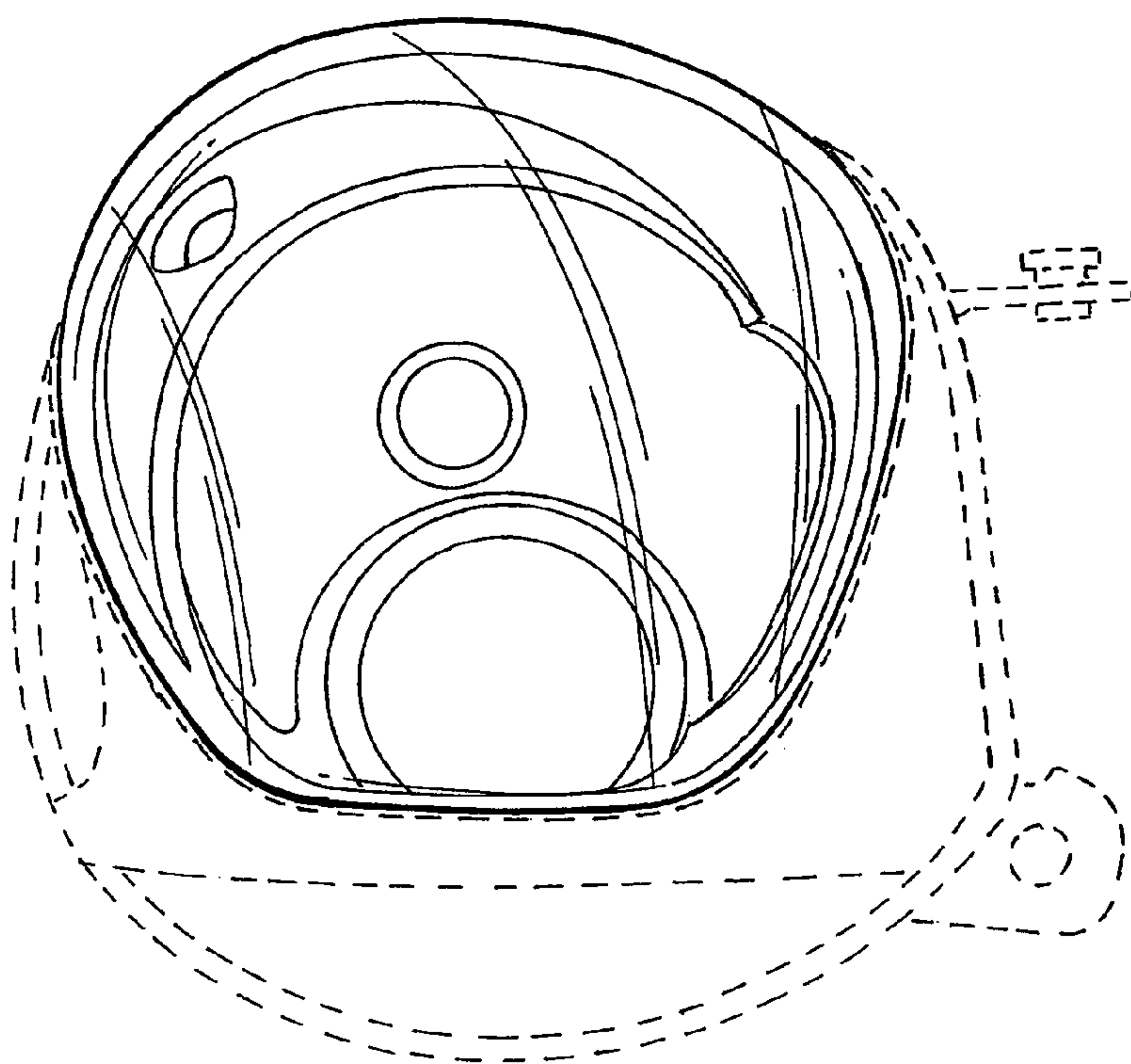

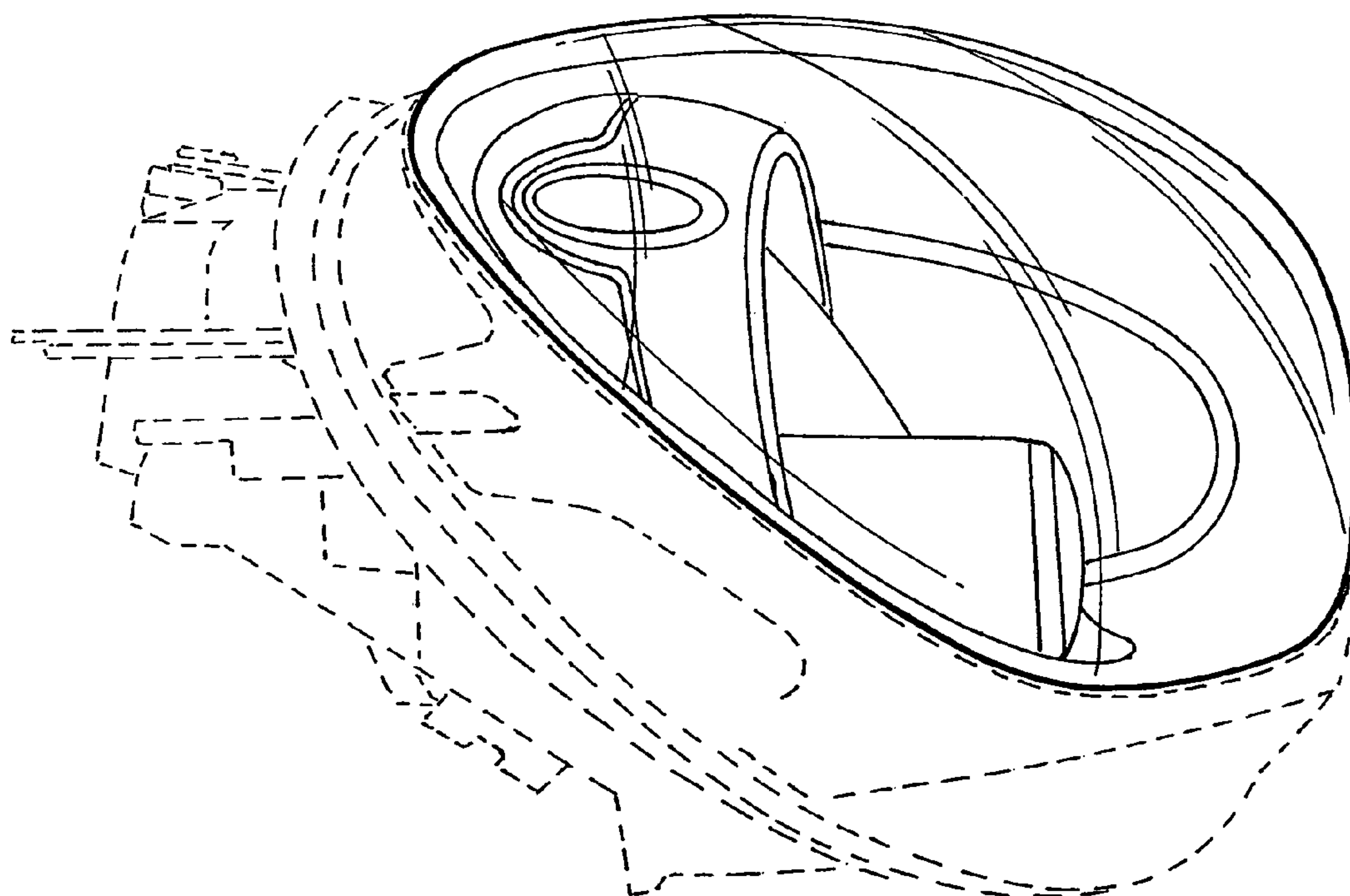

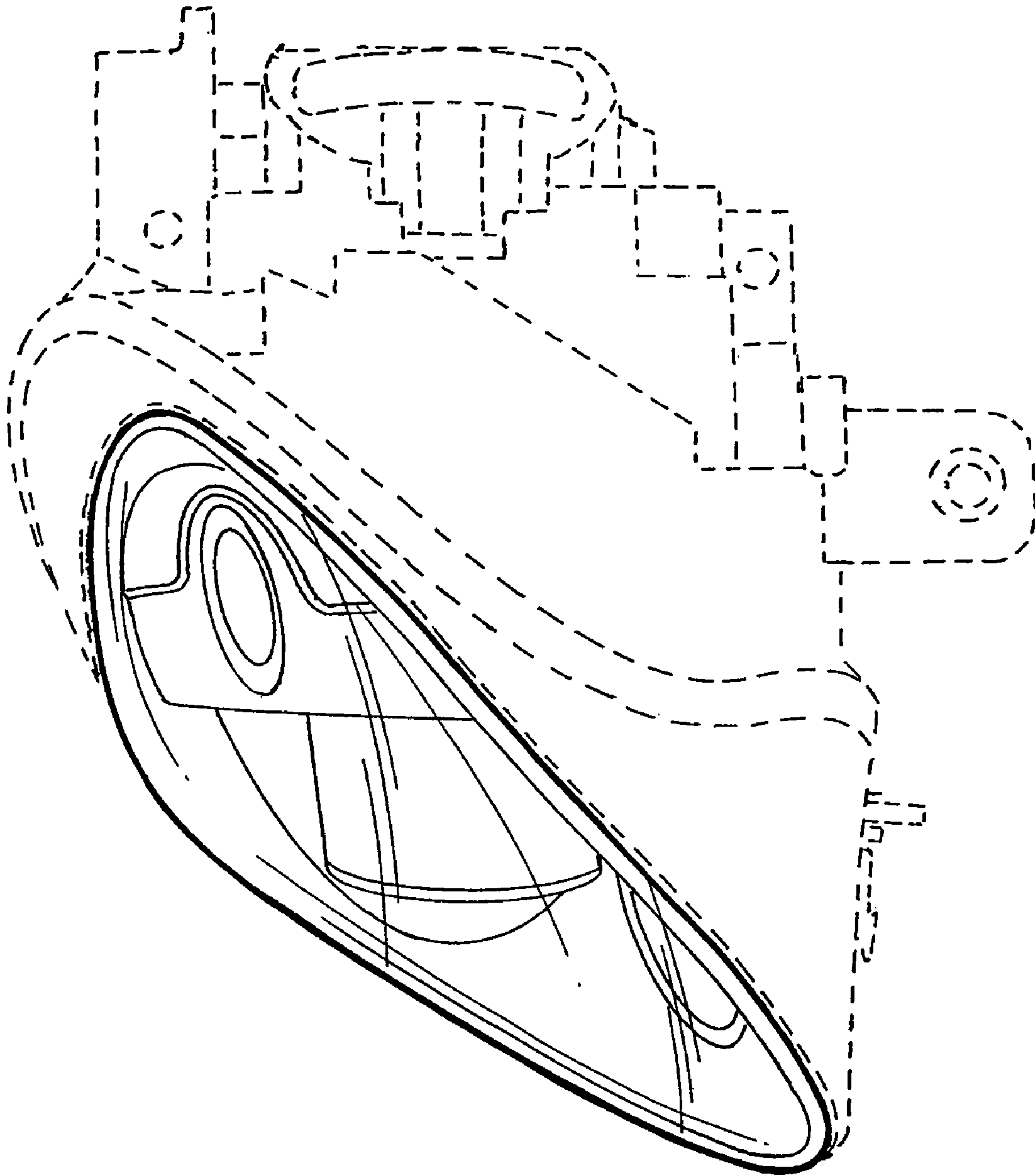
