FIG. 5 is a front perspective view of a pair of pants;

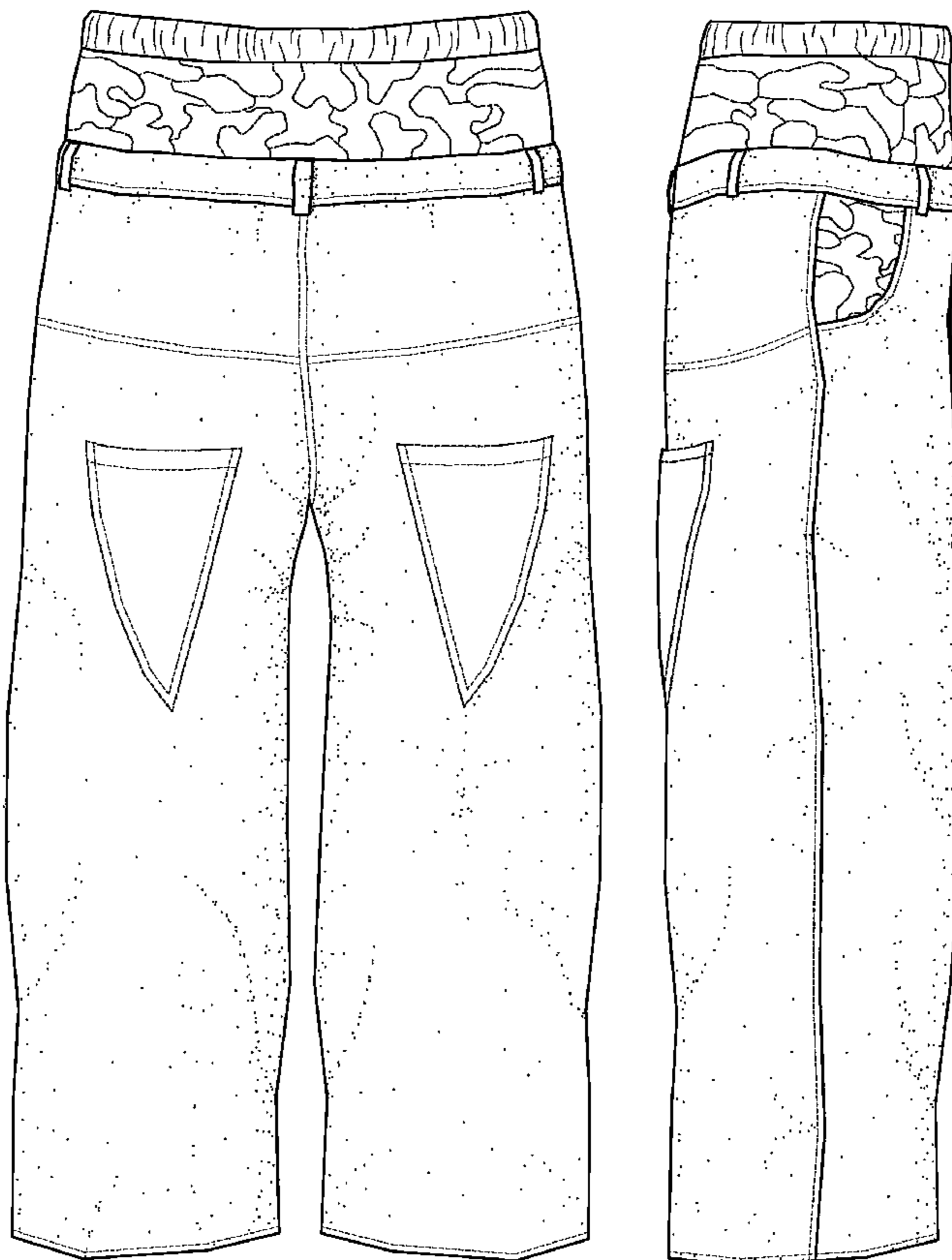
FIG. 6 is a rear view of a pair of pants;

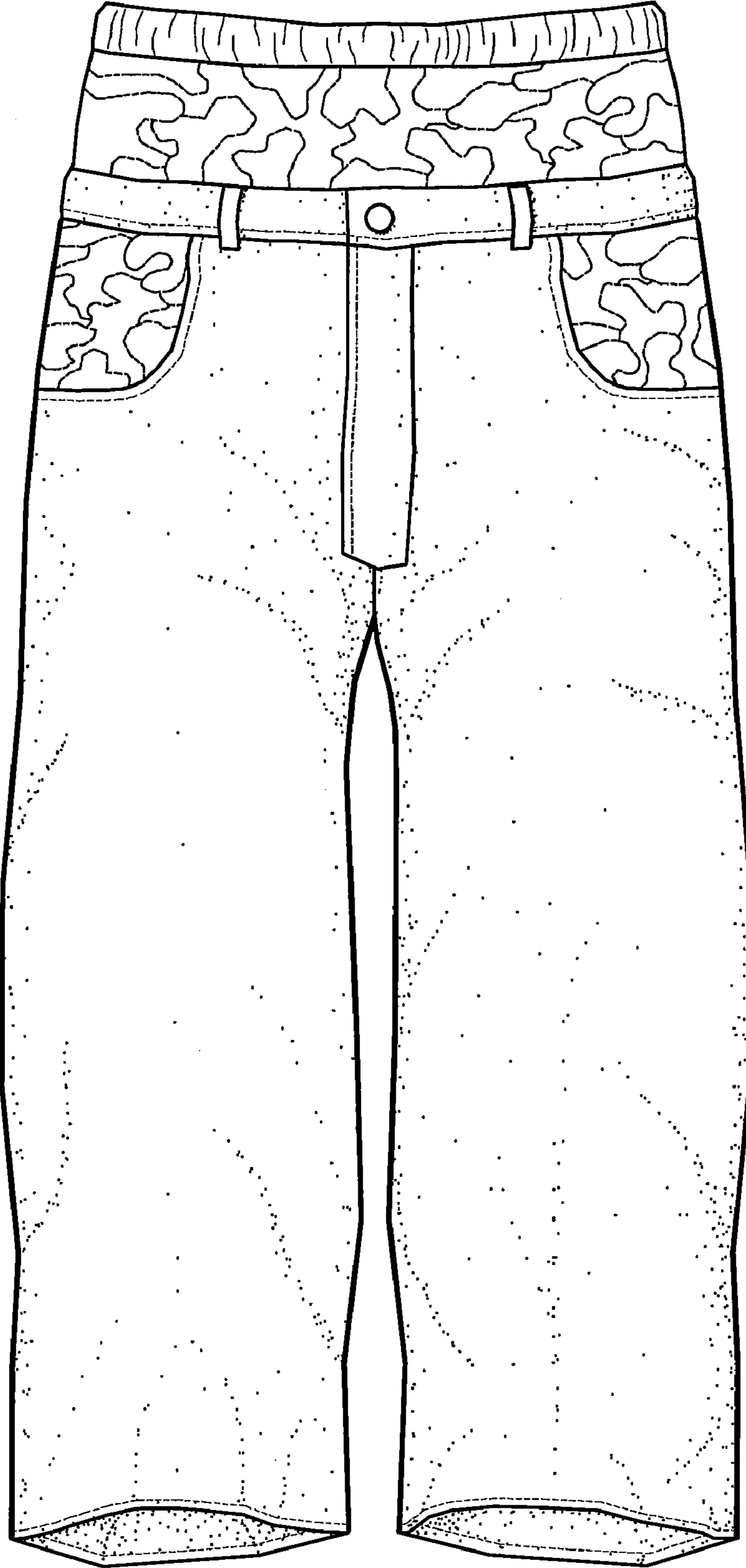

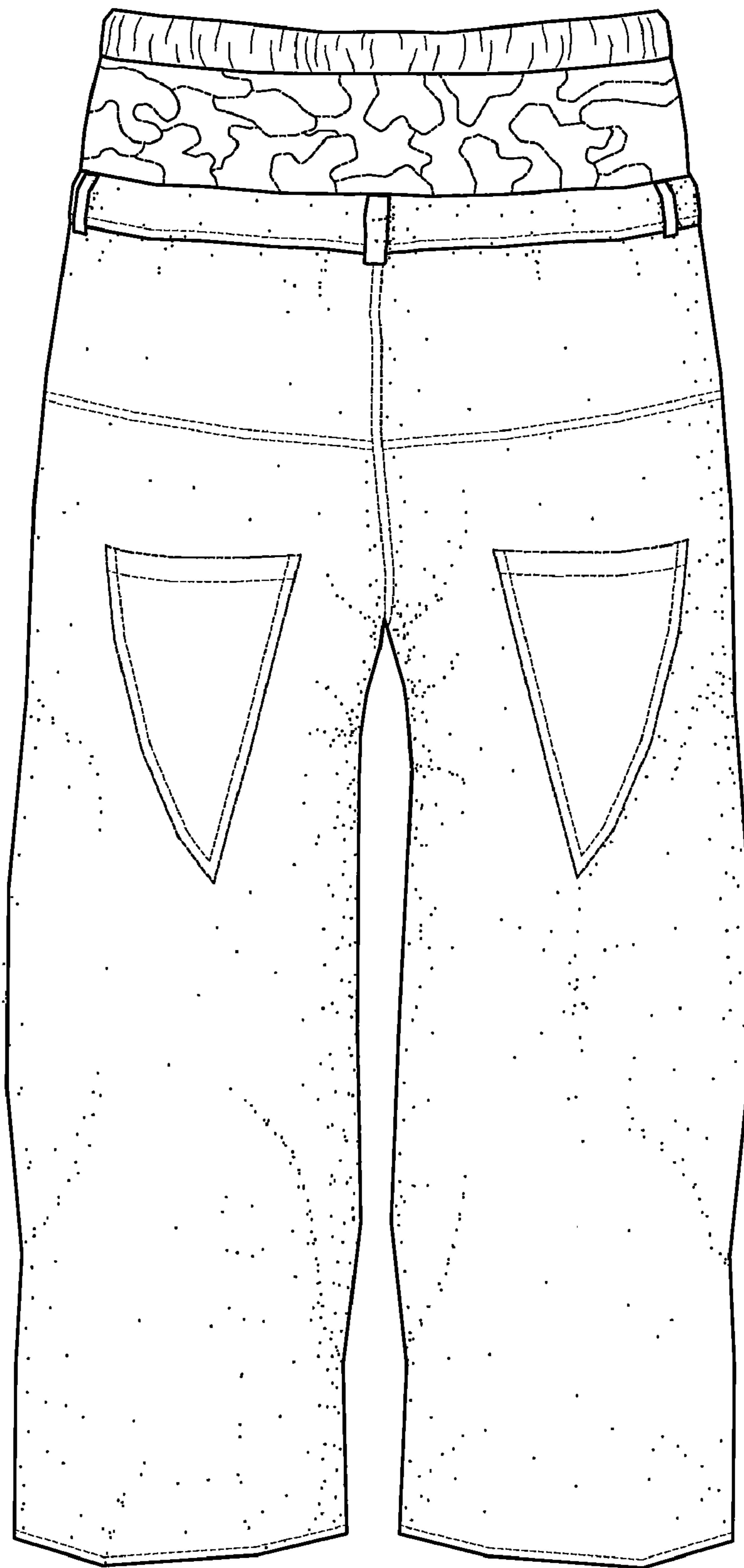

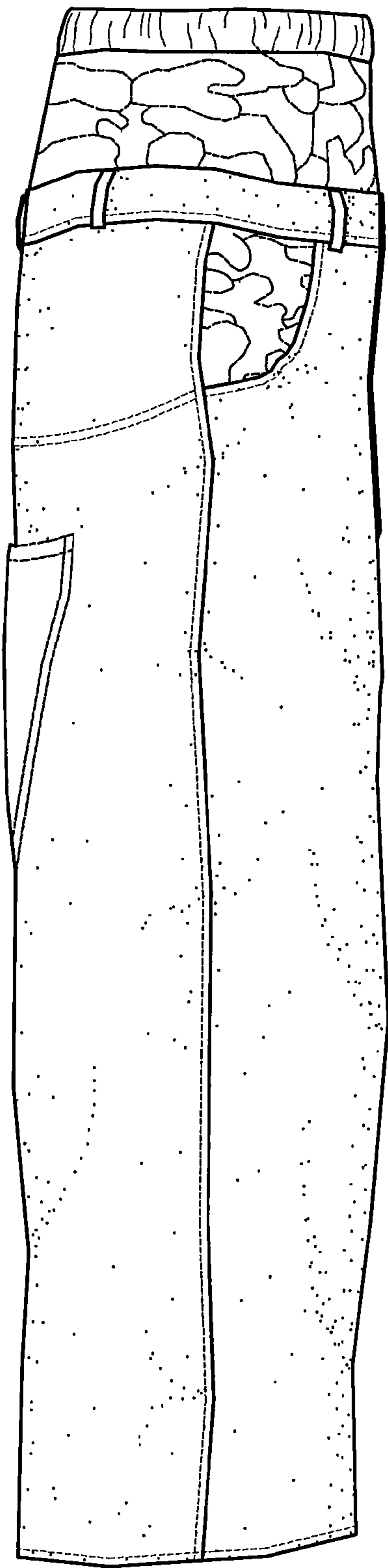

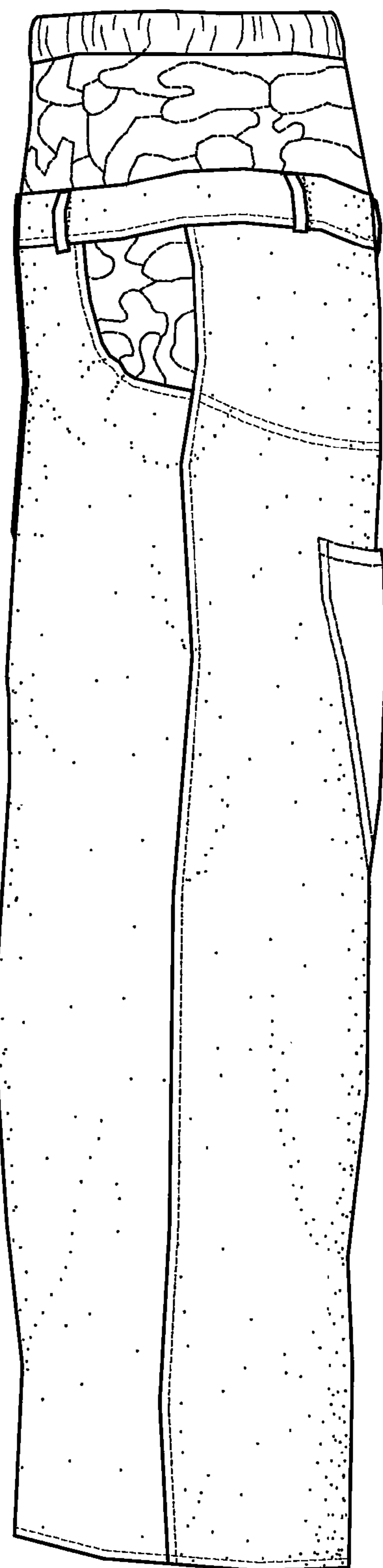

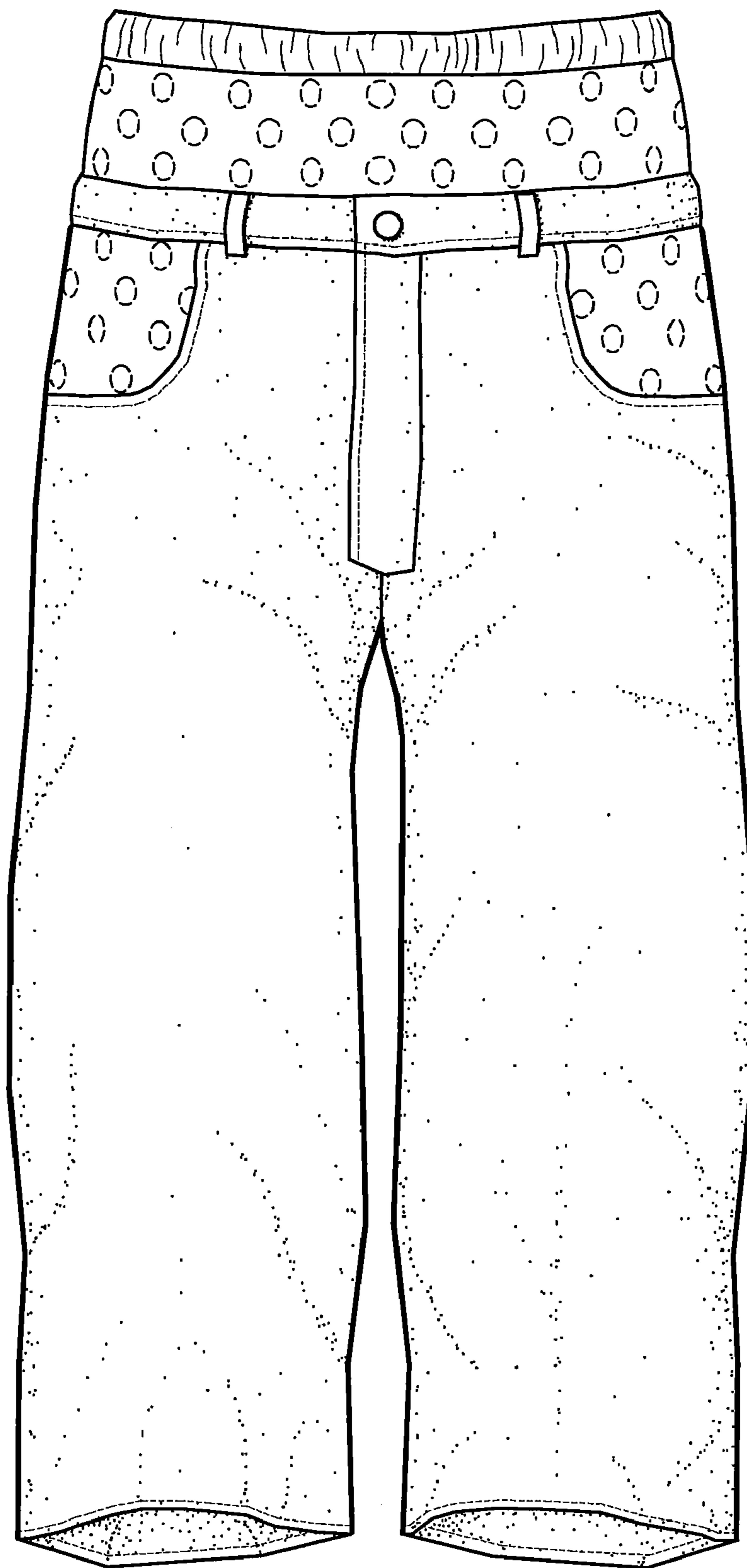

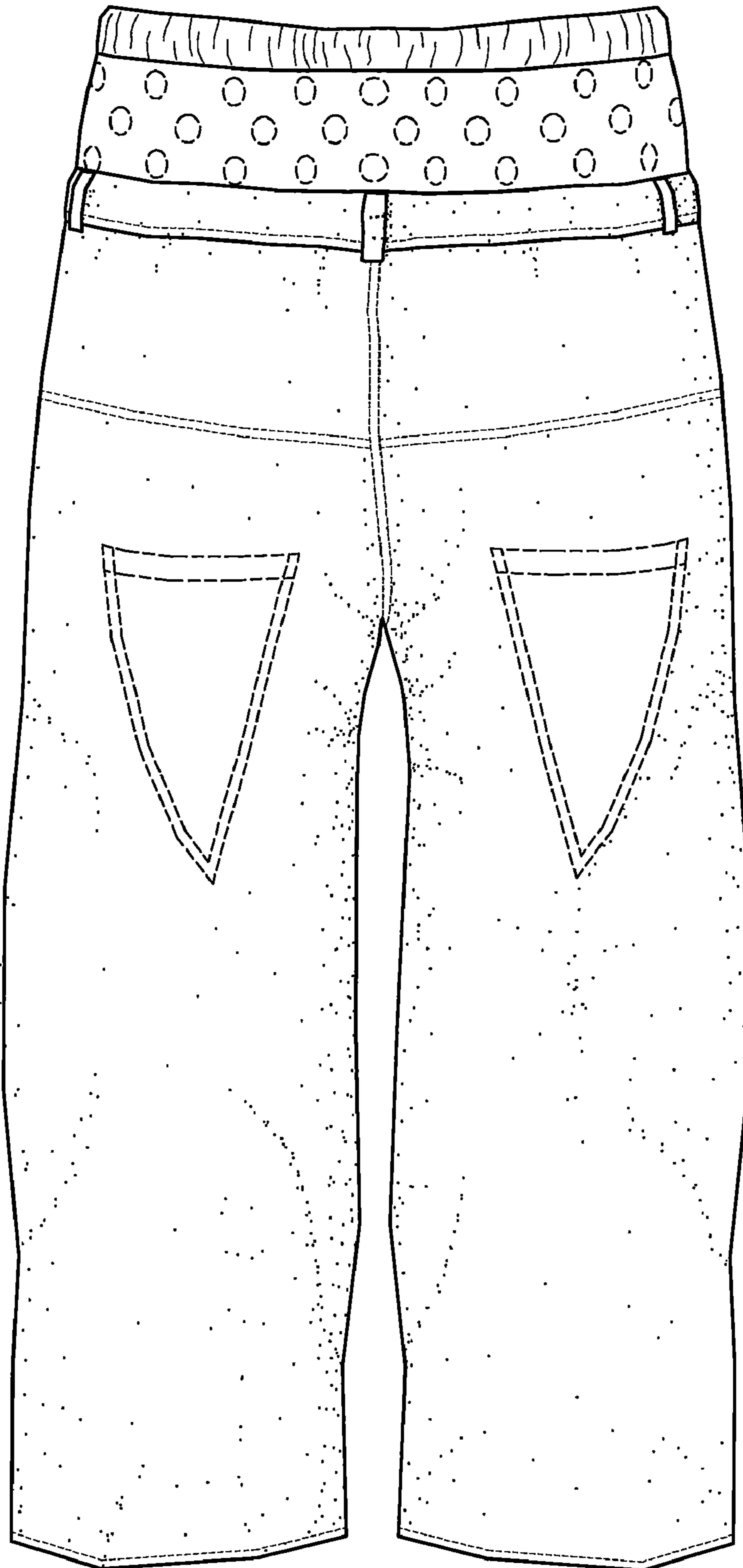

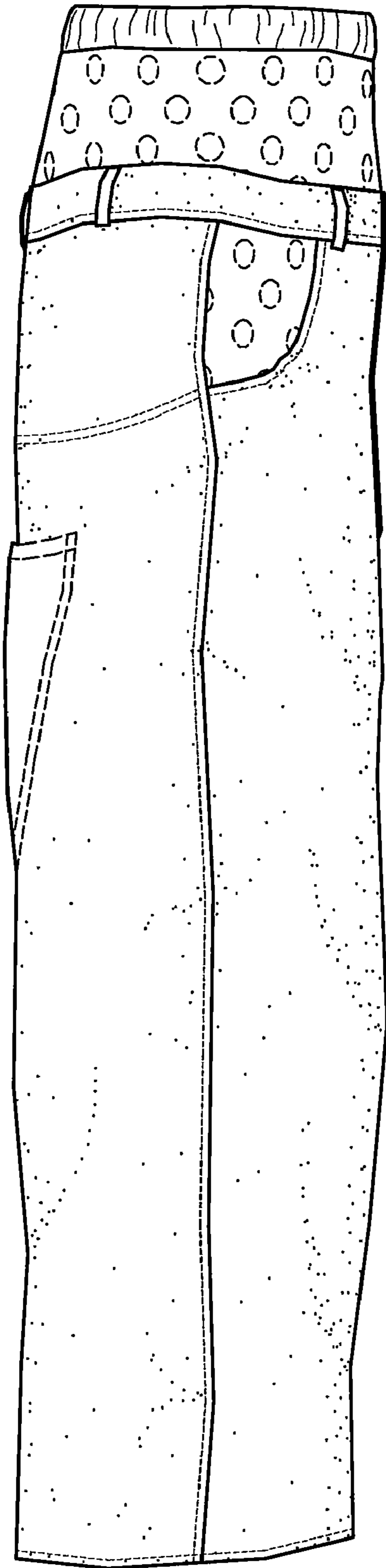

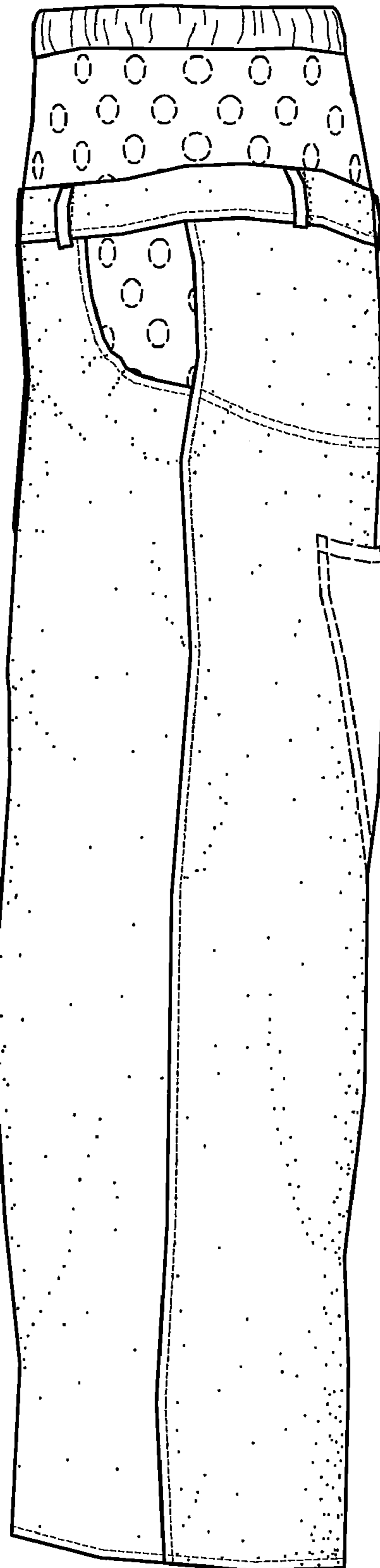
