The ornamental design for boot, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a boot showing my new design;

FIG. 2 is a left side view thereof;

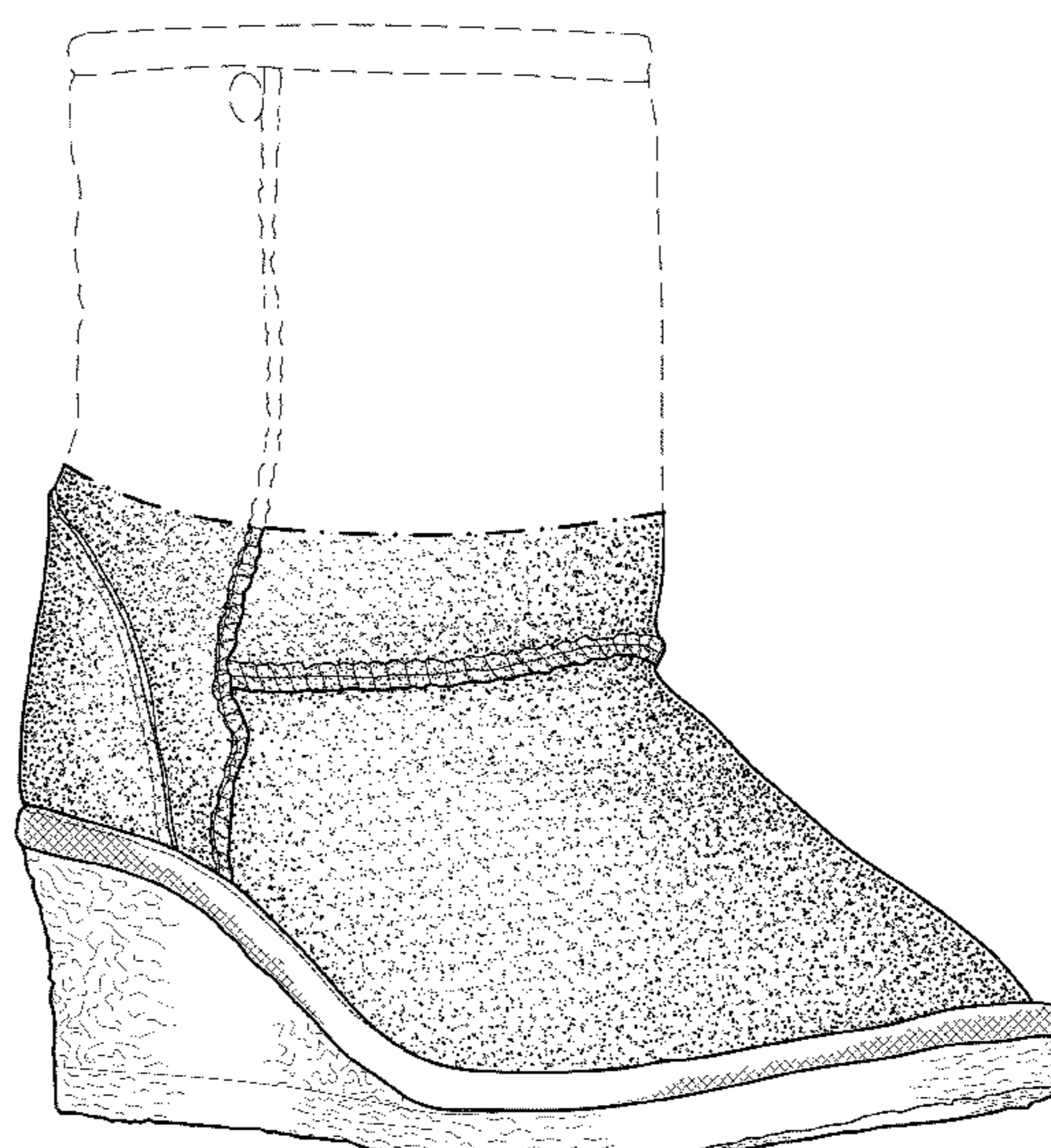

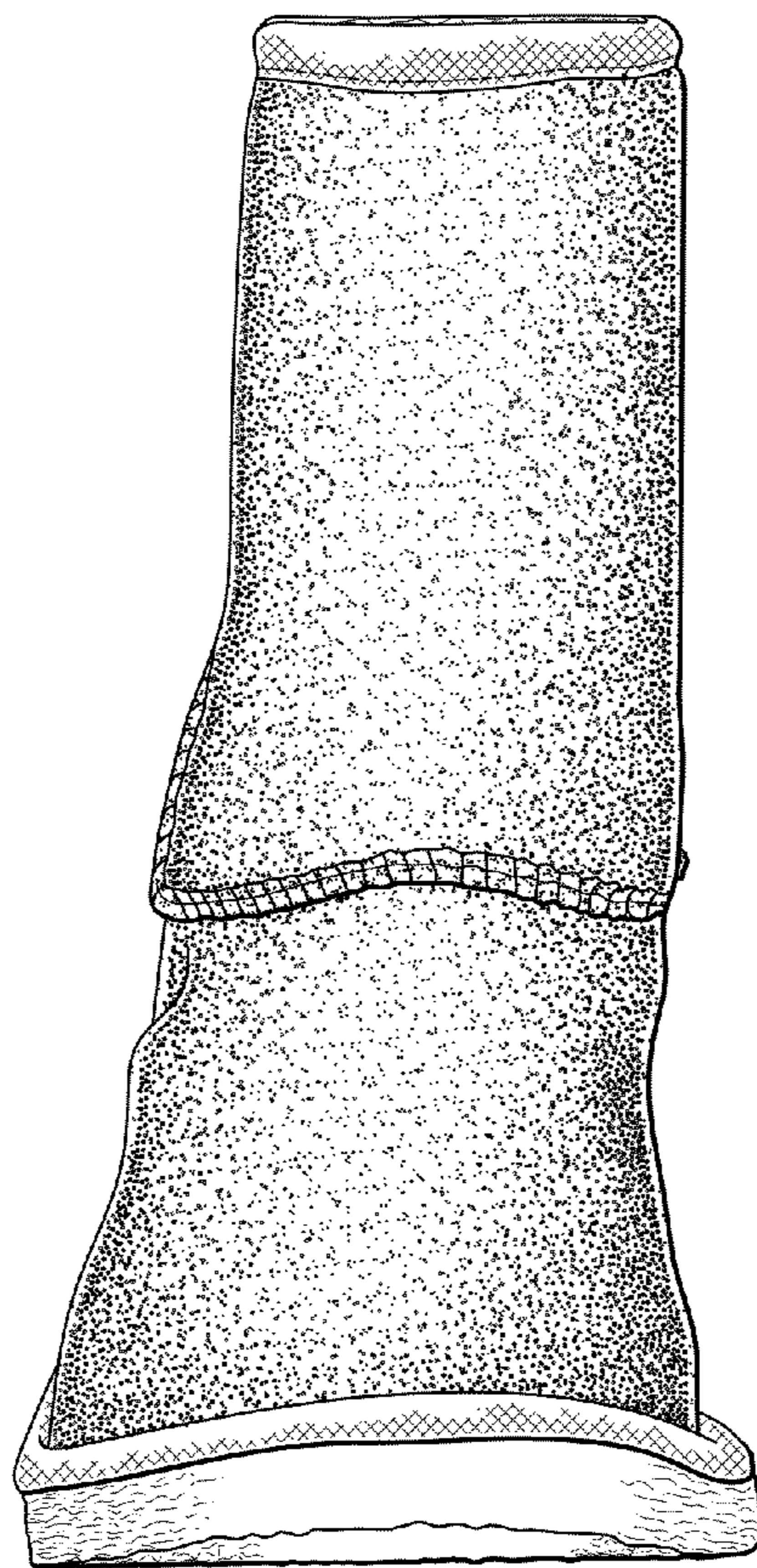

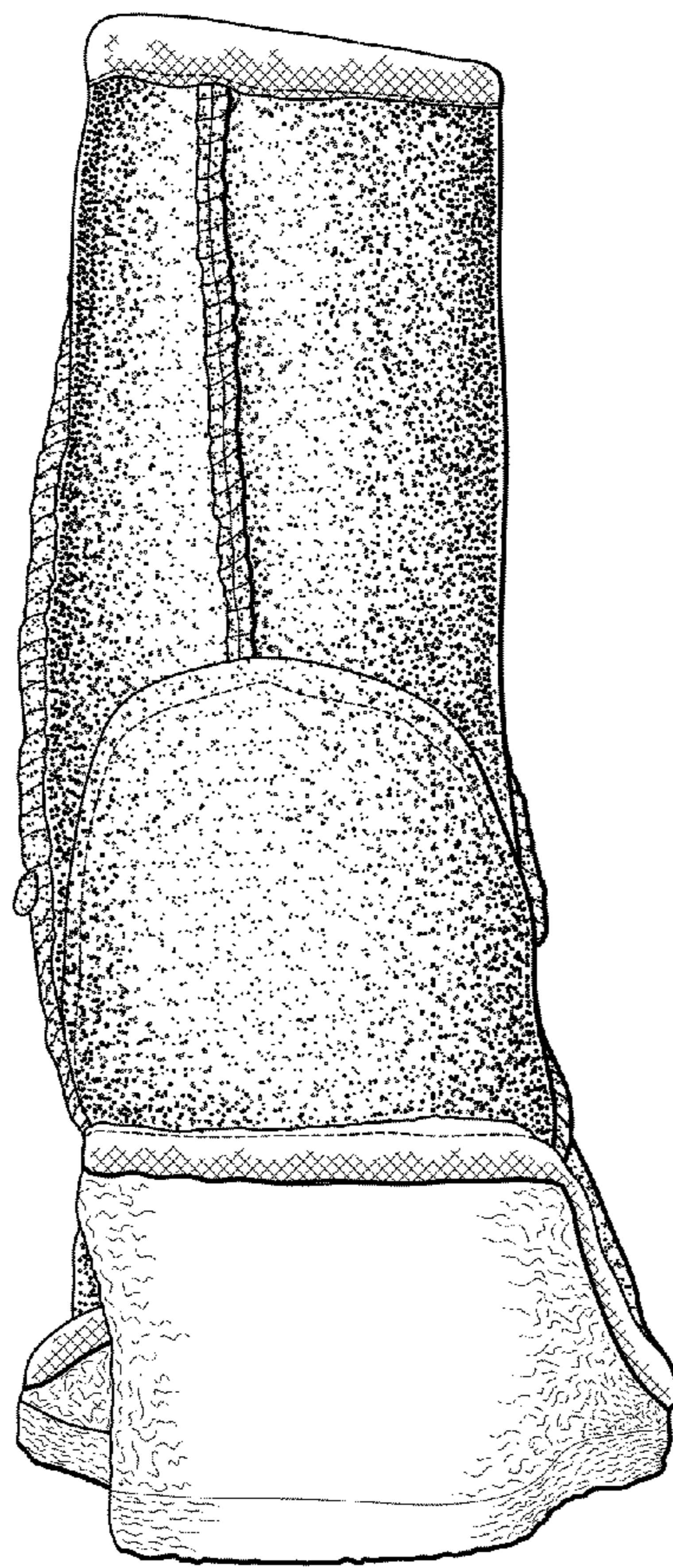

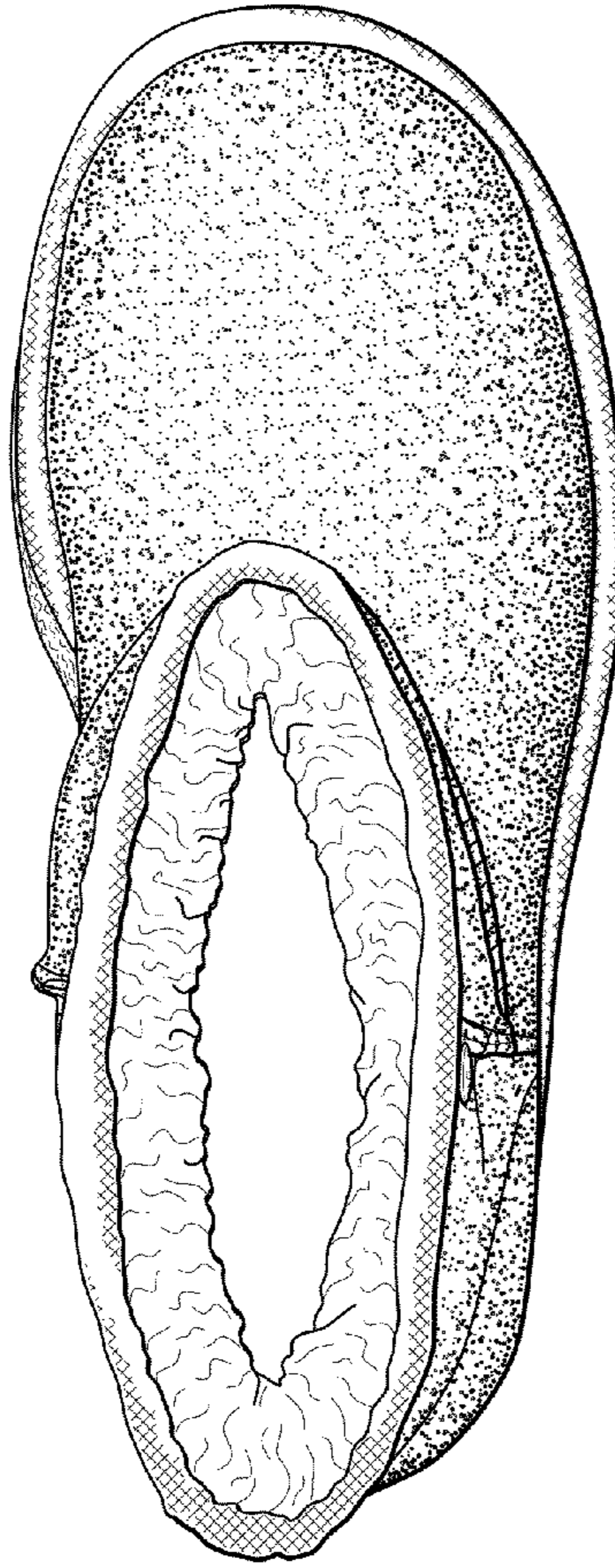

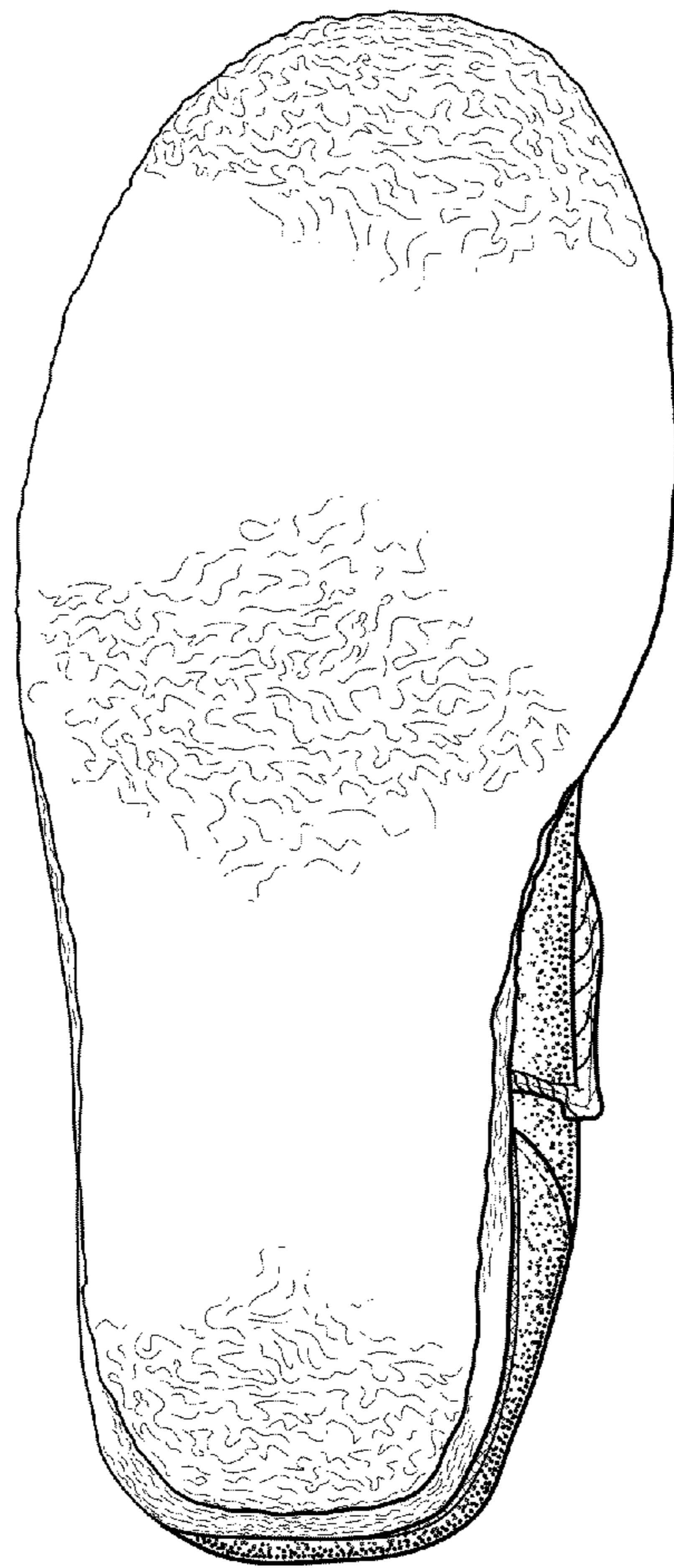

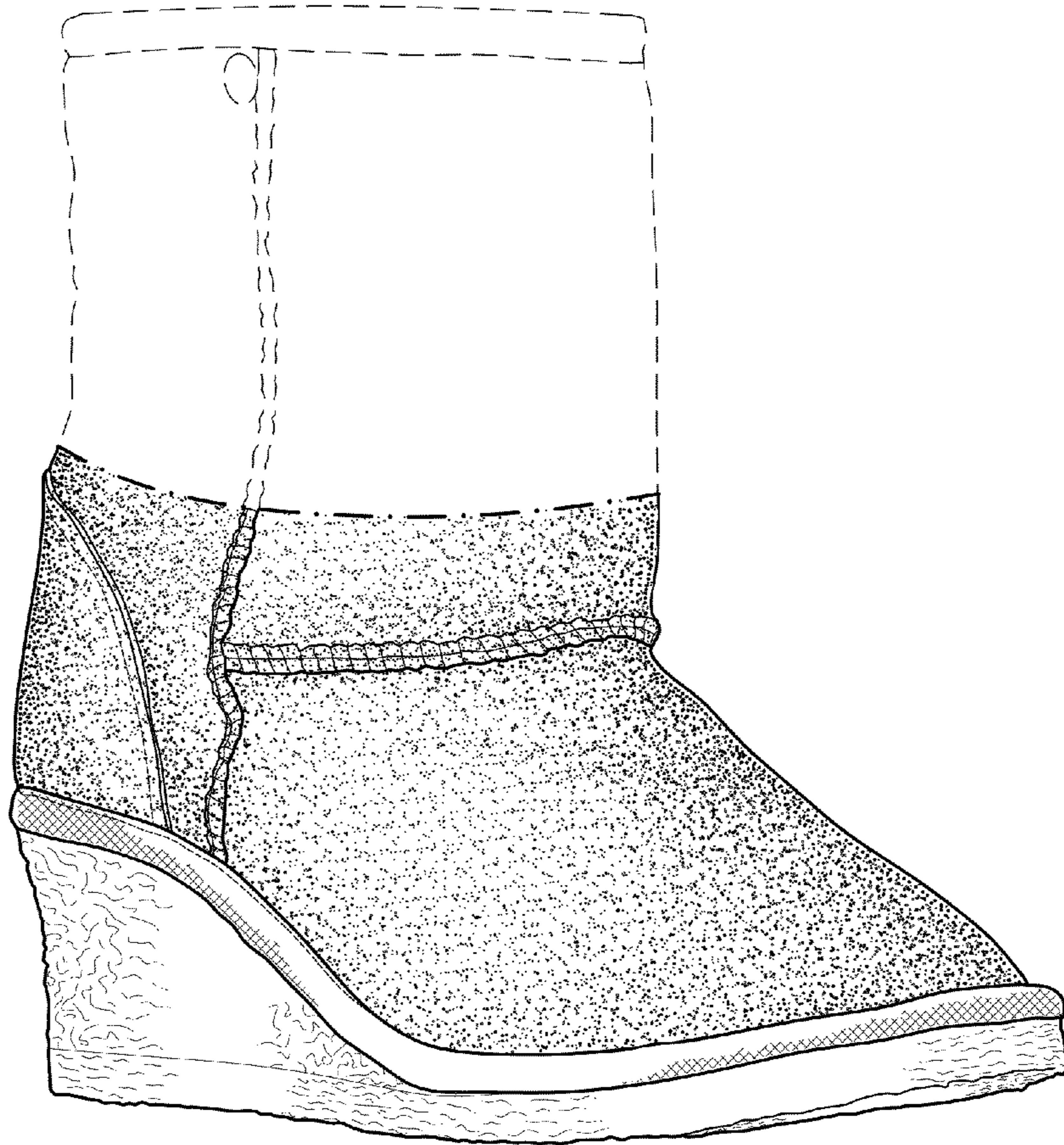

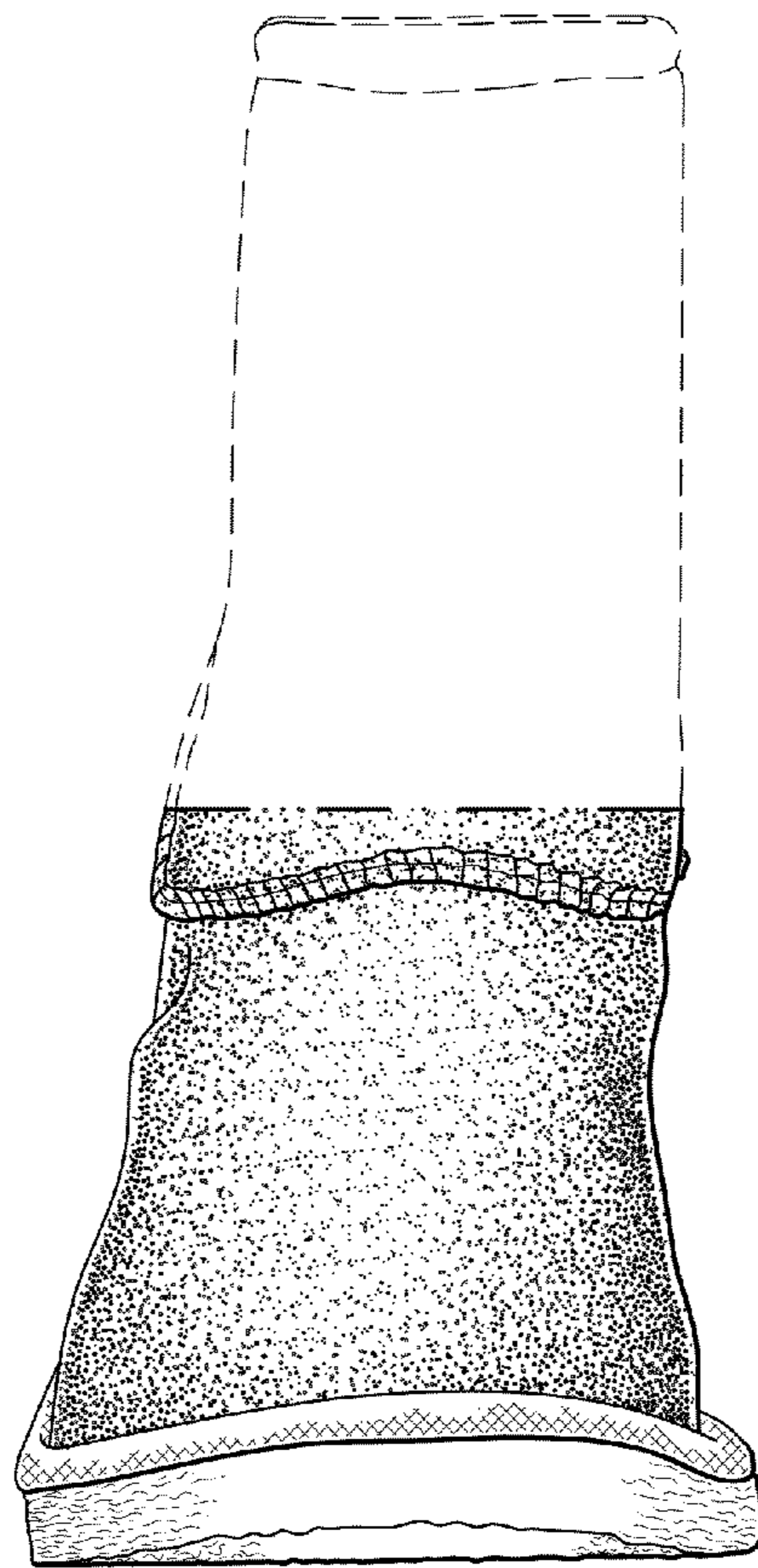

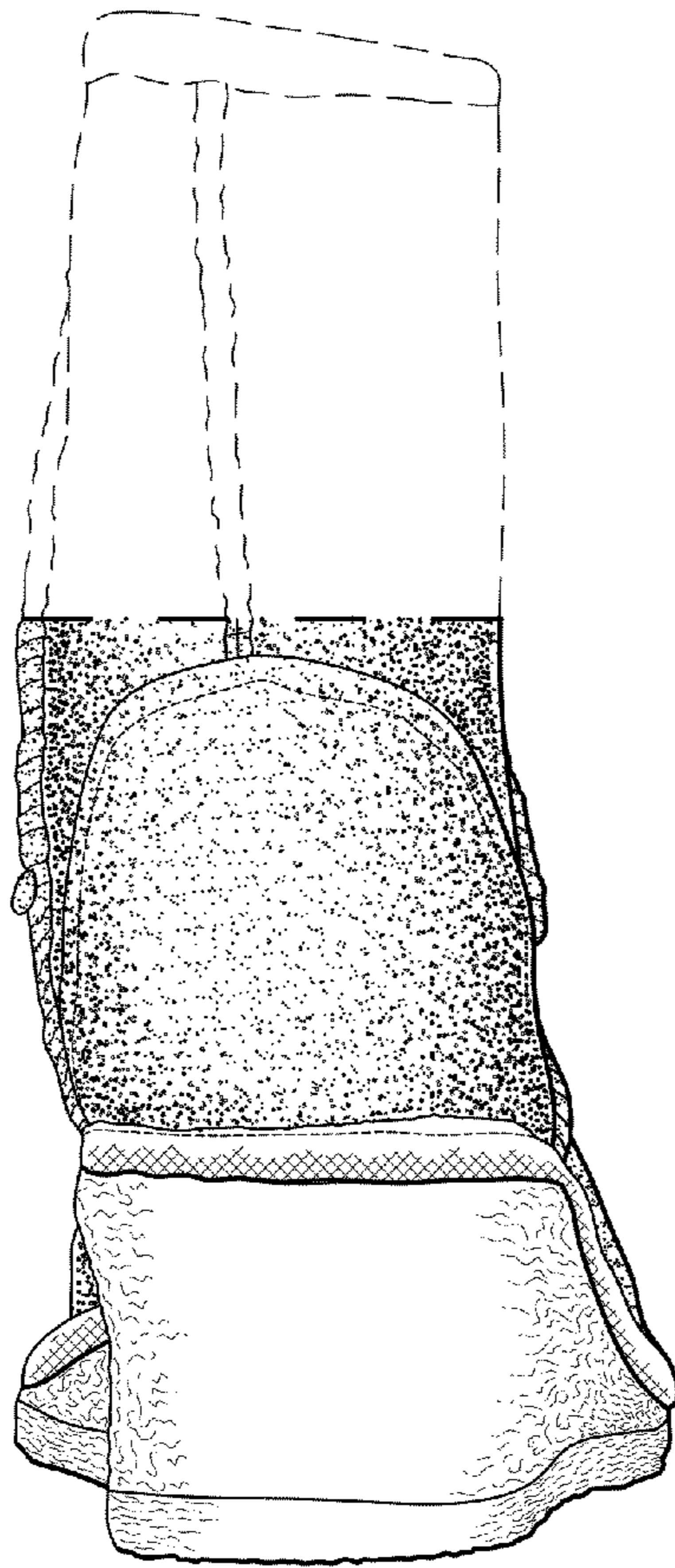

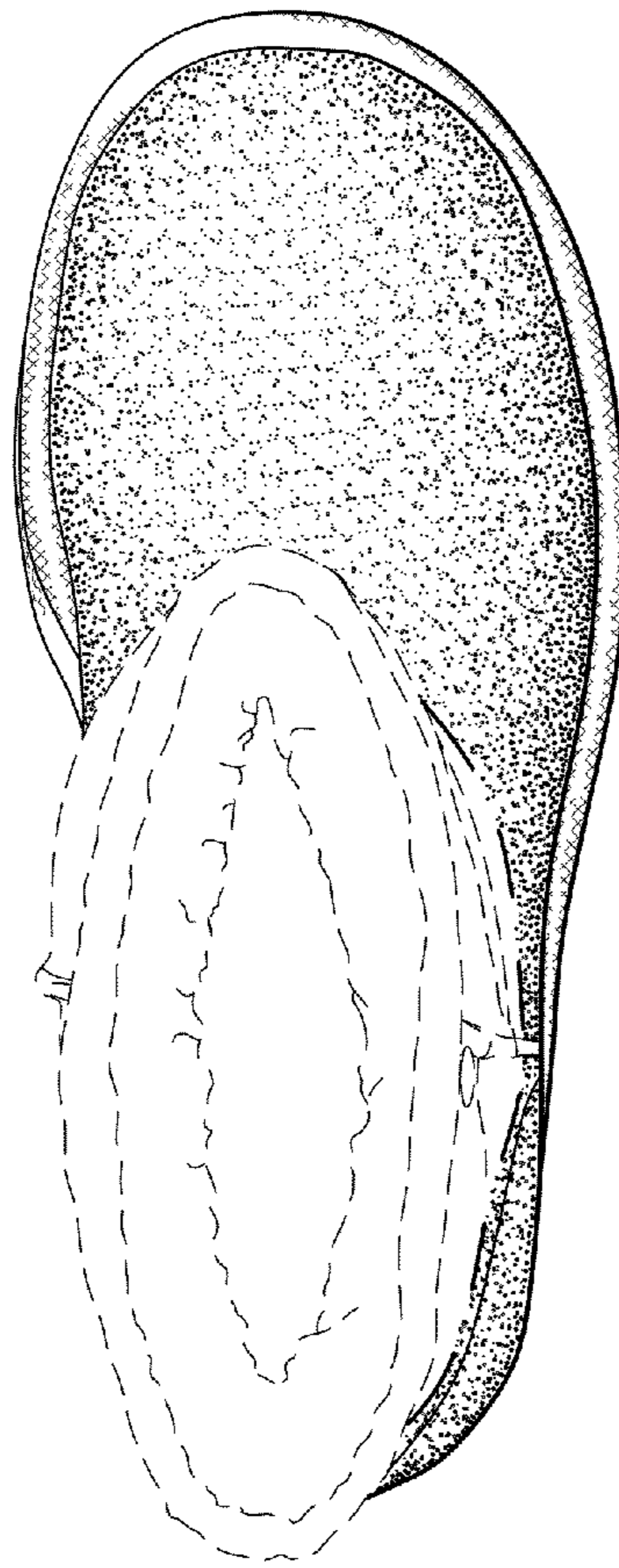

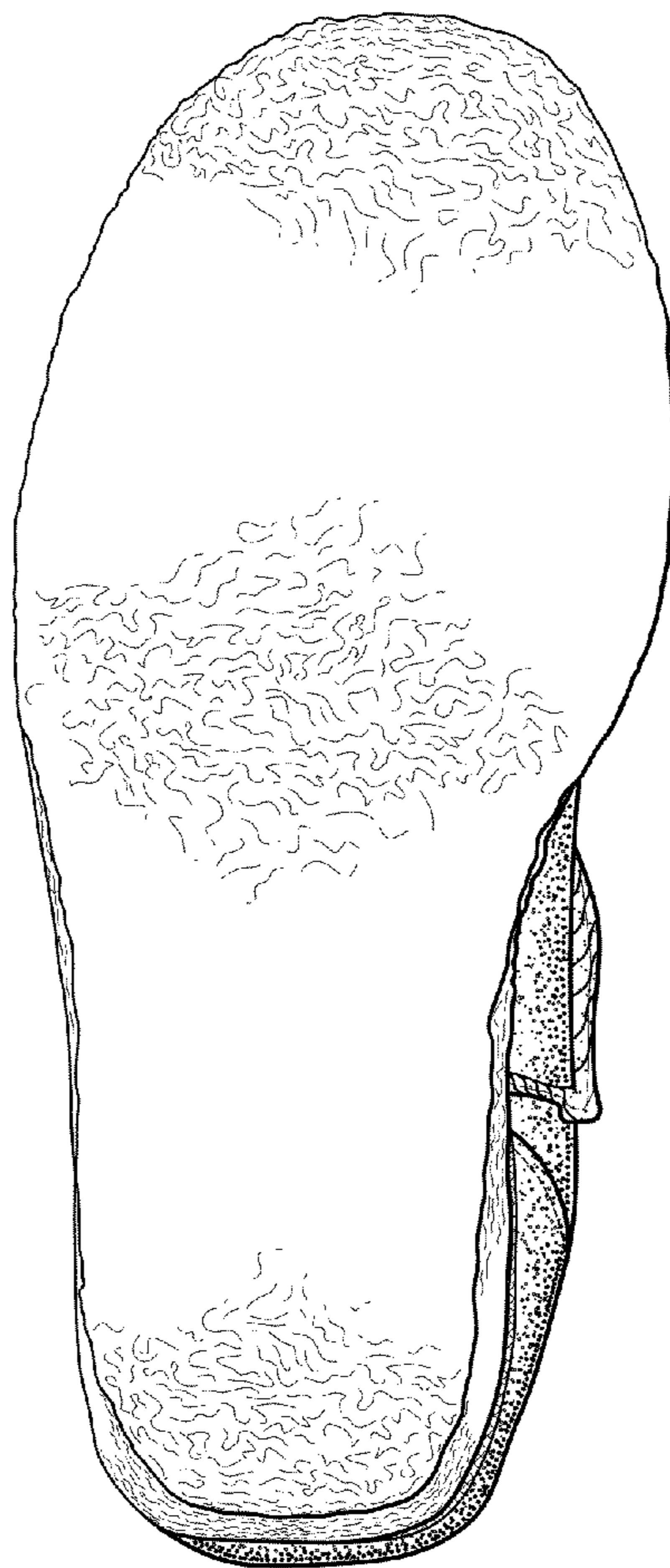
