(57) **CLAIM**

The ornamental design for a paper with a pattern, as shown and described.

**DESCRIPTION**

The sole FIGURE is a top plan view of a paper with a pattern. The evenly spaced broken lines surrounding the design form the boundaries of the claim and form no part thereof. The thickness of the paper with a pattern forms no part of the claimed design.
