(57) **CLAIM**

The ornamental design for a applique for apparel, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the applique for apparel shown in a position of use on an armband; and,  
 FIG. 2 is a front view of the applique for apparel shown in a position of use on a stocking.  
 The stippling indicates color contrast.  
 The claim is directed to the solid lines and the shaded areas within the solid lines.  
 The broken lines and the area around the design represent environmental subject matter that forms no part of the claim.

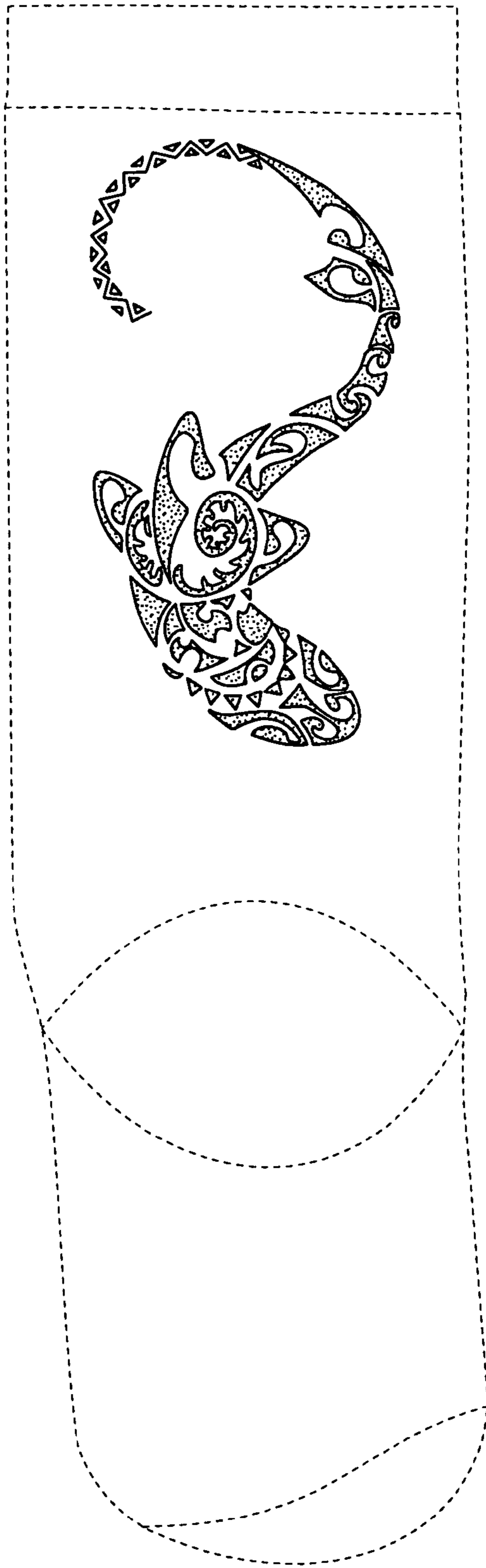
