(57) **CLAIM**

We claim the ornamental design for dresser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dresser according to the invention. The perspective view from the adjacent front corner being a mirror image thereto.

FIG. 2 is a front elevational view of a dresser according to the invention.

FIG. 3 is a side elevational view of a dresser according to the invention. The view from the opposite side being a mirror image thereto; and,

FIG. 4 is a top plan view of a dresser according to the invention.

The broken lines on the dresser in the figures are for illustrative purposes only and form no part of the claimed invention. The backside and bottom side of the dresser are not shown and form no part of the claimed invention.

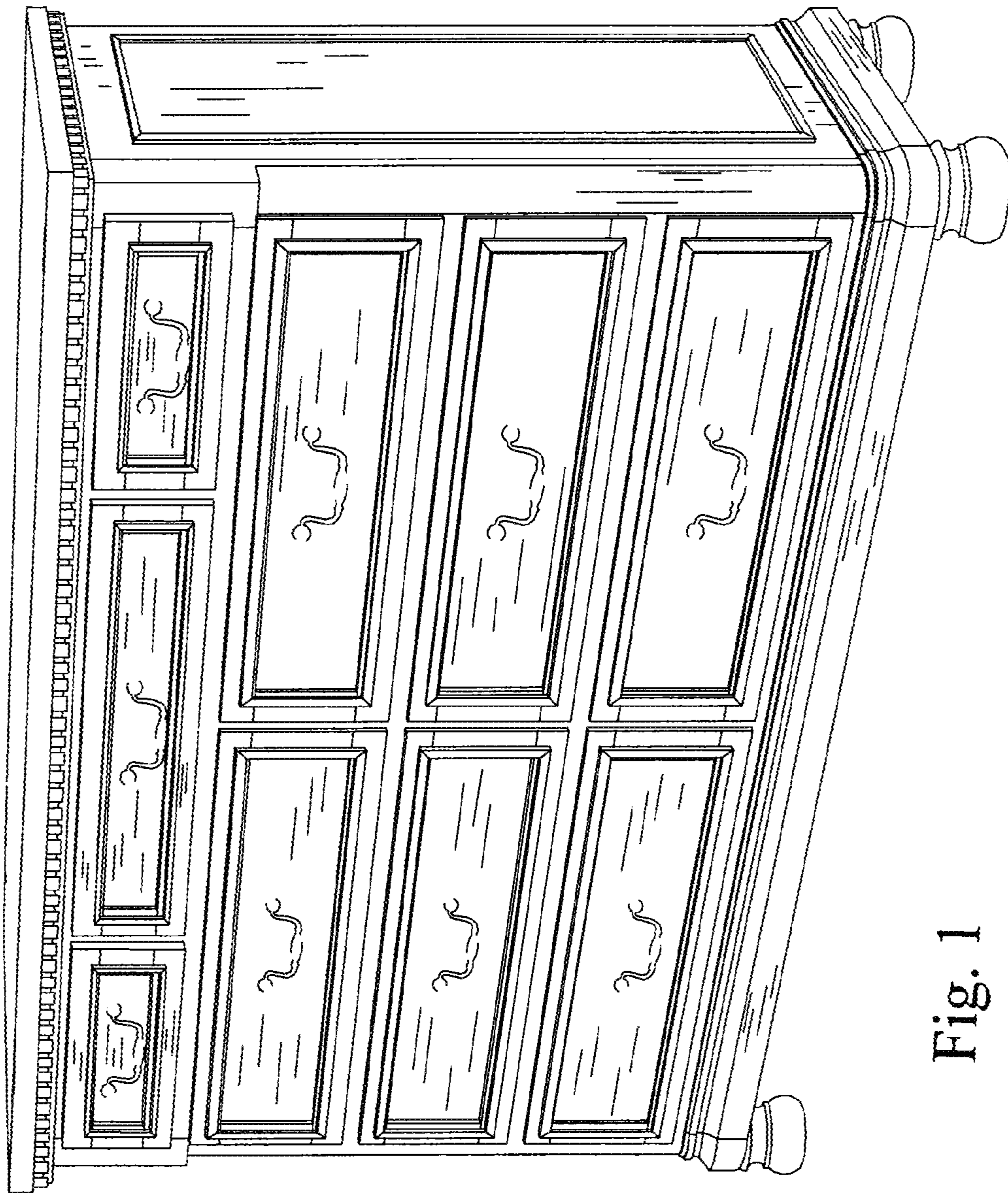

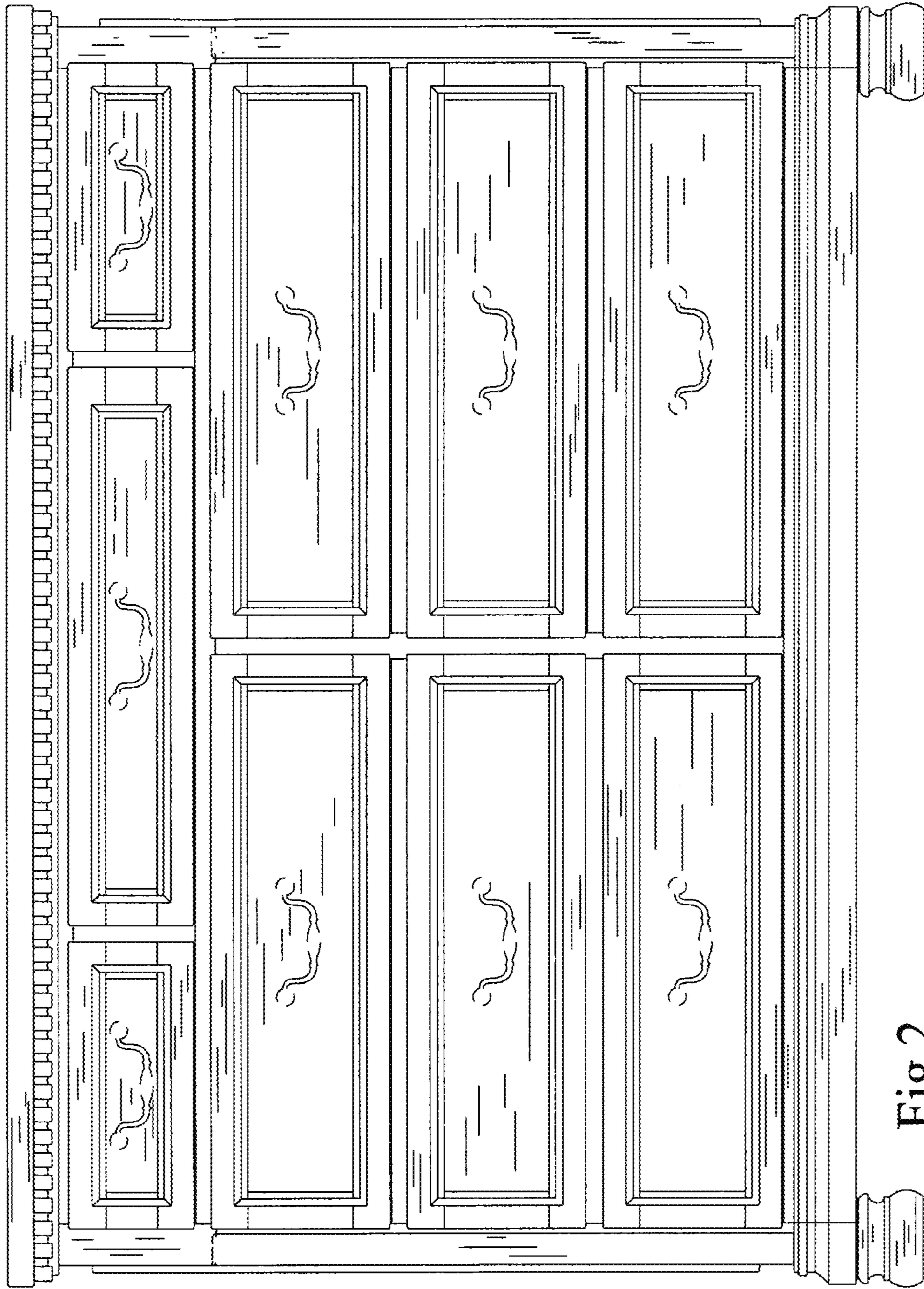

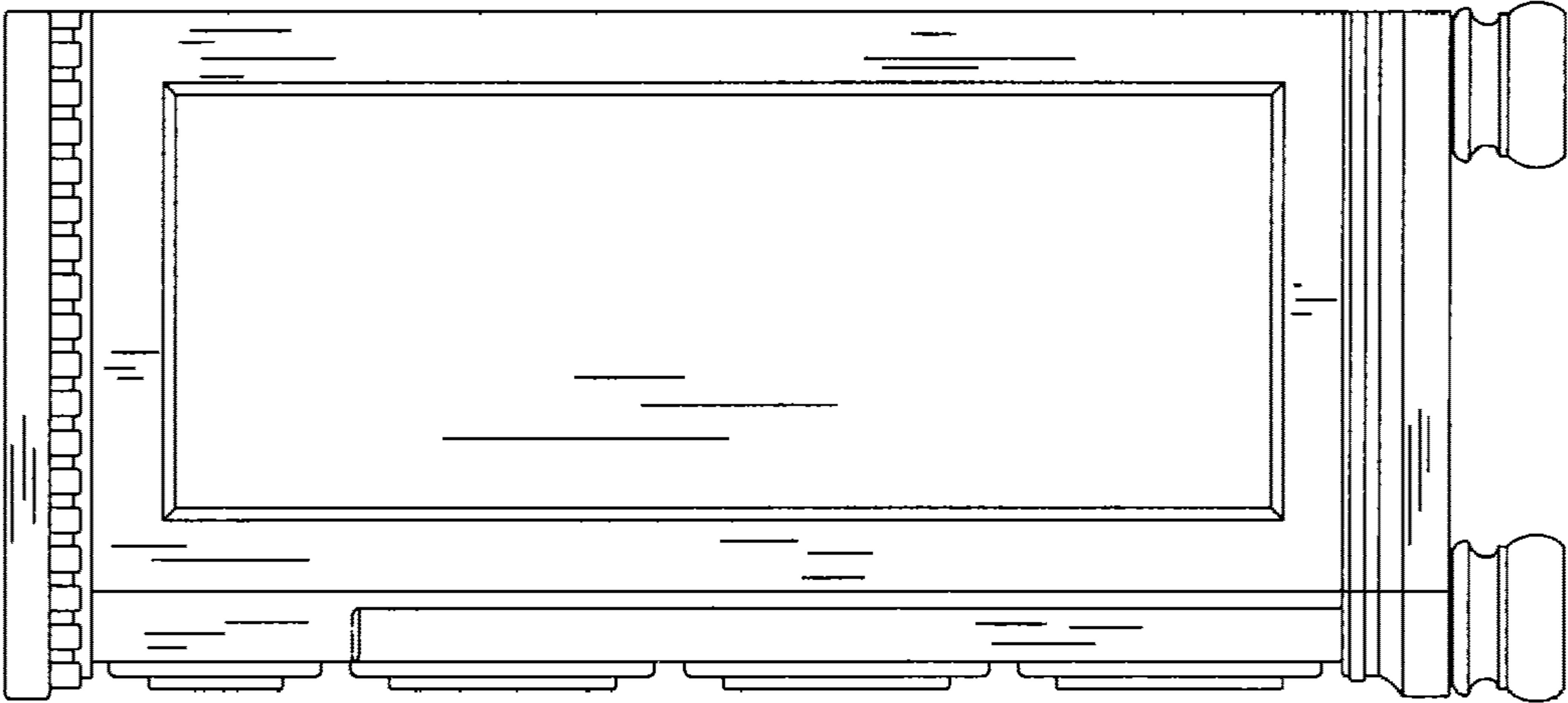

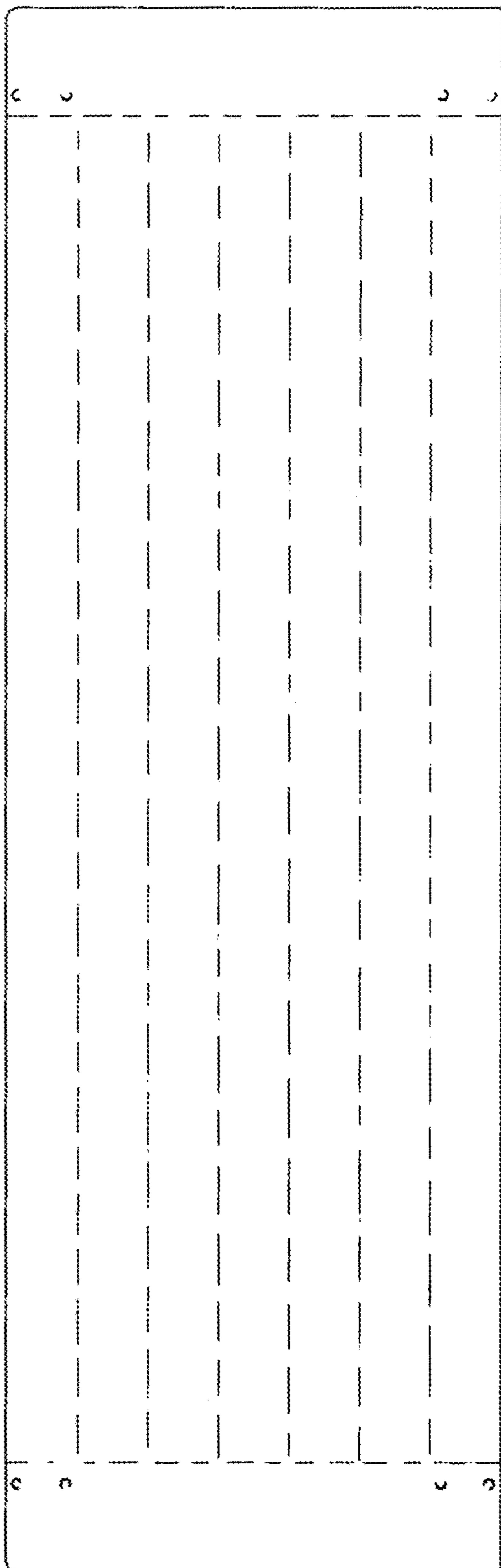
