(57) **CLAIM**

The ornamental design for a sanitary toothbrush holder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a sanitary toothbrush holder of the present invention;

FIG. 2 is a rear view of the sanitary toothbrush holder of FIG. 1;

FIG. 3 is a top view of the sanitary toothbrush holder of FIG. 1;

FIG. 4 is a bottom view of the sanitary toothbrush holder of FIG. 1;

FIG. 5 is a side view of the sanitary toothbrush holder of FIG. 1;

FIG. 6 is the other side view of the sanitary toothbrush holder of FIG. 1;

FIG. 7 is a front perspective view of the sanitary toothbrush holder of FIG. 1;

FIG. 8 is a front view of a sanitary toothbrush holder of another embodiment of the present invention;

FIG. 9 is a rear view of the sanitary toothbrush holder of FIG. 8;

FIG. 10 is a top view of the sanitary toothbrush holder of FIG. 8;

FIG. 11 is a bottom view of the sanitary toothbrush holder of FIG. 8;

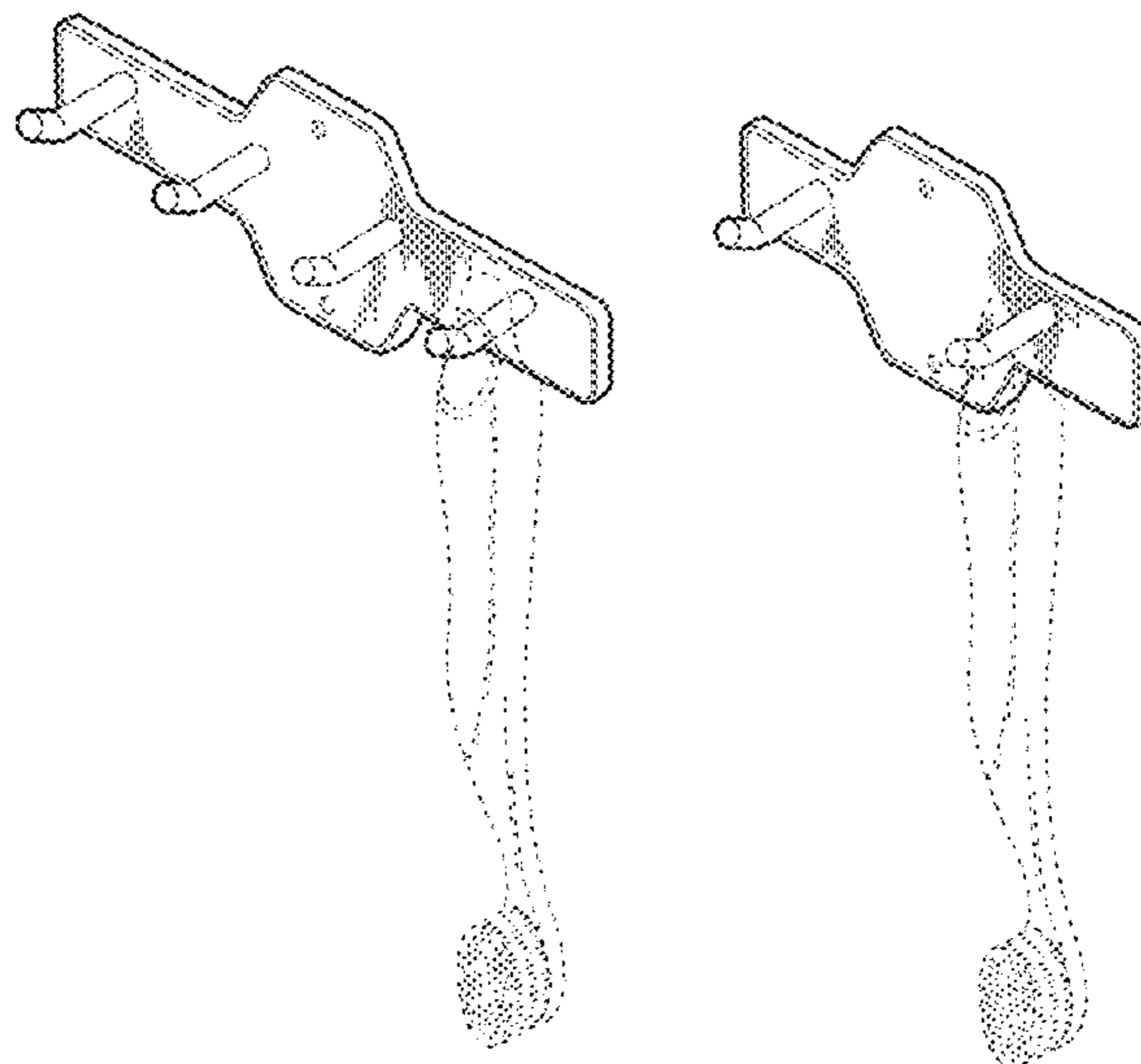
FIG. 12 is a side view of the sanitary toothbrush holder of FIG. 8;

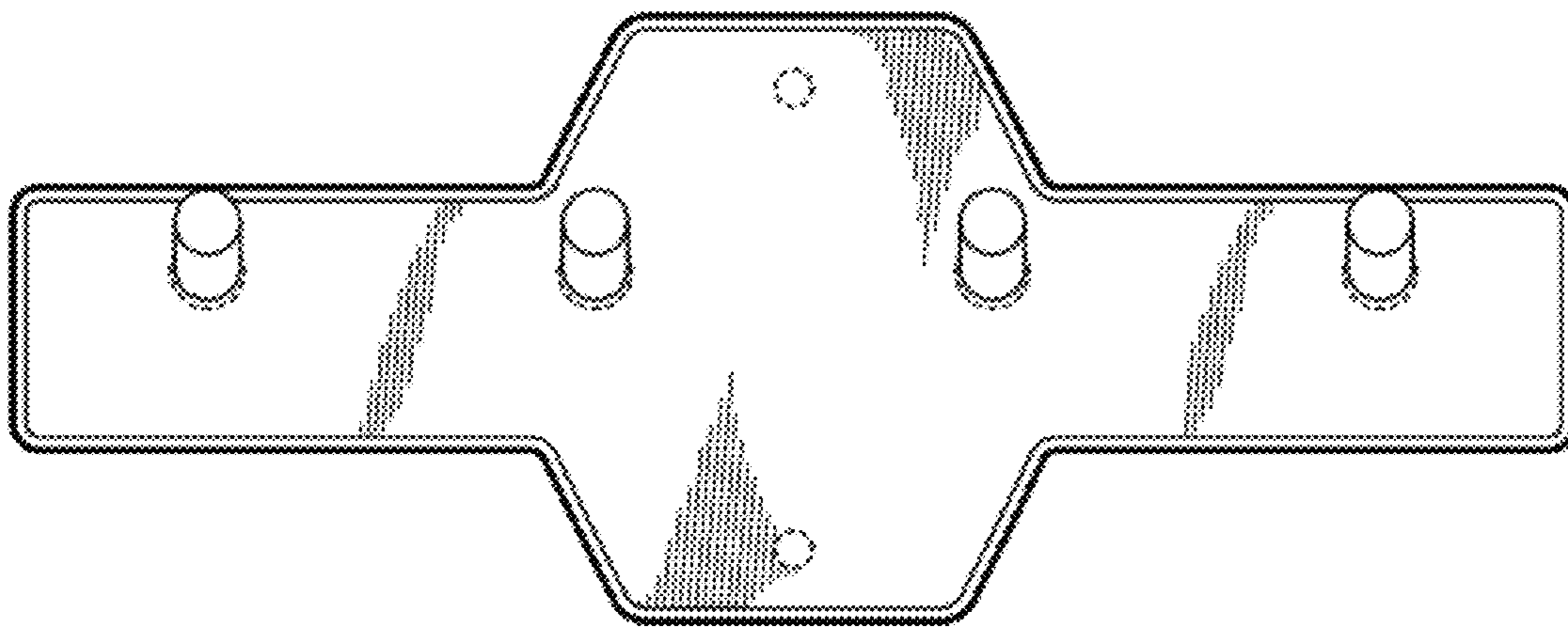

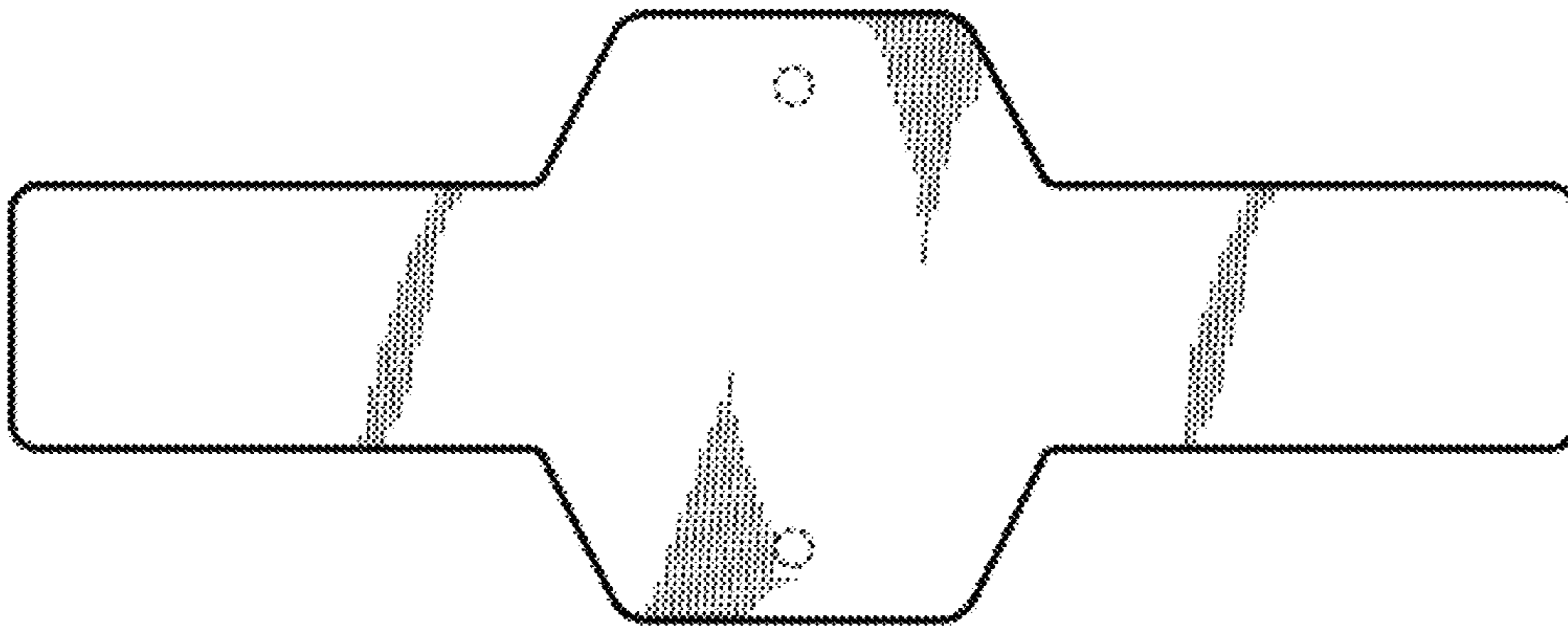

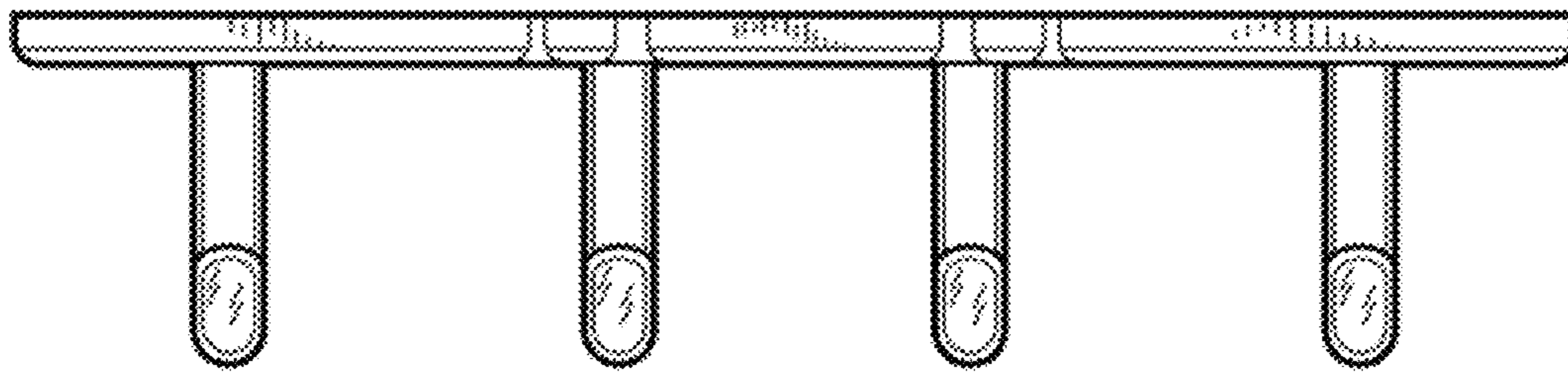

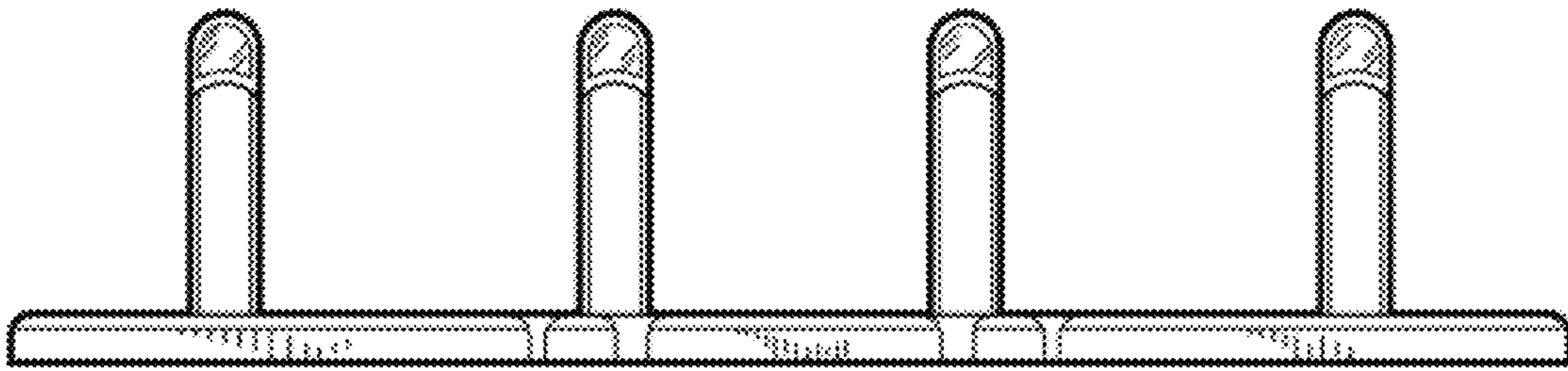

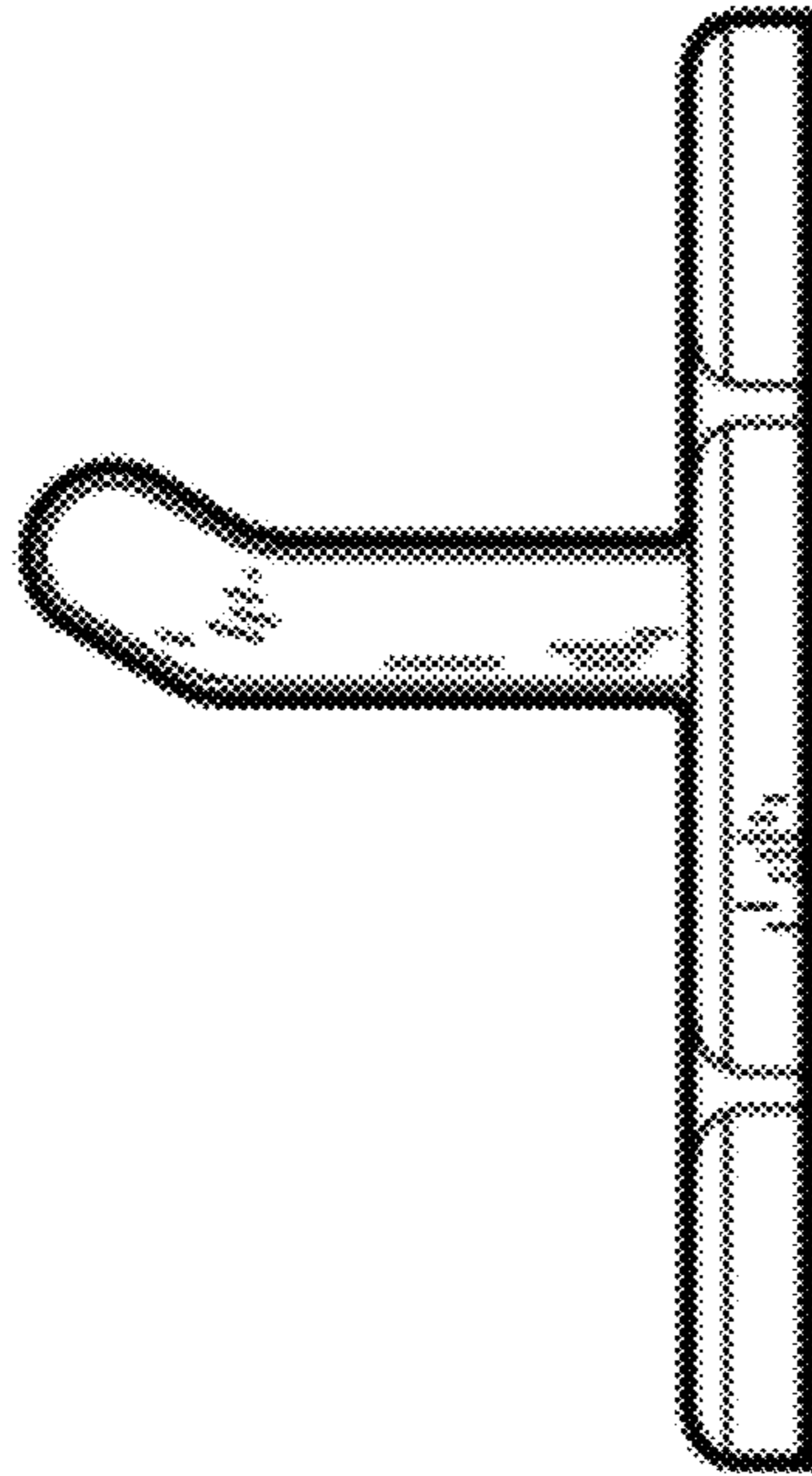

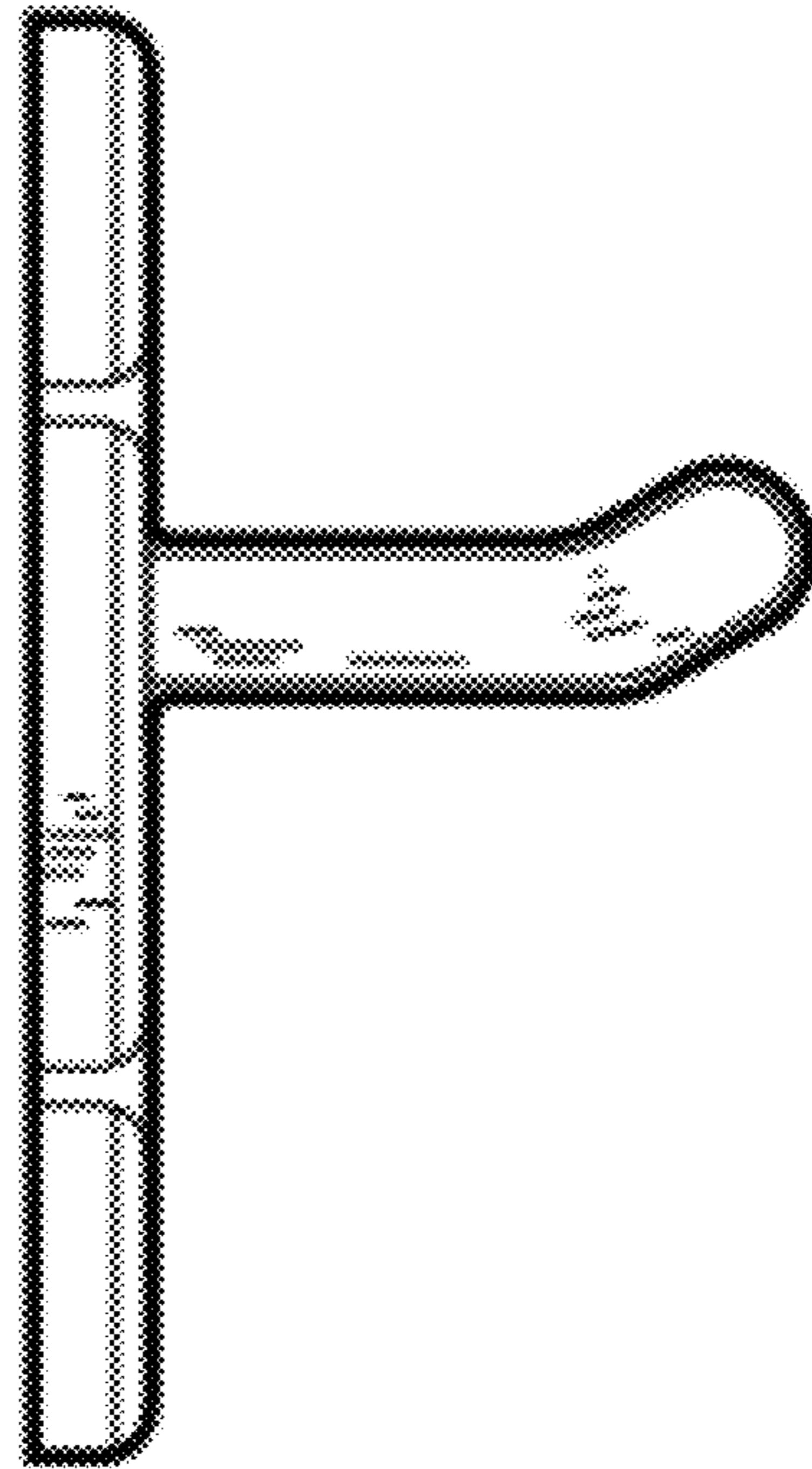

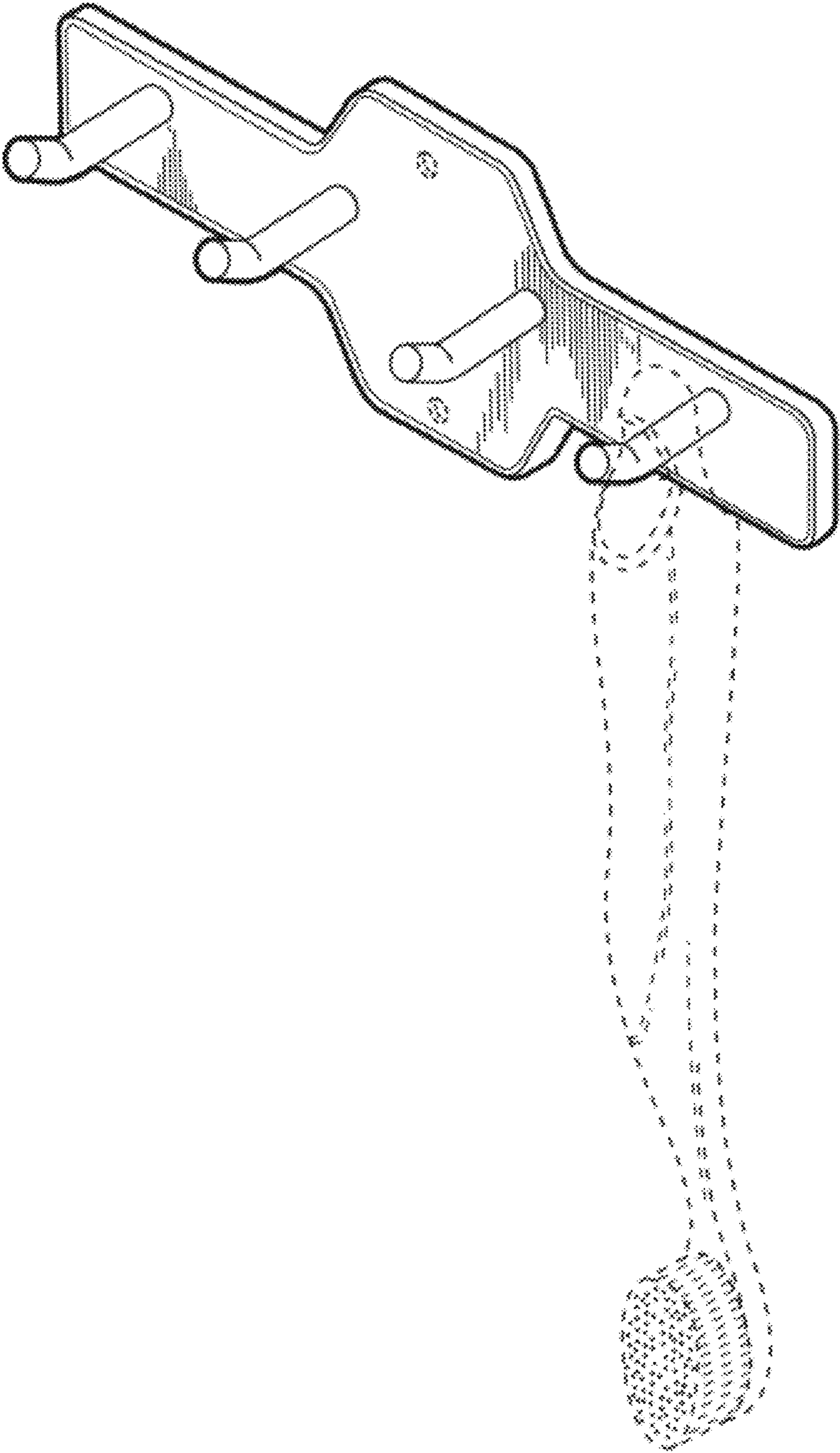

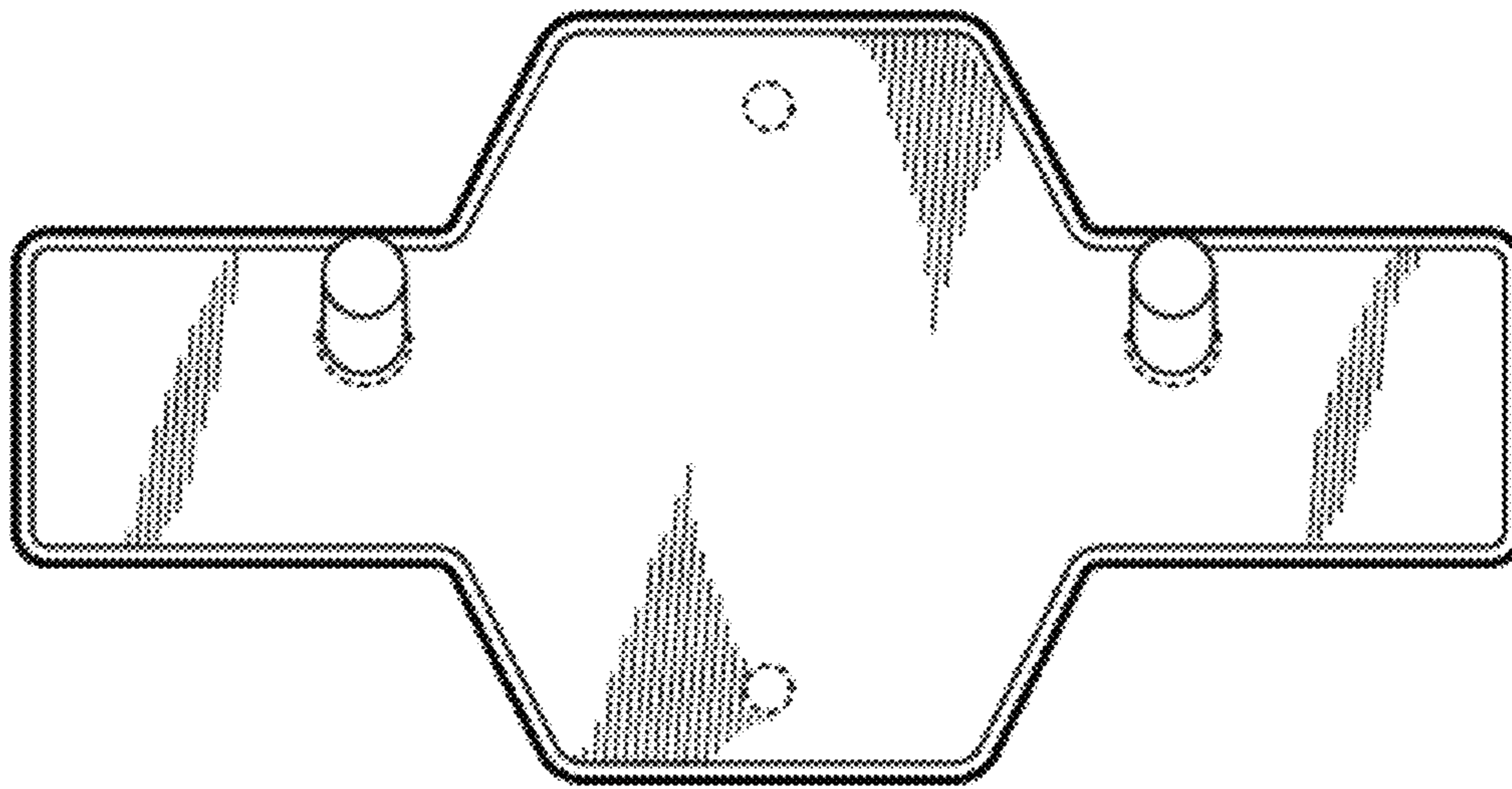

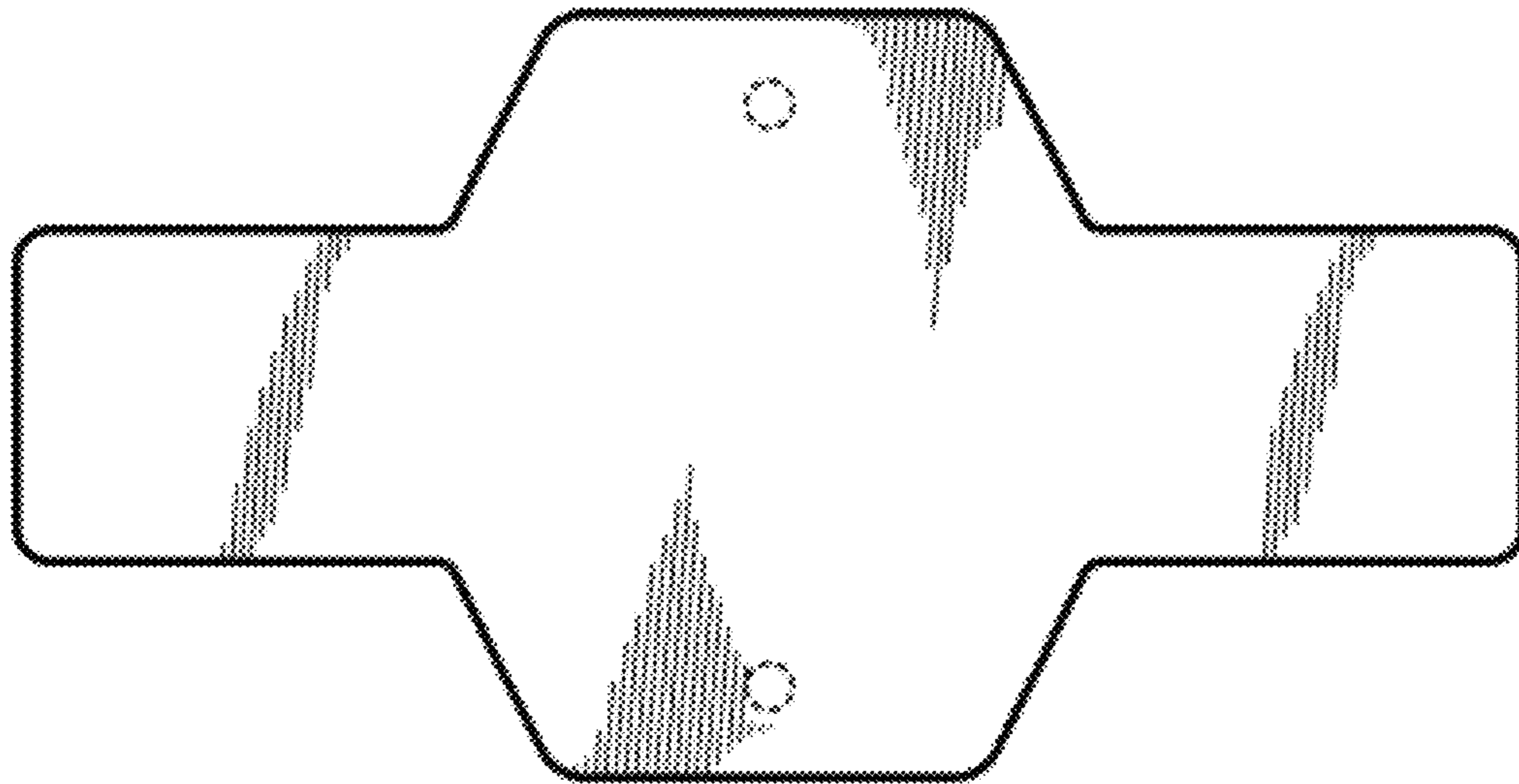

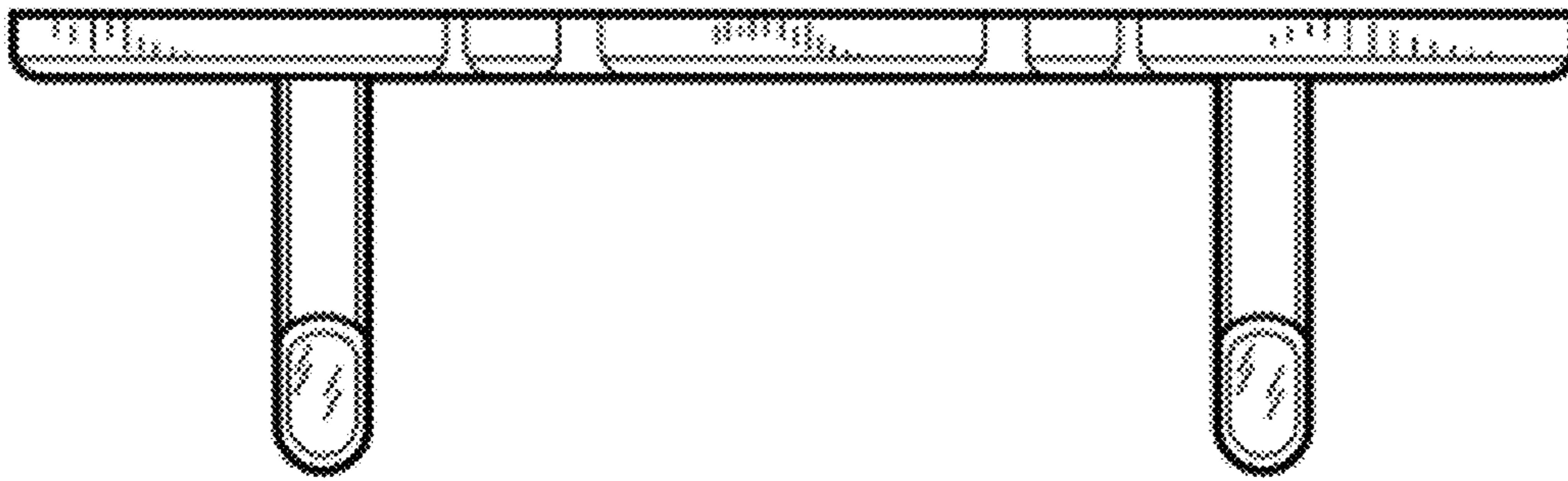

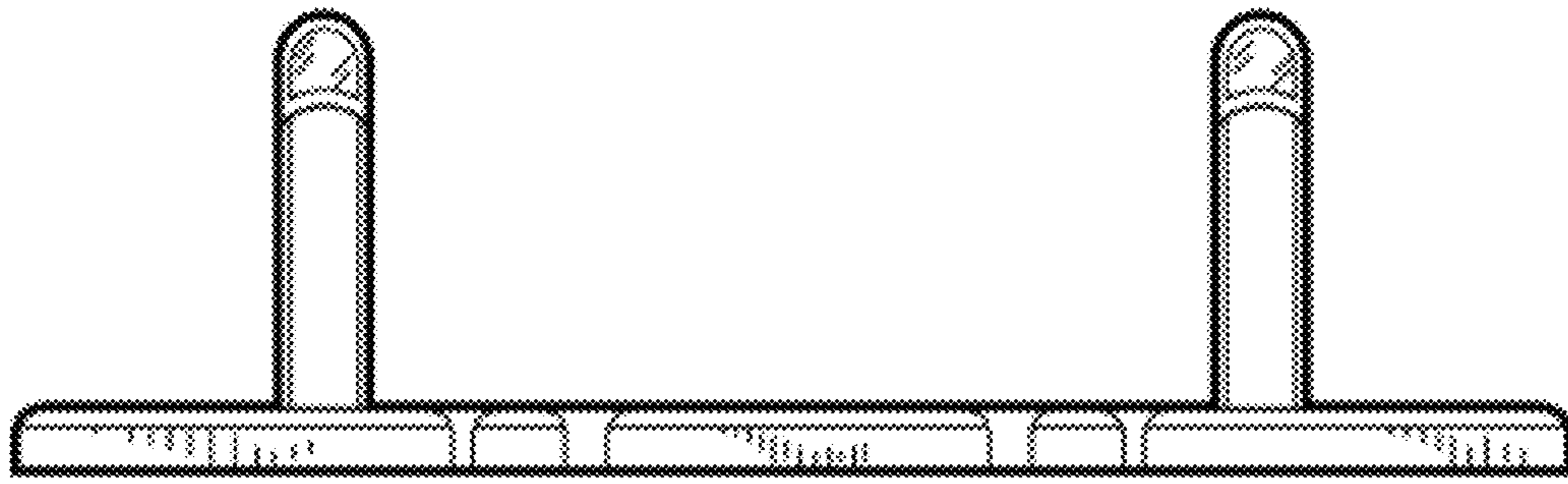

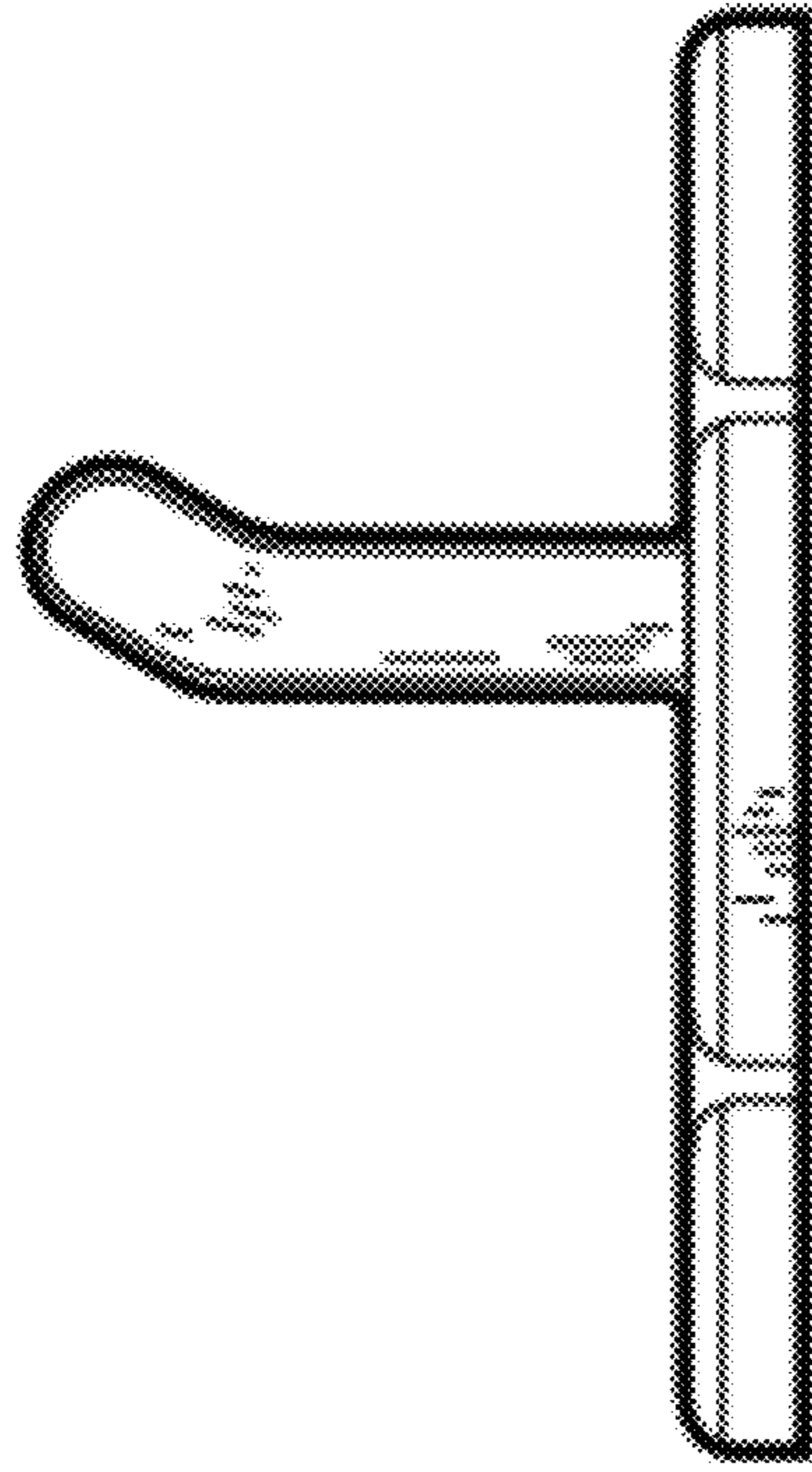

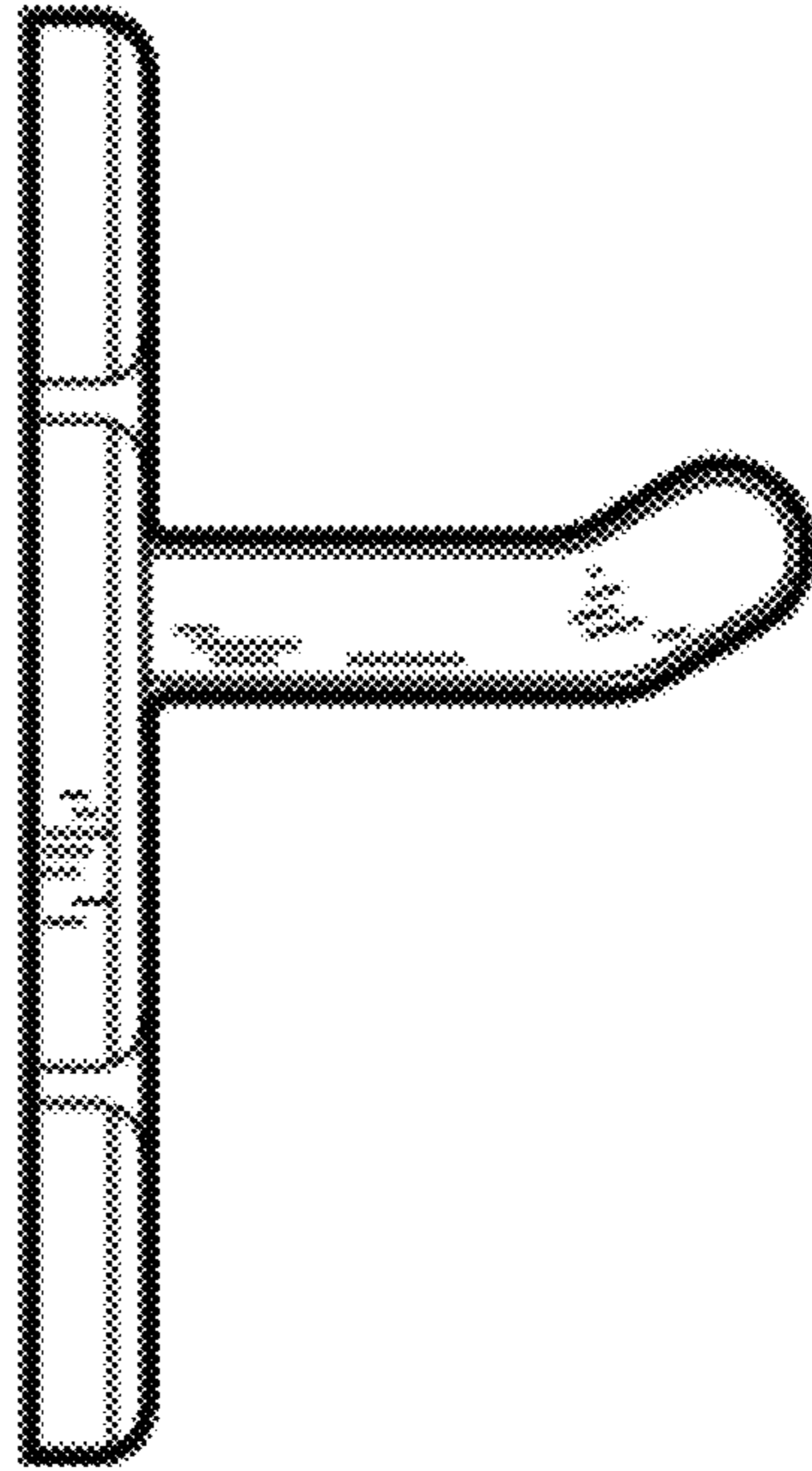

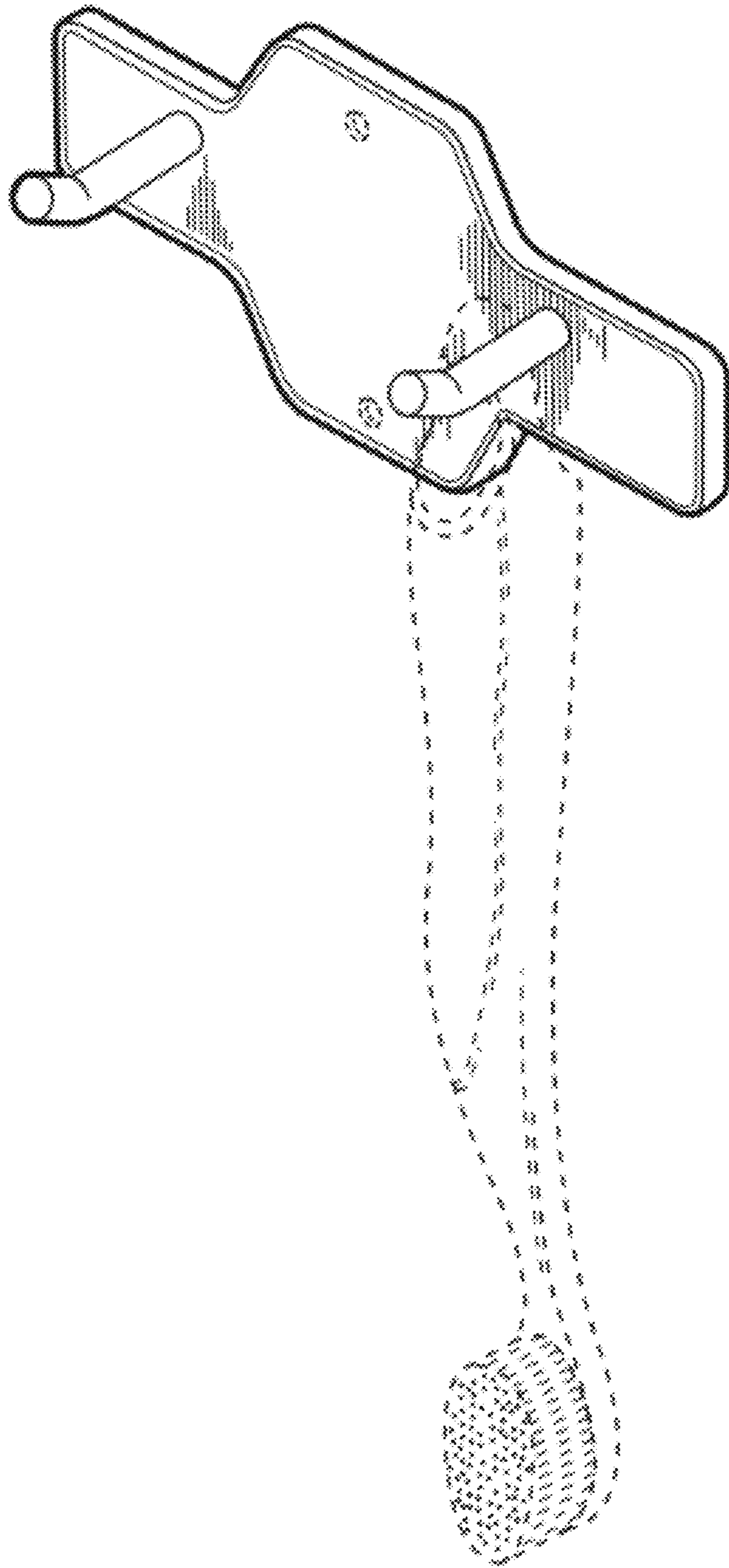
