FIG. 3 is a right side view thereof

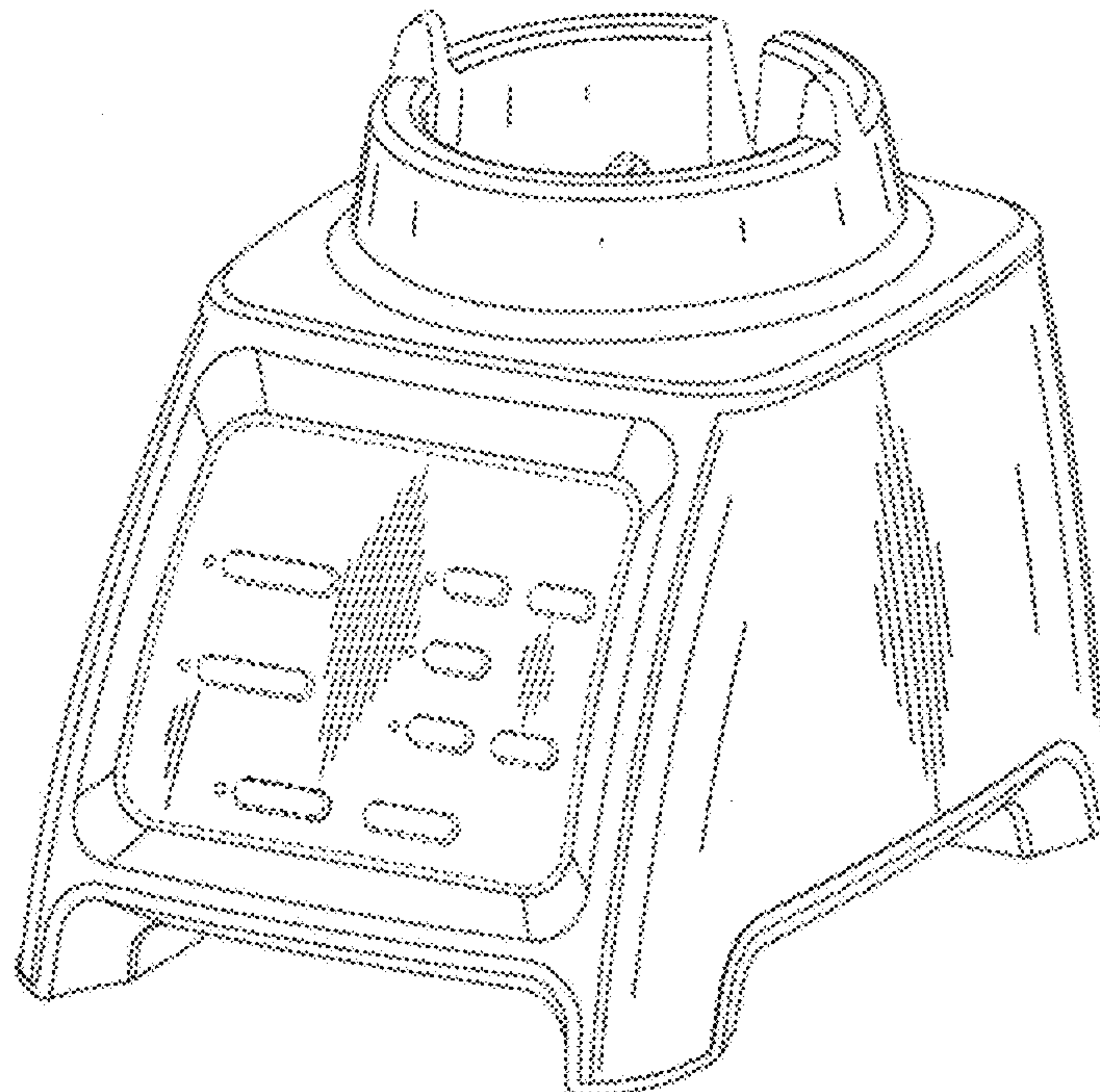
FIG. 4 is a rear view thereof;

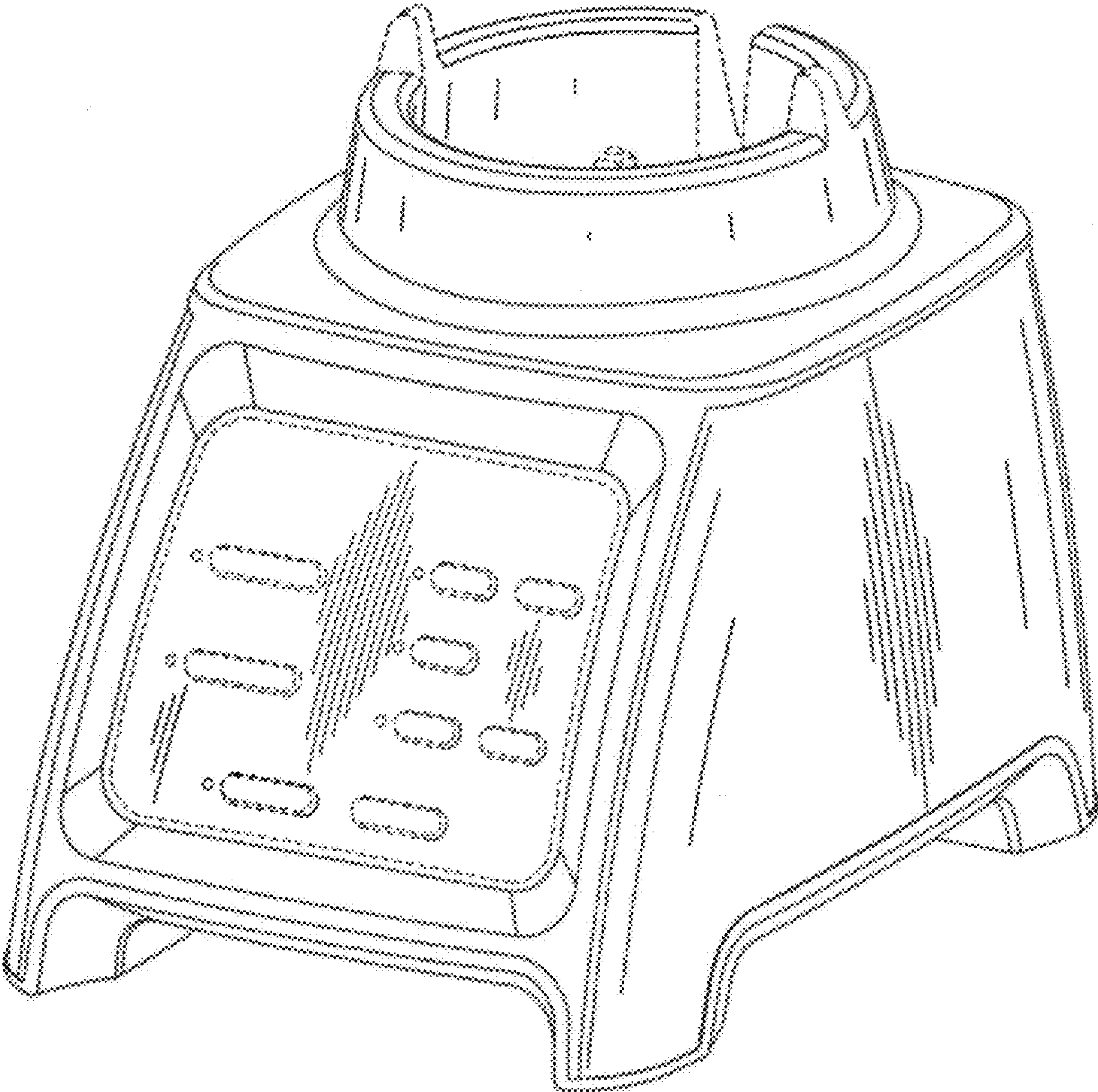

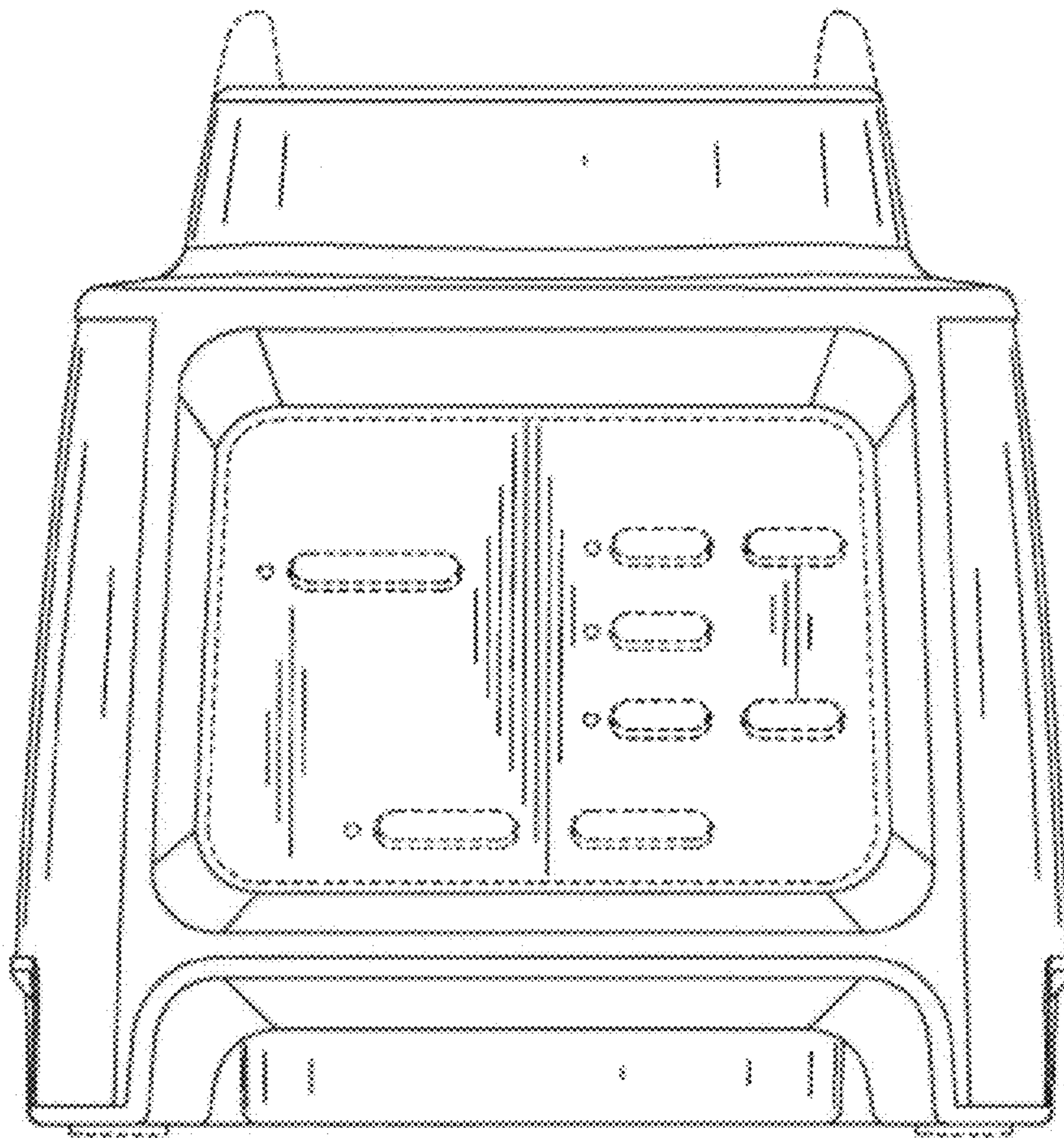

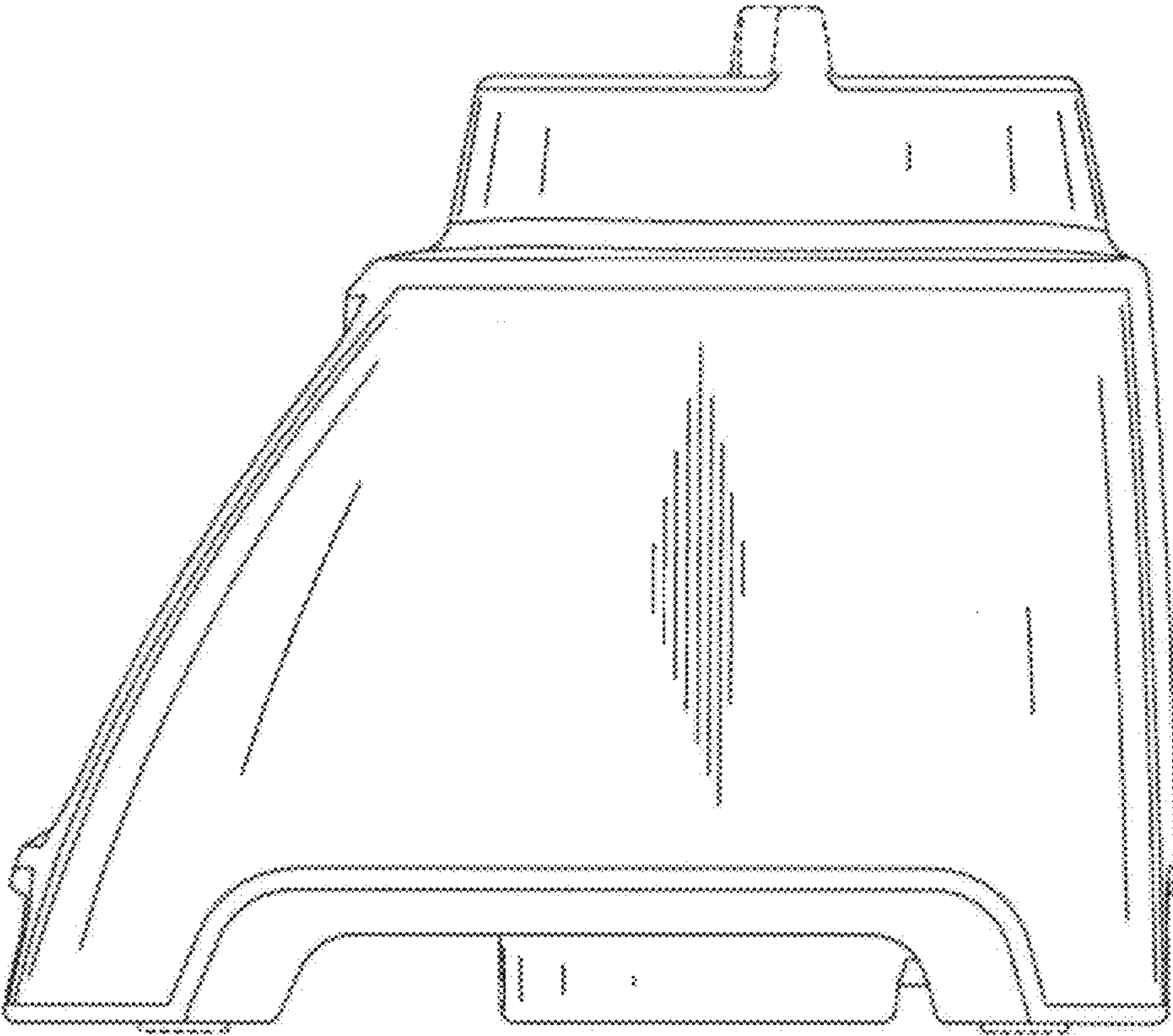

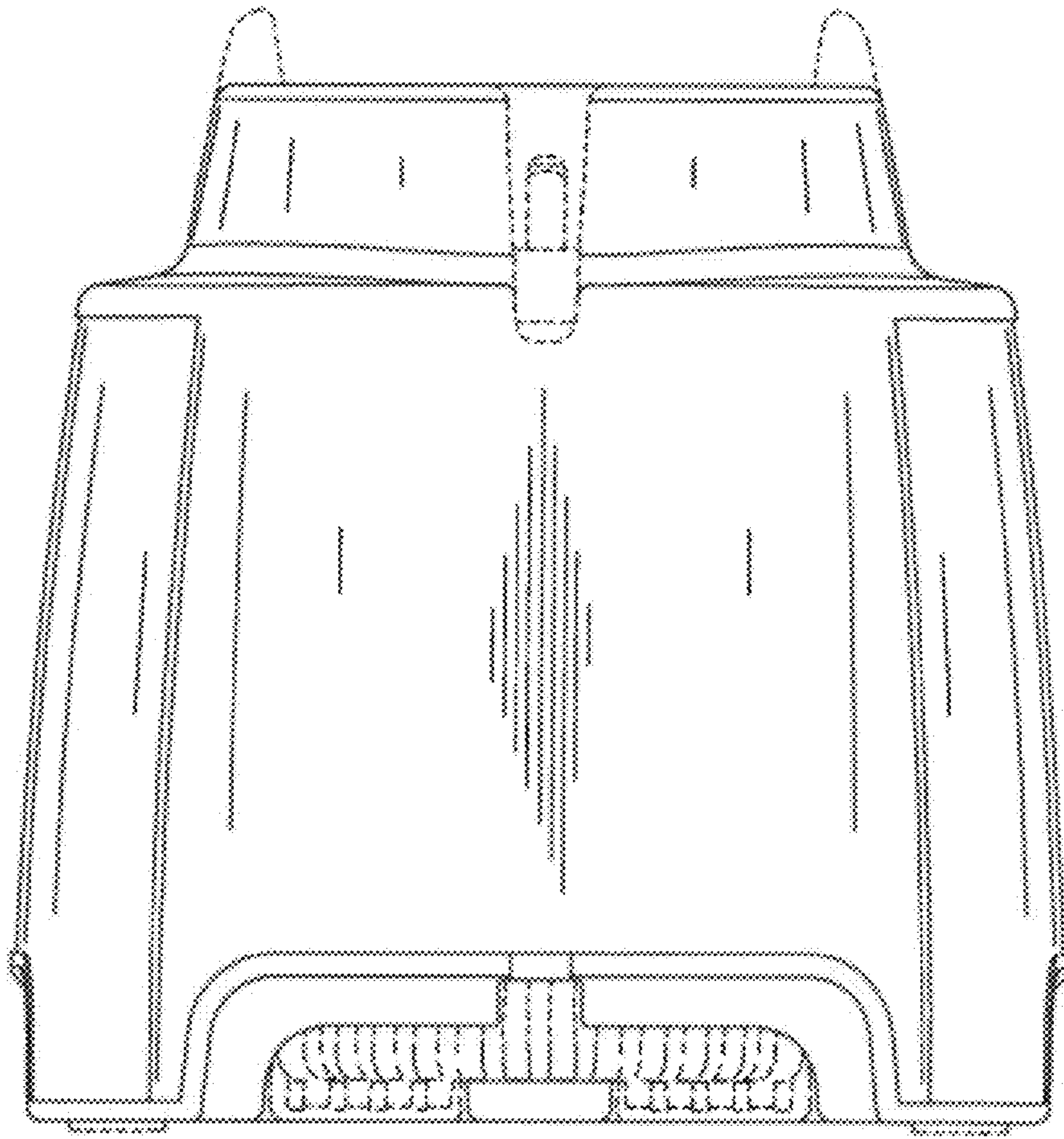

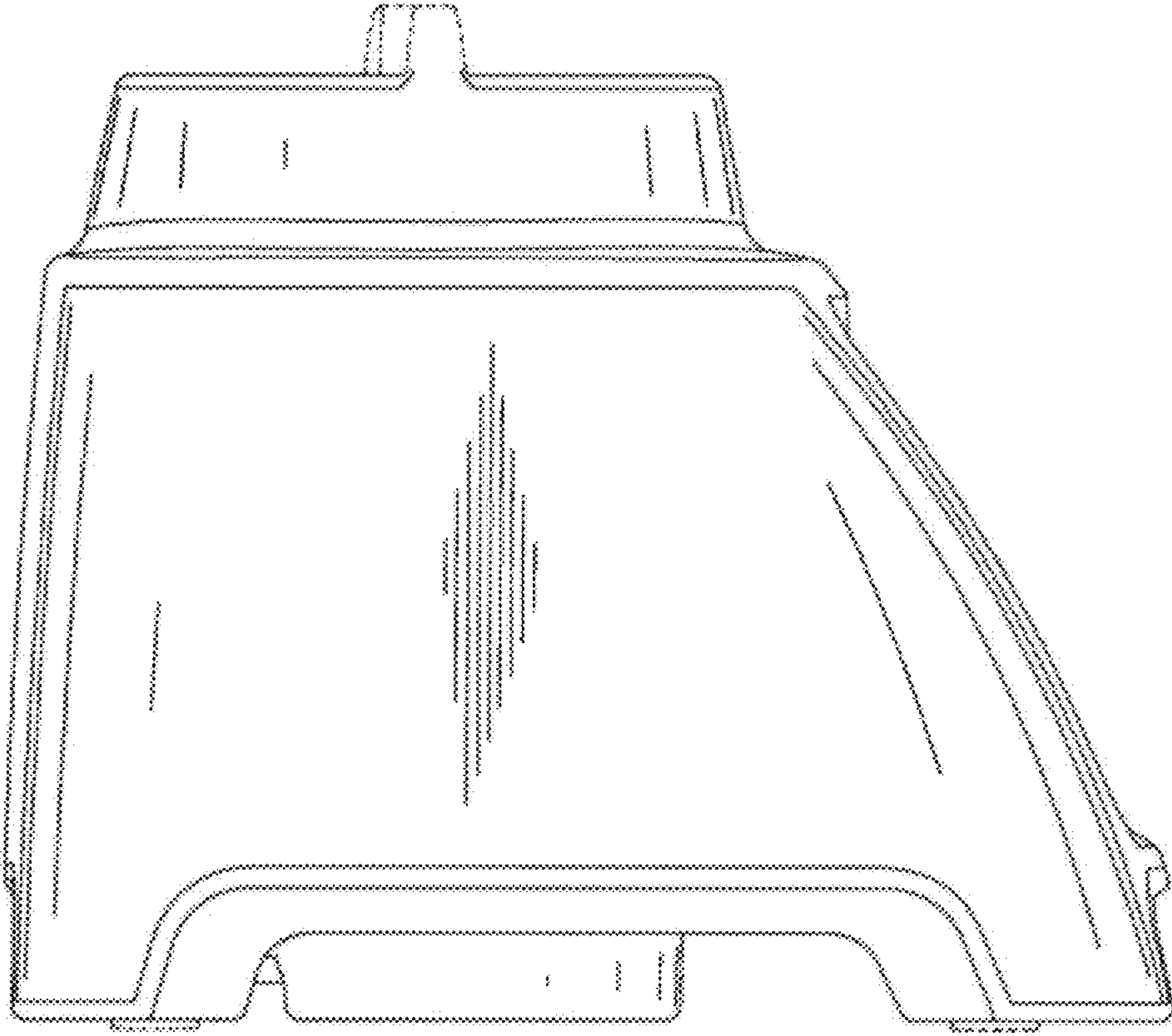

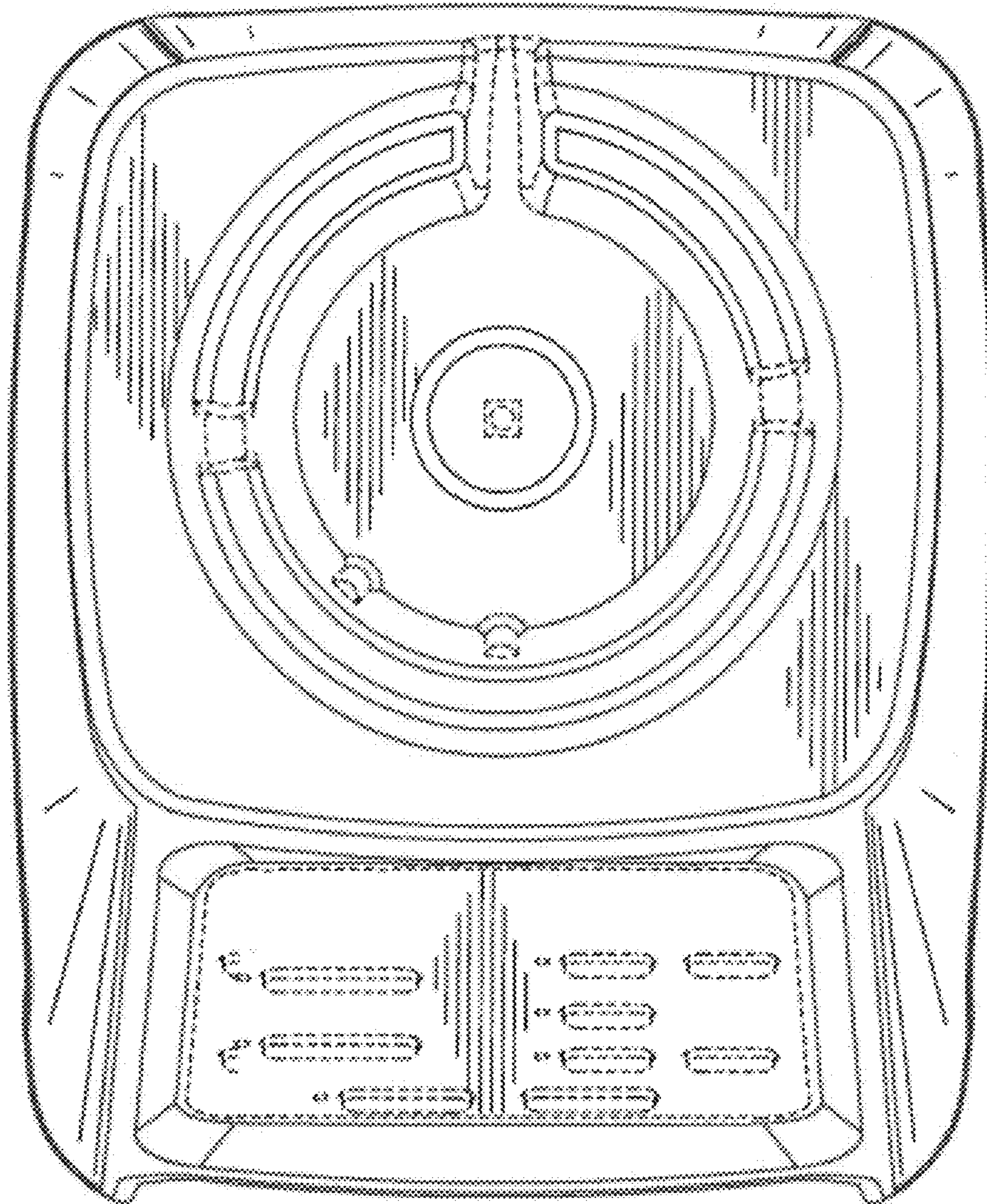
