FIG. 3 is a left perspective view thereof;

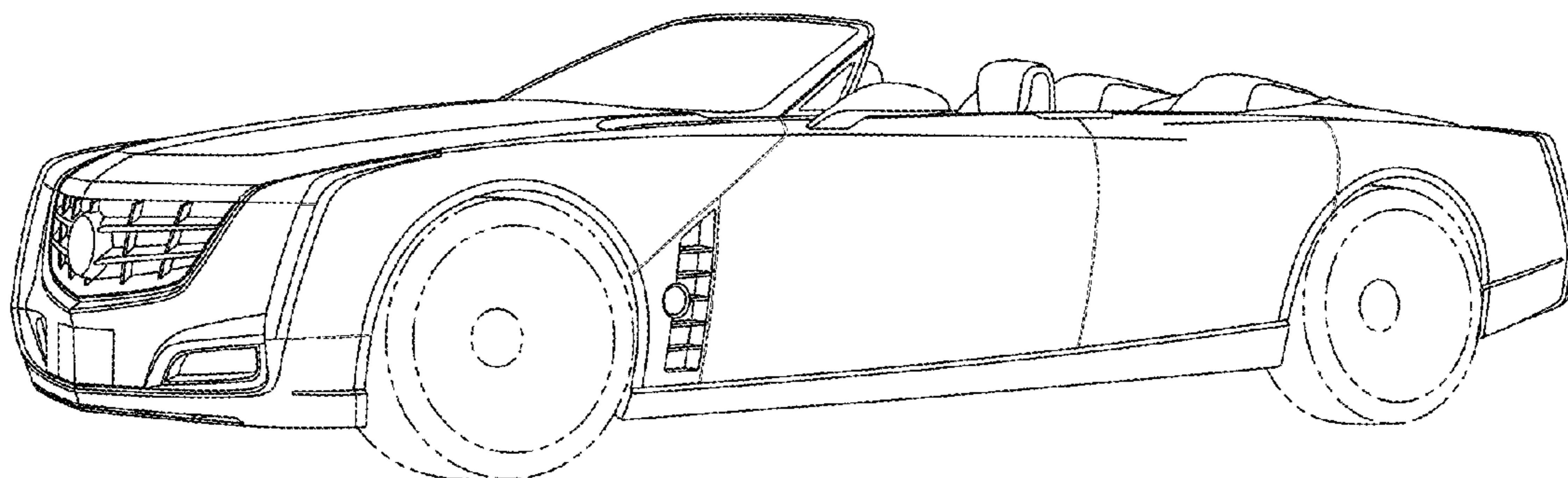
FIG. 4 is a left side view thereof, the right side being a mirror image thereof;

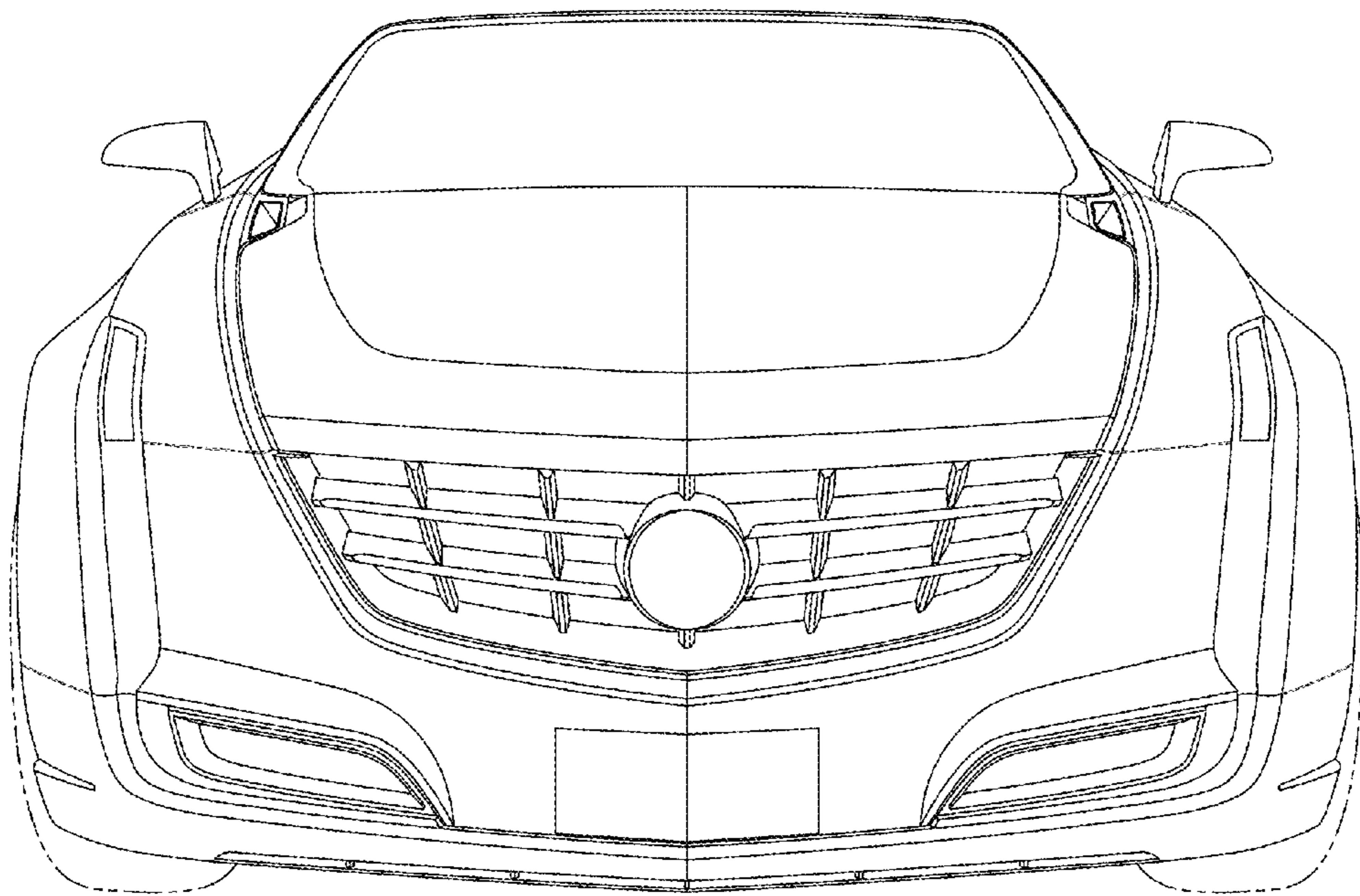

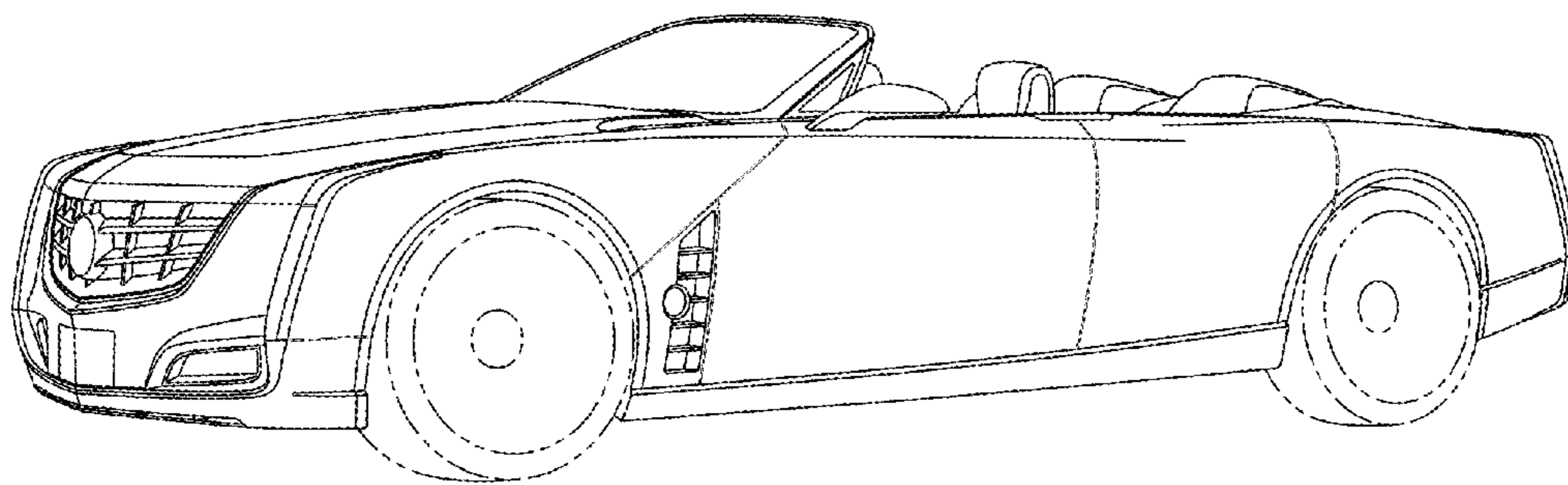

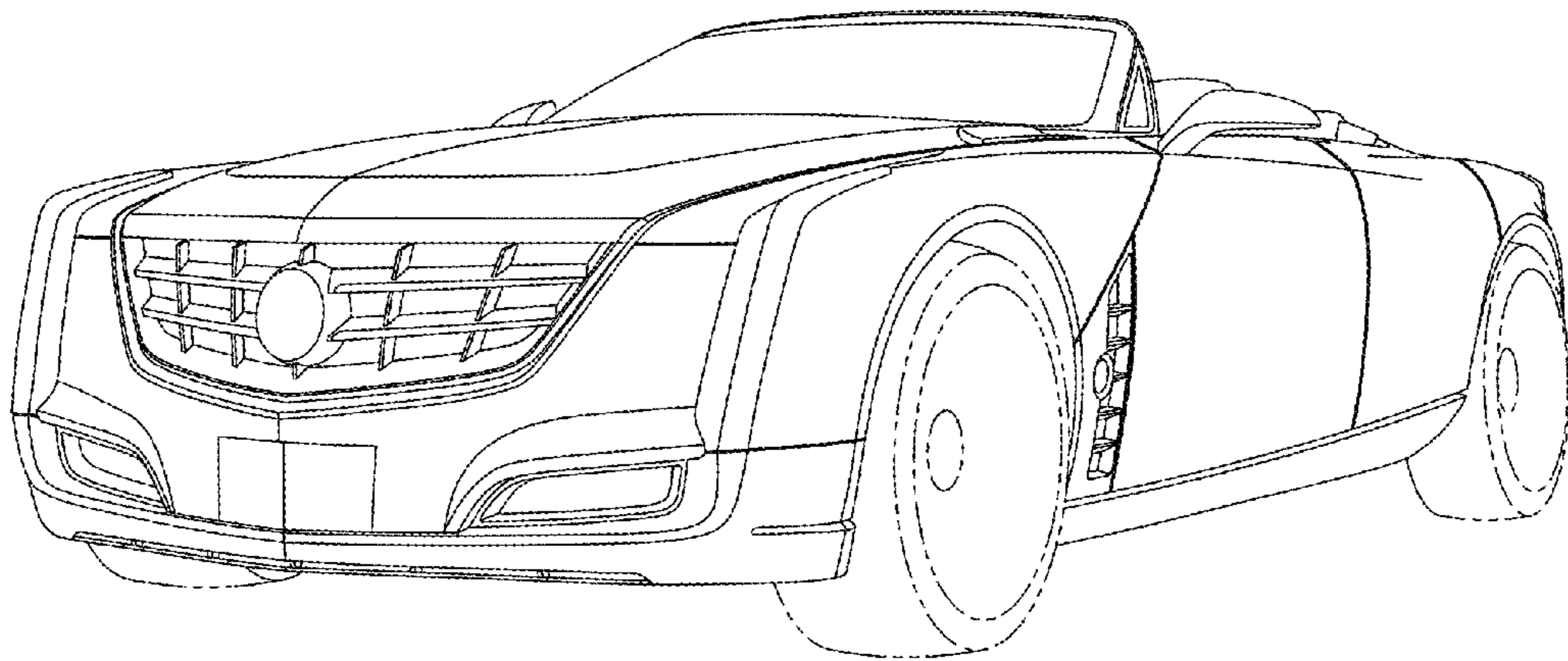

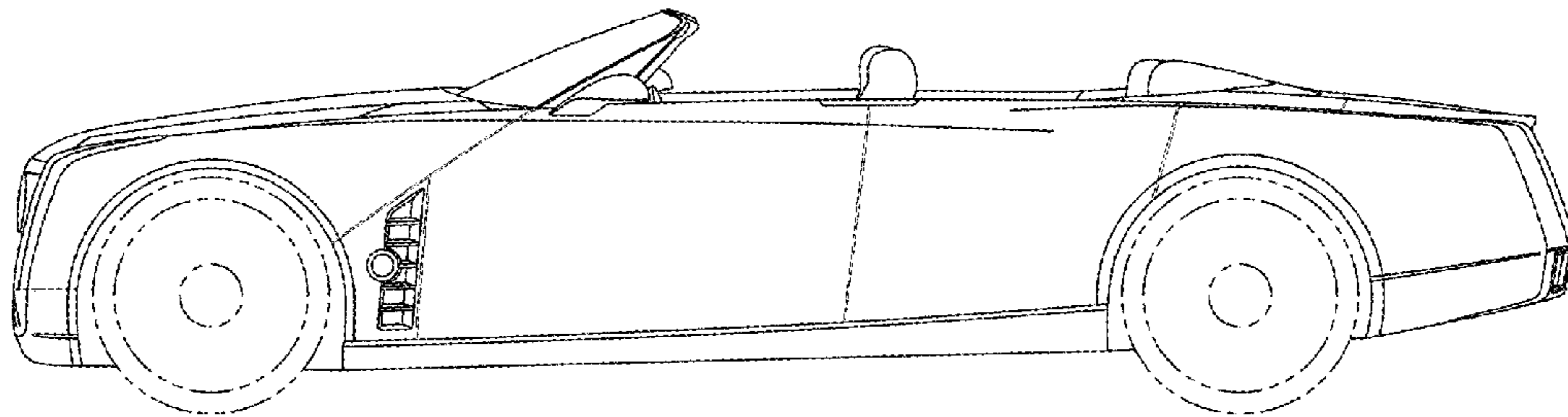

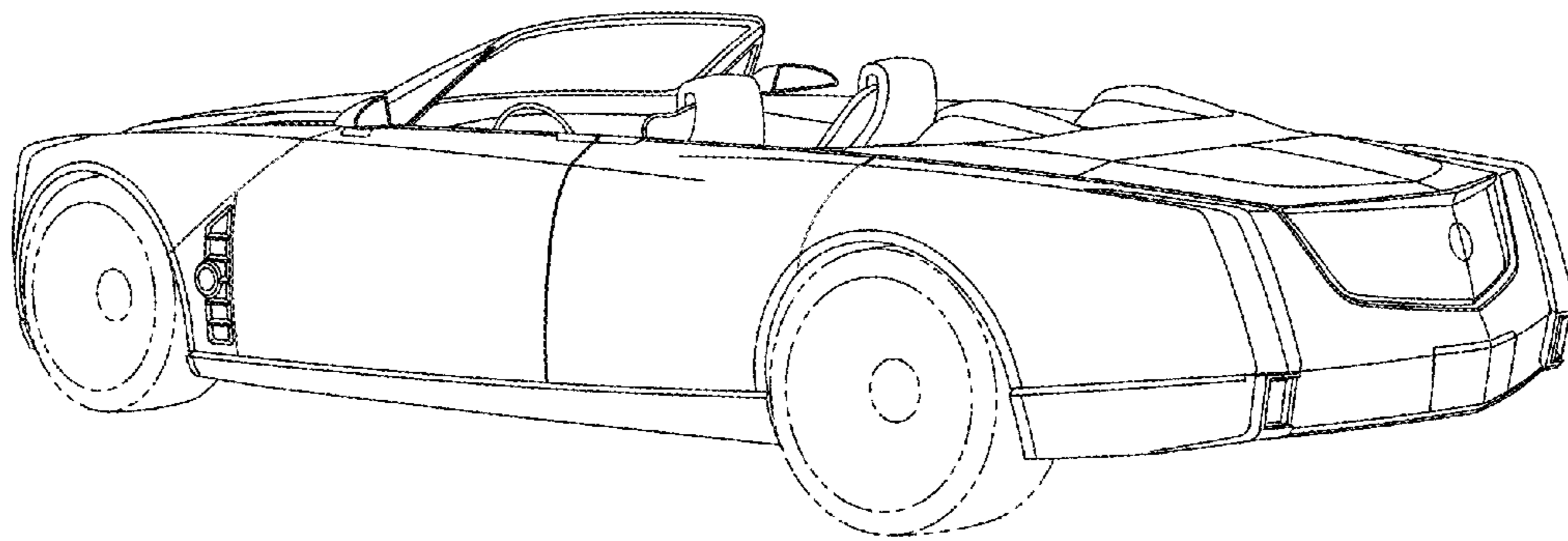

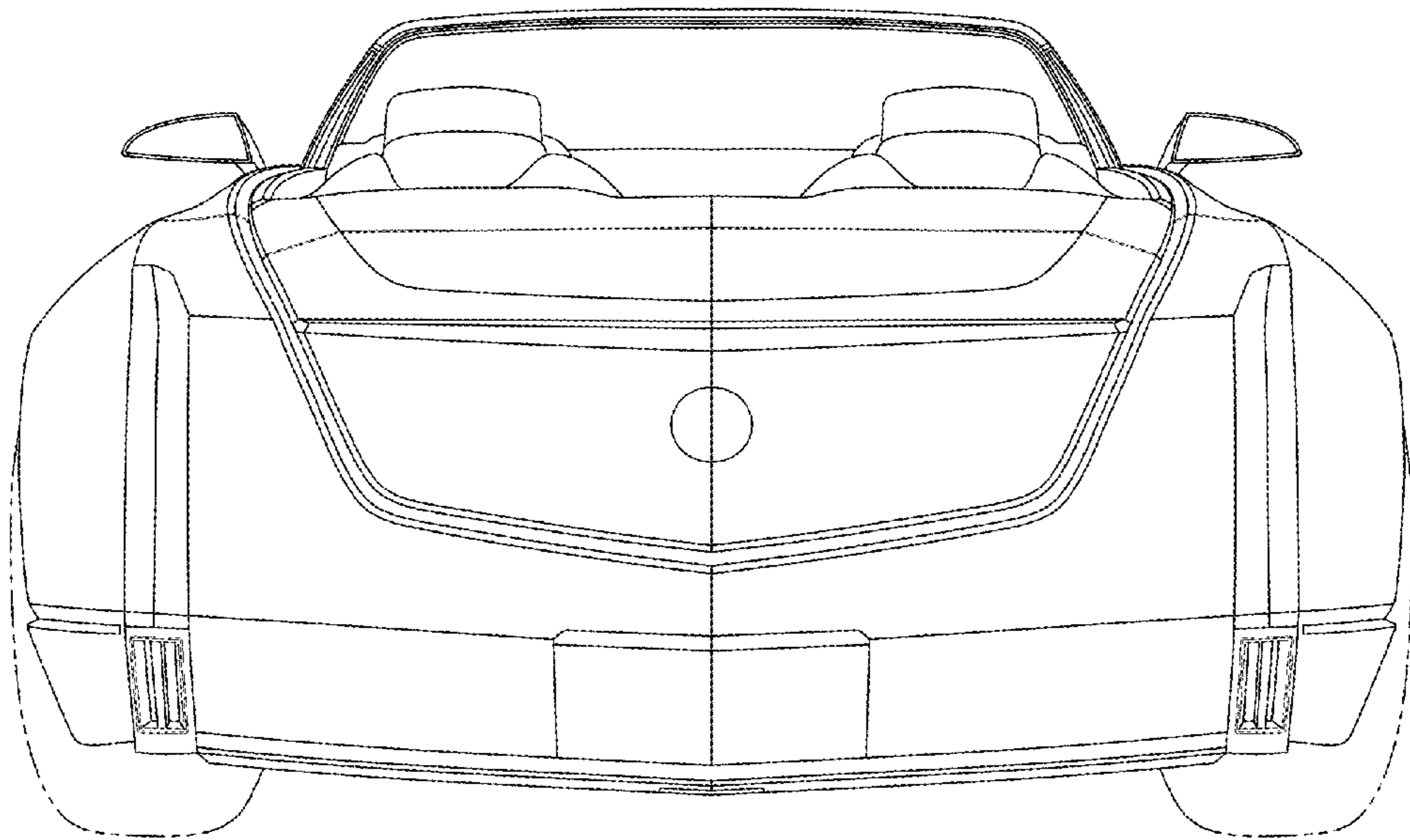
