(57) **CLAIM**

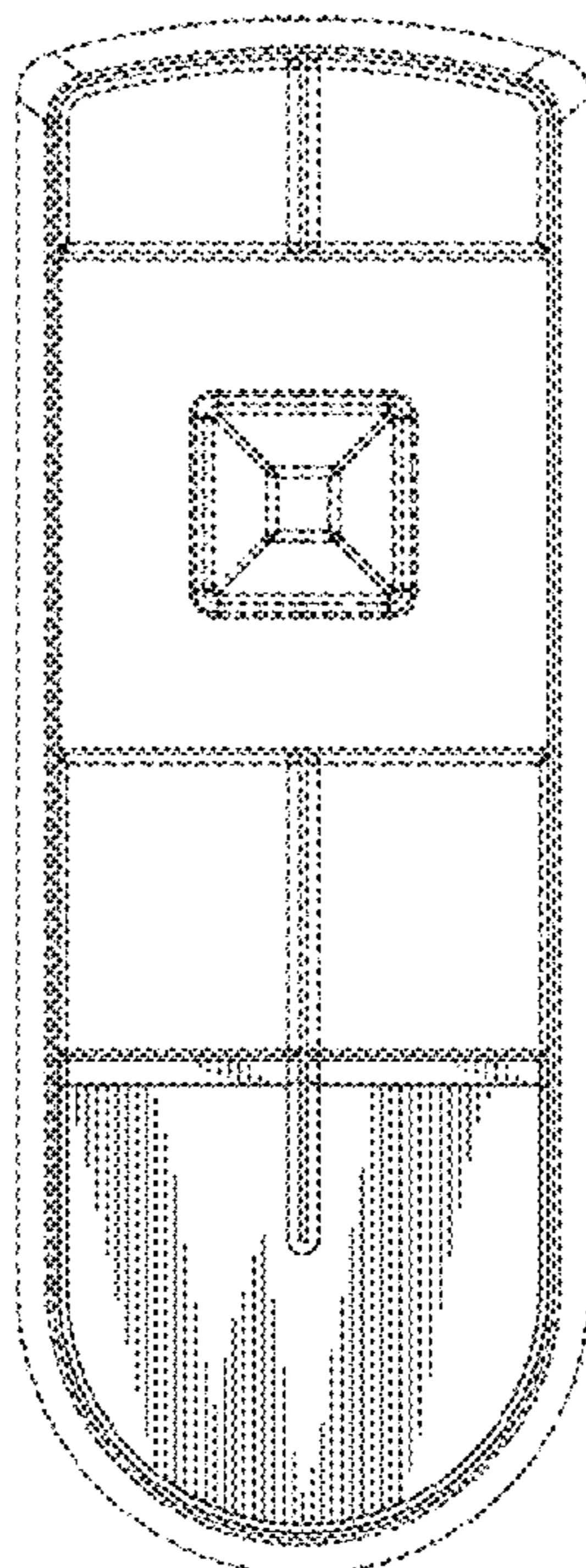
The ornamental design for a remote control, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a remote control as seen from the front, top and right side;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a right side view thereof, the left side view is a mirror image of the right side view;
FIG. 5 is a rear view thereof; and,
FIG. 6 is a front view thereof.

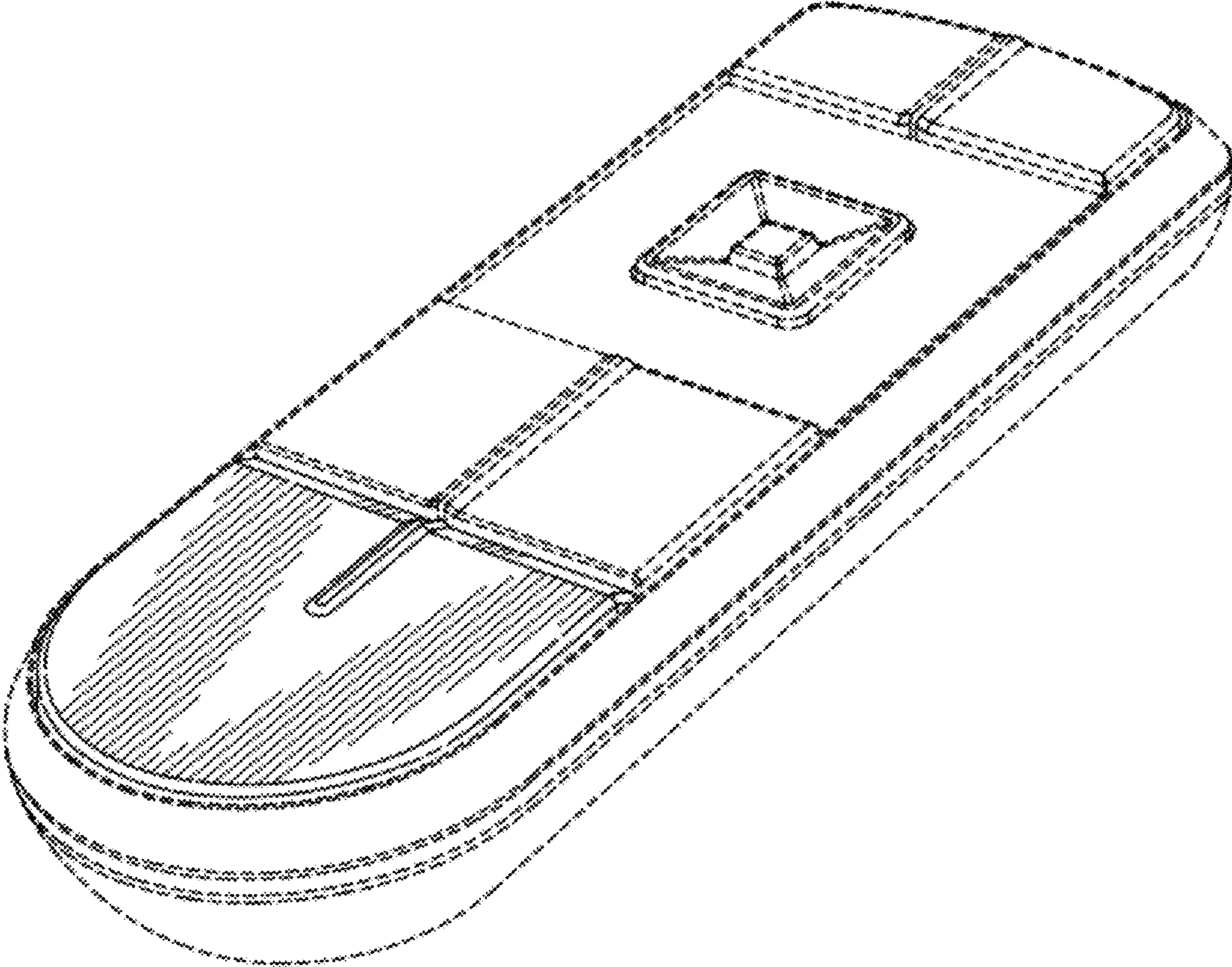

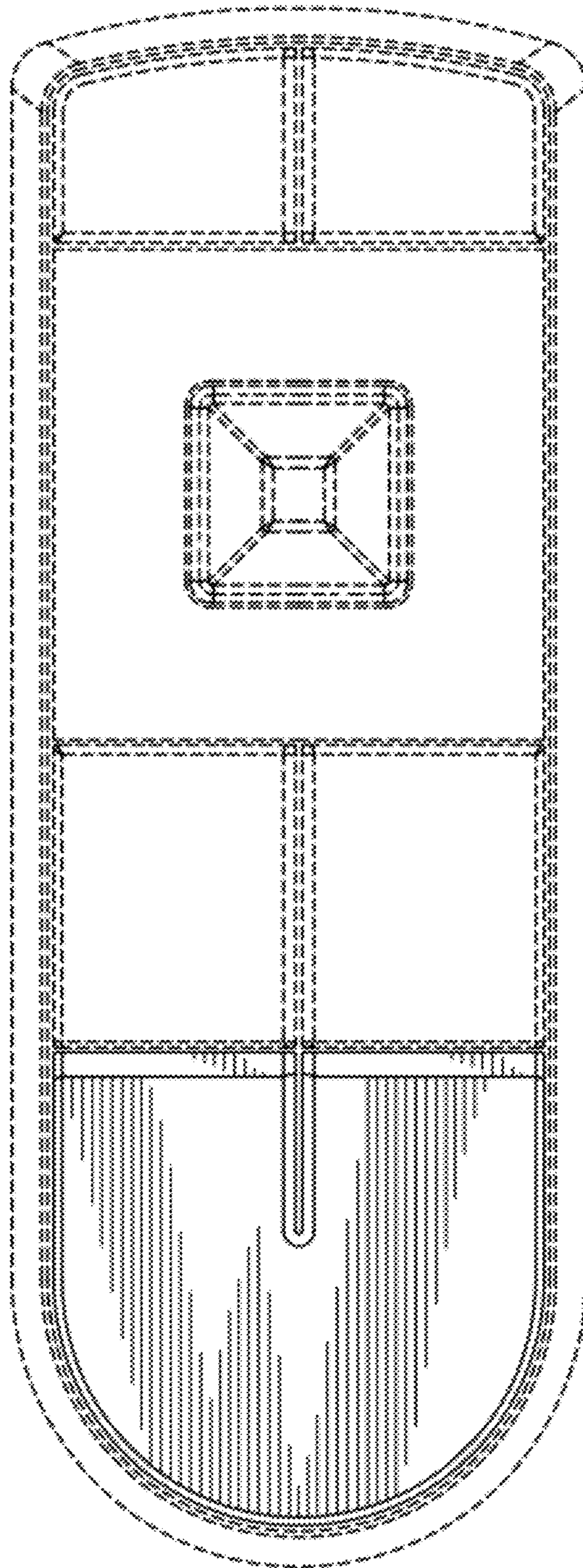

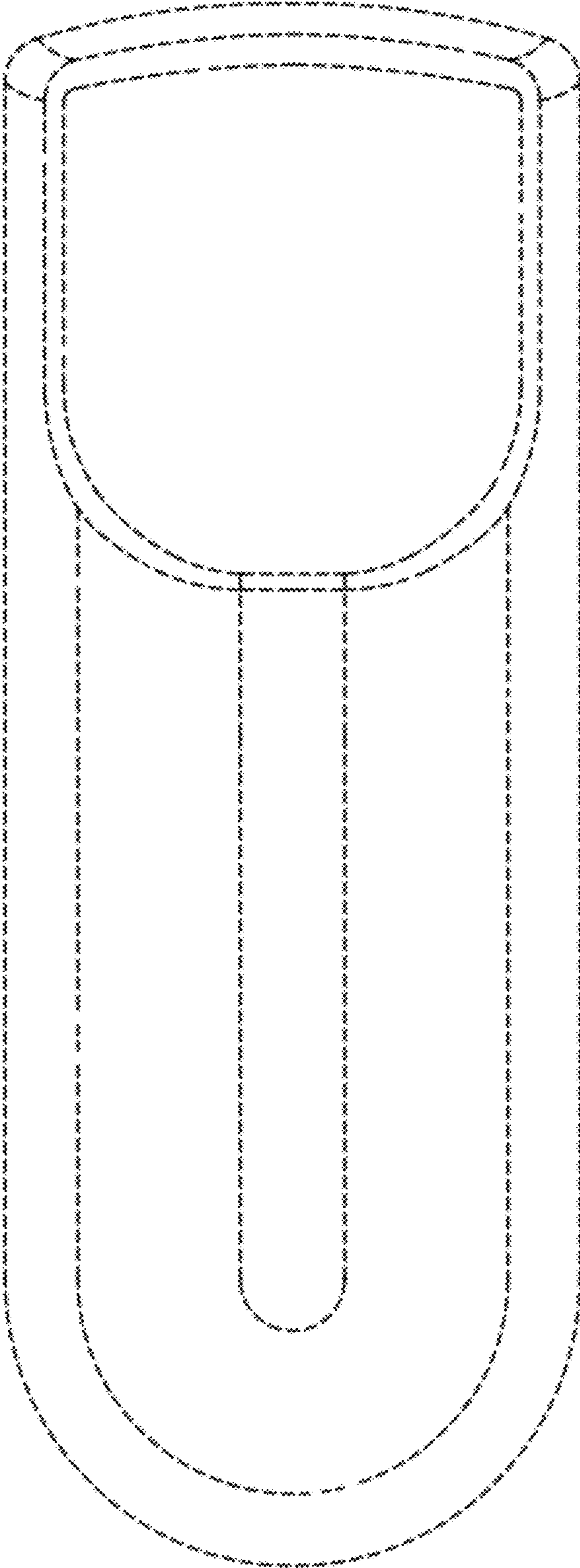

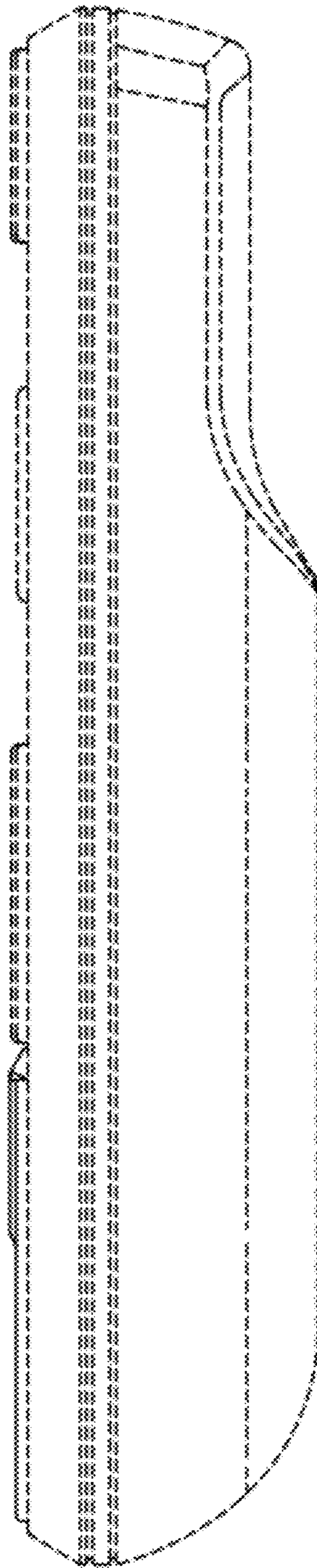

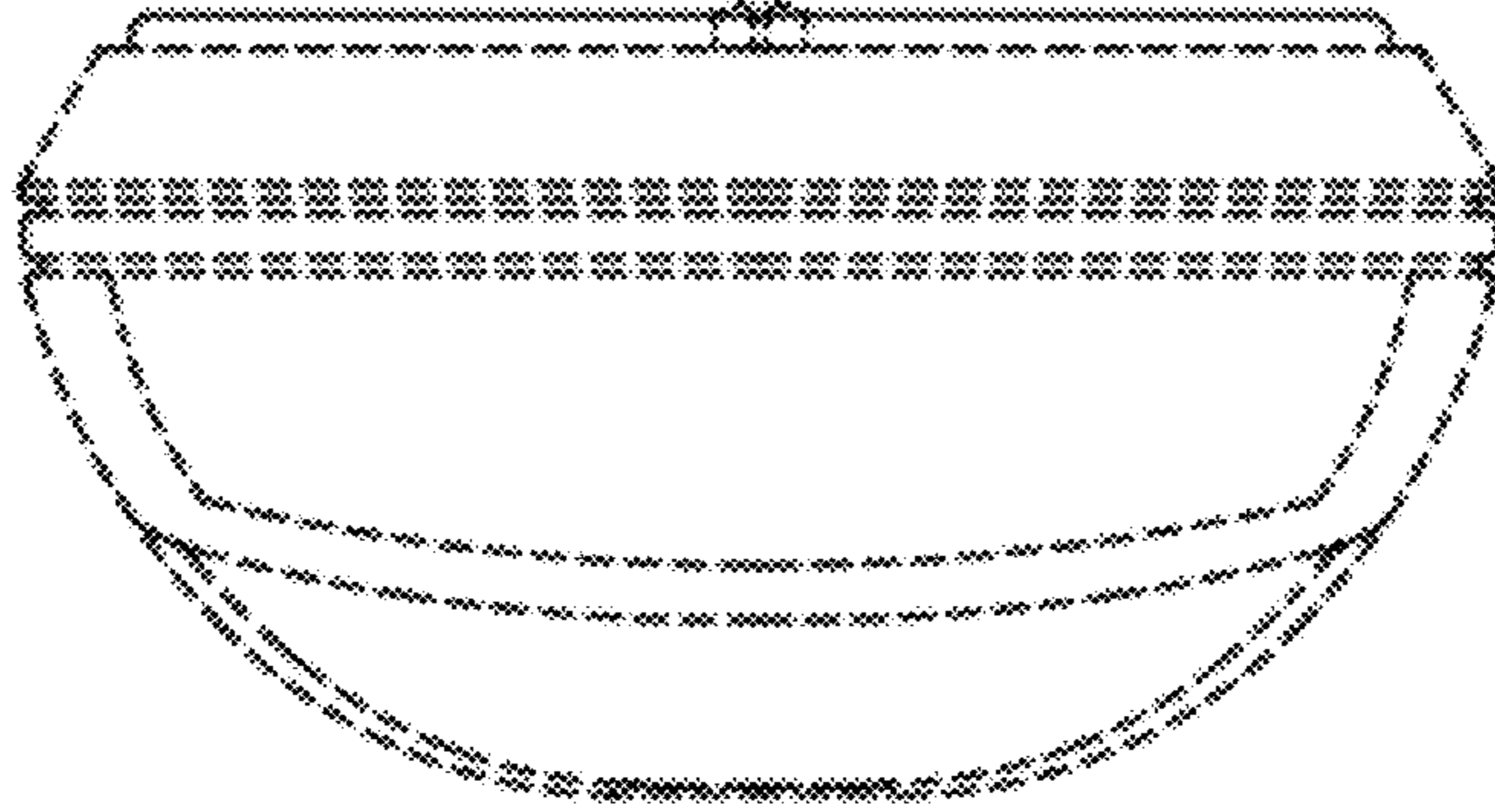

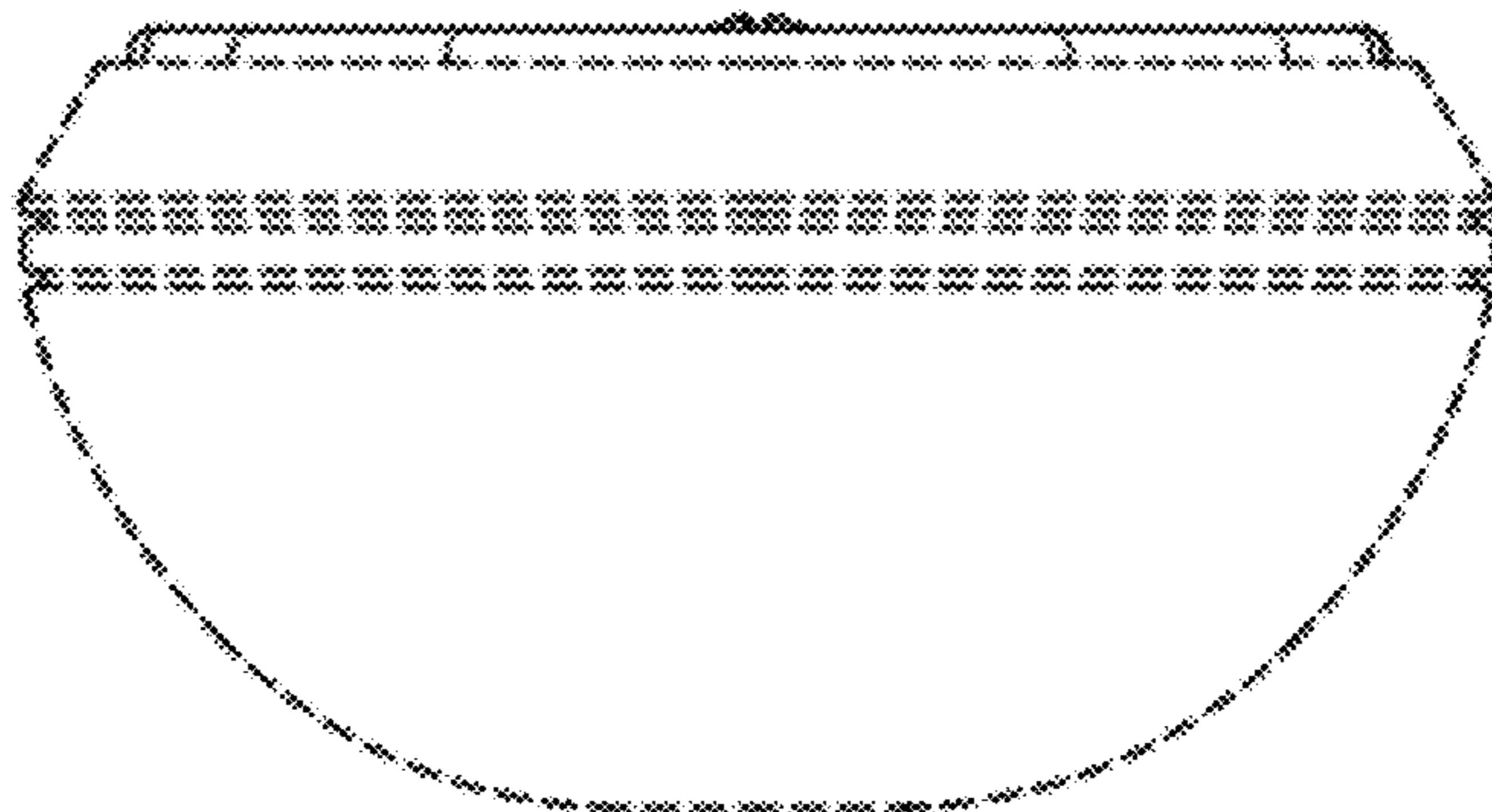
